## SJWD Selects Draft Map for Division-based Elections



On September 9, 2020, the San Juan Water District (SJWD) held a public hearing to select a draft map and identify the sequencing for division-based elections. The process began in response to a legal challenge asserting that the District's at-large election system violated the California Voting Rights Act (CVRA). Under the

five District divisions. The SJWD Board of Directors governs the District's wholesale and retail operations. ## **Board Votes** to Revise **Approved County Budget**

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Board of Supervisors voted on Sept. 10, to approve the Revised Recommended Budget for the 2020-21 fiscal year.

The Revised Recommended General Fund budget provided substantial additional funding to address the impact of COVID-19 on the community; avoided significant reductions in critical County programs and made new General Fund supported investments in some new programs to address the most critical needs.

The budget also accounted for the County's \$170 million revenue loss with one-time State and federal funding, which is likely unsustainable into future fiscal years.

"It is important to continue to provide the critical health, social, public safety and other services to the people of Sacramento County, and in spite of the significant economic impact of COVID-19, the Revised Recommended Budget did exactly that," said County Executive Nav Gill.

The \$3.08 billion General Fund expenditures increased by \$204.6 million. Departments with the largest expenditure increases included Health Services with a \$140.3 million (29%) increase; Sheriff with a \$38.2 million (6.9%) increase: Human Assistance with a \$26.4 million (7.8%) increase; Child, Family and Adult Services with an \$11.8 million (5.5%) increase; and Probation with an \$8.6 million (5.4%) increase.

During budget deliberations, the Board added a number of restorations to the budget totaling \$1,886,446 in appropriations, which included:

\$957,446 for body-worn cameras for probation officers; \$300,000 for the Foster Care Recruitment and Retention Program in Child, Family and Adult Services; \$203,000 for the Cares Plus Program in Child, Family and Adult Services' Public Guardian Division; \$126,000 to retain two staff positions that would have been eliminated in the Women, Infants and Children Program; \$300,000 to Child, Family and Adult Services to use as part of an effort to develop a Senior Safe House.

## President Gets Briefed on Wildfires

It was looking a little lonely on the tarmac when President Donald Trump arrived in California to be briefed about record-breaking wildfires that have burned an area the size of Connecticut, killed two dozen people and blanketed the West Coast with smoke. Not a single California state official greeted Trump as he stepped off the plane at an airfield in Sacramento County.

Gov. Gavin Newsom was in a hangar nearby, and promptly met with Trump and several fire officials. But his absence at the steps of Air Force One revealed the latest move in what's become the Democratic governor's delicate dance with the Republican president who is both a tantalizing political foil – and a key link to aid the state needs as disasters mount.

"We've been working very well with Gavin," Trump told reporters gathered on the tarmac.

"We're obviously from different sides of the spectrum, but we have a very good relationship."

Then, inside the hangar where Newsom (wearing a mask) and Trump (not wearing a mask) met with emergency officials, the governor also took a cordial tone.

"I want to thank you and acknowledge the work that you've done to be immediate in terms of your response," Newsom told Trump.

Newsom said they agree on the need to thin more trees and delicately lectured Trump about global warming driving the frequency and intensity of wildfires.

"Climate change is real and that is exacerbating this," Newsom said.

The dynamic between Newsom and Trump has turned out to be one of the major surprises of Newsom's short time as governor. Newsom won office in 2018 positioning himself as the antithesis of Trump, and pledged to lead a "resistance state." But his tenure has been marked by an extraordinary spate of disasters – catastrophic wildfires, the deadly coronavirus pandemic, a decimated state budget and record unemployment – that have required cooperation between two men who once cast each other as clowns.

Newsom has repeatedly praised Trump's disaster aid for California, saying he wants to put political differences aside when problems need to be solved. But it's involved a bit of whiplash. He recently called their relationship "very effective" in responding to emergencies

– just the day after he dissed Trump for saying California wildfires were due to insufficient forest raking. He talked last week about a productive phone call with Trump, even as he criticized the federal government for a lack of action on climate change.

It's a fine line to walk, and Newsom has occasionally slipped, by being so nice that he gave ammunition to a political opponent. While heaping praise on Trump for sending a batch of coronavirus test kits in April, Newsom used one of the president's campaign slogans – "Promises made, promises kept" – and promptly found himself in an ad

for Trump's reelection.

Newsom's approach – meeting with Trump to discuss forest management and climate change, but not appearing in any chummylooking photo ops in front of Air Force One – suggests that he is trying to thread the needle. On the one hand, he needs to demonstrate apolitical leadership amid disaster, but also avoid looking too bipartisan in an election year when he's campaigning for Trump's Democratic rival.

"It's a carefully-considered, carefully-orchestrated tango with the president that the governor has no choice but to participate in,"

said Nathan Ballard, a Democratic political consultant who worked for Newsom when he was San Francisco mayor.

Though Newsom disagrees with Trump "about almost everything under the sun," Ballard said, "it is vital for the governor's constituents that he continues to play ball with the president during these unprecedented disasters."

While Newsom and Trump kept things cordial, Newsom's environmental deputies got into a terse exchange with the president.

Wade Crowfoot, Newsom's secretary of natural resources, emphasized the unprecedented heat and warming trend, saying: "If we ignore that science and put our head in the sand...we are not going to succeed together protecting Californians."

Trump, smiling, said, "It'll start getting cooler, you just watch."

Crowfoot shot back, "I wish science agreed with you."

Trump responded, "I don't think science knows, actually," then briskly called on another presenter.

Demonstrators – of both parties – outside the meeting said they understand why Newsom plays nice with Trump.

Lance Caster said Newsom's approach makes sense to him, even though he doesn't like it. "It depends on what he wants. When he doesn't like what Donald's doing, he bad mouths him, and when he wants something, he's really nice," said Caster, a Republican who works as a truck driver and lives in the Sacramento suburb of Citrus Heights.

Most Californians believe climate change is "extremely important" or "very important" to them personally, according to a Public Policy Institute of California survey last month, and just one-fifth of the state's likely voters said they trust the federal government to handle environmental issues. Not surprisingly in this overwhelmingly blue state, 70% of voters said Joe Biden would be better than Trump on environmental policy.

## **Council Approves Contract for Regional Radio Communications**

CITRUS HEIGHTS, CA (MPG) - The September 10, 2020, Citrus Heights City Council meeting was again held via teleconference. Citrus Heights resident David Warren submitted a public comment regarding Councilmember Jeannie Bruins' prepared remarks at the Chamber of Commerce's Measure M forum. Bruins stated that the City has poll results showing a majority of residents would support a tax increase to gain the benefits provided by that funding, but Warren questioned those results.

Warren wrote that he and his neighbors were never asked if they would support a sales tax increase: "If such a poll was taken, the City should publish the specific question asked and the total number of votes cast approving or rejecting the 1% increase in the sales and use tax." He acknowledged that the majority of residents likely do support increased funding for the police department, city services, and street repairs. Warren suggested that the City conduct a poll specifically asking whether residents would support Measure M, "instead of asserting because residents want public services and municipal repairs, that the taxpayers will agree to a sales tax increase to pay for them."

Dan Stockridge, communications supervisor with Citrus Heights Police Department (CHPD), asked the Council to renew the agreement with the Sacramento Regional Radio Communications System (SRRCS). Stockridge explained that the SRRCS, which is maintained and operated by the Sacramento County, is the sole source provider for radio communications in the region. "SRRCS maintains a vast network of radio communications, equipment that provides two-way voice radio communications, and agency interoperability," said Stockridge. He described it as "the backbone for all radio communication for the CHPD."

Citrus Heights originally joined SRRCS in 2006 with an initial buy-in cost of \$116,194. The contract allowed Citrus Heights to operate its own police department and 911 communications center, and Stockridge said the renewal will allow CHPD to maintain its radio communications. If the City decides not to renew the contract, they would have to build and maintain an entire radio system, which would be cost-prohibitive. If approved, the proposed licensing agreement will run through July 1, 2030.

CHPD has 215 radios with SRRCS and the annual maintenance fees for this fiscal year are \$330 per radio, for a total cost of \$70,950. Planned increases in the next several years, which are already included in the CHPD's projected budget, will absorb the cost of required infrastructural improvements necessary for system sustainability. The annual increases will bring the cost to \$375 per radio by fiscal year 2026-2027.

Alliance with SRRCS promotes cooperation among 28 user agencies and spreads large capital and on-going operations costs across these agencies. Stockridge said, "Continued participation and influence as an SRRCS member allows CHPD to continue innovation and relevance in the region," and CHPD benefits from the shared costs as well and the shared knowledge and experience.

The City Council unanimously approved renewal of the SRRCS agreement.

The Council then considered an amendment to the City's Cardroom Ordinance Sunset Provision. After the City incorporated in 1997, many of the County's codes and ordinances were adopted until the City could adopt their own amendments. At that time, the County's cardroom ordinance was adopted – but with a sunset provision specifying the future date when cardrooms in the city would be prohibited.

Over the years, the sunset provision has been extended on several occasions - postponing the prohibition date. The current sunset date is December 31, 2020. Staff recommended an amendment permanently eliminating the sunset provision. The City submitted the proposed amendment to the Bureau of Gambling Control, which responded that eliminating the sunset provision does not conflict with the Gambling

The Council voted unanimously to approve the amendment. So, cardrooms in Citrus Heights will not be prohibited.

Citrus Heights is part of the League of California Cities, which is holding its annual conference in October (via teleconference this year). The Council chose Councilmember Porsche Middleton as its primary voting delegate, with Councilmember Bruins serving as

The Council then gave direction to Councilmember Middleton about their position on the League's proposed resolutions, which will be voted on during the conference. Katherine Cooley, assistant to the city manager, said there is only one item for consideration: Call to Amend the Communications Decency Act of 1996. The resolution would require that social media companies remove materials promoting criminal activities. Currently, social media companies are immune from civil liability for criminal activities promoted on their sites, which Cooley said is likely a case of the law not having caught up with how social media is used.

The League is requesting that social media companies can only retain their immunity if they meet the following requirements: Platforms must establish a reasonable program to identify and take down criminal content, and platforms must provide information to law enforcement. If a company willfully or negligently fails to meet these requirements, it will lose immunity from state and local laws and civil liability. The Council agreed that they support this resolution.

## City Reviews FlashVote Survey **Results: COVID Response and Recovery**

CITRUS HEIGHTS, CA (MPG) - The City of Citrus Heights launched FlashVote and the community's first survey - that focused on COVID responses and recovery - closed with over 400 responses in two days.

"We had an internal goal of 400 FlashVote sign-ups in two weeks, and we hit 514," said Communications Officer Nichole Baxter. "We knew FlashVote had high participation rates in other cities, so we were hoping our community would be responsive – and they were."

The City's first survey had a 72% participation rate for those who signed up, and sign-ups for the platform continue to grow. City leaders shared that they are encouraged by the participation rates, and that the feedback they received was invaluable. Staff have already begun preliminary plans for follow-up action items, based on community responses.

The City will continue to promote the platform and use FlashVote as a tool for community engagement. "It's more important than ever that we connect with our residents, and we are extremely focused on listening and responding to what our community wants," said Baxter.

With the first FlashVote survey, City staff asked questions to get a sense of how to best support the community during the pandemic. Full results of the survey are available after signing up at FlashVote.com/ CitrusHeights, and those without internet vey will launch in October 2020.

One of the survey questions focused on how COVID-19 has influenced buying behavior, and asked residents how shopping might change after State and County restrictions end. "We knew that question would provide interesting results," said Baxter. "When we think about shopping behavior, it's hard to imagine everything going back to the way things were pre-COVID."

Continued from page 1 collaboration between Behavioral Health and law enforcement to respond together to emergency calls for people experiencing mental health crises. Staff will return to the Board within 45 days with a sta-

tus report on this effort. "Concerned about elevating law enforcement accountability and transparency, the Board of Supervisors not only approved body cameras for sheriff deputies and park rangers, but we are one of the first in California to also fund the deployment of body cameras for our probation officers" said board chairman and first million (testing, contact district supervisor Phil Serna, who made the proposal in consultation with

the Chief of Probation. Lee Seale. "Other innovative and restorative budget actions the board took included adding funds for WIC (Woman Infant & Children) lactation services, preserving important foster care programing for some of our most vulnerable youth, buttressing mental health crisis services, and investing in a senior safe house for Sacramento County's elderly residents."

The Revised General Fund budget addressed the County's continued response to COVID-19 with \$89.1 million in expenditures:

Health Services: \$71.1 tracing, business navigators, food and housing assistance, Public Health surge capacity); Child, Family and Adult Services: \$6.9 million (Dine at Home Sacramento program for home-bound seniors); Human Assistance: \$11.1 million (COVID-19 Homeless Response Plan, Project Roomkey)

Additional growth requests included \$2.1 million for body-worn cameras for Sheriff's deputies and park rangers; \$9.4 million for the Mays Consent Decree, in which the County agreed to make significant investments in the jails to resolve the lawsuit concerning conditions of confinement; and \$2.6 million for mental health programs.

The Board is scheduled to formally adopt the Budget on Sept. 22.

## **Measure M is a Penny for Safer Communities and Stronger Public Safety**

Over 20 years ago Citrus Heights residents felt it was necessary to incorporate to provide more local control and better services for our community. A decade after incorporation, residents wanted safer neighborhoods and a stronger public safety presence, so the city created its own police department.

Our police department has worked strategically with limited resources to decrease overall crime. Since 2017, overall crime has been reduced by nearly 18%. Violent crime decreased by 9% in 2019, due to responsible, proactive crime prevention efforts and neighborhood patrol programs.

Unfortunately, however, the pandemic-induced recession means that our police department will not have the resources necessary to maintain these crime reductions that we on. Whether your focus have come to expect. Our police department is currently grappling with a \$1.6 million revenue shortfall, which means fewer officers on the street. Citrus Heights has already experienced a 7% increase in violent crimes since January of this year!

But it doesn't have to be this way.

After more than a year of community engagement and feedback, our city council placed Measure M on the ballot to provide critically-needed local revenue that will shore up our police department and keep Citrus Heights safe. Measure M will provide locallycontrolled funding to improve 911 emergency response times and successful programs that keep youth away from crime, drugs and gangs.

I urge my fellow Citrus Heights residents to vote YES on Measure M to keep dangerous criminals off our streets and time-tested programs that curb domestic violence, child abuse and elder abuse operating.

## No Pandemic Shutdown for Scammers, They Are Still on the Prowl

COVID-19 may have shut down portions of the economy and put restrictions on Americans' daily lives, but cyber scams and other efforts to defraud people continue to

"Scammers are tapping into the uncertainty related to the global pandemic," says Chris Orestis, the president of LifeCare Xchange who is known as the "Retirement Genius" (www.retirementgenius.com).

"They are using social engineering to target people with tactics that take advantage of today's technology. Seniors need to be especially mindful of the mechanisms that have been explicitly designed to target people in retirement."

Some scams to be on the lookout for include:

Dishonest retailers. Many dishonest retailers and fake products are popping up, Orestis says. "The shortage of toilet paper, hand sanitizer, soap, and masks at the beginning of the quarantine resulted from people's panic," he says. "The fear of scarcity created a gateway for scammers. Fraudulent online retailers are showcasing these items as bait, especially medical supplies." But they don't have any inventory, so stick with reputable stores, Orestis says. Scammers also try to sell products to prevent or cure COVID-19, even though they do not exist. "Anyone who receives a message from someone selling any of these items should not respond," Orestis says.

Phony advertisements. Scammers also try to advertise hard-to-find products through social media, email or ads that pop up on certain sites. Avoid clicking on anything unfamiliar because cyber criminals may be trying to steal your personal information or infect your computer with a virus, Orestis says. "Be cautious of people who try to contact you under odd usernames and do not have a profile picture," he says. "If anyone asks for your personal information or invites you to click on a link, block them immediately or report them as spam."

Government or organization disguises. Is a government official or someone from the CDC or from the World Health Organization trying to contact you? Maybe, but probably not. Scammers often try to convince potential victims that they are with a legitimate agency or group, Orestis says. "For example, an email might claim that there have been

new COVID-19 cases in your area and ask for your personal information to see if you have been in contact with anyone infected," he says. "Be suspicious of any COVID-19 related emails and use only official government websites to get information about the virus."

Fake charities and crowdfunding. Criminals have also created counterfeit charities and crowdfunding sites. They ask for money in the form of cash, gift cards, and wire transfers. "Real charities will never use these resources," Orestis says. "Be sure to use reputable sites and research the charities you

want to donate to for coronavirus relief.' **Phone scams.** Phones are still the No. 1 way scammers target seniors, both through calls and text messages. The Federal Communications Commission warns about these methods being used by people who claim to be the IRS or have coronavirus treatments, at-home testing kits, and vaccinations. "If you receive a robotic voice call, do not press any buttons or return any calls," Orestis says. "Hang up immediately. If you receive text messages regarding this information, do not respond or click on any links."

"It's important to be wary of these and other scams, both off and online," Orestis says. "The more conscious people are of how scammers are trying to trick them, the less likely they are to fall for one of those tricks."

## **Know the Warning Signs of Suicide**

SACRAMENTO COUNTY, CA (MPG) - Suicidal thoughts, much like mental health conditions, can affect anyone regardless of age, gender or background. Every day friends, family and co-workers can be struggling with intense emotional pain and hopelessness. It may be too difficult for them to initiate a conversation to talk about their pain, thoughts of suicide and the need for help. It's important to know the warning signs that may show in conversations, their actions or in social media posts. By recognizing these signs, knowing how to start a conversation and where to turn for help, you have the power to save a life.

September is National Suicide Prevention Awareness Month – a time to share resources and stories in an effort to shed light on this stigmatized topic. Sacramento County Division of Behavioral Health Services wants to use this month to reach out to those affected by suicide, raise awareness, connect individuals with suicidal thoughts to treatment serstigma is the largest obstacle to seeking treatment.

"While Californians are enduring the emotional toll of crises from COVID-19 to devastating wildfires, and racial injustice, this month serves as an added reminder that behavioral health is inseparable from our overall health as a state. Our behavioral health wellbeing has much wider implications for us as a community," said, Sacramento County Behavioral Health Director Ryan Quist. "It's important to remember that we all have a role to play in promoting connectedness, belonging, resiliency and prevention. Today, it's more important than ever before that we reach out and support each other."

# Why Is My Medicare Part B **Premium Costing \$723?**



My Medicare began on August 1st and on September 3rd I received my first bill which is \$723 for my Medicare Part B. This bill is

due September 25 th and is not giving me very much time to have this paid.

I do not see this Medicare cost anywhere on the Medicare site and have not received a letter informing me that I will have to pay "extra" because I made too much. I came into the Toni Says office for a Medicare consultation and with my wife's income, we are below the \$174,000 yearly income to have to pay more in my Medicare Part B and D monthly premiums.

Why am I being charged the Medicare Part B penalty? I signed up before I turned 65. What is wrong? I thought I would be paying the monthly Part B amount that is around \$145. Any suggestions because this has placed an unexpected financial hardship on me? I am unemployed due to COVID-19.

~ Thanks, Dennis from Spring, TX Dennis:

I have great Medicare news for you .... You are not being charged EXTRA or a penalty!! You have been charged for 5 months of Medicare Part B premiums because you are not receiving a Social Security check to have your Medicare premiums deducted. Security has lumped your

months together in the bill which was sent.

Some that are paying their Medicare premiums monthly are having Medicare premiums deducted from their Social Security check. Social Security will automatically take the Medicare premiums monthly from a person's Social Security check. Social Security will send a letter informing the Medicare beneficiary that Social Security is deducting the monthly Medicare Part B premiums from one's Social Security check.

Dennis, if you divide your premium of Annual Enrollment can be.

\$723 by 5 months, it is exactly \$144.60 per month. The average Part B premium for those with income of \$87,000 or less as an individual or \$174,000 or less as a couple

is \$144.60 for 2020. Medicare has two programs that can allow one to pay premiums monthly. One is by going online to your secure MyMedicare. gov account (or create an account at www. MyMedicare.gov) to pay by credit card or debit card. Sign up for Medicare Easy Pay, a free service that automatically deducts your premium payments from your savings or checking account each month.

One can GOOGLE "Medicare Easy Pay" online or search on the Medicare. gov website at www.medicare.gov website for the Medicare Easy Pay form. It is not hard to set up Medicare Easy Pay to pay monthly, but it does take time.

Until you can set up a monthly payment from your checking or savings account with "Medicare Easy Pay" then you can pay your Medicare bill at your www. MyMedicare.gov account.

If one does not stay current paying their Medicare premiums, whether it is Part A, B, C and/or D, then they can lose their benefits and may be charged a penalty when they re-enroll. When one does not have 40 working quarters to qualify for Medicare, then they may have to pay a premium for Part A.

It may take about 6-8 weeks to have the "Medicare Easy Pay" form processed and drafted monthly from your checking account. Until that takes place then use www.mymedicare.gov. Make sure that your monthly premiums are being paid, so that your Medicare Parts A, B, C and/or D premiums are current.

## **Supreme Court Makes Local Tax Hikes Easier**

In a roundabout, passive way, the California Supreme of higher taxes.

Without comment, the justices declined to take up a state appellate court decision that would allow specialized local government taxes to be increased by a simple majority of voters, if they are placed on the ballot by initiative petitions rather than by the governments themselves.

The victory for tax proponents, especially government worker unions, was an equally large defeat for anti-tax organizations such as the Howard Jarvis Taxpayers Association. However, it also may bring more ballot box budgeting and indirectly weaken the role of city councils and other locally elected boards.

Proposition 218, approved by California voters in 1996, declares that local governments seeking more revenue must win voter approval. Proposals for general purpose revenue through increases in sales taxes or other levies need only simple-majority approval. However, if cities, counties and other local governments seek new taxes for specific purposes, Proposition 218 requires two-thirds votes.

Three years ago, the state refusing to take it up. Supreme Court issued a decision called "Upland" because it dealt with a balmarijuana in that Southern California city.

Writing the 5-2 majority opinion, Supreme Court Justice Mariano-Florentino Cuéllar declared, "Multiple provisions of the state constitution explicitly constrain the power of local governments to raise taxes. But we Court last week handed a will not lightly apply such big victory to the advocates restrictions on local governments to voter initiatives."

He thus implied that special purpose taxes placed before voters via initiative may not be affected by the two-thirds vote requirement for taxes sought by governments themselves.

Ouickly, special purpose taxes placed on the ballot via initiative that garnered less that two-thirds votes were challenged by the Jarvis organization and other taxpayer groups, but trial court judges differed sharply on whether Cuéllar's opinion did, indeed, validate

Two of the tests were San Francisco taxes placed on the ballot via initiatives personally sponsored by members of the city's Board of Supervisors, one for early childhood education, the other to battle homelessness. Both received less than two-thirds votes, but a local judge, Ethan Schulman, validated them anyway.

In June, a San Franciscobased appellate court upheld Schulman on the homelessness taxes and the Jarvis organization appealed to the state Supreme Court, which last week validated the appellate court ruling by

The tax on business gross receipts for homelessness services will raise as much lot measure on taxing as \$300 million a year. "San Francisco voters have the right to direct democracy and self-government," City Attorney Dennis Herrera said in a statement. "We're pleased that this legal victory will free up millions of dollars to provide services, housing and mental health treatment for those who most desperately need it in our city."

> The Supreme Court's action, or non-action, also may validate other disputed special purpose taxes, including another for early childhood education in San Francisco, an Oakland parcel tax for education and a Fresno sales tax for parks. Local judges had blocked the Oakland and Fresno taxes, declaring that Proposition 218 required them to have two-thirds

> Local government officials prefer to ask voters for general revenues because they are more flexible. But advocates for particular causes prefer special purpose taxes to prevent revenues from being diverted elsewhere.

> The way is now clear for interests with the wherewithal to qualify and pass ballot measures, such as unions, to push for taxes that benefit their members, thus reducing the authority of local elected officials to set budget priorities.

## **Social Security Matters**

## Can I Claim My Widow's Benefit at Age 57?

Dear Rusty: My husband passed away in 2001, and he paid into Social Security every year he worked, which would be over 30 years. If he were alive today, he would be 75 years old. I am 57 years old and still working full time. Am I able to collect his Social Security benefits now since I am still working? Signed: Widowed Worker

Dear Widowed Worker: You are not eligible to collect a survivor benefit from your deceased husband if you have remarried, and you cannot collect the survivor benefit until you are at least 60 years of age. And, if you claim at age 60, the survivor benefit will be reduced by 28.5% from what it would be if you waited until your full retirement age (FRA) to claim it (your full retirement age is 67). Any time any Social Security (SS) benefit is taken before FRA, it is reduced.

You can claim only your survivor benefit (not your own SS benefit) at age 60, but whenever benefits are taken before full retirement age, and you are still working, you are subject



to Social Security's "earnings test" which limits how much you can earn before Social Security takes back some of your benefits.

The earnings limit for 2020 is \$18,240 (it changes yearly) and if the limit is exceeded Social Security will take back benefits equal to \$1 for every \$2 you are over the limit. Such lost survivor benefits are not recoverable. Social Security publishes next year's earnings limits in the fall of each year prior, so what the earnings limit will be when you reach age 60 isn't vet known, but it will be an amount that is more than the 2020 limit.

be eligible for your own only and does not represent Social Security benefits from your own lifetime It presents the opinions work record, you should evaluate which benefit, at maximum, will give you the highest benefit amount. If that is your survivor benefit from your husband (which, at your FRA, would be 100% of the benefit your husband was collecting when he died), then you should consider maximizing the survivor benefit by not claiming it until you reach your FRA. If money is needed earlier, you could claim your own SS benefit as early as age 62 and

allow your survivor benefit to reach maximum at your FRA. Conversely, if your own Social Security benefit from your own work record will be higher at maximum than your survivor benefit, then you could claim your survivor benefit first and delay claiming your own benefit until it reaches maximum at age 70 (your own benefit will be 24% more at 70 than it will be at your FRA). Your goal should be to get the highest possible benefit for the rest of your life and comparing these two options will permit you to do that. You can find out your estimated benefit amounts in both cases by

contacting Social Security. And remember, if you decide to claim your own benefit before vour FRA that, too, will be subject to the earnings limit until you reach your FRA, after which there is no longer a limit to how much you can earn.

## **CHWD Submits Revised Map** to SJWD for CVRA Transition Process

Dear President Costa:

The Citrus Heights Water District, appreciates additional perspectives on the San Juan Water District's ("SJWD") process to transition from "at large" to "by district" elections. Having been through this process ourselves recently we understand it is not an easy task. My colleagues and I request that you and your colleagues consider the attached map as the proposed electoral map for SJWD.1 This map makes amendments to your District's previously released Map W to more accurately capture your Board's expressed preference for respecting urban-rural divides within SJWD while also ensuring compact and contiguous districts that reflect size. Using this metric, existing communities of interest, namely the existing counties, cities, and a lower score can be a sign self-identified neighborhoods within SJWD.

**Concerns with Process** to Date - As an initial matter, CHWD has concerns with some of the difficulties you have encountered

in the process to date: Lack of Opportunity for Remote Participation. While CHWD appreciates SJWD's scheduling workshops in addition to the required four public hearings, some of these meetings have been "in person" only and schedshort notice. For example, the August 15th public outdoors during an unprecedented heat wave. While the workshop moved into the SJWD Board room because of audio issues, there was no opportunity for the public to participate remotely. Given the COVID-19 pandemic, SJWD's obligations under the Americans with Disabilities Act, and basic fairness, we hope that SJWD can ensure that all future meetings have a remote option for those who may be unable or unwilling to attend in person hearings. This remote option should ensure that all participants (remote and in person) can hear and see all speakers. SJWD may Counsel on the effect (if

of Legally Use Appropriate Metrics to Capture Density. We understand that the SJWD Board has apparently reached consensus on the importance of drawing maps to respect existing urban-rural divides. While the merits of this approach are discussed below, SJWD should re-evaluate its chosen metrics in order to legally achieve this objective. You will recall that it was recommended that you and your Board use "household density" to measure actual population very different things. Urban-Rural Split Must Not be Pre-textual. If the SJWD Board decides to consider the urbanrural divide when drawing maps, please remember that it may not be used as a pretext for some other impermissible purpose like splitting minority groups or incumbent protection. On this later point the maps being considered this opportunity to provide by your Board do not seem to follow existing urbanrural splits. I believe your Board wants to achieve the best urban-rural division it can and hope you will not consider other unexpressed interests, like incumbency protection actually driving the process.

Lack of Compactness. As you know, one of the most important considerations for map drawing is compactness. The most common mathematical method for measuring compactness is Polsby-Popper, which is a measurement of the ratio of the length of the perimeter of the shape of the district, compared to a perfect circle of the same in which a higher score is better (more compact) and of concern, or even evidence of gerrymandering, Map W performs best.

Evaluation of Maps -Under existing law and as noted in our prior comment letter, the preparation of voting district maps requires compliance with certain state and federal requirements. Perhaps the most important requirement is the longrecognized "one-person, one vote" standard, which requires all voting districts be as nearly equal in populed on a weekend with ulation as possible. > The other maps provided by SJWD to date do not reflect these natural boundaries and do not emphasize appropriate communities of interest. As an example, Map AB attempts to be contiguous by having portions of Divisions 1 and 5 be contiguous through a single "point." This is not generally appropriate, as your legal counsel has correctly noted. (See generally Article 21 of California Constitution; Elections Code, § 21500(c)(1).)

> The maps presented by SJWD to date do not accurately capture the expressed preference for respecting the urban ruraldivide. As an example, Map B which seems to be preferred by some does not actually respect urbanrural boundaries. Division 1 includes urban areas on its western and southern boundaries that better fit with adjacent urban areas. It similarly excludes rural portions of Division 3 on its south-eastern edge. Division 2 wraps through the other divisions without any real expressed community of interest. Admittedly, this map does group urban portions of Granite Bay into Division 3. However, this one modification does not appear to achieve your ruralurban objectives through the other actual line-drawing set forth in Map B.

> Map W Should be Revised to More Accurately Capture the Urban-Rural Divide -While the maps provided by CHWD best adhere to accepted legal standards, we recognize that redistricting is an imperfect process of compromise. Based on this, CHWD requests that SJWD consider a revision to Map W to more accurately capture its expressed preference for maintaining the urban-rural divide as attempted in Map B. This map acknowledges the discussion by the SJWD Board regarding including the more urban portions of Placer County in a district with adjacent urban areas. Specifically, Division 2 now includes this area, and Division 3 has captured area to account for the population difference. This revised map makes an adjustment to Map B that reflects the urban-rural split of Map B while also respecting existing self-identified neighborhoods.

> Finally, we thought it might be helpful to attach for your use what we understand to be a precise delineation of CHWD's service area boundary to assist SJWD in correlation of its wholesale and retail boundaries with that of CHWD. CHWD appreciates the opportunity to participate in this process, and we would be happy to share shape-files of the revised map or answer any questions. Thank you for your consideration.

## SJWD Selects Draft Map for Division-based Elections

Continued from page 1 water use needs than the typical suburban area.

The Citrus Heights Water District and Fair Oaks Water District submitted potential draft maps for consideration, based on existing county, city, and neighborhood boundaries. SJWD Legal Counsel Jennifer Buckman said that those maps were rejected because they did not accurately reflect District boundaries.

The Board of Directors instructed the demographer to consider the following criteria when drafting potential maps: community associations, rural area boundaries, county and city lines, and the boundaries of other special districts—such as water, fire, park, and cemetery districts. Out of multiple potential maps, SJWD staff identified Plan B as the best option to meet all the required considerations. Buckman explained that the map is compact, contiguous, meets the population requirements, and also creates a division representing the rural areas of Granite Bay and Orangevale. In contrast to some of the other map options, Buckman said that Plan B also avoids "packing" the retail customers into one division, which could dilute their voting power.

According to the most recent census data from 2010, SWJD doesn't have significant concentrations of African American or Asian populations, but there is a significant Latino/Hispanic population in the Citrus Heights area. Buckman said Plan B was drawn so that Latino voters could be concentrated into a "majority/ minority division." This is encouraged by the CVRA, as long as the division is compact and drawn without

racial gerrymandering.

The Board agreed with staff's assessment and expressed a preference for advancing Plan B. On the question of election sequencing, staff recommended that Divisions 2, 4, and 5 be elected in 2022 and Divisions 1 and 3 be elected in 2024. President Ted Costa suggested an alternative, asking that the divisions on the map be renumbered so that the blue, green, and brown divisions are odd numbers and the purple and yellow divisions are even numbers. He suggested odd-numbered divisions come up for election in 2022 and even-numbered divisions come up for election in 2024: "That would make a smooth transition."

Director Dan Rich motioned that they move forward on a vote following President Costa's recommendation. The motion was seconded by Vice President Pam Tobin.

Director Marty Hanneman brought forward a substitute motion to vote on the sequencing in the staff recommendation. With no second on the motion, the motion failed.

President Costa opened the meeting for public comment. Two members of the public spoke in support of the proposed map and sequencing, including Granite Bay resident Amber Beckler who said she believes the rural areas are "well represented."

President Costa also entered into the record confirmation of receiving a joint letter from Citrus Heights Water District and Fair Oaks Water District. President Costa did not read the letter during the meeting, but it was posted to the SJWD website. In the letter, dated September 4, the Citrus

Heights Water District and Fair Oaks Water District acknowledged the Board's desire to respect rural areas as a community of interest. But they expressed concern that Plan B "does not actually respect urban-rural boundaries." The letter states that "the maps being considered by your Board do not seem to follow existing urban-rural splits. We believe your Board wants to achieve the best urban-rural division it can and hope you will not consider other unexpressed interests, like incumbency protection actually driving the process."

Director Ken Miller asked Legal Counsel Buckman whether she had reviewed the letter from Citrus Heights Water and Fair Oaks water districts about their concerns regarding the District's proposed maps. Buckman said, "Nothing in that letter gave me pause or concern about the recommendations that were included in the staff report."

When asked which divisions current Directors reside in, Buckman said, "We're not going to answer that question, because where the current Board members live has not been a factor that this Board has taken into consideration in drawing the divisions. And we don't want to introduce that evidence into the administrative record. That's not something the Board has been considering."

The Board of Directors voted 4-1 in favor of Plan B and President Costa's proposed sequencing, with Director Hanneman dissenting. The map and election sequencing will move forward for final approval at the October 14 public hearing.


