**SACRAMENTO REGION, CA (MPG)** - The Sacramento Regional Transit District (SacRT) announced today they are implementing a September 2020 service recovery plan to restore service to pre-COVID-19 levels. The additional service begins on Sunday, August 30, 2020. The service recovrail (Blue and Gold lines), bus (routes 1 through 93) all peak-only/express routes 102, 106, 107, 109, 113, 129, Line (routes 10F and 30F).

### **Public Health** Order to All **Sac County Schools**

Sacramento County **Public Information Office** 

SACRAMENTO COUNTY, CA (MPG) - Sacramento County Public Health (SCPH) noticed all schools (TK-12), both public and private, with a Public Health Order for Schools that all schools in Sacramento County must utilize a distance learning model, until further notice.

Schools may not conduct instruction or otherwise operate as a "day care," "child care," "camp," or any other allowable activity. Students are not permitted on school campuses or to otherwise engage in in-person school activities, except as specifically noted below:

Emergency Mental Health Counseling - If emergency in-person mental health counseling is deemed necessary, in lieu of virtual settings, it may be conducted on an individual (1:1) basis; initial English Language Learner Assessments - May occur in-person on campus and conducted on an individual (1:1) basis unless group settings are legally required, in which case the groups should be the smallest size possible; Special Education Assessments - May occur in-person on campus on an individual (1:1) basis as required by state and federal regulations.

The Order provides clarification that all schools must not conduct in-person instruction while the County is on the State's Monitoring List. The State requires counties on the Monitoring List be removed for a period of at least 14 consecutive days in order for the Public Health Officer to consider in-person instruction for grades 7 - 12. The State has provided guidance that allows local health officers to grant waivers for elementary schools to conduct in-person instruction, but Public Health will hold off on the consideration of these waivers until the data shows evidence that the transmission of COVID-19 is slowing. It is anticipated that waivers could be considered no sooner than mid-September.

Along with the Order, schools received a letter from the Sacramento County Health Officer and a document with answers to frequently asked questions for schools.

Sacramento County Public Health understands the difficulty this creates for students, teachers, staff, and families. However, these restrictions are in place to limit the spread of COVID-19 in Sacramento County to help keep our community healthy and safe.



### Blackouts Reveal Our Power Shortage Social Security Matters

The prolonged heat wave of 100-degree-plus temperatures that grips California has strained the state's electric power grid to the breaking point, resulting in rolling blackouts for the first time in nearly two decades.

California's Independent System Operator (ISO), which manages the distribution of power for the state's investor-owned utilities, imposed temporary outages as demands from air conditioning systems in millions of heat-stressed homes approached supply capacity.

The blackouts clearly tell us that California has a has repeatedly warned power supply problem. It's unacceptable that a state with a world-class economy grounded in cutting edge technology has the unreliable electrical service of a third world country.

Moreover, if we lack sufficient generating capacity now, the gap between supply and demand will grow even wider as our population continues to grow and if, as we are constantly told, the climate becomes ever warmer.

Our power supply problem stems largely from political policies aimed at phasing out hydrocarbon energy, such as natural gas-powered generators,

"renewables" such as solar panels and windmills.

By decree, the latter are supplying ever-increasing amounts of power, but they are much less reliable than traditional generation. Therefore, when demand climbs to near-record levels ISO must turn to natural gas-fired plants to make up if it cannot acquire more juice from out-of-state generators.

ISO data reveal that when demand peaks, natural gas plants are supplying half or more of California's power, but even so there are not enough electrons because we have discouraged construction of more gas-fired generation.

"The situation is one that could have been avoided." Steve Berberich, ISO's top executive, told the agency's board on Monday during a review of weekend blackouts, adding that the supply situation "is broken and needs to be fixed."

Berberich said the ISO the California Utilities Commission that an additional 4,700 megawatts of supply is needed but only a portion was authorized on a delayed basis, leaving a gap that couldn't be closed when the heat wave hit.

In theory, massive battery banks could be constructed to store solar and wind power when it's plentiful and supplant hydrocarbon generation altogether, but so far that's just a theory.

Other than laws requiring utilities to increase their use of solar, wind and other renewable sources, however, little of the ISO's vision, which mirrors other official projections, has become reality. The COVID-19 pandemic and the severe economic the difference, particularly recession it spawned will probably retard the conversion to an all-electric society even more.

> For the foreseeable future, therefore, we will need the natural gas generators that environmental activists love to hate, along with the equally vital infrastructure of gas wells and pipelines that they also want to cancel. In fact we need even more of them as demands increase.

Minutes after Berberich's report, Gov. Gavin Newsom took to social media to say that the blackouts are "sobering to the reality" that "more insurance" in power supply is needed and pledged to pro-

However, he must also answer why the Public Utilities Commission, composed of governor's appointees, has failed to heed ISO's warnings about inadequate supply.

Newsom is fond of the word "foundational" to describe things that must be done. There's nothing more foundational than having the lights shine when you flick the switch or air conditioning to function when the mercury soars.

### What Will My Wife's Benefit Be If I Die?

Dear Rusty: I am 76 years old and began collecting Social Security when I retired at the age of 62. My wife also began collecting SS when she turned 62 based on my benefits. She did not work enough to qualify on her own for Social Security benefits. My question is, how much will my wife receive after my death? Will she receive what I receive now, or will it be a percentage of the total that we both receive? Or will it be based on just my benefits alone or some other formula? Signed: An Inquisitive Senior

Dear Inquisitive: Your wife's survivor benefit as your widow will be based upon your Social Security benefit alone. Usually a surviving spouse receives the same amount the deceased



the survivor is already receiving, and if the survivor has reached their full retirement age. However, in your case, if you should predecease your wife there's a special rule which may benefit her because you claimed your benefit at age 62.

That rule says that because you claimed before your full retirement age (FRA), your wife's benefit as your survivor should be at least 82.5% of the benefit you were entitled to at your full retirement age (66), even though you actually claimed at age 62. And because your benefit was reduced by 25% when you took it at age 62, your wife's benefit as your widow may actually be more than you are receiving when you pass. This special rule is known as the "widow limit," which stipulates that a surviving spouse is entitled to the greater of what the deceased was receiving while alive, or 82.5% of the spouse was receiving at deceased's "primary insurdeath, if that is more than ance amount" or "PIA,"

which is the amount due at full retirement age.

Here's an example: If your FRA benefit amount was \$1500/month, then your age 62 amount when you claimed was \$1125. But due to the special rule, your wife would get \$1238 (82.5% of \$1500) instead of the reduced \$1125 amount. Of course, this example doesn't reflect the COLA (cost of living) increases which would have been applied to your benefit over the years, but as your widow and because you claimed before your full retirement age, your wife would be entitled to at least 82.5% of your PIA if that is more than the actual amount you were receiving when you passed.

The Public Housing wait lists are for Marina Vista (1 bedroom units); Alder Grove (1 bedroom units); Walnut Grove (3 bedroom units); and County (4 bedroom units). Public Housing wait list preferences may be given to families who have a veteran family member, are homeless, or who are displaced by natural disaster recognized by the Federal government.

Project Based Voucher wait list preferences are given to families who are homeless or rent burdened; have a family member who is a veteran; have a family member who is disabled, or live or work in Sacramento

internet access to complete the application. There is no cost to apply for housing and a credit report is not needed to apply. However, Sacramento Housing Authority officials caution applicants not to use any other website and do not use a search engine to apply for the wait list. A number of websites charge fees to submit an application and may require personal information such as social security numbers or debit/credit card information to apply for assistance. This is a scam and could lead to possible identity theft. Housing Authority officials advise that the best way to find the correct website to fill out the application is to type www.sacwaitlist.com directly into the address bar usually located at the top left of the browser on the computer screen. The application submission process is supported for modern, popular browsers such as Chrome, Edge, Firefox, and Safari. Mobile devices using modern versions of IOS and Android are also supported.

For only the second time, California was segmented out from the national readings (New York, Texas, and Ohio were the only other states), and while some issues ranked parallel to, or didn't vary widely from, the national readings (cost of health care, federal taxes, property taxes, to name a few), five issues did show a double-digit disparity between how small-business owners across the nation ranked them as problems in comparison to California's Main Street entrepreneurs:

(1) Environmental

regulations ranked 38th nationally, 15th in California for a 23-placement difference; (2) Cost of government required equipment/procedures came in 39th nationally, 19th in California for 20-placement difference; (3) Hiring/firing/employment regulations ranked 43rd nationally, 23rd in California for another 20-placement difference; (4) Obtaining licenses, permits, etc. came in 45th nationally and 29th in California for 16-rank difference; (5) Minimum wage/living wage ranked 34th nationally, 20th in California for a 14-placement difference.

"There were some issues that were of less concern to California small-business owners than they were to others across the nation," said John Kabateck, California state director for NFIB, "but for five of the 75 issues, there was an alarming variance it would behoove state policymakers to give serious consideration to ameliorating. With only a few weeks left in the 2020 session, it's probably too late now, but that leaves four whole months to start laying the groundwork for

An Open Letter to the Citizens of Citrus Heights

Reading recent guest articles and social media content regarding the Citrus Heights proposed MEASURE M has been concerning. It appears some of our residents are not seeing the positive benefits or future growth potential of Measure M. Many were residents who were against cityhood, against starting our own police department, against building the Community Center and finally the City Hall and the Dignity Health Medical Office Building projects. But we have now seen how these successful endeavors have brought benefits and positive change in the social and economic growth to Citrus Heights. I had hoped those issues were behind us. But ironically, life in the Rearview Mirror tends to blur our focus and prohibits a vision for future growth and economic stability.

MEASURE M is a tax proposal that completely benefits the City of Citrus Heights. The funding is not shared with, controlled or managed by any outside group or government agency. It is one cent tax paid by residents and non-residents who shop and dine in our city. It is not a regional tax and funds cannot be spent projects outside Citrus Heights. This is completely opposite of county wide sales tax propositions such as Measure A. Those tax dollars went into a fund managed by the Sacramento Transportation Authority and we should in theory have receive 50-60 cents of each dollar we paid. However, we never received the bulk of the funds due us and are now looking at FY2025 before we receive funding. Yet we continue to pay the half cent sales taxes towards that measure.

In a newspaper article a taxpayer advocate outlined several regional transportation tax proposals, including a new measure in Sacramento County, that have been removed from the ballot. The key to the argument is these were regional road tax funding proposals. The simple fact is

those and prior tax measures failed to provide road repair funding the communities being taxed were promised.

A former Citrus Heights council member recently wrote that based upon their experience on the council there is no need for the proposed tax measure. What is not said is that those experiences were from a time when the Sunrise Mall and other major big retailers provided significant sales tax income that allowed Citrus Heights to build the savings surplus that carried our city through several years without loans or tax increases. Now is the time for viewing our city through The Windshield. MEASURE M will generate the funding necessary to build for the future of our community. In studies and outreach sessions undertaken by the city, the residents have responded with a wish list of projects, shopping, entertainment and recreational facilities that are important for Citrus Heights families. The Sunrise Mall property is just one such multi-use proposal on the list and the city has responded. The future of the Sunrise Mall under new ownership and with significant efforts by our city leadership promises to once again be a focal point of economic, recreational and residential growth and stability for Citrus Heights.

Measure M tax dollars will provide funding to build the envisioned public venues, help meet the needs for road repair and resurfacing projects in our neighborhoods, provide matching funds required to apply for state and federal grants, and save funds for future projects like an animal shelter or community recreational complex. As voters we ask for accountability. The city proposes an Independent Citizen Oversight, mandatory financial audits and transparency for Measure M funding expenditures.

MEASURE M is a long-term view for the future of Citrus Heights. Let's look at our future through the Windshield of possibilities and not the Rearview Mirror presented by some. We need to stay **#CITRUS HEIGHTS STRONG!** 

### Sac County and CARES Act Funding

SACRAMENTO COUNTY, CA (MPG) - The County's Chief Fiscal Officer presented to the Board of Supervisors a status update of the Coronavirus Relief Fund Revenue received by Sacramento County as of June 30, 2020.

What is the purpose of the Coronavirus Relief Fund, and how much funding did Sacramento County receive?

The Coronavirus Aid, Relief and Economic Security (CARES) Act was enacted on March 27, 2020, and with it the \$150 billion Coronavirus Relief Fund (CRF) to help stabilize state, local, and tribal budgets. The relief fund falls under the purview of the U.S. Department of Treasury. Sacramento County received \$181 million from the CRF.

How did the County determine the use of Coronavirus Relief Funds?

The CRF Committee asked departments to identify expenses relating to the coronavirus and approved expenditures that meet the requirements of the Coronavirus Relief Fund.

How much of the \$181 million has been used as of June 30, 2020?

The County has spent \$146.8 million to cover payroll costs for existing employees and services and \$1.2 million in new or enhanced services to address the impact of COVID-19 for a total of \$148 million.

Does that mean that departments who received funds for payroll costs receive additional funds or positions?

No. Departments that received CRF money for payroll costs received that much less in General Fund money. The County then used that General Fund money towards departments and services that are critical to the residents of Sacramento County.

What General Fund departments and services will avoid the budget and services cuts, due to the freeing up of General Fund money?

Departments such as Child Protective and Adult Protective Services; Health Services; Sheriff; Human Assistance; In-Home Supportive Services and homeless services.

Why is it important to fund those General Fund departments?

The County will receive approximately \$170 million less in General Fund revenues in the last and current fiscal year, as a result of the pandemic.

These revenues fund critical social and health services from Child Protective and Adult Protective Services, Health Services (Public Health and Mental Health), Human Assistance, In-Home Supportive Services and homeless services.

Freeing up General Fund revenue that otherwise would have gone to payroll costs will allow the County to avoid significant budget cuts and maintain services for FY 2020-21 that the CRF money could not be used for.

Is covering payroll costs an appropriate use for CRF money?

Yes. The CARES Act does not allow the use of CRF money to backfill revenue losses directly, but CARES Act guidance clearly says that payroll costs for public safety and health, human services and similar employees can be used for CRF.

Has the use of the CRF money in this way prevented the County from using it to fight the pandemic?

No. All of the CRF funding requested by Public Health staff to deal with COVID-19 has been provided.

How has the remaining CRF been approved?

The remaining CRF money has been approved for services identified as needed by Public Health and other departments,

COVID Testing; Community-Based Testing; Dine at Home Sacramento Programs; Contact tracers; Homeless Response Plan; Business Navigators; Project Roomkey

How will the County cover costs for services needed for the pandemic after the County's CRF allocation has been fully spent?

The County will continue to work at the State and Federal level to obtain additional funding. The State budget commits a portion of the State's CARES Act funding to local governments over and above the \$181 million already allocated to Sacramento County. The County has received \$5 million to date and has been allocated \$25 million. Discussions at the Federal level also suggest there could be additional funding provided for testing and other services required to respond to the

Are there other funds that the County is using to combat the pandemic besides CRF?

Yes, the County is utilizing a variety of state and federal funds besides the Coronavirus Relief Fund to cover costs incurred by the pandemic, so items that were not eligible for CRF may be eligible for those other state and federal funds.

You fell hundreds of is nothing wrong with falltimes while learning to walk. Yet, you got back up each and every time. Each fall was a learning experience, not an indication of failure. A fall leads to failure only when you decide to not get up.

Once you have learned to walk, how many attempts were required was irrelevant. All that mattered is you got up one more time than you fell. Learning to walk is impossible without falling. Similarly, any success in life involves falling as well.

However, falling is scary because it is associated with failure. Since we have an innate fear of failure, we focus on the fall instead of the recovery. ing, you don't want to fall twice for the same reason. Once you have identified the cause for a fall, decide how to avoid repeating it.

You are in command of your life. No other person or circumstance is responsible. Blaming external factors for a fall makes it harder to get up. Getting back on your feet is in your hands. Take responsibility, take control, and do what it takes to stand up.

Staying down is agonizing. You won't get back up until you make it happen. It's your choice whether to get back up or not. Waiting for things to improve accomplishes nothing. Effort and determination are essential for an effective recovery mindset.

Once you have fallen, think about all of the reasons for getting back up. Don't waste time with any excuses for not doing so. People who fail to get up have numerous excuses justifying why they can't. Since your mind believes whatever you tell it, you won't accomplish anything you believe is impossible.

A possibility mindset powers your success. You have to believe in your goals in order to attain them. Having a burning desire to reach your objective is a powerful force. When learning how to walk, failure was not an option. You were determined to succeed and had

Each fall leads to new opportunities. When a strategy doesn't work as planned, you are compelled to discover a new approach. There is always a better way. That's why falls are so educational. The more you fall, the more you learn.

Only positive action is worth taking. Avoid any action which harms others in any way. Ethnical or moral shortcuts ultimately lead to disaster. They are a dead-end road which leads off a cliff. Avoid associating with anyone who offers assistance at the expense of others.

Get back up with a specific plan for moving forward. Just like learning how to walk, your next step is the most important one. No magic is required. Any goal is reachable one step at a time. History has proven this fact repeatedly.

### **Newsom Exploits Health Crisis to** Free Thousands of Convicted Felons

SACRAMENTO, CA (MPG) - Senate Republican Leader Shannon Grove (R-Bakersfield) released the following statement in response to Governor Newsom's expansion plan to release additional convicted felons from four separate correctional facilities. According to a recent article published in The San Francisco Chronicle, the Governor's early release plan could free at least 50,000 convicted felons which is nearly three times the original figure as reported in the media.

On March 4, Governor Newsom ordered the mandated shutdown of California. Under the guise of the crisis, the Governor has granted the early release of 18,000 convicted felons. He now has ordered the California Department of Corrections and Rehabilitation (CDCR) to expand the early release program to include four additional correctional facilities.

"Once again Governor Newsom and his liberal administration choose convicted felons over victims' families and law-abiding Californians. Governor Newsom has already released over ten thousand prisoners early and California's reentry system is already having trouble finding housing, food and other re-entry services for the released prisoners."

"Instead of focusing on releasing criminals from prison early and over whelming communities with thousands of unhoused and dangerous felons, Governor Newsom should focus on securing the energy grid, stopping these rolling black-outs, and protecting our law-abiding citizens and families," said Senate Republican Leader Shannon Grove.

**SACRAMENTO COUNTY, CA (MPG)** - This past February, the Sacramento County Board of Supervisors voted to authorize the establishment of the American River Bike Patrol to watch over the bike trails on the American River Parkway. The volunteer Bike Patrol, organized by the National Ski Patrol (NSP), has recruited and trained members and began patrolling the trails in July.

The patrol's 55 volunteer members were trained by the NSP in first-aid, CPR and basic bicycle repair. Regional Parks Rangers helped to train volunteers on expected trail etiquette. All volunteers are required to wear a volunteer bicycle patrol uniform, distinguishing themselves from regular users of the trail. NSP coordinates bicycle trail volunteer schedules with Regional Parks.

"We are excited for these volunteers to hit the trails to help teach trail users about trail safety and etiquette," said Liz Bellas, Director of Regional Parks. "We have seen an increase in new trail users this year and these new users don't always know proper trail etiquette, which can be dangerous for other trail users. The Bike Patrol members will be great educational resources."

"We are delighted to be part of the Parkway team and our agenda focuses on safety; safe cycling, safe walking and family enjoyment on the trail," said Jim Cheng, Bike Patrol Representative.

Members of the Bike Patrol will act as trail ambassadors providing directional advice, equipment assistance, safety insights and bike safety programs, assistance with events and first-aid services.

Similar volunteer trail programs exist throughout the state, including the American River Parkway Equestrian Patrol, Fort Ord Friends, East Bay Regional Park District Volunteer Trail Safety Patrol, Oakland Bike Patrol, Santa Monica Mountains National Recreation Area Mountain Bike Patrol, Marin Open Space Bike Patrol, and Tahoe Bike Patrol.
