Board Ratifies Local State of Emergency

SACRAMENTO COUNTY, CA (MPG) - The Board of Supervisors unanimously approved the ratification of the Local State of **Emergency Proclamation** for Civil Unrest. The County will review the need for continuing the local emergency at least every 60 days.

With the ratification and letter to the Director of the California Office of Emergency Services, Sacramento County is asking the Governor to Proclaim an Emergency for Sacramento County, along with authorization for California Disaster Assistance Act funding. With the ratification and letter, the County is also asking for a Small **Business Administration** Declaration to provide loans to support businesses that sustained economic injury due to civil unrest beginning and after May 30, 2020.

The proclamation went into effect retroactively to May 30 because of civil unrest in Sacramento that resulted in damaged storefronts, looting activity and property damage. Preliminary damage estimates indicate a dollar loss of \$10,030,000.

The proclamation does not call for additional National Guard troop deployment to the area beyond those that arrived last week to assist with local law enforcement agencies. Additionally, the County did not enact a curfew with the proclamation. Both items are made clear in the Board of Supervisors' Resolution.

According to First District Supervisor and Chairman of the Board Phil Serna, "It was obvious to all of us that we needed to make expressly clear what our intent is and what it is not. The actions, in fact, are the first steps to assure our access to state resources to help small businesses affected by recent violence, and to also protect our General Fund a budget that is already severely stressed by the onset of the pandemic Continued on page 5

SACRAMENTO REGION, CA (MPG) - Six hundred goats recently joined the morning Fair Oaks Boulevard commute. Accompanied by whistles, barks and bleats, 2400 hooves beat a rapid tattoo through Schweitzer Grove (Carmichael) to board stock trucks. A short ride later, the bearded dayworkers were munching weeds near Bannister Park (Fair Oaks). Once that two-week riverside picnic was behind them, they moved to Rollingwood, Orangevale.

The gentle mowers also cohabit well with wildlife - they don't hurt ground-foragers like quail or turkey chicks. They devour invasive vegetation - blackberry and thistles are a particular delight and their droppings return nitrogen to the soil. While machines spread seeds to germinate elsewhere, ruthlessly grinding caprine teeth reduce kernels to pulp.

Though his livestock has fulfilled many Sacramento County contracts, the passage of Fair Oaks' century-old truss bridge presented a picturesque challenge. "It's a bridge with so many pedestrians and cyclists," explains Gregory. "We don't worry about how the goats will manage - they move well as a herd - our concern is how people react to them. Fortunately, eating's their favorite thing to do. That's what gets them across bridges so smoothly. They're all led by their stomachs."

The City of Citrus Heights Mid-Cycle Budget Update



A Message from City Manager Chris Boyd

Dear Citrus Heights Residents.

Citrus Heights City staff presented a mid-cycle budget update to City Council last night. As part of our commitment to government transparency, staff provides regular updates during our newly adopted two-year budget cycle to Council. The presentation detailed the City's lean operating budget, stark projections related to the economic effects of COVID-19, and reflect serious impacts the immediate actions staff have taken to mitigate certain impacts, consistent with our tradition of fiscal prudence.

City staff started the presentation by taking a step back to look at budget projections prior to COVID-19. The previously approved budget for Fiscal Year 2019/2020 estimated the City's General Fund would have a shortfall of \$1.4 million. This anticipated deficit has been consistently reported by staff and is primarily due to the property tax agreement required by the County to allow our City

The 2019/2020 shortfall required a plan to draw from the City's existing line of credit, in order to balance the budget while continuing to provide essential services. especially true during the COVID-19 public health crisis. Due to the pandemic, many more families requested plots in the garden, so Elijah helped build new planter boxes to expand the facility and make room for the new families. "I try to do the best of my ability - doing the best for them so they get the best out of it," said Elijah.

Elijah first realized the significance of community service in the summer of 2018. While visiting friends in Redding, CA, the Carr Fire burned through Shasta and Trinity counties, burning more than 229,000 acres. Elijah and his friends helped transform a church in Redding into a "cool down center" for evacuees. After rushing to unload water and clothes, Elijah stayed for another week helping evacuees on site. "It was chaotic. People were crying," said Elijah. "It was difficult." But he said that experience opened his eyes: "When people need it the most, give everything you can to help them. ... No matter how small, every bit helps."


Elijah is now an integral volunteer at Sylvan Ranch Community Garden, helping people maintain their plots as well as tending to the community plots. He often ends up staying longer than he planned because there is always more to do. When Elijah commits to helping someone, he always follows through: "I'm going to keep my word, and work until

Judy Thornton, a long-time volunteer gardener at Sylvan Ranch Community Garden, said Elijah's assistance is invaluable to many of the elderly gardeners: "They couldn't do it without him helping them. ... He's made it so these people have a garden bed and can enjoy gardening. He's always will-

Elijah described his volunteer work as "humbling." The people he helps are incredibly grateful, and Elijah said, 'When it means a lot to them, that means a lot to me."

"He's always going above and beyond," said Fawny Vernon, Elijah's mother. "I am so proud of him. ... He's taken it on as his own personal mission." She admires his determination and his commitment: "The character he's built, the strength I see in him - he puts others first. He's amazing." She said many of his friends and teammates look up to Elijah, so she hopes his work can inspire other students to follow in his footsteps.

Elijah will be attending Sacramento State University in the fall, but with the COVID-19 complications, he will likely be commencing his studies through online courses. He plans to major in business, and he is hoping to play baseball at the college level.

I was dressed as a soldier under the command of my target, a cartoonishly evil Moroccan general, whose hunger for power made him almost as dangerous as the elite squad of bodyguards that protected him at all times. I was exploring his base, my outfit ensuring I don't raise suspicions. I stumbled upon two soldiers are talking about the general, insulting his lack of combat experience or honor. Little did they know that their conversation was just a little too close to the microphone of the base's

intercom system. This was my chance. I subtly turned on the intercom system, and the soldiers' slander was suddenly broadcasted to the entire base. It was only a matter of time before the general himself arrived to chastise his undisciplined subordinates. I leaped through a window into a nearby alley and waited, weapon drawn. Within a few minutes the general arrived. Before he could start speaking I landed a single shot and took out my target. I began sprinting down the alleyway, alarms blaring and bodyguards on my tail. There was nowhere to hide. I smashed through a door and slammed it shut behind me as my status changes from "suspicious" to "hunted." Bewildered guards at the entrance to the

base let me run past without confrontation and I faded into the crowded Moroccan market. Out of the corner of my eye I spotted a mechanic ducking into an unobserved kitchen. I followed him, lugged a pool ball at his head (it's mean, but he'll wake up alright in a few hours), and swapped my soldier fatigues for his uniform. I've vanished.

Miniature James Bond novels like the one above are the lifeblood of *Hitman*. a reboot of a long-running series that places you in the shoes of a globe-trotting conspiracy-unraveling assassin. The game drops you into enormous environments with little to no guidance, asking you to take out your target by any means necessary. Silent, creative play is rewarded; kill your target (and only your target) without anyone ever knowing you were there and you maximize

But achieving the envied perfect kill might often appear to be an insurmountable challenge. It was this challenge that drew me to the game in the first place. Though I'm usually drawn to high-octane low-brainpower action games as a way to relax after a hard day of schoolwork, the lack of mental stimulation in quarantine had me searching for something more intellectually substantial. Playing Hitman scratches this itch, as the short bursts of adrenaline like the story above are often preceded

by upwards of half an hour of quiet exploration and scheming.

And the game itself encourages these meticulous best-laid-plans. Tantalizing opportunities, like the soldiers talking a bit too close to the intercom mic, appear at every turn. Noticing a winch that allows you to drop a chandelier might spark ideas on how to lure your target underneath one. Knocking out and assuming the identity of a security guard who stepped out to smoke provides a way to infiltrate entire new areas without suspicion. Each of these potential opportunities leads to more opportunities, creating a spiraling network of complexity that comes together in a single, magical moment when a flawless plan is perfectly executed.

Satisfying moments like the ones *Hitman* delivers are why many of us came to games in the first place. My girlfriend, usually uninterested in my violent digital escapades, was cheering along as I sprinted down the alley, all the while pointing out opportunities for escape that I might have missed. Games are best when they don't create memorable moments, but when they allow you to create those moments for yourself. And in this sea of similar games that I trudge through with a brainless grin, Hitman's encouragement to introduce my mind and my creativity to the experience makes all the difference.

Why is My Medicare Part B Premium Over \$400 Monthly ... I Was Laid Off!

Dear Toni:

Been reading your articles regarding COVID-19, being laid off and enrolling in Medicare properly. I have not read an article on how to lower the premium if you are not making the income you were before you were laid off.

I received a letter from Social Security stating that I must pay \$462.70 for Part B and \$70.00 for Part D, totaling over \$532.70 monthly.

I was recently told that you understand Medicare rules and I could possibly appeal my Medicare premium because I am not working full-time with an income of \$350,000; instead only receiving a \$2,400 monthly Social Security check.

What do I do to appeal this decision and bring my Medicare premium to a lower, affordable amount?

Do you want to wait 2 years for the IRS to inform Medicare that your income has decreased due to being laid off or do you want to let Medicare know that you have lost your job and are no longer making the kind of income you

were making?

Your MAGI was over \$320,000 and the table used in the letter you received from Social Security shows what the Part B and Part D premium adjustment (nice way of saying it's going to cost you more) will be, whether you are filing single or married.

Most retirees do not realize that they have special situations also known as life changing events that can lower your "income related monthly adjusted amount" (IRMAA). Below are a few of the life changing events that can make your income go down:

- You have gotten married or divorced, or your spouse has died.
- You or your spouse have stopped working or have reduced your hours.

- · You have lost property that you were making money from due to a disaster or other event beyond your control; or
- You or your spouse's benefits from an insured pension plan stopped or went down.

Use form SSA-44 titled "Medicare Part B Income-Related Premium -Life-Changing Event" and attach the original documents or certified copies to verify your change in income.

Once Social Security is satisfied with the evidence, it will update its records and correct Part B and Part D premiums to what your current income is.

Don't forget a onetime increase in your income such as property that is sold or cashing in your IRA or even winning the lottery(aren't we wishing for that) can change your monthly adjusted gross income (MAGI) that may cause you to pay a higher Part B or Part D premiums.

**Social Security reviews your income each year and will adjust your Part B and D premiums to your new income level the next year and again you will want to file SSA-44 form until your income finally comes down to the lower amount.

Governor Newsom Announces New Policing and Criminal Justice Reforms

SACRAMENTO, CA (MPG) - After a week of engagement with civic leaders and law enforcement in the wake of the killing of George Floyd and demonstrations nationwide, Governor Newsom announced his support for new policing and Black Caucus, the criminal justice reforms. Governor Newsom will work toward a statewide standard for policing peaceful protests and ending the carotid hold. This announcement follows the work California did last year to enact the nation's strongest standard for police use of deadly force.

"We have a unique and special responsibility here in California to meet this historic moment head-on," said Governor Newsom. "We will not

sit back passively as a hold be removed from state. I am proud that the state police train-California has advanced a new conversation about training materials. He broader criminal justice committed to working with reform, but we have an extraordinary amount of work left to do to manifest a cultural change and a deeper understanding of what it is that we're working to advance. We will continue to lead in a direction that does justice to the message heard all across this state and nation."

Governor Newsom called for the creation of new standards for crowd control and use of force in protests. Governor Newsom committed to working with the Legislature, including the California Legislative California Latino Legislative Caucus and other legislative leaders, in consultation with national experts, community leaders, law enforcement and journalists to develop those standards – much like the collaboration that produced AB 392 last year, California's nation-leading use-of-force bill.

Additionally, he called for the end of the carotid hold and other like techniques in California, directing that the carotid ing program and state the Legislature on a statewide ban that would apply to all police forces across the state.

Criminal justice reform has been a key priority of Governor Newsom's first year in office. He placed a moratorium on the death penalty, citing racial and economic disparities in how it was applied. He proposed to close the Division of Juvenile Justice and proposed closing two state prisons. In his May Revision budget, Governor Newsom proposed expanding opportunities for rehabilitation and shortening prison time for offenders participating in treatment programs, in education programs and otherwise engaging in good behavior; as well as increasing access to higher education for young people who are incarcerated.

Governor Newsom acknowledged that more action is needed, and stated that additional reforms around police practices, educational equity, economic justice, health equity and more must be addressed with urgency.

the protection of both marchers and the community.

Asking Modkins where he got the idea for this event in Citrus Heights, he explained 'protest' to him means, "peacefully fighting for what you believe in". "I had the urge to go downtown (Sacramento) but was not allowed to. I thought, what if I brought the protest out here in this type of community where there hasn't been anything like this, especially when injustices happen. There should be more bringing police and the community together for better communication." His goal and passion is to bring understanding for where both sides are coming from.

Prior to the start of Saturday's event, Modkins began with a prayer for God "to bring safety and peace, and justice to this march". Speaking on a bullhorn to the 100+ participants he reiterated that this was to be a peaceful march. "We're here to make a change not to bring ourselves down to the level of those against us.

Putting into words the feelings of those who have not felt the sting of discrimination, Kelly Christianson of Fair Oaks held a sign which read, "I understand that I will never understand, but I stand with you."

At one point, marchers split up, walking on both sides of the street to the exuberant honking and thumbs up of drivers in support of the cause.

At City Hall, participants and speakers knelt and took 8 minutes – the time it took for Floyd to die under the knee of Derek Chauvin - to read the names of other victims of police brutality.

Organizers made sure there was ample water throughout the day and snacks following the one hour, 4.4-miles hike in over 70-degree temperatures.

Police presence on both days was understated but effective. Following Friday's protest, Citrus Heights Police Chief Ron Lawrence said in a statement on social media (which also applied to Saturday's march), "Although we expected the march to be peaceful, we always want to ensure the safety of community members exercising their freedom of free speech and right to peacefully assemble."

"We were requested by the group to assist as they crossed the street of Sunrise and Greenback. Although the march stayed mostly on the sidewalk, during the march, we maintained traffic safety in the lane adjacent to the side walk to avoid any vehicle and pedestrian conflicts if the protesters stepped off the sidewalk into the roadway.

"The police department is committed to traffic safety and the safety of our community and we appreciate the cooperation and communication with the organizers of the march. The organizers helped ensure that those involved remained peaceful. We want to thank our community for their continued support of their local police department."

With Modkins, Morris and other youth and their mentors involved in making this weekend a reality, their continued persistence will bring the safety, peace and justice this generation is looking for closer to becoming a reality.

Additional Charging Decisions Related to Acts of Looting

Sacramento County District Attorney's Office

SACRAMENTO, CA (MPG) - On June 3, 2020, the Sacramento District Attorney's Office received thirteen reports relating to looting from law enforcement agencies to review for filing of criminal charges. All events took place in the late evening hours of May 31st to the early morning hours of June 1st. Charges were filed in all of the cases received including:

- (1) At midnight, several subjects were located inside the Sunrise Mall. One of the female adult suspects admitted to driving six juveniles to the mall. She also admitted that someone broke glass and she went inside. They went to the Vans store, but then heard police and ran. Several boxes of new shoes were found in her trunk. The second suspect was found in a car parked at the mall just outside of the broken glass point of entry. When police arrived, she fled in her car and took police on a threemile pursuit. Both were charged with commercial burglary, looting, and receiving stolen property. The second suspect was also charged with reck-
- less evasion of a peace officer. (2) At 12:00 a.m., a male adult suspect was observed fleeing Walgreens

- located at 2201 Arden Way. He was stopped nearby and in possession of stolen items. He was charged with commercial burglary, looting, and receiving stolen property.
- (3) At 2:30 a.m., two male defendants were observed trying to break into Paradyme on 1720 Fulton. They were charged with attempted burglary and attempted looting.
- (4) At 2:50 a.m., a male adult suspect and a female adult suspect were observed fleeing a Boost Mobile store located at 6176 Auburn Blvd. Their car drove off as officers approached, reached speeds in excess of 100 mph and ran a red light. An infant was located in a child seat in the rear of the car. They were charged with commercial burglary, looting, reckless evasion of a peace officer, child endangerment, and receiving stolen property.

As was stated in previous releases, the Sacramento District Attorney's Office supports every citizen's right to lawfully exercise their first amendment right to protest, particularly in these painful times. At the same time, we will also zealously prosecute those who choose violence, looting or lawlessness over peaceful protest thereby creating a threat to public safety and the well-being of our community.





Legislative Democrats Pass Incomplete State Budget with \$9 Billion Tax Increase

SACRAMENTO, CA (MPG) - Senate Republican Leader Shannon Grove (R-Bakersfield) issued the following statement after legislative Democrats passed a fake budget bill, Senate Bill 74, just to meet state and constitutional deadlines.

"The state is facing a government-induced recession with more than 4.8 million unemployed Californians and a budget deficit of \$54 billion." Despite this economic crisis, the Democrats' backroom budget deal has prioritized pet projects and includes a \$9 billion tax increase on our job creators.

"Today's incomplete and poorly prioritized budget is the result of last-minute discussions that lacked public transparency. Californians deserve better," said Senate Republican Leader Shannon Grove.

As presented, SB 74 is a budget riddled with bad accounting practices and does not prioritize the needs of California families and job creators. The Governor and Legislative Democrats' Budget include:

\$22 million to enforce the anti-worker law (AB 5, 2019) forcing more people out of work, even though there are more than

4.8 million residents on unemployment now; \$5 million to buy a new state park even though the Governor has prevented people from going outside; \$2.9 billion to continue the high-speed rail project, despite more cost increases, project delays, and a \$54 billion state budget deficit; \$9 billion in new taxes on businesses, even though thousands of businesses are barely staying afloat or being forced to close due to the stay-at-home order; Lastly, the Governor and legislative Democrats are relying on billions of dollars from the federal government-yet the Governor allocated \$6.5 million to sue the federal government.
