

All-Time High Raised by Gas Tax SACRAMENTO REGION -

SACRAMENTO REGION – George Runner, BOE, recently announced that California motorists paid a record \$8.3 billion in state and local fuel taxes during the 2011-12 fiscal year. "Our latest numbers show that high gas prices resulted in a record windfall for government at the expense of California consumers," said Runner. "It's bad enough that California's gas tax is among the highest in the nation. It's even worse that gas tax goes up whenever gas prices rise."

From July 1, 2011 through June 30, 2012, the California State Board of Equalization collected \$6.9 billion in motor vehicle fuel taxes, up from \$6.7 billion the prior year. Excise tax revenues accounted for \$5.2 billion, while sales tax revenues accounted for \$1.7 billion. Over the same time period, the state collected \$1.4 billion in diesel fuel taxes, up from \$1.2 billion the prior year. Excise tax revenues accounted for \$343 million, while sales tax revenues accounted for \$1.1 billion.

"What's particularly concerning about these numbers is that they would have been even higher had the Governor been successful in extending the higher sales tax," noted Runner. Had the 1% temporary sales tax not expired on July 1, 2011, Californians would have paid an additional \$96 million in diesel tax last fiscal year. Furthermore, California's 2010 fuel tax swap law would have required a larger motor vehicle fuel excise tax rate increase, costing Californians more than half a billion dollars extra in the 2012-13 fiscal year.

According to the American Petroleum Institute, California's gasoline taxes and fees, averaging 68.9 cents per gallon, and California's diesel taxes and fees, averaging 77.1 cents per gallon, both rank second highest in the nation. Among these taxes

and fees are a federal excise tax of 18.4 cents per gallon, a state excise tax of 36.0 cents per gallon (up from 35.7 cents effective July 1) and a sales tax averaging 3.12% when local taxes are included.

Notably, the sales tax is calculated on the total price of the fuel sale including excise taxes, resulting in double taxation—California consumers pay a tax on a tax. For diesel, the federal excise tax is 24.4 cents per gallon,

the state excise tax is 10 cents per gallon (down from 13 cents effective July 1) and the sales tax is 9.42% (up from 9.12%) plus applicable local taxes.

A Vietnam Veteran's First Thank You After 50 Years

CITRUS HEIGHTS-Thousands of stories of war, from front line battles to those of crucial non-combative service, live on in the memories of Veterans living in our City, and through loved ones of those deceased. Some of these follow here.

I met Jacob D. Alger, 21, following the 2012 Memorial Day service at Mount Vernon Memorial Park in Fair Oaks.

I had noticed a young man far in the distance amidst hundreds of waving flags, dressed in a blue Union uniform and kneeling at one of the cemetery plots. Curious about the uniform and wondering, "what his story is",

I worked my through the flags and around the gravesites to the young man and we began talking. Alger explained he was in uniform as he is a Civil War Reenactor and had hoped to make it to a Red Bluff Memorial Day event, but decided to attend instead the service at Mount Vernon. There was plenty of history surrounding his visit.

Two members of his family: his mother's great grandfather and father's grandfather are buried at Mount Vernon, and he and his brother, Logan, were visiting their gravesites.

Like many families in Citrus Heights and surrounding areas, Alger comes from a long line of brave men and women who have served their country for generations, in many diverse ways, and in almost every one of our wars and conflicts.

His mother's great grandfather devoted his career to the Marines as an Artilleryman. He served on one of the famous amphibious Ducks (DUKWs) in WWII where he fought in the Battle of Guadalcanal to protect it and surrounding islands from re-invasion by the Japanese.

RT Introduces New "City Ride" Shuttle Service

New Service Offers "Dial-A-Ride" for the General Public

CITRUS HEIGHTS - On Monday, October 29, 2012, the Sacramento Regional Transit District (RT), in partnership with the City of Citrus Heights, began operation of a new shuttle service for travel in Citrus Heights called "City Ride." City Ride offers curb-to-curb, "dial-a-ride" service for the general public to and from any destination within the city of Citrus Heights and Mercy San Juan Medical Center on Coyle Avenue in Carmichael. In the near future, RT also plans to offer service to Kaiser Medical Offices on Riverside Avenue in Roseville.

City Ride operates on week-days from 7 a.m. to 7 p.m. Reservations are required and can be made by calling 916-556-0258 (during service hours) no earlier than one business day in advance. Reservations are taken on a first-come, first-served basis. Regular RT Basic and Discount fares apply.

City Ride shuttle buses, which can seat 12 to 14 passengers with space for two wheelchairs, are identifiable by the special vehicle exterior featuring photos of Citrus Heights amenities and destinations.

"Residents of Citrus Heights will benefit from City Ride and other bus service improvements implemented in September as part of TransitRenewal," Mayor Jeff Slowey, City of Citrus Heights, stated. "The City of Citrus Heights continues to work closely with RT on the implementation of TransitRenewal, RT's comprehensive operational analysis, which will improve transit service in Citrus Heights and connections throughout the Sacramento region."

Citrus Heights City Ride is RT's first collaboration to implement a dial-a-ride type of service for the general public. RT currently contracts with Paratransit, Inc. to provide a similar dial-a-ride service dedicated for individuals with disabilities.

"Citrus Heights City Ride is a great opportunity to offer a brand new transportation option that offers more convenience and flexibility for customers," Mike Wiley, General Manager/ CEO, stated.





A Veteran's First Thank You

Her grandfather served in the Air National Guard during Vietnam as a Decoder, intercepting, sending and receiving critical information during Vietnam and the Cold War.

On Alger's father's side, his great grandfather served in the Army during WWI protecting the then U.S. colonies of the Philippines during the 'Philippine Insurrection'. He served with a coastal artillery crew, setting up artillery regiments from the Philippines to San Francisco and up and down the Pacific coast. He is buried at the San Francisco Presidio.

Finally, his grandfather, Daniel Alger (I), was a Quartermaster on a sub chaser off the Aleutians in Alaska. He served for 6 years and enjoyed his service but Jacob shares that his grandfather struggled with all the killing. Out of respect, Jacob's father, Daniel II did not enter the service and has been serving as a firefighter with Sacramento Metro Fire for over 23 years. However, Alger's brother Logan at 16 years is preparing for possible military service by serving as a Cadet in the U.S. Air Force Auxiliary, the Air Civil Patrol. Alger himself has served with the Army Reserve and is planning to return shortly.

After relating his family's

extensive military service, Alger told me a story that had recently reinforced even more his admiration for all who serve, and has strengthened his own resolve to return to duty. The story is as follows:

"My father was in the hospital because he had broken both of his heels about 2 years prior. Following reconstruction he had experienced complications, which is what he was being treated for. My family was there to pick him up. We were put in this little waiting room at Sutter. We were all sitting there with a couple of other families, when another family came in.

I noticed this gentleman had a Vietnam vet's cap on and I've always supported the military. I come from a family who has ancestors that have fought in all the previous wars. So when the nurse came to take us to see my father, I walked up to him and held out my hand and I said, "Sir I just want to thank you for your service, it really means a lot to me." He looked up at me and said, "thank you" and I walked out.

Later, the nurse stops us in the hall and asks us to wait there. Soon I see the man coming out of the waiting room. He comes up to me and says, "You are the first person to ever thank me for my service. No one has ever thanked me for my service, to

this day, even when I came back from Vietnam. You don't know how much that means to me.""

Alger added, "And to me, that is why supporting the military has always been strongly embedded in me, these people deserve to be honored."

Following the story, Jacob explained his interest in our veterans stemmed from his family's active involvement in the Services.

These stories are just a few represented by the thousands of tombstones and grave markings of our Veterans from the Spanish-American War to today's conflicts in the Middle East. They could be told by families of Veteran's interred at more than a dozen cemeteries in Sacramento and immediate surrounding counties.



DMV: Ask "George"

Expert Answers to Common DMV Questions

Do you have questions about general driving related requirements like registration and insurance?

Are you unclear about laws and restrictions related to driving? The California Department of Motor

Vehicles has answers. "Save Time by Going Online," at www.dmv.ca.gov.

Q: I was involved in a collision for the first time last week and had no idea what I was supposed to do. What steps should I take?

A: Being involved in a traffic collision can be very traumatic, especially your first one, so it is normal to feel overwhelmed. After any type of vehicle DMV within 10 days collision, no matter how minor, you must stop. Otherwise you may be convicted of "hit and run" and could be severely punished.

At the scene of a crash, it is important to show the following information to the other driver or persons involved, or to any peace officer.

- Your driver license
- Registration card
- Evidence of insurance
- · Your current address

If you hit a parked vehicle or other property, try to find the owner. If you can't find the owner, leave a note with your name and address (and the name and address of the owner of the vehicle you are driving, if different) and securely attach it to the vehicle. Report the collision without delay to the city police or, in unincorporated areas, to the Highway Patrol.

Following a crash, you or your insurance agent, broker, or legal representative must do the following:

• Move your vehicle off the street or highway. If you do not move your vehicle or have it removed from the street or highway, any peace officer or authorized personnel may have your vehicle removed and impounded

• If someone is killed or injured, report the collision to the police or Highway Patrol within 24

• If there was more than \$750 in damage to the property of any person, or anyone was injured or killed, report the collision to the

The DMV has a brochure on what to do in the case of a collision. You can find it online at www.DMV.ca.gov.

Q: I am moving out of state. I know I need to re-register my vehicle. Should I notify California DMV that my car will no longer be in the state?

A: As with any time you move, you should report this change of address to the DMV using a Change of Address form. Save time by going online! This can be accomplished at http:// www.DMV.ca.gov/online/coa/ welcome.htm!

Please also notify DMV, in writing, to report that the vehicle was removed from California and will be registered in another state or country. Your letter **must** include the following information:

- California License plate number, and/or,
- Vehicle identification number,
- Date vehicle left California (MM/DD/CCYY), and mail to: DMV

Q: Is it possible to "remove" points from your driving record?

A: Points are not something you want on your driving record, and they can be assigned as a result of collisions or traffic tickets. Generally, collisions where you are at fault are one point and tickets are between one and two points.

The only way to remove points from a driving record is to wait. Most points stay on your record for three years. Depending on severity, points may stay on your record for up to 10 years.

To avoid accruing points, always follow the traffic laws and avoid reckless behavior. Be certain that you are driving defensively and never distracted while on the road. Keep this advice in mind, and you will be able to keep points off of your driving record!

Home Invasion on Pearl Way

CHPD Special Report

CITRUS HEIGHTS - On October 26th, 2012 at approximately 2026 hours, officers from the Citrus Heights Police Department responded to a report of an interrupted residential burglary in the 8400 block of Pearl Way. Initial reports were that the homeowner discovered the suspect inside her home. The suspect fled the home in what was later confirmed to be a stolen vehicle. Witnesses observed the suspect crash the stolen vehicle into a telephone pole at the intersection of Twin Oaks Avenue and Mariposa Avenue. The suspect then fled on foot into a nearby residential area.

Officers from Sacramento County Sheriff's Department, Roseville Police, Placer County Sheriff's Department, and California Highway Patrol arrived on scene to assist with a

perimeter to contain the suspect. A short time later, a resident from the 7600 block of Roberts Lane reported the suspect had just forcibly entered his home and made threats to shoot the people inside. The resident said the suspect stole the keys to his vehicle. The resident was able to flee his home, but said his elderly parents were still inside with the

Officers in the helicopter spotted the suspect fleeing the rear of the home towards Twin Oaks Avenue. The people inside the home were not injured. The suspect continued northbound and was seen by the helicopter entering an enclosed patio of a residence at 7600 block of Twin Oaks Avenue. The home

was occupied at the time by two people who hid inside a locked bathroom.

Several announcements were made over a loud speaker for the suspect to surrender. Officers on the ground spotted the suspect exiting the patio. Officers moved in on the suspect and took him into custody without incident. The occupants of the home were not injured and there were no additional suspects.

The suspect was later identified as: Daniel Travis Tinney (09/21/1989) of Fair Oaks.

Tinney was booked into the Sacramento County Jail for the charges of burglary, home invasion robbery, stolen vehicle, and attempted stolen vehicle, possession of stolen property, resisting arrest, and controlled substances.

CASE: Jose Gomez (11/2/12)

PROSECUTOR: Deputy District Attorney Sonia Martinez

District Attorney Jan Scully announced today that Jose Gomez was convicted by jury on 12 counts of child molestation and child sex assault charges. The jury also found true a multivictim allegation. Gomez sexually abused a female relative from the age of 4 to the age of 10. The assaults included forcing the victim to perform sex acts on him and eventually to Gomez having intercourse with her. Another female relative disclosed that Gomez sexually assaulted her when she was 8 years old. Gomez had also abused a third female relative when she was between the ages of 3 and 5 years old. The three young victims each testified against Gomez, resulting in guilty verdicts on all counts. Gomez faces a possible maximum sentence of 113 years to life in prison. Sentencing is set for December 7, 2012 at 9:00 a.m. in front of the Honorable Judge Helena Gweon.

CASE: Joe Orosco (11/2/12) PROSECUTOR: Deputy District Attorney Tim Carr

District Attorney Jan Scully announced today that the Honorable Judge Russell Hom sentenced 69-yearold Joe Orosco to 30 years to life in prison. On August 22, Orosco was convicted by jury of two counts of lewd and lascivious acts with a minor with a prior conviction allegation.

Orosco molested a 7-year-old female family member in 2011. He had previously been convicted of lewd and lascivious acts with a minor in Yolo County in 1986.

CASE: Carlton Reid (10/31/12)

PROSECUTOR: Deputy District Attorney Anthony Ortiz

District Attorney Jan Scully announced today that Carlton Reid was convicted by jury of first degree murder and a gun enhancement for the shooting death of Gregory Lewis.

On June 5, 2010 at approximately 1:40 a.m., the Sacramento Police Department received 911 calls regarding shots being fired at 2415 Northgate Boulevard. A caller stated that his father had been shot in the 7/11 parking lot. Responding officers found Gregory Lewis lying on the ground with multiple gunshot wounds. He was transported to UCD Medical Center where he was later pronounced dead. Upon questioning by law enforcement, the victim's son stated that his father was arguing with someone on his cell phone and set up a meeting with them at the 7/11. He and his father then drove to the convenient store and waited in the car. When the person arrived, his father got out of the car and the two men began to struggle. The person then pulled out a gun and shot his father several times. After a thorough investigation, including interviews and reviewing surveillance video and cell phone records, Reid was identified and arrested.

Reid faces a maximum potential sentence of 50 years to life in prison. Sentencing is scheduled for November 30, 2012 in Department 40 before the Honorable Troy Nunley.

CASE: Taurus Aquarius Baker (10/26/12)

PROSECUTOR: Deputy District Attorney Chris Ore

District Attorney Jan Scully announced today that Taurus Aquarius Baker was convicted by jury for the first degree murder of Joseph Wayne Bush with the special circumstance that the crime was committed during an attempted robbery.

On the afternoon of February 8, 2006, Baker shot and killed Joseph Wayne Bush during an attempted carjacking in the parking lot of a shopping center on Mack Road in south Sacramento. Baker faces a maximum sentence of life in prison without the possibility of parole. Sentencing is set for January 18, 2013 in Department 21 before the Honorable Steve White.

But the second you relent, the moment you acknowledge your exhaustion, that you just can't keep up, then that familiar conditional approval will rear its ugly head.

Conditioned like this, when Jesus shows up and says, "If you're tired I can help with a little grace," we just can't believe it. Yet, that's exactly what Jesus said when he showed up! With words that make most type-A congregational leaders cringe, Jesus said, "Come to me, all you who are weary and burdened, and I will give you rest."

Eugene Peterson's translation of those words is more pointed: "Are you tired? Worn out? Burned out on religion? Come to me. Get away with me and you'll recover your life. Walk with me...watch how I do it. Learn the unforced rhythms of

grace: That is what we religious laborers need, because the people that Jesus most wants to set free are those of us who are eyeballs deep in religious work, we who are religious ergomaniacs. He wants us to see that our religious work really doesn't work; it works against us.

His invitation is for us to get off of the spiritual hamster wheel and to crawl out from beneath the choking voke of religious workoholicism, and dance freely to the easy tempo of grace. Grace will teach us to serve God, not to make him like us, but because he already adores us. It will teach us to give up our overachieving and slaving ways, and find peaceful rest for our souls.

Now, if you are happy with doing all your religious work, then please, just keep doing it. If work is your passion, and time spent on the treadmill suits you just fine, then disregard all I have said as useless drivel and carry on.

But if you have had it; if you are sick and tired of being sick and tired; if you're looking for a way out; if you are desperate for your life to change; if you are finally at the end of yourself and need a rest, have I got good news for you: That is exactly what Jesus offers. Go with him, and he will give you the rest you

Roberta MacGlashan: "I support the \$16.6 million allocated to fund inmate housing"

As we all know, the State of California is experiencing a crisis from its management of the State Prison System. To address this problem, in 2011 the State Legislature adopted Assembly Bill 109, which transferred, or "realigned," to counties the responsibility for housing tens of thousands of prisoners for which the State previously had responsibility. The state provided funding to deal with certain offenders newly sentenced to State prison, but this funding source has fallen well

short of the amounts promised. AB 109 creates local Community Corrections Partnerships (CCP). In Sacramento County, the CCP is comprised of the Sheriff, District Attorney, Chief Probation Officer, Chief of Police for the City of Sacramento, the Public Defender, the Presiding Judge, and the head of the County's human assistance and welfare agency. The CCP is tasked with formulating a plan for allocating the realignment funds, which is forwarded to the

Board of Supervisors for adoption. Only with a 4/5 vote can the Board of Supervisors reject the CCP plan, and the Board has no authority to change the plan.

On Tuesday, October 16, the Board of Supervisors adopted the 2012-2013 CCP plan. This plan results from months of deliberations by the CCP, which ultimately adopted the plan on a 6-1 vote. The plan, which allocates \$28 million in current fiscal year revenues along with \$1.9 million in carryover funds from last year, was approved by the Board of Supervisors on a 4-1 vote. The \$28 million in revenues this year are almost 25% less than the \$37 million promised by the State at the time AB 109 was adopted.

I am proud to have supported the plan, which I believe properly prioritizes public safety in the post-realignment world, while still providing a balance between incarceration and programs designed to keep inmates from reoffending.

My biggest concern with realignment is to ensure that accommodating these offenders in our County jails not impact public safety. If jail funding is insufficient, the Sheriff could find himself in a position of having to either release inmates early or pull deputies from the street to staff the jail. Neither of these options is acceptable to me as your Supervisor, and I support the \$16.6 million allocated to fund inmate housing.

The Sheriff also received \$2.2 million for electronic home monitoring, which will responsibly ensure space in County jail facilities for the most serious offenders. Additionally, \$500,000 will go towards a pretrial release program, and \$500,000 will go towards

educational and rehabilitation classes for inmates in custody.

The Probation Department received a total of \$8.7 million. Of this amount, \$8.4 million will fund an adult day reporting center at which offenders will be engaged in intensive, on site community supervision. These offenders, who are identified as having a moderate to high risk of reoffending, will be engaged in education and oversight designed to reduce recidivism.

The Sheriff and Probation combined will be spending \$750,000 on mental health services and medications for realigned prisoners in their respective custody.

Additional funding of \$350,000 has been allocated to the District Attorney to offset costs associated with realignment, and \$430,000 has will be spent for the Department of Human Assistance to provide eligibility assistance and emergency housing for recently-released inmates.

While I remain concerned about the risks associated with the State's realignment of offenders to County oversight, I am confident that the plan adopted provides the greatest protection for public safety with the resources provided. Some feel more funding should be allocated to rehabilitation programs. While I agree that rehabilitation, particularly in-custody, is an important component of reducing recidivism, I point to the \$9 million shortfall in State funding for the County that could have been used at least in part for such programs. Absent full funding from the State, the County must use the resources provided to ensure the safety of the law abiding public.



Take the state job and fashion a good, long-lasting career for yourself. Don't go chasing money on the short term!

Dare to Live Without Limits

TAKE A BREAK

Your schedule is packed. There never seems to be enough time. You have more to do than will fit into 24 hours. You are physically tired and mentally stressed. These are some of the symptoms of today's hectic lifestyle.

What can you do to recharge and make life more manageable? One of the best ways of coping is to take a break. This provides you with an opportunity to recharge mentally and physically. Taking breaks is more than just a good idea, it's essential.

The need for sleep demonstrates how important breaks are. Sleep is a biologically required break. Without enough sleep, you are incapable of functioning. In addition to adequate sleep, regular breaks enable you to reduce stress and fatigue while enhancing your overall ability to deal with everything on your plate.

Your body can not properly digest food when you are stressed. Regardless of how little time you have, sit down and relax. Listening to music, conversing with friends, reading from a book, or sitting quietly are a few suggestions.

Don't overlook the importance of a proper diet. Food is your fuel. You won't function properly if it's defective. Junk food may be enjoyable but it is not a meal replacement. Use common sense. Candy, donuts, and cakes don't qualify as a meal.

There are others strategies you can use to break up your day. Changing or varying tasks is a good way to reduce boredom. Doing so can also get you out of a mental block. If you spend a lot of time sitting, get up and walk around. Even if you can only stand up and stretch you will feel better.

Some people find a quick five or ten minute nap to be very refreshing. You do this right at your desk or in a parked car. Some employers even encourage napping by providing quiet lounges. It may take some creativity but the benefits of a nap are worth it.



1) Become Self-aware. When you feel a complaint coming on, no matter how trivial, stop yourself. You can't delete the thought, but you can revise it before saying it aloud. So instead of saying, "Oh, that's nice, but I could never afford it," you might say, "That will look wonderful with my black pants when I can afford to buy it."

2) Redirect the conversation. When you participate in negative dialogue with a complainer, you'll walk away feeling depleted. Instead, take control of the direction the conversation is going. If he says, "I hate Mondays. The weekend isn't long enough," counter his negative thoughts with a positive set of images: "I'm glad I rested up this weekend! Now I'm ready to dig into that big project."

3) Smother a negative thought with a positive image. If a negative thought pops into your mind, immediately input a different image. This is the process of neurogenesis...creating new pathways in your brain that lead to positive behaviors.

Pitfall of 529 Saving Accounts

The IRS, under code section 529, provides for a tax free method for paying for qualified education expenses. In general you may gift money to a qualified plan, and if certain rules are kept, there will be no tax to either the owner (normally the parents) nor the beneficiary (normally their child), if the funds and earnings are used to pay for qualified education expenses. This article will discuss some of the pitfalls associated with these plans.

Gifting Issues:

Watch out if you plan to give more than \$13,000 (\$26,000 for a husband and wife) to a qualified individual in a tax year. The excess over these amounts may be subject to gift tax. However, there is an exception to this rule if you make an election on form 709 to "treat the transfers made this year to a qualified tuition program as made ratable over a 5-year period beginning this year". Translated this means a single individual can give \$65,000 (\$130,000 for a husband and wife) to a qualified individual in year one. However, be sure you file the gift tax return in the year the gift is made and make this election. If a married couple elect's gift-splitting, both husband and wife must file separate gift tax returns and make the fiveyear election. The gift tax return is due by April 15th after the year in which the gift is made.

Investment Issues:


The IRS allows you to change your investments only once a year. In the current secular bear market this rule has wreaked havoc on investment results of 529 plans. Since 2001 the stock market has been flat to down from its March 2000 highs. Many plans are flat and some have even lost money. Therefore, make your yearly investment selection wisely.

Account Rollovers:

Watch out for rollovers! You can rollover a 529 plan to another plan with the same beneficiary only once every twelve months. It is much like the IRA rollover rules. If you break this rule taxes and penalties will be due. If you have two or more 529 plans for the same beneficiary check to be sure that you have not rolled over any of these plans during the last twelve months. Rollovers must be deposited into the new 529 plan within 60 days from the distribution.

Timing the Payment of **Qualified Expenses:**

Distributions used to pay for qualified expenses should be made in the same calendar year the expense is incurred. However, IRS may allow the distribution if made by March 31 following the calendar year of the expense was incurred. As with all tax law it changes quickly. Be sure to check with your tax accountant.
