

DIXON, CA (MPG) - 'More Opportunity, More Smiles' is the theme to kick off National 4-H Club Week, October 2-8 new season. For over 100 years, California 4-H has provided ways for youth to make a positive difference in their world and Solano County 4-H clubs are now open for sign-ups.

This organization provides a place where young people develop positive relationships, leadership, and skills for life. 4-H members make friends and share interests, ranging from engineering to raising rabbits, from tabletop gaming to gardening.

Two different 4-H clubs, Maine Prairie 4-H and Dixon Ridge 4-H both were awarded \$500 each this past spring to enable six new youth to become members to each club. The grant will cover their program fees thanks to the Dixon Women's Improvement Club.

Both 4-H programs in Dixon have experienced a significant increase in underserved youth enrolling and some of those students need financial assistance to participate. Normally the clubs would have local funds saved for this but due to the pandemic, traditional fundraising efforts have been limited.

The special week will begin with an information booth at Dixon's Tractor Supply and the club holding their 'Paper Clover Campaign,' which raises money for scholarships to 4-H camp and conferences.

"We also hold our annual 4-H Achievement Night where 4-H members in Solano County are recognized for their 4-H achievements, as well as Friends of 4-H and the Solano County Leader of the Year," reported Sandy Means, a Community Leader of the Dixon Ridge 4-H group.

The Solano County 4-H Youth Development Program serves all of Solano County through programming offered by the following local 4-H Clubs. Dixon: Dixon Ridge 4-H Club and Maine Prairie 4-H Club; Suisun Valley 4-H Club; Rio Vista 4-H Club; Elmira 4-H Club, Pleasant Valley 4-H Club and Vaca Valley 4-H Club; and Vallejo/Benicia's Sherwood Forest 4-H Club.

Peña Adobe **History Told**



histories and paths to the Peña Adobe in Vacaville

DIXON, CA (MPG) - The Dixon Historical Society welcomes guest speakers Cecelia Peña and Armando Pérez to share their family histories and paths to the Peña Adobe in Vacaville. at the next Dixon Historical Society presentation on Sunday, October 16, 2 to 4 p.m. at the Dixon United Methodist Church Fellowship Hall.

This first presentation is Part I of a series that will focus on the history of the interactions among Americas' First Peoples, the early Spanish and Mexican Colonists, and the looming Manifest Destiny of the Anglos from Prehistory to 1841.

The families of Juan Felipe Peña, and Juan Manuel Vaca came to the Laguna Valley from New Mexico in 1841 during California's Mexican era. The Peña Adobe, built in 1842, on a 10-league land grant, is the oldest restored structure in Solano County.

Cecelia and Armando, two of the Peña Adobe Historical Society docent storytellers, team up to share their history as part of the Peña Adobe Historical Society's educational outreach.

Cecelia Peña, a retired businesswoman, is a fifth generation Peña, an officer of the Peña Adobe Historical Society, and officer of the Descendants Chapter of the Old Spanish Trail Association. Cecelia has written a book for 4th graders, A Visit to the Peña Adobe and is currently transcribing her great aunt's correspondence, Rose's Letters.

Armando Pérez, Chiricahua Apache and Tarahumara, is a retired Respiratory Care Practitioner. He was a youth football coach for many years. Armando shares his extensive Native American experiences and knowledge about native cultures.

The Dixon Historical Society welcomes the community to join us for this very special and unique opportunity. The presentation will take place from 2 to 3:15 p.m. Refreshments and the Membership Meeting will follow the presentation. The community is invited to join our membership.

DUSD Superintendent's Message

We have referred to our District-wide implementation of AVID several times in the Weekly Update and will continue to provide information regarding the program throughout the rest of the year.

AVID, which stands for Advancement Via Individual Determination, is a college and career preparation program that begins in Kindergarten and runs all the way through 12th Grade. It has a number of key components, four of which will be highlighted today. These domains, or areas of focus, are the framework for how we can transform our schools, integrating the AVID philosophy and methodologies into everything that we do. By providing the AVID experience to every student in the District, we are attempting to prepare every student for whatever college and career path they choose to pursue.

The Four Domains of AVID:

INSTRUCTION:

Students will not reach the necessary levels of preparation if classroom instruction is not rigorous and properly designed to meet the needs of all students through a variety of strategies and practices. Central to instruction in AVID are WICOR tools. WICOR



stands for Writing, Inquiry, Collaboration, Organization, and Reading. We will further explain these components in detail in a future update. Staff properly use WICOR strategies when they have been adequately trained and are supported to do so. The District has invested a very large amount of time and funding in professional development for our staff, and evidence of WICOR practices can be seen across the District.

SYSTEMS: Systems provide structures that support the full implementation of AVID at every site. They provide organization, planning, implementation, and monitoring of how AVID is being embedded at each school site and across the District. Systems help to ensure the successful development of AVID and its benefits for every student in the District.

LEADERSHIP:

Leadership sets the vision and tone that promotes college and career readiness, and high expectations for all students. While school site and district administrators have a large and important role as leaders, the development of effective AVID Leadership Teams with a variety of staff members on it is the most important part of ensuring strong leaders at each campus. Each school has an AVID Site Team that plans and supports implementation of the program. We could not become an AVID District, with certified AVID schools without strong leadership teams.

CULTURE: One of the

underlying principles of

AVID is that culture trumps

strategies every time. In

other words, if a school or the District does not have a shared vision, common beliefs and behaviors, and the effective inclusion of all members of the school community - students, families, and staff - the plans that contain strategies, plans, and various activities cannot be successfully implemented. The culture must include principles such as every student can learn and benefit from AVID, all stakeholders agree that AVID is the foundation of how we will do our work, and that we must look past the awarding of a high school diploma and prepare students for their futures, whether that includes an immediate career, or college or other training before starting a career. ★

WOODLAND, CA (MPG) - In memory of Paul and Barbara Taloff, Chris and Betsy Taloff present The Ghost of Woodland Opera House. This theatric work is inspired by the history of the WOH and the heroism of Woodland resident and volunteer firefighter William W. Porter. Porter was the single casualty of the fire of 1892 that resulted in the loss of the original Opera House along with many downtown buildings and residences.

Since Porter's death, there have been numerous reports of ghostly sightings throughout the years at the Woodland Opera House. Volunteers and visitors, actors and audience members alike claim to have experienced supernatural specters, strange smells, and startling sounds. Traditionally, many of these unexplained events have been attributed to William Porter whose spirit purportedly still inhabits the historic theatre.

Use Google Earth features to locate additional cemeteries in likely areas and see how different cultures honor their dead.

THE FUTURE OF THE CW NETWORK **COMES INTO GREATER FOCUS**

Last month, Nexstar Media Group announced that it was taking a 75% ownership interest in The CW Network. Nexstar claims that, together with its partner stations, it is the nation's largest local television broadcasting company.

This could be good news for The CW because it is apparently the lowest-rated broadcast network when compared to the big four of FOX, ABC, CBS and NBC. The network has been tagged as appealing only to the younger demographic.

Trade publications like "Variety" reported last month that the Nexstar president stated the average viewer of The CW is 58 years old. Hardly anyone could believe this until Nielsen data backed it up.

How to explain the interest of older viewers to tune into youth-oriented programming like "Riverdale" and "All American?" A plausible answer may be that the younger crowd are watching on platforms other than traditional television.

Now that the fall season is upon us and major networks are launching new series in September, we can take a closer look at The CW's new slate of programs, all of which will premiere in the early days of October.

One of its most successful franchises, "Supernatural" ran for more than a dozen years. Now along comes "The Winchesters," a wild-west origin story to this big hit.

Told from the perspective of narrator Dean Winchester (Jensen Ackles, "Supernatural"), "The Winchesters" is the epic, untold love story of how John Winchester (Drake Rodger) met Mary Campbell (Meg Donnelly).

Putting it all on the line to not only save their love, but the entire world, when John returns home from the war in Vietnam, an enigmatic happenstance sparks a new mission to trace his father's past.

In his journey, John crosses paths with 19-year-old demon hunter Mary, who is also searching for answers after the vanishing of her father. Together, they join forces with young hunters-in-training to unearth concealed truths about both their families.

The action-packed "Professionals" follows Vincent Corbo (Tom Welling), a top-tier security operative who is paid to protect the interests of wealthy clients by any means necessary, whether legal or not.

After a next generation medical data satellite explodes on launch, Corbo is hired by the rocket's designer, billionaire futurist Peter Swann (Brendan Fraser), who suspects sabotage.

Complicating Corbo's gig is his former courtesan and now Swann's betrothed, medical visionary Dr. Grace Davila (Elena Anaya), who is racing to help avert a global calamity.

As Corbo and his team of veteran security

pros investigate the rocket disaster, they

take control of Swann's empire. Worse, Corbo must also contend with Swann's overindulged, mischievous teen daughter (Jazzara Jaslyn) and a rogue Europol agent (Ken Duken), who is hellbent on busting him for past sins.

Set in the late 1800s, "Walker Independence" is an origin story for the current hit series "Walker." The new program follows Abby Walker (Katherine McNamara), an affluent Bostonian whose husband is murdered while on their journey

After crossing paths with Calian (Justin Johnson Cortez), a curious Apache tracker, Abby arrives in the town of Independence. Texas, where she encounters assorted free-spirited residents running from their pasts and pursuing new dreams.

Quirky burlesque dancer Kate Carver (Katie Findlay) has perhaps too keen an interest in Abby's origins, and Kai (Lawrence Kao), a soulful Chinese immigrant runs a local restaurant and offers Abby friendship without an agenda.

Abby literally runs into Hoyt Rawlins (Matt Barr), a slippery rogue, thief and con artist with a dented heart of gold who quickly eyes Abby as a mark, until she turns the tables on him.

In seeking justice for her husband, Abby encounters noble deputy sheriff Augustus (Philemon Chambers), and his new boss, Sheriff Tom Davidson (Greg Hovanessian), who she has reason to believe is a very bad man.

California Farm Receipts Up 3.6% in 2021 Despite Drought Year, State Reports

Despite water shortages and continued drought in 2021, California farms and ranches took in \$51.1 billion in cash receipts - a 3.6% increase over 2020. That's according to newly published agricultural production statistics from the California Department of Food and Agriculture. According to the 2021 report, California's top value commodities for the year were dairy products and milk at \$7.57 billion, followed by grapes at \$5.23 billion, almonds at \$5.03 billion and cattle and calves at \$3.11 billion.

Farm exporters resort to rail, alternative routes to bypass congested ports

California agricultural exporters are turning to alternative routes and transportation modes to move their products to bypass some congested ports. The Port of Oakland, a key agricultural trade hub, has seen reduced vessel service by ocean carriers. This summer, almond growers and processors launched a so-called "almond express," using rail lines to instead transport exports to ports of Los Angeles and Long Beach. One walnut producer has resorted to shipping product by rail all the way to the Port of Virginia in Norfolk.

California Walnut Yield May Exceed 2022 Expectations

California's walnut crop, now in harvest, is forecast at 720,000 tons, which would be down by 1% from last year. However, California Walnut Board and Commission CEO Robert Verloop said the industry consensus is that the yield may be significantly higher – likely between 775,000 to 800,000 tons. California produces 99% of America's walnuts. The state this year had 400,000 bearing acres of walnuts, with 60% of the nuts destined for export markets.

Irrigators with Senior Water Rights Win Court Fight Over Curtailments

A state appeals court ruling protects longstanding water rights of many California farmers, ranchers and water agencies. The Sept. 12 ruling by California's Sixth Appellate District Court of Appeal, related to water cuts imposed in 2015, signals that the State Water Resources Control Board cannot target senior water rights holders with acrossthe-board curtailments. California Farm Bureau President Jamie Johansson said the decision recognizes that water rights are "critical to California communities, agriculture and securing our nation's food supply."







My guess is you have friends or relatives who could loan you a car in a pinch, and public transportation is an option for some folks. So yeah, knock out the credit card first, then move on to the truck.

Do you understand my reasoning, Grant? Going this route serves two purposes: First, it will save you a little money. And second, I've got a feeling it will fire up your wife, and get her on board with the idea of you two getting your finances in order even more than she already is.

She's taking this whole thing pretty seriously if she's eyeballing interest rates, buddy. She loves the thought of you two having control of your money. Use this momentum to work together as a team, and knock out that debt!!

SCOE Awarded \$300,000 Grant for **Student Salmon Monitoring Project**

SCOE News Release

SOLANO COUNTY, CA (MPG) - Solano County Office of Education (SCOE) has been awarded a \$300,000 Bay Watershed Education and Training (B-WET) grant from the National Oceanic and Atmospheric Administration (NOAA). The grant focuses on engaging teachers and students in citizen science to help solve a mystery threatening the salmon population in California's ecosystems. SCOE's grant program, dubbed the Spinning Salmon Citizen Science Monitoring Project, launched on September 23, 2022, with a two-day training for a small pilot group of teachers from across Solano County at SCOE's main office in Fairfield.

The Spinning Salmon project was developed through a collaborative effort with SCOE, NOAA, the UC Davis Center for Watershed Sciences, the California Department of Fish and Wildlife and the UC Davis Center for Community and Citizen Science. Other community organizations like the Solano Land Trust and the Fairfield-Suisun Sewer District also supported the project and teacher training. The teachers will lead Solano County high school students through a partnership with researchers from UC Davis and facilitate the collection of data in the classroom to support UC

"Exposure to STEM (science, technology, engineering, and mathematics) and STEMrelated fields can be a significant equalizer for students. We are excited to be awarded this grant that will provide students the opportunity to provide real research and data

that can help CDFW and UC Davis scientists solve a problem endangering salmon in our local ecosystems."

A mystery emerged in 2020, when experts at the California Department of Fish and Wildlife's Fish Health Laboratory and UC Davis Aquatic Animal Health Laboratory discovered something was causing young salmon in fish hatcheries to swim in corkscrew patterns and die at unusually high rates. Investigators with the U.S. Fish and Wildlife Service's California-Nevada Fish Health Center noticed that a bath of thiamine immediately revived the ailing juveniles. They now suspect the problem is linked to a deficiency of thiamine in returning adult salmon that fed off the coast of central California.

SCOE's Spinning Salmon project will place fish tanks, research equipment and salmon fry in local classrooms. Teachers received training and permitting from the California Department of Fish and Wildlife (CA DFW) allowing them to legally possess the wild species. The program aims to provide real-world data collected by Solano County high school students to support research looking to uncover what is causing the deficiency in the salmon, which play a critical role in our Californian and global ecosystems.

The NOAA B-WET program is a competitive grant program that promotes Meaningful Watershed Educational Experiences: activities driven by rigorous academic learning standards that aim to increase participants' understanding and stewardship of watersheds and related ecosystems.

Safeway Environmental Settlement Amounts to \$8 Million

Solano County DA News Release

SOLANO COUNTY, CA (MPG) - Solano County District Attorney Krishna A. Abrams announced on September 16, 2022, that the Solano County District Attorney's Office, together with California Attorney General Rob Bonta and five other California District Attorneys reached an \$8 million settlement with Safeway resolving allegations that the company violated state environmental laws while operating underground storage tank systems at its 71 gas stations across California. An investigation into Safeway's gas stations - branded as Safeway and Vons fuel stations – found a recurring failure to install, implement, and operate various spill prevention and safety measures since at least March 2015. Today's settlement includes robust injunctive terms to improve operational safety and compliance with state laws to avoid potential contamination to soil and groundwater.

"The Solano County District Attorney's Office remains committed to the enforcement of these violations that can have an immeasurably detrimental effect on our citizens. Today's settlement will protect the public and ensure future compliance with all regulations that safeguard the water sources that we rely upon every day in our community." said District Attorney Krishna Abrams.

Underground storage tank systems are subject to strict regulations in California because of the potential for even a small tank leak, if undetected, to cause substantial contamination to soil and groundwater. California requires that all underground storage tank systems be designed and constructed with primary and secondary levels of containment, continuous monitoring systems, constant vacuum pressure, equipment to prevent spills and leaks, and automatic leak detectors.

Beginning in 2015, Safeway is alleged to have violated state laws regulating the operation of underground storage tanks and the handling of hazardous waste. Specifically, the Attorney General and district attorneys found evidence of recurring violations at Safeway gas stations, including failure to:

Install and/or maintain automatic line leak detectors; Construct, operate, and maintain secondary containment systems; Maintain a monitoring system capable of detecting a leak at the earliest possible opportunity; Continuously monitor and conduct required testing of underground storage tank systems; and, Properly notify local agencies of the release of a hazardous substance.

This settlement resolves these allegations. As part of the settlement, Safeway will pay \$7.5 million in civil penalties, including \$600,000 to fund several supplemental environmental projects, and an additional \$500,000 for investigative costs. Solano County will receive \$696,544 in civil penalties and \$66,020 in costs. Safeway will also be required to take immediate steps to improve spill and alarm monitoring, employee training, hazardous waste management and emergency response at its gasoline stations. For example, Safeway will employ an environmental compliance manager to ensure compliance with the applicable state laws, document any unauthorized release of hazardous waste, and submit annual reports to the California Department of Justice, among other responsibilities.

Pentagon in 'Potential Noncompliance' With Law in Denying Religious Exemption Requests to Vaccine Mandate: Leaked Memo

The inspector general calls the volume and rate of religious vaccine exemption denials 'concerning'

The Department of Defense (DOD) has been in "potential noncompliance" with standards for reviewing and communicating denials of religious accommodation requests to the vaccine mandate, the Pentagon's watchdog wrote to the secretary of defense in a June memo obtained by The Epoch Times.

The June 2 memo by Acting Inspector General (IG) Sean W. O'Donnell states that after reviewing dozens of complaints from service members who were denied religious accommodation, the IG's office "found a trend of generalized assessments rather than the individualized assessment that is required by Federal law and DoD and Military Service policies."

The purpose of the memo was to inform the secretary of defense of "potential noncompliance with standards for reviewing and documenting the denial of religious accommodation requests of Service members identified through complaints submitted to the [IG's] office."

"The denial memorandums we reviewed generally did not reflect an individualized analysis, demonstrating that the Senior Military Official considered the full range of facts and circumstances relevant to the particular religious accommodation request," the memo reads.

It provided an example of such cursory treatment. An Air Force general used a one-sentence statement to deny an airman's request: "I disapprove your request for exemption from vaccinations under the provisions of AFI 48-110, paragraph 2-6.b.3."

The acting IG also noted that the volume and rate of denial decisions were "concerning."

An average of 50 denials per day were processed over a 90-day period, according to the memo.

"Assuming a 10-hour work day with no breaks or attention to other matters, the average review period was about 12 minutes for each package," it reads. "Such a review period seems insufficient to process each request in an individualized manner and still perform the duties required for their position."

The acting IG drew attention to DOD Instruction 1300.17, titled Religious Liberty in the Military Services. Paragraph 3.2.d, which was extracted in a footnote of the memo, states that "officials charged with making recommendations or taking final action on a Service member's request for the accommodation of religious practices will review each request

individually, considering the full range of facts and circumstances relevant to the specific request. ... The means that is least restrictive to the requestor's religious practice and that does not impede a compelling governmental interest will be determinative."

The memo was received by Secretary of Defense Lloyd Austin who, in a Sept. 2 memo that was also obtained by The Epoch Times, referred the matter to the undersecretary of defense for personnel and readiness "for appropriate action, in coordination with the Secretaries of the Military Departments and the DoD Office of General Counsel, as necessary and appropriate."

"Uniform standards must be applied to all requests for medical or administrative exemption in a manner consistent with law and DoD policy, including DoD Instruction 6205.02, 'DoD Immunization Program,' and DoD Instruction 1300.17, 'Religious Liberty in the Military Services,'" reads the Sept. 2 memo signed by Austin, a Biden appointee.

When contacted by The Epoch Times about the June memo, a spokesperson for the IG's Office said via email, "The memorandum in question is Controlled Unclassified Information and will not be released at this time."

The spokesperson didn't dispute the authenticity of the document.

To date, the combined services have separated at least 7,476 service members over the vaccine mandate, according to the most recent publicly released figures.

As of July 11, the Air Force had approved 104 religious exemptions and administratively separated 834 service members for refusing the vaccine mandate. As of Sep. 8, the Marine Corps had approved 14 religious exemptions and separated 3,436 service members. As of Aug. 24, the Navy had approved 46 religious exemptions and separated 1,533 people. As of Sept. 1, the Army had approved 32 religious exemptions, with 1,673 separations.

'Unethical Behavior'

Army Chief Warrant Officer Danny Erickson (a pseudonym) discovered the IG memo through a fellow member of the military last week and posted extracts of the memo on his personal website that he created to be a voice for service members who continue to battle against the military's vaccine mandate.

Erickson, an active-duty service member for more than 20 years and a whistleblower, spoke to The Epoch Times using a pseudonym because of a fear of reprisal.

The officer's website provides more than two dozen examples of Air Force and Navy religious accommodation request denial letters sent to service members.

"Air Force denials are almost identical, while Navy denials are an exact match," he said. "For the last year, I've seen hundreds of other letters with striking similarities.

"These identical letters expose a level of corruption or unethical behavior within chains of command and leadership.

"They are clearly not looking at individual cases considering the full range of facts and circumstances relevant to specific requests for religious accommodation. They are blanket denying any religious accommodations, and it's happening at the highest levels.

"The DOD has flat out, undeniably, broken the law concerning religious liberty, and the [secretary of defense] is fully aware of it, because of the memo dated June 2."

What's more, the secretary has done nothing to address the acting IG's warning, Erickson alleged.

A Common Theme Warrants Investigation

The Epoch Times also spoke to Navy Commander Robert A. Green Jr., who was relieved from his position as an executive officer of one of the seven Maritime Expeditionary Security Squadrons within Navy Expeditionary Combat Command on Jan. 7.

"I provided evidence that the Navy was violating federal law and military regulation in how they adjudicated the standardized predetermined denials of religious accommodation requests," Green said.

He was relieved of his duties as an executive officer only four days after this evidence was used as the basis for a preliminary injunction granted to Navy SEALs by a federal court.

"In December 2021, I filed an internal Navy complaint against Vice Admiral John Nowell who was the chief of naval personnel and the person designated by the Navy to adjudicate all religious accommodation requests for COVID-19 products," Green said.

His complaint pointed to Nowell's utilization of a standard operating procedure that "streamlined the process" that his staff would take to deny all religious accommodation requests. Green noted that "one of the very first steps in the process, once they received a request, was to paste the requestor's name into the denial template and then route the denial for review."

"It wasn't until one of the last steps of the process, that a staffer was finally directed to actually open the request," he said.

Green's complaint was formally dismissed in August.

"This is shocking because the Navy's response came two months after the [IG's] memo to the secretary of defense," he said. "Claiming that they could find no evidence should have been impossible, considering a higher-level inspector general had already found that blanket denials of religious accommodations were being given to service members."

Erickson and Green emphasized that their views don't reflect those of the Department of Defense, the Department of the Army, or the Department of the Navy.

DOD officials and the Office of the Naval Inspector General didn't respond to requests for comment.

Biden Admin's New 'Climate Cop' Studied at CCP-Controlled University With Ties to Chinese Military

A former employee at New York's financial regulator who once lived in China and earned a bachelor's degree at a Chinese Communist Partycontrolled university has taken an important job in the Biden administration.

The Office of the Comptroller of the Currency—a Treasury Department bureau overseeing the country's largest banks and federal savings associations—has named Yue (Nina) Chen as the agency's first "climate cop," or chief climate risk officer, according to a Sept. 12 statement.

Her responsibility is to guide the bureau to "focus on the development and implementation of climate risk management frameworks for the federal banking system."

She'll report to Acting Comp-


troller Michael J. Hsu, who said in the statement that Chen is "an asset" to the bureau, given her "background and experience in both finance and climate-related financial risk."

Chen replaces Jonathan Fink, who assumed the responsibility in an acting capacity in March.

Tsinghua University

Chen obtained a bachelor's degree in chemical engineering from China's Tsinghua University in 2000 and later earned a doctorate degree at the Massachusetts Institute of Technology.

Tsinghua University is funded by the Chinese regime's Ministry of Education and supervised by the State Administration of Science, Technology, and Industry for National Defense (SASTIND), a defense industry agency for the Chi-

nese Communist Party (CCP). According to Canberra, Australia-based think tank the Australian Strategic Policy Institute (ASPI), Tsinghua University conducts "defense research," including in areas such as air-to-air missiles

and artificial intelligence, and the school is home to several defense-focused laboratories.

The Pentagon also high-lighted Tsinghua University in a 2020 report, noting that the university has ties to the CCP's military-civil fusion strategy,

which allows the communist regime to leverage commercial technologies for military development.

The CCP controls Tsinghua University through the school's party committee, which is headed by a Party secretary, Qiu Yong, who reminded students and teachers in a July speech about the importance of being "loyal to the Party."

Tsinghua University, like many universities and colleges in China, has its own "United Front Work" office, which is part of the CCP's sprawling bureaucracy headed by the United Front Work Department, a powerful Party agency.

According to a 2020 ASPI report, the department coordinates thousands of groups to carry out foreign political influence operations, suppress dissident movements, gather intelligence, and facilitate the transfer of technology to China.

The Washington Free Beacon first reported on Chen's educational background in China.

Senior wideout Matthew Whitaker led the way for Dixon with two rushing touchdowns on five carries for 35 yards. Senior running back Braden Baumbach followed closely behind with two rushes for 40 yards and a score.

Dixon junior WR Jordan Sengmany had a game-high four catches for 73 yards and two TDs. Senior WR Luis Torres caught three passes for 65 yards and a score. Fellow senior WR Brent Green added three receptions for 44 yards and a TD. Torres and Green each also had one interception on defense.


Junior inside linebacker Marcos Gregorio tied for a game-high with six tackles. Torres contributed to all three facets of the game. The senior nailed five of six point after attempts with his leg.
