Experts Look for Solutions as Fentanyl Overdose Deaths Surge

There's no question that the pandemic caused a troubling upward trend in addiction disorders, with many people turning to substances like opioids to help them cope with the loss of a loved one, feelings of isolation or job stress. But amid the darkness came a sliver of light: the dawn of telehealth and tele-mental health services, which provide convenient ways for folks to seek help.

"We've also seen the rollout of naloxone, the opioid reversal agent that can save lives," said Dr. Paul Christo in a recent interview. "It doesn't have to be prescribed by a physician. It can be, but in certain states, pharmacists can dispense it without a prescription. Drugs like methadone, buprenorphine and suboxone, these drugs help prevent relapse, reduce craving and are really important.

Dr. Christo, Associate Professor in the Division of Pain Medicine at the Johns Hopkins University School of Medicine, wants to remind those battling addiction to make use of these valuable telemedicine and tele-mental health services, and adds that it's important for clinicians to advocate to their patients that online treatment options, including telehealth prescriptions for critical medications are available.

The opioid epidemic today progressed in three phases, according to the Centers for Disease Control and Prevention. The first involves deaths caused by prescription opioids, the second, an increase in heroin use, and the third, a surge in the use of synthetic opioids or fentanyl. Experts say the U.S. is right in the middle of the third phase of the epidemic, due to the increasing availability of fentanyl and increasing rates of overdose deaths involving synthetic opioids.

According to a recent study there were 632,331 drug overdoses between 1999 and 2016. Most of these deaths (78.2 percent) were drug overdoses with known drug classification. Moreover, 21.8 percent were unclassified drug overdoses. A further investigation revealed that for unclassified drug overdoses, 71.8 percent involved opioids, translating to 99,160 additional opioid-related deaths.

There were over 70,000 drug overdose deaths in 2017, according to an *Continued on page 2*

DIXON, CA (MPG) - Wait no more parents of budding adolescent children who have noticeable overbites, underbites, or crooked teeth: Dixon has its first orthodontist.

Matthew Sanders, father of five and owner of three other offices, opened Sunrise Orthodontics at 2355 North Lincoln this past week already greeting families who have been waiting for him to arrive in

Dixon. His other offices are in Gold River, Placerville, and Elk Grove.

"I kept coming back to Dixon," he said. "I've come here several times and drove every street in town. I know Dixon didn't have an orthodontist." He was looking for possible cities and possible buildings when he saw the lot available across from the new Grocery Outlet.

Sanders received his Doctorate of Dental Surgery at Loma Linda University School of Dentistry and earned a degree in orthodontics and dentofacial orthopedics with honors. He then completed a year of general practice residency at a VA Hospital before returning back to LLUSD to obtain his Master's in orthodontics and certificate in orthodontics.

Because he grew up in Humboldt, son of the only dentist in a small town, he said, he likes small towns and likes to find properties that need to be fixed up. Reminding him of Humboldt, he was drawn to the redwoods and the half-buried building on the corner of Highway 113 and North Lincoln.

"I like taking something old and re-doing it," he said about his vision for the building. "Like creating the perfect smile... it's very exciting." It has taken them over a year to remodel. Sadly, though, the redwood trees had to

estimate from the CDC. Based on findings from the new study, over half of those deaths, about 47,000 are suspected of having involved opioids.

Another study on opioid overdoses found that the number of drug overdose deaths decreased by 4 percent from 2017 to 2018. In 2018, more than 67,000 people died from drug overdoses, making it a leading cause of injury-related death in the United

States. Almost 70 percent involved a prescription or illicit opioid of those deaths.

"COVID-19 impacted the drug supply chain by closing borders on some regions, and it led to the higher death rate," Dr. Christo explained. He added that drugs become more challenging to get, and the potency of overdose goes up. It also impacts the price, everything goes up, and in that sense, it becomes more deadly each day, according to Dr. Christo.





Rams Earn 6th Consecutive Sweep

DIXON, CA (MPG) - The dominant play from the Dixon High School boy's varsity volleyball team continued Monday night, April 18, at home with a sweep of Vacaville Christian.

The sweep was the sixth match in a row for the Rams (10-1, 6-0 Golden Empire League) without giving up a set to their opponent. This was also the team's ninth consecutive win after losing their second game of the season to Vanden (13-2, 8-0 Sierra Delta) of Fairfield.

Vacaville Christian (7-5, 5-2 Sierra Delta) came into the match winners of six of their last seven with their lone

defeat against Vanden as well. However, the Rams proved to be the far superior team on Monday

The first set got the match off to an intense start, as Dixon senior libero Demetrio Acosta dove all over the floor numerous times to save bullet-speed serves from the Falcons attack. The senior captain's play earned him a new nickname: The Diver! The Rams led by at least five points throughout the entire set and ultimately won 25-16.

After the teams switched sides, the second set began with the Falcons starting out strong. Dixon began to struggle and missed several opportunities as they adjusted to their opponent's new strategy. Rams coach Jessica

Biesanz called a timeout midway through the set as her team trailed 17-13.

The second set was an opposite to the first, as Vacaville Christian controlled most of the set and maintained the lead by at least five points. However, Dixon began to click when it mattered most as the Rams perfectly gelled enough late to steal the set and win 25-23.

Following the thrilling second set, the Falcons began the third set of the match in desperation mode attempting to stay alive and extend the match to a fourth set. Tension was high as Dixon senior outside hitter Dylan Diaz spiked a volley very hard over the net, but the Falcons saved the spike and returned it for a point to tie the set at 13 and send the crowd into a frenzy.

The set was neck and neck until the Rams began to pull away and a timeout was called with Dixon leading 18-14. The Rams never looked back as they controlled the set from there and finished off the Falcons with a 25-18 third set victory, earning their sixth consecutive sweep.

Dixon had two more matches this week against Mira Loma (7-12, 4-3 Golden Empire) on Wednesday and at Woodland Christian (5-5, 3-4 Central Valley California) on Thursday. The results of each match were unavailable by press time. The Rams' next match is Monday, April 25 in league play at Casa Roble in Orangevale.

Dixon's Bracero Program Bracing for the Future **Kicks Off at Museum**

DIXON, CA (MPG) - Bringing millions of Mexican farm workers to the United States, the Bracero Program will be the topic of the next Dixon Historical Society meeting as well as a new display inside the downtown museum.

A national agricultural labor shortage during World War II gave birth to the Mexican Farm Labor Program in 1942. This program permitted millions of Mexican men to work legally in the United States on short term labor contracts. The program was called 'The Bracero Program' and ended in 1964 and during that time, brought more than four million Braceros to work in U.S. agriculture and on the railroads.

The public is invited to join the Dixon Historical Society to learn more about this at their next meeting on Sunday, May 24, at the Dixon Methodist Church at 209 North Jefferson from 2 to 4 pm. Fred Barry along with Maria Cornejo-Lopez and Tom Galindo will share their knowledge of the Bracero Program in the Dixon area. The program provided the needed agricultural labor to feed the nation, brought another culture and new families to Dixon and other communities across the United States.

Members and guests are invited to attend the presentation and share their memories of the Bracero Program. Light refreshments will be served followed by a membership meeting. Applications for

"Dutch Bros sent me a thank you letter for cutting them down," he said. "They said the trees regularly had large branches fall on them." He worked with his wife, Joyce, who is a dental hygenist to redesign the inside and outside of the older building formerly housed by a credit union then a farm equipment dealer's association.

Almost all of the inside of the building was transformed into a gleaming white-walled, state-of-theart orthodontist office. The main client room has a half-dozen reclining chairs, each having a view of the outdoors and its own television screen for distractions while the experts work, she said. There are other rooms that afford

more one-on-one consults with parents present.

Along one wall is a set of 10 framed color photos of smiling children-they are his family of five children with two poses: One smiling and one being silly. The couple have two boys, and three girls which include a set of twins.

Dr. Sanders wants to be part of the Dixon community and wants to do "community things" like his Dad who supported 4-H, FFA, and had students raising pigs, he said. They are very involved in their communities and offer a completely free mouthguard program for local youth sports. They also sponsor many community-involved events, which helps them get to know neighbors in their community and their needs even better.

"We love kids and have a lot of fun with them," Sanders said. "We give lots of rewards for doing a good job and even being on time. Kids love it!"

Water Supply Cuts Expected to Curtail Klamath Valley Farm Production

Food production along the California-Oregon border is due to suffer this year, with federal water cuts impacting farmers. The U.S. Bureau of Reclamation said it expects to deliver less than 15% of allocations from the Klamath Water Project. In good years, the Klamath Basin can produce 50,000 pounds of potatoes or 6,000 pounds of wheat per acre. But Ben DuVal, president of the Klamath Water Users Association, predicts vast acreage will be fallowed in 2022.

Federal Official Predicts Extensive Fallowing in Sacramento Valley

The drought is bringing hard choices for farmers throughout the Central Valley. Ernest Conant, the Bureau of Reclamation's regional director, said, "There's going to be hundreds of thousands of acres in the Sacramento Valley that have never been fallowed before that are going to be fallowed this year." Conant said the region is facing water challenges unseen in 160 years. The federal Central Valley Project is granting zero allocations this year.


Egg Producers Gear Up for Easter and 'Nice Little Bump' in Sales

California egg producers are gearing up for a boost in sales for Easter. But despite the lure of the Easter egg hunt, many producers say the holiday ranks well below Thanksgiving and Christmas in egg demand. San Diego County egg farmer Frank Hilliker says he sees "a nice little bump" in sales this time of year. Then again, the holiday isn't the driver it used to be for farm-fresh eggs. These days, he says, "those plastic eggs kind of rule the world."

Strawberry Demand Fuels Increased Planting in California

Strong demand for strawberries is encouraging California farmers to plant more. Strawberry acreage in the state is up by more than 6% since last year. A new report from RaboResearch says the U.S. market accounts for more than 2 billion pounds of fresh strawberries, with strawberries ranking just below bananas and apples in household consumption. RaboResearch predicts strawberry production will peak in May, led by harvests in California.

Focus on the Debt First, then Save and Invest

Dear Dave,

My husband and I have paid off all our credit card debt, and we are following your Baby Steps plan. We still owe about \$40,000 on two cars, and our combined income is around \$150,000. Since we have a good income, we were thinking about finishing our emergency fund and contributing to our IRAs while we finish off the car payments. Under the circumstances, is this okay?

- Paola

Dear Paola,

I understand the temptation you guys are facing. But there's a power in behavior modification on a short-term

basis that supersedes the power of mathematics. Stick to the plan, and pay off the cars first.

When you're still on Baby Step 2, you need to stop all saving and investing, and attack your debts with a vengeance. You've got a lot of money wrapped up in cars, and even with all the great work you two have done I know it's probably still a little hard to see light at the end of the tunnel. Debts that large can be intimidating.

But I'm afraid you'll lose focus and intensity when it comes to getting out of debt if you worry about your emergency fund and setting aside for retirement too soon. I've seen that happen to lots of people, and when it does it can end up taking several years to get rid of all that debt.

payments can be history in about a year and a half. Think about how fast you can get that emergency fund in place then, and how much money you'll have freed up to go into retirement.

World's Most Extreme Pro-Abortion Bill Signed as World Recoils

Those are the names given to five children allegedly killed by an abortionist near or at term - whose remains were recently recovered in the Washington, DC, area by pro-life activists. The five were among 115 babies' bodies allegedly discarded by an abortion clinic and scheduled to be incinerated at a Maryland power plant.

The extremely graphic, gruesome, and deeply disturbing images of those five children have now been made public.

The Progressive Anti-Abortion Uprising organization, whose members turned the remains over to authorities, said in a press release, "Their late gestational ages as well as their apparent sustained injuries potentially show violations of the Partial Birth Abortion Act as well as the Born Alive Infants Protection Act which are federal crimes."

Pro-life activists and members of Congress are calling for full investigations. In contrast, Democrat lawmakers in states across America are working to rapidly pass laws granting immunity for the slaughter of babies in the womb up to birth, and in some cases after birth up to 28 days!

Democrats are feeling the pressure to enshrine radical abortion rights now out of fear that the U.S. Supreme Court decision in the pending case of Dobbs v. Jackson Women's Health Organization will reverse its infamous 1973 pro-abortion decision of Roe v Wade. Since Roe, abortion has taken the lives of at least 63 million children in America and has been the number one cause of death worldwide for many years.

Among the disturbing provisions of new Colorado law (deceptively called the "Reproductive Health Equity Act"):

Unborn babies are explicitly stripped of any rights under state law.

All babies can be aborted at any time up to birth with no civil or criminal legal consequences for anyone.

Minors are empowered to obtain unlimited abortions with no parental notification.

While a number of Republican-led states have passed laws protecting the unborn in anticipation of Roe's reversal, Democrat led states are following Colorado's lead. California and Maryland are even considering measures allowing babies to be killed after birth - outright legalizing infanticide. It's a strategy to create abortion 'sanctuary' states ahead of the possible overturn of

Children are a gift from God (Psalm 127:3), and shedding innocent blood is an abomination to Him (Prov. 6:16-19).

In the Bible, Israel was forbidden from worshiping the false god Molech (Lev. 18:21), a practice which involved child sacrifice. Biblical scholars believe Molech's priests would place live infants into the outstretched arms of the idol, which had been superheated by fire, cooking the child to death. The sacrifice was committed to earn prosperity from the false god.

How different are Colorado and other Democrat-controlled states these days from the cult of Molech? In just 50 years, activists have gone from claiming a "right" of abortion (not found in the U.S. Constitution), to demanding taxpayer funding and enthusiastically supporting the death of babies up to and well after birth.

Is the outright butchery exposed in images of aborted children in Washington any different than the detestable ritual of child sacrifice to Molech? Consider recent reports of women happily taking abortion pills on the Supreme Court steps while taunting prolife activists - all for the attention of the adoring left-wing media.

The overturn of Roe is far from certain. But even if it is ultimately retracted by the High Court, states under Democrat control (like Colorado) will still be abortion havens. Americans who value the sanctity of life and want unborn babies protected must continue to stand for truth, insist that lawmakers protect life, work for the election of genuinely prolife candidates, and resist all attempts to legalize the barbaric practice of child sacrifice.

Warmer Temps Bring Focus on Mosquito Awareness Week

Office of Senator **Bill Dodd**

SACRAMENTO, CA (MPG) - With warmer weather hastening the arrival of mosquito season, posing a public health threat to California communities, Sen. Bill Dodd, D-Napa, announced his resolution marking April 17- 23, 2022 as Mosquito Awareness Week.

"Mosquitoes are more than a nuisance - they are a real public health threat," said Sen. Dodd, who authored Senate Concurrent Resolution 93. "I encourage all California residents to take precautions to protect themselves and their families from mosquito-transmitted

diseases. Dumping and draining standing water around your home and yard are easy ways to eliminate mosquitoes in your community."

Mosquito experts say warm spring temperatures are prompting an early mosquito season and drought conditions may lead to increased West Nile virus activity. In general, mild winters have been associated with West Nile outbreaks, according to the U.S. Environmental Protection Agency.

Spread by Culex mosauitoes. West Nile virus is the most prevalent and serious mosquito-borne disease in California. There is no human vaccine for West Nile virus, a disease which can cause debilitating cases of meningitis, encephalitis, and even death. In 2021, there were 127 human West Nile virus disease cases from 28 counties in California, including 12 human deaths. Since 2003, more than 7,000 human disease cases have been reported, including more than 300 deaths.

And as California residents brace for a third year of drought, mosquito experts are concerned that the lack of water is also conducive to the spread of invasive Aedes mosquitoes, whose eggs are resistant to drying out and can survive for many months. These mosquitoes are particularly hard to control and pose a public health threat because they have the potential to spread serious diseases like Zika, dengue, chikungunya and yellow fever to people, and animal heartworm to pets.

"Climate change is

magnifying the spread of invasive species, and we are seeing the effects first hand as invasive Aedes mosquitoes continue to spread throughout the

state," said Ken Klemme, president of the Mosquito and Vector Control Association of California. "As drought mitigation measures are put into place, it is important for residents to remember that mosquito production can occur in water sources as small as a bottle cap. Water storage containers need to be sealed properly, and swimming pools and ornamental ponds should not be

Mosquito experts say the future of mosquito control requires innovation to protect the public from mosquito-borne disease risks. Specifically, mosquito and vector control agencies in California are exploring the potential use of three innovative technologies: self-limiting mosquitoes, Wolbachia and irradiation.





"ALL THE OLD KNIVES" **CEREBRAL SPY STORY; "FLATCH" ON FOX**

"ALL THE OLD KNIVES" Rated R

Amazon's "All the Old Knives" is not the type of espionage thriller one has come to appreciate in the James Bond series. This is a cerebral affair akin to something that might have been written by John le Carre and then adapted to film like "Tinker Tailor Soldier Spy."

Expecting anyone to draw a gun resulting in a protracted shootout will not come to fruition. Notwithstanding the title, no one pulls a knife unless to carve a juicy tenderloin. Don't recall that happening.

No explosions or extended car chases ensue. At one point, we see veteran CIA case officer Henry Pelham (Chris Pine) driving a spiffy convertible near the Big Sur area and it looks like he's adhering to the speed limit.

Why is Henry driving the scenic route along the coast of Northern California? We'll get to that soon enough, but first Henry is stationed in cold, wintry Vienna where he reports to CIA Chief of Station Victor Wallinger (Laurence Fishburne).

On a bleak morning in the capital of Austria, Chief Wallinger delivers some explosive news about an airline terrorist attack that remains unsolved from eight years ago.

A Chechen extremist by the name of Ilyas Shushani (Orli Shuka), apparently the mastermind behind a deadly hijacking that killed more than 120 airline passengers and crew, has been captured by the agency.

During interrogation, Shusani reveals that a mole in the Vienna station provided vital intelligence to the hijackers, resulting in the tragic loss of life. Faced with this new information, Henry is assigned to reopen the case of Flight 127 to find the traitorous double agent.

The mission means revisiting painful memories and laying traps for old friends, and even for a spy as adept at compartmentalizing his emotions as Henry is, that's no easy task.

First stop on the cold trail is where Henry meets at a London pub his cagey former superior Bill Compton (Jonathan Pryce), who was second in command in Vienna during the terrorist attack on the airliner.

Long since retired from the agency, Bill

considers the incident ancient history not to be dredged up, but Henry points out several disturbing inconsistencies in Bill's story that suggest he knows far more than he's letting on. The path forward now leads Henry to

Carmel-by-the-Sea to question another retired Vienna colleague, Celia Harrison (Thadiwe Newton). More than just ex-coworkers, Henry and Celia were once passionate lovers.

The relationship fell apart after the hijacking disaster. Celia is now married with children, but romantic sparks reignite when they meet at stylish cliffside

Reminiscing about their bittersweet past over a meal gives way to a more intense situation as the conversation drifts into a sly cat-and-mouse game played by two

Common to many spy thrillers, red herrings arise to tempt the viewer into identifying the culprit. In the end "All the Old Knives" is not that compelling but Pine and Newton have enough chemistry to make their seaside reunion worth watching.

"WELCOME TO FLATCH" ON FOX

Flatch, Ohio, a fictional small town with a population of 1,526, is the setting for the new FOX comedy "Welcome to Flatch," a mockumentary that follows the daily routines of two cousins who are best friends.

The show has the same sort of style as series like "The Office" and "Parks and Recreation," and "Welcome to Flatch" takes a cue from the former by being based upon a British comedy series called "This Country."

The cousins are twentysomethings trapped emotionally, it would appear, in their teen years as they navigate the stereotypical mundane life of a small town where the highlight of the year is the Scarecrow Festival.

Kelly Mallet (Holmes) and Lloyd "Shrub" Mallet (Sam Straley) are motivated, respectively, to win the skillet-tossing contest or taking the prize for the best scarecrow, and other kicks come from messing with the local bus driver.


Colorful town character Mandy "Big Mandy" Matthews (Krystal Smith) notes that Flatch has only two restaurants, one with menus, and observes that youth are the future while excluding Kelly and Shrub as "walking disappointments."

One of the more recognizable cast members is Seann William Scott's Father Joe, the local minister who ends up helping Kelly with her scheme to create a ride share business called "Kuber."

Kelly is quite amusing telling Father Joe that she is "an idiot savant with business ideas" who comes from a "long line of business tycoons" because her father ran a Christmas tree farm and her grandmother operated a "successful black market cigarette ring in prison."

Eccentric characters abound in Flatch. Nadine (Taylor Ortega) pitches the Flatch Historical Society's efforts to preserve a historic outhouse and Aya Cash's Cheryl gave up big city reporting to be the editor of the "Flatch Patriot" with a circulation in

Big Mandy tells the documentary crew that there's no decent place to stay in Flatch. The TV viewer, of course, is only visiting, and "Welcome to Flatch" may be worth a look.

Next Hornets Coach Introduced

SACRAMENTO, CA (MPG) - Journeyman coach David Patrick was introduced as the new Sacramento State men's basketball coach on Tuesday afternoon, April 15, at the Hornet Athletic Center.

Patrick is the 15th head coach in program history. He most recently served as the associate head coach for the men's basketball team at the University of Oklahoma last season.

"It's a dream come true for me," Patrick said Tuesday at his introductory press conference. "(My family and I) have always wanted to come back to California in the right situation. I was in a good spot at Oklahoma (and) had no reason to leave unless it was for a great opportunity. When you see Sac State after being in NorCal for a long time, I just thought it was somewhere that was untouched, somewhere that could really blossom."

Patrick takes over for interim coach Brandon Laird, who stepped in for Brian Katz after he retired days before last season began following 13 seasons due to a health issue. The Hornets won five of their last seven games to end the season and had 11 total wins, the most wins for any first-year Sac State head coach in the Division I era. Laird spent 11 years with the Hornets program.

According to a report from The State Hornet, the student news organization at Sac State, Laird and Katz were unhappy with the mishandling of the coaching staff's departure by the Sac State Athletics Department.

Sac State Athletic Director Mark Orr has known Patrick for years, dating back to their days together at Saint Mary's College. Patrick served as an associate head coach for the men's basketball team from 2006-2010 while Orr was Director of Athletics and Recreation.

"The previous staff left great character here, that's where it starts at," Patrick said. "The talent is one thing but high character kids is what you want to be around. I can get the players, that's not the hard part. It's the character, it's guys that wanna win and guys that wanna win at a high level. And we'll do that here, I promise you that.

"We're going to recruit from the inside out. We'll recruit here locally and then build out from nationally and internationally."

It didn't take long for Patrick to get started

recruiting from the NCAA transfer portal.

On Monday, April 14 he signed 6-foot-9 Australian forward Hunter Marks, a three-year starter who is transferring from Hartford. Several college basketball reporters were surprised Marks signed with the Hornets rather than a high-major school, indicating that the new Sac State coach got a steal of a prospect. Four days later Patrick reunited with Callum McRae, a 7-foot-1 Kiwi center who is transferring from UC Riverside.

Patrick brings many years of college coaching experience at several different stops with him to Sacramento. Since 2006 when Patrick retired from his playing career overseas, he has been an assistant coach at six collegiate programs.

In 2018, he got his first head coaching job at UC Riverside, where he spent two seasons. Patrick made an impact in his short stint with the Highlanders, as he currently holds the best two-year start in school history with a 27-38 (.415) record. In his second season at UCR, he led the team to a 17-15 record, which is the most wins in the program's Division I era.

"This isn't a steppingstone job for me," Patrick said. "I've got two girls that are (in)

tenth grade and sixth grade, we're not trying to jump spots. If you look at my resume, I've kind of moved a little bit the last year or two but that's not what we're about. We're about staying somewhere and staying here to make it last."

With his experience, Patrick has brought in some great players over the years. He has recruited 19 players who have gone on to play professionally with 11 of them playing in the NBA. Seven of those players were selected in the NBA Draft and four were first round picks.

In 2016 while Patrick was at LSU, his godson Ben Simmons was selected with the first overall pick in the draft by the Philadelphia 76ers. Simmons has gone on to become the 2018 Rookie of the Year, a three-time All-Star and has been selected to the All-Defensive First Team twice during four seasons in the league.

"I am so excited for coach Patrick to take on the role as head coach at Sacramento State," Simmons said in a Sac State news release. "He is one of the most underrated coaches and recruiters in the country. When I went through the recruiting process, there was never a doubt that I wanted to be coached by him. He is more than a coach,

he is family. He cares deeply about his players, not only as it relates to basketball, but also life."

Other current NBA players that Patrick has coached include Desmond Bane of the Memphis Grizzlies, Moses Moody of the Golden State Warriors and Patty Mills of the Brooklyn Nets. The 46-year-old Patrick has coached on five NCAA Tournament teams, four NIT teams and was an assistant coach on the Australian men's national basketball team that won bronze at the 2020 Summer Olympics.

"I think if you win in the classroom, you win on the floor," Patrick said. "This degree will help you longer in life because the ball is going to stop bouncing at some point. And this is a lifelong deal with me. I want to be at their weddings, when they have children, this is about a life term relationship, not just the four years that I'm going to be with these student-athletes."

Patrick said that he is going to rely on his older players and prioritize playing defense and rebounding.

"Everybody wants to shoot and play offense," Patrick said. "But they'll tell you the first day of practice every morning we're starting with bricks and getting after it. I promise you we'll be one of the best defensive and rebounding teams not only in the Big Sky (Conference) but in the country, I guarantee that."

The new Sac State men's basketball coach addressed the size of the Nest at his introductory press conference. The 1,012 seat multi-purpose gymnasium that the Hornets play in is one the oldest and smallest venues in all of NCAA Division I college basketball.

"The gym doesn't matter, it's the people," Patrick said. "If you're going somewhere for just the gym, you ain't going for the right reasons. (If we) get a real trust and relationship with these student-athletes, it doesn't matter where they play at."

Patrick will now attempt to do something that no Sac State basketball team, men's or women's, has ever done: Win a Big Sky Conference Championship and advance to the NCAA Tournament.

"People say, 'Why Sac State? Why would you take (the) Sac State (head coaching position)? You're at a Power Five job.' But I see this place being somewhere you can compete for Big Sky Championships yearly," Patrick said. "I promise you we'll win a lot of games here over at Sac State."
