

### **COVID News**

As of April 27, we had an increase in positive tests over the last week, with a kindergarten class at Tremont being the largest number of positive students. We continue to work with Solano Public Health on a daily basis to ensure that the proper protocols and reporting is followed. Total student cases: 15; Total staff cases: 2

COVID testing remains available at Dixon High School every Monday and Thursday from 2:00 to 3:30. Please register in advance through at www.dixonusd.org/ schoolclosureinformation

We continue to plan and offer more of the regular things that happen every year. To the delight of almost everyone. Please watch for information from your schools with the details. All three elementary schools are holding their Open Houses this evening, as an example. Check your school's regular communication locations if you somehow missed the information on them.

## Town Hall on **Student Behavior**

We held a Town Hall Meeting last Wednesday that focused on student behaviors, including bullying. Families were given the chance to share their concerns with the District administrators, including the principal from all of the schools. On Wednesday, May 4, we held the second meeting of three that are scheduled with May 11, for the third one. Our focus in this meeting is to provide information about laws and policies, and outline all of the District programs and work addressing the negative behaviors that are happening. The meetings are intended for families from all schools and grade levels to attend, and we encourage all of you to do so.

## State Testing

Our secondary schools are completing testing this week, and all reports are that students have been taking them seriously and problems have been limited. Elementary schools begin on May 16th, and we again encourage students and families to follow the suggestions that are being made by schools to maximize students' performance.

## Kindergarten Registration

We continue to encourage any family that will have a student in Transitional or regular Kindergarten to get enrolled at their school site immediately. We must be sure to have the

# Farmstead Senior Living Breaks Ground

DIXON, CA (MPG) - With a huge bulldozer helping to hold the waving banners of the Calson Management and J3C Group, about a hundred contractors, electricians, investors, administration, and family and friends of Jason Reyes, Calson's Managing Partner, celebrated the official groundbreaking of the new Dixon Senior Living facility at 350 Gateway Drive last week.

There was music and food, and even playhouses for the children-all exuding the warmth and personal care Reyes has built his reputation on as a creative and collaborative community visionary. A dozen shiny new shovels stuck upward out of a long mound of dirt so that instrumental supporters would all be involved in the ceremonial dig and official 'naming.'

"We asked all of our

## **Parade Morning Tips and Tricks**

This is my almost annual column on "parade tips" for the sake of those first-timers who may enjoy it all the more if the locals' secrets are known. As a disclaimer this year, though, remember that we have not had a parade for two years...

First of all, lots of folks bring their folding chairs and blankets down to the sidewalks along both sides of First Street from the Women's Improvement Club Park where it starts to the opposite end where the parade turns at the corner of Chestnut and the May Fair. The parade disperses at Hall Park at the end of Chestnut.

After a few years and being too late to find a good spot to sit and watch the parade Saturday mornings, I put out our chairs. I was worried about them being stolen. I was more endeared to Dixon when the next morning, I found that hundreds of chairs were still safe and sound.

This is where I plug the Rotary Pancake Breakfast at the Olde Vet's Hall across from the library (\$5 per plate.) It's just a great way to fill up the tummy before the parade. The pancakes are good and there is hot coffee plus, funds go for a great cause (student scholarships.) Oh, and make sure your children go to the potty before you leave!

Now, you have to remember that this is a parade-full of loud sounds. Music from bands and dance troupes blare, and there are roaring sounds from hot rods and firetrucks. Most children love the sounds but babies usually don't.

Years ago, I was holding my 4-month-old grand-daughter at the parade. She seemed delighted with all the colors and balloons and was happy... until a parade entry shot a canon. It sounded like a bomb. She crawled up my body in terror like a monkey trying to get away from a tiger.

When I couldn't find a place that would protect her (all storefronts were closed,) and the explosions re-occurred with her screaming again, I wrapped her close to me and ran as fast as I could until blocks away from the noise and finally got her calmed down. When I met up with the family afterwards, I had busted a vein in my eye and had several

cold sores that had popped out on my lower lip. My back was killing me, but the baby was good.

Now whenever I see strollers at the parade, I get nervous. My advice is to leave the baby with Grandma at home or miss the parade. For toddlers and preschoolers, give them a talk about what they can expect at the parade and show them how to cover their ears if the sounds are too loud.

Also tell them to NOT run out in the street to hug a giant costumed chipmunk or grab something off the street. Parade participants often have things to hand out (they are not allowed to throw from their vehicles) so you might want to bring a bag of some sort for your goodies; And, a blanket so you or the children can sit on a curb.

The parade can be an hour or two-depending on how many entries there are and how slow entries move in line so wear sunblock, bring a hat or visor, sunglasses and water. At press time, the forecast says partly cloudy and 82 degrees with only a 1% chance of rain and a slight wind

It should be a great day and lots to see! ★

"This is not a nursing home," said Sam Thomas, Senior Specialist Architect in a presentation last summer to the Dixon City Planning Commission. "The average age of our residents is 82 and our residents are still somewhat mobile." There will be a central-

"Growing old doesn't mean you're closing the book on life," Reyes said. "One of our biggest chal-

this generation in their 80s is that they still have a negative stigmatism of what [assisted living] is. We move people in all the time and soon, you can see them relax with a complete transition in four to five weeks."

Currently, Calson operates seven communities comprising over 640 units of senior living and totaling more than \$150 million in market value. In addition to Dixon, they have three other projects actively under construction in Los Gatos, Santa Rosa and San Jose, equating to another 368 units.

They can be altered to change your status, looks, value, and even power; however, altering shadows also come at a significant cost. Magic doesn't come free, and the cost can be time off your life, memories, or even your shadow altogether. But there were those who craved the need for power and those specialty alterationists who could provide the service. As a low-level con artist trying to change her life as a bartender, Charlie learned just enough art of manipulation to get by. Then a figure from her past returns, tearing everything apart. As Charlie's future straddles existent and non-existent, she will have to make some dark decisions to keep those she loves safe, which will ultimately throw her into a tumult uproar of murder, secrets, and hidden agenda's where everyone's sights are on controlling the shadows.

Holly Black takes readers on a dark, mysterious, and magical ride where innermost thoughts and fears are woven into a spine-tingling story. Black masterfully forces readers to imagine a world where shadows hold a unique power and influence and can be used to propel a person



into fame and fortune. Yet, these shadows also hide dark and gritty secrets, holding the key to your deepest desires, and for a fee, can be cosmetically altered, manipulated, changed, and even stolen. This chilling thought delivers the backdrop of a story bound to fly off bookstore shelves and keep readers afraid of the shadows that always lurk just out of reach.

### The Bone Orchard

Charm spends her days confined in a garden of Orchard House, where trees are grown from bones, and the marrow holds the darkest of secrets. As the last necromancer, Charm tends the garden, as well as to the boneghosts that she grew from the orchard. As the madam of the house, Charm is also the mistress to the Emperor, and when she is called to his deathbed, Charm is finally given a chance at freedom, but at a cost. Now, Charm is charged with the heavy burden to uncover who is responsible for the murder of the Emperor she despises, or vengeance for herself and the ghosts she tends and lose her chance at freedom.

Sara Mueller delivers a powerful story built on beautiful worldbuilding and complex characters. With the heavy weight of multiple agendas combined with politics, mystery, and fantasy elements, The Bone Orchard delivers on all levels. While this story does depict many sensitive issues and triggers, this plot takes a powerful turn opening the door for reflection and discussion for any book club.

## "MASSIVE TALENT" SPOOFS A FILM LEGEND; TCM FESTIVAL FINALE"

### "THE UNBEARABLE WEIGHT OF MASSIVE TALENT" Rated R

Nicolas Cage as a fictionalized version of himself in "The Unbearable Weight of Massive Talent" has odd parallels to troubled legal, real estate and tax issues in his past.

For all his perceived quirks, Cage is more than just an actor. In the words of director/co-writer Tom Gormican, Cage has become not only "a cultural figure," but the "patron saint of strangeness" and this film sets out to prove it.

In the dramatized tale of this film, Cage is first seen deep into compounding his personal and professional difficulties. His career is floundering and huge debts are about to put him out on the streets.

Divorced from makeup artist Olivia (Sharon Horgan) and not relating well to their teen daughter Addy (Lily Sheen), Cage receives the distressing news that he's not getting a great role that could easily launch his comeback.

Hallucinating at times with the surreal presence of his younger self named Nicky, apparently from his "Wild at Heart" era, Cage is admonished that he's a movie star and not an ordinary mortal dealing with family and career issues.

But the best that his smarmy agent Richard Fink (Neil Patrick Harris) can come up with is a strange invitation to collect one million dollars to attend the birthday celebration of obsessed fan Javi Gutierrez (Pedro Pascal).

With no other options on how to pay \$600,000 owed to his hotel residence, Cage ends up as the guest of honor at the eccentric billionaire's oceanfront estate on the Spanish island of Mallorca.

The movie-obsessed Javi, who includes "Paddington 2" as one of his personal favorites, maintains his own little museum of Nicolas Cage memorabilia, including film props and a life-sized wax figure brandishing two golden handguns.

Bonding over a love of cinema, Javi persuades Cage to take a look at a screenplay that offers a chance for their incipient friendship to evolve into a working collaboration that could easily be a caricature of Hollywood fantasy.

The wrinkle to this tale of fandom is that Javi is an international arms dealer, and two CIA agents (Tiffany Haddish and Ike Barinholtz) enlist Cage on a spy mission to rescue a kidnapped daughter of a political leader.

The movie turns into the kind of action thriller that was once the staple of Cage's career, and now he's mired in his screen persona of confronting thugs in the Gutierrez crime family with some gunplay and a car chase through quaint Spanish streets.

More than anything, "Massive Talent" places Cage in absurd situations of living up to his own legend, channeling his most iconic screen characters in order to save himself and his loved ones.

### TCM CLASSIC FILM FESTIVAL **FINALE**

The 13th TCM Classic Film Festival, or as I prefer to call it the 11th because the last two gatherings were virtual, came to an end with the usual flourish.

Classic films on display include fan favorites that most cinephiles have already enjoyed over the years. It's great to see Humphrey Bogart in "Key Largo" or Paul Newman and Robert Redford in "The Sting" on the big

On the last day of the festival, the better option was to choose films not as readily available. Watching Piper Laurie and Rock Hudson as young actors in 1952's "Has Anybody Seen My Gal" was a welcome treat.

Ostensibly, the star was Charles Coburn in the role of aging bachelor Samuel Fulton, a millionaire without an heir, who wants to find out if the family of the woman who rejected his marriage proposal decades ago deserves to inherit his fortune.

Fulton finagles his way into the home of the Blaisdell family as a boarder under an assumed name and arranges for them to receive an unexpected windfall and sits back to observe the results of his anonymous beneficence.

The family patriarch (Larry Gates), who runs a pharmacy and soda fountain in a small town, is prompted by his social-climbing wife (Lynn Bari) to sell the family home and business in order to relocate to a wealthy neighborhood.

Piper Laurie's Millicent, the eldest Blaisdell daughter, is romantically linked to Rock Hudson's soda jerk Dan Stebbins, but her disapproving mother tries to arrange a marriage with a rich socialite.

The nouveau riche status of the Blaisdells is soon derailed by poor decisions, and the family finds themselves broke and returning back to their old lives. Yet, everyone seems to be happier, and a life lesson proves that the grass is not always greener on the other

"Has Anybody Seen My Gal" is a remarkably agreeable and charming comedy, mostly due to Coburn's bluffing his way into an ordinary lifestyle, going so far as to train as a soda jerk with hilarious mishaps.

A bonus for film buffs at the screening was seeing James Dean in a cameo appearance as a soda fountain customer and hearing from Piper Laurie in person that Charles Coburn's fondness for pinching young ladies was problematic even back then.




