Newsom wants statewide panel to review any COVID vaccine

Coronavirus vaccines approved by the U.S. Food and Drug Administration in coming months will not be distributed in California until a statewide panel of health experts can ensure they meet safety requirements, Gov. Gavin Newsom announced Monday, October 19, 2020.

While there is no vaccine available yet, California and other states have been gearing up for its eventual distribution. On Friday, California sent a draft of its vaccination plan to the Centers for Disease Control and Prevention. In the draft, state officials said a scientific safety review workgroup, made up of immunization and public health experts from agencies

Here's How **California Keeps Early Votes Secret**

Some county registrars lock up equipment and threaten dismissal to protect California's early votes from being tallied before election day.

The state legislature changed election law this year so election officials could scan ballots as they come in, to deal with an expected crush of ballots well before election day. Officials wanted to be sure the count wouldn't be slowed by the decision to send each voter a mail ballot because of the pandemic.

Ballots have been coming in at a record pace. As of today, 32 percent of voters already returned their ballots, according to Political Data Inc.'s ballot tracker.

County elections departments are processing the ballots, but not compiling vote totals.

"(U)nder no circumstances may a vote count be accessed or released until 8 p.m. on the day of the election." the election code states. No one wants to influence the outcome of a race by releasing vote counts before the polls close.

Yet once a ballot is scanned, doesn't a computer take over? Isn't a vote total in there somewhere? Couldn't someone take a peek at it?

No, elections officials say. Scanning starts the process but doesn't total the votes.

"We don't generate any reports to know what the result is until election night," said Michael Vu, registrar of voters for San Diego County.

In San Diego County, the vote tabulation system does not connect to the scanner, he said. And the tabulator puts out a total only "when we ask it to," he said. That's election

Just to make sure there's no trickery, the tabulator is kept under lock and key in a separate room, he said. Only the few people who must tabulate votes have access and even they must sign in at the door. Vu said he doesn't even have keycard access to the room. There's video surveillance of the equipment, too.

Keeping scanning and tabulation systems separate appears to be common in California. Forty of the state's 58 counties use the same tabulation system as San Diego County, according to a list from the Secretary of State's office.

Shasta County uses the same system. Counting votes involves two servers,

has an ADA-approved restroom. The location in the middle of town with restaurants all around, would be a plus for opening a new history museum because of foot traffic and events held downtown," Hoffmann said.



Continued from page 1 back on the idea that a vaccine could be ready for safe distribution by then.

The drug company Pfizer is expected to have one of the first coronavirus vaccines. If its vaccine proves effective, safe and can be consistently manufactured, the company would apply for emergency use authorization in the third week of November, CEO Albert Bourla said in an open letter last week.

But even if ready in this calendar year, Newsom said, supply is expected to be limited and, just like previously with coronavirus diagnostic testing, people who are considered high risk would be first in line.

In one projection, Newsom said that about 45 million doses could be ready for national distribution by the end of this year. California would only get a percentage of these, and each person will likely need two doses. Health workers and first responders would be prioritized, followed by people with high risk of becoming severely ill if infected, according to the state's vaccination plan.

To the rest of Californians: Don't anticipate getting a vaccine at your local pharmacy anytime this year, Newsom

Newsom also acknowledged that the state will need to work through some logistical hurdles. Some of the prospective

vaccines will need to be stored in cold or "ultra cold" spaces, and their administration would require additional supplies of needles, alcohol pads, bandages and more face masks as doses become available.

Celebration of Life for Veteran Greg Coppes this Saturday

DIXON, CA (MPG) - People who knew Greg Coppes might have described him as 'rough around the edges'as he was good about being direct and opinionated – but all knew his dedication and love for his family, athletics, and the local veterans. It was devastating to hear the news that Greg was killed last Wednesday evening on a motorcycle jaunt to Fairfield with other Veteran Riders. He was 65.

Greg and Patti Coppes raised three children in rural Dixon and now have grandchildren. After serving in the US Air Force, Greg owned American Commercial Electrical since 1985. He spent many years coaching youth football thus earning the affectionate title of "coach" and also regularly volunteered at the Northbay Stand Down for Homeless Veterans.

He was instrumental in getting the Veterans Memorial Hall that was originally built as a strip mall and then managed it for several years thereafter, creating it to be a popular coffee spot in the mornings and Bingo/bar at night.

He was a former Commander of the American Legion Post 208 in Dixon and founded the Veteran Riders of Napa and Solano Counties, a large group of motorcyclists that became a tight-knit family of friends. As a make-ithappen personality, Greg was also successful in securing a prime spot for the annual fireworks fundraiser across from the Safeway Store that raised thousands for the veterans.

The Solano Area California Highway Patrol responded to the motor-

off-ramp to Manuel Campos Parkway and an ambulance responded.

Greg was riding with a group of other motorcycles when the group exited Interstate 80 at the Manuel Campos off-ramp when for unknown reasons, his 2007 Harley Davison motorcycle left the roadway, crashed into a drainage trench and he received major injuries. He was transported to Kaiser Permanente Vacaville where he died.

As the news spread around Dixon, many folks expressed shock and grief. Many posts poured out on the Napa Solano Veteran Riders Facebook page.

"I don't know the details of what happened but I do know that I feel a huge hole in my heart. Coach was my Brother in the wind and a true Patriot," said one.

'There are a million phrases the club uttered while standing outside the ER last night. Tears were shed, brothers were reunited, old rivalries dismissed. Coach was our leader, who left not only a legacy but a fleet of men ready to carry the torch for him well beyond his plan. He had no regrets, for he was never one to keep his opinion to himself. To be so lucky..." another writer posted.

"Coach had a dream. He wanted to take a ragtag group of Veterans and turn them into something monumental. His focus and effort paid off. This club went from an oppressed corporate organization to a loyal band of brothers worthy of the MC cube. He loved riding, loved the biker community, and loved his family, both direct and club," was part of the tribute.

According to the CHP report, alcohol and/or drugs were not suspected to be a factor in the collision.

He is survived by his wife, Patti, three children, and several grandchildren including expected twins. A celebration of life will be held this Saturday, October 31, at 11 am at the Dixon Veterans Memorial Hall. 1305 North First Street.

In lieu of flowers, donations can be made in Coppes' honor to the American Legion Post 208, 1305 North First, Dixon 95620 allowing him to continue to serve other veterans.


DIXON, CA (MPG) - Dixon residents may drop off their signed and sealed ballot at the City of Dixon up until Tuesday, November 3, 9 am to 5 pm. That is at City Hall, 600 East A Street.

Curbside drop-off can be done at the Dixon Senior/Multi-Use Center at 201 South Fifth Street. Hours are 8 am to 5 pm, including Saturday, plus 7 am to 8 pm on Election Day, Tuesday, November 3. This is ideal for those who have difficulty getting out of a vehicle or prefer to exercise as much safety as possible from the COVID virus.


In addition to the senior center, other polling places include the Veterans Memorial Hall at 1305 North First Street, CA Jacobs Middle School at 200 North Lincoln Street, and the Dixon Moose Lodge, 180 West B Street. Your voting place should be listed on your ballot but you can also go online and see a map also on the Solano County Registrar of Voters page.

On Election Day, ballots can be dropped off at any location listed on the Solano County website, listed on the ROV page, plus 100 poll-place locations also listed. They are located in every city in Solano County.

Press Covers for Biden

Joe Biden is the most cosseted presidential candidate in memory.

He's run a minimalist campaign that's avoided the press as much as possible, while the press hasn't been braying for more access and answers, but eager to avoid anything that could be discomfiting to the campaign.

Never before has the media been so openly fearful of asking or reporting something that might hurt a presidential candidate. Even the lowest common denominator of news simply being interesting – has been tossed aside. Boring and uneventful is the new newsworthy.

The tendency reached a new level in the media's handling of New York Post reports on emails obtained from a laptop that Hunter Biden reportedly left off at a Delaware computer repair

Here was a story with enough mysteries and plotlines to keep a couple of newsrooms busy. Are the emails, putting Hunter Biden's sleazy overseas business dealings in a more sinister light,

legitimate? Did Hunter really take the laptop to the shop and forget about it? And, more importantly, what do the emails say about what Joe Biden knows or should have known about Hunter's work that depended so heavily on proximity to the vice president?

Instead, the press has been uninterested at best and hostile at worst. It's the opposite of a feeding frenzy. The media has deployed its bomb disposal unit for fear that a potentially explosive story might detonate.

What Biden has to say about the emails is inherently of interest. Yet, he wasn't asked about it at his recent ABC News town hall. Never mind that his response would have made headlines afterward and the clip would have been shown in every TV segment about the debate.

Subsequently, CBS reporter Bo Erickson betrayed his profession by asking Biden his response to the Post story on a tarmac. He got slammed by Biden, "I have no response, it's another smear campaign, right up your alley, those are the questions you always ask." No one rallied to Erickson's defense. Instead, respectable figures on the center-left shamed Erickson for having asked a politician an unwelcome question - which, the day before yesterday, would have been considered Journalism 101.

Much of the press has pronounced the Post story debunked without doing any work to debunk it and believes as a matter of faith that it is Russian disinformation. Rather, the focus has been reporting on how the Post reported the story, as the press works to discredit media outlets that don't toe the correct political line – you know, just like Woodward and Bernstein did during Watergate.

This tendency toward "anti-reporting" has long characterized Biden coverage. The New York Times took 19 days to cover Tara Reade's sexual assault allegation against him, not wanting to burden its readers with information about a newsworthy charge too quickly.

Any Biden misstep is quickly explained away. The press doesn't seem to mind that the campaign is prone to declare "lids" - or the end of the candidate's public day early and often.

Usually, the media loves candidates who make good copy, who provide drama and color. In its hatred and fear of President Donald Trump, though, it has thrown in its lot with the dull and meandering Joe Biden, bringing to the effort all the complacency and pointed incuriosity it can muster.

said Cathy Darling Allen, registrar of voters. They are separate. The first server stores data generated by the scanners that read the ballots. The second is a reporting and tabulation server that runs a different program.

"That's the server we use on election night," she said. Both are kept in a protected area.

In San Joaquin County, scanners and vote tabulation software are supplied by a different company, but the result is the same: the system scans ballots without tabulating them. Eleven counties use this

No one can sneak in, run the numbers and take a peek without getting caught,

said Joseph Holland, registrar of voters of Santa Barbara County. "They'd be fired" if they did, he said.

For security, Holland said two people are required to access the tabulator. And whenever anyone accesses the tabulation server, it creates a permanent record called an audit log that cannot be removed from the system.

Finally, the equipment is not connected to the Internet. That's the law to thwart hackers and prevent tampering.

Wildfire Survivors Can Apply for Federal Aid Even if Insured

Governor's Office of Emergency Services

SACRAMENTO, CA (MPG) - If you suffered personal or business losses in the devastating wildfires that broke out in August and you're waiting for your insurance settlement before you register with the Federal Emergency Management Agency, don't delay any longer. Disaster assistance may be able to fill insurance gaps or provide help if you've been waiting more than 30 days on a homeowner's claim. Another reason not to delay: the deadline for registering with FEMA is Nov. 23, 2020.

By law, FEMA cannot duplicate insurance or other benefits. However, it may be able to help with uninsured or underinsured losses if the insurance settlement is delayed.

FEMA may also be able to help:

If you have received the settlement from the insurance company but you still have unmet needs; If you have exhausted the settlement for Additional Living Expenses (ALE for loss of use) and you need disaster-related temporary housing; If your settlement does not cover disaster-related needs such as medical, dental and funeral costs, emergency home repairs and other disaster-related expenses.

Register with FEMA:

Online, by visiting www.disasterassistance.gov; By downloading the FEMA app to a smartphone or tablet; Or by calling the FEMA Helpline at 800-621-3362 (TTY 800-462-7585). Multilingual operators are available. The toll-free lines are open 7 a.m. to 10:30 p.m. PDT daily. Helpline operators are also available to answer questions about applications already submitted.

The registration process includes your providing a phone number so FEMA can contact you and set up a virtual home inspection. If you use a relay service such as a videophone, Innocaption or CapTel, you should provide FEMA your specific number assigned to that service.

If your settlement has been delayed longer than 30 days, you may write FEMA to explain your situation. Provide insurance documentation to prove you've submitted your claim, including the claim number, the date you applied and how long you estimate it will take for the company to settle, and mail your letter to:

DIXON, CA (MPG) - On Wednesday, October 28, 2020, the Dixon Public Library created a community altar (ofrenda) on the steps of the original Carnegie library, facing B street. We wish to honor the tradition of Día de Los Muertos (Day of the Dead) and to honor the relatives and friends that our community has lost. We invite you to participate in this community ofrenda by placing photos or other offerings in the ofrenda. It will remain on the steps of the library until the morning of Tuesday, November 3, 2020. Please do not place valuable items in the ofrenda. Your items will not be returned to you.

Traditionally, Dia de Los Muertos is not a time for sadness. It is a time for celebration and remembrance of those who are no longer with us. Typical items placed on an ofrenda are: Pan de Muerto (Bread of the Dead), which is criss-cross shaped, representing bones, and signifies the generosity of the host; white candles

which represent hope and faith, or purple candles for grief; skulls representing the people who have passed (when using sugar skulls the sugar symbolizes the sweetness of life); marigold flowers, often referred to as "Flor de Muerto" (Flowers of the Dead), the strong scent and bright orange blooms are believed to help attract souls to the altar; Papel Picado (Perforated Paper) the delicate paper symbolizes the fragility of life and photos of loved ones who have been lost.

We hope that our community ofrenda inspires you to create a personal ofrenda of your own to create a new family tradition or continue your family tradition of honoring those who are no longer with us and their contribution to our lives our community. 
Fatal Motorcycle Collision


Horrid

California's Vague New **Financial Regulation Law**

Assembly Bill 1864 didn't get much media or public attention as it zipped through both houses of the Legislature on the last day of the 2020 session.

Superficially, it appeared merely to reconfigure the state's financial regulatory agencies into a new entity called the Department of Financial Protection and Innovation.

However, those in California's vast financial industry were paying lots of attention because the bill creates an entirely new regulatory regime with broad powers, including fines of up to \$1 million a day, to police financial players that hitherto have had little oversight.

The official rationale for the legislation is that President Donald Trump's administration neutered the federal Dodd-Frank Wall Street Consumer Financial Protection Act of 2010, so the state must step in with an equivalent to guard against predatory financial practices that harm consumers.

The new California Consumer Financial Protection Law gives the reconstituted agency authority to go after "abusive practices" whose definition in the law is fairly vague. Thus, the agency itself will define the term as it also Newsom also signed will face its scrutiny.

It appears that the new law will affect firms involved in debt settlement, credit repair, check cashing, rent-to-own contracts, payday lending, student loan servicing and financing for retail sales. However, its primary target seems to be financial services offered by non-banks, particularly what are called "fintech companies" that offer bank-like services via the Internet without maintaining physical offices.

Fintechs, many of them based in the San Francisco Bay Area, have blossomed in recent years as part of the digital economy, competing with traditional brick-and-mortar banks. Their disruptive nature is not unlike the challenge that technology-based ride services such as Uber and Lyft pose to taxicabs and buses.

Late-blooming changes in AB 1864 exempted traditional financial firms that are already regulated, such as banks and credit unions, from the new consumer protection law, leading some analysts to conclude that its unstated aim is to help them stave off competition from new kids on the financial

The vagueness of the new law was encapsulated in what Gov. Gavin Newsom said during a signing ceremony. The new law and the new department, he said, will "create conditions for innovation to flourish in a way where we can steward that and we can just work against its excesses. So we support risk-taking, not recklessness.'

tection measures, one that requires debt collectors to be licensed beginning in 2022 and the other creating a Student Loan Borrower

with the lights on.

Bill of Rights. Although the new state law is said to mirror the Dodd-Frank law, it contains at least one significant difference. When federal regulators levy fines for what they consider to be bad conduct, the money goes into the federal treasury. When state regulators impose their fines of up to \$1 million a day, the money will be retained by the new agency to finance more activity.

Will that give the new agency a financial incentive to skip over minor consumer issues and go after big companies? It's a question that only time will

Significantly too, the new investigative and regulatory mechanism contained in AB 1864 specifically does not usurp the authority of the attorney general to also target companies under the state's equally vague "unfair competition" law.

From its inception a decade ago, Dodd-Frank has attracted criticism from business executives for regulatory overkill. Will California's new version be less controversial? We won't know until the new agency puts some definitional meat on its bones.

"GANGS OF LONDON" **IGNITES BRUTAL CRIMINAL TURF WAR**

A Film and TV Review by Tim Riley

"GANGS OF LONDON" ON AMC+ NETWORK

Brutal, gruesome violence on cable television is nothing new. Stabbings, amputated extremities, mutilations, beatings, slit throats, mauling by wild animals, crushed skulls and eye-gouging have become staples with many series.

We may think television programs like "Game of Thrones" and "American Horror Story," to name two of a zillion, are unique on the scale of bloodshed, but then along comes the British entry of "Gangs of London" on the AMC+ ad-free premium

From the very first frame, "Gangs of London" wastes no time establishing its ruthless criminal underworld milieu. Dangling from a high-rise building, a victim witnesses his assailant pouring gas on the rope that holds him high above the

Ignoring the pleas of his quarry, the man sets the rope on fire as it gradually burns through, dropping his prey screaming in pain from the flames to his inevitable death on the concrete pavement.

In a flashback to a week earlier, two jittery young men await a text message that sends them off to a seedy apartment building in Little Albania. Apparently, a drug deal is about to go down as one enters the building while the other waits in the get-

Arriving moments later in a luxury sedan is Finn Wallace (Colm Meaney), the leading crime boss of London. For reasons not readily apparent, he enters the same building while his driver Jack (Emmett Scanlan) waits outside.

The young man waiting in the building, Darren (Aled ap Steffan), is on a mission, but exactly what we're not sure. Then in a flash, Finn Wallace, standing outside an empty apartment, is gunned down in a hail

As the head of an organization which united the city's most prominent gangs, Finn's demise leaves a huge power vacuum. First of all, nobody knows who ordered the hit that ostensibly employed two punks to do the dirty work.

With rivals everywhere and billions of British pounds at stake, it's up to the impulsive, hot-tempered Sean Wallace (Joe Cole), with the help of the Dumani family, to take his father's place.

The patriarch of the Dumani family is Ed Dumani (Lucian Msamati), and he has been Finn's right-hand man and consigliere ever since they seized control of London's underworld two decades ago.

A skilled tactician, Ed Dumani is an influential figure within the Wallace organization who explicitly runs the criminal side of the business. With the approval of his mother Marian (Michelle Fairley),

Sean is ready to take thereins of the family enterprise.

Following his father's funeral, Sean makes it known to the leaders of the city's other gangs that his primary objective is to first find out who ordered the hit on Finn, followed by cementing his place at the top of the Wallace empire.

Since all of London's organized criminal activity appears to get the green light from the Wallace clan, there may be any number of suspects that wanted to bump off Finn, which is another reason Sean is fixated on exacting revenge.

Flexing his underworld muscles, Sean orders all criminal business in the city to be held in abeyance until his father's killer is identified. To no one's pleasure, Sean manages to close all the ports to incom-

Haunted by the ghost of his father, Sean must prove to his enemies as well as his mother that he should be in charge, even if he must destroy the business. One crime lord observes that "a boy like him would burn cities just to convince the world he's a man."

Meanwhile, Elliot Finch (Sope Dirisu) is a bottom-rung criminal hoping to work his way up the Wallace organization for reasons that could easily imperil his own life, but he proves his worth by taking on some Albanian thugs with the help of Alex Dumani (Paapa Essiedu).

The brawl with the Albanians at the pub across the street from where the Finn Wallace funeral takes place is such an

epically vicious fight that Elliot bounces one thug's head so hard on the bar counter as to impale his face with a beer mug.

The storyline of revenge and criminal activity may seem straightforward but there is much to follow in terms of characters from the Wallace and Dumani families, to say nothing of the criminals from different nationalities operating on British soil.

Aficionados of the gangster genre may be intrigued by the callous and violently bloody carnage of "Gangs of London," which despite being a cable program feels like a distant cousin of feature length films such as "Goodfellas" and "Scarface."

Anyone hoping that the setting of ondon might feature all the picturesque areas of the city that look so inviting will be disappointed. The scenery shifts too often from gritty slum areas to drab highrise buildings under construction.

While "Gangs of London" does not stint on violence, the intense drama benefits from effective character development that keeps you wondering about the various threads of dangerous actions that can easily go astray.

FBI Reminds Public about Election Security and Foreign Influences during Elections

For decades, the FBI has served as the primary law enforcement agency investigating federal election crimes. This includes investigating allegations of voter and ballot fraud, campaign finance crimes, civil rights violations, unique cyber threats targeting the election process, and threats posed by foreign governments and actors. The FBI is also the lead federal agency for identifying and combating malign foreign influence operations targeting our democratic institutions through the FBI's Foreign Influence Task Force (FITF). The FITF brings together all FBI authorities and capabilities from multiple divisions to include counterintelligence, cyber, criminal, and counterterrorism assets to coordinate and work together to combat the threat.

"Every American should be free to vote without interference or discrimination and

have their vote count," said Special Agent in Charge Sean Ragan, who leads the FBI Sacramento Field Office. "The FBI is committed to ensuring safe, secure elections and thwarting the actions of any foreign actors who may attempt to influence our elections for their own political or national interests. Our office continues to engage with law enforcement partners and election security officials to ensure the security of our national elections and preservation of this important civic right."

Each state has primary responsibility for conducting free and fair elections within its borders. The FBI Sacramento Field Office serves communities located in 34 of California's 58 counties and is in continuous contact with election partners including the California Secretary of State, Justice Department, U.S. Department of Homeland Security, U.S. Postal Inspection Service, and other agencies. Together, we stand ready to investigate federal election crimes, identifying and assessing potential threats, and to protecting the public's constitutional right to vote.

Richard McCormick Found Guilty on Ten Counts of Sexual Assault

SOLANO COUNTY, CA (MPG) - On October 23, 2020, after a two week trial in Department 11 of the Solano County Superior Court before the Honorable Judge William J. Pendergast III, Defendant Richard McCormick was found Guilty as charged on ten counts of sexual assault against three separate minor victims. Defendant Richard McCormick was found Guilty of four counts of Sexual Penetration with a Child Under Ten Years of Age in violation of Penal Code § 288.7(b), two counts of Oral Copulation with a Child Under Ten Years of Age in violation of Penal Code § 288.7(b), three counts of Lewd and Lascivious Acts Upon a Child in violation of Penal Code § 288(a), and one count of Continuous Sexual Abuse in violation of Penal Code § 288.5(a). The defendant was also found to have suffered a prior felony

strike conviction for Residential Burglary. Between 1990 and 2018, the defendant repeatedly sexually abused family members. The victims, who are now 9, 10, and

35, courageously testified about this horrific sexual abuse. The defendant testified that any touching was either a misunderstanding, initiated by one of the child victims, or a false allegation. He further testified that he was the only victim in the courtroom. The jury was unpersuaded by his fabricated testimony.

Defendant remains in custody without bail and is scheduled to be sentenced on January 15, 2021, at 8:30 a.m. in Department 11 of the Solano County Superior Court.

Detective Steven Carnahan of the Fairfield Police Department investigated the case. The case was prosecuted by Deputy District Attorney Elaine Kuo. Victim Witness Advocate Jeffrie Lelea provided victim advocacy.

Solano Area Major Injury Pursuit

SOLANO AREA, CA (MPG) - On October 23, 2020 at 5:07 p.m., Solano Area Officer Scott Heitman, was driving on Interstate 80 eastbound, just east of Pitt School Road, in heavy stop and go traffic. Officer Heitman observed a gray Ford F150 pickup truck pass his location on the right shoulder at approximately 60 miles per hour. Officer Heitman positioned his patrol vehicle behind the Ford and an enforcement stop was initiated. The Ford did not yield to the patrol vehicles lights and siren. The Ford proceeded to rapidly accelerate while using the right shoulder. Traffic on the freeway decreased and Officer Heitman used the #1 lane (fast lane) to track the Ford. The Ford accelerated to an estimated 85 miles per hour

when the driver intentionally (later verified by the driver's statement and video recording) drove across the grass shoulder and collided with a large tree. After the collision, the truck immediately burst into flames. Officer Heitman used his fire extinguisher, after which he and a bystander (off duty California Department of Corrections and Rehabilitations Officer) attempted to remove the combative driver. With help from the bystander, Officer Heitman was able to rescue the driver from the burning Ford. The driver suffered major injuries and was transported to Kaiser Permanente for medical treatment. The driver will be receiving care for his personal wellbeing prior to release from Kaiser Permanente. Felony charges for evading arrest in a reckless manner have been filed with the Solano County District Attorney's Office.



America's Frontline Doctors Censored by Big Tech

At least a dozen medical doctors from all over America assembled in front of the Supreme Court July 27 to counter the only message going forward allowed the American people with respect to the coronavirus. Many had already experienced the removal of their messages on Google, which owns 70% of most American media outside Fox News, including FaceBook, and YouTube (Tucker Carlson Tonight, June 16, 2020).

Outside their COVID expertise they had one thing in common that made their contribution superior to those of Anthony Fauci (a vaccineologist), the CDC and WHO, they are the actual physicians of those with COVID-19. They also each had come independently to the conclusion that the 65-year-old drug hydroxychloroquine used so successfully in COVID-1 previously, also worked extremely well with its cousin COVID-19 "it's 78% similar to the prior version the COVID-1.
