Dixon May Fair Cancelled Due to COVID-19 Concerns

DIXON, CA (MPG) - For Dixon, 2020 will be remembered as "The Year There Wasn't" - when dozens of well-loved local traditions were cancelled due to the historic Corona Virus pandemic.

Even the 145th Dixon May Fair, which was scheduled for May 7 -10, will not be held this year. The fair has been the oldest continuing fair in California.

According to Bill Schroeder, President of the Dixon Historical Society, the fair is believed to never been cancelled before – although the Parade at least once was due to rain.

May Fair CEO Pat Conklin thought the fair may have been cancelled once before during World War II – but she wasn't sure, and the Fair has no records to confirm that.

The May Fair Parade hosted by the Dixon Chamber of Commerce and which normally draws a crowd of over 6,000 people was also cancelled.

The annual Soroptimists Antique

Show cancelled earlier.

So too was the 28th Annual Dixon Mother of the Year (MOTY) Award. The Dixon Kiwanis Club was to take on organizing those awards, including distributing over 1000 nomination forms to Dixon schools. But after all the schools were closed, the project has to be cancelled.

The Dixon Scottish Games, held annually the last week of September, have also been cancelled, according to Phil Venable of the Dixon Scottish Cultural Association.

So too was he Kiwanis annual "Breakfast With The Bunny;" and the Knights of Columbus St. Patrick's Day Dinner; and the Dixon Family Services Comedy Night.

Still in jeopardy – but might be possible are the July 4 fireworks, the VFW Poppy Drive; Grillin' & Chillin': the Dixon Lamb Festival (the first weekend in October); the Downtown Business Association Tree Lighting; and some annual crab

No firm information yet on the

Dixon Toys for Tots / Community Christmas Programs.

Dixon churches have cancelled most open services. St. Peter Catholic Church cancelled all Masses, at the direction of Bishop Soto of the Sacramento Diocese. However, St. Peter's is live-streaming a 9 am bi-lingual Mass every weekday, and on Sunday an English Mass at 9 am and Spanish Mass at 11:00 am. Congregants can post comments on the face book page during the Masses.

St. Peter's church is also open daily for personal prayer and adoration. Parishioners may sign up for specific times for each day, both to make sure someone is in the church at all times. And the number of people there is sufficiently small. Holy Week services are also expected to be live-streamed.

At this time, it is unlikely there will be a community sunrise service Easter morning. If anyone plans to live-stream services,

DMV Offices to Continue **Serving the Public during COVID Outbreak**

SACRAMENTO, CA (MPG) -

The California Department of Motor Vehicles (DMV) is moving to offer Californians essential services online starting next week to continue processing critical transactions during the COVID-19 pandemic. Field offices will be temporarily closed to the public statewide beginning March 27 and reopen, virtually, on April 2. All in-office appointments at this time will be canceled. Customers are encouraged to check the dmv.ca.gov website for future appointment availability.

DMV online services will continue to be available at dmv.ca.gov. Customers can also take care of many tasks at the hundreds of kiosks throughout the state or through available local business partners. DMV's customer service centers will continue to operate during normal business hours at 1-800-777-0133 or connecting via the live chat feature on the DMV website.

DMV field office employees will return on Wednesday, April 1 to process transactions and begin training on the DMV Virtual Field Office, which began in a limited pilot March 23. The Virtual Field Office gives customers the capability to take care of transactions that previously required an in-person office visit by virtually interacting with DMV staff. Beginning April 2, customers initially can complete vehicle title transfers and complex vehicle registration renewals by visiting virtual.dmv.ca.gov. The DMV will gradually add more transactions to continue to provide alternatives to an in-person office

The DMV is concerned about the health and safety of its customers, including seniors and those at risk for COVID-19. Following deep cleaning of the offices, expansion of virtual services and development of new protocols, DMV will offer in-person services in each region. More updates on how DMV is addressing the needs of its customers will be announced soon on its website.

Californians who do not have an urgent need to go to a DMV field office should delay their visit, including those interested in applying for a REAL ID. The U.S. Department of Homeland Security has announced that the REAL ID enforcement date is October 1, 2021, and customers who want a REAL ID will have an opportunity to apply at a later date.

Rebuild CA Foundation Calls for Full Transparency and Accountability in Dealing with the Coronavirus Crisis

SACRAMENTO, CA (MPG) - Doug Ose, Chairman of the Rebuild California Foundation (rebuild-ca. org), issued the following statement:

"All levels of government work best with full transparency and accountability.

Transparency and accountability allow the voter to make informed decisions. Rebuild California Foundation strives to do the research and education necessary for an informed electorate.

As reported by the LA Times on Friday, California was prepared in 2010 for a pandemic: millions of masks, gloves and garbs for medical personnel; up to 21,000 beds of standby capacity; mobile capability to go where needed. Unfortunately, beginning in 2011, the Governor and the Legislature systematically dismantled the Health Surge Capacity Initiative. Consecutive budget year decisions by the Governor

and the Legislature meant that the relatively small amount of funding necessary to preserve California's ability to respond to a pandemic was re-programmed for other purposes.


In addition, policy judgements by the Governor and the Legislature contributed to a reduction in the number of laboratories that can be utilized to combat medical emergencies. According to a report in the Sacramento Bee, the number of laboratories that can do the testing needed has been reduced from 40 to only 29. In addition, funding for laboratory staffs has not changed since 2009; funding for the fiscal year ending June 30, 2020 for public health is the same the voters that live here."★

as it was for fiscal year ending June 30, 2010.

Further, our research indicates that the Governor has access to significant sources of non-public information that can serve to give leaders an early heads up for a potential emergency. We have not been able to determine when Governor Newsom was first briefed about the threat posed by coronavirus.

Finally, we are not privy to any discussions Governor Newsom may have had with Legislative leaders about the coronavirus crisis.

budget based on the amount it. But the Four Walls come of money on hand. If you have \$600 left to your name, budget out exactly where each of those dollars will go. It's time to squeeze every last penny out of what you've got. If you still have cash coming in from a spouse's job or some other source, then adjust your budget to reflect that. Maybe the two of you usually bring in a combined \$5,000 a month. Adjust your budget to live off that one income for the time

When the going gets tough, you need to focus on the things you really need to survive—food, utilities, shelter, and transportation. I call these the Four Walls. If there's any money left over after you take care of the Four Walls, make a list of what else you need to pay, and tackle those in order of importance. Reach out to anyone you can't pay, and explain the situation. They might be able to work something out, but they can't help if they don't know. Be up front with them, and pray for the best.

When you're just trying to make it to another day, you don't need to pay extra on debt. Instead, focus on piling up cash. Once life gets back to normal and everything is okay, you can pick up where you left off with your debt snowball. If it's within your budget to keep making minimum payments on your debt, go for DaveRamsey.

first. This is also the time to sell anything and everything you don't need to make some extra cash. With so much being shut down right now, there might not be as many traditional ways to make extra money. So, look into driving for Amazon, delivering takeout food, or dropping off grocery orders. LETTER TO THE EDITOR

Dear Editor and Readers of the IV,

I have received several emails with conflicting concepts about the vote of the Dixon City Council at the Special City Council Meeting two weeks ago. Since there are concerns that the council overstepped by voting to set up a civil fine structure for flagrant and repeat violations of the County Health Officer's Order, I would like to explain why it was so important to do so.

First off, the city did not create its own list of violations regarding COVID-19, it only created a civil penalty structure for violating the Solano County Health Officer's Order, which is slightly more stringent than the statewide order.

The reason this structure was and is necessary is because of the wording at the beginning of the Health Order that says, "Violation of or failure to comply with this Order is a misdemeanor punishable by fine, imprisonment, or both."

Given that statement, this order carries the full weight of the law and even has a criminal weight attached to it (misdemeanor), however it also says it is "punishable by fine." Fines are civil penalties and not criminal penalties. Violations with a civil penalty attached to them WILL NOT result in arrest so long as it is within the steps of a legal fine structure.

Without a legal fine structure for violations of a law, an officer enforcing that law must use criminal standards to enforce it if the unlawful action continues, which I would point out is disturbingly sanctioned in the County's Order explicitly by the use of the word "imprisonment."

At the special council meeting it was clear that not only myself, but the majority of council members did not want anyone arrested for violating the county's health order. One of my colleagues on the council, while still stating he wanted fines and not arrests, even advocated at first for the first penalty being \$500, which I thought was absurd. Despite that councilman's earlier statements, I was able to get the council to back a four-tier fine structure starting at \$100, compared to the staff recommendation of a three-tier fine structure starting at \$250.

The majority of the council members

also implored the Police Department to issue warnings first and to reserve civil citations for only the most flagrant and repeated violation of the law.

This was considerably less heavy handed than putting Dixon's police officers in the default position of having to make arrests as would have been the case had no action been taken to set up a civil penalty structure. I think we can definitely agree that throwing folks into the detention cell or taking them up to Fairfield over all of this would be absolutely ridiculous, however that would have been the only action available to our police department had the council not taken this action.

You may be thinking to yourself, "Why can't they just warn people?"

The first answer to this is that they are just warning people. To my knowledge, there haven't been any citations issued since the civil penalty structure was voted on.

The second answer is that there must be rule of law. If the consensus formed that there was no consequence for breaking the county's order, there would be some folks that would publicly violate it in any way possible for the sake of doing so and undermine the entire thing, as well as other city and county ordinances. An officer of the law has to be able to administer some type of consequence for violations of the law, so I pushed for the least impactful option and a lower starting point for the fines.

I hope this clarifies the situation a bit for those who were upset at the council's action. These times are hard enough without throwing people in jail over going about their lives. I find it regrettable that rumors were able to circulate regarding the decision of the council, and I take full responsibility for not clearly articulating the reasoning behind this decision for myself both at the council meeting and immediately following.

Dixon has been blessed for many years with dozens of community events. At least the current crisis will help us all appreciate each of the more — and appreciate the hundreds of people who diligently work to make them happen.

On March 4, 2020, Governor Gavin Newsom proclaimed a State of Emergency to exist due to COVID-19. Executive Order N-25-20 was issued on March 12, 2020 and requires compliance with any orders and guidance of state and local public health officials.

On March 11, 2020, the California Department of Public Health issued "Gathering Guidance" which states that large gatherings should be cancelled. Updated guidance issued March 16, 2020, states that all events that bring people together in a single space at the same time (such as auditorium, stadium, arena, large conference room, meeting hall, cafeteria, or any other indoor or outdoor space) should be cancelled until further guidance is issued by the California Department of Public Health.

On March 19, 2020, California Governor Gavin Newsom ordered (Executive Order N-33-20) all individuals to stay at home indefinitely. He has regularly cited an 8 week time frame but has stated it could be longer.

The fairgrounds staff has been carefully monitoring the situation and

reviewing timelines to be able to produce the annual event. Many steps must be taken to produce the Dixon May Fair and with restrictions placed on businesses and patrons the planning has been stalled.

The decision was made by the Fair Board at their meeting Thursday, March 26 to comply with guidelines set forth by the Center for Disease Control and Prevention for mass gatherings and State of California recommendations.

"While the decision was difficult, the Board of Directors has the utmost concern for the safety of the staff, the participants and the patrons during this unprecedented period in our history," said Roy Gill, board president.

"This is a difficult time for all of us and we realize the economic impact this has on the fair industry, our partners, exhibitors and friends. We will be exploring ways to assist the young livestock producers who have entered the Fair to get their animals to market. We would encourage them to contact the Solano County Fair regarding exhibiting their animals which is June 18-21, 2020," said Patricia Conklin, CEO.

Fairgrounds staff will be reaching out to participants and anyone who purchased online tickets regarding refunds in the next few weeks. Due to Executive Order N-33-20 the Dixon May Fair office is currently closed. The best way to contact the office is info@dixonmay-fair.com.

"Tom Clancy's Jack Ryan" On Amazon Prime Video

As a prolific American novelist, Tom Clancy became very popular for churning out numerous books centered on espionage thrillers and military subjects, several of which became the source material for box office hits.

Amazon Prime Video is now streaming the entire second season of "Tom Clancy's Jack Ryan," based on characters created by the noted author, and John Krasinski returns in the titular role.

While Season 1 had Ryan globetrotting to the volatile Middle East and elsewhere, Season 2 introduces us to a new look for Clancy's CIA analyst hero. Clean-shaved the first go around, now he's got a full beard and working on Capitol Hill for Senator Jim Moreno (Benito Martinez).

To be sure, Jack Ryan started out in the first season as a desk-bound financial analyst for the CIA who uncovered a terrorist plot while working under the cantankerous James Greer (Wendell Pierce) before getting into the rough-andtumble of espionage.

With Season 2, it's no surprise that Ryan won't linger for long in the stuffy hallways of Congress after he tracks a potentially suspicious shipment of illegal arms in the Venezuelan

Venezuela has been in the news plenty over recent years, having much to do with a succession of corrupt, tyrannical leaders, each one as odious as the other for decimating their country. Here's looking at you, now deceased Hugo Chavez and Nicolas Maduro.

The latest "Jack Ryan" seems very topical in many ways. Itching to get back into the fray, Ryan and his Senator boss head down to Venezuela for a "diplomatic" mission that does not go well.

The president of this South

American country is Nicolas Reyes (Jordi Molla), who is so patently slippery and deceitful that he's equally cartoonish and viciously thuggish. The wonderful Andy Garcia would have also been a great choice for this role.

Greer gets back in the picture when he gets sidelined from his new post in Moscow and ends up in Venezuela with Ryan just at the time President Reyes is facing a re-election campaign.

Reyes has an unexpected formidable opponent in Gloria Bonalde (Crisina Umana), a real contender whose husband, a former government Minister, has suspiciously been missing for more than a year.

On a covert mission with U.S. special forces, Ryan's intel leads them up the Orinoco River to a compound deep in the jungle that is guarded by a bunch of mercenaries where contraband is located.

Before being relieved of duty in Venezuela, Ryan gets involved with mysterious Harriet "Harry" Baumann (Noomi Rapace), who might be a rogue agent but certainly knows about German hitman Max Schenkel (Tom Wlaschiha) who killed Ryan's friend.

Ryan talks his superiors into letting him chase a lead in London to track down a shadowy figure behind the financing of arms deals, but it affords a chance for a catand-mouse game with the assassin Schenkel.

Then it is back to Venezuela for daring missions and political intrigue that makes "Jack Ryan" Season 2 worthy of bingewatching, especially now that we can't leave home except for groceries and medicine.



"California's attack on fundamental rights in times of emergency must be stopped in its tracks," observed SAF founder and Executive Vice President, Alan Gottlieb. Social Security Matters

Retiring from Work; When Should I Claim Social Security?

Dear Rusty: I turned 63 August 12th, 2019. I will be retiring June 30th, 2020 from my current job. I will have made approximately \$35,000 by then and am receiving severance pay of \$19,000 on June 30th. Will the pay I receive through June 30th affect what I can draw from Social Security? Also, how much of a difference would it be if I wait until August 12th, 2020 to officially start drawing Social Security? Is there any other information I should be aware of before I start drawing Social Security Signed: Anxious to Retire

Dear Anxious: First, let me assure you that the money you earned this year before your benefits start aren't counted as part of Social Security's "earnings test" which could affect your payment after your benefits start. When you claim, your Social Security benefit amount will depend upon two things – your "primary insurance amount" (or "PIA") which is determined from your highest earning 35

years (adjusted for inflation)



over your lifetime, and the age at which you claim your SS benefit. By claiming at age 64 in August, your benefit will be cut by about 15.6% from what it would be if you wait to claim at your full retirement age (66 plus 4 months). Your earnings for 2020 won't be applied to your SS record until after you file your 2020 taxes in 2021, so won't affect your benefits (if appropriate) until after that. If your 2020 earnings are more than any of those in the 35 years used to initially compute your benefit, your benefit will increase at that time. The day of the month you were born isn't significant, only the month. So, if you apply to start benefits in August of 2020, your benefit cut will be as stated above because you're claiming exactly 2 years and 4 months early. But if you wait longer you'll gain another 5/9ths of 1% (.556%) for each additional month you delay up until your full

retirement age (FRA).

Although you plan to retire from work, be aware that if you decide to return you'll be subject to Social Security's earnings limit once you are collecting benefits before your FRA, and that will be the case until you reach your full retirement age. If you go back to work

after you start your SS and earn more than \$1,520 in any remaining month of 2020, you'll not be entitled to benefits for that month. Starting in 2021, you'll be subject to an annual earnings limit of at least \$18,240 (that's the 2020 limit – limits for future years aren't yet known but will be higher). Exceeding the annual limit will cause SS to withhold half of anything you earn over the limit. The limit is more, and the penalty is less in the year you reach your FRA and goes away once you have reached your full retirement age.

Finally, to be sure you're aware, you can actually defer claiming SS until age 70 if you wish. After you reach your full retirement age you'll earn delayed retirement credits (DRCs) of 8% per year of delay, which are added to your benefit when you finally claim it. That would give you a benefit which is 29% more at age 70 than it would be at your full retirement age.

California Government Makes Recovery More Difficult

On March 26 the national unemployment numbers were released. Nationally, in the past week 3.3 million Americans were unemployed. In California, we contributed over one million to that number. While we are 14% of the nation, we had 33% of the unemployed. Could it be the implementation of AB 5, which was expected to kill hundreds of thousands of jobs, "worked". No more freelance journalists, photographers, health care workers, truckers and more.

Then you have the price of gas. On March 25 the national average cost of unleaded was \$2.06 a gallon. In Dallas the price was \$1.61 a gallon – in Simi Valley it was \$3.09 - the difference between the Dallas cost and California Sacramento taxes and government regulation of the gas formula.

The City of Hayward, in the Bay Area is rethinking its increase in the minimum wage, due to the virus.

"The move by the three councilmembers comes in the wake of already massive layoffs in the Bay Area related to the COVID-19 outbreak and shelter in place order given last week by Gov. Gavin Newsom.

"I'm trying to preserve jobs," Marquez said. "I'm fearful if we don't do something to help these businesses, people will be out of work."

Councilmember Sara Lamnin, who voted for the minimum wage ordinance last month, said Tuesday that the wage bump actually foments jobs loss. "Minimum wage increases do eliminate jobs, and in a time like this, we need to preserve them," she said."

Even those that supported the minimum wage increase, when the economy was going good understood it would cost jobs. Now with the Wuhan Virus, the disaster magnifies.

Yet, the State of California is on the way to a mandated \$15 minimum wage.

How do you recover when AB 5 makes it too expensive to hire new workers, the minimum wage forces business to pay unqualified people wages and benefits that are not warranted?

Because of the factors noted, and others, this will accelerate the use of technology in California businesses. For instance, the push for driverless cars – already on the roads in San Fran, Oakland and Santa Ana, will be done by end of 2021 – then rider share companies will need much fewer drivers and cars. Oh, the new cars will be electric, making environmentalists happy.

Telecommuting will continue to explode, on a permanent basis. The State could even give tax credits for rent policies and leadership.

telecommuting employees. This will alleviate a lot of the gridlock on the roads.

The biggest change will be in urban planning. The Left has been promoting the New York lifestyle. High density communities, pushing people on buses and subways, by the millions, causing close contact and the spreading of disease before the health care industry is aware of the problem. State Senator Scott Weiner, with his SB 50 and current legislation, SB 902, wants us to look and feel like New York. That goes along with the push to get people out of safe cars and into disease carrying, and physically dangerous, government transportation.

After this crisis is over, one way of staying well is to stay out of crowds. No elbow to elbow commute on the BART. watch movies that are streamed into your home instead of sitting inches away from strangers with the sniffles at a theater.

Life is going to change when this crisis is over. As part of that is the way we do business. In California, high taxes, bad regulations, dangerous housing policies and more, make it more irresponsible and unhealthy – and maybe it is a necessity that productive and responsible families leave the State.

Even the illegal aliens are going to be a bigger problem. Since the cost of hiring is so high in the former Golden States, the use of people that can be paid under the table makes more economic sense. So, low skilled or inexperienced Californians will not get hired, while cheap illegal labor will get the menial and bottom rung jobs.

Hopefully, like housing density, this too will be rethought, and ended.

Do not expect California to become responsible after this crisis ends. Only the financial collapse of the State will accomplish that. Just last week Kaiser Permanente decided not to build a \$900 million facility in Oakland, due to delays, government costs and regulations. As tech firms leave the State, maybe the politicians will get the message?

Until then I would "short" California as if it was a stock. We are in trouble and those in charge are short term thinkers. Long term they still believe in making us the Socialist Paradise.

Stop the Spread: A Patient Guide to the Novel Coronavirus

WASHINGTON, D.C. (MPG) - The American College of Emergency Physicians (ACEP) is providing guidance for patients to minimize their risk of getting or spreading the novel coronavirus, COVID-19. A new resource from ACEP, Stop the Spread: A Patient Guide to the Novel Coronavirus (COVID-19), provides tips on how to minimize the risk of contracting the virus - including whether you should wear a face mask - and how to determine whether patients should visit an emergency department.

'We are in the middle of flu season, which means emergency departments are already strained. To make sure that everyone can get the care they need, it's important to know when to go to the emergency department if you think you have COVID-19," said William Jaquis, MD, FACEP, president of ACEP.

Older patients and those with chronic or pre-existing conditions have the highest risk of serious cases or complications. If you think you are sick with COVID-19, consider your symptoms. Call your doctor if you've been in contact with someone who already has COVID-19 or has traveled to an affected region and within 14 days you develop a fever, cough or shortness of breath.

If your symptoms are mild, contact your primary care physician to discuss your best options for care. Call 911 or visit your closest emergency department if:

You're experiencing a medical emergency; You're sick enough that you need to go to the hospital, especially if you recently started experiencing shortness of breath, or; You're sick and you are a highrisk individual, such as an older patient or a person with an already weakened immune system.

"Your local emergency department may not yet have the COVID-19 test. Your primary care physician can decide if you meet the criteria and help determine where to get tested if necessary," said Dr. Jaquis.

SACRAMENTO, CA (MPG) - The Department of Water Resources (DWR) awarded \$47 million in grant funding to 53 applicants to support local agencies in development of plans to manage groundwater basins for longterm sustainability. These grants will support various projects including facilitating community outreach efforts, preparing feasibility studies for proposed actions to restore groundwater supplies, and installing monitoring wells to oversee groundwater levels.

This funding will provide important assistance in successful local implementation of the Sustainable Groundwater Management Act (SGMA), which establishes a framework for managing the state's groundwater resources.

"Sustainable management of our groundwater basins is

our communities more resilient" said DWR Director Karla Nemeth. "The investments we make today will ensure that groundwater, such a critical resource for our state, continues to be a part of California's water portfolio long into the future."

The grants were awarded to nearly 30 groundwater sustainability agencies for the installation of monitoring wells to better evaluate the needs of the groundwater basins in their area. Five other grant recipients will conduct aerial electromagnetic surveys to map aquifer conditions to better assess groundwater quality and storage conditions and to identify opportunities for recharge. These are just a few of the actions supported by this round of grant funding to further assist in developing groundwater sustainability plans.

critically-dry years by providing a supplemental, clean water source when surface water resources are diminished. In the last decade, groundwater overdraft has severely depleted this valuable water source, impacting communities statewide.

Funding for these awards was made possible by Proposition 68, from which \$46.25 million was made available for competitive grants, and an additional \$1.2 million of Proposition 1 funds. DWR will begin working with grantees immediately to develop and execute grant agreements.

In 2022, DWR anticipates the launch of a competitive grant solicitation process to provide at least \$88 million in grant funding for plan implementation and projects that support local water supply and groundwater resiliency investments.

A number of types of sources found within residential neighborhoods are capable of producing enough adult mosquitoes to bother not only the residents of one home but a number of homes in the area. These mosquitoes are also capable of transmitting West Nile virus! Water left standing for seven to ten days can produce mosquitoes during warmer weather. There are a number of simple precautions that can be taken to prevent this from happening...

WHAT TO DO...

Repair or replace defective parts immediately.

Install sump pump and provide drainage if possible.

Maintain roof gutters and down spouts clear of debris.

Seal and cover all openings and screen vents.

Fill if possible or provide adequate drainage.

Drain-off excess water or invert if not in use.

Use filter and skimmer daily to remove egg rafts and larvae. Chlorine will not kill mosquito larvae. Provide drainage for filter and sump pumps. When not in use, cover tightly.

Change water weekly. When not in use turn upside

Tighten cover to prevent sagging.

Stock with mosquito fish and remove excess vegetation such as leaves, and thin pond lilies occasionally. Maintain even water level. Screen inlet on recirculation pump. When cleaning pond, transfer to glass bowl chlorine kills fish. If pond is no longer desired, make holes in bottom and fill with dirt or sand.

Change water frequently, preferably every 2-3 days

Avoid over watering.

Fill with a polymer such as Soil Moist or Broadleaf P4 granules which absorb water - can last for years, available at garden supply stores, sand or dirt, drain if possible - when in doubt, call a tree surgeon.

Change water weekly or stock with mosquito fish.

Use a water tight cover or store upside down.

Dispose of all unused containers that can collect rain or irrigation water such as tin cans, jars, barrels, buckets, old tires and tubs. Gardening containers such as vases and buckets should be stored upside down.

Will Medicare Pay for the Coronavirus?

I must have missed this when listening to the national media coverage of the Coronavirus, but no one has explained how Medicare is covering the testing, vaccinations or quarantined in a hospital if anyone in my family that is on Medicare becomes infected with the

My husband and I have recently retired and are covered by Original Medicare with a Medicare Supplement and a stand-alone Medicare Part D plan. Our parent's situations are different as they both are covered by Medicare Advantage plans. My parents are both Texas retired teachers covered by TRS Medicare Advantage plan and my husband's parents are covered by his father's employer retiree Medicare Advantage plan.

How will Medicare pay for these different situations? I'd like to know what to do if

I must take one of my family members or myself to the doctor or hospital.

Thanks, Sheila from Bellaire, TX

Sheila:

We are witnessing a healthcare crisis that no one can be sure if they are safe. Especially the 60+million Medicare beneficiaries frightened of COVID-19, the disease caused by Coronavirus.

Let me discuss the various ways that Medicare will cover the testing and medical care for the 2 different Medicare plans...Original Medicare and Medicare Advantage plans:

• Original Medicare with Stand-alone Part D and **COVID-19** (Coronavirus) testing began on or after Feb. 4, 2020. You will pay nothing for Medicarecovered clinical diagnostic laboratory testing provided. Your medical providerwill have to wait until April 1, 2020, to be able to submit a claim to Medicare forthis test. **it is very important to verify that your Medicare facility, provider ormedical professional is accepting *Medicare* assignment for Medicare to pay for COVID-19. When a vaccine is available for the Coronavirus, then all Medicare Part D plans will carry the vaccine and copays may apply. Telehealth is offered with Original Medicare. Medicare Part A (In-patient Hospital) and Part B (Medical Benefit) deductibles and copays may apply.

• Medicare Advantage plan with Medicare Part D and COVID-19: Medicare beneficiary will have access to the same Medicare benefits. Medicare allows Medicare Advantage plans to waive cost-sharing for COVID-19 lab tests. Check with your Medicare Advantage plans to verify your coverage and costs.

Telehealth coverage and additional coverage maybe offered. Once a vaccine for COVID-19 is available, then Medicare Advantage Prescription Drug plan copays apply. It is advised that the medical provider or facility be in network to receive your lowest cost for medical and vaccine costs.

Sheila, after April 1st when the medical community that is accepting Medicare assignment begin to file claims regarding COVID-19 (Coronavirus), then we will really know how claims will be paid. Remember accepting Medicare assignment and not just billing Medicare is the key to how a COVID-19 claim will be paid. Since you and your husband are covered by Original Medicare with a Medicare Supplement and stand-alone Medicare Part D, you may pay a certain amount for your claim and your parents which are both covered by a Medicare Advantage plan with Part D may pay a completely different amount or co pays because these are two different types of Medicare plans.
