The 107-foot-long jet rolled across the vastness of Beale AFB until arriving at its single runway... the nose of the Cold War spy plane swinging onto course, confirming its precise position by checking the position of up to 32

throttles over a detent into afterburner, initiating a small squirt of




The weather should be perfect, so plan to bring the entire family for some great fun and lots of fantastic food at this positive family-friendly event.




## 'Sanctuary State' Governor Upset Migrants Were Sent Here for Sanctuary

SACRAMENTO, CA (MPG) -California's sanctuary state Governor Gavin Newsom and Attorney General Rob Bonta were quick to blame Florida Governor Ron DeSantis for Friday's migrant flight into Sacramento, and then accused Florida of "state-sanctioned kidnaping" for transporting migrants from the Texas border to a Sacramento church.

However, when he was still Lieutenant Governor, Newsom proudly declared and reaffirmed California's sanctuary state status after the Trump Justice Department threatened to charge state or local officials who enforced sanctuary policies protecting illegal immigrants.

on Facebook saying, "California will remain a sanctuary state, and your attempt to intimidate will not stop us." So which is it Gov.

## San Francisco Man Sentenced for Death of Marysville Woman

YUBA COUNTY, CA (MPG) - In January 2021, the California Highway Patrol (CHP) conducted a traffic stop on Dominik Oshay Cash for speeding. Unknown to the CHP officer, Cash was in possession of a loaded 9mm handgun on the seat next to him and held multiple warrants for his arrest. Cash fled from the officer and led law enforcement in a vehicle pursuit. Despite multiple attempts from law enforcement to stop his vehicle safely, Cash ran a red light at over 80 mph and crashed into a vehicle driven by Dawn Loralee Ritter. The force of the impact immediately took Ms. Ritter's life.

Cash continued to flee from law enforcement on foot but was later apprehended and taken into custody.

Cash was convicted of several offenses including 2nd degree murder, reckless evasion, fleeing the scene of a collision, felon in possession of a firearm, and driving on a suspended license. On May 10, 2023, Cash was sentenced to state prison for a total of 21 years to life. Several members of Ms. Ritter's family spoke at the sentencing hearing to express the profound loss her death created in their lives. She was a beautiful human being, mother, sister, daughter, grandmother, and friend. Rest in Peace Dawn Loralee Ritter.



## 'Sanctuary State' Governor Upset Migrants Were Sent Here for Sanctuary

Ron DeSantis is actually behind the flights. Thus far, all reports about the illegal immigrant planes appear to be speculation, and DeSantis is mum.

Governors DeSantis and Greg Abbott (Texas) have sent planes with illegal immigrants to sanctuary cities Chicago, New York, and Martha's Vineyard to share in the housing and care of the migrants they claim to want sanctuary for.

Democrat President Joe Biden has called this movement of mostly Latin American migrants "playing politics with people's lives" and said it is inhumane, especially in areas such as New York City, which have services brought to the brink already because of the migrant influx, the Globe reported Monday.

However, officials from Texas and Florida, including DeSantis, have fired back that "every community in America should be sharing in the burdens."

The federal government has also sent secret flights full of illegal immigrants into Westchester, New York in the middle of the night, stirring controversy of their own:

Leaked video shows migrants being transported on secret charter flights under the cover of night from southern border states to Westchester, New York.

"The government is betraying the American people," a federal contractor told a Westchester County police officer in a conversation recorded on the

officer's body camera on the tarmac of a Westchester airport on Aug. 13, 2021.

Westchester Police Sgt. Michael Hamborsky asked the contractor hired to transport migrants around the country why: "You know why. Because if this gets out, the government is betraying the American people," the contractor said.

Gov. Newsom and Sacramento Mayor Darrell Steinberg turned on the rhetoric claiming, 'Human trafficking is not only despicable; it's a felony. I urge authorities to investigate how 16 vulnerable people were lured from El Paso, to Sacramento. " 'Is there anything more cruel than using scared human beings to score cheap political points?"


Both Steinberg and Newsom support open borders, and illegal immigration.

And it isn't human trafficking or kidnapping to take illegals from a non-sanctuary state to a sanctuary state that claims to welcome them.

Rich with irony, Gov. Newsom has been releasing dangerous felons from state prisons, most of whom reoffend or end up living on the streets, addicted to meth and/or heroin.

Perhaps the most ironic Tweet summed up their hypocrisy best: "Lol yes you are not worried about them coming across the dessert and risking their lives but put them on a private jet and send them to your cities, now that's a travesty."

Continued from page 1 eager to meet the man described on the inside book flap:

Severely burned in the wreckage after being shot down during the Vietnam conflict; Medevac'd with little chance of survival; Was told he would never fly again; Spent one year in military hospitals, enduring 15 major operations, before returning to active flying status; Passed the astronaut physical required to fly the SR-71 spy plane, with one of the highest recorded scores ever.

"Hey, you're the guy from San Diego! What did you think of the book?" I looked him in the eye while shaking his scarred and contorted hand, taking in the totality of his

horrific burn injuries. "Why don't you come to our hotel tonight and join us for dinner? We'll meet by the pool around 6."

I arrived at the appointed hour, strolled out to the pool area but did not see Brian. "Oh, there you are!" came the soon-to-be-familiar voice from behind me. Brian was sunbathing on a chaise lounge, wearing only swim trunks. "The sun feels so good on my scar tissue, I just had to lay out for a few minutes." I looked down in awe at the scarecrow-like patchwork of skin grafts crisscrossing his entire body, from head to toe... evidence of those 15 trips under the scalpel. And

a little switch flicked off inside of me... 'Good Lord. If HE's okay with this...? What the heck is MY problem?" And that was the last thought I ever had about Brian's "Hi-Viz" exterior. I reached down, took his hand, and pulled him upright. "I hope you're not wearing that to the Spaghetti Factory!"

In the following years, Brian would come to my museum numerous times for book signings... and I would return the favor by following him around the country, helping him in his airshow booth. He ended up flying with both the Air Force Thunderbirds and the Navy's Blue Angels, to produce books on their teams.

And later, after the mysterious SR-71 was somewhat declassified, he wrote a 4th book with his RSO, Walter, detailing their missions over Libya for President Reagan... and "giving away some secrets" about the Blackbird.

I must now bookend our 30+ year friendship between that story of my first look at the Sled Driver... and my last glimpse... on his way out the door to give his inspirational talk to a group in Reno last month.

I swear he was tucking in something red under his shirt.

### Farm Bureau President Urges Congress to Address Fire Risks

California Farm Bureau President Jamie Johansson is calling for increasing the pace and scale of forest management, including employing livestock grazing and prescribed burns to reduce dangerous fuels and protect communities and the environment. On May 23, Johansson testified in Washington, D.C., before a federal lands subcommittee of the House Committee on Natural Resources. He told the panel, "Given the extensive number of wildfire related impacts in California, California Farm Bureau has a vested interest in quality and quantity of forest management activities.'

#### Winter Storms May Have Increased Risks of Tree Pathogens

Atmospheric rivers that swept across the state this year have created conditions for plant pathogens that haven't been seen for decades in California. Florent Trouillas, a plant pathologist at the University of California, Davis, said he is getting more calls from growers and farm advisors concerned about potential crop damage. Recent tests in an orchard showed the presence of Phytophthora syringae, a pathogen that can affect almond crops but is rarely seen in California. Researchers are working to diagnose fruit and nut crop ailments that could be enhanced by wet weather.

#### Farm Bureau: Small Farmer Need Help After Storms

The California Farm Bureau is calling on the state to improve mechanisms for disbursing disaster relief payments for damages suffered in devastating 2023 storms. Testifying before a joint informational hearing of the California Assembly Agriculture Committee and the Assembly Emergency Management Committee, Farm Bureau Administrator Jim Houston said the storm impacts have been especially hard on small farmers, including many that may lack insurance. "There is no good mechanism for people to recover their losses," Houston said at the May 23 hearing.

#### Researchers: Lab-Grown Meat May Be Worse For Environment Than Retail Beef

Researchers at the University of California, Davis, have found that lab-grown or "cultivated" meat's environmental impact is likely to be significantly higher than retail beef. Researchers conducted a life-cycle assessment of energy needed and greenhouse gases emitted in all stages of production compared with beef. Based on current and near-term production methods, they concluded that lab-grown meat will be worse for the environment and more expensive than conventional beef production

## **Newsom's Expansive Health Care Promises to Californians Remain Elusive**

Five years ago, while running for governor, Gavin Newsom pledged to transform California's medical care to a single-payer system similar to those in Canada and western

Newsom backed single-payer legislation, which had passed the state Senate, saying there was "no reason to wait around."

"I'm tired of politicians saying they support single-payer but that it's too soon, too expensive or someone else's problem," Newsom said.

His position helped solidify support for Newsom among the proposal's progressive advocates as he dueled with a fellow Democrat, Antonio Villaraigosa.

Assembly, and after winning the election, Newsom began edging away from the single-payer concept, citing difficult barriers. One is persuading the federal government to give California the \$200-plus billion it spends on Californians' health care - about half the state's total medical expenditures.

Newsom segued into pursuing universal health care, meaning all of the nearly 40 million Californians would have some sort of coverage. and came close last year.

At the time, "About 3 million Californians reported

being uninsured in spring than a million people, still 2022," a report from the Public Policy Institute of California notes, citing census data. "Nearly seven in 10 (68%) are Latino, about 38% are noncitizens and 80% have low or moderate incomes (below 400% of the federal poverty line)."

Some of the gap was closed in the 2022-23 budget, drawing on what seemed to be a nearly \$100 billion budget surplus, by extending Medi-Cal coverage to undocumented immigrants otherwise ineligible for federally subsidized

"Beginning no later than January 1, 2024, Medi-Cal will be available to all income-eligible Californians," the final 2022-23 budget declared.

The expansion of Medi-Cal – California's version of the federal Medicaid program – was made easier during the COVID-19 pandemic when federal authorities relaxed eligibility requirements. This year, enrollment topped 15 million, or nearly 40% of the state's population.

Under his "California The bill stalled in the Blueprint," universal health care is still Newsom's professed goal. However, at the moment, coverage appears to be shrinking, and with the state facing chronic budget deficits, reaching it before Newsom's governorship ends would be difficult, if not impossible.

Single-payer advocates are, unsurprisingly, annoyed by Newsom's failure to deliver on his 2018 promise. They gave him some heat when he appeared at last month's state Democratic Party convention.

Covering all Californians would be expensive. Medi-Cal coverage costs federal and state governments about \$10,000 per enrollee. No one knows precisely how many Californians still lack coverage today but 2 million is as good a number as any, and including that many more in Medi-Cal could potentially cost another \$20 billion a year.

Meanwhile, single-payer advocates haven't given up. Last week, the California Senate passed Senate Bill 770, aimed at implementing a plan for single-payer coverage developed by the Healthy California for All Commission, which Newsom created in 2019.

The bill would direct state agencies to begin talks with federal officials about participating in a California single-payer system.

"It's time we made real progress toward eliminating the inequities and injustices of our fractured healthcare system," a co-author of the bill, state Sen. Scott Wiener, a San Francisco Democrat,

Newsom finally learned, it's much easier said than done.





## Grant Opportunities Available for Wildfire Safety and Preparedness

**SACRAMENTO REGION, CA (MPG) -**On June 1, 2023, Pacific Gas and

Electric Company (PG&E) and the California Fire Foundation (CFF) announced grant opportunities for California-based fire departments and community-based organizations focused on wildfire safety and preparedness. The grant program continues a successful partnership between PG&E and CFF. Applications must be submitted by 11:59 p.m. on June 30, 2023, through the CFF website. 'While the unprecedented storms of this past winter helped lift the majority of California out of the decades-long drought, the unfortunate flip side is the increased potential for a later but more robust wildfire season," said Rick Martinez, Executive Director of the California Fire Foundation. "The Wildfire Safety and Preparedness Program is a partnership with PG&E that was created to address the increasing wildfire risk. Our collaboration over the last six years has played an important role in helping local communities mitigate their wildfire risks and enhance the public's safety."

"PG&E and the California Fire Foundation share the same goal of ensuring that our hometowns are doing everything possible to prevent wildfires from starting. Local fire departments, agencies and community groups play such a key role in prioritizing and executing the projects that protect communities and in raising awareness about wildfire safety. We're grateful for our ongoing partnership with the CFF as it provides real-time benefits such as defensible space and fuel-reduction programs as well as

crucial awareness to customers in underserved communities," said Mark Quinlan, PG&E's Senior Vice President of Wildfire & Emergency Operations.

## Former Yuba County Deputy Acquitted of Excessive Force Charge

Yuba County DA News Release

YUBA COUNTY, CA (MPG) - A jury acquitted former Yuba County Sheriff's Deputy Henry Abe on Thursday, May 25, 2023, of a misdemeanor assault by a public officer. The charge stemmed from an incident that occurred on February 14, 2022, when Abe was called to a residence on Forty Mile Road for a burglary in progress. The responding deputies had body-worn cameras that captured the incident.

When Abe and other deputies arrived on scene, the suspect had been detained by neighbors in a field next to the house. A deputy placed the burglary suspect, 59-year-old Jerry Johnson, in handcuffs. Johnson, who could be heard breathing hard, asked for a moment to catch his breath, when deputies instructed him to get his feet. Abe told Johnson to get up or he would "boot" him in the ribs. Johnson replied, "boot me in the ribs," and Abe kicked him. Johnson got to his

feet and the deputies walked him

to a nearby patrol vehicle. Johnson was not injured by the kick.

Abe claimed the kick was necessary because he was worried that a second suspect could be hiding nearby with a firearm. The video from the body-worn cameras, however, did not show any particular hurry or concern on the part of the deputies.

Yuba County Sheriff's Deputy Kenny Smith testified at trial that the kick was outside of policy and not legally necessary. Smith, who teaches defensive tactics for the Sheriff's Department, explained to the jury that even if Abe needed to hurry, he should not have kicked the handcuffed suspect when he had other options, such as standing the suspect up or dragging him from the field. A use-of-force expert hired by the defense testified that the kick was not excessive under the circumstances.

The trial, which began on Tuesday, ended Thursday afternoon with the jury finding Abe "not guilty" of the single charge.

"Kicking a handcuffed,

out-of-breath suspect who wasn't resisting is unreasonable on its face," said Yuba County District Attorney Clint Curry. "We file charges based on the evidence, but it's ultimately up to the jury to decide what 'beyond a reasonable doubt' means in each case. I respect their decision."

Jerry Johnson was convicted by a jury in October 2022 of the residential burglary he was caught committing in this case. He was sentenced under California's Three Strikes law to serve 25 years to life








## Huskies are Top Dogs with Division IV NorCal Title

SUTTER, CA (MPG) - The Sutter Huskies and Gridley Bulldogs baseball teams made it to the final game of the season as the two former Butte View League rivals squared off in the California Interscholastic Federation Division IV NorCal Championship on Saturday, June 3.

The scene last Saturday at Arata field in Sutter looked like a fair as fans of both teams were lined up on the edge of the fence from each foul pole to leave no standing room to watch the game as the Huskies won the game 10-1.

For the second consecutive time in a little over a week and a half, Sutter junior shortstop/ pitcher Logan Yacavace had his longest outing of the season with a complete game, four hit and six strikeout performance.

Yacavace last pitched in the Huskies CIF Sac-Joaquin Section Division V Championship on May 23 in a 4-3 thriller that lasted 13 innings and Yacavace pitched 6.2 innings in relief to pick up the win.

Sutter (26-5-1) head coach Stewart Peterson told Messenger Publishing Group that they have always been confident with Yacavace on the mound, but he's also valuable defensively as well.

"We've used him in the closers role with one or two innings here or there, but when we called on him for the Bradshaw Christian game along with today, he was ready," Peterson said.

The unselfish Yacavace expressed to MPG the team effort throughout the entire season and added it was a perfect way for the seniors class to go out as most of the roster has played with one another for years.

Gridley (17-6) head coach Javier Solis told MPG that every game in the state playoffs was a bonus as their original goal was to win a Northern Section title as they did on May 20, in a controlled 8-0 win over West Valley

"Now that we have been here and seen what it looks like, we

have a goal for next season," Solis said.

Solis started his freshman lefthanded pitcher Tanner Abbott who had a little trouble finding the zone in the first inning as he walked two before Huskies sophomore first baseman Brady Wickum opened the scoring of the game with a two-runs-batted-in single to take a 2-0 lead. Abbott got an RBI single in the third to score senior captain/outfielder Michael Ryan to cut the Sutter deficit 2-1 as it would be the only run for the Bulldogs in the game.

Ryan went 1-for-2 as he tripled in the fifth inning. Ryan, who has spent his entire high school career on the varsity level credited multiple people throughout his years as a Bulldog.

Ryan's main message to the returners next season was to show up ready to play everyday.

"With our young pitching staff, they have a chance to win every game," Ryan said.

Being mentioned as the best leader in Solis's 12-year coaching career, Ryan exemplified that as being a leader in the classroom and on the field giving it 100 % all the time.

Abbott went 2-for-2 at the plate with an RBI. On the single, Abbott rolled his ankle and it didn't translate well as he went to pitch in the bottom of the third.

No excuses were made as the Huskies slammed four straight singles as Wickum had his second single and third RBI of the day.

In previous conversations

with Wickum, he expressed he has been up and down at the plate throughout the season.
"I worked on being patient,"

Wickum said. Wickum went 2-for-4 with three RBIs in the game.

Seven of the Huskies starters had a hit during the game along with four of them having two or more RBIs in the game.

Sutter added four more runs in the third to take a 6-1 lead. Yacavace sewed up the Gridley lineup for the rest of the game as he only gave up the triple to Ryan in the fifth.

The Huskies tacked on three more in the bottom of the fifth before junior designated hitter Rylan Giovannoni capped off the scoring with a solo home run in the sixth over the left field fence.

This was the first trip to the NorCal finals for the Huskies and Bulldogs as the format began in 2021 by the CIF.

As the season ends, turnover on both rosters begin as they both lose key pieces but Sutter and Gridley have a lot coming back next season.

While the Huskies lose four starters and the Bulldogs lose three, both squads have their primary pitching coming back.

Solis added that as much talk about the returning pitching, he is excited for another season and credits a lot of the pitching success with junior catcher Bryar McWilliams.

"He (Bryar) calls the pitches, studies batters. So, it's exciting to get another season with him," Solis said.

With both teams in different sections, the area of both towns can hope for future battles with these successful programs. ★

## Sutter's Bauer Adds Hardware as 49ers Sac-Hi Sports Softball POY

**SUTTER, CA (MPG)** - Although the Sutter Huskies softball season ended a couple weeks ago, it doesn't stop more accolades coming to the program as junior pitcher Olivia Bauer was honored and received the award for the 2023 49ers Sac-Hi Sports North Softball Player of the Year in a ceremony on Sunday, May 28 at Sutter Health Park in Sacramento.

Bauer was named to North POY via social media on May 15, and Bauer told the Dispatch it was an honor. She later celebrated the ceremony on May 28, to receive the award with her family, friends and coaches, including Huskies head coach Stefanie Danna and assistant coach Tim.

As expected, Bauer expressed a long list of thank yous to multiple people who helped pave the way towards an amazing accomplishment. Danna's teammates were noted as big contributors towards her appreciation.

"They (the Danna's) have been with me since the beginning of my high school career; I wouldn't be where I am without them today," Bauer said.

She added her role model was former Lindhurst 2016 softball star and alumna Cassia Ruiz because she helped Bauer learn to hit left-handed in the box, love the game all around and work hard.

It translated well to this season as Bauer had her most productive offensive production in her three-year career at Sutter with a .527 batting average. She also led the Huskies roster with number of hits (49) and on base percentage (.566).

Although the POY award recognized Bauer as an individual, she is quick to give nothing but consistent credit to her teammates as well.

"They have had my back, I received plenty of congratulatory messages and reposts," Bauer said. "They have been my biggest supporters."

Sutter has been recognized in some of the local polling throughout the season to the likes of The Sacramento Bee and the 49ers Sac-Hi poll as high as number one and eighth

in the most recent May 29 poll.

Bauer expressed to the Dispatch she felt that the program will get more recognition throughout the years as they are bound to go to the CIF Sac-Joaquin Section Division V semifinals their first year in the SJS.

Although local teams and the Northern Section know about the Huskies prolific program, the Sacramento region will continue to see and hear about the phenomenal program at Sutter.

Bauer added that they put in a lot of hard work day in and day out. Bauer went back to the circle primarily this season after the departure of former Sutter pitcher Riley Wickum graduated last year and told the Dispatch it was a transition stepping into her shoes.

Bauer went 23-2 with 141 innings pitched, 185 strikeouts and a 1.04 earned run average. Bauer also had 21 complete games, nine shutouts and one perfect game that she threw on

March 20 at Pleasant Valley of Chico.

Bauer added that she wasn't alone in the circle and smiled as fellow junior third baseman Makala Schamanski was brought off pitching retirement this season too as she hasn't pitched for a while.

Game day superstitions for Bauer include her hair must be the same every game, same walk-up song yearly. Her routines for warmups include the same number of pitches and the hard work ethic shows as she has to be at the field a half hour prior to her teammates arriving or she said she feels like she won't have a good game.

Hobbies include hiking, lifting with her GRIND:30 crew that includes playing hacky sack with teammates pregame and blasting music at the field.

Bauer added that her favorite moment of the season was the 1-0 win over East

Nicolaus on May 11.

"A lot of people doubted us because they

do have players with big commitments," Bauer said. "The joy of all of us screaming and hugging showed how high intensity of a game it was."

Bauer told the Dispatch her and her teammates will keep the same mindset as this season, and they will use the motivation of the exit from the semifinals this season towards next season.

Bauer heads into a summer of travel ball and will continue the grind onto her senior season with her Sutter family next season. ★


