# **Homeless Student Count Grows**

As the number of unhoused students in California's public schools continues to rise to pre-pandemic levels, experts and educators fear that today's economy paired with the state's unrelenting housing crisis will lead to unprecedented rates of home-

According to updated data released today by the California Department of Education, there are about 5.9 million students enrolled in public schools this school year, close to 40,000 fewer students than last year or a .7% drop. But the number of students experiencing homelessness increased by 9%, about 16,000, to a total of approximately 187,000 kids.

The overarching cause of homelessness among all Californians is the perennial shortage of affordable housing in the state, according to Angela James, a researcher at UCLA's Center for the Transformation of Schools.

"It's alarming to me, quite frankly," James said. "Housing instability may be deepening in California as a result of the pandemic."

The new data signals a return to pre-pandemic numbers. Last school year, about 2.9% of students qualified as homeless. The percentage is up to 3.2% this year, about the same as it

was in 2019-20.

"As a state we have not made the housing and well-being of our population a priority," James said. "Sadly, social policies have not been responsive to the needs of young people and their families."

Experts struggle to explain why homeless numbers dropped during the pandemic. They said students and their families may have been moving around during the early months of quarantine, so they may not have been counted. Or unhoused students may have just been falling through the cracks.

"In some cases, districts could

# Be Prepared Fair' With Focus on Wildfires Returns to Foothills

Yuba County Special Release

**BROWNSVILLE, CA (MPG)** 

- On the doorstep of the wildfire season, state and local emergency responders will once again bring their fire engines, command vehicles, and other equipment to the Yuba County foothills for the 2023 Be Prepared Fair.

The event is scheduled to take place on Thursday, May 18, from 5:30 to 7:30 p.m. at the Ponderosa Community Center, located at 17103 Ponderosa Way in

Brownsville. This will be the third year the Yuba County Office of Emergency Services has hosted the fair that brings top public safety personnel to one place to mix with residents and talk about the importance of being prepared for any emergency. Thirty-seven agencies have confirmed they will

be on hand to answer questions about preparing for the wildfire season, and many will provide both information and giveaways that can be useful in any emergency situation.

"We designed the Be Prepared Fair to be an informal and family-friendly event that makes it easy to have helpful conversations with the same people who have the jobs of keeping communities safe," said Yuba County Office of Emergency Services Manager Oscar Marin. "The children will be able to get up-close to fire engines and other emergency equipment, while the adults can have meaning conversation with our sheriff, firefighters, and people from several other emergency response agencies."

A variety of emergency vehicles and equipment will be on display in front of the Ponderosa Community Center, while several information tables will be located inside. Among the giveaways are items that will be useful for starting the process of preparing a go-bag, an important part of preparing for an emergency. There will also be door prizes that include fire extinguishers and bicycles.

Marin said food trucks will be at the Be Prepared Fair, for those who want to grab dinner, a snack, or something sweet.

Agencies scheduled to be at the 3rd Annual Be Prepared Fair include the Yuba County Sheriff, Cal Fire, Cal OES, U.S. Forest Service, California Highway Patrol, Foothill Fire, Camptonville Fire, Yuba Water Agency, PG&E, the American Red Cross, Yuba County Health and Human Services, The Yuba FireSafe Council, two

animal rescue projects,

FREED, and many more. During the event, the REACH medical helicopter will land on the baseball field across from the Ponderosa Community Center. Radio station 93Q will be broadcasting updates from the fair, as

"One of the most important things we do at this fair is help people sign up for CodeRED alerts and assist them in locating their home's Zonehaven zone," Marin said. "These are important services used by the Yuba County Sheriff's Department and Office of Emergency Services to immediately alert residents during an emergency."

Fair organizers say parking for the event will be at the park across the street from the Ponderosa Community Center, as well as near the baseball field behind the center. Shuttles will be available.

# Farm Bureau **Applauds State Senate** Passage of **SB 505**

SACRAMENTO, CA (MPG)

- The California Farm Bureau is applauding the state Senate for its passage of Senate Bill 505, which was approved with resounding, bipartisan support and now moves to the state Assembly.

Senate Bill 505 expands the insurance "clearinghouse" program of the California FAIR Plan, the state's insurer of last resort, to allow commercial insurance policies under the FAIR Plan to move back to the admitted commercial market. California Insurance Commissioner Ricardo Lara is a co-sponsor of SB 505, along with the California Farm Bureau.

The Farm Bureau previously worked with Commissioner Lara and Sen. Susan Rubio, D-Baldwin Park, to pass SB 11 in 2021. That bill allowed farmers and ranchers who lost or were denied coverage in the competitive insurance market after devastating wildfires to obtain alternative coverage through the California FAIR Plan.

SB 505, also by Sen. Rubio, would provide opportunities for agricultural producers to move back to the competitive market, with affordable commercial policies protecting farming and ranching operations.

"California's farmers and ranchers need insurance options to safeguard their ability to continue producing the food that America needs," said California Farm Bureau President Jamie Johansson. "Senate Bill 505 provides agricultural producers who turned to the California FAIR plan the ability to return to the competitive insurance market to protect farming and ranching operations. SB 505 is widely supported by insurers, brokers and agents. We applaud Sen. Rubio for her leadership on this issue, and we encourage the state Assembly to pass this important legislation so that it may be signed into law to provide affordable coverage options for California's vital food producers."

"California businesses do best when they have more choices for insurance coverage," said Commissioner Lara. "While the California FAIR Plan is an important safety net when businesses cannot find any other insur-

ance, giving them more Continued on page 3

#### This Month In Your Garden

April and May are special months for gardeners – so many plants look so fresh and beautiful with things leafing out and others bursting into bloom. We can all enjoy them to the fullest now, knowing that many areas will be drying up before too long as our summer heat approaches. Summer annuals add much beautiful color to all the shades of green of various shrubs in the yard. Planting some nice containers with various colored annuals gives the freedom to place nice color wherever it is needed, and switching them around if for some special reason, like unexpected company is coming or a party is planned, etc. Snapdragons add lots of color plus height as do zinnias, petunias come in many colors and so does annual vinca, marigolds will add yellow and orange. Try alyssum, lobelia or portulaca for a trailing effect. Begonias, impatiens and violas are great for brightening shady areas. If it sounds like something you would like to try, just use your imagination and have some fun with it. In the ground or in pots, they will provide colorful areas to the yard. Fertilize them occasionally or use a slow release fertilizer on them to keep them blooming, remembering that nutrients wash through plants in containers more quickly with frequent waterings.

The ever present weeds (at least for some of us) really make their presence known as they grow faster than anything else in the yard with the warming weather. I congratulate those of you who used pre-emergent to prevent weeds from sprouting. Because the weeds grow so quickly and are so invasive it is something that should be done soon. Other pests encountered at this time of year are aphids and the ants that farm them. The ants harvest the sticky substance left by the aphids. Aphids can be controlled safely by spraying with insecticidal soap. We have had a number of customers commenting on more snails than usual. They do their mischief at night, so you may not see them. Their most obvious trademark will be the irregular holes they make in leaves and they frequently leave a shiny

trail. They can be hand picked if seen, or snail bait bait can be spread in the affected area. Putting some bowls that are set into the ground a bit and filled with beer will attract them and drown them. If you have citrus trees, watch for mealy bugs. They will start as small white spots just about anywhere on the plant but, they multiply into larger groups and may have the appearance of a fungus or scale. They can be sprayed with an insecticide, but you will need to add a few drops of dish detergent to help penetrate their slightly fuzzy exterior. Catching them early definitely makes them easier to control.

Most camellias have finished blooming now. Clean up the old blooms that have fallen to the ground and dispose of them in the trash. They can harbor a fungus as they decompose that can spread a disease called petal blight to the plant that can cause the flower petals to turn brown. The spores can travel a good distance in the wind infecting other plants along the way.

As mentioned earlier in the season, watch your roses carefully for signs of powdery mildew, black spot, or rust. We have had the occasional rainy times followed by warm weather which is perfect weather for fungi. Treat them as soon as noticed because it is much easier to manage it early than when it is well established. Also mentioned earlier, planting ground covers from flats should be done fairly soon so that they can become somewhat established before we get into the really hot weather. The same applies to planting new lawns - it needs to be quite well established before the hot weather arrives or you will have quite a constant watering job while it becomes established. Enjoy our adequate water supply, but please apply your conservative methods.

be getting better at identifying students," said Dion Burns, a senior researcher at the Learning Policy Institute.

Student homelessness rose this year for the first time since 2020. The count includes students living in motels, trailer parks, campgrounds or public spaces.

While statewide numbers indicate a return to pre-pandemic levels, 13 of the 20 largest districts in the state have more students experiencing homelessness now than they did in the 2019-20 school year.

Since 2015, rates of homelessness were rising gradually up until 2020, when they started dropping steadily. Student homelessness rose this year for the first time since 2020.

The California Department of Education uses a federal definition of homelessness that includes students living in motels, trailer parks, campgrounds or public spaces.

School districts and county offices of education employ liaisons who keep tabs on students and families experiencing homelessness. James said they're often shorthanded, so collecting data may have been a challenge, especially during the chaos of 2020 and 2021.

Many unhoused students and their families have been evicted from their homes, James


said. She recalled her own personal trauma of having her family's furniture moved out to their front lawn when they were evicted. With no home, students and their families might go from one temporary shelter to another with no sense of how long they can stay in one place.

"The degree to which that impacts a child cannot be underestimated," James said.

She added that teachers are fortunately better prepared to work with these students than they were in past decades. When a student acts out or even gets violent, a teacher might try to calm the student instead of resorting to disciplinary actions like detentions or suspensions.

According to the state's new data, the numbers of foster youth, students with disabilities and students from low-income households have all increased by between 2% and 3%.

The rate of decline for overall enrollment shows signs of stabilizing after plummeting in the first years of the pandemic. Kindergarten enrollment took the biggest hit, but is starting to climb back up. Enrollment went from about 71,000 in 2020-21 to about 130,000 this year, but state officials said it's partly due to the state's expansion of transitional kindergarten.

# **Teacher Pension Fund Betrays Its Mission**

If you think that CalSTRS, the behemoth pension system that supports California's retired teachers, is focused on pensions, you are wrong. The largest teacher-focused pension system in the country is abandoning its core fiduciary role to chase left-wing political goals. Its mission creep will hurt teachers, taxpay-

ers, and students alike. In April, CalSTRS issued an extraordinary press release stating their priorities for the companies they invest in, including corporate greenhouse gas disclosures. CalSTRS is interested in achieving a "net zero" emissions portfolio. Of course, CalSTRS is also interested in corporate diversity, and states: "CalSTRS will vote against an entire board of directors that does not include at least one woman and against a board's nominating and governance committee if at least 30% of its board members are not women. Furthermore, CalSTRS will vote against the nominating and governance committees of Russell 3000 companies that do not disclose their board members' diversity characteristics."

CalSTRS' Board has morphed into Alexandria Ocasio-Cortez with a \$300-billion billy club to swing at businesses that aren't sufficiently Progressive.

If you were scouring the news for a few words about supporting corporate boards trying to grow profits, entering or creating new markets, utilizing innovation, expanding geographically, then CalSTRS is not the investment entity for you.

Who has time for the actual business of business when you can be leading a social revolution?

CalSTRS might want to check out the work of Bjorn Lomborg, who shows that the climate catastrophists claims about global warming deaths, costs, hurricanes, polar bears, forest fires, etc. are routinely contorted to further the policy agenda of the anti-fossil fuel crowd.

They might want to ask teachers if they themselves are willing to pay out of their own pockets for these political goals.

They might want to ask parents if they are willing to take dollars out of their children's classrooms to diversify corporate boards.

Because the problem with CalSTRS lifting its leftist political banner above all others is that the organization has an actual role, which is fiduciary. Its job isn't to be in the political vanguard but to caretake and grow its investments to meet its payout obligations.

CalSTRS pension payments are funded by payments from the state, from teachers and school districts. If investment gains fall short, contributions need to increase.

The system was already facing a serious insolvency threat in 2040, which is a blink of an eye for a pension system. In 2014, the legislature crafted a plan to stave off the problem and mandated increased contributions from all parties.

California has seen an explosion of education spending in the past decade. Parents hope and assume that their taxpayer dollars go towards classroom enrichment, student activities, training that increases student performance, and so on. Some of it surely has.

But when investments fall short, school spending will go to backfilling pension obligations. That has also been the case. What good is that increased school spending if it doesn't benefit students?

Women and minorities should, of course, be welcome on every corporate board without a discriminatory roadblock. But their presence should indicate merit, not government fiat or race-and-gender box checking. Diversity itself should not be the goal for corporate governance.

Every single California government activity should not be Progressive activism. CalSTRS should honor the teachers, parents, taxpayers and students who are all affected by its decisions and stick to its fiduciary job.

way, you're not stuck if
they decide to raise their
prices or their quality of
service declines.

Don't get me wrong: I'm not talking about jumping from vendor to vendor every time the wind blows. We have vendors we've worked with for 20 years at Ramsey Solutions. But I'm also not going to let myself or my business become a prisoner of one provider. Currently, we have three banking relationships. We have a primary bank, and we've been with them for 35 years. We also have two other minor banking relationships. Do you see what I'm saying, Matt? If you've only got one supplier for one of the key elements of your business and they suddenly go sideways, so do you! We deal with smaller, regional and local banks at my

# When California Laws Go Too Far, The Courts Intervene

Early explorers believed California to be an island, and while its physical attachment to the rest of North America eventually became evident, it nevertheless has sought to forge an island-like cultural and political identity – a "nation-state" in Gov. Gavin Newsom's description.

There are, however, limits. Legally, California is still just one of 50 states and thus is subject to federal law, including the U.S. Constitution.

California politicians sometimes ignore that basic fact of civic life in their zeal to lead the parade. But when they cross the legal line, as defined in federal law, they get their comeuppance.

For instance, the federal appeals court that oversees California recently overturned an ordinance passed by city leaders in Berkeley, one of the state's more adventuresome jurisdictions, to ban natural gas service in newly constructed buildings.

The 2020 ordinance, cheered by environmentalists as a gesture to reduce greenhouse gases, was challenged by the California Restaurant Association for violating federal authority to set energy efficiency standards.

A federal trial judge upheld the ordinance but the 9th District Court of Appeals declared that federal law did,

Berkeley could not strike it unworkable – safety requireout on its own.

California's governors and legislators are also prone to enacting new laws that run afoul of the U.S. Constitution, federal law or, in some cases, the state's own constitution.

Chris Micheli, a lobbyist who is also a student of legislative procedure and teaches at the University of the Pacific's McGeorge School of Law, has assembled a lengthy list of Legislature as a symbolic legislative decrees that later fared poorly in the courts.

One entire class of California laws, those imposing sometimes unique restrictions on private gun ownership, has fallen prey to constitutional challenges in recent months, thanks to the U.S. Supreme Court's expansive interpretations of the constitutional right to bear arms.

While gun organizations have been challenging California's array of gun control laws for years, the Supreme Court's landmark Bruen decision last year, invalidating New York's almost total ban on the carrying of personal weapons, opened the door. One by one, California's laws are being invalidated.

> Even before the Bruen decision, a San Diego federal judge, Roger Benitez, had tossed out California's ban on magazines holding more than 10 rounds, the state's ban on assault rifles, and a law requiring background checks for ammunition purchases.

Another law that fell recently was one dreamed up by Newsom and the stunt – authorizing lawsuits against some gun manufac-They include such recent turers with conditions that made defense almost impossible. It was patterned after a Texas law making it easier to sue those who performed abortions, and Attorney General Rob Bonta didn't even try to defend it when the inevitable lawsuit challenged it.

Undeterred by the serial invalidation of California gun laws, Newsom and legislators are working on another measure that, they say, would fit within the constraints of the Bruen decision. Senate Bill 2 would create new standards for the issuance of concealed weapons permits and list a number of new places where carrying weapons would be prohibited, even by those having permits.

Whatever emerges from this year's session would face new legal challenges, and given the state's recent record, would also likely be shot down in court.

#### Snowmelt Renews Flooding Fears as Tulare Lake Rises

The onset of warm temperatures is accelerating snowmelt and triggering worries about continued flooding in the Central Valley from a record-breaking snowpack accumulated during winter and spring storms. In Tulare County, farm fields have been inundated as floodwaters and now snowmelt fill lowlands of the former Tulare Lake. Tulare County Agricultural Commissioner Jimmy Hook said flooding impacts in the county have affected 64,000 acres, causing \$131 million in financial losses. He said he expects damages to extend to 115,000 acres and losses to grow to \$300 million.

#### Bill Introduced to Restrict Foreign Purchases of California Farmland

California's farmland attracts investment from all over the world. But as drought and climate change provoke anxiety over water and natural resources, state legislators are proposing new restrictions. State Sen. Melissa Hurtado has introduced a bill to bar foreign governments and government-controlled enterprises from purchasing agricultural land in California beginning next year. Hurtado said the bill is needed to keep too many California farms from falling into the hands of foreign governments, which then control the water and energy resources that come with the land.

#### Increased Vegetation from Rains Could Add to Destructive Fire Fuels

Generous rainfall may have erased drought conditions for most of the state, but it has not necessarily eased concerns for a potentially aggressive fire season. Todd Lando, wildfire hazard mitigation specialist for the Central Marin Fire Department, said he expects the extra rainfall and snowpack will promote additional vegetation growth. While the ground may be moist, heavy firestorms have followed rainy years before. As grasses dry, they become easy to ignite and can spread to heavier vegetation. In 2017, a then-record 1.5 million acres burned in California after a wet winter in 2016.

#### Asparagus Acreage Shrinks Dramatically in State, but Growers Stand by Crop

With high labor costs and intense competition from Mexico, California asparagus production has been dropping for years. California had a peak of 36,000 acres of asparagus in 1999, and acreage dropped from 22,500 in 2006 to 2,800 in 2022. Still, growers such as Jim Durst of Durst Organic Growers in Esparto stand by the crop's place in California. He may farm half the acreage he used to, but Durst said he markets his asparagus as California-grown, appealing to consumers seeking high-quality local produce over imports.

# Huskies Cruise over Mustangs, Snag First Seed in D-V Playoffs

**SUTTER, CA (MPG)** - The Sutter Huskies ended the regular season on a high note as they beat the Venture Academy Mustangs 8-3 in a non-league victory on Friday, May 5.

On top of the regular season finale at home, it was also time to give a round of recognition to the nine seniors that will be graduating and moving on from the program.

Throughout their time in the baseball program, this senior class has never lost a league championship with the exception of their freshman season getting canceled due to COVID-19.

Huskies head coach Stewart Peterson, who just clinched his fourth consecutive league title at the varsity level gives all the credit to the athletes.

"They come out and work hard yearly, they sacrifice individual accomplishments for team accomplishments," Peterson said.

He added the coaching staff on all three levels at Sutter deserve credit for being the support system and helping all the athletes in the program grow year-to-year.

Sutter (19-5-1, 10-2 Pioneer Valley League) took an early lead in the second inning when senior outfielder Matt McCall

scored on a passed ball to give the Huskies an early 1-0 lead.

Sutter senior pitcher Matt Lorentz shortly scored from senior third baseman Jack Munger's sacrifice fly to put the Huskies up 2-0.

Lorentz had a short day on the mound as he threw two short innings and recorded three strikeouts. Lorentz expressed to the Dispatch one of the best memories of the season so far was the San Diego tournament trip the Huskies played in early April.

"It was a lot of fun being able to play baseball, win games and win the championship down there. It was a great time for all of us," Lorentz said.

Along with Lorentz, Sutter senior catcher Landon Sable reestablished the San Diego tournament as a favorite memory this season so far.

He added the relationships he has built with his fellow seniors over between their time in high school and beyond reaches back to little league as well.

"Being able to share today with them shows the connection we have with one another and allows us to be thankful for all the time we've been able to share the field together," Sable said.

Sable led the Huskies in multiple offensive categories

at the end of the regular season including batting average (.479), on base percentage (.556), stolen bases (25), and hits (34).


Sutter junior designated hitter Rylan Giovannoni extended the Sutter lead as part of a five-run third inning as he sent a three-run home run over the left field fence. The Huskies had a couple of balls that were smashed throughout the game, but the cold air kept the balls in the park.

As the Huskies finished the season tied with Colfax for the PVL title, they needed to come up with a solution to separate the seeding as both schools would compete in the CIF Sac-Joaquin Section Division V playoffs.

Peterson told the Dispatch there was a coin toss that determined who would get the higher seeding in the playoffs, it's crucial in this predicament as the teams split a double header at Sutter on March 31.

Sutter won the coin toss Peterson mentioned to the Dispatch and the Huskies were named the number one seed in the Division V bracket on Saturday, May 6.

Sutter was 6-3-1 at home during the regular season and they were scheduled to host Delta Charter of Tracy on Wednesday.

YUBA CITY, CA (MPG) - The Yuba City Honkers baseball team clinched their first playoff berth since the spring of 2019 when they defeated their crosstown rival River Valley Falcons on Thursday, May 4 in a 4-1 Capital Valley Conference win.

The importance of Yuba City being back in the playoffs reinserts itself with the historic years of traditions as teams made it a staple to be in the postseason year after year.

Honkers head coach Maury Castaneda expressed to the Dispatch it's going to be great for this group of seniors to experience a taste of the postseason.

"For these kids to join the ranks of those that have gone before them just falls in line," Castaneda said.

Yuba City (17-10, 12-6 CVC) finished second in the CVC as they swept River Valley on May 5, which gave them five series won out of the possible six in CVC play.

Through previous conversations with the Dispatch, Castaneda exclaimed the importance of winning a series and how

crucial it could come later in the season like it did.

Besides Woodcreek (won six CVC series), the Honkers were the only team to win five or more series in CVC play. Yuba City trailed River

Yuba City trailed River Valley until the bottom of the third when senior first baseman Peyton Fredieu laid down a safety squeeze bunt to the first base side to score two runners and give the Honkers a 2-1 lead.

Fredieu expressed to the Dispatch that he had an idea he was going to get asked to lay down a bunt when he got to the plate.

"We work on bunting a lot and I've been successful with it. If the situation presented itself to where I could lay one down, I felt good about it," Fredieu said.

Fredieu went two-forthree in the game with the two runs-batted-in (RBI). Honkers senior third baseman later followed up with an RBI single later in the inning and Fredieu came around third and scored on a throwing error to first to give Yuba City the 4-1 lead and all of their runs for the night.

Fredieu and fellow senior outfielder CJ Hopper both led the Honkers on the night with two hits a piece as Hopper singled in the first and fourth inning.

Hopper is the team leader in hits for the regular season (34) as he narrowly edged out fellow senior outfielder Brent Gallegos with 33.

Hopper told the Dispatch postgame of the May 4 victory that to get good momentum into the playoffs, they needed to keep the foot on the gas pedal and keep pushing.

As seniors were recognized postgame on May 4, family and friends shared the field with the Yuba City players and as Hopper came out with family, his favorite memory as a Honker was a 14-inning game they won 8-6 against Roseville on April 29, 2022 because it was a long game and they came out the victor.

Yuba City was announced as the 10th seed in the CIF Sac-Joaquin Division II bracket on Saturday, May 6. They were scheduled to play this past Tuesday at Granite Bay.

Castaneda is not worried about traveling as he has full confidence in his team to play anywhere and anytime.

The Honkers were 6-6 on the road this season. ★



MARYSVILLE, CA (MPG) -May is National Bicycle Safety Month and the Marysville Police Department is encouraging more people to get active and safely take bike rides.

Bicycling is a great means of transportation and recreation, and everyone deserves to ride to

their destination safely, Let's look out for one another and share the road, share the responsibility.

The Marysville Police Department suggests the following safety tips for bicyclists and drivers.

Drivers should: Slow down and follow the speed limit. Be careful traveling through intersections; Look carefully for bicyclists and pedestrians before making a turn or opening a car door near streets or bike paths; Be patient when traveling behind a bicyclist and give them space when passing. California law requires drivers to change a lane, when possible, to pass bicyclists; Never drive distracted or impaired.

Bike Riders should: Use lights at night; Although not required for riders 18 and older, always wear a properly secured helmet. Helmets significantly reduce the chance of a head injury in the event of a crash; Bicyclists must travel in the same direction of traffic and have the same requirements as any slow-moving vehicle; Yield to pedestrians, just as a driver would. Pedestrians have the rightof-way within marked or unmarked crosswalks at intersections.


