The Marysville Drakes celebrated their first win postgame with children in attendance after the 26-6 win over Dublin on Thursday, May 25.

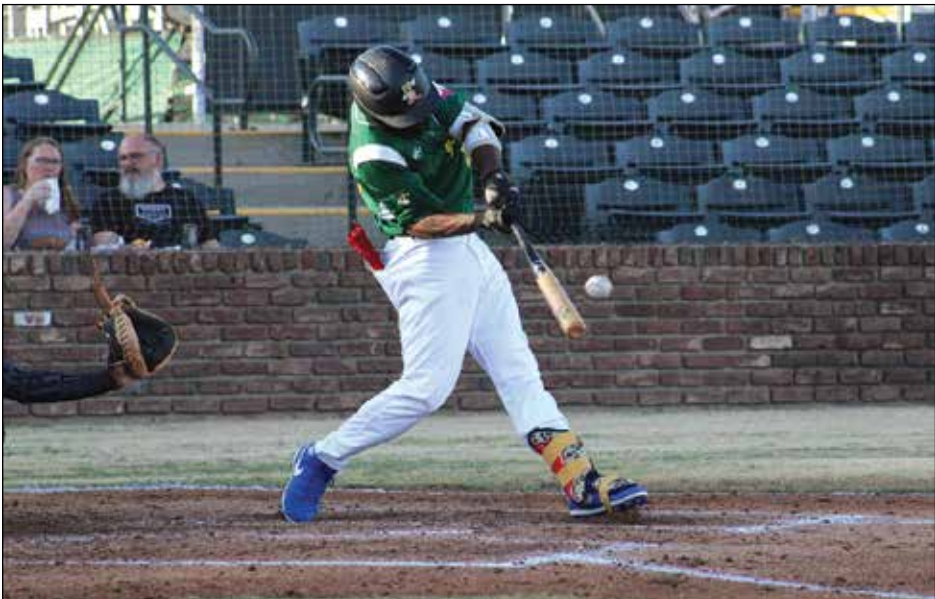

MARYSVILLE, CA (MPG) - The Marysville Drakes got off to a hot start as they began their inaugural season in the Pecos League with an outrageous amount of offensive production of 52 runs in their first three games from May 25-27.

Expect More Delays for Roadwork, Rock Blasting on State Highway 70

Caltrans Alert

BUTTE COUNTY, CA (MPG)

- Caltrans is alerting motorists to expect travel delays over the next two years on Highway 70 through the Cresta area of the Feather River Canyon due to construction.

Crews have set up an automated traffic signal to manage one-way traffic control from the Shady Rest area to one mile south of the end of the construction zone. Motorists can expect up to a five-minute delay

In June and July, motorists can expect long delays because of rock blasting operations. Rock blasting may occur anytime from 8 a.m. to 11 a.m. Tuesdays through Thursdays starting Thursday, June 1. During these operations, motorists may expect a temporary closure of the highway and up to a three-hour delay around the construction area to allow the contractor to clear debris and ensure the roadway is safe for travel.

The rock blasting operations are part of a project to raise the existing roadway by five feet, shore up the embankment with rock material to protect against future flood damage and build a retaining wall along the hillside.

Caltrans advises motorists to expect travel delays along the Highway 70 corridor between Jarbo Gap in Butte County and the Greenville Wye in Plumas County. Caltrans and PG&E have projects scheduled at various locations in both counties.

California Community Schools Public Partnership Awards Funds to Marysville School District

MARYSVILLE, CA (MPG) - At their meeting on May 18, 2023 the California State Board of Education approved \$750 million in community schools implementation grants proposed by the California Department of Education, of which more than \$13.5 Million was granted to Marysville Joint Unified School District. According to a recent press release issued by the California Department of Education, the approval marks the largest single investment in community schools anywhere in the nation.

The grant application was prepared based on the needs of individual school sites in the MJUSD family. Of the 23 schools under the Marysville Joint Unified School District umbrella, 11 schools were included in the grant application and 10 were funded, including: Lindhurst High School, South Lindhurst High School, Yuba Feather, Kynoch, Anna McKenney, Yuba Gardens, Linda School, Ella School, Cedar Lane and Johnson Park.

Since last year, wellness has become a major focus of the work at MJUSD. The district holds fast to

the belief that if students, adults and families are physically and mentally well, they will be able to move to the next level of success in their education, work and careers.

Superintendent Dr. Fal Asrani stated that district-wide data indicates that, similar to what is noticed across the nation, students in MJUSD are struggling with behavior, academics and attendance. "We have noticed that discipline and chronic absences have doubled since schools have reopened following the COVID-19 pandemic closures," said MJUSD Superintendent Dr. Fal Asrani. "Fighting, aggressive behaviors, defiance, vaping, etc., has resulted in a substantial rise in suspension rates as well," said Asrani.

Along with several members of her cabinet and school site administrators, Superintendent Asrani rolled up her sleeves to write and secure the CCSPP grant. "I'm immensely proud of our team for securing this grant without the use of a professional grant writer," said Asrani. This was hard work and

a true labor of love. These funds will directly benefit MJUSD students and their families and allow these

schools to design actions to enhance teaching and learning," she said.

The wellness-centered focus on students is something school administrators are excited to begin implementing. "Receiving the CCSPP grant will be a game-changer for students, staff, families and our community," said Jim Hayes, Principal of Yuba Gardens School. "I am looking forward to working with all of our stakeholders as we implement this important work. Creating a Wellness Center with all the different services that it will provide will be amazing and I can't wait to get started." The CCSPP grant funds will be utilized to develop wellness activities and programs at these school sites.

The California Department of Education stated that the \$4.1 billion California Community Schools Partnership Program (CCSPP) is the nation's largest investment in the community schools model and is designed to transform educational outcomes for students through a whole child and whole family approach that brings an array of services to the school site in order to

GRIDLEY, CA (MPG) - After CALFIRE Butte County's North vs South softball game Friday, May 19th, a combined team of Butte County Firefighters took on Sutter County Fire in a first ever contest.

An official roster was not provided by either team for this match-up, but players came from multiple firehouses throughout the two counties to battle on the diamond.

The 6-inning game was a tight one. Sutter was up first, but Butte would draw blood with 2 runs on the board in the 1st inning. Butte would rack in two more points during the 2nd, keeping Sutter at zero.

Sutter wouldn't answer back until the 3rd inning, pushing to score with one run in and men on first and second. Butte would hold Sutter to 4-1.

Moving into the 4th inning, Butte would load the bases. A drive down the right baseline by Kevin Finkenkeller would bring in 3 runs. With two outs, Butte would continue to rack up numbers as more runners crossed the plate. Butte's Conner Stapleton would send the ball out of the park for a total of 7 runs added

during the inning.

Sutter was quick to respond with Chris Brown hitting a line drive between first and second bases, putting runners on third and first. Sutter would end the inning with 4 runs on the board.

Shortstops Kevin Finkenkeller for Butte and Gustavo Rangel playing for Sutter put a lot of work throughout the game holding the opposing team at bay. It should be noted that both outfields saw a lot of play, and pitchers Sutter County Fire Chief John Shalowitz and CALFIRE's Information Officer Rick Carhart dodged their fair share of balls.

Beginning in the 5th, Sutter slowed Butte down and started getting more men home, closing the gap between the two teams. In the top of the 6th, Sutter's Dan Tarcher would hit a homer, bringing the score to 12 - 10. Rangel would follow suit, sending one over the fence with a runner batted in.

Stapleton would step into the box with the game tied. It would be his out-of-the-park homer in the bottom of the 6th that put the final score in lights and ended the game, 13-12. CALFIRE Butte County would be the victor. ★

Starick had a stint with the Lincoln Potters in 2018. Starick expressed to MPG that they are going to progress through the season game by game by giving it all they have on the field.

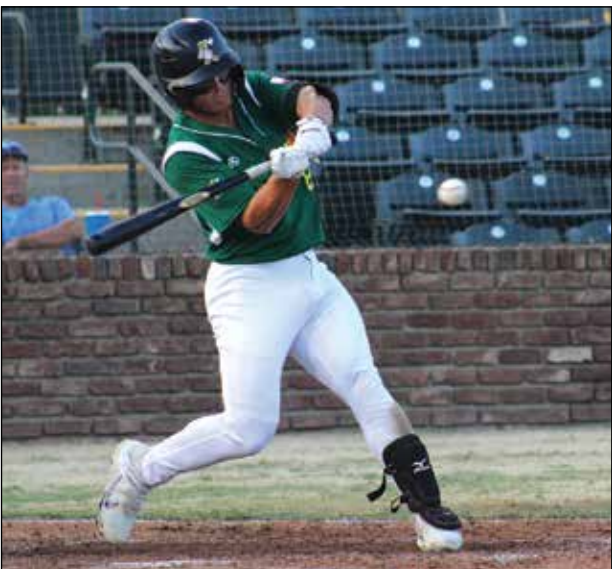
Mitchell told MPG they have been working collectively as a club for less than two weeks together, but their team chemistry is on point with one another.

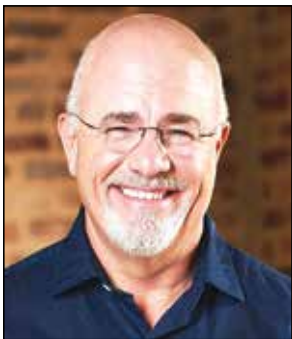

I'm 61, and I hope to be able to retire soon, but I'm watching my retirement savings completely eroding away day after day. The only place I'm not losing money is \$180,000 I have sitting in the bank earning almost zero interest. What should I do?

Come on, man. "Completely eroding away day after day?" That's a little dramatic. One of the things you have to understand, and coming to grips with it has helped me since I began doing research on things like this 30 years ago, is we all have a drama queen living in our brain that exaggerates things—especially when it comes to

investing. So, take a deep breath and calm down. Everything's going to be okay.

Studies have shown us it takes \$3 of gain in an investment to emotionally offset \$1 of loss. Our brains record negative things at a much greater rate than they do positive things, and it takes a lot of emotion to recover from that. Your investments may be down a little. If you've got \$1 million in there, it may be worth \$900,000 right now. Next year, it's liable to bounce up to \$1.1 million. In other words, your entire retirement savings is not "eroding away."

Have you ever heard people say they lost all their money in the stock market? Well, that's mathematically impossible, unless you put all your money into one company, and that company completely closed and was worth zero. Remember Enron? What most people really mean when they say that is they lost a

bunch of money because they freaked out and went into hyper-drama mode, then pulled all their money out while the market was down.

Jesse, did you know that in the last 20 years, every down year in the stock market was followed by two years of record gains? Facts and mathematics are your two best friends when it comes to telling your inner drama queen, "Shut up, we're going to continue to invest!"

Dairies in Tulare, Kings Counties Resuming Operations After Flooding

Dairy operators in Tulare and Kings counties say they are thankful to return to the normal rhythms of feeding, milking and calving after historic flooding in March burst levees and forced dairies to rapidly evacuate their cows. Tulare County is California's leading milk and milk products producer. Kings County ranks fourth. Thousands of cattle were evacuated during the storms. While most have returned to dairy ranches, they are being closely watched by veterinarians for stress, which can open doors for disease. No cattle illness spikes have been noted to date.

U.S. Supreme Court Rejects Challenges to California Animal Housing Law

The U.S. Supreme Court has upheld California's Proposition 12. Now out-of-state producers of pork, eggs and veal have decisions to make: Change their operations to comply with the law's animal housing requirements or stop selling their products in California. The Golden State enjoys a 13% share of the U.S. consumer pork market, making it economically infeasible for many pork producers to exit the California market. Because of the interconnected nature of the U.S. pork industry, all or most hog farmers would be forced to comply with the state's requirements.

Salinas Valley Lettuce Farmers Hope for Better Year After Floods, Crop Virus

Things are even more challenging for lettuce growers in the Salinas Valley after this year's storms. Farmers in 2022 had suffered an estimated \$150 million in crop losses as impatiens necrotic spot virus – a destructive plant disease spread by thrips – moved from field to field. Then this year, vast flooding from atmospheric storms damaged multiple crops, with lettuce growers suffering an additional \$54.4 million in losses, according to recent figures released by the Monterey County agricultural commissioner. Still, lettuce growers say they are hoping for a successful crop this year.

Monterey County Winds Soothe Winegrapes, Frustrate Tourists

Coastal winds in Monterey County create some challenging contradictions for a wine region trying to build its brand and attract more tourism. Some winegrape producers say they fear winds that push the fog and help cool vineyard leaves can also discourage winery construction and dissuade tourists who may not want to sip fine wine varietals in gusty settings. Still, the upstate coastal wine region is winning acclaim for its pinot noir and "premium, coastal, cool-weather chardonnay." The wine sector produces \$1.4 billion in economic activity for the county and provides 10,491 jobs ★





How Will California Deal With Budget Deficits That Seem Here To Stay?

A little more than two weeks remain before the June 15 constitutional deadline for enacting a 2023-24 state budget.

It's as certain as anything in politics can be that the Legislature will pass something it calls a budget. If lawmakers missed the deadline, they could lose their paychecks.

It's equally certain that whatever they enact will not be the final plan for the 2023-24 fiscal year that begins July 1. Due to declines in revenue, the state faces not only a multi-billion-dollar deficit in the forthcoming year but the likelihood of continuing gaps for several years thereafter.

There is, moreover, neither consensus on the scope of the deficit nor agreement on how the governor and legislators respond. Meanwhile, those in the Capitol are besieged by pleas by those with stakes in the budget to protect their projects and programs and demands for even greater allocations.

When Gov. Gavin Newsom introduced his first version of the budget in January, he said the state had a \$22.5 billion deficit, and then increased the shortfall by another \$9 billion in the revised budget

proposal this month.

Immediately, however, the Legislature's budget analyst, Gabe Petek, told his bosses that it's really \$34.5 billion and, more ominously, declared that the state faces continuing deficits averaging \$18 billion for several more years.

It is, in the parlance of fiscal mavens, a "structural deficit," meaning it's baked into the state's finances regardless of underlying economic conditions. All of the competing versions of the state's fiscal situation also assume that California does not experience a recession in the near future.

Were a recession to strike, the deficits could grow by tens of billions of dollars because California's revenue system is dangerously dependent on taxing the incomes of the state's wealthiest residents, as Newsom's budget acknowledges.

"California's progressive tax system, where nearly half of all personal income tax in the state is paid by the top 1% of earners, has contributed to extreme budget volatility over the years," the May revision says. "Maintaining budget stability requires long-term planning in the face of these revenue fluctuations."

In light of that statement and Petek's rather gloomy long-term projections, will Newsom and the Legislature respond responsibly? Or will they take the easy way out, paper over the current deficit with creative bookkeeping and backdoor borrowing, and ignore the structural deficit until it becomes a crisis?

Newsom's budget is

essentially a short-term response, dipping the usual bag of fiscal tricks to produce a budget that would be balanced on paper – assuming his deficit estimate of \$31.5 billion is accurate.

Both Senate and the Assembly leaderships have adopted budget frameworks that purport to protect vital services but differ in approach. The Assembly's version would reshuffle appropriations while the Senate's would cover the gap by raising corporate income taxes, arguing that a tax hike would merely recapture money large corporations gained from the Trump-era federal tax overhaul.

Although Newsom immediately rejected a corporate tax increase, if the deficit is as wide and chronic as Petek projects, budget stakeholders will intensify their demands for tax increases of some kind.

In recent elections, California voters have rejected proposed increases in property taxes and personal income taxes on the wealthy. Newsom opposed the income tax increase, is now opposing the Senate's proposed corporate tax, and also has rejected periodic bills to impose a wealth tax.

"A wealth tax is not part of the conversation," Newsom said of this year's version. "Wealth taxes are going nowhere in California."

This year's budget dance will kick off a political tussle over spending and taxes that will likely continue for the remainder of Newsom's governorship.

Don't Let Short Term Rates Affect Long Term Thinking

With interest rates higher than they have been in literally decades, retail investors and pros alike are once again forgetting history, donning their dunce hats and repeating the same assumptions they did the last time rates moved with some conviction.

When offered longer term investment strategies which lock in the current high interest rates, most all those who have money to invest are turning down locked-in rate investments in lieu of short term products like 3 month CD's and T-bills currently paying north of 5% APR.

On the surface, having the opportunity to sock money away on a 3 month term yet get over 5% APR sounds like a good deal, and it is, but it's not the best deal.

The shortsightedness on behalf of investors that continue to scoop up 3 month T-Bills and CD's is solely based on the interest rate and the length of the tie up. After all, 5% APR on a 3 month investment certainly sounds lucrative, but keep in mind the 5% is for 12 months, not 3 months, so you would have to buy them every 3 months, and that's IF the interest rates doesn't change.

And therein lies the problem.

To begin with, I am constantly bringing new investments to consumers that lately have been meant to minimize risk yet provide a decent return. The "minimize risk" part is because it is in my opinion the market may have stopped its hemorrhaging for now but I highly doubt our inflation problem will go away anytime soon and a recession looms.

Looking back on interest rates the last 2 or 3 decades illustrates a country that has a debt problem. Mainly the fact that consumer, government and business debt is continually increasing at an alarming rate.

If debt continually increases, interest rates would and will have to continually decrease to service that debt. And true to form, a three or five year moving average of interest rates in the United States show a persistent downward trend. Recent memory for many think of bank savings rates as near zero and its only recently have we seen rates as high as 5% or more.

There is a reason the Federal Reserve (FEDS), who set interest rates, have not been able maintain higher interest rates for a prolonged period of time and it's because of our gigantic debt levels.

Every time the FEDS have increased rates in the last few decades they tend to break something and have to reduce rates again. Think back to the dot.com, Y2K and 9/11 events that resulted in the FEDS lowering rates to ground level in response. That resulted in the adjustable

rate/ refinance craze which eventually resulted in financial Armageddon. That in turn caused the FEDS to drop rates to near zero once more.

Now the FEDS are back in the *up* mode and, if history is any indication, they will eventually break something, and be forced to drop rates again.

Investors, however, still resist to lock in the current high rates with longer commitments.

They still opt to instead buy short duration CD's and T-Bills thinking the 5%, three month term is an incredible offering and will continue.

What they fail to realize and therefore are missing a once in a blue moon opportunity to secure high rates for years to come, is that 3 month CD's and T-bills are just that: 3 months.

If the FEDS drop rates again, down will go the rate on the 3 month products, and you are right back to earning nothing.

Yes, a 3 month CD offering an APR of 5% looks good on the surface, but historically, they may not stay there for long.

One might consider the longer term offerings that lock in those healthy returns and guarantee them and your principal.

Although 5 year CD's and T-bills might be actually paying lower rates, there exists annuities, laddered portfolios and other investment vehicles that will lock in rates for many years to come.

Unlike the refinance craze where many homeowners assumed when their mortgage rates adjusted they could just refinance, many investors are thinking the same thing when it comes to predicting where rates might go, versus where rates can go.

The bottom line is high interest rates might not stick around very long. Thinking they will is shortsighted and could be costly.

Better to look at history and use some common sense, and consider longer term and guaranteed solutions. In other words, get while the gettin's good, and get those high rates locked up! Have questions? Feel free to send me an email.

This Month In Your Garden

June in the garden is a nice time of the year. The days are warm but usually not too hot. Mornings are nice and cool so it's good to get out early for gardening and planting then relax, or do less strenuous tasks in the garden during the warmer part of the day. Do your landscaping projects in the morning when it is cool. Watering is also more important now than earlier in the season where if you missed the watering, the weather is pretty forgiving and no dire consequences. Now that it is getting warmer, the need to keep on the schedule is important. Be sure your watering system is working well. Check all the emitters on the drip systems and be sure they are not clogged and are working as they should. It's best to do watering in the early morning before the heat of the day. There will be less evaporation and your plants can get a good soak to go through the days. Be sure to add mulch to your landscape. Three inches of mulch is recommended in garden beds and around trees. Mulching keeps the moisture in the soil so you use less water.

It is generally recommended that fertilizing should be done 3 times a year, February or March, June and September. March fertilizing helps to get everything off to a good start after the winter dormancy. June is for maintaining growth and energy needed for flowering and/or fruiting. September's feeding is taken up by the plant, some of it used and most of it is stored by the plants through the winter while they are dormant and then used when needed as they awaken for spring. Many people have definite ideas about fertilizing and what should be used. Basically, we have chemical or organic fertilizers to use. You will usually see a faster response by the plants to the chemical fertilizers, but organic fertilizers actually build up the soil so have a much better long term effect. If you have always used the chemical fertilizers and decide to go organic, keep in mind that you will see slower results from the organic fertilizers but they work equally well, and do it without depleting the soil.

During the summer there is lots of

color to see from all the blooming plants. If you are looking for colorful plants that are great summer bloomers that really seem to enjoy our heat, look for Crape Myrtles or Rose of Sharon, and many perennials. They are available in several different colors – shades of red, white, pink. Of course there are many beautiful roses to add color to the landscape. They need good soaks a couple of times a week and fertilizer every four to six weeks to keep them looking their best. It is also necessary to dead head them regularly. If the spent flowers are left on the plant they will become red seed pods, called rose hips, and the rose will quit blooming because it has done its job for the year. That is true of many plants since they set seed to carry on their species. If the seed pod – or whatever form they are - is removed, they will bloom again to produce more seeds. Perennials are also a good choice for summer color and they come back year after year.

More calls come during the summer months about wilting and dead plants than any other time of the year. The best thing you can do for your plants, is to mulch around the base, keeping the mulch a few inches away from the trunk or main stem, and deep water it twice a week. Deep watering is achieved by creating a slight basin and laying a hose or drip that is running slowly enough so that there is no run off, or allowing drip systems on trees and shrubs to run for longer periods but fewer times per week. This allows water to soak into the soil at the base of the plant. When the plant is deep soaked, roots are better able to get well into the soil, thus the plant is able to better sustain itself through the heat of summer.

Father's Day is June 18th, the first day of Summer is June 21st – enjoy your summer in the garden!

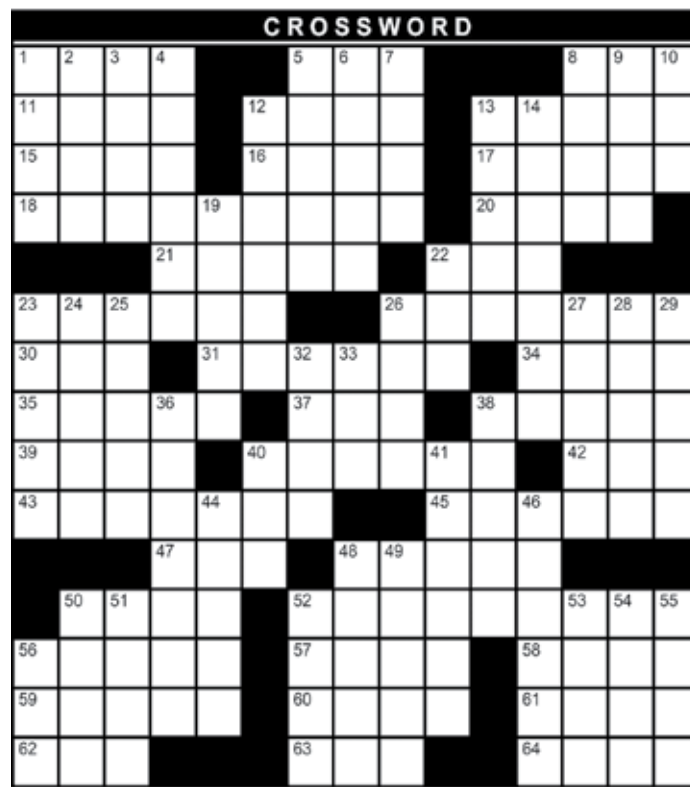

IRA Exemption is a False Promise to Small Biotechs

The legislators who drafted the Inflation Reduction Act (IRA) apparently had some idea that their bill was going to hurt small biotech companies.

Passed last summer, the new law will impose price controls on some drugs purchased by Medicare starting in 2026. As everyone from the non-partisan Congressional Budget Office to economists at the University of Chicago predicted, this will reduce investment into drug research, and as a result, cut the number of new medicines coming to market.

Patients hoping for new cures will pay the harshest price. Caught in the middle are drug companies, forced to make difficult decisions and reallocate investment funds now that the government has fundamentally changed the incentives.

Smaller companies, lacking cash reserves or multiple product lines to fall back on, are at greatest risk of being driven out of business by the IRA. But it's actually small biotech companies, many of them startups, that drive essential innovation and competition, accounting for more than half of new medicines.

Deep in the 725-page legislation, the drafters included a few paragraphs that seem intended to help small biotechs by temporarily sparing them from the IRAs most draconian measures. Specifically, if a small biotech drug brings in more than 80% of the company's Medicare revenue and accounts for less than 1% of Medicare Part B or Part D spending, then that drug is exempt from IRA price controls until 2029.

The problem is that few companies will be able to meet the criteria for exemption. A business receiving 80% of its Medicare revenue from a single drug

is by definition narrowly focused. But such companies, deeply invested in a single lifesaving cure, typically don't have the capacity to scale up.

For that, they partner with bigger organizations. We've all benefited from this type of arrangement in recent years: BioNTech developed a breakthrough mRNA vaccine against Covid-19, then partnered with much larger Pfizer to manufacture the shot and get it to clinics and hospitals all over the country.

But by joining in this kind of often-essential partnership with a maker of multiple common drugs, a small biotech will fall below the 80% threshold and not qualify for the exemption.

Perversely, those IRA paragraphs disincentivize a company like BioNTech from partnering with a massive company like Pfizer, and also discourage developing a second drug that could reduce the percentage of Medicare income brought in from the first one. Instead, the supposedly helpful exemption pressures small biotechs to develop their own manufacturing and distribution capabilities, encouraging them to risk resources on non-core activities when they would be better off focused on research and development.

At the same time, with the 1% rule, the exemption essentially punishes success. If a small biotech's new drug becomes so in-demand as to exceed that percentage of Medicare drug spending, the company will find itself slapped with price controls.

Small biotechs are developing future cures for cancer, Alzheimer's disease, diabetes, HIV, and the next pandemic. For the future of global health, we need them to keep going. But far from helping these companies survive and thrive, the IRA is crushing them. This needs to change, and quickly.

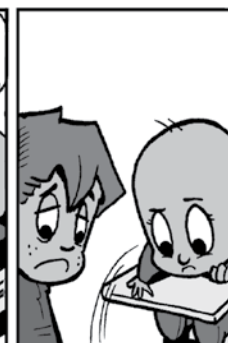

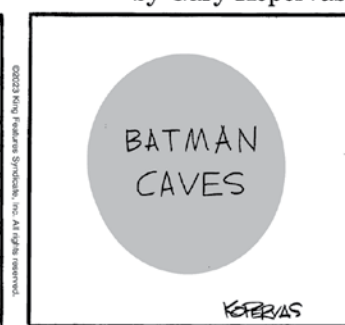

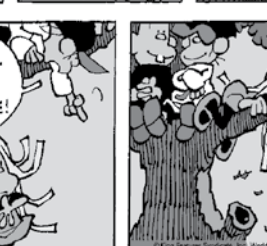

Huskies Walk-Off in 13th Inning Using Small Ball to Win Title

SACRAMENTO, CA (MPG) - The Sutter Huskies won their second consecutive section title Tuesday, May 23 as they beat the Bradshaw Christian Pride 4-3 in a thriller that came down to small ball execution to win the biggest game of the season to date.

Bradshaw Christian struck the scoreboard in the first inning as they brought in two runs off of three hits off Beck.

Beck settled into a groove after as he retired 12 of the next 13 batters from second inning to the fifth until the Pride took a 3-0 lead in the top of the sixth off a wild pitch.

Sutter (23-5-1) had the support of the entire community in the stands at Union Stadium. The Huskies did string a couple hits throughout the first few innings but were unsuccessful at times with trying to get some bunts down.

In the bottom of the sixth inning, Huskies junior shortstop Logan Yacavace singled and advanced to second on the throw. Sutter senior second baseman Andrew Hanson doubled and scored Yacavace for the Huskies first run of the night.

The Sutter dugout and fans went nuts as Hanson slid into second safely and the momentum shifted over to the Huskies.

Sutter junior designated hitter Rylan Giovannoni scorched a double to left field to score Hanson

and senior outfielder Matt McCall to tie the game and let everyone in attendance the game was not over.

"It was huge, Giovannoni said."

Beck was relieved in the seventh inning by Yacavace and received a huge ovation from the crowd for his performance on the night.

Beck told the Dispatch he had

a little trouble locating his spots in the first by leaving balls up in the zone, but felt more confident in the second and so on as the game played on. Beck threw 6.1 innings and surrendered three runs off five hits and struck out nine.

Yacavace came in and you could tell he wasn't letting Bradshaw

Christian score a run no matter how long it took.

Huskies head coach Stewart Peterson expressed to the Dispatch that Yacavace was dealing and they checked in with him every inning.

In his fifth appearance of the season, Yacavace dealt indeed as

he threw 78% strikes and struck out 10 in his 6.2 innings of work as he shut down the Pride's lineup with giving up three hits.

Yacavace said to the Dispatch that he was nervous at the beginning, but he wanted to get the win.

Sutter had the bases loaded in the bottom of the 11th with two outs, but couldn't end the game. In the top of the 13th with a runner on first and no outs, senior third baseman Jack Munger caught a line drive off the bat of Wiser and effortlessly threw the ball to first to pick up the double play.

Munger expressed to the Dispatch he knew the game was theirs (Sutter) as the momentum had been on their side for the better part of later in the game.

The foreshadowing that Munger had in the game worked wonders as in the bottom of the 13th after two singles to lead off the inning by Giovannoni and senior outfielder Matt Lorentz to be on first and second with no outs. Junior infielder Jordan Lee came up to the plate and laid the perfect soft bunt between the pitcher and third base to cause a rushed throw.

As the ball went toward Lee's back, the first baseman for Bradshaw Christian attempted to stop the ball but it went right past his glove and gave Giovannoni the chance to take home easily and win the Division V title.

Lee and Peterson told the Dispatch post game that the bunt was to be soft and not directly back to the pitcher, so Lee did his job.

Peterson said the team stayed together with one another and battled throughout the whole night.

With winning the SJS D-V title, Sutter qualified for the CIF NorCal Regionals and was awarded the first seed in the Division IV bracket of eight teams.

The Huskies hosted the Athenian Owls out of Danville on Tuesday in the first round. The Division IV NorCal Championship will be hosted at the highest remaining seed this Saturday, June 3. ★

Samuel Langhorne Givens. Quote: "Never put off till tomorrow what you can do the day after tomorrow." He visited Meadow Lake City aka Excelsior, Summit City in the year of our Lord 1866. Today, as in those forgotten days, the fishing for small rainbow trout is excellent in Meadow Lake. Unfortunately, the snow was 20-30 feet deep, and in late 1866 fire destroyed the town. Mark Twain used toe-bitter Hellgrammites that he scrounged from the creek bottom for bait. (b) Donnor Lake Mackinaw are biting. Good sportsmen practice catch and release to preserve the Mack's. Twenty pounders can be found at 40-feet deep. Try: Flat Fish. (b)
