## Avian Influenza Detected in Deceased Bobcat

**SACRAMENTO, CA (MPG)** - Wildlife disease specialists with the California Department of Fish and Wildlife (CDFW) recently received confirmation that an adult bobcat died from the Eurasian strain of highly pathogenic avian influenza (HPAI) H5N1. This is the first detection of the virus in a wild mammal in the state.

The bobcat's remains were collected in Butte County by CDFW on December 23, 2022. Samples were submitted to the California Animal Health and Food Safety Laboratory System for preliminary testing. On January 24, the U.S. Department of Agriculture's (USDA) National Veterinary Services Laboratories confirmed the detection of avian influenza H5N1 in the bobcat. Elsewhere in the U.S. and Canada, periodic detections of Eurasian HPAI H5N1 have been made in mammalian carnivores including foxes, bobcats, raccoons, and skunks.

The bobcat was wearing a GPS collar as part of a CDFW population study. The collar was equipped with a sensor that alerted biologists when the animal stopped moving for an abnormal amount of time. CDFW biologists located the remains and began an investigation into the bobcat's cause of death.

HPAI H5N1 was first detected in wild birds in California in July 2022. To date, HPAI H5N1 has been detected in wild birds from 44 counties. The California Department of Food and Agriculture (CDFA) has also reported detections of HPAI H5N1 in domestic birds from 18 counties. Waterfowl and domestic poultry are especially vulnerable to the disease. The strain of H5N1 currently circulating in the U.S. and Canada has been causing illness and death in a higher diversity of wild bird species than during previous avian influenza outbreaks, affecting raptors and avian scavengers such as turkey vultures and ravens. Mammalian and avian predators and scavengers may be exposed to avian influenza viruses when feeding on infected birds. This bobcat was found in an area where HPAI H5N1 had recently been detected in a turkey vulture. Notwithstanding this detection, infection of wild mammals with avian influenza viruses appears to be relatively rare.

## Lady Indians Shush Huskies

**MARYSVILLE, CA (MPG)** - The Marysville Indians girls' basketball team inched one game closer to the 2023 Division IV CIF Sac-Joaquin final as they silenced the Hughson Huskies in a dominant 76-18 victory last Thursday, February 16.

The fourth seeded Marysville squad best Ripon 60-15 on February 14 before they controlled the game from the jump against Hughson.

The Lady Indians quickly put the game out of reach for the Huskies by the end of the first half as they led 49-14. The defensive tactic of the full-court press flourished as it has done for most of the season.

Marysville (26-4) head coach Ike Prince expressed to the Dispatch that the

effort and hard work the Lady Indians have put in all season was paying its dividends towards the end of the season.

"They leave all the effort on the court," Prince told the Dispatch.

Marysville had a total of 36 steals and 12 blocked

shots in the game, which both were higher than their season averages of 27.2 and 5.7.

# Indians Soar Over Hawks, Hit Road for Semis

MARYSVILLE, CA (MPG) - The Marysville Indians flew past the Liberty Ranch Hawks in the second round of the CIF Sac-Joaquin Section Division IV playoffs in a 90-59 win last Friday, February 17.

Marysville jumped out early in the first quarter and never relinquished the lead on the way to their 22nd straight victory on the season.

The Indians were hitting their shots from the jump, including four of six attempts from behind the arc. On top of their high powered offense, the defensive effort was on display with multiple Marysville players stealing the ball from Liberty Ranch left and right.

The Indians led 28-11 by the end of the first and senior guard Amrin Mann led the way with 14 points.

Mann ended with a game-high 30 points and added three steals on the night.

Marysville (27-3) head coach Stan Easter expressed to the Dispatch he had full confidence in his senior leadership to take charge of the game.

Easter added they were in the exact same situation last season when they hosted Venture Academy in the 2022 playoffs and they were beaten at home, so Easter mentioned his seniors remembered what it felt like and didn't want to experience it again.

Mann exclaimed to the Dispatch that the biggest difference for playoffs is the win or go home mode with the single elimination tournament.

"Our goal from day one was to be in this position, this is our season and what we have been working towards," Mann said.

The Indians took a 47-28 lead at the half. In the second quarter junior guard Bradford Pietz and sophomore guard Dennis Syders

played effective minutes and were able to give breathers to some of the starters.

Mann and Easter both reiterated the play of their bench shows how deep in depth the team is because they all have different strengths and roles on the team.

Easter additionally pointed out the play of the tallest player on the floor in junior center Josiah Arrington and how physical he was throughout the night.

"He has progressed a lot during the season and tonight he was physical with his rebounding," Easter said.

Arrington had 12 points and eight rebounds during the game including a three-point field goal late in the fourth quarter where the entire Marysville bench jumped up in celebration.

Arrington expressed to the Dispatch that the competition between the Indians practice between their playoff win against Dixon and Liberty Ranch was competitive.

The Indians were successful in getting themselves to the free throw line profusely against the Hawks as they attempted 24 free throws as their season average was 12.7 attempts per game.

With the win, Marysville will travel on the road and play Venture Academy of Stockton in the semi-finals of the Division IV playoffs.

Venture Academy is the second seed in the Division IV bracket and is the first meeting between the squad this season.

Mann told the Dispatch it will be a challenging game, but the Indians need to take care of their business and they will be fine. The winner will compete in the finals this Friday at the Golden 1 Center where the Indians played a regular season game with Lathrop in the middle of the season.

The team saying this season for Marysville is "jobs not finished."

Mann expressed that job was not to jump ahead and focus on Venture Academy first. ★

# Caltrans, OTS Unveil New Student - Named Work Zone Safety Mascot

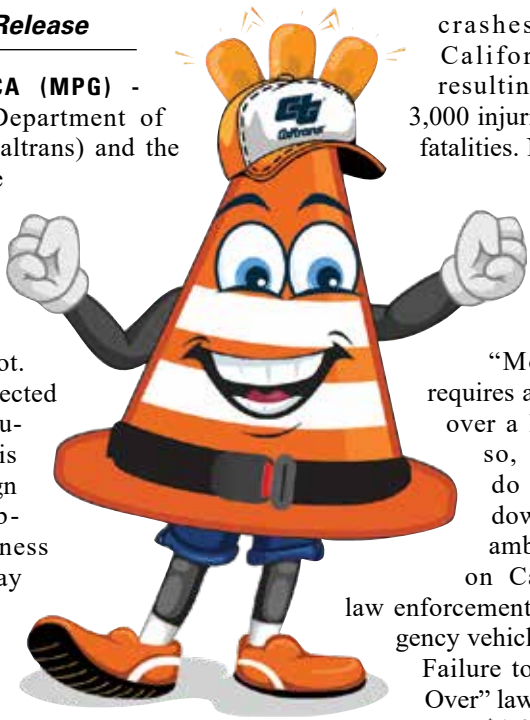
**SACRAMENTO, CA (MPG)** - The California Department of Transportation (Caltrans) and the California Office of Traffic Safety (OTS) unveiled on February 6, 2023, Safety Sam as their new safety cone mascot. The name was selected in a statewide student contest and is part of the campaign to expand public safety awareness to protect highway workers throughout the state.

Huntington Christian School (Huntington Beach) student Miller Ruiz's winning name was selected from nearly 2,000 entries submitted by K-12 students across the state. In recognition of his winning suggestion, Miller will receive a laptop, a \$500 gift card, a \$500 gift card for their teacher's classroom, T-shirts, and a visit from Safety Sam. The mascot will educate Californians on the importance of moving over a lane or slowing down when they see his orange friends and highway workers.

"Caltrans makes safety priority number one, and safety cones are critical to let drivers know when and where highway workers are on the road," said Caltrans Director Tony Tavares. "Including young people in our safety awareness campaigns helps us raise the awareness of both the next generation and current drivers, and we're excited to make Safety Sam the face of the important work being done to keep our highway workers and the traveling public safe."

"Educating the public on safe driving behaviors is key to helping save lives on our roadways," said OTS Director Barbara Rooney. "Safety Sam engages the public in a fun and interactive way while serving as an important reminder to be attentive when approaching work zones."

In 2020, nearly 7,000 work-zone



crashes occurred on California roadways, resulting in more than 3,000 injuries and nearly 100 fatalities. Nationally, drivers and passengers account for 85% of people killed in work zones.

California's "Move Over" law requires all drivers to move over a lane if safe to do so, or if unable to do so safely, slow down when they see amber flashing lights on Caltrans vehicles, law enforcement, and other emergency vehicles and tow trucks. Failure to obey the "Move Over" law can result in fines up to \$1,000, plus points on your driving record.

The statewide contest ran from Nov. 21, 2022, through Jan. 20, 2023. Safety Sam will be used by Caltrans Districts for community outreach and engagement efforts. The mascot's image will also be used in materials aiming to inform the public about the importance of the "Move Over" law and work zone safety.

With safety as its top priority, Caltrans is using the Safe System approach to achieve its goal of reducing to zero the number of fatalities and serious injuries on state highways by 2050. This approach builds on its ongoing work to improve safety throughout its network and on all transportation projects the department funds or oversees, which includes "complete street" features that provide safe and accessible options for people walking, biking and taking transit.

**SACRAMENTO, CA (MPG)** - On Wednesday, January 18, the Rural County Representatives of California (RCRC) installed its 2023 Officers and presented its Rural Leadership Awards.

During a meeting of the Board of Directors, California State Assemblymember James Gallagher administered the official Oath of Office for the 2023 RCRC Officers. Butte County Supervisor Doug Teeter was installed as Chair, Monterey County Supervisor Chris Lopez as First Vice Chair, Modoc County Supervisor Geri Byrne as Second Vice Chair, and Inyo County Supervisor Matt Kingsley as Executive Committee Member At-Large. The newly installed 2023 Officers will lead the organization in championing policies on behalf of California's rural counties.

"I am honored to have been selected to lead the Rural County Representatives of California in 2023, and I look forward to working with each of my fellow officers in advancing the rural California perspective at the state and federal levels," said Supervisor Teeter.

In the evening, at their annual reception in Sacramento, RCRC celebrated the new Officers and presented its Rural Leadership Awards to two public officials who have demonstrated an understanding of and distinctive leadership in rural issues and the unique challenges that rural communities face.

Assemblymember Jim Patterson (R- 8th District) was recognized as one of the two recipients of the 2022 Rural Leadership Award, largely because of his role in advancing wildfire risk reduction, community safety, and restoration of Williamson Act funding.

"Assemblymember Patterson authored several bills strongly supported by

RCRC, including RCRC-sponsored AB 1154 which sought to create CEQA exemptions for egress route projects in high wildfire risk areas, and AB 1773, which would have appropriated \$40 million to make Williamson Act subvention payments to counties," said RCRC President and CEO Patrick Blacklock. "His leadership on bills like AB 1078, which would have relieved a tremendous burden for individuals seeking to rebuild homes destroyed in the catastrophic 2020 wildfires, demonstrates great compassion for communities faced with the danger of wildfire, and the aftermath of tragedy."

"I am honored to be recognized by the Rural County Representatives of California for my legislation to address rural issues of concern, including my Assembly Bill 431. This bill extended the sunset date for an exemption for the state's timber harvest plan requirements for projects to create defensible space around structures in high-fire risk areas," said Assemblymember Patterson. "I look forward to working closely with supervisors and RCRC staff as we continue to support California's rural communities."

Angela Avery, Executive Officer of the Sierra Nevada Conservancy (SNC), also received the 2022 Rural Leadership Award. Ms. Avery was recognized for her bold leadership in forest stewardship and conservation. "Ms. Avery's leadership has been crucial in several areas of partnership between RCRC and SNC, including bringing attention to the resurgence of California's tree mortality problem, and providing support for RCRC member counties and their communities after the State's most devastating wildfires," remarked RCRC President and CEO Patrick Blacklock.

"It is a privilege and pleasure to accept this recognition from RCRC,"

# COVID-19 Effects on California Will Linger for Years

Gov. Gavin Newsom says California's COVID-19 state of emergency will end on Feb. 28, just four days shy of three years since he issued the first of countless orders he said were necessary to cope with the pandemic.

"Throughout the pandemic, we've been guided by the science and data — moving quickly and strategically to save lives," Newsom said in October announcing the February end date. "The state of emergency was an effective and necessary tool that we utilized to protect our state, and we wouldn't have gotten to this point without it."

The efficacy of Newsom's pandemic orders will be debated for years, particularly the shutdowns of schools and businesses and the billions of dollars in no-bid contracts his administration issued.

What cannot be debated, however, is that their impacts on millions of Californians will linger for years, decades or perhaps even generations.

Nearly 3 million Californians lost their jobs due to the shutdown orders. While the state has, on paper, recovered all of the jobs it lost, countless small businesses that shut their doors have not reopened.

With work-at-home the growing norm, restaurants and other businesses

dependent on concentrated employment were clobbered. The downtowns of the state's larger cities — including the state capital, Sacramento — were hollowed out and have not, in the main, recovered.

California's stark divide between haves and have-nots grew wider. Upper-income Californians could do their jobs from home but lower-income service workers simply lost their jobs. Some qualified for unemployment insurance, but a managerial meltdown at the state Employment Development Department delayed, sometimes for months, benefits for legitimate claimants while EDD handed out billions of dollars to fraudsters.

School shutdowns, and the fitful efforts to continue instruction via the internet, had a devastating effect on students, especially those from poor families which lacked technology and whose parents could not work from home. The "achievement gap" that has long plagued California's public school system widened even further, recent research has found.

Several new studies add even more evidence that the steps taken by the state to combat COVID-19 will have long-term negative impacts.

An analysis by The Associated Press, Stanford University's Big Local News project and Stanford education professor Thomas Dee determined that 234,000 students in 21 states vanished from public school enrollment rolls during the pandemic. More than half of them were in California.

Overall, in those states, enrollment dropped by about 700,000 students, but

most of the decline could be explained by enrollments in private schools, movements to other states or shifts to at-home instruction. Of the remaining 234,000 absences for which there was no explanation, researchers said, 152,000 were in California.

The Public Policy Institute of California crunched the numbers and discovered that not only did COVID-19 kill about 100,000 Californians but that the state's life expectancy, which had been tied for the nation's highest with Hawaii at 80.9 years, has dropped by two years — the first such decline since World War II.

PPIC found that the higher death rate has disproportionately affected non-white Californians, particularly Latino and Black residents. "Between 2019 and 2021, the death rate (deaths per 1,000 residents) increased 51% among Latinos, 31% among Blacks, 26% among Asian-Americans, and 17% among whites," the PPIC reported.

Finally, a new study UCLA Center for Health Policy Research found that Newsom's stay-at-home orders, affecting businesses, child care centers and school, created financial hardships that led to psychological distress and a sharp increase in turmoil and conflict, including domestic violence.

Some COVID-19 victims are experiencing long COVID, with lasting debilitating effects. California suffers from lingering effects as well.

## More on Annuities

Because of my article a few weeks back on triggered annuities (my term), I received more than the usual amount of emails.

In response, I thought I would lay out some more details about annuities in general.

An annuity is a contract between you and an insurance company. You can obtain annuities through banks, advisors, insurance agents or financial planners, but only insurance companies write the actual policies. The companies are usually multi-billion dollar entities, highly regulated with publically available financial ratings which you can find easily on the web.

The buyer of the annuity pays one lump sum to the insurer or can elect to make regular installment payments over time depending on preference.

The insurer promises to pay you back either in periodic payments or in a lump sum. Annuities can be tax deferred, meaning during the growth period your investment may compound at a greater rate than one subject to yearly taxation.

Basically there are three types that fall into two categories. The three types are:

Fixed, variable, and fixed-indexed (my favorite).

*Fixed annuities* offer a fixed and guaranteed rate of return. Much like a CD or any other type of investment that offers an interest rate back to the customer, fixed annuities do basically the same thing.

*Variable annuities* track an underlying investment such as a stock market or hybrid index and its payments and value can go up or down depending on index performance.

*Fixed-index annuities*, similar to a variable annuity, track an underlying "index" but may provide principal protection in a down market. An opportunity for growth exists when the underlying index performs positively within a measuring period but there is never any downside. The "triggered" annuity I wrote about falls into this category and may offer a guaranteed return no matter what. The two categories of annuities are immediate and deferred.

An immediate annuity starts paying you back as soon as you sign the contract, while the deferred annuity starts the payments sometime in the future.

For a long time, I was not a big fan of annuities and in my opinion, they were sort of the wild west of investing. Many were complicated, fee expensive and convoluted.

However, in recent years, I find many have been simplified, streamlined and constructed in a way that is easily understood and easily explained. And a few are

downright brilliant. My opinion of course.

Annuities are not for all investors but they do have their place, and in many cases help alleviate the stress of up and down markets. As explained above, some offer guaranteed returns and some offer 100% principal protection yet possible stock market participation in up markets without the downside. One could argue the best of both worlds.

Keep in mind, variable annuities DO have downside risk, so make sure you understand the difference between a fixed and variable annuity.

A common complaint about annuities in the past is buyers of annuities lock up their money for the duration of the contract, making it in essence an illiquid investment. This is not entirely true in today's annuity environment as many annuities allow for periodic withdrawals up to a certain percentage of the account without penalty.

In a nutshell, properly selected, and quoting from my favorite types here, certain annuities can guarantee your entire investment thereby eliminating the stress that comes with the ups and downs of today's markets. Simply put, one has the possibility to participate in up markets, yet not take part in the down ones and possibly even earn interest during that time. You can withdraw a portion of your cash if needed, and avoid the bite of the tax man by the deferment quality of the investment.

Annuities don't have to be complicated. In fact, they shouldn't be. If you find one that is, look elsewhere. There are many offerings out there that may meet with your risk tolerance and investment expectations and are easy to understand.

As always, make sure you understand all the ins and outs of any investment you are considering. A capable financial professional should be able to help you navigate the annuity options out there in a way that is simple and easy to understand.

Annuities may not be for everyone, but for some, they might be exactly what the doctor ordered.

It is a good thing to be interested in the community you live in, not just Brownsville, but the entire Yuba Feather area. One of their main projects now is to begin planning the Mountain Fair that will take place this (and every, we hope) summer. Please consider getting involved in our local projects. We all need volunteers.

I have become interested in the large "Welcome to Brownsville" sign on Willow Glen Rd. as you come down into Brownsville Basin. How did it get there? Whose idea was it? I know it was on the property owned by Les and Mable Arnold considerably before 1970 when we arrived here. Rosemarie Mossinger told me that it was a project of Harlan Roy and Herb Killen in 1974. Those people

were involved in starting Yuba Feather Historical Assn. I know that this area was bouncing with energy during the building of Bullard's Bar Dam. Brownsville did not have much in the way of businesses, but Challenge had a great general store, a full service station with gas, tires and more. There was a liquor store and a pool hall. Yuba Feather School was much larger than it is now. The U.S. Forest Service was centered in town. Then the dam was finished in 1970 and the general population changed. I want to know more about the Brownsville sign, though. We helped do some work on it about two years ago and it is always interesting to know the past of a landmark in your area. Lynn Griffin said that Rodney Soja brought in the big rock and Don Clouse (I hope I have the names right) repainted the sign. I will study on that a bit.

**Program to Provide Financial Relief for Organic Dairies**

Skyrocketing production costs, especially for organic feed, have pummeled organic dairies for the past two years, forcing some to sell their cows and leave the business. But California's organic dairies are beginning to see a glimmer of relief. Last month, the U.S. Department of Agriculture offered up to \$100 million in financial aid through a newly created Organic Dairy Marketing Assistance Program. The funds are expected to be released in the late spring or summer. They will target small to medium-sized organic dairies.

**Hard-hit Colusa County Celebrates its AG Heritage at Annual Farm Show**

Farmers in the Sacramento Valley and beyond turned out at the Feb. 7-9 Colusa Farm Show to check out agricultural equipment and technology to boost farming outcomes in future crop years. The event celebrated farming in a hard-hit region. Last year, more than half of California's rice fields, particularly in Colusa County and the Sacramento Valley, were fallowed due to drought. Speaking at the farm show's annual breakfast, California Farm Bureau President Jamie Johansson called for state action on infrastructure to address future water needs.

**Report: San Joaquin Valley Water Supplies Could Shrink by 20%**

Average annual water supplies for the San Joaquin Valley could decline by 20% by 2040, with shortfalls largely driven by mandates of California's 2014 Sustainable Groundwater Management Act. That's according to a new report from the Public Policy Institute of California. The institute's policy brief said America's most bountiful farming region faces a future with less water for irrigation. It said nearly 900,000 acres of farmland could be fallowed and almost 50,000 jobs lost without new water system investments and water trading programs.

**California Table Olive Growers Applaud Continued Duties on Spanish imports**

The U.S. will continue to impose countervailing duties on imports of Spanish ripe olives after it lowered rates of the tariffs to satisfy findings by a World Trade Organization dispute settlement panel. California table olive growers have praised the move. Elizabeth Carranza, director of trade and technical affairs for the Olive Growers Council of California, said she was pleased that the U.S. Trade Representative and the government "decided to continue to uphold these safeguards, which have made a huge impact for the table olive industry in California." ★

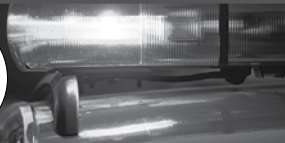

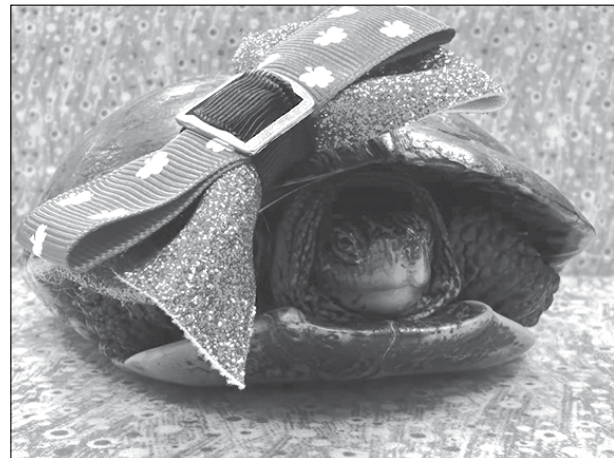

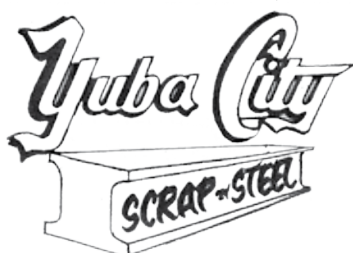

# LaMalfa Votes to Protect Petroleum Reserve and Energy Independence

**WASHINGTON, D.C. (MPG)** - Congressman Doug LaMalfa (R- Richvale) voted in support of H.R. 21, the Strategic Production Response Act, to restore America's depleted Strategic Petroleum Reserves (SPR) and fortify domestic energy independence. Over the last two years the SPR has been depleted to its lowest level in nearly 40 years in an attempt to reduce high energy prices both domestically and overseas, including over one million barrels to a Chinese Communist Party-affiliated company.

"President Biden blocking domestic oil production and relying on

the Strategic Petroleum Reserve is like quitting your job and expecting to live off of your piggy bank. President Biden has shown that he would rather destroy American jobs, allow gas prices to increase to as much as \$7 a gallon, deplete our Strategic Petroleum Reserve by nearly half, and buy oil from OPEC nations than unleash American energy production and lower prices. Our nation has the largest oil reserve in the world, all we have to do is drill for it. It is flat out dangerous and irresponsible to deplete our domestic energy supply so that we depend on adversarial nations in an attempt to also force consumers to switch to costly electric vehicles. This bill will require President Biden to put the wellbeing of American families and workers first," said Congressman LaMalfa. ★

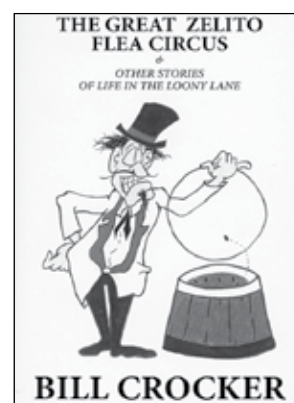
### ROCK PAPER SCISSORS A Tongue in Cheek Parody

The game of rock paper scissors is well known throughout the world in various forms. There are many explanations of the history of this popular hand game. However, none satisfactorily explain how the game originated. After exhaustively researching this important subject, I have uncovered some ancient writings that might tell the story of this game's origin.

Gunar Gunarsen, curator of the King Haakon Magnusson Viking Museum of Hammersvik, Finnmark, Norway, has in his possession a collection of Old Norse poems that include Snussi Stuelalson's stirring account of the training of Viking warriors. and discharged the weapon. King Valkil probably would have hightailed it off the battlefield to fight another day had he been aware of what was about to happen, but the shield that he held in his teeth obstructed his view. Consequently, after the smoke had cleared, it was apparent that the valiant King was now a puddle of goo.

As the years passed, children took up this old way of three-phase fighting as a game after hearing the heroic tales told by their grandfathers. The game passed into disfavor as the Scandinavians turned away from their warring ways and became farmers.

The modern version was created in nineteenth century Italy. As usual, it has been difficult to pin down the actual creator. However, a Neapolitan tailor named Aguzzo Forbici seems to be the top candidate with his method for keeping his many children entertained and out of his receding hair. His version employed glass marbles, scraps of cloth, and scissors. The unintended consequence of a great idea was that the marbles crushed nothing, so the kids started throwing them at each other.

Further unintended consequences were black eyes and scissor cuts. When the kids decided to dump the marbles and substitute Senora Forbici's very expensive, brightly colored Venetian glass beads, Aguzzo had had enough. As so often is the case, invention is born of necessity. Aguzzo modified the game, substituted hand gestures, and created rock paper scissors, a game enjoyed by millions. ★

# What Are 'Red Flag' Laws and How Can They Prevent Gun Violence?

California's red flag law, which allows people to obtain gun violence restraining orders (GVROs), went into effect seven years ago. Since then, GVROs have been credited with deterring at least 58 potential mass shootings and other types of gun violence in California, including suicides. Currently, 19 states and the District of Columbia have red flag laws, also known as extreme risk protection order laws.

But what are they, and how do they work?

"Red flag laws are a tool law enforcement and others can use when somebody is clearly at high risk of doing something with a firearm, but they can't be arrested because no crime has been committed and they don't appear to need a mental health hold or qualify for one," Amy Barnhorst said.

Barnhorst is a psychiatrist at UC Davis Health and an expert on violence prevention. She is vice chair of Community Mental Health and the director of the BulletPoints Project, which teaches clinicians how to prevent firearm violence. She remembers the days before California's red flag law. "When somebody was making threats about hurting people at their school or even threats of suicide, there wasn't much that could be done," Barnhorst said. "Red flag laws have changed that. With the law, there is something that can be done about people who are making threats or have concerning behaviors."

Obtaining a gun violence restraining order

Gun-related deaths remain high in the U.S. The Gun Violence Archive, which tracks firearm violence in the U.S., reports 648 mass shootings, 20,176 homicides, and 24,090 suicides in 2022.

Research has found that in

about 80% of cases, people who commit mass shootings or suicide make their intentions known in advance to family members or friends or via social media. "It's really important that if you are concerned about a student in your school, or you're a concerned parent, teacher, employer, or somebody who's worried about someone, know there is a way to intervene and reduce the risk. But you need to tell someone, such as law enforcement, who can act," Barnhorst said.

"If you're in California, and there is someone you're concerned about who may be at risk of firearm injury, and they have access to guns, you can go

to the Speak for Safety website. It can help walk you through how to pursue a gun violence restraining order," Barnhorst said. The website has different tabs you can select for your relationship to the person at risk, such as employer or co-worker, family or household member, law enforcement or teacher or school employee.

The California Courts website also has information in English and Spanish about how to obtain a GVRO.

"In many cases, law enforcement can get an emergency GVRO on the scene, and they can remove any firearms from the person at risk at that time," Barnhorst said. "If the judge

determines that the person is at risk, the judge can continue the prohibition. The guns will continue to be kept away for the duration of the order, which can be renewed after a year or longer in some cases."

Barnhorst explains there is due process during all stages of the legal procedures. "People who have had their firearms removed can appear in court to give their side. If the judge determines they are not a danger, the prohibition can be lifted, and the firearms returned," Barnhorst said. She notes GVROs are civil court actions. They don't involve the criminal courts, and they don't become part of a person's criminal record.

Most people don't know about GVROs

Despite the potential to reduce mass shootings and suicides, the use of GVROs in California has been limited. One of the biggest barriers appears to be the lack of awareness about them. A recent survey found that nearly two-thirds of the respondents did not know about GVROs, although 70% said they would consider using one in a high-risk situation.

"The GVRO law empowers people to play a role in preventing firearm violence among friends, family members, co-workers and classmates by providing a tool to remove firearms from crisis situations," said Veronica Pear, an assistant professor at the Violence Prevention Research Program at UC Davis. Pear studies violence prevention and has published numerous studies about the efficacy of red flag laws. "However, the law can only save lives if it is used, and for that reason, education is key," Pear said.

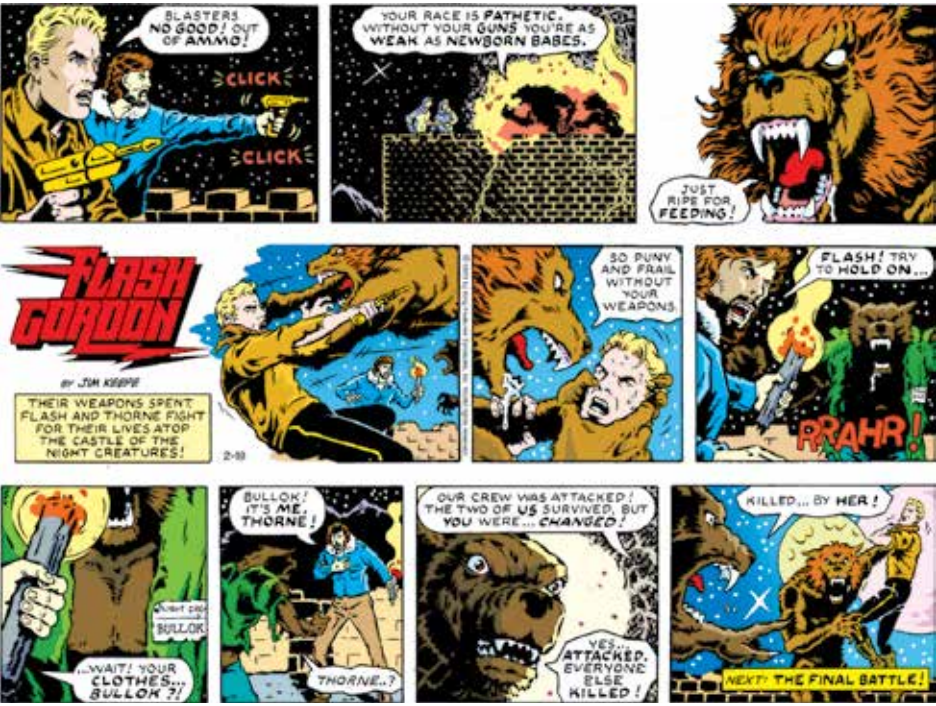
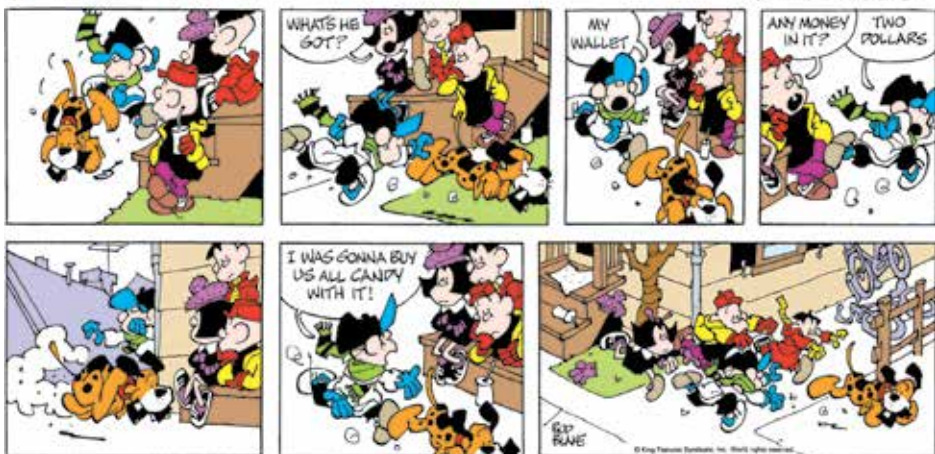
