MARYSVILLE, CA (MPG) - During the Yuba-Sutter Veterans Stand Down board meeting last Thursday, January 12, 2023, representatives of the Yuba River Endowment presented the volunteers with a donation of \$10,000 to cover 1 year's rent for the organization's Marysville office.

The Yuba River Endowment is a non-profit organization created by Yuba County farmers. Since formation in late 2019, the Endowment has donated over \$450,000 to local

organizations, including the Yuba-Sutter Food Bank, the Yuba-Sutter Fair's Jr. Livestock Auction and all Yuba County FFA groups.

"Due to COVID restrictions, most of our fundraising events have been cancelled for three years now, but the needs of veterans in our local area have only grown," said Stand Down President, Mike Nichols. "The Endowment's funding will give us the financial security we need to get through this year."

The Yuba-Sutter Veterans Stand Down provides a myriad of services to veterans and veteran's spouses

and dependents, including assistance with medical transportation, rehabilitation, housing, meals, shelter, burial costs, counseling services, connecting vets to State and Federal service programs. They hold an annual multi-day Stand Down event bringing all these services to one location to serve hundreds of vets at one time. The 2022 Stand Down was held at the Yuba-Sutter Fairgrounds and served over 650 veterans.

The Yuba River Endowment was established by a group of Yuba County farmers and their Irrigation

CalVCB Offers Resources, for Human Trafficking Victims

SACRAMENTO, CA (MPG) - The California Victim Compensation Board (CalVCB) is promoting national Human Trafficking Prevention Month with a social media campaign and reminders about the support available for survivors.

Three years ago, CalVCB began authorizing income loss compensation for victims of sex and labor trafficking as a result of Assembly Bill 629, which took effect on Jan. 1, 2020. In that time, CalVCB has approved 590 human trafficking claims and paid victims \$4,445,861 in lost wages.

"Sex and labor trafficking victims face many challenges as they try to rebuild their lives," said CalVCB Executive Office Lynda Gledhill. "CalVCB can help by compensating for lost income or other expenses, such as mental health counseling, caused by the trauma of being trafficked."

To help bring awareness to the problem and make victims aware of the support and resources available, CalVCB launched a social media campaign and created a media toolkit for others to use.

Human trafficking is the practice of enslaving people for labor, sexual activity, or commercial sexual exploitation. Human trafficking can occur within a country or trans-nationally and does not necessarily involve the movement of the victim from one place to another.

Human trafficking is considered the world's third-largest criminal enterprise, after drug dealing and arms trafficking. An estimated 12.8 percent of all human trafficking cases in the United States in 2021 came from California, according to the National Human Trafficking Hotline.

In an effort to bring attention to this national and global problem, in 2007 the U.S. Senate designated January 11 as a National Day of Human Trafficking Awareness. In 2010, President Barack Obama proclaimed January as National Slavery and Human Trafficking Prevention Month.

In addition to income loss compensation, which covers up to \$20,000 for a two-year period, CalVCB can reimburse survivors for other expenses caused by human trafficking, including medical, dental, and mental health treatment, home security and relocation.

Over the years, Taber has had her ups and downs, at one point selling all her equipment and swearing off photography. In 2013 she relocated to Gridley, and it was another love in her life, Paul Deniz, that

reinvigorated her passion for photography. Believing in her talents, Deniz set up and dedicated an area for Taber to use as a studio. With his support, she took up her art again and since then, has not looked back.

Taber maintains her studio headquarters in Downtown Gridley in the Historic Hazel Hotel building. She says she waited 5 years for the space and that “landing the building was one of the happiest days of my life!” Taber has made “magic” in her studio there and believes it’s assisted her growth and status as a highly sought-after maternity, newborn, and child photographer.

Although she has 3 other studios located in San Francisco, Los Angeles, and Orange County, she plans to keep her Gridley Studio open regardless of her status. “Paul and the members of this community played a huge part in my success. I will never leave my local small-town clients who supported me.” She continues, “I am so blessed, humbled, and thankful for them.” But adding easily accessible locations across the state was key to expanding her business.

And how it has expanded. She would have the opportunity to shoot her first celebrity client, John Lovitz, in 2010. Since then, the celebrity list has grown to include Ms. Nations of States 2022 Jessica Vangaalen, Danijela Milisic the fiancé of A’Shawn Robinson from the LA Rams, and more A-listers that would rather remain nameless.

Taber says she treats all her clients the same, regardless of status. “My #1 focus in my career is empowering women.” Taber says. “Most women come into my studio so nervous and shy, but they always leave comfortable, with a new glow, trust, and confidence. That’s how I know I’ve done my job right!”

The artist provides an extensive wardrobe for her maternity clients, including gowns and flowing fabrics. For newborn, baby, and children’s sessions, she has on hand multiple props and backdrops to choose from. She can and loves to make any client’s vision come to life.

Taber employs a small team of trusted booking receptionists, makeup artist Azael Guzman who is indispensable to her team, hair stylists, a creative team for help with sets, a studio organization team and at times, a production assistant (PA) and actors. To assist creating gorgeous visions of pregnant women, newborns, and young children, she often uses her PA to pre-screen any issues potentially affecting the photo’s quality

via computer before shooting and adjustments are made on set. Taber is hands on, taking charge during her sessions. Afterwards, she likes to allow her clients to see captured images unedited before she makes her personal edits. “I have a specific editing style and I have to stay consistent, so my clients know exactly what they’re getting.”

Over her career Taber has elevated her art, achieving goals she had never thought attainable.

Her work has drawn acclaim throughout her career. Just 3 years into her career, Taber won Yuba-Sutter’s Favorite photographer and again in 2020. In 2017 she won “Best of Biggs” photographer in 2017 and she currently holds the title of “Best of Yuba Sutter” photographer for 2021 and 2022.

Taber has been featured in multiple publications, including LA Wire, The New York Weekly (Jim Kwik and Kobe Bryant editions), CEO Weekly, Parent Magazine, Influencer Daily and more. She has recently been invited to be the main photographer at the Prego Expo hosted by the Magic Box in LA. In addition, Taber shares she’s in negotiations with a worldwide backdrop company who wants to use her designs and is working out a deal with Anne Geddes PR team that would provide a workshop in her studio with the renowned baby photographer who inspired Taber’s work.

When asked what that means to her, Taber tells the Herald, it’s priceless. “Mastering and conquering my childhood dream means absolutely everything to me.” She offers encouragement to those who question their destiny, “No matter the setbacks, the fear, or the discouragement – Do it! Chase your dreams!”

As for her craft, Taber says, “My hard work has

paid off and I have made my way to higher ground. Yet, I will continue to climb and hopefully reach new heights I’ve never imagined.”

How We Can Prepare for Future Floods before a Megastorm Hits

Californians have suddenly turned their attention from drought to flooding. The future likelihood of a series of huge atmospheric rivers in California, a so-called Ark storm scenario, seems to be a certainty. Atmospheric rivers channel moist tropical air towards the West Coast, where mountains condense it to rain and snow. Over the last few weeks, California has suffered through a sneak peak of its devastating potential. In late December of 1861, weeks of snow and rain from a huge Ark storm caused flooding from Oregon and Idaho to Mexico. The new settlers did not listen to the Indigenous peoples of California who knew that winter meant moving away from the river. State government had to be temporarily relocated from Sacramento to San Francisco. The California Supreme Court made the move permanently. The Central Valley became an inland sea, and flooding was severe in Southern California. One percent of the state's population died. These megastorms occur about once every 150 years. Climate change will intensify them. Flood control reservoirs already line the Sierra Nevada foothills, including Shasta, Oroville, Folsom, New Melones and others. Some reservoir space is emptied each fall to make way for potential oncoming floods, reducing the value of the reservoir for hydroelectric generation, water supply, recreation and cold water storage for fish. Reservoir operators can minimize (but not eliminate) dumping valuable water if no major

storm is predicted. But Sierra Nevada and similar Southern California flood control reservoirs like Prado and Seven Oaks cannot store enough floodwater to sufficiently reduce the effects of atmospheric river megastorms. The reservoirs will fill, but continuous flood flows will pass through as if the reservoirs were not there. Gigantic new flood control reservoirs could theoretically be built. But the costs would be in the tens of billions of dollars, and the reservoirs would serve little purpose for decades since they would have to be emptied at the start of each flood season. It's unlikely that the Legislature or Congress would invest in such a flood control system. Indeed, at least \$3 billion in levees and floodwater bypasses are needed just to prevent major flood damage in the Central Valley from storms that are expected to occur much more often than megastorms. Can flood waters be diverted into "off-stream" storage reservoirs for later use? Not really. The proposed giant Sites Reservoir could divert only a small percentage of the water expected in the Sacramento River in even moderate flood events. The value of such reservoirs is largely in their water supply benefits. Still, much can be done to prepare. First, California needs to increase investment in flood plain acquisition and expansion, and prevent the urbanization of flood-prone areas. Staying out of harm's way is the best idea. Flood water bypasses help protect the Sacramento Valley and can recharge

groundwater. The San Joaquin Valley urgently needs a similar system. It's likely too late to build them in highly urbanized parts of Southern California. Second, property owners who are at risk only from a megaflood should be encouraged to purchase flood insurance. For property outside the "100 year" flood zone, it would be a small annual investment to cover the damage that is bound to occur. Third, locally managed evacuation drills should be held in areas where the flood risk is highest, such as Sacramento and areas near the Los Angeles and Santa Ana Rivers. A megastorm will require evacuation of millions of people in the Central Valley and parts of the Bay Area and Southern California. The public needs to be prepared. Californians have spent billions of dollars to prepare for earthquakes and catastrophic wildfires. Recent quakes and fires are often on our mind, and leaders are reacting appropriately. But Californians have largely forgotten the death tolls and huge property losses of previous deadly floods, and even larger floods are likely to come. They will affect all Californians, and require greater investment in flood preparation, insurance and evacuation planning. *Gerald Meral is the director of the California Water Program at the Natural Heritage Institute. Lawsuit Filed for Gender Transitioning a Child behind her Mother's Back

CHICO, CA (MPG) - On Friday, January 6, 2023, the Center for American Liberty filed suit against the superintendent and individual school board members of the Chico Unified School District on behalf of Aurora Regino. Aurora's daughter, also known as A.S., was eleven years old when her public school transitioned her to a male identity behind her mother's back. In the fall of 2021, when she was a few months into fifth grade, A.S. began feeling depressed and anxious. A.S. took her school counselor's advice and began to think these feelings were caused by her being born a different gender. The school counselor invited A.S. to an arts-and-crafts club (the "Girls Group") with other girls in her school and after a few meetings, A.S. "came out" to her counselor as transgender. Instead of exploring what the cause of the anxiety and depression might be, the school counselor focused on one thing only: how to transition A.S. to a male identity. The school counselor and teachers at the school called A.S. by a male name, male pronouns and essentially treated her as if she were a different person all without her mother's knowledge. This went on for a couple of months before Aurora found out. Aurora sought help from a licensed family therapist and immediately sought answers from the school district about how it could transition her daughter behind her back. "If the school system thinks this is the law, then someone needs to stand up for our children and let them know how wrong and damaging it is," Aurora Regino said. "Our rights as parents do not stop as soon as we drop our children off at school." "The District's policy of transitioning

kids behind their parents' backs is radical gender-ideology at its worst," Harmeet Dhillon, Founder of The Center for American Liberty, said. "For the government to assume this role is both unconstitutional and reprehensible." The district claims it is required by state law to keep parents in the dark when their child is transitioning to a different gender in school. Therefore, the school has refused to abandon the policy. Fortunately, A.S. has returned to identifying as a girl but Aurora has no assurances that what happened to her daughter last year won't happen again. "In the Chico Unified School District, children as young as five years old can transition to a different gender in secret from their parents," Josh Dixon, Director of Litigation for The Center for American Liberty, said. "This act of 'social transitioning' is powerful psychological treatment that often leads to much more permeant procedures like puberty blockers and even surgery." The lawsuit argues that the district's secrecy policy violates parents' fundamental rights protected by the due process clause of the Fourteenth Amendment to the United States Constitution. The Center for American Liberty is seeking declaratory relief and an injunction that would prohibit the Chico Unified School District from continuing to implement the Parental Secrecy Policy. The Center for American Liberty is a non-profit litigation, education, and public policy organization dedicated to advancing Free Speech rights and Civil Liberties. Founded by Harmeet K. Dhillon in 2019, the Center for American Liberty offers pro-bono and low-bono legal representation to Americans whose fundamental freedoms are violated. ★

Districts who have a right to water that flows on the Yuba River. In a truly win-win situation, the farmers' water is used to provide the required flow levels to protect endangered fish on the Yuba River, then once past this critical point, the water can be transferred to drought-stricken areas of the state. Proceeds from these transfers provide the funding for the Yuba River Endowment, allow these farmers to expand their agricultural operations and create jobs in Yuba County. Through generations of conservation, cooperation, infrastructure investment and groundwater

recharge, Yuba County is a model for water management in California. The Endowment was created to give back to the community and provide organizational and educational grants. "Our motto for the Endowment is 'Local Farmers Giving Back'," said local farmer and Yuba River Endowment board member, Mike Filice. "Our board is made up of representatives from eight different Yuba County regions, from Browns Valley to Wheatland. It's an honor to be able to help our local veterans with this donation to the Stand Down. Without their sacrifice and service, we would not have the freedoms we enjoy today." ★

CHP Highlights New Laws in 2023

SACRAMENTO, CA (MPG) - As we head into the new year, the California Highway Patrol (CHP) is educating the public on traffic safety laws that were passed during this year's legislative season and signed by Governor Gavin Newsom. The laws take effect January 1, 2023, unless otherwise noted.

Public Employment: Peace Officers: Citizenship (Senate Bill (SB) 960, Skinner)

The law maintains that peace officers, including peace officer trainees, be legally authorized to work in the United States consistent with federal law and regulations, however, removes the requirement that they be citizens or permanent residents of the United States.

Catalytic Converters (SB 1087, Gonzalez) (Assembly Bill (AB) 1740, Muratsuchi)

These laws specifically list who can sell catalytic converters to recyclers and require those recyclers to keep documentation such as the year, make, model, and copy of the vehicle title from which the catalytic converter was removed. The purpose of these laws is to help reduce catalytic converter theft.

Vehicular Manslaughter: Speeding and Reckless Driving (SB 1472, Stern)

This law expands the criteria for "gross negligence" as it relates to the crime of vehicular manslaughter. Drivers involved in sideshow activity, exhibition of speed, or speeding over 100 miles per hour which results in a fatality could now be charged with Vehicular Manslaughter with Gross Negligence.

Online Marketplaces: Reporting (AB 1700, Maienschein)

This law requires the Attorney General's Office to create an online reporting system for users of third-party online marketplaces to report listings of suspected stolen items. The reported information would be available to local law enforcement and the CHP's Organized Retail Crime Task Force to assist with investigations.

Bicycles Omnibus Bill AB 1909, Friedman)

Much like the move over or slow down law, this law provides for increased protections to bicyclists by requiring vehicles passing or overtaking a bicycle in the same direction, to move over to an adjacent lane of traffic, if one is available, or slow down and only pass the bicyclist when safe to do so. The law also permits Class 3 e-bike riders to use approved bicycle paths and trails, bikeways, and bicycle lanes. The law prohibits local governments from requiring bicycle registration and allows local authorities to prohibit any electric bicycle on an equestrian, hiking, or other recreational trail.

Electric Bicycles: Safety and Training Program (AB 1946, Boerner Horvath)

This requires the CHP to work with other traffic safety stakeholders such as the California Office of Traffic Safety, to develop statewide safety and training programs for electric bicycles. This training program, which will consist of electric bicycle riding safety, emergency maneuver skills, rules of the road and laws pertaining to electric bicycles, will launch on the CHP's website in September 2023.

Pedestrians (AB 2147, Ting)

This law prohibits peace officers from stopping pedestrians for certain pedestrian-specific violations, such as crossing the road outside of a crosswalk, unless there is an immediate danger of a crash. The CHP reminds all road users of the responsibility to travel safely and look out for one another on the road. The mission of the CHP is to provide the highest level of Safety, Service, and Security. ★

Has the Ukraine War Been Worth It?

By the time this column is read, Congress and the White House will have sunk nearly \$100 billion of tax money down an endless Ukrainian rathole. That figure is an enormous sum of money, roughly equal to what it cost to run the entire federal government when John F. Kennedy was President. In fact, it seems as if Senile Joe Biden believes there should be an endless spigot of American money flowing to the corrupt regime in Kiev while he gleefully shuts off the spigots of cheap energy to the American people.

This war in Ukraine was unnecessary from the beginning and could have been ended months ago. Various proposals were advanced from numerous parties which could have led to a negotiated settlement between Putin and Zelensky, yet the U.S. State Department would have none of it. Think of the tens of thousands of lives that could have been saved, the physical destruction to a country avoided, and the devastating global impact (especially to Western Europe) of energy and food shortages that could have been prevented had the globalists simply sought a just peace.

Instead, the New World Order crowd in Washington and London was determined from the outset to allow this conflict to bring the planet to the edge of nuclear war. The sheer insanity of Biden depleting America's own military stockpiles to bolster an authoritarian dictator on the other side of the world is virtually treasonous. America has no treaty with Ukraine. Ukraine is not a member of NATO and the Zelensky regime is neither democratic nor free. Little different from Vladimir Putin, the tee-shirted president of Ukraine shuts down his political opposition, censors the press, and persecutes ethnic Russians in the eastern territories. The cross-dressing Zelensky demands America write him a blank check (regardless of whether it leads to World War III), hobnobs with military contractors, and declares his allegiance to the woke-LGBTQ agenda of the New World Order. He has permitted his nation to become the playground and playpen of the global elites, a money-laundering operation and cash cow for the likes of the Clintons, Bidens, and Pelosis. He himself has ripped off millions from his own people and sent them to his Swiss bank accounts.

The constant media drumbeat for Zelensky and disinformation about Ukraine "winning the war" against Russia is laughable. It is beyond ridiculous to believe a poor, economically struggling former state of the old Soviet Union could defeat Moscow and its vast arsenal of deadly, civilization-annihilating nuclear weapons, some more sophisticated than anything the United States possesses. What has happened is the non-ending flow of American money and weapons to Kiev has just dragged out and prolonged a war that could have been settled in weeks with a pledge by Zelensky not to join NATO and his agreement to allow the Russian-populated eastern regions to unite peacefully with Moscow. Putin wants a

"buffer zone" to protect his country from the advances of NATO, a military alliance which should have been dissolved thirty years ago when the Cold War ended and the Red Army went home.

Biden, a decrepit and demented puppet of the Deep State and the military-industrial-banking complex, has vowed to keep the war going in Ukraine for "as long as it takes." This means more deaths, more destruction, and more despair for Western Europe facing a brutally cold winter without food or energy. Say it ain't so, Senile Joe! Of course, this war could not continue if the United States did not persist in funding it and enriching the defense contractors eagerly salivating for the new multi-billion-dollar Pentagon contracts required to restock all the military hardware we have shipped to Zelensky.

The peoples of Germany, France, the UK and Italy can only pray for an end to this war and the useless sanctions against Russia which have cut off their energy and fertilizer while subsidizing Putin's ability to wage war by boosting the price of oil. Sanctions – as usual – don't work and end up hurting the very people they are supposed to help. Now, Germans are cutting down the forests in order to obtain firewood necessary to survive the coming winter freeze. Stores are cutting back hours, companies and plants are closing, gas rationing is looming, and Western Europeans are preparing for more frequent blackouts and brownouts in the coming months. The cutoff of natural gas to Europe could easily lead to the rapid de-industrialization of those nations. Is propping up a kleptocracy in Kiev worth that?

Had a hard-nosed negotiator like a Nixon, Reagan, or Trump been in the Oval Office, this war would have never occurred, or it would have ended in a settlement. Nixon brought about peace agreements with the Soviet Union and in the Middle East. Reagan brought down the Soviet Empire without firing a shot and Trump was the first president in decades not to involve the United States in a new war while getting us extricated from the Bush-Clinton wars and negotiating the Abraham accords in the Middle East.

The Democrats, of course, have always been the party of war. A Democrat, Woodrow Wilson got America into World War I. A Democrat, Franklin D. Roosevelt got us into World War II. A Democrat, Harry Truman, got us into Korea and two Democrats – Kennedy and Johnson – got us into Vietnam. A Democrat, Bill Clinton, invaded Haiti and bombed Serbia for 78 days and his foreign policy became known as "drive-by shootings with cruise missiles." It is true that the Bushes – ostensibly Republicans—got us into thirty years of wars in the Middle East but those RINOs were the exceptions that prove the rule.

Vladimir Putin, whatever his flaws and sins, is a patient man. He has permitted the West to break all its agreements with Russia and encircle his nation with missiles, military bases, and client states, but he has not yet reached for the nuclear button. The question now is how long will his patience hold out? ★

States Must Do Better Protecting Unborn Life

ORLANDO, FL (MPG) - Now that the U.S. Supreme Court has overruled the Roe v. Wade and Planned Parenthood v. Casey abortion decisions, several states had ballot measures involving abortion. Three states added abortion provisions to their state Constitutions. Two states voted down measures that would restrict abortion.

California voters approved Proposition 1, introduced by Gov. Gavin Newsom, which explicitly protects abortion and contraceptive rights in the state Constitution.

Michigan voters also passed a ballot initiative to fortify abortion rights. Proposal 3 affirms a woman's right to make decisions "about all matters relating to pregnancy," including contraception, fertility, abortion and childbirth.

Vermont's Proposal 5 overwhelmingly passed and creates a constitutional right to "personal reproductive autonomy."

Regarding states attempting to protect unborn life, Kentucky's Amendment 2 was defeated which would have amended the state Constitution to explicitly state it doesn't "secure or protect a right to abortion or require the funding of abortion."

In addition, voters in Montana voted against Legislative Referendum 131 which would expand rights for infants who are "born

alive" after failed abortions, and allow health-care workers to face punishments if they don't give them proper medical treatment.

Liberty Counsel has filed amicus briefs at the state Supreme Courts in Indiana, South Carolina, Kentucky and Oklahoma on behalf of the National Hispanic Christian Leadership Conference (NHCLC) and the Frederick Douglass Foundation to uphold there is no right to abortion within the states' Constitutions and defend pro-life laws that limit the killing of innocent unborn children.

The NHCLC and Frederick Douglass Foundation represent millions of African Americans and Hispanics. These minority communities have been the direct target of abortion, and most Planned Parenthood's abortion clinics are in black and Hispanic neighborhoods. Liberty Counsel also filed an amicus brief on behalf of the NHCLC and the Frederick Douglass Foundation at the U.S. Supreme Court in the Dobbs abortion case. In overturning Roe v. Wade and Planned Parenthood v. Casey, the High Court cited to this brief acknowledging that abortion has disproportionately impacted the black community.

Liberty Counsel's Founder and Chairman Mat Staver said, "It is shameful that any state would vote to kill innocent unborn children in the womb. We must do better and make the womb a safe place – once again." ★

Californians’ Patience on Homelessness Wears Thin

Last week, a viral video showed the owner of a San Francisco art gallery using a water hose to spray a homeless woman camped outside the doorway of his business.

The gallery owner, Collier Gwin, semi-apologized later, telling a television interviewer, “I totally understand what an awful thing that is to do, but I also understand what an awful thing it is to leave her on the streets.”

Gwin said he and other business owners complained to police about her blocking the sidewalks and business entrances. Efforts had been made to help her get off the streets, but nothing has worked.

“We called the police. There must be at least 25 calls to police,” Gwin said. “It’s two days in a homeless shelter, it’s two days in jail, and then they drop them right back on the street.”

Finally, after the woman once again refused to move, in frustration Gwin sprayed her down.

Gwin obviously did the wrong thing, but the incident dramatized the frustration that millions of Californians feel about the squalid encampments of homeless people that have become the defining feature of urban California.

Gov. Gavin Newsom acknowledged the growing resentment as he introduced his new state budget last week. “People have just had it,” he told reporters. “They want the encampments cleaned up.”

“People are dying on the streets all across this state,” Newsom said. “The encampments, we’ve got to clean them up, we’ve got to take ownership, we’ve got to take responsibility.”

In the last two state budgets, Newsom and the Legislature have committed \$17.5 billion for housing and services to the estimated 170,000 homeless Californians – about \$100,000 each. However, as Newsom’s new budget acknowledges, “Despite unprecedented resources from the state and record numbers of people being served by the homelessness response system, the population of unhoused individuals grows faster than the population exiting homelessness.”

The new budget adds several more billion dollars, but suggests that local governments are still not doing enough – a theme that Newsom has pursued in recent months.

Last year, he rejected all of the plans that local governments had submitted, saying they fell well short of actually making real progress on reducing the upward trend. After a showdown meeting with local officials, he agreed to release more state aid.

“The first iteration of these plans made clear that more ambition is required – and more direction from the state is necessary,” the budget declares.

“Accordingly, the administration plans to work with the Legislature this year to advance homeless accountability legislation.”

The budget suggests that cities failing to meet their state quotas for zoning land for new housing might lose state financing for homelessness programs.

“If we can’t clean up the encampments and address what’s happening chronically on our streets, I’m going to be hard-pressed to make a case to the Legislature to provide them one dollar more,” Newsom told reporters.

That threat doesn’t sit well with local government officials. The League of California Cities issued a sharp reaction, saying, “one-time investments will not solve the crisis” and adding, “We need ongoing state funding and a coordinated approach with clearly defined roles and responsibilities for all levels of government that supports long-term solutions.”

The exchanges suggest there is still no consensus on what combination of actions would have a visible impact and all of the politicians involved are engaged in some blame-shifting as the voting public’s patience with the squalor wears thin.

Newsom knows that if the crisis is not resolved, it will leave an indelible mark on his governorship and haunt whatever future political career moves he might make.

Low Net Savings Investor Strategies

I often get approached by investors who have \$10,000, 20,000 or 30,000 in total and ask if they should invest in stocks.

Since the majority of Americans don’t have hundreds of thousands of dollars at their disposal, the question becomes a reoccurring one. Each recommendation depends on the specifics of the individual such as their age, the income level, dependents, and expectations to name but a few.

Generally speaking, if the investor is young, they might consider investing a certain amount on a regular basis in order to establish a sound and long term retirement plan. It doesn’t have to be a lot. Indeed, adopting a crippling commitment amount that one cannot continue for whatever the reason is a sure way to derail an otherwise intelligent endeavor.

It is better to start with smaller amounts that is doable no matter what may lay ahead.

Since the young “investor” is new to the world of money, I first issue warnings covering beginning investing mistakes which are so common with new or young investors. I won’t cover them here but there are many (email me for previous article).

Since the young investor has plenty of time to build wealth, I am of the opinion they don’t need an investment advisor (nor their fees) and instead open up a discount brokerage account and buy a well-known and low cost index fund and then add to it on a monthly or quarterly basis. The Vanguard family of funds comes to mind but there are many other fine funds. Generally speaking, the larger the funds envelope of asset allocation or geographical localities, the less volatile it might be.

The reoccurring deposit into the account establishes not only a good habit one takes into adulthood, the compounding of even a small reoccurring amount can grow to a significant amount given enough time.

For older investors that might not have an extremely large nest egg, I remind them what they have is ALL they have, and it’s that amount that keeps them from the line at the local food bank. That means not losing it.

And that may mean placing their nest egg in a principal guaranteed investment. Today that could include a savings account, CD’s or a portfolio of U.S. Treasuries, all of which are 100% principal protected by the U.S. government.

Although for the past few decades they offered only a paltry return, these products are now paying a comparatively healthy return. Today, a properly constructed US treasury portfolio might offer an investor annual yields north of 4%.

A triggered annuity might also be

another option. Although annuities are not FDIC insured, they can be 100% principal protected by the underlying insurance company. Triggered annuities may offer guaranteed interest rates and possible participation in market rallies yet may avoid any downside.

Even though someone may have a modest investment amount, they may still wish to take some risk in the hopes of growing their nest egg.

If that’s the case, consider more well-known and widely popular growth stocks that have a proven track record and real profits instead of investing in wild startups with lots of promises yet no profits. Going for the gusto might work out in their beer selection but rarely pans out for the inexperienced investor when it comes to stock selection.

On the flip side, I see the most damage done by investing in what I call “privates”. These offerings are not available through a broker but brought to the investor by an advertisement, relative or friend of a friend. Some are story lines about this or that idea or invention that sounds great pushed by some enthusiastic entrepreneur or glitzy advertisement. Other clickbait investments might be seeking money for some property, businesses or startups.

They are great stories for sure but from my experience, instead of big opportunities, they turn out to be big holes where money disappears along with the person that’s at the bottom of the hole with their mouth open.

Great visual, I know.

Summing this up is to say don’t buy anything that’s not listed in the Wall Street Journal, which is to say whose existence is not widely known and not publically listed.

There are worthwhile and profitable investment opportunities privately available for sure, but I see too many dismal failures that swallow up people’s money to recommend a private to the average investor.

Avoiding some of the common pitfalls suffered by investing newbies and then considering some of the suggestions made here might go a long way in helping you reach your investment goals no matter what your nest egg.

Storms, snowpack spur optimism for ample water supply for farmers

A year ago, California’s first snowpack survey of the year revealed deep snow measuring 160% of average. Then came the driest January, February and March in more than 100 years. This year the snowpack measured 174% of average on Jan. 3—and ensuing storms dumped another 10 feet of snow in parts of the Sierra Nevada. At last, that may presage a healthy water year for agriculture. A state climatologist says the string of atmospheric storms signals that California may be moving from a dry La Niña pattern to a wet El Niño phenomenon.

Agricultural groups say ‘Waters of U.S.’ law creates confusion, burdens farmers

Farm groups say they fear the Environmental Protection Agency’s new “Waters of the United States” rule will create confusion and cause disruptions to routine agricultural activities. The rule expands the federal government’s reach, allowing regulation of most any low spot on a farmer’s field where water stands or channels. Critics say that may expose farmers to unknowing violations of the law and require permits for ordinary activities such as plowing, planting or fence building. Agricultural groups say the law could result in costly legal fees for farmers.

Farmers, ranchers challenged by rule banning older trucks

Large trucks and buses made before 2010 are now prohibited from operating in California, under a California Air Resources Board rule that took effect Jan. 1. Until this year, an agricultural exemption had allowed pre-2010 big rigs to run up to 10,000 miles a year. Now farmers and ranchers with non-compliant vehicles must abide by a 1,000-mile limit. The market is already saturated with older vehicles retaining little value, and many business owners face steep financial costs to replace them.

Researchers hail new rice-breeding effort as a breakthrough

An international team, including researchers at the University of California, Davis, has successfully propagated a commercial hybrid rice strain as a clone through seeds—with 95% efficiency. According to researchers’ conclusions published in Nature Communications, the development may help lower the costs of hybrid rice seed, allowing rice farmers worldwide to obtain access to high-yielding, disease-resistant strains. Historically, rice has been costly to breed as a hybrid, with previous yield improvements of only about 10%. ★

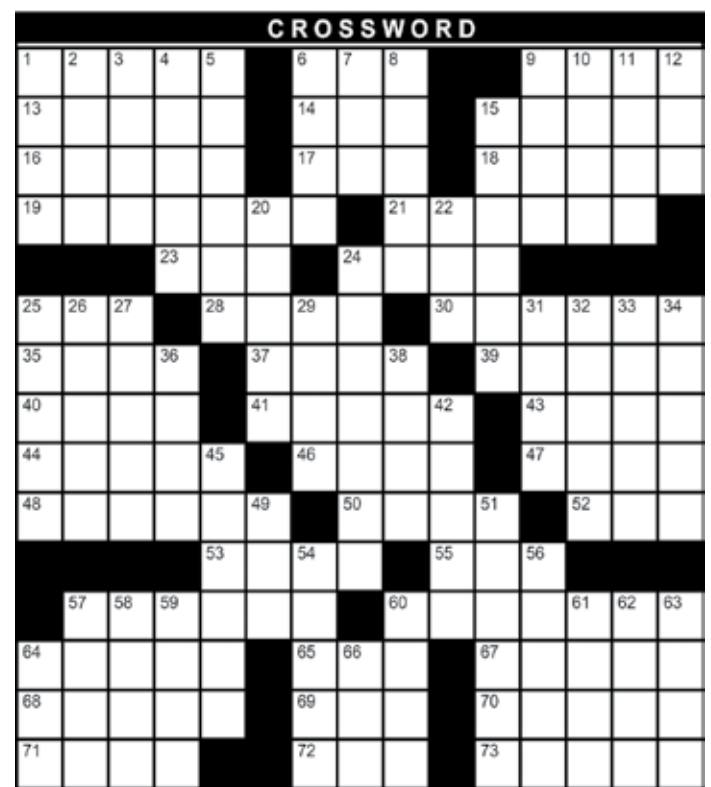

State Budget Must Get Back to Basics

SACRAMENTO, CA (MPG) - On Tuesday January 10, 2023, the Governor unveiled his \$297 billion budget proposal. Vice Chair of the Assembly Budget Committee Vince Fong (R-Central Valley) issued the following statement:

“Californians are demanding real results, not more political headlines.

“Californians continue to persevere as they face a weakening economy, inflation, and an affordability crisis, rising costs of energy, and now the consequences of a lack of needed water infrastructure investments. When Mother Nature blesses

us with rain, we need to save the water, instead of dumping it out to the ocean.

“Families are rightfully frustrated as they are tired of paying more and getting less.

“The Governor’s rhetoric does not match reality. Facing a \$22 billion deficit, Governor Newsom’s budget continues his misguided habit to overspend with little accountability. Newsom’s budget again fails to adequately build water storage and conveyance infrastructure to store water and move it across the state. And this budget framework perpetuates ill-conceived energy policies that will stifle needed affordable and reliable energy supplies when Californians are demanding relief.”★

Republicans Call on Newsom to Make Water a Priority

Assembly Republicans Press Release

SACRAMENTO, CA (MPG) - California Assembly Republicans are calling on Governor Gavin Newsom to prioritize water storage, conveyance, and flood protection in the state budget. California has not built significant new water storage since the 1970s, despite its population nearly doubling during that time.

“Providing water is a core function of government, and it’s time to make that a priority,” said Assembly Republican Leader James Gallagher (Yuba City). “We need Sites Reservoir, policy reforms and better water management so our residents and farmers don’t face even more water rationing during the next dry spell.”

“We need more water storage in California,” said Assemblymember Juan Alanis (R-Modesto). “That’s why on my first day in the legislature I proposed Assembly Constitutional Amendment 2 to put water storage goals into California’s Constitution and provide guaranteed funding for water infrastructure. It will bring California better flood control and more relief during periods of drought. It’s just common sense to get this done.”

“Conservation alone is not going to solve this crisis. Storage alone is not going

to solve this crisis,” said Assemblyman Heath Flora (R-Ripon). “We need an all-of-the-above approach to water: desalination, storage, conservation. Those are all part of the solution and something that we are all very, very committed to.”

“The Governor announced this week that he is protecting the state’s budget reserves. I implore the Governor to protect our State’s greatest natural resource, water, and move forward aggressively to build the reservoirs that the voters approved nearly ten years ago in 2014,” said Assemblymember Diane. Dixon (R-Newport Beach). “This water reserve will protect our state against future droughts, which are certain to occur again - just as the floods will return as well. This is not rocket science, save our water that falls free on a rainy day!”

Decades of neglect and underfunding have allowed the state’s infrastructure to crumble, resulting in difficulty transporting water across the state and causing the levee failures that have flooded communities in recent days.

The Assembly Republicans are urging Governor Newsom to prioritize these investments in the state budget to address current and future water challenges and protect the economic and social well-being of California. ★

Proposed Budget is Not Sustainable

California Senate Republicans Press Release

UC Davis Health Improving Eye Care for People with Diabetes

UC Davis Health News

SACRAMENTO, CA (MPG) - Diabetes affects 34.2 million people in the United States. Diabetic retinopathy, a diabetes complication that affects blood vessels in the eye, is the leading cause of blindness in adults. Early detection and treatment are critical to prevent vision loss but fewer than 50% of the 3.2 million Californians with diabetes undergo their recommended yearly eye screening. Glenn Yiu, a professor of ophthalmology at UC Davis Health, hopes to increase that number significantly.

The UC Office of the President announced Yiu received a \$2 million grant to lead an interdisciplinary program, the Collaborative UC Teleophthalmology Initiative, or CUTI. The project, part of UCOP Multicampus Research Programs & Initiatives, is in partnership with medical centers at UC San Diego, UC San Francisco and UC Los Angeles. CUTI builds on a screening program Yiu launched at UC Davis Health in 2018. The goal is to expand eye care access for diabetics, particularly for underserved populations. The project will utilize digital medical equipment for teleophthalmology or “remote” ophthalmology.

How Teleophthalmology can be used for Screenings

A key feature of the CUTI program is integrating digital eye screenings into routine care at primary care facilities or clinics for patients with diabetes. The screening is simple and just requires the patient to look into a special camera. Known as a fundus camera or retinal camera, the machine takes high-resolution images of the interior of the eye. The images can detect changes that may signal diabetic retinopathy and other eye conditions. After the digital image is

taken at the primary care office or clinic, the results are sent to an off-site eye care provider for evaluation and diagnosis.

“Teleophthalmology pro-

will work with community clinics and Federally Qualified Health Centers (FQHCs) to reach underserved members of the community.

community clinics, such as Clinica Tepati and Paul Hom Asian Clinic, that provide care in Sacramento’s inner-city neighborhoods. UC Davis

awareness and acceptance of telehealth. He thinks this technology can reduce in-person health visits and improve access and adherence to preventative eye care.

The interdisciplinary CUTI team includes members from the four different UC campuses with expertise in public health, clinical informatics, and health economics who can address obstacles in clinical workflow, technology integration, and financial sustainability.

The retinal images taken during the four-year study will be collected in a centralized repository for research using artificial intelligence. Artificial intelligence may be able to identify eye diseases and predict the risk of cardiovascular events and strokes simply from images of the eye’s interior.

“The introduction of artificial intelligence is another exciting development in teleophthalmology,” Yiu said. “The incorporation of AI for automated image interpretation allows for faster and more sensitive diagnosis of early eye disease.”

Remote diabetic eye screening is already available at UC Davis primary clinics in Midtown, Folsom, Elk Grove, and the Lawrence E. Ellison Ambulatory Care Center. Yiu and his team believe that remote eye imaging may be used in the future to screen for other eye conditions such as glaucoma and age-related macular degeneration (AMD). Over the four-year program, they hope to spread the word to improve awareness about preventative eye care.

“We are excited to start this project and hope to find a way to scale it up for all of California. Our long-term goal is to make it easy for people with diabetes to get their annual eye screening, so we can help people avoid preventable blindness.” ★

Since launching a separate pilot teleophthalmology program at UC Davis in 2018, Yiu has improved diabetic eye screening rates by more than 15%, helping to make UC Davis Health one of the top performers in the country.

Screening for Underserved Patients

In addition to eye screenings at primary care facilities at UC health systems, the program

Health is also working with Communicare Health Care Centers, a FQHC, to provide remote diabetic eye screening to rural areas of California’s Central Valley. The region has limited eye care access. UC San Diego and UC San Francisco will also be engaging with community clinics in addition to primary care centers.

Training and Identifying Barriers

Because eye screenings are not a routine part of primary care, the program will train health care providers and identify the barriers that prevent the widespread adoption of remote eye screening. Yiu noted that the COVID-19 pandemic increased

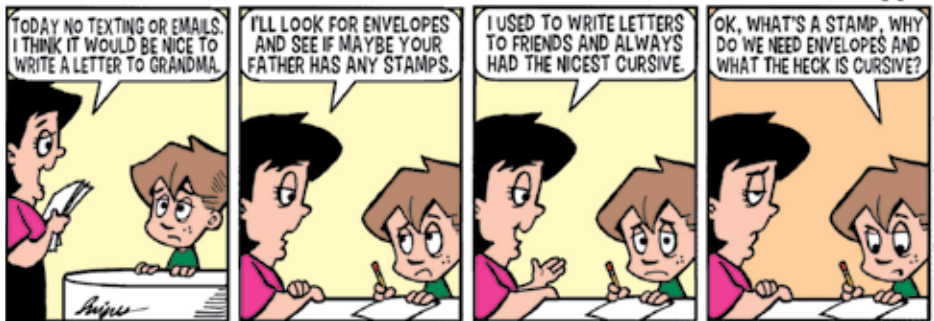

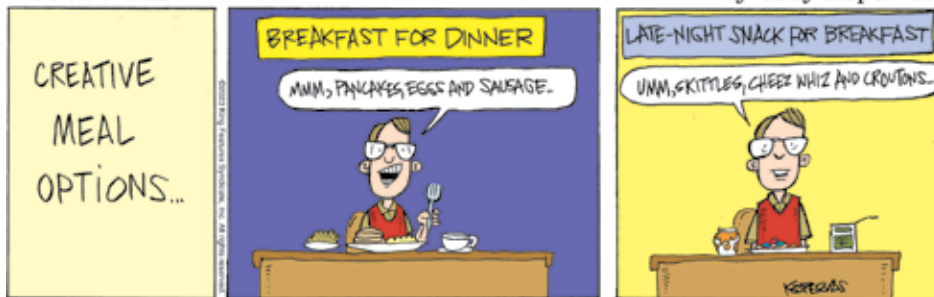

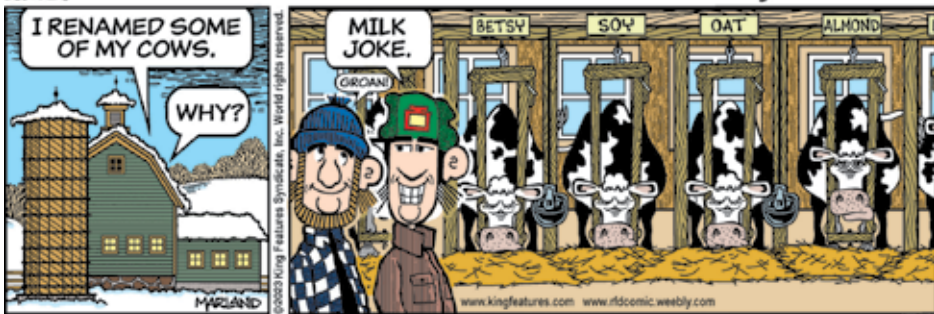

Honkers Drop to 0-2 in CVC after Tough Fall

YUBA CITY, CA (MPG) - The Yuba City Honkers Boys Basketball dropped to an 0-2 start in the Capital Valley Conference after they lost to the Antelope Titans 77-59 on Wednesday, January 11.

This was Yuba City’s first home game in over a month since they hosted their annual Mel Good Tournament from December 8-10.

The Honkers also play in the competitive Capital Valley Conference where Yuba City (10-6, 0-2 CVC) went winless last season against fierce competition like powerhouse Inderkum, Antelope and Woodcreek.

Honkers head coach Terry Evans in his first season has changed the culture of the basketball program already in the first half of the season.

“We are supporting each other, everyone is involved throughout the entire game,” Evans told the Dispatch.

Yuba City was undersized against Antelope, but the Honkers scrappy defense approach gave the Titans trouble throughout the game.

Yuba City was down 18-10 after the first but had eight turnovers in the first that gave them limited opportunities on the offensive end.

Senior point guard Ryan Grace expressed to the Dispatch the defensive pressure and communication on the floor kept them in the game throughout the first half. Grace had eight points, eight rebounds and three assists.

Evans and senior shooting guard Davis Warren added the way junior guard Anthony Medina flustered Antelope by being able to take charges sparked the bench and the momentum on the floor for the Honkers. Warren added 12 points, five rebounds and two blocks in the game.

One of the new ways Evans has changed the culture of this squad is after every charge taken by a Yuba City player, you’ll hear the Honkers bench yell “Gatorade”.

Evans exclaimed that for every charge taken by one of his players, he’ll reward them with a Gatorade post game. Medina earned three or

four for his efforts last Wednesday.

One strength Yuba City did phenomenally against the Titans, was getting to the free throw line. The Honkers were eight for nine from the charity stripe in the first half along with limiting the turnovers with two in the second quarter. Yuba City trailed Antelope 32-23 at the half.

One of the struggles the Honkers had against the Titans was shooting from beyond the arc. Yuba City was one of nine in the first half but made an improvement in the second half and ended up five of 19 throughout the game.

In the third quarter, senior forward Luis Dumarán took over offensively for the Honkers as he lit up the scoreboard with 10 of his 15 team-high points. Dumarán also had six rebounds and four steals.

Dumarán, Grace and Davis expressed to the Dispatch the energy of Evans has rubbed off on the team and is infectious.

Yuba City closed out the third quarter when junior forward Dhiraj Atwal hit a crazy buzzer beating three-pointer to dwindle the Antelope lead to six.

The Honkers crowd and bench erupted after the shot and Evans jumped out of his seat like a rocket shooting into outer space, running up and down the bench giving monster high fives to his players.

The Titans pulled away in the fourth quarter after Dumarán took a nasty fall on his knee with a little more than six minutes to go in the fourth and didn’t return to the game. Dumarán and Evans told the Dispatch he will be fine.

Evans mentioned to the Dispatch one of the biggest priorities when he took the head coaching position was for the kids to have fun.

“From day one in practice, as long as they play hard and getting better with one another, we’re going to have fun,” Evans said. “That’s the whole point of basketball, you have the crowd and the bench behind you, what more do you want.”

The Honkers hosted Roseville on Tuesday and will travel to Bella Vista on Thursday night. ★
