

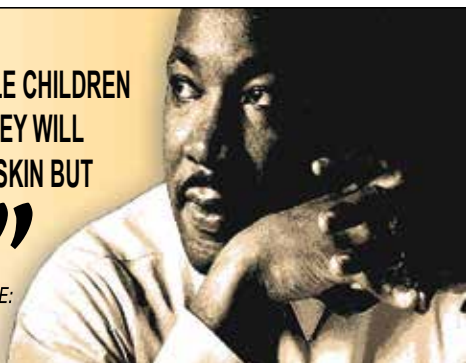

Trafficking has to Stop

This is Human Trafficking Awareness Month

MARYSVILLE/YUBA CITY, CA (MPG) - Human trafficking is one of the most horrendous crimes happening in the United States today. It is the one crime not enough people know enough about. Did you know that the Sacramento region is one of the most active metropolitan areas for human trafficking?

The local Soroptimists group wants to alert everyone that January is "National Human Trafficking Prevention Month" reaffirming our nation's commitment to protecting and empowering survivors of all forms of human trafficking.

They are holding the Walk to Raise Awareness of Human Trafficking in Yuba-Sutter on Tuesday, January 24th at 12pm, starting at 1210 Stabler Lane in Yuba City. Come on out and support this local group of volunteers and save someone's life from unspeakable crime.

As described by The U.S. Department of Health and Human

Services, there are two types of a severe form of human trafficking; Labor Trafficking: Individuals are compelled to work or provide services through the use of force, fraud, or coercion; or Sex Trafficking: Individuals are compelled to engage in commercial sex through the use of force, fraud, or coercion. When a person under 18 years old is induced to perform a commercial sex act, it is a crime regardless of whether there is any force, fraud, or coercion.

The website DeliverFund.org, which offers education, facts and statistics and resources for parents notes that human trafficking in the United States has been banned since the passage of the 13th Amendment. The federal statute outlawing trafficking is Title 18 of the United States Code, particularly section 1584 which makes it a crime to make someone work against their will, and section 1581, which makes it illegal to work in "debt servitude."

In 2000, the Victims of Trafficking and Violence Protection Act made it

easier to prosecute and sentence traffickers, and provided resources to do so. There is also a National Human Trafficking Resource Center Hotline (1-888-373-7888), which answers questions and responds to crises in 170 languages. Since 2007, the hotline has logged 60,000 calls.

Safe harbor laws have also been enacted to protect victims, so that they will not be prosecuted for prostitution or other crimes they may have committed while in slavery. Doctors and medical professionals are also trained and instructed to identify and protect victims. For more information check out DeliverFund.org.

YWA Board Votes on 2023 Leadership

MARYSVILLE, CA (MPG) - During its first meeting of the new year on Jan. 3, the Yuba Water Agency Board of Directors unanimously selected Gary Bradford as chairman and Don Blaser as vice-chairman for the 2023 calendar year. The board also welcomed Wayne Bishop and Jon Messick as its two newest board members.

"I appreciate the board's trust in me and the opportunity to serve you another year as chair," Bradford said.

This is Bradford's second term as chairman. He previously served as chairman in 2022 and as vice chairman in 2021. Bradford has served on the board since 2017 through his role as a Yuba County supervisor representing District 4, which includes Plumas Lake and Wheatland.

Bishop was elected last year as the board's representative of South Yuba County. Messick was elected as Yuba County's District 5 supervisor representing Yuba County's foothill and mountain communities and rural eastern Yuba County. Both will serve four-year terms on Yuba Water's board.

Yuba Water's seven-member governing board is comprised of all five members of Yuba County's Board of Supervisors, plus two elected representatives of North and South Yuba County. The board works with the agency's general manager to set policy and make decisions related to the agency's missions of flood risk reduction, water supply reliability, fish habitat protection and enhancement, hydroelectric power generation and recreation at New Bullards Bar Reservoir. Their work is guided by a five-year strategic plan.

"I look forward to working closely with this new board to advance the agency's core mission areas and serve the people of Yuba County together in the years ahead," said Yuba Water General Manager Willie Whittlesey.

The board also approved

Local Emergency in Midst of Storm Events

SUTTER COUNTY, CA (MPG) - Sutter County Administrative Officer Steven M. Smith, acting in his capacity as Director of Emergency Services, today proclaimed the existence of a county-wide emergency in the midst of a series of severe winter storms.

The proclamation, which allows the County to access state and federal resources, expires in seven days unless ratified by the Sutter County Board of Supervisors.

In a staff report for the January 10 regular Board of Supervisors meeting, Smith described the reason for requesting ratification, Smith noted the County has since December 28 "experienced extraordinary storm conditions resulting in local flooding and power outages in areas throughout

Sutter County. The storms, caused by a large atmospheric river, are expected to continue until at least January 16, with additional high mile per hour

winds and significant rainfall that could bring local rivers to monitor stage and, possibly, flood stage. On Wednesday, January 4, the Governor declared

a statewide emergency related to the severity of the storms.

Smith said he signed the proclamation "due to the

Widespread Flooding

SACRAMENTO REGION, CA - Raising questions about whether California's elaborate system of flood protections will hold, another dangerous storm is barreling toward the Sacramento Valley, where rains already punched through some levees and floods killed at least one person.

Last weekend's storms have already tested the flood-prevention infrastructure across the region, which sits at the confluence of two major rivers and bears the brunt of heavy rains. "It's a bathtub, basically," said Beth Salyers, deputy district engineer for the federal Army Corps of Engineers in Sacramento.

An estimated 1.3 million people and \$223 billion worth of property in the Central Valley are protected by the state-federal systems of levees, dams and other structures.

California spends \$48 million annually for operating flood protections but needs much more — "\$3.2 billion over the next five years of implementation," according to the state's Central Valley Flood Protection Plan, a document produced in 2012 and updated last month. Of that, the state's responsibility ranges from \$1.8 billion to \$2.8 billion.

An estimated \$25 to \$30 billion in funding over 30 years could help the state "avoid the astronomical cost of catastrophic flooding in the Central Valley estimated to be as high as \$1 trillion, in addition to an incalculable toll on lives and public well-being," the plan says.

So far, this winter's storms have been severe but not catastrophic: The New Year's Eve storm "stalled out" over the watershed of the Cosumnes River. Portions of privately owned levees on the river gave way, flooding nearby areas. The levees, constructed to reclaim the land for agriculture, are generally rated only to handle a 10-year flood, according to Sacramento County officials. The breeching of the levees shut down Highway 99 and stranded motorists.

But the region's two major reservoirs held, and the Sacramento and American rivers did not experience major floods.

"The investments we've made to the flood system have absolutely helped," said Gary Lippner, the Department of Water Resources' deputy director of flood management and dam safety. "At the larger scale, our system is much

more ready for high-water events."

The Central Valley has a long, painful history of deluges: The Great Flood of 1861-2, triggered by weeks of rain and snow, is still remembered as the worst disaster to ever befall California, inundating the entire valley, killing thousands of people statewide and devastating the economy.

The state's capital city was built in a floodplain and requires an extensive system of dams and levees to protect it. Even now, federal, state and local authorities are in the midst of upgrading those defenses, particularly in the Sacramento region, where multi-year, multi-billion-dollar projects are underway.

Major improvements have been made in the region and more are underway, thanks to about \$1.8 billion in state and federal funds. The Army Corps and state have been upgrading about 45 miles of levees over a 5-year period, and work on the final 2.8 miles is scheduled to begin in the spring.

Among the structural upgrades are raising levee

heights, boring as deep as 150 feet to reinforce levees to prevent seepage and piling rocks on riverbanks to reduce erosion.

"All of the work that we've done along the American and Sacramento Rivers are helping the current situation. We are not seeing flooding off these rivers," Salyers said. The completed projects are now weather-tested, she said, and "performing the way we wanted them to."

State officials expressed confidence that the Central Valley's levees and bypasses will contain the deluges coming tonight and next week.

"We do have a significant amount of capacity within the bypass system in that 1,600 miles of levee, and I don't anticipate ... there to be emergency management needs," Lippner said.

But every flood-protection system has its limits.

Michael Anderson, a climatologist with the California Department of Water Resources, noted that impacts from the upcoming storm system could escalate to a "worst-case scenario" if

it "becomes an unrelenting series of storms."

Forecasters are warning residents in the Sacramento region and the Bay Area to prepare today and Thursday for yet another assault, this time from a "bomb cyclone" spinning in the Pacific that will not make landfall but will amplify rain, wind and frigid temperatures along the coast and foothills.

Forecasters are expecting more atmospheric rivers — the powerful streams of tropical moisture that deliver most of California's winter rainfall.

In the mountains that supply California's reservoirs, snow levels are now above average. The Department of Water Resources' first snow survey of the season took place on Tuesday at Phillips Station, in the Sierra Nevada, west of Lake Tahoe. Scientists measured 55.5 inches of snow and a snow water equivalent of 17.5 inches. That's 177% of average for this location. Statewide, snowpack levels are at 174% of average for that date.

Statewide, this is the best start to the snow

season in 40 years, according to Department of Water Resources officials.

It would be hasty, though, to assume the ongoing storms and wet forecast mark an end to the prolonged drought. In 2021, record rains and heavy snowfall arrived between October and December. Then, California experienced its driest January-through-March — typically the state's wettest months — in recorded history.

Experts say consecutive storms are made more dangerous by an already-soaked landscape's inability to absorb more water. In addition to creating swollen creeks and mudslides, incessant rain reduces soils' ability to hold vegetation, and California's millions of drought-ravaged trees can easily fall over. Areas with wild-fire burn scars are at risk of flash-flooding, officials said.

The state has established emergency shelters in Sacramento and San Mateo Counties and has stockpiled 3.7 million sandbags.

Some experts think the flooding from the incoming

storms could be tempered by the fact that the developing system is relatively cold. This will translate into more snow and less rain, at least at high elevations.

Last weekend's storm was relatively warm and produced rainfall at high elevations, where the liquid water fell on several feet of snow, melting it and magnifying the runoff into streams and rivers.

The flood board updated Central Valley Flood Protection Plan, released last month, warns of "1,000-year storm events ... and the need to act with renewed urgency and purpose before the next large flood event occurs in the Central Valley."

The plan calls on nature-based solutions, like restored floodplains, and infrastructural improvements, like fortified levees near urban areas, to help reduce the impacts of higher-energy storm systems expected as a result of the warming climate.

Most of the historic floodplains along the Central Valley's rivers have been separated from the water by levees. Scientists now say that restoring floodplains can be an effective flood control strategy by allowing surging rivers to spill their banks and shed their energy on unpopulated flatlands, rather than bursting through aging levees surrounding populated areas. Floodplains also provide fish and wildlife habitat and serve as ground-water percolation beds.

"It takes a lot of time for that water to find a way out," said Mark Dickman, associate director for data at the U.S. Geological Survey in Sacramento. "There's just nowhere for it to go."

It's a persistent and familiar challenge: What to do with water when there's too much and how to manage when there isn't enough.

"We are built for this," said Jeffrey Mount, a water specialist at the Public Policy Institute of California. "We built the system around the notion that we get occasionally wet years and mostly dry years. But, unlike the Colorado River Basin, where they can capture and control four years of runoff, we are full after one year. Our ability to store surface water is limited."

The ongoing rains are already boosting California's water storage system. Major reservoirs are rising, some rapidly. Folsom Lake was 29% full on Dec. 20, and as of Jan. 2 it jumped to 61%. The much larger Lake Oroville jumped from 29% to 38% in the same window — an increase of more than 300,000 acre-feet. ★

potential for displacement of people from low-lying areas immediately adjacent to the rivers and other areas of Sutter County that may be affected, and the need for resources to address safety and property issues."

While Sutter County has fared well thus far in the storms and there is no immediate threat to any of the 260 miles of levees in Sutter County, there are a number of south county and Sutter Bypass roads flooded and officials are preparing for potential future issues.

Emergency Manager Zachary Hamill has been coordinating meetings with city, county, levee district, reclamation district, school, transit, fire, law, PG&E, California Office of Emergency Services, and National Weather Service officials.

"As the result of the ongoing drought, there is plenty of room in the reservoirs behind the dams that impact our rivers, so the rivers are not currently forecast to be a threat to our levee systems," said Hamill. "However, there is a history here of atmospheric river events filling up reservoirs fast and dumping enough rain on top of saturated soils below the dams to generate enough runoff to create substantial rise in river elevations. We need to be prepared and we ask that all residents of the county think in terms of preparedness as well. You can sign up for local emergency alerts and find great resources on river and reservoir levels,

and how to be prepared for any emergency, at bepreparedsutter.org."

Prior to the New Year's weekend storm, Sutter County sheriff's deputies and Yuba City police officers began informing those living on the river side of the levees on the Feather River at Yuba City of the expected rising water levels. While a majority of the individuals heeded the warning and moved to higher elevation, some were awakened by the river entering their tents.

No one was injured. For the duration of the storms and high water, Sutter County has converted its secure, three-acre overnight camping area on Second Street into an area where those abandoning the river's edge can get respite. Members of the Homeless Engagement and Resolution Team (HEART), supervised by Sutter-Yuba Behavioral Health Services, are engaging with those in camp to help connect them to services. Adventist Health and Rideout's street nursing program has been on site. Some tents and sleeping bags have been provided by various non-profit and local government sources.

In northwestern Sutter County, at Lovey's Landing near the Colusa County border north of Meridian, sheriff's deputies this week notified about 70 people living at a commercial trailer park on the levee side of the Sacramento River that the river is forecast to enter the park early next week. ★

an additional \$1 million in funding for continued flood risk reduction work and levee improvements in South Yuba County. The funding adds to a previous financial commitment of \$9 million by the agency aimed at leveraging state and federal dollars for a total investment of \$41.6 million into completing design and implementation of a Climate Resiliency Project and to prepare a feasibility study for a multi-benefit project in an area of the lower

Yuba River known as the Goldfields. If successful in securing state and federal funding, Yuba Water and the Three Rivers Levee Improvement Authority will use the money to complete the design and implementation of the Climate Resiliency Project, which will create a uniform level of protection for Plumas Lake, Arboga, Linda and Olivehurst. Those areas are currently certified at the 200-year level of protection for the state.

This project will increase that level significantly, exceeding the state's level of flood protection requirements. A 200-year level of flood protection is the state's current standard in the urban areas of the Central Valley and means there is a 1-in-200 or half of a percent chance in any given year that a storm more powerful than the system is designed to handle will come along. 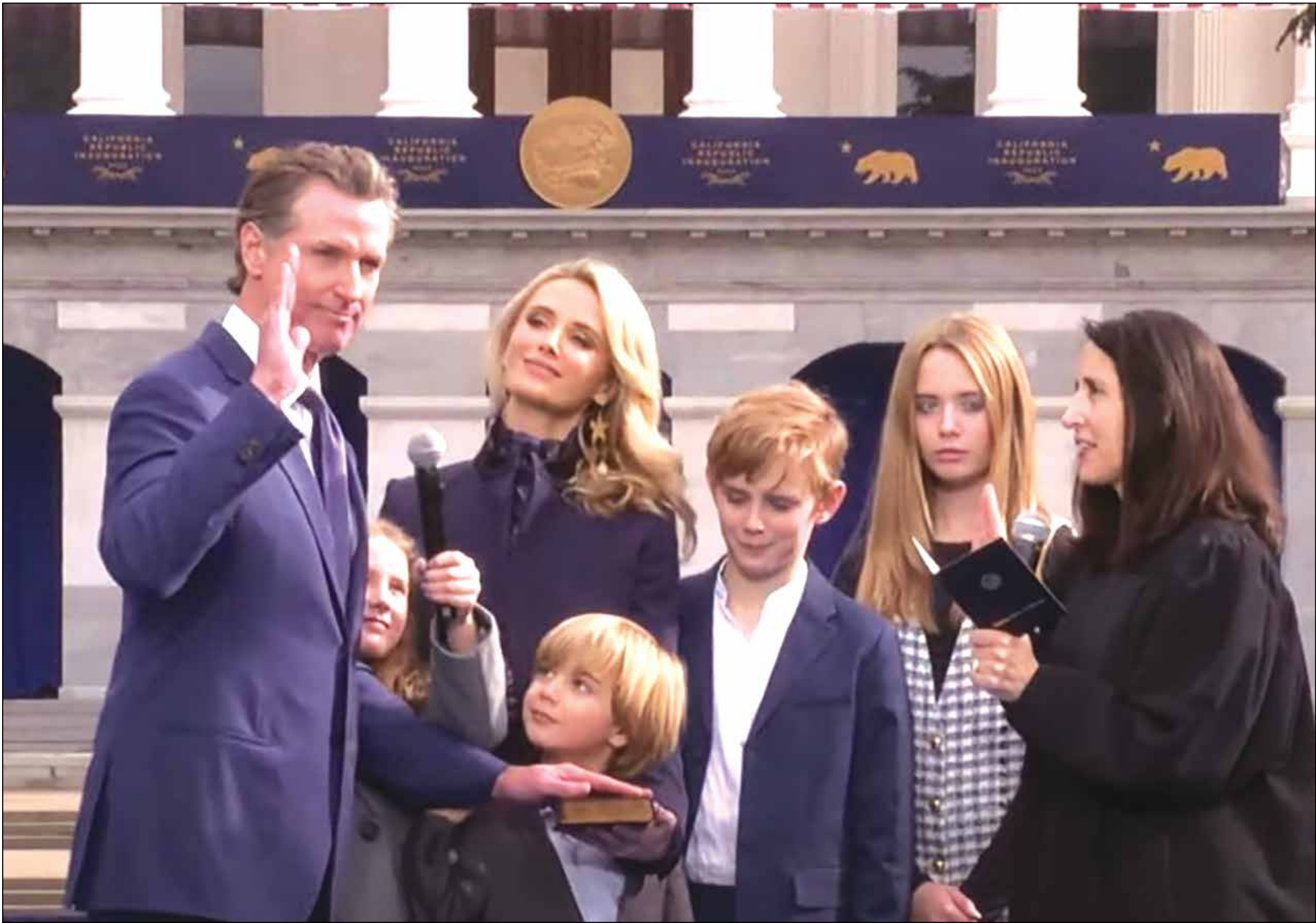

Newsom Rewrites State History

Newsom blames GOP and Right for issues plaguing state, ignoring complete Democrat control

California Governor Gavin Newsom was sworn in Friday (January 6, 2023) for a second term.

With the state suffering under a plague of hundreds of thousands of homeless drug addicts living on the streets, a serious spike in violent crime and theft, highest-in-the-nation taxes and cost of living, failing public schools, a state-created water shortage, and hundreds of thousands of California businesses and residents fleeing to friendlier states, Newsom made his second inaugural speech all about him – and he attacked the toothless GOP in this Democrat one-party state.

“Time has done its usual trick on me,” Newsom said.

“It says it has been four years since I stood in the shadow of this Capitol and delivered my first inaugural address.”

“Four years, disaster and plague, they bend the clock in strange ways,” Newsom said. *(doesn’t he know that he was governor these past 4 years during disaster and plague?)*

“In nearly 30 years in politics, I have had the opportunity to see this process firsthand, learning as we go, and etching these learnings on the consciousness of a country that perhaps hasn’t yet caught up,” Newsom said. “When we started issuing same-sex marriage licenses in San Francisco in 2004, it felt as if history moved at light-speed, in the right direction, decades of advocacy culminating in that beautiful Winter of Love.”

(Newsom started issuing same-sex marriage licenses as Mayor of San Francisco in violation of state law. A few months later, the California Supreme Court ruled unanimously that Mayor Newsom, and the City and County of San Francisco had exceeded its authority and violated state law by issuing the marriage licenses.)

Newsom played a victim of the Covid time period, in denial of his decisions to lock down school children and businesses,

force vaccines on millions of Californians, and mask the population indoors and outdoors, while he went about his life unmasked, attending events and parties, and while his children attended private school:

“It feels like both a flash, and an eternity.

“In the longest hours of my first term, trying to plot a course through pandemic, wildfire, mass shootings, and social unrest ... I found myself looking backward, as much as I was looking forward.

Newsom took us on a journey back in time to his childhood, omitting the omnipotent presence of the Getty family in his life, while lamenting victimhood because of his divorced parents:

“I recalled the late-1970s, when I was 10 or 11 years old, a child of divorce and dyslexia, trying to find my bearings.”

“I was a kid, traveling back and forth across the Golden Gate Bridge, between the two very different lives of my mother and father.”

“I couldn’t read, and was looking for any way to ditch classes. I’d fake stomach aches and dizziness. I’d bite down on the thermometer in the nurse’s office trying to make the temperature rise past 100.”

He also perpetuated the gross fabrication of a January 6th “insurrection” on the U.S. Capitol two years ago:

“...there are still forces in America that want to take the nation backward. We saw that two years ago, on this day, when the unthinkable happened at a place most Americans assumed was invincible,” Newsom said. “An insurrectionist mob ransacking a sacred pillar of our democracy, violently clashing with sworn officers upholding the rule of law. Just like the brave men and women whose heroism we inscribe, here on our own Peace Officers’ Memorial.”

“Since that terrible day, we’ve wrestled with what those events say about us as a country. The ugliness that overflowed on January 6th, 2021, was in fact decades in

the making. Fomented by people who have a very different vision of America’s future. Red state politicians, and the media empire behind them, selling regression as progress, oppression as freedom. And as we know too well, there is nothing original about their demagoguery. All across the nation, anxiety about social change has awakened long-dormant authoritarian impulses. Calling into question what America is to become, freer and fairer ... or reverting to a darker past.”

Newsom callously laid-out California’s cruel, evil history, full of bigotry, genocide, discrimination, and homophobia, omitting a few crucial details:

“California’s statehood, after all, was also sealed with a brutal genocide against native people.” *(Newsom is cherry-picking history to serve his own political positions. The Spanish colonization of the Americas began in 1493. The Spanish Empire expanded across the Caribbean Islands, South America, most of Central America and much of North America, but was not confined to California.)*

“Let’s not forget, the Chinatown I visited as a boy is a remnant of the bigotry of agitator Denis Kearney, and the Chinese Exclusion Act of the 1880s.” *(Newsom omitted that Kearney was anti-capitalist, and was elected president of the Workingmen’s labor Union. Kearney was arrested twice for using incendiary language and inciting a riot.)*

“Tens of thousands of Japanese Americans were interned right here during World War II.” *(Newsom omitted that the Japanese internment took place after an executive order by Democrat President Franklin Roosevelt.)*

What a contrast of Gov. Newsom’s speech to the inaugural speech of his nemesis Florida Gov. Ron DeSantis, who wowed the people of the Sunshine State with his praise, accolades and appreciation:

“Freedom lives here, in our great Sunshine State of Florida!” DeSantis said.

“It lives in the courage of those who patrol the streets and keep our communities safe, it lives in the industry of those who work long hours to earn a living and raise their families, it lives in the dedication of those who teach our children, it lives in the determination of those who grow our food, it lives in the wisdom of our senior citizens, it lives in the dreams of the historic number of families who have moved from thousands of miles away because they saw Florida as the land of liberty and the land of sanity.”

While Gov. Newsom wagged his finger at oppressive California and its residents, Gov. DeSantis uplifted his people, thanking them while recognizing that “Florida has led the way in preserving what the father of our country called the ‘sacred fire of liberty.’”

Liberty is something we are in short supply of in California under Gov. Newsom and the Democrat supermajority.

The rest of Gov. Newsom’s speech was directed to a wider audience – the nation, as he pretends he’s not running for President in 2024:

“Since that terrible day, we’ve wrestled with what those events say about us as a country.

The ugliness that overflowed on January 6th, 2021, was in fact decades in the making. Fomented by people who have a very different vision of America’s future.

Red state politicians, and the media empire behind them, selling regression as progress, oppression as freedom.

And as we know too well, there is nothing original about their demagoguery.

All across the nation, anxiety about social change has awakened long-dormant authoritarian impulses.”

Newsom played the game of “I know you are, but what am I?” described by the Urban Dictionary as, “quite simply the most retarded comeback someone makes when they’ve completely lost the argument. This statement signifies that the argument has gone to a

completely immature level.”

He continued attacking the right, GOP, and red states:

“They silence speech, fire teachers, kidnap migrants, subjugate women, attack the Special Olympics, and even demonize Mickey Mouse.”

“All camouflaged under a hijacking of the word ‘freedom.’”

“But what they really want is more control – intrusive government, command over your most intimate decisions – when to have a family, how you raise your kids, how you love.”

That last statement is really rich coming from the Governor who still clings to his Covid State of Emergency powers three years after the order, and ruling by fiat, locked down 40 million people during Covid, issued more than 70 executive orders containing 561 provisions, and killed off half of the businesses in the state.

Evan Symon with the Globe spoke with Washington-based analyst and speechwriter Craig Haddock after Newsom’s inauguration speech on Friday who said:

“I mean, let’s begin with the whole tone of the speech. Usually what people go for, especially in reelection speeches, is to promote unity and working together. Governor Newsom just destroyed any hope of bipartisanship by going after the GOP. If he is looking at a presidential run in the future, these are just further nails in that coffin. Any good leader will at least throw out a few brownie points at the other party. I mean, even [Florida Governor] Ron DeSantis has. Newsom just didn’t.”

“Even worse, he kind of praised the division between the two parties over and over again, and made the whole situation black and white. He lumped pretty much everyone against him with extremists and those that broke into the Capitol on January 6th. I mean, it’s no coincidence of the inauguration speech date. He wanted that and pretty much said “Democrats good, Republicans bad.” ★

How Environmental Law is Misused to Stop Housing

It’s well known that the California Environmental Quality Act, signed by then-Gov. Ronald Reagan in 1970 and meant to protect the natural environment in public and private projects, is routinely misused to stop or delay much-needed housing construction.

Anti-housing NIMBYs in affluent communities misuse it to stymie high-density, multi-family projects, arguing that their neighborhoods’ bucolic ambience would be altered. And construction unions misuse it to extract wage concessions from developers.

It’s a long-running civic scandal and a major factor in California’s chronic inability to reduce its severe housing shortage, one that cries out for CEQA reform, which former Gov. Jerry Brown once described as “the Lord’s work.” But neither Brown or any other recent governor has been willing to take on the task, which would mean confronting environmental groups and unions, two of the Democratic Party’s major allies.

In the absence of comprehensive reform, governors and legislators sometimes grant CEQA exemptions for particular projects, such as sports arenas, or narrow categories of housing. However, CEQA misuse continues and the courts

have become venues for battles over its application.

Two recent state appellate court actions in the crowded San Francisco Bay Area – one expanding the use of CEQA by those who oppose housing projects and another that restricts its use – underscore the law’s chaotic role.

Just before Christmas, one panel of the First District Court of Appeal issued a preliminary ruling that could open a new avenue for using CEQA to halt projects. It declares that a University of California student housing development in Berkeley violates the law because UC didn’t consider the impact of having more people – 1,100 students – in the neighborhood, citing the potential of late-night parties and other gatherings that could worsen a “persistent problem with student-generated noise.”

In other words, the court said that the presence of more people is an environmental impact – a novel theory that could hand anti-housing groups everywhere a potent weapon.

As UC law professor Chris Elmendorf tweeted about the draft decision, “The court’s reasoning is devastating ammunition for racist white homeowners who would leverage CEQA to keep poor people and minorities out of their neighborhoods.”

For example, he continued, “using the court’s statistical-associations logic, white homeowners could argue that CEQA requires affordable housing developers to analyze and mitigate putative ‘gun violence impacts’ from any lower-income housing project in an affluent neighborhood. The homeowners would point to statistics

showing that poor people, and African Americans and Hispanics, are statistically more likely than affluent people and whites to be victims of gun violence.”

A few days later, another panel of the same appellate court rejected efforts by a group opposing a 130-unit project in downtown Livermore, called Save Livermore Downtown, to employ CEQA. Attorney General Rob Bonta had interceded in the case, supporting the city’s approval of the project and its win in Superior Court.

“Timing is critical for affordable housing projects, which often rely on time-sensitive funding sources like tax credits to finance development,” Bonta said while intervening, adding, “Our state is continuing to face a housing shortage and affordability crisis of epic proportions. CEQA plays a critical role in protecting the environment and public health here in California. We won’t stand by when it is used to thwart new development, rather than to protect Californians and our environment.”

After the appellate court action, Bonta tweeted, “CA’s housing crisis is dire. We won’t stand by and let people misuse our laws to avoid being part of the solution.”

The outcomes of both cases underscore the need for a fundamental CEQA overhaul to reinstate its original purpose, rather than continuing wasteful project-by-project skirmishes.

A Market Redux in 2023

2022 no doubt was a year that many stock investors would like to forget. Unlike many of the previous crashes of the last few decades, the crash of 2022 has been prolonged and severe, and indeed is continuing to this day.

That said, I can comfortably say this crash is very, very different.

Previous crashes were caused by a variety of reasons including, but not limited to, an overindulgence in financial assets, irrational exuberance in stocks and the bursting of various economic bubbles.

The current market crash however finds its roots in rising prices of which we know as inflation. It has been over four decades since we have seen inflationary rates of this magnitude.

Previous stock crashes were addressed by increasing liquidity in the system. This means the central bank of the United States, known as the Federal Reserve (the FED), printed up lots of cash and handed it out where they saw fit.

Although it is a well-known fact printing up massive amounts of cash by a central bank can lead to inflation, the FED had a long history of rescuing previous economic calamities by printing dollars without seeing the resulting inflation. The reasons for this are hotly debated.

Just know that the Fed had apparently learned over many previous economic rescues that they could get away with flooding the system with cash without causing prices to subsequently rise. These repeated rescues of markets by the Fed was soon to be known to Wall Street traders as the “Fed Put.”

Specifically, it was now believed that if severe market crashes started to materialize, the FEDs would simply do what they had always done and what had always worked: print up copious amounts of dollars and fling them into the financial system.

Then came the Covid shutdowns and the markets turned down hard in March of 2020 because of them. Once again the Fed fired up the printing presses.

What was different this time around however was the amounts of cash the Fed created dwarfed any amounts previously attempted.

Handing it out not only to companies and the banking system, but to consumers as well, they increased the amount of cash in the system by an estimated 40% of all the US cash in existence, an unprecedented monetary intervention to be sure.

With copious amounts of cash flowing out of Washington to address any and all Covid-related problems, the FEDs and Washington apparently guessed they could print up whatever was needed and again not cause inflation. After all, they had gotten

away with it so many times before.

When the worst of Covid had subsided, the economies of the world began the reopening process. Supply lines however were all but seized up and were extremely slow in restarting.

At the same time, consumers, pent up for months and now flushed with all this government cash, soon flooded into the streets, and onto planes, trains and automobiles to escape the confines of a Covid isolation.

When a spike in demand by consumers met a severely restricted supply line, and huge amounts of newly printed cash sloshing around everywhere, prices had nowhere to go but up. Adding to the inflationary conflagration, employers were finding it difficult to fill badly needed job openings to service the increasing demand, which only made the situation that much worse.

While prices rose, the FED mistakenly thought the inflation was transitory and did nothing to address it. As inflation continued to soar, the FEDs finally acted by raising interest rates and stock markets subsequently began to crater.

Company earnings then started to decline as the consumer pulled back due to increasing inflation. As a result, the stock market decline accelerated.

With inflation now heavily entrenched, the FED realizes it cannot print its way out like it had done so many times before. Creating more cash would only exasperate the inflationary wildfires that are incinerating consumer pocketbooks.

This time around the FED PUT is no longer viable. It would only make a bad situation much, much worse.

Ironically, despite that fact, Washington is still handing out money by the truckload. About five trillion and counting in the last six months alone. Apparently, and appallingly, Washington believes it can still print away its problems, even though the Federal Reserve knows otherwise.

It is why, in this analyst’s opinion, until Washington and the Federal Reserve start using the phone lines between the two, the economic problems of 2022, will probably continue to be the economic problems of 2023.

Strawberry Growers Increase Acreage to Meet Record Demand

California strawberry growers are projected to plant record strawberry acreage in 2023. According to the California Strawberry Commission, farmers are planting more strawberries this year “to meet record consumer demand.” To satisfy that demand, California growers are expected to plant 41,570 acres of strawberries this year. That would be up from 40,714 acres last year. Of the 2023 total, 31,852 acres are already in the ground. Fall strawberry plantings produce fruit during the winter, spring and summer months.

New Lws May Ease Export Fees, Create Farm Workforce Challenges

New California laws, which went into effect New Year’s Day, are expected to impact farm operations and exports. Key legislation passed last year includes Assembly Bill 2406. That law is intended to keep international ocean carriers from imposing onerous cargo detention and demurrage charges on farm goods delayed at California ports. Meanwhile, AB 2183 will allow labor unions to organize agricultural employees by collecting signatures instead of holding secret-ballot elections. Agricultural groups say it may lead to union intimidation.

Research Project Seeks to Sustain Pistachio Production in Warmer Climates

University researchers from California and other states are joining in a four-year research project that seeks to improve pistachio production as growers face warmer winters and water shortages. California grows 99% of America’s pistachio crop and nearly 60% of the world’s crop. Researchers at University of California, Davis, UC Merced, New Mexico State University and Purdue University are conducting research to aid pistachio pollination and to develop rootstocks that can thrive despite increasing water scarcity.

Report: Dairy Farmers are on Track to Meet Methane Emission Reduction Goals

California dairy farmers are making progress in reducing methane emissions. According to a new report, the state’s dairy industry is on track to meet a goal of reducing methane emissions by 40% by 2030. The report was produced by the California Dairy Research Foundation and the University of California, Davis, CLEAR Center. The report notes that dairies’ use of feed additives is expected to have a positive impact in curbing enteric methane produced by livestock. Several new feed additives are expected to become commercially available soon. ★

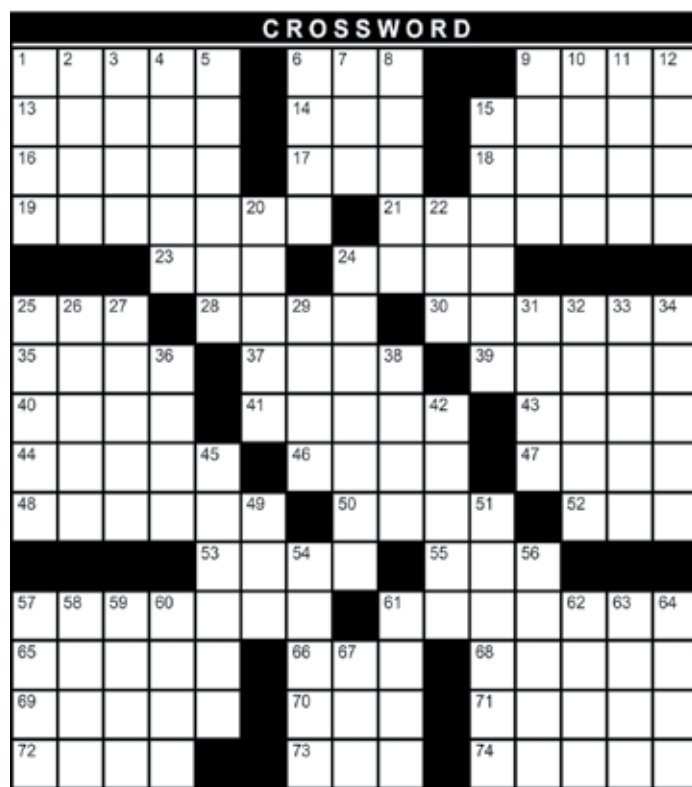

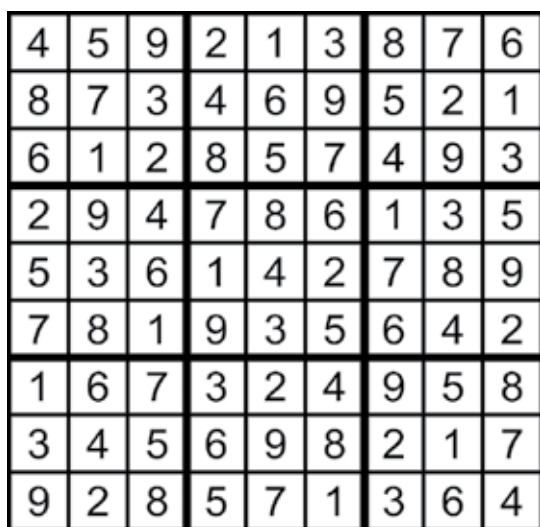

What Taxpayers Need to Know about Unemployment

I sincerely hope that readers aren't turned off by the title of this column. While most taxpayers aren't directly responsible for paying unemployment insurance taxes, the truth is we all pay and, in California, we pay a great deal more than we should. Last week I received an email from a dentist who operates a small dental office and is required to pay the unemployment insurance tax

and, sadly, is paying much more than he should because our unemployment insurance program is insolvent. Like so many other measurements of California's performance relative to other states, our businesses – both large and small – are paying a penalty for the incompetence of our elected officials and bureaucrats. Here's what taxpayers should know about unemployment insurance. California's unemployment insurance program (UI) is funded by a tax imposed on employers. The proceeds are deposited in the Unemployment Trust Fund of the U.S. Treasury Department. States may withdraw funds from their accounts to pay unemployment benefits. Here's the kicker: If a state's trust fund does not have adequate funds to pay benefits, it must borrow money from the federal

fund to satisfy unemployment claims. But if a state's UI Fund is insolvent for more than two years, that tax rate increases each year. The tax can be hefty, as much as \$420 per employee per year. Like other states, California was slammed by the pandemic. Low unemployment quickly became unprecedented levels of high unemployment. While few dispute the need for workplace closures early in the pandemic, California was much slower in reopening than more freedom-oriented states like Texas and Florida. This had a direct impact on the further decimation of the UI fund. That's just one reason why, by the spring of 2020, California's UI Fund was depleted and continued to fall further behind. This required even more borrowing from the federal government. Even worse, California

was suffering from a second epidemic: an epidemic of massive fraud in the administration of unemployment insurance claims. On Gov. Gavin Newsom's watch, the Employment Development Department (EDD) failed to process a backlog of claims for hundreds of thousands of unemployed Californians while sending out as much as \$30 billion in unemployment benefits for phony claims, including fraudulent claims paid to death row inmates. Much too late, after several legislative hearings on the lack of oversight of EDD, there were modest corrective actions taken. But this was the epitome of closing the barn door after the horses bolted. If anyone believes that the massive EDD fraud didn't impact ordinary taxpayers, they couldn't be more wrong. California's employers are directly responsible for the cost of

EDD providing benefits on fraudulent claims, which means that all of us must absorb the cost of this inexcusable lack of oversight. Perhaps the most important thing for taxpayers to know about California's unemployment insurance program is how insolvent it is. EDD itself projects that at year's end the UI Fund's total debt will exceed \$19 billion. Moreover, the U.S. Department of Labor confirms that California's debt problem is the worst of any state, with an accumulated debt that exceeds the debt of all other states combined. Again, in the competition between states, it is notable that most other states have no outstanding debt because they used Covid relief funds from Washington to pay down their UI loans. For example, Texas approved a \$7.2 billion payment and has eliminated its UI

debt entirely. What about California? Because of its insolvency, it must pay \$470 million in interest payments alone to the federal government. That's nearly half a billion that could otherwise go to education, transportation, or public safety. Worse yet, this is an annually recurring expense. Remember just last June when California had a \$95 billion surplus? That would have been the time to increase the payments to the federal government to reduce our UI debt. But now, the LAO tells us we have a \$25 billion deficit "problem." So let's just chalk this up as another missed opportunity for the Golden State. And citizen taxpayers, as well as California's beleaguered business community, are paying the price. *Jon Coupal is president of the Howard Jarvis Taxpayers Association. ★*

Lady Indians Open PVL with Big Win over Sutter

SUTTER, CA (MPG) - The Marysville Indians girls basketball team opened Pioneer Valley League play with a decisive 61-17 victory over the Sutter Huskies on Wednesday, January 4 en route to their fifth win in a row.

Marysville controlled the game early and didn't look back as they opened with a 15-0 run in the first four and a half minutes of the game before Sutter was able to crack the scoreboard.

The Lady Huskies roster is young and resilient, but head coach Brandee Harter expressed to the Dispatch that most of her roster is new to the game of basketball.

Sutter graduated seven seniors last season and their current roster is made up of one senior with the rest of the roster filled up with seven juniors and two sophomores.

"I'm very proud of the athletes I have and as time goes on, they're going to do very well," Harter told the Dispatch.

Marysville (13-2, 1-0 PVL) led 23-2 at the end of the first.

The Lady Indians, who have an experienced club that has played with each other for a while, have multiple standout players that can attack from any angle.

Marysville senior guard and captain Sophia Rogers mentioned the continued full-court pressure defense the Lady Indians start out each game with, set the tone defensively and creates multiple opportunities on the offensive end.

Marysville had 36 steals in the game against the Lady Huskies which brought their season average to 27.2 per game.

Rogers is the 22nd ranked leader in steals nationally according to

Prince and Harter both told the Dispatch they are great friends and their families are close.

Sutter (7-8, 0-1 PVL) sophomore forward/guard Torrence Harter is the leader of the young Lady Huskies squad.

Torrence was averaging a double-double throughout the first 12 games of the season with averaging 12.1 points and 12.9 rebounds per game, but Sutter's stats haven't been updated on MaxPreps since their game against Highlands on December 20.

Torrence is also ranked in the top 75 of the country for steals per game with an average of 6.2 per game.

Torrence mentioned to the Dispatch that the chemistry on the team is good and everyone is supportive of one another.

MaxPreps with an average of 7.1 per game; she had eight against Sutter.

"We're going to keep playing hard and play our game," Rogers exclaimed to the Dispatch.

Rogers also had six points, five rebounds, five assists and two blocks.

The Lady Indians took a 45-9 lead into the half.

On top of this being the PVL opener for both teams, it was also a return game for Marysville head coach Ike Prince as he was the head coach at Sutter for two seasons from 2015 to 2017.

Prince said to the Dispatch it's always fun to coach against a former school, he added that he still has relationships with the Sutter coaching staff as they were assistants for him during his time as head coach of the Lady Huskies program.

Torrence had five points, eight rebounds, four assists, seven blocks and seven steals against the Lady Indians.

The Lady Indians defensive pressure troubled their opponents and it led to multiple options offensively whether it could have been a long-lead pass down the court, or if someone wanted to drive the ball from one end to the other.

Marysville junior guard Kaliyah Henry expressed to the Dispatch that the Lady Indians are always communicating with one another about how they can make each other better.

"We talk to one another about what we should do in between games played so we can improve and make adjustments," Henry said.

Henry scored 10 points, had five assists and stole the ball six times against Sutter.

Henry and Rogers both expressed that it was good to give Prince a win against his former school, and that he is both a great coach and they enjoy playing for him.

The Lady Indians followed up the win over Sutter with a 46-point blowout win over Center on January 6, while the Lady Huskies got their first PVL win with a 47-25 victory over Wheatland on January 5.

With the season a little over half over, Prince said the biggest difference he has seen in his senior leadership from the beginning of the season to currently is the communication between everyone.

"When the seniors are communicating with each other, it trickles down to the other players on the team, it's amazing to see," Prince said. ★

‘Stories of the Museum’

Series 12 by Bill Crocker, CDR, USNR, Ret.

Museum of the Forgotten Warriors board member and webmaster

More than a thousand military men and women and family members have donated thousands of personal items and stories to the Museum of the Forgotten Warriors over the past forty years. The displays span World War I to the conflicts in Iraq and Afghanistan and tell the stories of those who fought and died. The series, Stories of the Museum, describes a few of these in more detail.



WAC STAFF SERGEANT AGNES INEZ PICKERING

Agnes was a force! Her great niece described her as a “kick”. She had a pet alligator in the 1930s and on her way west from Florida, she stopped at a tavern and asked the owner to watch her pet gator while she attended to some business. She was very upset when she returned to claim her reptile to find the poor fellow had been put headfirst into a barrel of water and had drowned.

Agnes Walden was born in DeFuniak Springs, Florida, on 28 May 1913, to Samuel and Elizabeth Walden. She had four brothers and

sisters all with names beginning with the letter A. She was introduced to family trauma early in life when her mother and her baby sister were killed as their automobile malfunctioned and flipped over. This caused a rift in the family for a number of years.

Agnes was living in Magnolia Beach, Washington, when she met and married John Pickering of Seattle. They were living in Alaska when Agnes learned about a new program promoted by the US Army, the Women’s Army Auxiliary Corps known as WAAC. It had

been established on 14 May 1942. It cleared the way for women to serve in a variety of jobs and to serve their country in a patriotic way. Agnes decided that was for her. She enlisted in the WAAC just nine months later on 1 February 1943 and became a photographer. She was sent to Army Service Forces Administrative School in Daytona Beach, Florida, for six weeks then to Publicity Photography School, Lowry Field, Colorado, for four weeks where she completed an advance course in newspaper photography. The WAAC was converted to an active-duty status as the Women’s Army Corps (WAC) on 1 July 1943 and Agnes was one of the first women to serve in that corps just one month after it was created. She became a war photographer in Europe. She also served in the Army’s Pictorial 292 Signal Service Battalion. The Army Pictorial Service supervised the Signal Corps Photographic Center and its branches. The center produced training, morale, and combat films. Staff Sergeant Pickering

remained in Europe after the war ended documenting the destruction. While touring, she traded with the civilians she met and obtained many interesting items that she brought home.

She completed her military service in 1947 and returned to Klamath Falls, Oregon, where she and John built a cottage. The home was filled with her treasures that included a coffee grinder from the 1600s and antique firearms. They remained in the cottage through John’s

passing and to Agnes’s passing on 20 July 2003 at the age of 90.

Minivan Crosses over and Collides Head-on with Semi-truck

YUBA-SUTTER REGION, CA (MPG) - On January 5, 2023, at 10:55pm, a 2017 Dodge Caravan was being driven south on SR-99 approaching SR-113 at a high rate of speed, in the left lane. The truck driver was driving a 2020 Kenworth T680 Semi w/ 53' trailer north on SR-99 from SR-113, in the right lane. The driver of the minivan veered to the left, directly into the path of the semi-truck where the two vehicles collided head on. An off-duty CHP Officer

drove upon the scene and pronounced the driver of the minivan deceased. The truck driver complained of pain and declined medical aid. A substantial amount of debris and fluid covered approximately 200 yards SR-99. Vehicle removal and scene cleanup required the highway to be closed for approximately three hours. Alcohol is believed to be a factor in this collision. The name of the driver of the minivan is being withheld until proper notifications are made. His name can be released if you contact the Sutter County Coroner. ★
