Yuba River Endowment Donates Another 16,000 Pounds of Rice

YUBA CITY, CA (MPG) - In their fourth such donation since COVID began, Yuba County farmers who are part of the non-profit group Yuba River Endowment, delivered 16,000 pounds of locally grown rice to the Yuba-Sutter Food Bank. The rice, valued at over \$13,000, will be distributed to over a dozen Yuba County Food Pantries.

"Food insecurity began to spike during COVID, and now with rising inflation we are again seeing a massive need for staples like rice," said Naomi Cabral, CEO of the Yuba-Sutter Food Bank. "This same bag of rice costs 30% more than it did nine months ago. This donation is a true blessing for thousands of families in Yuba County."

made in April, 2020; February, 2021; and November, 2021. With this current donation, 64,000 pounds of rice have been delivered to date.

"Our motto for the Endowment is 'Local Farmers Giving Back,' and there's no better way we as farmers can help our community than by supplying our locally grown food," said Yuba River Endowment President, Al Lassaga.

The Yuba River Endowment is a non-profit organization created by Yuba County farmers. Since formation in late 2019, the Endowment has donated over \$300,000 to support Yuba County ag education, provide food resources, veteran's support, and much more.

The Yuba River Endowment Previous rice donations were was established by a select group of Yuba County farmers who have a right to water that flows on the Yuba River. In some years the farmers are able to transfer a portion of their water to drought-stricken areas of the state. Proceeds from these transfers provide the funding for the Yuba River Endowment.

Man Arrested for Assault with a Deadly Weapon on **Two Peace Officers**

MARYSVILLE, CA (MPG) - On October 1, 20022, Yuba County Sheriff's Deputies attempted a traffic stop on a Ford F-150 in the city of Marysville. The driver, Michael Williams from Chico, CA., initially yielded but quickly sped away leading Deputies on a pursuit throughout Marysville. Williams is on **Butte County Probation** for Assault on a Peace Officer, and the Ford F-150 was later determined to be stolen out of Chico.

During the pursuit, Williams rammed a patrol vehicle on the driver's side causing significant damage to the vehicle and injuring a Deputy. He continued to flee until coming to a stop at a dead end near F and 3rd Streets. Williams reversed his vehicle and rammed a second patrol vehicle several times, which caused significant damage, but no injuries to the Deputy. He then drove through a gate and into a sewage drain where the vehicle became disabled.

Williams ran and climbed to the top of a cell tower that was approximately 150 feet high and refused to come down. Yuba County Crisis Negotiation Team and Yuba-Sutter SWAT responded and began negotiations. After approximately six hours of negotiations, Williams climbed down and was taken into custody. He was booked into the Yuba County Jail for multiple felonies, including assault with a deadly weapon on a peace officer. The Deputy who was injured has been released from the hospital and is recovering at home.

YCFD Staffing Levels Help Residents **Feel Safe with Fire Protection**

YUBA CITY, CA (MPG) - Yuba City residents should feel safe with the city fire protection. There has been a lot of recent comments around the level of support that Yuba City Fire Department gives and receives. First and foremost, the safety of the residents of Yuba City is our top priority.

Mutual aid is a common practice among fire agencies to protect the residents of the jurisdictions. During the current year as of September 22, 2022, The City of Yuba

City has provided aid to Sutter County 61 times and Sutter County has provided aid 64 times. As you can see no one agency over burdens the other as our firefighters do their job and do it well.

While some recent comments reflect that the city could be impacted greatly, YCFD is on pace to respond to close to 12,000 incidents this year. We expect that aid provided and received will be approximately 100+ calls in this calendar year for each agency. This is a typical year for mutual aid. Also, the City of Yuba City is under contract to

cover fire and emergency medical calls outside of the city limits yet within the city's sphere of influence. This is currently being subsidized by the residents of Yuba City through our normal operational budget.

There are two types of aid, mutual aid and auto aid. Mutual aid is actual aid requested and auto aid is based upon preplanned operations. The aid received by YCFD from Sutter County is mostly auto aid.

Sutter County provides more Auto aid than Mutual Aid, which primarily occurs with Station

8 on Barry Road that responds to vegetation fires in the River Bottoms and Hwy 99 accidents. YCFD provides more Mutual Aid than Auto Aid to the County to supplement Structure and Vegetation fire response. Both Fire Chiefs agree, that neither agency feels adversely impacted by the current mutual and auto aid responses.

To our 72,000+ residents of Yuba City, your YCFD is fully staffed and prepared to handle any situation that should arise and is prepared to provide mutual and auto aid to our partners in Sutter County.

MARYSVILLE, CA (MPG) - A suspect has been arrested for transporting a controlled substance with the intent to sell, carrying a concealed loaded firearm, and possessing drug paraphernalia. The suspect has been identified as 59-year-old Stewart Arthur Wakefield of Antelope.

On September 23, 2022, at approximately 9:23 p.m., Marysville Police Officers were working a DUI enforcement detail as part of the California Highway Patrol (CHP) Cannabis Tax Fund Grant. Marysville Police Officers conducted an enforcement stop on a vehicle for erratic and unsafe driving on the E Street Bridge.

Officers determined Wakefield was operating a motor vehicle while under the influence of a controlled substance. A search of Wakefield and his vehicle revealed just under 22 grams of methamphetamine, drug paraphernalia, a concealed loaded .38 caliber revolver, and nearly \$52,000 in cash.

After the investigation concluded, Wakefield was booked into the Yuba County Jail for 11378 H&S, possessing a controlled substance with intent to sale, 11379 H&S, transporting a controlled substance with intent to sell, 11364 H&S, possession of drug paraphernalia, and 25850 PC, carrying a concealed loaded firearm.

Fatality in New York Flat Road **Collision of 2 Pickup Trucks**

SUTTER COUNTY, CA (MPG) - On September 23, 2022, at approximately 6:45 pm, a driver was driving a gray Ford F250 southbound on New York Flat Road, north of Idlewood Circle at an undetermined speed. The second driver, Jonathan Jordan, was driving a green Ford F150 northbound on New York Flat Road, north of Idlewood Circle at an undetermined speed. Both vehicles collided head on and as a result, the first truck overturned and its driver

was ejected. The driver of the first vehicle suffered major injuries which he succumbed to on scene. The facts and circumstances of this collision are still under investigation.

Alcohol and/or drugs are considered to be a factor in this collision.

The Yuba County Sheriff Coroner will be releasing the name of the victim after proper notifications are made.

2 Vehicle Collision at Intersection of SR-20 and Humphrey Road

SUTTER COUNTY, CA (MPG) - At approximately 8:26 pm dispatch broadcast a two-vehicle collision on SR-20 at Humphrey Road, with multiple people trapped including several children and an infant. In total there were 11 people involved. In a Honda Pilot there were 1 adult and 5 children. The second vehicle was a 2018 Jeep Compass with 4 adults and 1 infant. All 10 injured patients were transported with moderated to major injuries to various regional hospitals (Enloe, Mercy San Juan, UC Davis, and Adventist Health Rideout.) One 12-year-old female was airlifted to UC Davis for a broken femur. All patients are expected to survive with the most severe injury being a-broken femur.

Both vehicles involved sustained major

damage. SR-20 was shut down in both directions for 1 hour and 45 minutes. Westbound traffic was diverted onto Township Road and eastbound traffic was divert at Acacia Ave. Preliminary investigation revealed that the Honda Pilot was traveling northbound on Humphrey Road crossing SR-20 (failing to yield the right of way) when it was struck by the second vehicle, which was traveling westbound on SR-20.

Officer Cunningham is handling the investigation. The driver of the Honda Pilot (Lopez) was interviewed at Adventist Health Rideout and was determined to be under the influence of alcohol. Lopez was arrested for felony DUI causing injury and a blood sample was obtained. Due to her injuries, Lopez was released to the hospital for medical care.

YUBA CITY, CA (MPG) - The River Valley Falcons varsity football team has forfeited the remainder of their season after a video of some team members acting out a "slave auction" recently surfaced.

According to The Sacramento Bee, Yuba City Unified School District Superintendent Doreen Osumi sent an email to district staff members that announced River Valley was going to forfeit their Capital Valley Conference game against Roseville last Friday, September 30.

"I received a copy of a recording of River Valley High School football team members acting out a reprehensible act of a slave auction. The recording clearly demonstrates that this situation was orchestrated and organized," Osumi wrote in the email obtained by The Bee.

With the forfeiture of the game against Roseville, the Falcons record dropped to 0-6 on the season.

The season was then canceled Friday, according to The Appeal Democrat, after a meeting that included Osumi, other district officials and school personnel in a private parent meeting.

Osumi sent a statement that read that the

students involved in the incident will not participate in the rest of the season.

Osumi followed with a statement that read, "They violated our student-athlete code of conduct, which they all signed and committed to follow, and that will not be ignored or minimized."

She added that with multiple players being suspended for the remainder of the season, the team will be unable to safely field the varsity team, forcing the remainder of the season to be canceled. Osumi also stated that the junior varsity team would be allowed to compete, and eligible sophomores and juniors can join that team.

Osumi said the district launched an investigation immediately to find out which players were involved

"When students find humor in something that is so deeply offensive, it tells me that we have an opportunity to help them expand their mindset to be more aware, thoughtful and considerate of others," Osumi said.

The Messenger Publishing Group reached out to River Valley coach Tony Battista for comment and no response was given as of press time.

Wildfire Victims Get 'Healing' Tax Exemption from Settlement Payments

payments with the signing of Assembly Bill 1249 (Gallagher). Senator Jim Nielsen, R-Red Bluff, is AB 1249's principal co-author.

"The signing of the measure into law was critical for the healing of the victims of the devastating Butte and Camp Fires," said Nielsen. "I am deeply grateful for the unanimous bipartisan and heartfelt support AB 1249 has received."

AB 1249 will provide financial relief to wildfire victims of the 2015 Butte Fire and the 2018 Camp Fire by exempting them from paying state income taxes on settlement payments made out of PG&E's "Fire Victim Trust" fund.

Elected to the State Senate in January 2013, Senator Nielsen represents the Fourth Senate District, which includes the counties of Butte, Colusa, Glenn, Placer, Sacramento, Sutter, Tehama and Yuba. NET-5 Agents Arrests 2 in Possession of Powder Fentanyl

YUBA CITY, CA (MPG) - On September 15, 2022, at approximately 10:30 am, member of the Yuba Sutter Narcotic and Gang Enforcement Task Force (NET-5) with the assistance from the Sutter County Sheriff's Office executed a search warrant on Casey Donaho (33 years old of Yuba City) and Crystal Hanson (31 years old of Arena Point) who were both located driving in their vehicle northbound on Hwy 113 in Sutter County.

During the execution of the search warrant, NET-5 agents located 82.7 grams of powder fentanyl, a digital scale, packaging, and two cellphones. As a result of the investigation, both subjects were arrested and booked into the Sutter County Jail on charges of possession and transportation of a controlled substance for the purpose of sales per sections 11351 and 11352 of the Health and Safety Code.

This investigation was forwarded to the Sutter County District Attorney's Office. ★

California Fire Foundation Provides over \$87K for Mill Fire Survivors

SACRAMENTO, CA (MPG) - The California Fire Foundation has activated hundreds of its Disaster Relief cash cards and distributed them to survivors of the recent, deadly Mill Fire in Siskiyou County. To date, 350 cards were distributed at the Weed Community Center between September 9th and 11th.

The Foundation's activated cash cards provide more than \$87,000 in rapid assistance to those in need. The California Fire Foundation coordinated the cash card distribution with the Siskiyou Domestic Violence & Crisis Center (SDVCC) in Weed with additional funding support from the Foundation's partners the Rural County Representatives of California (RCRC) and Golden State Finance Authority (GSFA).

"During a wildfire disaster, we need to get aid to those that need it most," said Rick Martinez, Executive Director of the California Fire Foundation. "When we partner with organizations such as RCRC and GSFA, we can get that aid into the hands of those in dire need, quickly and effectively."

The California Fire Foundation's Disaster Relief program brings immediate, short-term relief in the amount of a \$250 cash card to survivors of fire or

other disasters throughout California. The Disaster Relief cards provide immediate relief so they may purchase basic necessities such as medicine, food, gas, lodging,

"Our communities in Siskiyou County are suffering immeasurably right now," said Michael Kobseff, Siskiyou County Supervisor and RCRC Board Delegate. The Mill Fire has burned nearly 4,000 acres, destroyed over 100 structures, and killed two people since it began on September 2.

Red Light Violation Collision Leaves 1 Fatality and 4 Injured

BUTTE REGION, CA (MPG) -On September 5th, 2022, at approximately 12:20 pm, a 37-year-old male from Yuba City was driving a 2007 Chevrolet Colorado northbound on State Route 99 approaching the intersection of State Route 162. The driver of the Colorado ran the red light at the intersection of State Route 99 and State Route 162. Subsequently, the front of the Colorado

collided with the driver's side of a 2011 Kia driven by a 75-year-old male from Oroville. The collision between the Colorado and Kia caused the Colorado to begin to roll over before it came to a rest on its roof, west of State Route 99. The Kia was pushed in a northerly direction and collided with a 2014 Ford and 2016 Chevrolet who were both waiting at the red light on southbound State Route 99.

As a result of this

driver of the Colorado suffered major injuries, the juvenile passenger inside the Colorado suffered minor injuries, the driver of the Kia suffered major injuries, a 77 female passenger suffered fatal injuries and a juvenile passenger in the Kia suffered moderate injuries. This collision is still under investigation, but drugs are suspected to have played a factor in this traffic collision.

Live Oak's Response to **Grand Jury Findings** At the December 20, 2021, The SCGJ made recom-By Seti Long,

LIVE OAK, CA (MPG) - The Sutter County Grand Jury Report, released on June 24th of 2022, listed five findings regarding its investigation into the City of Live Oak.

Intitled "City of Live Oak: Crisis of Municipal Dysfunction" and beginning on page 45, the Sutter County Grand Jury Report (SCGJR) provided a summary, background, methodology, and discussion which delved into each of its findings during the investigation. The Grand Jury required a response from the City of Live Oak to each of its findings, which are listed below:

F1 – When the City of Live Oak did not appoint a council person to fill the vacant council seat, it cost the citizens of Live Oak financially.

Response: Disagrees in part. The City of Live Oak had nine applicants for the open City Council seat. Six of those were moved to a vote, and each of the six candidates failed on a 2-2 vote each time. Five of the six candidates Santana and Woten voted yes and Thiara and Ghag voted no. The sixth candidate Thiara and Ghag voted yes and Woten and Santana voted no. However, it should be noted that we disagree in part because not all candidates are necessarily qualified to fill the position.

F2 – The City Council of Live Oak did not pass the budget in a timely fashion.

Response: Agree. The City Council was presented with the final 2021-2022 Annual Budget for approval at the June 2, 2021, meeting and it was moved to the June 16, 2021, meeting. The budget was then tabled at the June 16, 2021, meeting. There was a budget workshop and then a special council meeting to approve the budget. However, only Council Members Woten and Santana were present. Council Members Thiara and Ghag were absent. At the following seven meetings the budget was presented for adoption and failed each time to a 2-2 vote. The dates for those seven meetings were, June 29, 2021; July 7, 2021; July 14, 2021; June 21, 2021; August 4, 2021; September 9, 2021; September 15, 2021. Each time Council Members Woten and Santana voted yes while Council Members Thiara and Ghag voted no.

Council meeting, the City Council passed the 2021-2022 Annual Budget by a vote of 4-0. It is to note that the original budget that was presented to the City Council on June 29,2021, for approval was the same that was passed at the December 20, 2021, Council Meeting. There were no changes between the original presented budget and the budget that was adopted.

F3 – The City Council of Live Oak scheduled a budget workshop to resolve the budget deadlock, but all members of the Council did not attend.

Response: Agree. At the request of Council Member Thiara, a Budget Workshop was scheduled for June 29, 2021. Council Members Woten and Santana attended; however, Council Members Thiara and Ghag did not attend. The Grand Jury did commend the two Council Members who took part in the scheduled budget workshop as well as commended them in making a great effort to work cooperatively with the rest of the Council.

F4 – The City Council of Live Oak did not pass the authorization to collect the annual CFDs and special assessments by September 2021, therefore these could not be added to the tax

Response: Agree. The 92-1 and 2004-1 CFDs were presented to the City Council for adoption on August 4, 2021 and failed on a 2-2 vote. Council Members Woten and Santana voted yes while Council Members Thiara and Ghag voted no.

The special assessments were presented to the City Council for adoption on September 1, 2021 and failed on a 2-2 vote. Council Members Woten and Santana voted yes while Council Members Thiara and Ghag voted no.

F5 - This year's CFD taxes could not be collected. This has cost the City over \$800,000 in budget reserves.

Response: Agree. CFDs were presented to the City Council for adoption. Council Members Woten and Santana voted yes while Council Members Thiara and Ghag voted no, resulting in over \$800,000 in lost Revenues. Instead of the City taking funds out of the general fund, the City used the ARPA funding to make up the difference for the lost revenue.

mendations to the City of Live Oak. These were outlined in the response from the City of Live Oak to the Grand Jury.

R1: The City Council of Live Oak will pass the budget in a timely fashion.

Response: The recommendation has been implemented. The City Council passed the 2022-2023 Annual Budget ahead of schedule on May 18, 2022, by a vote of 4-1. This is approximately 6 weeks before the State's deadline to have such budgets adopted.

R2: The City Council of Live Oak will establish budget workshop dates with sufficient time to resolve any concerns prior to voting on the budget resolution.

Response: The recommendation has been implemented. The FY 2022-2023 Annual Budget had three workshops. Those dates were: March 30, 2022; April 6, 2022; and April 20, 2022.

R3: All members of the City Council will participate in any budget workshops to understand the proposed budget and to discuss areas of concerns.

Response: The recommendation has been implemented. All five Council Members attended all three budget workshops for the FY 2022-2023 Annual Budget.

R4: The City Council of Live Oak will pass the authorization to collect the annual CFDs and special assessments in a timely manner, so that these levies can be added to the current year's tax rolls.

Response: The recommendation has been implemented in part. The CFD's 92-1 and 2004-1 were adopted for collection at the August 3, 2022, City Council meeting by a vote of 3-2. The special assessments will be placed on a City Council meeting for adoption once received by the Sutter County Assessor's Office.

Insurance Commissioner's Moratorium Protects Homeowners

SACRAMENTO, CA (MPG) - As California continues to battle wildfires throughout the state, Insurance Commissioner Ricardo Lara ordered insurance companies to preserve residential insurance coverage following Governor Gavin Newsom's latest emergency declarations. The Commissioner's Bulletin shields those policyholders within the wildfire perimeter or in adjacent ZIP codes of the Mountain, Barnes, and Fork fires in Siskiyou, Modoc, and Madera counties from insurance non-renewal or cancellation for one year from the date of the Governor's September 19th declaration regardless of whether they suffered a loss.

"This law gives wildfire survivors much-needed breathing room from having to immediately shop for insurance as they recover, while stabilizing the insurance market as well," said Commissioner Lara. "As wildfires continue to threaten our state, this one year of protection will give these hard-hit communities time and added incentive to protect their homes from future wildfire disasters. My Department and I will be there from day one of recovery until the job is done and communities are safer."

Today's moratorium order includes 30 ZIP codes in the Siskiyou, Modoc, and Madera counties, affecting approximately 31,000 wildfire survivors.

Consumers can go to the Department of Insurance website to see if their ZIP code is included in the moratorium. Consumers should contact the Department of Insurance at 800-927-4357 or via chat or email at insurance.ca.gov if they believe their insurance company is in violation of this law, or have additional claims-related questions.

Commissioner Lara's ability to issue moratoriums is a result of a California law that he authored in 2018 while serving as state senator in order to provide temporary relief from insurance non-renewals and cancellations to residents living within or adjacent to a Governor-declared wildfire disaster. Since 2019, Commissioner Lara's actions have protected nearly 4 million homeowners, including over 363,000 to date in 2022.

The Commissioner's action is part of a larger solution he is pursuing for consumers and wildfire survivors that includes working to increase insurance protections and market competition to help protect consumers. Commissioner Lara's actions since taking office in 2019 include:

Announced "Safer from Wildfires," a new insurance framework that incorporates wildfire safety measures to help save lives while making homes and businesses more resilient. Safer from Wildfires was created by a first-ever partnership between the Department of Insurance and the emergency and preparedness agencies in Governor Newsom's Administration, including the Department of Forestry and Fire Protection (CAL FIRE), the Governor's Office of Emergency Services (CalOES), the Governor's Office of Planning and Research, and the California Public Utilities Commission.

Proposed a new regulation to incorporate Safer from Wildfires in insurance pricing, driving down costs for consumers who have taken actions to protect their communities while increasing transparency about their home's or business's 'wildfire risk score." This regulation is in its final step towards adoption.

Sponsored new insurance protections igned into law by Governor Newsom despite opposition from insurance companies — that will mean larger payouts for some consumer claims, less red tape from insurance companies, and more help for people under evacuation orders.

Ordered the FAIR Plan, the state's insurer of last resort, to offer a more comprehensive homeowners policy as an option, which a judge has upheld, as well as increasing residential and commercial coverage limits for the first time in 25 years to keep pace with inflation and rising costs.

Following Governor Newsom's state of emergency declaration, the Department of Insurance partners with the CAL FIRE and CalOES, pursuant to existing statute, to identify wildfire perimeters for mandatory moratorium areas. The Department of Insurance will continue to collaborate with CAL FIRE and CalOES to identify additional wildfire perimeters for any fires where there is a declaration of a state of emergency.

The mandatory one-year moratorium announced today covers approximately 31,000 residential policies in ZIP codes located within or adjacent to the Mountain, Barnes, and Fork fires under Senate Bill 824 (Lara, Chapter 616, Statutes of 2018), also known as the "Wildfire Safety and Recovery Act."

On September 19, 2022, Governor Newsom proclaimed a state of emergency in Siskiyou, Modoc, and Madera counties due to the Mountain, Barnes, and Fork

The 2018 law established protection for those living within or adjacent to a declared wildfire emergency whether they suffer a loss or not — recognizing for the first time in law the disruption that non-renewals cause in communities following wildfire disasters. Homeowners who suffered a total property loss have up to 24 months of protection from non-renewal or cancellation.

Government Disclosed Jan. 6 Activities of 5 Confidential FBI Sources: Defense Lawyer

The U.S. government has acknowledged for the first time that five FBI confidential informants were involved with the Oath Keepers on Jan. 6, 2021, but prosecutors failed to disclose that none of the sources provided evidence of guilt, a defense lawyer said on Sept. 26.

FBI officials have repeatedly declined in congressional hearings to say whether there were agents or confidential human sources (CHS) in the crowd when the U.S. Capitol was breached on Jan. 6. But in pretrial communications in the Oath Keepers' seditious conspiracy case, prosecutors disclosed that there were five sources informing on the Oath Keepers, David Fischer, who is representing defendant Thomas Caldwell, said in the new filing.

"What the Government knew—but only recently disclosed to the Defendants—was that none of the CHSes provided evidence of guilt on the part of the Oath Keepers as an organization, or the individual Defendants in this case," Fischer said.

He said the fact was confirmed by the government telling defense lawyers that only one of the informants will take the stand during the Sept. 27 trial of former Oath Keepers leader Elmer Stewart Rhodes III and four others, including Caldwell.

Top FBI officials have declined to answer questions on how many, if any, informants were at the Capitol around the time of the breach.

"I can't answer that," Jill Sanborn, the FBI assistant director for national security, told Sen. Ted Cruz (R-Texas) during one hearing.

But prosecutors in a recent motion disclosed that multiple sources have been involved in the investigation into the Oath Keepers, a group comprised of former and current members of the military, law enforcement, and first responders.

"At trial, the government or defense may call to testify certain CHSes who were either involved in the investigation that led to prosecution of the defendants, or who became CHSes subsequent to the initiation of the instant investigation," prosecutors said in the motion, which asked U.S. District Judge Amit Mehta, an Obama appointee overseeing the case, to impose a protective order.

Prosecutors want defense lawyers barred from asking any questions seeking personal identifying information from any informant witnesses, including their date of birth; any questions about the Members of the

witnesses' participation in investigations outside of the probe in question; and any questions about training in the FBI's CHS program.

"The protections requested herein, while minimally restrictive, would ensure the integrity of any ongoing investigations and would reduce the security threat posed to any testifying CHSes," prosecutors said in the filing, which has not yet drawn a ruling from Mehta.

'Rhodes Plan'

Prosecutors contend that Rhodes and his co-defendants engaged in a seditious conspiracy to attack the Capitol on Jan. 6 and prevent the counting of Electoral College votes for the 2020 presidential election.

The federal indictment charges the Oath Keepers with stockpiling firearms in a Virginia hotel for use by quick-reaction forces to attack the Capitol. Rhodes has said the weapons were legal and for use only if President Donald Trump invoked the Insurrection Act and raised a militia to guard against Antifa.

None of the informants, however, reported the existence of a "Rhodes Plan" and all of the sources have denied knowing any information about it when questioned by FBI handlers after Jan. 6, 2021, Fischer said, citing disclosures by the government to defense lawyers.

"The potential testimony of these CHSes, along with the corroborating testimony of their FBI handlers, will establish either 1) that the 'Rhodes Plan' was so secret that even members of Oath Keeper leadership who interacted regularly with Defendant Rhodes and others alleged to have been involved were kept in the dark both before and after January 6, or 2) that there never was any such 'Rhodes Plan," the defense lawyer said.

"The defendants are entitled to examine the totality of the Government's investigation and prosecution for the purposes of undermining the jury's confidence in the work done and the conclusions reached by the agents and prosecutors over the course of the past 20 months," Fischer added.

The FBI chose to ignore the exculpatory information and has, with prosecutors, "reverse-engineered' the existence of such a 'plan' through selective use of

'evidence' it has cherry-picked out of context, while ignoring all evidence to the contrary," the filing states.

The FBI has declined to comment on court cases, referring requests for comment to the Department of Justice, which has said it doesn't comment on ongoing cases.

Mehta recently granted a different motion, which asked to withhold certain information on civilian witnesses, after he reviewed the information behind closed doors. The judge said the information wasn't relevant to the trial.

The FBI chooses to use CHSes knowing that the sources might be cross-examined by defense lawyers in criminal cases and defendants want to probe "relevant information," such as the reliability and accuracy of information that originated with a CHS, Caldwell's lawyer said.

"The Defendants, moreover, do not intend to elicit testimony from a CHS for the sole purpose of exposing the CHS to possible retribution or otherwise place his or her safety at risk. However, given the physical proximity of certain CHSes to the Defendants, cooperators, and unindicted coconspirators in this case, it is unrealistic to seek to prevent the geographic location of a testifying CHS from becoming known as a result of testifying in this case," Fischer added.

The piece in the government motion on preventing questions on the FBI CHS program also runs counter to the Supreme Court's ruling in Kyles v. Whitley, according to the defense. Lawyers want Mehta to reject that and all other portions of the government's motion.

Conservative Group Asks IRS to Deny Tax Exemptions to Zuckerberg for 2020 Election Grants

A conservative activist group has filed a complaint with the IRS asking the agency to deny personal tax exemptions for Mark Zuckerberg and his wife, Priscilla Chan, arising from the couple's funding of grant programs to help municipalities pay for the 2020 general election.

In a second complaint, the Center for Renewing America (CRA) requested the removal of tax exemptions for three Zuckerberg-supported non-profits: the Center for Tech and Civic Life (CTCL), the

Center for Election Innovation & Research (CEIR), and the National Vote at Home

Institute (NVAHI).

The complaints allege that the Zuckerbergs and the three organizations pumped almost \$500 million into the 2020 election process in an effort to influence the outcome in favor of candidate Joe Biden and other Democrats.

CTCL alone distributed nearly \$350 million in grants to local election departments with a stated mission of helping them conduct safe elections during the first year of the COVID-19 pandemic.

"Mark Zuckerberg, through various non-profit organizations, contributed hundreds of millions of dollars towards efforts to rig the 2020 election," the CRA wrote in a Sept. 22 Twitter post. "Today, we filed TWO formal IRS complaints against Zuckerberg to call him on this ILLEGAL activity."

CTCL brushed off similar allegations from conservative groups in December 2021 as "disinformation," stating in its final report on the 2020 COV-ID-19 response grant program that "partisan considerations played no role in the availabil-

ity or awarding of funding."

The report states that nearly 2,500 election departments spread over 49 states received grants ranging from \$5,000 to \$19 million.

For years, conservatives have accused the Zuckerbergs and the three organizations of directing millions of dollars in grant funding to Democratleaning localities.

They allege that most of the money was spent on voter registration drives and get-out-the-vote efforts in the large cities of several swing states instead of on public health.

Statistics published by CTCL

show that the city of Detroit, a Democrat stronghold, received more than \$3.5 million in grant money in the runup to the 2020 presidential election, while most Republican-dominated jurisdictions received \$5,000 grants or nothing at all.

Data from CTCL's report demonstrates that in Michigan, the top nine Democrat strongholds of Detroit, Flint, Pontiac, Lansing, Saginaw, Ann Arbor, Muskegon, Kalamazoo, and Benton Harbor received a combined \$6.4 million in CTCL grant funding, representing 86 percent of the \$7.4 million in grants distributed in Michigan.

Mark Zuckerberg couldn't be reached for comment. Representatives for CTCL, CEIR, and NVAHI didn't respond by press time to a request from The Epoch Times for comment.

Drought takes an economic toll on Northern California rice region

Rice farming is the economic lifeblood for towns such as Williams, Maxwell and Colusa in Colusa County and Willows in Glenn County. The Northern California region is now suffering as fields lay fallow. Farms in the Glenn-Colusa Irrigation District planted just 1,000 acres of rice this year due to water shortages. They typically grow 100,000 acres. Drought impacts are expected to result in the loss of some 14,300 jobs and \$1.3 billion in economic profit, according to the University of California, Davis.

Water year ends with reservoirs low and La Niña threatening another dry season

California's bleak 2021-22 water year officially ends on Sept. 30, with hope for the future still elusive. The California Department of Water Resources says another parched year may be in the works. That's because of a continuing La Niña atmospheric phenomenon in the Pacific Ocean, which generally translates to more warm, dry conditions. This week, Lake Shasta, the largest reservoir in the federal Central Valley Project, stood at 59% of its historic average levels, less-than-promising

State Supreme Court declines to hear appeals on bumblebee status

Are bumblebees fish? That interpretation stands after the California Supreme Court declined to review legal challenges to California's designation that will give four bumblebee subspecies protection under the state Endangered Species Act. Agricultural groups argue that protections for the bumblebees could affect growing crops and grazing, herbicide and pesticide applications, and use of commercial honeybees to pollinate crops. The Supreme Court signaled that it is up to lawmakers – and not the courts – to provide clarity on the rule.

Researchers turn to satellite technology to gauge water use in Central Valley

Researchers at the University of California, Merced, are turning to drones and NASA satellite technology to quantify water use in the Central Valley. Professors Erin Hestir and Joshua Viers are working with scientists at a Bay Area nonprofit, Point Blue Conservation Service, to gather data to help regional water resource agencies needing information on groundwater levels. They are partnering with the Grassland Water District, which manages 75,000 acres of wetlands in Merced County.



Today's Debt Yield

A few weeks back I detailed the rising rates on U.S. guaranteed debt instruments and how investors might take another trip down to their local bank and ask about current CD and savings rates. With interest rates on bank products sneaking up in response to the FED increasing the overnight rate three times in an attempt to rein in inflation, investors are starting to wake up to the fact that the typically anemic rates at their local bank and credit unions are creeping up and might be worth taking another look at.

In an event called an "inverted yield curve', analysts are noting that when it occurs, it has been a dependable indicator a recession is on the horizon. But the inverted curve also has a bright spot for investors.

The U.S. government finances it's spending by issuing IOUs securities called Treasuries, bills, notes and bonds. The different names indicate the length of the time before you get your money back. Simply put, you "buy" the debt and the U.S. in essence borrows your money and the receipt are these securities.

Which debt issue you select is based on how long you wish to loan out your money for.

Those familiar with CDs, bonds and treasuries know that a 10 year debt issue normally pays more than a 30 day debt issue. The higher payment (the interest you get) for the longer terms is because you are making a longer commitment.

Right now, in some instances, the interest you get versus how long you normally wait before being paid is inverted, hence the name "inverted yield curve".

For example, right now, if you agree to loan your money out for two years, you might get more then if you committed to ten.

Wha?

Today's rates are definitely an aberration as it relates to normal usury rates (what you get paid for how long you lend your money out). You get more interest the longer you agree to hold the debt.

Not so right now, at least between certain time frames. Two year loans may pay you more than a ten year loan. This means in technical terms we have an inverted yield curve.

This rare occurrence is because buyers of debt are nervous about the outlook of the economy and are piling into the longer term debt instruments, such as the ten year bond. This is because they are unsure about the near term future of the stock market and are looking toward U.S. guaranteed securities to protect principal.

Higher demand for debt instruments like

bonds and T-bills means the sellers of this debt don't have to pay as much interest to entice buyers.

In essence, strong demand for the longer term bonds means lower interest needs to be paid and yields drop. Meanwhile the interest rate on two years might remain the same or even rise. This drop in the ten year note interest payments while the two year remains the same means you might make more money by buying a two year all the while getting your money back sooner.

This would suggest that, at this moment in time, while the yield curve is inverted, investors might take a look at CDs, savings accounts or Treasuries, which are short term based, and get a decent yield without committing money for 2 or 3 decades.

Savings accounts versus CDs yield curves is still normal, so savings, which are on-demand accounts, (meaning there is no time commitment) are paying less than a one month, two month or a six month Treasury, but overall it could be said rates are definitely above the near zero rates we all remember on savings, CDs and short term Treasuries.

Searching the latest Treasury and CD prices on an advisor screen as of late last week, I was seeing one month rates well north of 2% and three months well above 3% APR. Keep in mind rates can change daily and the above are only non-binding estimates.

The bottom line is U.S. 100 % guaranteed bank debt such as savings, Treasury department issued debt and CDs may be offering rates that could be worth considering for risk adverse investors that want to avoid the stock market at this time.

Parking funds in U.S. government guaranteed issues will at least provide some yield while you wait for some clarity and normalcy in today's markets.



California Refusing to Release School Test Results

California's Department of Education has finally acknowledged the obvious: It is arbitrarily delaying the release of results from this year's round of academic testing.

In years past, scores from the spring Smarter Balanced tests of academic achievement have been released in late summer or early fall, but this year, the department denied a request for statewide results even though it authorized individual districts to make their data available.

Why?

Mary Nicely, chief deputy state superintendent for instruction, told EdSource, a website devoted to California education issues, which had requested the data, that the numbers would be released as part of a "dashboard" that includes other "metrics" on how schools are performing.

"We are on track to release the data as we did last year. If we can come out sooner, we will," she said. "We are not withholding anything; people are working hard to finalize the data."

That doesn't wash.

There's absolutely no reason that data already given to school districts should not be made public now and included in the "dashboard" later.

It's likely that the test results will show a sharp decline in the abilities of California's school children in basic skills, such as reading and math, due to the state's shutdowns of schools during the COVID-19 pandemic.

State officials probably want to sugarcoat the bad news by delaying it until after the Nov. 3 election and combining it with other material that would dilute its importance. Tony Thurmond, the state schools superintendent, will be on the ballot along with Gov. Gavin Newsom and other Democratic officeholders and while all are favored to win re-election, bad news on schools would be embarrassing.

We know that the groupost-pandemic test results

are likely to be disappointing. That's been the pattern in other states. Los Angeles Unified has already released its quite negative test results, reversing about five years of gradual progress in the state's largest school system.

In LA Unified, about 72% of students did not meet state standards in math, five percentage points higher than pre-pandemic testing. In English, 58% were subpar, two points higher.

"The pandemic deeply impacted the performance of our students," said LA Unified Supt. Alberto Carvalho. "Particularly kids who were at risk, in a fragile condition, prior to the pandemic, as we expected, were the ones who have lost the most ground."

If LA Unified had

enough guts to tell its voters and parents the harsh truth, there's no valid rationale for Thurmond not to do so for the entire state.

After its request for statewide results was denied, EdSource pressed the issue with a letter from its attorney requesting reconsideration.

"EdSource considers delay tantamount to denial as it effectively robs the public of its vital role in overseeing the CDE (Department of Education) and individual districts and in holding both accountable to its students and the public. This is especially important during what continues to be one of the most challenging and impactful times to our educational system due to the COVID pandemic," EdSource attorney Duffy Carolan

EdSource's letter told the Department of Education that it "cannot identify any 'public' interest in non-disclosure that could justify its denial position, let alone an interest that 'clearly outweighs' the substantial public interest in access to this information."

This is not only a politically tinged education issue but a major test for the state's Public Records Act, which allows public agencies to withhold information only under extreme circumstances. If records can be withheld for obvious political purposes in this case, the Public Records Act might as well be junked entirely.

Chico Woman Sentenced for Murder in Hwy 70 DUI

Butte County DA News Release

BUTTE COUNTY, CA (MPG) - A Chico woman was sentenced in Butte County Superior Court on Friday, August 26, 2022, for second-degree murder involving her drunken high-speed collision with another motorist on Highway 70 last year.

On February 4, 2021, at 11:25 p.m., Nicole Schalles, 36, of Chico, was driving her vehicle north on Highway 70 at speeds over 120 mph when she ran into the rear of another northbound vehicle on the road. The collision happened near Lower Honcut Road killing Dollar Vang, 30, of Olivehurst. Vang had been traveling from Olivehurst to work a night shift in Oroville when Schalles' vehicle overtook his as she traveled from Marysville back to Chico. When Schalles hit the rear of Vang's vehicle, it caused Vang's vehicle to spin into the opposite lane of traffic. Another vehicle traveling in the opposite (south) direction then hit Vang's vehicle. Vang died from injuries sustained in the crash, and the driver of the other southbound vehicle sustained a broken collarbone.

Butte County District Attorney Mike Ramsey said Schalles had purchased a bottle of vodka earlier that morning and drank most of it throughout the day before she left her home in Chico after 7:30 p.m. Schalles then drove to two bars in Marysville to drink and buy illegal opiates. An analysis of her blood revealed that Schalles' blood alcohol content was more than three times the legal limit and showed the presence of oxycodone in her system.

Ramsey said Schalles was previously convicted of a DUI in 2012 during which time she was ordered into alcohol programs as well as a DUI School. Schalles described herself as being involved in Alcoholics

Anonymous for at least 10 years before the collision. However, Ramsey said, Schalles was involved in a single car collision in 2019 that she later admitted occurred while she was drinking.

Ramsey said the murder charge resulted from Schalles having been previously warned during her prior DUI case and in subsequent DUI classes that should she drive under the influence and cause a death, she could be charged with murder. This subjective knowledge of the dangers of drinking and driving, and the grossly negligent nature of the recent collision with Vang, ultimately resulted in Schalles' murder conviction for the death of Vang.

At the sentencing hearing, Vang's family members addressed the court and provided insight into the life Vang had lived before being killed by Schalles. Vang was a father, brother, uncle, son, and friend and family members made it clear his death will impact the lives of the living forever. As one family member stated:

"Dollar was an amazing person and he had a bright future ahead of him. He had dreams that he was unable to accomplish because [Schalles] stole that from him. Dollar was a great father to his children, and he was excitedly waiting for the birth of another child. He did not even know the gender at the time [Schalles] took his life...All that was taken away from him."

Schalles was sentenced to 15 years to life in prison. Under recent California prison policy, she will be eligible for parole in 10 years. Additionally, restitution was awarded to family members of the victims for expenses associated with their participation in the court process, travel expenses, and future child support for Vang's two minor children.

Indians Get Fresh with Rotations in First League Win

MARYSVILLE, CA (MPG) - The Marysville Indians varsity football team picked up their first Pioneer Valley League (PVL) win Friday night, September 30, as they beat the Colfax Falcons 26-7.

Marysville (4-2, 1-1 PVL) already has the same number of PVL wins that they have achieved every year since the 2018 season. The Indians haven't won more than one game in the PVL since 2017, when they won three.

Marysville coach Will Claggett told the Territorial Dispatch after a 35-0 loss at Sutter on September 16 that he wanted to focus on getting more players into the game through player rotations.

"We did that," Claggett told the Dispatch. "We added 10-12 more guys than what we normally play."

The Indians split the carries primarily between four senior players that included running backs Danny Lanini, Joe Endicott, fullback Luke Harryman and quarterback Kayden Ellyson.

The four seniors had nine carries each for Marysville, combining for 43 of the team's 47 rushing attempts and 291 out of 297 rushing yards. Claggett told the Dispatch that the extra depth and constant rotations kept his players fresh and they weren't gassed by the time the fourth quarter came around.

The leading rusher for the Indians against

Colfax (3-3, 1-2 PVL) was Ellyson with 13 carries for 140 yards and two scores. One of the senior's two scores came on a 53-yard rushing touchdown where he wiggled through a bunched pile at the line and darted to the end zone when he was able to break free.

Lanini, who is second on Marysville in rushing yards and carries for the season, contributed 99 yards and a touchdown on 12 carries.

Endicott is the leading rusher for the Indians in multiple categories that include yards (592), carries (97), and rushing touchdowns with nine. He had a quiet night Friday as the senior added nine carries for 22 yards and a score against the Falcons.

Harryman pitched in nine carries for 30 yards on the ground. Claggett told the Dispatch that he noticed a big difference in his team's stamina during the games against Colfax and Sutter.

Marysville has not made the playoffs since the 2016 season when they were eliminated in the semifinals of the California Interscholastic Federation (CIF) Sac-Joaquin Section (SJS) Division V playoffs.

The Indians have four PVL games remaining and were projected on September 26 by MaxPreps to make the CIF SJS Division VI playoffs as an at-large entrant.
