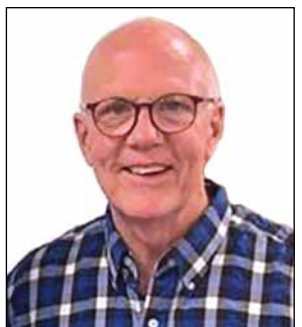

## The Need for a Newsom-Dahle Debate

*A debate would allow Californians to hear perspectives they don't usually hear*

With less than two months to go until the 2022 election, most races already have all the major events lined up. For many of the bigger and closer races, things like rallies with well-known lawmakers and celebrities can be key. But the biggest event, the one where the opponents square off against each other, is the crown jewel for many. Debates can make or break

candidates and provide a forum to really show what kind of person they will be while in office. Plus they offer potential huge jumps in polls.

Despite most races debating this year, there remains a glaring exception: The gubernatorial race. Even a cursory search online finds not even a mention of it, with Senator Brian Dahle (R-Bieber) continuing to ask for a debate as recent as a few weeks ago. "My biggest challenge obviously is to get known in California," said Dahle last month. "That's a positive for me. The challenge for me is to get that message out. We'd love to have a debate with the governor."

However, despite it being such an important race for California, many have questioned if it was even needed this

year. Polls show Governor Gavin Newsom currently leading Dahle by more than a 2-to-1 advantage, 52% to 25%. The same poll found that 58% of all voters simply had no idea who Dahle even was. With Dahle down by so much, then why bother?

Many political experts, however, reason that a debate is needed due to many factors.

"First of all, it would allow Californians to hear perspectives they don't usually hear," explained Justine Rollins, a political advisor and debate organizer, to the Globe on Monday. "With the internet, a lot of people stay in their political echo chamber and just go with the party or whoever the incumbent is. Debates allow candidates to freely express their ideas and what they would do without any added commentary

minus a rebuttal or two."

"Second, it would give political accountability. Candidates say and promise a lot of things during debates. This would effectively make them be accountable in the future, especially when campaign slogans are invoked. And another big reason is that they can melt partisan lines. California has a huge Democratic bloc of voters. Huge. And we have seen in previous debates that this melted somewhat after a debate. That age old saying that debates don't matter because by the time they happen most people have made up their minds? That is by no means a fact. Debates can change the outcome a bit. In 1992 for example. A third party candidate, Ross Perot, was added to the presidential debates, and he always got a big boost after them."

## Undercover Agents Make Arrest at Walmart Parking Lot

Net-5 Release

**YUBA-SUTTER REGION, CA (MPG)** - On August 30th, 2022, at approximately 3:15 pm, members of the Yuba Sutter Narcotic and Gang Enforcement Task Force (NET-5) with the assistance of the Sutter County Sheriff's Office Investigations Division and the Yuba City Police Department contacted and arrested Jakiem Gerard Halstead (24 years old of Yuba City) in the parking lot of Walmart, located at 1150 Harter Parkway. Jakiem Gerard Halstead was found to be in possession of 15.40 grams of cocaine which he possessed for the purpose of sales. Undercover NET-5 Agents had been in contact with Jakiem Gerard Halstead prior to the arrest and he agreed to sell undercover agents the suspected cocaine. Jakiem Gerard Halstead was immediately taken into custody when he arrived at the predetermined meet location. Jakiem Gerard Halstead was driven to the location by a subject believed to be his father and identified as, Samegod Allah Halstead (46 years old of Sacramento), who was eventually released from the scene.

Jakiem Gerard Halstead is a previously documented member of a local subset of the Blood criminal street gang known as 'SGE' or 'The Slim Gang.' Jakiem Gerard Halstead was on active Parole with the California Department of Corrections and Rehabilitation (CDCR) at the time of the incident. According to the CDCR, Jakiem Gerard Halstead was released from prison on July 29th, 2022, after serving just 2 years and 11 months of his 9 years 8-month commitment. Jakiem Gerard Halstead had pled guilty in Sutter County Court to charges of Assault with a Firearm, per 245(a)(2) PC and Gang Enhancements, per 182.22(a) & 186.22(b)(1) of the California Penal Code, in August of 2019 for his involvement in a gang related shooting which occurred in Yuba City and resulted in one person shot.

According to the Sutter County District Attorney's Office, CDCR had previously notified them in writing of an early release hearing for Jakiem Gerald Halstead. In March of 2022, the Sutter County District Attorney's Office responded to CDCR, in

# Indians Duo Runs over Bulldogs Late in Second Half to Improve to 3-1

**MARYSVILLE, CA (MPG)** - The Marysville Indians controlled the second half in their 27-13 win over the Gridley Bulldogs on Sept. 8, to improve to 3-1 on the season.

Marysville (3-1) got on the board first in the first quarter after senior running back Joe Endicott scored on a 3-yard rushing touchdown, the first of his two touchdowns on the night.

Endicott ended the game with 63 yards on the ground from 12 rushing attempts.

Gridley (1-1) tied the game up at 6 late in the second half after a long 90-yard offensive drive that took a good chunk of the time in the second quarter.

Bulldogs sophomore quarterback Gus Stogsdill led the long drive until senior running back Luis Corona capped it off with a 4-yard touchdown rush.

“Coach mixed in a lot of good plays,” Stogsdill said. “The blocking was well executed, and everyone ran hard.”

Gridley didn’t have the same momentum to start the second half as they had two consecutive three-and-out possessions and gave the ball back to Marysville.

Bulldogs head coach, Matt Kemmis, said he thought his team had the momentum after the long drive to end the first half and it would

carry over to the second half.

“There were some fundamental things that didn’t happen for us,” Kemmis said.

The Indians capitalized on their first two possessions of the second half when senior running back Danny Lanini powered his way into the end zone from six yards out to end the first.

Endicott bursted open on the second drive with a 30-yard touchdown rush that gave Marysville a 20 - 6 lead with three minutes left in the third quarter.

The Indians backfield are electric and feed off one another’s energy.

“It’s nice to have a brother that can run the ball as good, if not better,” Endicott said.

After the ensuing kickoff, two of the stadium lights went out which caused a 25-30 minute delay.

During the delay, Marysville head coach Will Claggett said the main focus was to keep his teams’ legs fresh and drink plenty of water.

After the delay was over, Gridley was able to put a long drive down the field before they turned the ball over on downs deep in the Indians 10-yard line.

Marysville didn’t look back as Lanini scored on an 89-yard rushing touchdown that gave the Indians a 27-6 lead with a little more than seven minutes left in the game.

“It was an outside play, but coach told me to adjust to it, hit the open hole and go for it,” Lanini said.

He added that he and Endicott have been running the ball together since playing Pop Warner together and that was only excluded in their freshmen year together when they had to play other positions.

The Indians will open league play at the Sutter Huskies tonight.

This is the first meeting between the two teams since the 2017 season and the first season for the Huskies in the Pioneer Valley League.

Claggett said one of his main goals throughout the game was to remain healthy for their league debut tonight and he succeeded that.

The Bulldogs scored a late touchdown in the fourth quarter when senior running back Aiden Gomez ran into the end zone for a 1-yard rushing touchdown.

Gridley will be on the road tonight as they travel to play the Live Oak Lions for the yearly coveted Harvest Bowl.

The Bulldogs have held onto the Harvest Bowl trophy from their cross-town rivals since the 2013 season where they have won the yearly match-up besides 2020, where there was no game scheduled.

“It’s always competitive when it’s a rivalry game,” Kemmis said. “You never know what’s going to happen.” ★

# Lions Scorch Blazers in Turnovers to Move to 3-0

**LIVE OAK, CA (MPG)** - The Live Oak Lions improved to 3-0 on the season last Friday as they dominated the Lindhurst Blazers in a 48-0 victory.

Live Oak forced a total of six turnovers throughout the game that consisted of four fumble recoveries, an interception and they forced a turnover on downs.

The Lions now have a total of 9 takeaways through their first three games of the season.

Live Oak head coach, Robert Tilton, said his defense made a lot of plays at the line of scrimmage.

The Lions defense has posted two consecutive shutouts and gave up 13 points in their first game against Biggs.

The Live Oak defense is led by senior outside linebacker Sammy Khan.

“We work everyday hard and as a family,” Kahn said.

Kahn is the team leader in tackles on the season so far with 31.

As impressive as the Lions defense, their offense has rushed for 824 yards this season, according to MaxPreps.com.

Live Oak has two premier running backs in junior Eben Jones and senior Raul Romero.

Romero had a total of two touchdowns on the night that included rushes of 1 and 63 yards.

Romero rushed the ball four times for a total of 88 yards.

“With the Wing-T offense, getting up to the ball quickly puts a hurt on the defense,” Romero said. “If we’re able to do that, the holes begin to open up more and more.”

Jones ended the first quarter with an electric 85-yard touchdown rush.

Jones ended the game with 114 yards on three carries.

“I look for my holes and I hit them,” Jones said.

The Lions first three possessions were in the Blazers territory.

The only bright spot for Lindhurst throughout the game that Live Oak struggled with defensively was the deep ball coverage.

The Blazers had a few deep balls that were thrown where Lindhurst receivers were able to jump up in the air and catch the ball well over the head of the Lions defenders.

Anytime the Blazers would get any momentum on a drive, the Live Oak defense created a turnover instantly.

The Lions led 35-0 at the end of the first half. The officials signaled for the running clock to begin in the third quarter.

With the victory last Friday, Live Oak is off to its best start since the 2012 season, where they began 4-0.

The Lions will host their cross-town rival Gridley Bulldogs tonight in the Harvest Bowl.

“None of us have been able to do it (beat them),” Jones said.

He added that he was told by one of his coaches during a conversation to visualize having the trophy in his hand and being one of the players that contributed to bringing the trophy back to the city of Live Oak.

The Lions have lost every Harvest Bowl game since the 2012 season with exception of the 2020 season where there wasn’t a scheduled game to play.

Tilton said this game is going to be a good test for his team to start league play in a few weeks.

He added that although Gridley doesn’t have a lot of players on their roster, they have a lot of athletes that play well. ★

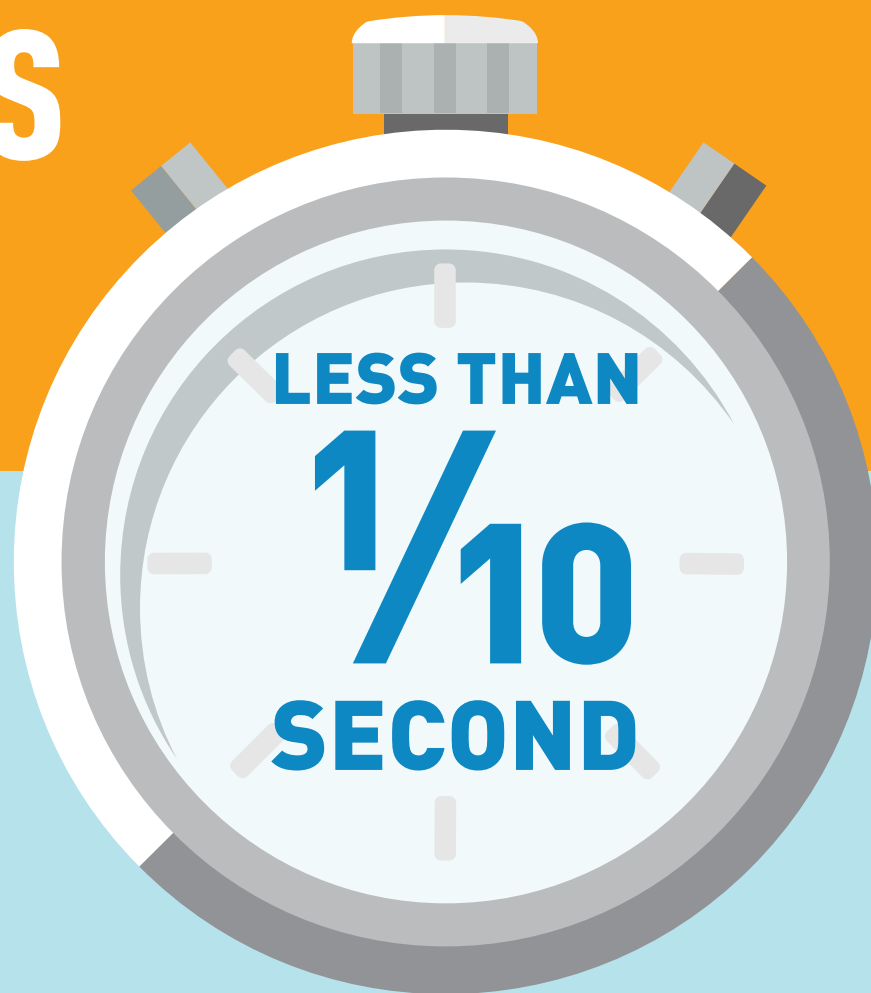

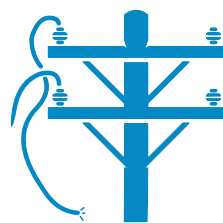

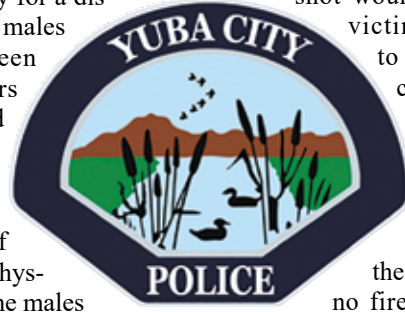

## Shooting at Yuba City Walmart Results in One Arrest, One Injured

**YUBA CITY, CA (MPG)** - On September 1, 2022, at 7:40 P.M., Yuba City Police officers responded to Wal-Mart in the 1100 block of Harter Parkway for a disturbance between three males and shots that had been fired. Once the officers arrived, they learned three males were involved in a physical altercation in the parking lot in front of Wal-Mart. During the physical altercation, one of the males pulled out a handgun and fired several gunshots at the other two males.

Yuba City Police Officers viewed surveillance video from Wal-Mart and were able to identify 18-year-old Karambir Gill, of Yuba City, as the person who shot the firearm. All three subjects fled the scene before law enforcement arrived.



A short time later, the Yuba City Police Department received a call from Adventist Rideout Hospital, who advised a 15-year-old male victim had arrived at the hospital suffering from a non-life-threatening gunshot wound. The male juvenile victim had self-transported to the hospital. During the course of the investigation, a search warrant was served in the 1100 block of Sam Rider Way in Yuba City in an attempt to locate Mr. Gill. At the conclusion of the search, no firearm was recovered, and Mr. Gill was not located. The third subject involved in the fight has not been identified.

### Drought, Freeze Take a Toll on California's 2022 Almond Yield

California's almond production is expected to drop by 11% this year, with the yield falling by 2.6 billion pounds. The state's continuing drought and a devastating February freeze in several almond-growing counties is to blame. The U.S. Department of Agriculture reported that \$35 million in indemnities were paid to state almond growers this year, with more than 90% of crop losses blamed on the freeze. Major Northern California almond counties, Colusa and Glenn, suffered respective crop losses of \$209 million and \$150 million.

### Purple Limes Stoke Discussion on Bioengineering

A new transgenic lime developed by scientists at the U.S. Department of Agriculture can dramatically change the tint of your next margarita. Ready for purple? The new purple lime is created by inserting the pigment gene from the blood orange into Mexican lime plants. USDA research geneticist Jim Thomson says the idea is to stir discussion over bioengineered products in hopes of gaining greater public acceptance. Bioengineering of citrus products is also seen as a potential guard against crop diseases, such as huanglongbing or HLB.

### California Union-Organizing Bill Reaches Governor's Desk

Gov. Gavin Newsom last year vetoed legislation that purported to make it easier for farm employees to vote for union representation. Newsom rejected Assembly Bill 616, a mail-order ballot measure criticized as a ruse to impose a card-check union-organizing system that could replace secret-ballot elections. Now he is considering an updated bill, AB 2183, which passed in the Legislature. The governor's office has expressed reservations, saying the bill lacks "critical protections" to safeguard the election process.

### Application Period Opens for \$2 Million in State Pollinator Habitat Grants

The California Department of Food and Agriculture is making \$2 million in grants available to help farmers and ranchers install pollinator habitat on agricultural lands throughout California. The grant application period for the Pollinator Habitat Program began Aug. 31 and ends on Nov. 23. The state Legislature last year set aside \$15 million for pollination efforts through such grant programs. Information is available on the Pollinator Habitat Program page of the CDFA website. ★



## Confusing Action in the Markets Continues to Plaque Investors

Although late last week saw some serious green in equity prices, confusing action in the markets continues to plague investors. Inflation has backed off a tad in only a few areas, gasoline being one of them. For the most part however, the bite of ever increasing prices is chomping at the checkbooks of consumers' worldwide.

Protests against higher prices are popping up in a handful of countries. The raising of interest rates by central banks worldwide to combat inflation is likely what is driving the markets.

In an interesting observation, the U.S. government seems to be doing battle with the Federal Reserve's war against inflation. While the Federal Reserve is trying to sop up excess cash in the system by raising rates and instigating programs to remove money from the banking system, Washington dumped about another 4 trillion onto U.S. consumers within the last two months through multiple spending programs.

Ironically, one of those programs was called the "Inflation Reduction Act."

You can't make this stuff up.

Because of this massive government spending, both past and present, various analysts are warning of more pain to come. This analyst agrees that inflation is far from tame.

At some point, all this inflation and interest rate chatter we hear on the news will cease to effect markets as investors yawn louder and louder with each news flash.

Historically, market participants become numb to the same bad news over and over again. That's when markets sometimes stop their reactionary descent and healing can occur as buyers finally step forward. I remind readers, for stocks to rise, the news doesn't necessarily have to be good, the news just has to stop being bad. We may not be there yet, but we getting closer with each passing day.

In world news, Queen Elizabeth II passed away September 8th. I don't think that will effect markets much but British investors may slow down a tad as the ten day mourning process begins.

More news on the electric vehicle (EV) market as startup companies both here and abroad stretch their pocketbooks into the red trying to catch EV leader Tesla. Investors often ask me if they should buy one or more of these EV startups in hopes of catching a Tesla like price explosion. My response is why buy a startup who's trying to catch a dominant leader in a difficult market as the automobile is.

In my opinion, not all EV newbies will survive. I recall the DeLorean Motor

Company startup which began in 1975 and ended seven years later. Its's very difficult to start an auto company, not to mention exorbitantly costly. My vote amongst the EV auto group remains with the industry leader, Tesla.

The housing market continues its slow motion train wreck with mortgage rates rising to levels not seen since 2008. Add in the damage to consumer pocketbooks from the worst inflation in 4 decades and home affordability is fast eroding.

Although not cratering as of yet, prices will soon start down as a dominoes fall into each other. (<https://www.newsweek.com/house-prices-go-down-prediction-economy-experts-1728298>). We are already seeing failures of some mortgage companies reminiscent of 2008. (<https://www.yahoo.com/now/us-mortgage-lenders-starting-bankrupt-120000031.html>).

Not to be undone however, mortgage lenders are back to offering low or no down payment loans, adjustable rate mortgages and lending to buyers whose income and credit status may be sub-par.

Oh boy, here we go again.

Bitcoin looked as if it was on its way to recovery after its recent fall into the 17,000's range. In my previous articles on Bit, I was of the opinion it was nowhere near done on the downside. With its recent retraction back under 20,000, I am still of the opinion Bit and coins like it are "vapor", run by folks of unknown repute, who are likely much smarter at computers than the majority of Bit buyers. All this with little oversight by governmental agencies.

A potentially lethal combination.

As we progress through September, I remind investors that this particular month holds the record for the poorest performance. Not that it will be again, but it has been. So far however, stock Armageddon hasn't occurred.

Hope springs eternal.

## Newsom Feels the Heat on Farm Labor Measure

Gov. Gavin Newsom will soon write a new chapter in California's decades-long conflict over the unionization of workers in the state's huge agricultural industry — and what he does could affect his obvious quest to become a national political figure.

Assembly Bill 2183, a measure that would make it easier for the much-troubled United Farm Workers' Union to organize farmers'

employees is sitting on his desk, passed by overwhelming margins by Newsom's fellow Democrats in the Legislature.

The union's drive for using a card check process or mailed ballots took on urgency when the U.S. Supreme Court declared in 2020 that it had no right to enter farmers' property to talk with their workers, exacerbating the UFW's chronic inability to make significant organizational inroads.

That failure, union leaders say, is due to farmers' undermining organizational elections, which now are conducted by secret ballot. However, the UFW has also suffered from its own organization shortcomings as journalist Miriam Pawel chronicled in her authoritative book, "The Union of Their Dreams."

Newsom vetoed an earlier version of the bill last year, saying, it "contains various inconsistencies and procedural issues related to the collection and review of ballot cards," and adding, "Significant changes to California's well-defined agricultural labor laws must be carefully crafted to ensure that both agricultural workers' intent to be represented and the right to collectively bargain is protected, and the state can faithfully enforce those fundamental rights."

This year's version contained some changes that the UFW and its allies hoped would placate Newsom, but just before final votes last month, Newsom once again indicated his opposition. "We cannot support an untested mail-in election process that

lacks critical provisions to protect the integrity of the election," Newsom spokesperson Erin Mellon said.

Newsom's unusual preemptive declaration may have been an indirect request that the Legislature not send him a second measure, but it didn't deter legislators from acting with 55 votes in the Assembly and 26 in the Senate.

If anything, it spurred the UFW to redouble its public campaign, including a highly publicized week-long march to the Capitol from Delano, site of a 1965 grape worker strike that led to formation of the UFW and in 1975 to passage of the state's Agricultural Labor Relations Act.

The UFW also formally joined the California Labor Federation after former Assemblywoman Lorena

Gonzalez took the umbrella organization's helm and obtained expressions of support from national political figures such as House Speaker Nancy Pelosi and, this week, President Joe Biden.

"In the state with the largest population of farmworkers, the least we owe them is an easier path to make a free and fair choice to organize a union," Biden said on Labor Day.

All of this puts Newsom in a political pickle.

If he signs the bill, he will not only be reversing himself on a high-profile issue — never good optics for an ambitious politician — but could be providing critics with ammunition should he someday be seeking presidential votes in agricultural states that are critical in White House contests, such

as Iowa, Ohio and Florida.

However, if he vetoes the measure, it could make it much more difficult for him to gain support in the Democratic Party's progressive/activist wing, to which unionization of workers in agriculture and other low-wage industries is a holy grail. Delores Huerta, the UFW's most revered figure, has predicted that Newsom would sign the bill because he'll want union support for a presidential campaign.

A veto would also mean that he would probably see another UFW bill next year and every other year of his governorship.

# Gallagher Tax Relief Bill for Wildfire Victims Heads to Governor

**SACRAMENTO, CA (MPG)** - Assemblyman James Gallagher's (R-Yuba City) effort to make PG&E wildfire victims' settlement payments tax-free cleared the legislature when the Assembly passed Assembly Bill 1249 with unanimous bipartisan support. AB 1249 will provide financial relief to wildfire victims by exempting them from

paying state taxes on settlement payments made out of PG&E's "Fire Victims Trust".

Gallagher said, "Victims deserve to receive the maximum amount of compensation possible from PG&E, especially since the trust is underfunded and not able to pay victims their full claims. I will continue to push for solutions to ensure victims are made whole."

"AB 1249 will be a huge boost for all the fire victims that

are still struggling to get their life back together. As they wait with uncertainty if they will have enough money to rebuild this will give them some hope and help to rebuild their lives," stated Steve Crowder, Mayor of Paradise.

Doug Teeter, Butte County Supervisor representing Paradise said, "Payments from the Fire Victims Trust are already going to be less than what many people are expecting due to PG&E's

stock price and the structure of the settlement. Providing income tax relief will help provide more financial resources to Camp Fire victims to help them rebuild and recover. It's the right thing to do."

PG&E's "Fire Victims Trust" was created to compensate victims of the 2015 (Butte), 2017 (North Bay) and 2018 (Camp) wildfires. AB 1249 will clarify California's tax code to allow all types of filers to be excluded from paying state taxes on

advance settlements paid out of the trust.

AB 1249 is joint authored by Senator Nielsen (R-Tehama) and has a large coalition of bipartisan co-authors. The bill now heads to the Governor's desk.

Assemblyman James Gallagher represents the 3rd Assembly District, which encompasses all of Glenn, Sutter, Tehama and Yuba counties as well as portions of Butte and Colusa counties. ★

# Henderson's Warning Ignored

A medical educator enlightened me early-on that Covid was the science name for the irritable "common cold." There are no effective vaccines for colds because by the time they are created and tested the bug has mutated. Why risk killing or crippling someone with a "warp-speed" toxic jab to temper a couple miserable weeks on earth.

Even after the virus was weaponized and released by Anthony Fauci, Ralph Baric, Peter Daszak, Francis Collins, Jeremy Farrar and their Wuhan Associates, safe and effective medications were still around to minimize its impact.

However, these good medications were media-smear and good doctors threatened by these medical Nazis with punitive measures for docs healing people.

The Covid miscreants noted above along with Deborah Bix and Robert Redfield then concocted the killer protocol of Remdesivir, use of ventilators, and discarding ill loved ones into nursing homes. They added stifling masks, closed schools, small businesses, churches and various support groups. Don't forget minimizing social interaction to break the human spirit.

It's like they wanted to create fear, panic, a mental health crisis, and break the spirits of youngsters. They hoped to kill or damage people of all ages. Hospitals were paid millions in bonuses to terminate and abuse patients, deny their medical rights and isolate them from families.

And they all knew exactly what they were doing.

Donald Henderson, who died in 2016, was an icon in the field of epidemiology and public health. In 2006, he gave prophetic warnings that were ignored

in March 2020.

Dr. Henderson was famous for a ten-year international mission from 1967-1977 that successfully eradicated smallpox. He then served as Dean of the Johns Hopkins School of Public Health from 1977 to 1990. Toward the end of his career, Henderson worked on national programs for public health preparedness and the response needed following biological attacks and national disasters.

In 2006, Henderson and his colleagues at the University of Pittsburgh Center for Health Security, published an analysis, "Disease Mitigation Measures in the Control of Pandemic Influenza," in the journal Biosecurity and Terrorism: Biodefense Strategy, Practice, and Science.

They studied options to curb the overall impact of a pandemic. This included a review of proposed biosecurity measures, later utilized for the first time during Covid - "large scale or home quarantine of people believed to have been exposed, travel restrictions, prohibitions of social gatherings, school closures, maintaining personal distance, and the use of masks."

Even assuming a Case Fatality Rate (CFR) of 2.5%, roughly equal to the 1918 Spanish flu but far higher than for Covid, Henderson and his colleagues concluded that these mitigation measures would do far more harm than good.

The best strategy would be isolating symptomatic individuals (but not those who had merely been exposed) at home or in the hospital, a strategy that had long been part of traditional public health. They also cautioned against reliance on computer modeling to suggest interventions. "No model, no matter how accurate its epidemiologic assumptions, can illuminate or predict the secondary and tertiary effects of particular disease mitigation measures." Furthermore, "If particular measures are applied for many weeks or months, the long-term or cumulative second and third order effects could be devastating socially and

economically."

The authors noted, "There are no historical observations or scientific studies that support the confinement by quarantine of groups of possibly infected people." They concluded, "The negative consequences of large-scale quarantine are so extreme (forced confinement of sick people with the well; complete restriction of movement of large populations; difficulty in getting critical supplies, medicines, and food to people inside the quarantine zone) that this mitigation measure should be eliminated from serious consideration."

"Travel restrictions, such as closing airports and screening travelers at borders, have historically been ineffective." Social distancing was also deemed impractical and ineffective.

During previous influenza epidemics, large public events were occasionally cancelled; but, the authors found no evidence "that these actions have had any definitive effect on the severity or duration of an epidemic," and "closing theaters, restaurants, malls, large stores, and bars... would have seriously disruptive consequences." The review offered proof that school closures would be ineffective and enormously harmful. They found no benefits of mask wearing outside the hospital setting.

Henderson and associates concluded: "Experience has shown that communities faced with epidemics or other adverse events respond best and with the least anxiety when the normal social functioning of the community is least disrupted."

For Covid, a devious and criminal agenda prevailed over science and medical sensibilities.

Yuba County Sheriff's Deputies and Detectives responded to the area and recovered the remains and additional personal belongings.

On August 29, 2022, Yuba County Search and Rescue conducted a search along Oregon Creek but due to the terrain, additional resources were required. Nothing else was located at that time.

On August 30, 2022, Yuba County Search and Rescue conducted an

extensive search along a cliff side off of Pike City Rd. During the search, they located additional human remains and a maroon GMC Acadia. The vehicle is registered to Dean Penn, who was reported missing in May of 2022. CHP responded and is handling the crash investigation. The Yuba County Sheriff's Office is currently in the process of identifying the remains by use of rapid DNA technology. Mr. Penn's family is working with detectives, to provide DNA for comparison. This investigation is ongoing and further information will be released when available. During the last non-recall Governor's race in 2018, a Newsom-Cox debate in October proved to give Republican candidate John Cox a bit of a jump in polls against Newsom.. In previous weeks, polls showed Cox in the high 30's by percentage. After the debate, Cox went into the 40's for a few weeks until further campaign issues moved him back down just before the election.

"Dahle is so far behind right now that many are discounting him," added Rollins. "But he is the only other candidate and he deserves to be heard and go against Newsom. It would also be beneficial to Newsom. The guy loves sound

bites, but often has difficulties working in the right ones during press conferences or speeches. In a debate, it would give him that stature. And if he really is running for president in a few years, giving some humility and, you know, proving that you support democracy through things like debates would give him further traction for that. Because he could be asked why he didn't want to be in a debate a few years ago during the Governor's race, and he may not have the best response to that."

As of Monday, there are currently no plans for a 2022 Gubernatorial debate in California.
