Stampede Highlights Rodeo Tradition

MARYSVILLE, CA (MPG)

- The Wednesday evening commute might have looked a little different on September 14th. Instead of the usual cars and trucks, cattle were seen making their way from Yuba City to Marysville.

The Marysville stam pede, hosted by Flying U Ranch, ran a small heard of long horned cattle from Bridge Street in Yuba City to the Cotton Rosser arena in Marysville. The most popular stop for viewing was downtown Marysville.

Marysville Stampede is a weeklong event celebrating rodeo and cowboy culture. Events during the week

included dances, women's lunches, and a steak dinner. The main event is the rodeo on Saturday and Sunday afternoon. The rodeo combines traditional Western cowmanship with a unique California flair. The show adds, clowns, motorcycles, and other entertainment to set themselves apart. One unique event is Bull Jumping where participants literally

jump over bulls. Mexican Rodeo styles are also featured. For the children there is a coin dig and "Mutton Bustin" where young cowgirls and cowboys can try their rodeo skills by ridding sheep.

This tradition was started 88 years ago by Cotton Rosser, a Rodeo legend and longtime Marysville resident. After settling in Yuba County, he founded the Flying U Rodeo which remains a local institution. Cotton Rosser was so respected in the world of Rodeo that when he passed away last year, his funeral was broadcast nationally and replayed multiple times. Now the company is headed by his daughter,

Bill Signed to Crack Down on Street Racing and Illegal **Sideshows**

SACRAMENTO, CA (MPG) -On Monday, September 19, Gov. Gavin Newsom signed Assembly Bill (AB) 2000, which will prohibit street racing and sideshows from occurring in parking lots across

the state. The bipartisan measure, authored by Assemblymember Jesse Gabriel (D - Woodland Hills), aims to crack down on dangerous driving including street racing, "sideshows," and street takeovers - which continue to cause injuries and fatalities across California.

"Far too frequently, street racing and illegal sideshows devastate families, harm innocent bystanders, and cut short young lives," said Assemblymember Jesse Gabriel. "Communities in the San Fernando Valley and across California are sick and tired of this reckless behavior. I'm grateful for Governor Newsom's leadership on cracking down on this dangerous activity and signing this commonsense measure that will save lives across our state."

"AB 2000 will help us save lives and prevent further crashes and drivers going to prison for manslaughter," said Lili Trujillo, Founder and Executive Director of Street Racing Kills, a non-profit created in 2014 after Trujillo's 16-year-old daughter, Valentina, was killed in a street racing incident. "An exhibition of speed in a parking lot is way too common now and people are being hurt and killed, AB 2000 is definitely a great tool to help us save lives."

"There are countless stories every week throughout California about illegal street races and dangerous sideshows shutting down streets, causing accidents, damaging neighborhoods, and endangering lives," said Assemblymember Vince Fong (R - Kern County), a joint author of the measure. "They are unpredictable, destructive, and can lead to senseless deaths that devastate families. AB 2000 is an important and needed step in cracking down on illegal sideshows to make our communities safer."

Across the state, COVID-19 has caused a sharp rise in illegal street racing activity as drivers took advantage of roads emptied by stay-at-home

Marysville Officials Begin Negotiations with Pecos League Baseball

MARYSVILLE, CA (MPG) - The Marysville City Council will hold a special meeting this week to begin negotiations to keep a baseball team fielded in Marysville. City officials were saddened to hear that Gold Sox Baseball would not be supporting a team at Marysville's Bryant Field for the 2023 season.

"The City is forever grateful for the investment and the efforts of the ownership group of the Gold Sox for their many years of commitment to keeping baseball alive in Marysville," said Marysville Council Member Dominique Belza.

Just prior to discovering the news about the Gold Sox, the city was contacted by PECOS League

baseball LLC, an independent professional league, about bringing a new team to Marysville. Council members and staff are set to meet with PECOS League officials in the coming week to begin negotiating the terms of a potential contract.

"With the recent news of the Marysville Goldsox taking a hiatus, myself along with the Rec Development Committee are thrilled that we may be able to save baseball in Marysville," said Marysville Vice Mayor Bruce Buttacavoli.

PECOS started as a regional league with teams in New Mexico and West Texas and has since grown into the largest independent league in the United States. Since 2017 the Pecos league has had 14 teams in six states and

three time zones. In 2022 the Pecos league grew to 16 teams. Despite moving to much larger markets like Bakersfield, Tucson and Monterey in 2022 the Pecos league still remains strong in smaller markets. In 2017 the league expanded into California, fielding teams in Martinez and San Rafael in 2021. In 2022 they added a team in Santa Rosa. "After learning the history of Bryant Field in Marysville, we feel it will be a great fit to our league and our geography," said Andrew Dunn of the PECOS League. "Marysville has a great baseball history and will fit seamlessly into our California Division with Santa Rosa, San Rafael, Martinez, Bakersfield, Monterey and Santa Cruz,"

said Dunn. Marysville officials

strive to provide the highest level of baseball it can host for Yuba and Sutter counties and the Pecos League would be the highest level without MIL B affiliated baseball in Marysville.

The City expressed their excitement at the possibility of hosting a new baseball team that is part of the PECOS League.

"Having a team in the PECOS League will undoubtedly have positive impacts on economic development as we continue working diligently to make Marysville a destination for new businesses and tourism," said Community Development Director Dan Flores. "Marysville has a long history with baseball and keeping a strong baseball team at Bryant Field is a priority for the City Council," finished Flores. ★

Avoid West Nile Virus with Some Simple Tips

YUBA-SUTTER REGION, CA (MPG) - Sutter County Public Health and Yuba County Public Health have each confirmed the first human case of West Nile Virus (WNV) in Sutter County and Yuba County this year. As of September 9, 2022, forty-one human WNV cases have been reported in California. WNV is active June through October. Both of the recently confirmed local human WNV cases are experiencing severe illness.

Confirmed cases in Sutter County: 1 human, 4 dead birds, 31 mosquito samples and 9 sentinel chickens have tested positive for WNV as of Sept 15, 2022.

Confirmed cases in Yuba County: 1 human, 1 dead bird, 12 mosquito collections and 9 sentinel chickens have tested positive for WNV as of Sept 15, 2022.

People infected with WNV generally fall into three categories: No symptoms/ asymptomatic (8 in 10 people); Mild to moderate fever illness with fatigue and body aches (2 in 10 people); Severe illness with neurologic symptoms such as encephalitis or meningitis (less than 1 in 150 people).

For those who develop a severe WNV illness, symptoms may last several weeks and some symptoms may be permanent.

Although overall mosquito abundance is trending downward, the risk of West Nile virus continues to be high throughout Sutter and Yuba counties. "We continue to see ongoing virus activity and detections in our surveillance system. The risk for human infection is high," said Stephen Abshier, District Manager. "Residents need to remain vigilant in protecting themselves from being bitten by mosquitoes," added Abshier. Residents should inspect their yards for anything holding water. Regular landscape irrigation or unseasonable rains, as forecast for this coming weekend, can provide mosquitoes with good breeding habitat. Simply draining or dumping water will prevent new mosquito breeding.

"The best way to prevent West Nile virus infection is to avoid mosquito bites. We want to remind everyone to stay protected by wearing long pants and long sleeves, especially at dawn and dusk

when mosquito activity is high, and by wearing a good mosquito repellent," said Bi-County Public Health Officer Dr. Phuong Luu.

WNV is transmitted to humans and animals by the bite of an infected mosquito. Mosquitoes become infected when they feed on infected birds. Residents can reduce the risk of infection by practicing the "Three Ds":

1. DEET – Use a proven insect repellent like DEET. Other recommended repellents include: picaradin, lemon eucalyptus oil, para-menthane-diol, IR3535 or 2-undecanone. Always use according to label instructions. DEET can be used safely on infants and children 2 months of age and older;

2. DAWN AND DUSK – Mosquitoes that transmit WNV bite in the early morning and evening. Wear proper clothing and repellent if outside during these times. Make sure that doors and windows have tight-fitting screens to keep mosquitoes out. Repair or replace screens with tears or hole;

3. DRAIN – Mosquitoes lay their eggs on standing water. Eliminate or drain all sources of standing water on your property, including flower pots, old car tires, rain gutters and pet bowls. For standing water that cannot be drained such as fountains, ponds, etc., consider adding "Mosquito Dunks" or mosquito fish, which feed on mosquito larvae.

In response to recent findings and increased virus activity, District staff will continue to trap mosquitoes for testing, continue our disease surveillance program, and treat areas of high WNV activity with truck mounted foggers to reduce the adult mosquito population. Spray areas can be viewed at the District's website at www. sutter-yubamvcd.org. A surveillance map can be found there as well, which shows the location of WNV positive dead birds, mosquito collections and sentinel chickens.

Update on Death Investigations of Two Females

YUBA COUNTY, CA (MPG) - On September 16, 2022, autopsies were performed on the bodies of the two women recently found deceased in Yuba County, by a forensic pathologist in Placer County.

The first victim, who was located on Linda Avenue near Oleander Way, has been identified, 33-year-old Nichole Jeanne Parra. The body was in an advanced stated of decomposition and had been in the location where she was found for several days. She had fractures to the upper torso and arm, but due to the decomposition, a cause of death could not be determined and is pending a toxicology report. The deceased has been contacted by law enforcement on numerous occasions, with the most recent previous contact with the Yuba County Sheriff's Department in June of 2022.

The second female, who was located near Cattail Court, has been identified as 57-year-old Corinna McDaniel of Yuba City. A forensic autopsy revealed no trauma to her body and the cause of death is pending toxicology as well. McDaniel

had a history of mental illness and had prior arrests for being under the influence of a controlled substance. Investigators found evidence that suggests she may have been staying in a transient camp close to where her body was found. A few days before she was discovered, video surveillance from a nearby convenience store showed McDaniel acting bizarre and speaking incoherently to herself. While she has had extensive contact with law enforcement, law enforcement was not contacted regarding her behavior at the convenience store.

Toxicology reports are performed by an outside laboratory and the turnaround time is approximately six weeks. The Yuba County Sheriff's Office understands the community is very concerned about the deaths of both women, and understandably have a lot of questions, which is why we have requested that the reports be expedited.

These investigations are ongoing, and currently there is no evidence connecting the deaths of both women. We encourage anyone with information on either case to call our office at (530)749-7777.



Bill Signed to Crack Down on Street **Racing and Illegal Sideshows**

orders. In 2020, the California Highway Patrol responded to more than 25,000 calls involving illegal street racing activity statewide, an alarming increase of more than 3,500 calls from the year before.

In Southern California, street racing and sideshows have become extremely popular. In August and October of 2021, respectively, a Calabasas teen was among three people killed by apparent street racers in a three-vehicle collision in Burbank caused by street racing, and a Woodland Hills woman was killed and seven others were injured after a driver lost control while racing. Just last week, police arrested three dozen people at several illegal street takeovers

in and around Los Angeles and the San Fernando Valley.

Statewide law enforcement groups have identified driver's license suspensions as an effective tool for the deterrence of illegal street racing activity. Expanding on AB 3, which was signed into law last year, AB 2000 allows courts to issue a driver's license suspension for the exhibition of motor vehicle speed during a sideshow taking place in a parking lot – an area not currently covered under the law - and thereby helps to further deter individuals from engaging in these dangerous activities.

Election Fraud Ten Times Bigger than '2,000 Mules' The Tiger Project

After the release of "2,000 Mules," Gregg Philips told the Arizona Assembly, "We do indeed have a matter brewing that is 10 times bigger than the Mules." That information was disclosed in The Pit Conference held August 13, 2022 in Arizona sponsored by True The Vote investigative journalists and founders Gregg Phillips and Catherine Engelbrecht to journalists gathered to hear more of what was discovered ("China Interfered in the 2020 Presidential Election, After All," Harold Pease, Ph. D., LibertyUnderFire.org).

When True The Vote proved in "2000 Mules" that domestic vote fraud was more than enough to have "elected" Joe Biden, that was the most serious crime in American history – even a coup to overthrow the president of the United States. But their research also documented collusion between many high profile Americans with a foreign country, China. For Americans "knowingly" involved this was treason as well and for a foreign country, an act of war against the United States (See. 18 US Code 2384 Seditious Conspiracy and 18 U.S. Code 2381-treason).

Phillips and Engelbrecht took their documents to the FBI. At the lower levels of the organization they received support and encouragement but as the evidence went up the ladder, hostility. The FBI began accusing them of having stolen their documentation from China (X22 Report, Ep. 2849b, Aug. 15, 2022, 18:55). (X22, Ep. 2866b, Sept. 4, 2022, 29:25) Given the FBI reaction at the top and their efforts to censor the Hunter Biden laptop from the 2020 Presidential Election information, we suspect the latter. If they "knowingly" covered up the China connection they were working for a foreign government.

With collusion and censorship by the Deep State media and the national security agencies of the federal government, True The Vote had to form their own investigative body. They needed other investigative journalists to prob further with them. They called their group of "over 100 experienced thinkers and researchers," The Tiger Project. If you're on WeChat or Tick Tock get off now." 4) "And since they own the data and it belongs to them, once the data is inside mainland China they can do whatever they want with it." 5) "It was discovered by Catherine Engelbrecht and Gregg Phillips of True The Vote that China has been downloading some of the data running over these CCP connected EMS apps and platforms. The detailed personal identification, PII, from 1.8 million US election workers is just the start of what the CCP considers itself to own." 6) "CCP wrote the code for and manages and operates the EMS system in multiple countries, and it considers all the data it gets its hands on via the EMS system, to be theirs and they can do whatever they see fit with it." 7). "This makes removing the CCP controls and affiliates so for apps and platforms from the US election system in hundreds of U.S. counties a serious matter of national security" (X22 Report, Ep. 2866b, September 4, 2022,

25:00-30:00). He told us what must be done after the country is fully awakened to the fact that "our election system has been corrupted by a hostile foreign power." Then all "CCP controlled affiliate EMS apps and platforms" and machines must be discarded and we

must return to only paper ballots. Thus far Deep State platforms have given no rebuttal to the information respecting the Pit findings or the Tiger Project. It, as with its predecessor "2000 Thousand Mules," benefits from an enemy that argues with silence and censorship. But with a team of a hundred investigative journalists attempting to discover and report more fully this coup, LibertyUnderFire will have opportunity to share more details later.

What we do know is that China operates an election management system that is used in hundreds of our cities and counties that allows them to influence our elections, perhaps select our leaders as well as per Biden, and thus they have conquered half of America without their firing a missile or a bullet. 

The Rental Stock Portfolio

Many investors love rentals. More millionaires have been made from real estate than any other asset class.

When I ask investors about what they like about rental properties, the obvious answer given is the rent checks. Then asked if they care if the property drops in value, they usually answer, no, as long as they get the rent checks.

There is a similar opportunity in the stock market and without some of the headaches real properties have such as having to deal with tenants, late rents, rent moratoriums, leaky roofs, insurance, liability exposure and hefty commissions when one decides to sell a property. Add in property taxes and possible tax assessments and the hassles become pretty obvious.

An option is what I call a "Stock Rental Portfolio" which can pay just like a rental but with some definite advantages utilizing dividend paying stocks.

Dividends are payments by companies whose stocks you own. Dividends can be cut, eliminated or increased at the whim of the Board of Directors, but there are many reasons why they would not want to do that.

The members of the board probably have stock themselves, so if you get a dividend, so would they. Tax rates on dividends can also be less then tax on income, so in lieu of a big salary, VPs might opt instead for lots of stocks, reap the dividends and possibly pay less in tax.

A group of stocks called "Aristocrats" have not only paid dividends for more than a quarter of a century or more, but have increased them every year for the same amount of time or more (a requirement to make the Aristocrat list). Some have paid dividends and increased them every year for over 50 years! Some even longer.

How many landlords out there can say can they increase their rent to their tenants every year?

Probably not many.

But Aristocrats stocks by definition have to in order to remain on the Aristocrat list, and the Board has every incentive to maintain the record of increases to remain an Aristocrat.

The board also knows should they break the streak of increases, their stock would likely get punished as not increasing the dividend may mean there are financial issues preventing them from doing so, not to mention angering stock holders who expect annual increases.

costs, no vacancies, and no huge sales commissions. There are also no long wait times to liquidate like waiting for a buyer or long escrow to cash out. Stocks can usually be sold in microseconds when the markets are open.

Can stocks drop in price?

Sure they can, but remember landlords tell me they don't really care if the rental drops in value as long as they get their rent checks. So if stocks drop, but the Aristocrats keep their history of paying dividends intact (and increasing them every year to boot), you will still get your "rent".

With the advent of the rent moratorium, inflation pushing maintenance and insurance costs up, taxes going up, more wildfires, increasing mortgage rates, memories of the 2008 housing crash, and more consumers struggling, the threats to landlords and their financial stability is on the increase.

With the possibility of lower tax rates on income through dividends, essentially zero commissions to buy or sell these stocks through the use of discount brokers who offer commission free trades, zero property taxes, no tenant problems such as midnight calls or unpaid rents, instant liquidity and no maintenance costs, there is a lot to like about a "Stock Rental Portfolio".

In conclusion, I used to be a landlord, and loved the rent checks. But as time wore on and the hassles of the rentals properties and their tenants increased, I sold all my properties and instead now hold many an Aristocrat dividend-paying stock.

Should the boards of directors of these companies elect to stay on the Aristocrat list, and they have every incentive to, I will continue to get higher and higher payments every year, without all the threats to my financial picture as rental properties can expose me to, and without all the problems and landlord stress as well.

LaMalfa and Pappas Legislate on Travel Reimbursement for Veterans

Office of Congressman LaMalfa

WASHINGTON, D.C. (MPG) - On September 14, 2022, Congressmen Doug LaMalfa (R – Calif.) and Chris Pappas (D – N.H.) introduced new legislation to help cover the out-of-pocket expenses that veterans and their caregivers incur when traveling to receive medical care provided through the Department of Veterans Affairs (VA). In response to high inflation, the Veterans Medical Mileage Adjustment Act of 2022 would increase the mileage reimbursement rate for the Beneficiary Travel Program for eligible veterans who have to travel more than seven miles, or more than 14 miles round trip, for VA-related health care.

U.S. Senators Jon Tester (D – Mont.) and Jerry Moran (R – Kan.), the Chairman and Ranking Member of the Senate Veterans' Affairs Committee (SVAC), introduced companion legislation in the Senate earlier today. In addition, Congressman Rick Larsen (D – Wash.) has signed on to the legislation as an original co-sponsor in the House of Representatives.

"With gas prices in California up over two dollars in the last few years, traveling is more expensive than ever. While some Californians try to make ends meet by cutting back on driving or other necessities, rural veterans seeking medical treatments have few options. They rely on hospitals and clinics located far from their home. We shouldn't force our veterans to shoulder more and more of this cost because Washington has abandoned a reasonable energy policy. This legislation will increase the mileage reimbursement rate to protect our veterans from government-created inflation," said Congressman LaMalfa.

tect our veterans from government-created inflation," said Congressman LaMalfa.

"No one should struggle to access care because of the distance they must travel for an appointment or the cost of transpor-

tation. But veterans in New Hampshire,

especially veterans who live in rural areas,

often have to travel long distances to access VA health care services," said Congressman Pappas. "This overdue increase in reimbursement rates for veterans traveling for VA health care would ensure that Granite State veterans are properly compensated for their travel costs, and I'll keep fighting to protect access to community-based care that will reduce the travel burden shouldered by our veterans."

"Travel to medical appointments is often a real burden, especially for veterans and caregivers who live a long distance from VA facilities," said Congressman Larsen, a senior member of the Armed Services and Transportation and Infrastructure committees. "This bipartisan bill improves equity and public health by increasing reimbursement rates to ensure Washington veterans can access the medical care they need, regardless of where they live."

"Inflation and rising costs have resulted in more and more veterans shouldering additional costs when traveling to receive health care provided by the VA," said Senator Moran. "Raising reimbursement rates will help keep the Beneficiary Travel Program relevant and make certain travel-related costs are not inhibiting our veterans from receiving the care they deserve."

"For Montana veterans living in rural or remote areas, getting to a VA health care appointment can mean driving dozens of miles each way to their nearest facility," said Senator Tester. "Increasing the mileage reimbursement rate will ensure VA benefits are keeping pace with rising transportation costs, so veterans can continue accessing their earned care — no matter where they live."

This legislation is endorsed by the American Legion, Veterans of Foreign Wars of the U.S. (VFW), Disabled American Veterans (DAV), and Wounded Warrior Project. ★

COVID-19 School Closures Undermined Learning

Whether California's schools should remain open or be closed was a hot issue when the COVID-19 pandemic was raging in 2020 and 2021.

Although medical authorities quickly concluded that children had a much smaller risk of being infected or experiencing severe effects if infected, California schools were mostly closed, in large measure because teachers and their powerful unions insisted on it.

With schools closed, local administrators scrambled to provide on-line classes, what became known as "zoom school," but they were poor substitutes for the real thing — especially for Englishlearner students and those from poor families.

Those children roughly 60% of the state's nearly 6 million public school students — were already trailing their more privileged contemporaries academically when the pandemic hit. The closures made it worse, for obvious

They tended to lack internet access and proper equipment for on-line classes. Their parents were often compelled to work outside the home to make ends meet, so kids were often left to fend for themselves. Absenteeism from on-line classes was widespread.

Affluent parents, particularly those who could easily work from home during the pandemic, made certain that their kids attended on-line classes, helped them with their school work, formed informal collaboration groups and/or hired tutors. Thus, the ill effects of closures were mitigated. And, of course, private schools, such as the one Gov. Gavin Newsom's kids attend, either remained open or minimized closures.

For months, politicians from Newsom downward quarreled over how the schools should function and angry parents formed the core of a movement to recall him from office. Newsom survived the recall, but the educations of millions of kids did not, as new data

While the state Department of Education has not released 2022 academic test data that would allow comparisons with pre-pandemic results, individual school districts are doing so and the numbers from the state's largest school district, Los Angeles Unified, are stunning.

About 72% of the district's students are not meeting state standards in math and 58% are behind in English, essentially wiping out five years of progress that it had recorded prior to the pandemic.

"The pandemic deeply impacted the performance of our students," LAUSD Supt. Alberto Carvalho said. "Particularly kids who were at risk, in a fragile condition, prior to the pandemic, as we expected, were the ones who have lost the most ground."

While the district released

gross data, it did not break down the test results by ethnic or economic subgroups. The Los Angeles Times, however, gleaned the detail from a school board document marked "not for public release."

Why the secrecy? Apparently, it was to mask the particularly disturbing data about Black and Latino kids.

"About 81% of 11th-graders did not meet grade-level standards in math. About 83% of Black students, 78% of Latino students and 77% of economically disadvantaged students did not meet the math standards," the Times reported.

We won't know how the state as a whole fared until — and unless — the Department of Education finally releases 2022 complete "Smarter Balance"

test results. But there's no reason to believe that what happened — or, more accurately, what didn't happen — in Los Angeles isn't also true of other systems, particularly those with large numbers of at-risk students.

The educational deprivation that California inflicted on its kids is not only shameful, but will reverberate for decades. Children who fail to master the basics of education in lower grades will be ill-prepared for high school and post-high school training and education. If they are not prepared to take their place in the work force, the state's economy will



Final Farewell for Queen Elizabeth II

It was a spectacle few will see again. A Queen – perhaps the greatest monarch in history – borne to rest with pageantry beyond Cecil B. De Mille. Monday's funeral was a masterpiece only the Queen's horses and men could achieve; meticulously choreographed by the lady herself.

The massed pipers, gun carriage and swaying naval phalanx was not just pomp. Pragmatic to the last, Elizabeth II knew great

meet again." The nonagenarian bore the yoke of duty until death.

Service came at a price. Her babies lacked a mum's hands-on guidance and later blundered into mistakes she so deftly avoided. But three Windsor generations' heartfelt mourning demonstrated the brood's profound love.

When I was a little girl, I waved to the Queen from a street crowd. In pale flesh, I beheld the icon from New Zealand's stamps and pound notes. When I met her many years later, I was told to address her as her

pageantry stirs sentiment. What better tonic for royal continuance? What better kick-start for her heir's succession?

Ten thousand military officers and the tears of a grateful nation accompanied an Empress into legend. Elizabeth was not born to her role, yet this accidental monarch managed sovereignty so peerlessly that her death was – for millions – like the loss of a mother, a grandmother or great grandmother.

The Queen encapsulated the Greatest Generation. Her radio voice comforted Londoners during Hitler's blitzkrieg. Her wedding dress was purchased with clothing ration coupons. The Navy bride followed her husband's deployments, and she paraded children at her coronation. As a Commonwealth leader, she walked a steel tightrope through 70 years of diplomacy. During pandemic, she reassured locked-down subjects, "We will

ma'am. Through nerves, I called her "mum." She looked at me askance, but the irony was surely not lost on the mother of the Commonwealth.

I was then a court correspondent in London. Palace press corps members saw her frequently, but the jokey banter of Charles and Diana's entourage was absent with the Queen. Some people called her shy; I found her reserved. I recall achingly polite conversations about the weather. Her sapphire gaze was beguiling. But in disapproval, what she called "the look" could silence cannon fire.

Stoicism is not the same as snobbery. As much as her 15 prime ministers, the Monarch knew adaptability was key to survival. In tune with her times, she knighted rock stars, agreed to pay taxes, shelved her minks, mothballed her yacht and shook hands with activists.

She bent only as far as her

principles allowed. The Queen gave no interviews; nor did she pander to the press. She believed a monarch should be seen hence her bright ensembles – but heard as little as possible. In an age of celebrity narcissism, the world's greatest celebrity eschewed exposure of emotions or private life. Her children divorced; a son was disgraced; a grandson defected. The matriarch seethed or grieved in private. Her husband died; she soon donned lavender ensembles and returned to work. Her policy to neither

explain, complain or comment served her well.

The Queen nevertheless knew the age when few questioned colonialism – or Britain's right to the Koh-in-Nor diamond – were over. Abdicating from dynastic problems on September 8, her final coup was to unite stewing elements of the Commonwealth in mourning.

Elizabeth II's most crucial legacy is the king she groomed. What Charles missed in motherly cuddles was not stinted in his training. The mentor likely hammered in

responsibility to a changing society over tea and scones.

When Elizabeth ascended, her realms were emerging from war years with adoration for Queen and Country. Charles III inherits national crises and a complaining Commonwealth. But as passionately as one Sovereign believed in contouring monarchy for the times, so will her heir.

Elizabeth II was the right Queen for her era. Thanks to her unflinching example, I believe Charles III will be the right King, for his.

Huskies Stay Perfect with Shutout Over Indians in PVL Opener

SUTTER, CA (MPG) - The Sutter Huskies continued their undefeated streak in the CIF Sac-Joaquin Section with a 35-0 shutout over the Marysville Indians on Friday night.

This is the Huskies' first year in the SJS after years of dominating the Northern Section. This is also the team's first year in the Pioneer Valley League (PVL).

Sutter (5-0, 1-0 PVL) head coach Ryan Reynolds was pleased with his rushing attack throughout the game and how his team executed their game plan.

"We did enough to be efficient and capitalize," Reynolds told the Messenger Publishing Group.

The Huskies came into the game with an average of almost 47 points per game and about 475 yards of offense in each game.

Senior running back Troy Brucie entered the game with 508 rushing yards and seven touchdowns on the season so far for Sutter. Brucie added to his totals Friday night, carrying the ball 15 times for 129 yards and three scores, averaging a whopping 8.6 yards per rushing attempt.

Brucie also added another team-high with two receptions for 70 yards. Unfortunately for the Huskies and their fans, fellow senior RB Landon Sable broke his collarbone in the second quarter and will be out the remainder of the season.

Senior quarterback Luke Miller scored a 13-yard rushing touchdown to give Sutter a 14-0 halftime lead. Miller rushed seven times for 24 yards and a score on the ground. However, with his arm, the senior completed 5-of-7 pass attempts for 81 yards.

Brucie added two more touchdowns in the second half, which included a 27-yard touchdown run early in the fourth quarter to extend the Huskies lead to 28-0.

Marysville (3-2, 0-1) head coach Will Claggett said despite the shutout loss, he was happy with how his team battled defensively. The Indians have a bye week and will host Colfax (3-1, 1-0) next week, which gives Claggett and his team time to adjust.

"We're going to look and try and reduce the load on our two-way players," Claggett explained to MPG.

He added that his team was a little gassed in the second half and this bye will be nice to get a little rest. The week off will allow the coaches to evaluate the team to see if anyone on the roster could potentially fill a spot where a current two-way player lines up.

This was the third shutout for Sutter this season. The defense is led by senior middle line-backer Joseph Martinez and junior defensive end Asiata Auckland. Martinez and Auckland both contributed a game-high 11 tackles in the win Friday night.

With PVL play underway, each game is crucial. The Huskies will travel and play on the road Friday night at Colfax.


"They're well coached and disciplined," Reynolds said. "It's going to come down to execution." ★
