### **Yuba Water Commits Funds** for Flood Risks and More Yuba Water Agency News Release

MARYSVILLE, CA (MPG) -Yuba County will save more than \$315,000 over the next year with the help of a \$14.4 million low interest loan from Yuba Water Agency to pre-pay the county's annual California Public Employees' Retirement System payment.

"Yuba Water has carefully managed its reserves to be able to accommodate loans exactly like this," explained Kurtis Crawford, Yuba Water's director of finance. "The agreement saves the county significant money and has no negative impact on our reserves, since we'll still be earning the same interest in repayments as we would from keeping the money in savings. It's really a win-win for all."

The loan will allow the county to make its annual payment to CalPERS in one lump sum, rather than financing it through CalPERS at a much higher, seven percent interest rate. Yuba Water has helped cover the county's unfunded liability portion of its CalPERS payment since 2017. The county in turn has made monthly payments to the agency.

Unfunded pension liability is the gap between future benefits a pension fund expects to pay out and its current assets.

#### **Flood Risk Reduction**

approved a \$3 million line of credit and a grant worth up to \$2 million to the Three Rivers Levee Improvement Authority. The funds will help TRLIA close out several state and federal grant agreements related to its work to provide a 200-year level of flood protection for south Yuba County, which it recently achieved following years of local, state and federal efforts and more than \$500 million in investments. This level of protection is among the highest in the Central Valley and means there is a one in 200 chance in any given year of a flood occurring that is larger than the system is designed to handle.

## **Losing Ground in Protecting Our Air Quality**

For decades, California has been the nation's leader in reducing tailpipe emissions from cars and trucks and other aggressive work to clean up smog. Southern Californians old enough to remember their eyes stinging from air pollution in the old days know how important that work was.

But now, the state's hard work cleaning up the air is going up in smoke.

California has always had fires, and summer and fall smoke used to be an occasional annoyance. But the mega-fires the state is increasingly seeing send up so much smoke that the air quality gains made over the past years are being lost.

As the L.A. Times recently reported, California's 2020 wildfires sent up so much smoke that we reversed decades of progress in improving air quality. This is no surprise to Californians who spent months under apocalyptic dark skies, but it's a sad confirmation of how much progress has been lost.

And while 2020 was a record-setting wildfire year, 2021 was nearly as intense. It would have set a record if 2020 hadn't come first. This air pollution isn't just unpleasant. It is deadly. Stanford researchers, as the Times reports, estimate up to 3,000 premature deaths from the smoke in our air.

As a member of the state Legislature, I've been fighting for healthier forests for a decade. I've written legislation to get the government's bureaucracy out of the way of fire prevention, launch a major reversal of "no management" management practices, and supported and expanded the Sierra Nevada Conservancy, a champion of healthy forests and watersheds. I wish I could say it was enough.

A large part of the problem is leadership. The current governor says the right things, but real work to keep communities safe and reduce wildfire severity is scarce; there has been no significant reform to California Forest Law in the last 20 years. We still manage our forests under policies that reflect the reality of the 1960s, not today.

This administration is great at issuing press releases but very bad at follow-through, as multiple reports from Capital Public Radio reporters documented over the past year. State and federal policies still put countless barriers in front of the work needed to actively thin overgrown forests (in some places 400% overgrown). We can do better. We can more aggressively waive long reviews under the California Environmental Quality Act for fire-safety

Environmental groups cling to the power to stall and stop projects under these laws in the name of protecting forests. Still, I defy any of them to take a tour of Plumas County, where the Dixie Fire burned a million acres last year and tell me that it is a healthy environment.

We must consistently support the local governments and nonprofit Fire Safe Councils that plan and organize fuel work. Competitive grants primarily drive the state's current system. CalFire does its best to fund essential projects, but too many communities don't have the organization to ask. Many rely on volunteer groups to handle this critical public-safety work. I have the highest admiration for the people who step forward to help their neighbors, but the critical fire risks we're facing demand a 21st-century response. We have to tap the nearly forgotten wisdom of the ranchers, and the California Native tribes before them, who learned that fire in California is inevitable, but burning on purpose in the right season is safer and better for the

environment. The risks of prescribed fire are serious, but we need to expand our capacity to burn where we can do it safely. And we must work with the federal government, which manages nearly half the land in California, so it does its part to change course. Our national forests are a California treasure, but in recent decades their extreme, barely managed fire risk has made them a bad neighbor. The wildfire crisis is destroying watersheds, leveling whole towns, and blanketing the state in smoke that is literally killing Californians even if they live miles from the fire lines. We must do better.

## Bill to Repeal Federal Excise Tax on Heavy Trucks Introduced

WASHINGTON, D.C. (MPG) - Congressman Doug LaMalfa (R - Calif.) and Congressman Chris Pappas (D - N.H.) introduced legislation repealing the twelve percent Federal excise tax on heavy trucks. The excise tax on heavy trucks is the highest excise tax levied by the Federal government and could add more than \$30,000 to the cost of new heavy trucks, trailers, semitrailer chassis, and tractors for highway use. Off-highway equipment such as agriculture, earthmoving, forestry, and mining machinery are exempt from the tax. This tax is paid at the time of sale and is not levied on used truck sales, consequentially encouraging the purchase of used

For more than a century, the Federal government has levied excise taxes on heavy duty trucks to raise money for wartime mobilization in WW1 and WW2, fund Great Depressionera programs, and for the Highway Trust Fund. The Senate previously attempted to repeal the tax in 1975, but the House failed to include it in their version of a broad tax bill. It was last increased in 1982 to twelve percent, and although it was set to expire in 1987 it was extended in 1987, 1991, 1998, 2005, 2012, and

2015. "The Federal excise tax has outlived its original purpose by more than a century. Between Sacramento and Washington, truckers have dozens of regulations on emissions and safety to follow. However, at the same time, our tax code disincentivizes them from purchasing the most up-to-date trucks, with the Federal excise tax adding as much as \$30,000 by itself. With American producers and consumers shipping more than ever, we should drop the

burdensome tax preventing our truck drivers from having the most modern. highest technology and safest equipment on the road," said Congressman LaMalfa.

"As a small business owner, I've seen firsthand just how challenging it can be to operate a business, especially when costs rise," said Congressman Pappas. "This is a time when we must do all we can to lower costs for small businesses and consumers and cutting the federal excise tax on heavy trucks and trailers will help America's Main Street economy grow, address supply chain challenges and shortages, and lower costs for essential items that families need like groceries and gas. Not only will cutting this tax help small businesses and ensure we can transport more goods across the country, but it will also facilitate the adoption of newer, safer, and greener trucks and reduce our dependency on foreign energy sources. I urge leaders in Congress to take up this bipartisan bill to provide immediate relief to small businesses

and consumers alike." ★

#### **Yuba River Habitat Restoration**

Yuba Water also granted the South Yuba River Citizens League \$350,000 to support a habitat restoration project at Lower Long Bar on the lower Yuba River. The project will create nearly 43 acres of restored salmon habitat at a total cost of approximately \$3.2 million. The grant from Yuba Water will cover a budget shortfall and

allow construction of the Lower Long Bar Restoration Project to begin immediately, ensuring that the project can be initiated and completed this year.

"Considering the challenging conditions for fish throughout the state due to California's ongoing drought, this project couldn't have come at a better time," said Jeff Mathews, Yuba Water's habitat enhancement project manager.

COLUSA, CA (MPG) - On May 21, 2022, Colusa County officials hosted a legislative tour and informative briefing for Assemblymember Cecilia Aguiar-Curry (D-Winters), highlighting the crisis-level economic impacts resulting from the unprecedented drought and winter freeze. Colusa County Supervisors Daurice Kalfsbeek Smith and Gary Evans, as well as Agriculture Commissioner Anastacia Allen, Public Works Director Michael Azevedo, and County Administrative Officer Wendy Tyler participated on behalf of Colusa County. Other stakeholders in attendance were California Herigate Mills CEO Steven Sutter and Depue Warehouse Co-Owner Kevin Dennis, and from the Sites Project Authority Board Vice Chair Jeff Sutton, Executive Director Jerry Brown, and External Affairs Manager Kevin Spesert. The event concluded with a request for local assistance.

"We are experiencing a confluence of crises resulting in catastrophic economic impact to our local agricultural industry," said Supervisor Kalfsbeek Smith. "We appreciate Assemblymember Aguiar-Curry's interest in this matter and look forward to working with her office on economic assistance to carry us through this challenging time."

As the top producer of rice in the Sacramento Valley, Colusa County historically produces more than 150,000 acres of rice in a normal year. In April 2022, the water districts serving Colusa County were given their final allocation for the 2022 growing season – 0.4-acre feet per acre. This 1 allocation is not enough to support rice production, and estimates show that the Sacramento Valley will fallow 370,000 of 450,000 acres in the Sacramento River Settlement Contractors service area, primarily in Colusa and Glenn Counties. Currently, less than 7,000 acres are estimated to be planted in Colusa County, resulting in a direct financial loss to

growers in excess of \$270 million.

In addition to the drought crisis, on February 24, 2022, Colusa County and much of the Sacramento Valley experience a devastating freeze, ultimately resulting in a 74 percent loss of local almond crops, with an estimated direct financial loss to growers of nearly \$210 million. Downstream impacts are felt by dryers and processors, and growers are concerned about future

labor shortages. Colusa County's request of Assemblymember Aguiar-Curry's office is for an economic bridge to support and assist the industry through this crisis. The expected ripple effect of the freeze and drought is becoming a reality, impacting mills, aerial applicators, crop dusters, pesticide and fertilizer dealers, and ground applicators. Without assistance, generations of local heritage and our place in the global market are at risk. It is critical that the State develop and deploy local programs to help assist the industry through this historic crisis.

## Holding July 4th Boating Under the Influence Checkpoints

**SACRAMENTO, CA (MPG)** - On one of the deadliest holidays for recreational boating-related accidents, California State Parks Division of Boating and Waterways (DBW) is reminding recreational boaters to avoid alcohol this Fourth of July holiday weekend. DBW and more than 45 law enforcement entities across California will be participating in a nationwide boating under the influence (BUI) effort from July 2 – 4. Dubbed "Operation Dry Water," law enforcement entities will increase patrols and/or carry out BUI checkpoints.

For the 13th straight year, the goal of the Operation Dry Water campaign is to reduce the number of alcohol and drug-related accidents and fatalities and educate water enthusiasts about the deadly consequences of BUI. According to the National Association of State Boating Law Administrators, where the primary cause was known, alcohol use continues to be the leading known contributing factor in recreational boating deaths in the United States.

"Spending time with family and friends in a boat on California's waterways is one of the most popular ways people enjoy the Fourth of July Weekend," said DBW's Acting Deputy Director Ramona Fernandez. "We would like to remind boating enthusiasts that drinking and boating is just as deadly as drinking and driving. The environmental stressors of the marine environment accelerate the impairing effects of alcohol. We encourage boaters to keep alcohol off the water completely."

It is against the law in California to operate a boat or water ski with a blood alcohol concentration (BAC) of 0.08 percent or more. Officers may also arrest boaters with a BAC less than 0.08 percent if conditions are deemed unsafe. BUI convictions can result in up to six months in jail and/or fines of up to \$1,000. Two convictions within seven years could add a jail term of up to one year. Boaters caught operating under the influence may also have their voyage terminated and their vessel impounded.

### A Place to Hide

Although stocks and bonds have tendency to move opposite of each other, often when stocks continually slide for days or weeks on end, bonds can also give way to lower prices. Simply put, the correlation to bonds and stocks seems to hold up well at the onset of market routs, but in severe and prolonged downturns, bonds can experience contagion and fall in concert bucking the usual trend.

Since investors may hold a variety of stocks and bonds in their portfolio as recommended by many an advisor and is an accepted practice by many an investor to provide some stability to portfolio balances, when bonds start to slide, where can an investor hide short of moving to cash or money market funds?

U.S. Treasuries are debt from the U.S. government and come in a variety of maturity dates ranging from a few months to many years. They can be called Treasury Bills, Bond or Notes depending on how long to maturity. They are what is called government-issued fixed income securities that are guaranteed by the U.S. Government and therefore deemed safe and secure. The common practice for monetary debt of any kind is for the borrower to pay some sort of compensation to the lender for the privilege of borrowing the money. Called maturity, how long an IOU is written for will generally reflect how much a lender will make for entering into the lending agreement.

Interest payments, which can be the compensatory method, usually increase the longer the money is borrowed.

Buy a one year U.S. Treasury and it will likely pay less than if you buy a ten year treasury. It is not always the case that a longer maturity results in a higher yield, and when a longer maturity pays less than a shorter maturity day, it is called an Inverted Yield curve, but that is a story for another day.

In any case, investors getting slammed by both stocks and bonds could purchase Treasuries for at least some sort of yield which would be better than zero if just sitting in cash.

Although paying only a few percentage points, one year treasuries may pay more that CDs and savings accounts. They don't actually pay you interest per se. Instead you buy them under par (stated value) and then when they mature, you get the full value of the Treasury.

An example would be an investor buys a one year bill with a maturity of June 2023

with a face value of \$1,000.00.

He buys it in June of 2022 and has to wait a year since the Treasury has a one year maturity coming due in June of 2023. . He might pay only \$950.00 for the bill but when it matures, he gets the full \$1,000.00. (Example is for illustration only).

Longer treasuries called bonds or notes pay a periodic interest payment instead of utilizing a discounted buy price.

Although treasuries, like all debt, has a maturity date when bought, the treasury market is always liquid meaning an investor can bail out early if need be for whatever the reason. Selling a debt instrument like a treasury before its maturity date however may mean the final sell price may be less or greater than the stated pay off amount. This can happen when interest rates move in the general economy which is affected by the overnight rate set by the Federal Reserve.

Treasuries may also exempt from State and Local taxes, making their minimal yields a bit more attractive. (https://www.irs.gov/ tax-exempt-bonds)

It may sound a bit convoluted to some, but it's actually quite simple and any banker, investment advisor or brokerage house should be able to explain it to you in short order.

Treasuries can be regarded as a hiding place during times of market duress yet still pay the investor at least some income. Be aware that the longer maturity one selects, the longer you will have to hold it without being subject to a possible revaluation of the payoff amount. This revaluation can happen when interest rates move which can happen on a daily basis. In general, you should be aware the longer the maturity you select, the more the revaluation amount will be when interest rates move up or down.

## **Supreme Court Gives Business** a 'Tort Wars' Win

"Tort wars" is the term Capitol insiders apply to the perennial political conflict over the rules governing personal injury lawsuits.

Lawyers who file such suits seek to expand opportunities for litigation, often in concert with other interests, such as unions and environmental activists.

Business and employer groups and their insurers resist such expansion and occasionally propose ways to reduce exposure.

The conflict plays out in the Legislature, in the courts and in ballot measures with countless billions of dollars at stake in outcomes. Earlier this year, a 44-year-long dispute over medical malpractice compensation was resolved in a compromise that averted a ballot measure battle.

However, there are many other fronts in tort wars, including one that resulted in a U.S. Supreme Court ruling last week.

In 2003, just four days after California voters decided to remove him from office, then-Gov. Gray Davis handed personal injury lawyers and unions a major victory by signing legislation called the Private Attorneys General Act (PAGA). It enabled workers who had disputes

with their employers to file class action lawsuits even if they had signed pre-employment agreements to submit such disputes to arbitration.

Advocates said it was needed to protect workers' rights and make up for the state labor department's inability to keep up with disputes over wages and other working conditions. Business and employer groups said it gave greedy lawyers a license to demand big settlements of cases and earn big contingency fees.

Ultimately, business interests spent millions of dollars to qualify a ballot measure that would gut PAGA. The initiative petitions have been submitted for signature-counting, but probably too late for the 2022 ballot. Most likely it will go to voters in 2024.

Meanwhile, a case challenging PAGA's provisions has been winding through state and federal courts and the U.S. Supreme Court last week declared that some important features are void because they conflict with the Federal Arbitration Act, which encourages civil disputes to be arbitrated rather than litigated.

The case involved Viking River Cruises and one of its employees, former sales representative Angie Moriana. Essentially, the Supreme Court declared that California's Supreme Court had erred in a previous PAGA case and state courts had applied that erroneous decision, involving the division of complaints, to Moriana's case.

The decision was not unexpected, given the tenor

of oral arguments, but surprisingly did not reflect the court's much-discussed 6-3 ideological split. The vote was 8-1 with only the court's most conservative member, Clarence Thomas, fully dissenting, saying state issues should be left to state legislatures and courts.

Predictably, even a Supreme Court decision does not end the battle over PAGA because it was decided on technical legal points rather than the broader issue.

Unions, lawyers and their political allies immediately pledged to write new legislation to get around the Supreme Court decree. Sen. Dave Cortese, a San Jose Democrat who chairs the state Senate's labor committee, said the ruling "has provided a roadmap as to how we can create for employees a new pathway to legal standing as well as safeguard the protections that state law puts in place for our workers."

Because the Supreme Court did not strike down all of PAGA, the business coalition backing the ballot measure, dubbed the California Fair Pay and Employer Accountability Act, pledged to continue its campaign. "Even with the SCOTUS ruling on Viking River Cruises, PAGA will still be an avenue for shakedown claims against businesses where trial attorneys take a huge portion of the recovery, leaving employees with a reduced amount," it said.



## Big Pharma Approves mRNA COVID Shots in Babies

WASHINGTON, D.C. (MPG) - On June 17, 2022, the U.S. Food and Drug Administration (FDA) granted emergency use authorization (EUA) for mRNA COVID shots to be injected into babies as young as six months of age. All this despite the evidence that these shots are not safe or effective for babies and toddlers. Nor are they necessary for this young age.

For the Moderna COVID-19 injection, the FDA amended the EUA to include use of the vaccine in individuals 6 months through 17 years of age. The vaccine had been authorized for use in adults 18 years of age and older. For the Pfizer-BioNTech COVID-19 Vaccine, the FDA amended the EUA to include use of the vaccine in individuals 6 months through 4 years of age. The vaccine had been authorized for use in individuals 5 years of age and older.

The announcement came just two days after the FDA Vaccines and Related Biological Products Advisory Committee voted unanimously to recommend that the agency authorize the mRNA COVID injections for children under five years of age and as young as six months. Previously, only children five years of age and older were allowed to get jabbed, and only with the Pfizer injection, while people 18 years of age and older were allowed to take Moderna. Now, infants can have their DNA permanently destroyed with either brand, thanks to the FDA.

Then on June 18, the Centers for Disease Control and Prevention (CDC) Director Rochelle P. Walensky, endorsed the Advisory Committee on Immunization Practices' recommendation that all children six months through five years of age should receive a COVID-19 shot.

Research shows that there is no benefit

to children receiving a COVID shot and the injections can cause potential harm, adverse effects and death. According to Pfizer's own study trial data, the chance of death in children from the shot is 107

times higher than death from COVID.

In addition, an analysis by two Israeli researchers shows that at least 58 life-threatening adverse events from the shots in infants and toddlers under three years old were reported to VAERS. The most common serious adverse events were life-threatening bleeding, anaphylactic shock, anticholinergic syndrome, encephalitis, hypoglycemia, and neuroleptic syndrome. In most of the reported cases, these children had multiple injuries. During the analysis, cases were removed in which it was stated that the exposure to the COVID shot was through breastfeeding.

The FDA's briefing document released before the FDA's committee meeting last week claimed that the vaccine efficacy in children under five years is 80.3 percent. However, even though the study to "determine" this included 1,678 children who received three doses of the formulation, the stated 80.3 percent efficacy claim is based only on "10 symptomatic COVID-19 cases identified from seven days after the third dose and accrued as of April 29, 2022" (emphasis added).

A recent study also suggests that the effectiveness of COVID-19 shots in children is low in the beginning and wanes rapidly to statistical insignificance. Moreover, the data suggests that vaccine effectiveness in children actually becomes negative within several months after the second dose.

Liberty Counsel Founder and Chairman Mat Staver said, "There is no significant benefit and all risk to inject a baby with an experimental COVID shot. The FDA has discredited itself."

## 'Speak on It,' Mike Brown is 'Here to Win'

**SACRAMENTO, CA (MPG)** - Hours after parading through the streets of San Francisco to celebrate the Golden State Warriors' fourth championship in eight years, Mike Brown was formally introduced Tuesday afternoon as the new coach of the Sacramento Kings.

Brown is the 20th head coach in Sacramento franchise history and the 12th since Rick Adelman departed the organization in 2006. Adelman is currently the only Sacramento coach to lead the team to a winning record. The Basketball Hall of Famer had a (.633) regular season winning percentage along with eight playoff appearances in eight years.

"I'm excited about being here," Brown said at his introductory press conference. "The fan base is tremendous. I remember back in the day, them damn cowbells just use to ring in my ear and use to drive me crazy. I hope we get back to that point because now I'd love to hear them cowbells every game.

"I'd be the first one raising the roof and telling everybody to get up and ring those things all day long. The fans, they're extremely passionate, they're knowledgeable and I'm just looking forward to being around them."

Brown has been as an NBA head coach on three separate occasions, with the Los Angeles Lakers (2011-12) and twice with the Cleveland Cavaliers (2005-10 & 13-14). In seven full seasons as the leading man, Brown has led his teams to the playoffs six times, without a single first round elimination. Brown was named the NBA Coach of the Year in 2009 after leading Cleveland to a 66-16 record and a trip to the Eastern Conference Finals.

"We conducted a very robust, thorough, comprehensive process and we wanted to ensure that we found the right coach," said Kings general manager Monte McNair. "We did a lot of research, and it came down to really three key things for us: experience, successful head coaching experience; relationships, the ability to build relationships across the organization; and leadership, as a head coach and leadership for everything that we're trying to do here."

During seven plus seasons as a head coach in the league, Brown has a winning record in both the regular season (.616) and playoffs (.566). The 52-year-old spent the last six seasons as an assistant coach with the Warriors, adding three rings to the one he earned as an assistant with the San Antonio Spurs in 2003.

"We gotta get one for the thumb, I only got four!" Brown said to a media member while pounding the table with a laugh and a smile.

Brown expressed three areas of focus as he enters his new role: 1. An alignment of trusts within the organization. 2. A set of values upheld by leadership. 3. An embracement of your role.

"I was brought here to bring some leadership in a lot of different areas," Brown said. "I've been with a lot of different teams in my 30 years, and I've experienced what I believe is something that can get organizations over the top, not just in one year, but year in and year out, and that's having a winning culture. Every organization out there in my opinion has a soul. A strong soul in my opinion equates to a winning culture."

It's well chronicled that the Kings' active playoff drought is the longest in NBA history at 16 seasons. Some new coaches may try and avoid questions about it, but not Brown.

"There ain't no elephant in the room, you can speak on it," Brown said. "We're going to embrace that. I'm not coming here to 'have fun and be excited enjoying the area.' I'm coming here to win!"







## **Chico State Custodian Admits Hate Crime for YouTube Posts**

**Butte County DA** News Release

BUTTE COUNTY, CA (MPG) - The Chico State custodian and recent graduate charged with a hate crime for his comments to YouTube news videos pleaded no contest on June 16 in Butte County Superior

Kerry Thao, 33, of Chico, appeared in custody and entered his plea to the misdemeanor charge this afternoon. Butte County District Attorney Mike Ramsey said the charge stemmed from comments Thao had posted between May 16, 2022, and May 24, 2022, on various YouTube news channels depicting the recent shootings in Buffalo, Orange County and Texas.

Ramsey said Thao's several comments encouraged "Asians" to take up arms and "kill whites and blacks." YouTube's owner, Google Inc., provided the comments to the FBI National Threat Operations Center. The FBI then notified the Chico State University Police Department of the comments.

University police investigated and learned the comments were posted by Thao, who was employed as a custodian for the University and had recently graduated from there with a bachelor's degree in Psychology. A records check revealed several firearms were registered to Thao.

A no-bail arrest warrant was obtained for Thao and a local judge also issued a California "Red Flag" Gun Violence Emergency Protective Order. On May 27, 2022, Thao was taken into custody and interviewed. Thao acknowledged to the investigators he had posted the comments and he was responding out of anger to videos he saw that were posted about attacks on Asian Americans.

When Thao was informed that a Gun Violence Emergency Protective Order was issued, he voluntarily surrendered all of his firearms. A search of Thao's residence revealed four rifles, three pistols, and a box of ammunition. These firearms were registered and legally possessed by Thao. All firearms belonging to Thao were seized by law enforcement.

Charges of a violation of civil rights, a hate crime, were filed by the Butte

County District Attorney's Office on May 31, 2022. On that date, the District Attorney's Office requested that Thao be held without bail pending further investigation into his intent and motivation behind the comments. The motion was granted.

Ramsey said that since then, investigators with the University police along with the Butte County District Attorney's Office did further investigation to determine the true nature of Thao's threat to the public. Numerous coworkers, professors, family members and friends were interviewed and provided statements expressing surprise that Thao was capable of making such comments.

One professor did state Thao told him he suffered from terrible anxiety. Family members and friends of Thao expressed concern that the recent death of his father along with witnessing social media posts about Asians being attacked may have emotionally affected him leading to his recent intense online comments.

Ramsey said to determine whether these comments were just an isolated event, investigators examined all of Thao's social media and found no evidence of further comments or threats made by Thao other than what was provided by Google. All of Thao's photos, videos, web history, search history, and messages were also reviewed. Thao himself cooperated with the examination by voluntarily providing access to his FaceBook account through his attorney.

Ramsev said investigators found no evidence that would indicate any further threat to the public.

Thao told investigators he never intended to carry out any violence or have others carry out any violence. He said he had learned his lesson from his incarceration and that he needs to deal with his anxiety

Ramsey said the judge sentenced Thao to the time he has already served from May 27th and a maximum term of one year of probation with conditions that he seek and maintain mental health treatment through Butte County Behavioral Health. The judge also ordered that Thao is not to have or possess any firearm for the next ten years.  $\star$

"Our entire way of life – our freedoms, our peace, our pursuit of happiness – depends on the rule of law and those fearless, faithful few willing to stand watch," said Governor Gavin Newsom. "I applaud the bravery and selflessness of these California Highway Patrol officers as they are recognized nationally for their heroism. They exemplify California values and represent the very best

of our state's law enforcement."
On August 12, 2019, Officer
Paul was assisting CHP
Officer Andre Moye Jr. with
an enforcement stop and vehi-

an enforcement stop and vehicle impound near Interstate 215 in Riverside when the suspect suddenly retrieved a rifle from his car and opened fire without warning. Officer Moye was struck and killed, and Officer

Paul immediately drew his weapon and engaged the suspect before radioing "Officer down." Additional Riverside Area CHP units immediately responded along with units from the Riverside Police Department and Riverside County Sheriff's Department.

Officer Paul was shot multiple times in his legs and, despite the

life-threatening injuries, held off the suspect until backup arrived.

Officer Smith arrived after several minutes, and his patrol vehicle immediately took rounds from the suspect. Officer Smith exited his vehicle and returned fire and pulled Officer Paul to safety as he was wounded in both legs. Officer Mendoza then arrived and shot at the suspect

with a rifle, drawing fire away from Officers Smith and Paul. With the assistance of allied agencies, the gun battle continued for more than 12 minutes until the suspect was fatally

"The actions of these men that day were noble, courageous, and crucial to getting another officer to safety," said CHP Commissioner Amanda Ray. "I am incredibly proud of these officers for their teamwork and the numerous acts of bravery which took place during this horrific incident.

While we tragically lost one of our own that day, countless other lives were saved because of their heroism."

Sworn to serve and protect the people of California, CHP officers vow to "assist those in peril or distress, and, if necessary, lay down their [my] life rather than swerve from the path of duty."

The mission of the CHP is to provide the highest level of Safety, Service, and Security. ★
