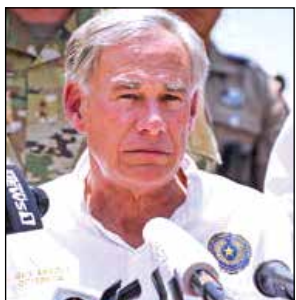

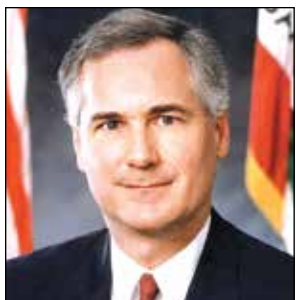

## California Sheriffs Issue Public Alert Following DOJ Data Breach

**SUTTER COUNTY, CA (MPG)** - The California State Sheriffs' Association (CSSA) is alarmed to learn of a data breach by the California Department of Justice (DOJ) that has made public the personal information of California's citizen concealed weapon (CCW) permit holders.

CSSA is issuing this alert to make CCW permit holders aware of the situation so they can take appropriate precautions.

"It is infuriating that people who have been complying with the law have been put at risk by this breach," said CSSA President and Butte County Sheriff Kory Honea. "California's sheriffs are very concerned about this data breach and the risk it poses to California's CCW permit holders."

CSSA will continue to engage with DOJ in an effort to ensure that the risk to CCW permit holders is mitigated and a breach of this nature does not happen again.

Every law enforcement agency in California that issues CCW permits is required by law to provide certain information about CCW permit holders to DOJ, which in turn is required to safeguard that information. The data breach was in conjunction with DOJ's launch of its "2022 Firearms Dashboard Portal." The breach included, but was not limited to, the names, ages, and addresses of individuals who hold CCW permits in California. It appears that before the breach was detected by DOJ, the information was copied and at least some portion of it was posted on the internet.

After learning of the breach, CSSA President and Butte County Sheriff Kory Honea contacted DOJ officials. During that conversation DOJ confirmed there was a data breach involving CCW permit holder information. DOJ advised it has deactivated the dashboard and is working to determine the scope of the breach. DOJ stated it would be contacting all CCW permit holders directly to advise them of the breach and will institute a program to mitigate any harm or damages to CCW holders that result from the breach.

DOJ has issued a statement regarding this situation that can be accessed on their website. ★

## Yuba River Endowment Donates to TIP

**YUBA CITY, CA (MPG)** - During a live radio interview on June 29, 2022, representatives from the Yuba River Endowment surprised the Yuba-Sutter Trauma Intervention Program (TIP) Director and Assistant Director with a \$30,000 donation – the largest single donation TIP has ever received.

"To say we were shocked is an understatement," said TIP Director, Lisamarie Helmer. "During COVID we were not able to hold our annual fundraiser, but our volunteers did not miss a day on the job. We are extremely grateful to the Yuba River Endowment for giving this amazing organization a solid financial foundation again."

Yuba-Sutter TIP currently has 30 volunteers who provide immediate emotional and practical support to survivors of tragedy. They cover both Yuba and Sutter counties, serving all 35 emergency agencies and Adventist Rideout Hospital. TIP volunteers are available

24 hours a day, 365 days a year, and respond to all types of tragedies, some of which include accidents, suicides, homicides, drownings and fires. There are currently 14 regional chapters of TIP in the nation, serving over 250 cities. The Yuba-Sutter TIP chapter is the only one completely funded by donations.

"Most of us had no idea the vital role TIP volunteers play for our local first responders," said Yuba River Endowment President, Al Lassaga. "Our community is blessed to have a TIP chapter, and these dedicated men

and women. They are truly our unsung heroes."

The Yuba River Endowment is a non-profit organization created by Yuba County farmers who have a right to water that flows on the Yuba River. While it did not happen last year, in some years the farmers are able to sell a portion of their water to drought-stricken areas of the state. Proceeds from these transfers provide the funding for the Yuba River Endowment. Since formation in late 2019, the Endowment has donated over \$300,000 to support

Yuba County ag education, provide food resources, veteran's support, and much more.

"As farmers, we are long-term members of the community," Lassaga said. "Our roots are here and if there's something we can help with, we're going to do it."

# ‘Stories of the Museum’

More than a thousand military men and women and family members have donated thousands of personal items and stories to the Museum of the Forgotten Warriors over the past forty years. The displays span World War I to the conflicts in Iraq and Afghanistan and tell the stories of those who fought and died. ## Gunner's Mate 3rd Class Frank Carson A Pearl Harbor Survivor

Gunner's Mate 3rd Class Frank Carson was at his cleaning station topside aboard battleship USS Oklahoma (BB-37). He and another young sailor watched with surprise as a group of planes descended on battleship row that infamous Sunday morning. Surprise turned to horror as the Nakajima B5Ns, known as Kates, began dropping torpedoes hitting the twenty-five-year-old oil burning dreadnought. The ship be-

gan to list badly to port and finally capsized as Carson crawled up the side of the ship toward the keel that now was out of the water. Finding he was unable to go any farther, he turned, slid feet first fifty feet down the ship's side, and disappeared into the flaming, oily sea.

The bay was filled with men in various stages of distress.

Carson surfaced and began swimming toward the battleship USS Maryland (BB-46), moored in the next berth. He had swallowed a lot of oil, was sick, and was having difficulty breathing as he fought his way toward safety. Someone grabbed at him and dragged him under. Carson broke the man's hold, surfaced, and continued swimming. He man-

aged to reach his destination, found a Jacobs ladder to the main deck, and reached safety.

"I was covered with fuel oil from head to toe, and I'd swallowed a bunch of it, and I was deathly sick when I got over on the Maryland. But I got over it and got in an ammunition train passing ammunition to one of their guns."

After the attacks, Carson was assigned to a working party on shore picking up the dead and wounded. The dead were stacked like cordwood in one of the bombed-out hangars.

"I will never forget that 'cause the smell of burnt flesh, and it would stick to your hands if you'd pick 'em up. It was weeks before I could even put my hands up without imagining I could smell it."

Just thirty-two men survived; 429 were lost, the majority entombed below decks.

After months of recovery, Carson was reassigned to a destroyer and participated in the Battle of Savo Island, the first major naval engagement of the Guadalcanal campaign on 8-9 August 1942.

"We lost four heavy cruisers that night: USS Vincennes (CA-44), USS Astoria (CA-34), USS Quincy (CA-39), and HMAS Canberra. I had the misfortune of being in on

two of the worst defeats we suffered during the war."

Carson left the Navy at the end of the war, a chief gunner's mate, having served for six years. He returned to Tennessee a decorated veteran hero and served as a state game warden until retirement.

Chief Gunner's Mate Frank Carson is an uncle of Roberta Spear, the museum's owner. His donation may be viewed in glass case marked C-20.

## Bitcoin Bust and Trust

The latest news in the market resembles the 1950's radio disc jockey that shouted between songs "and the hits just keep on coming".

Previous Wall Street darling stocks manage to get off the mat after being hammered down 70, 80, 90 percent or more, only to be carpet slammed again by another brutal sell off on any given day. Relentless is the word that comes to mind.

Crypto fans who dabble in the Bitcoin universe and thought they were safe are finding out they too are not immune from the markets financial beat downs.

More than a handful of cyber coin dealers and marketers have had liquidity problems in the past few weeks with some halting or limiting redemptions. The so called "stable" coin, Terra USD, which was supposed to remain in lockstep with the US dollar, lost its mojo as it not only failed to maintain its peg to the dollar, but almost completely collapsed. Now the news wires contain almost daily headlines that major players in the crypto universe are having some very serious financial issues.

Warning multiple times Cyber coins were "vapor", I reiterate a direr warning again today that the whole cyber universe reeks of an out of control mania that will end badly. In fact, the cyber coin phenomenon is the worst mania ever when compared to previous price explosions in any other asset mania recorded in human history.

Unfortunately, these types of liquidity headlines have a tendency to become only more frequent, until the "one" headline that announces a total collapse of the asset in question or that of a major player hits the wires and causes an all-out panic wipe out.

Not saying it will happen of course, as no one can forecast the workings of financial markets, but the whole thing has a very familiar ring to it.

Since Bitcoin came to my attention about 7 years ago, I didn't trust it and written such in more than a handful of news articles and covered it on my radio show multiple times over the years.

The coins themselves, called tokens, are not guaranteed by any government, and the market has grown into the trillions. It is estimated over 100 billion worth of bitcoin accounts have been lost in cyber space due to password loss or theft. The actual numbers may never be known. Never knew anyone who lost a bank or stock account.

This brings another issue to light that bothers the heck out of me. Truthfully I don't fully understand the whole cyber coin thing, how it works, who runs it, and all the ins and outs of this relatively new version of electronic currency, and frankly I believe few do.

With trillions in cyberspace, not doubt there are many, many hands in the mix, of which we have no idea of their moral makeup and honesty versus their self-interests. We also know that there are tens of thousands of very computer savvy thieves running amongst them.

With no one you can call or ask for assistance from, an investor is at the mercy of this vast and complicated electronic universe. Making matters worse, it has no checks or balances that apparently work right and there is little to no regulatory oversight at this time, although some is pending by concerned governments.

The whole things is downright frightening to this analyst.

And finally, I am surprised one of the reasons proponents of Bitcoin tell me they want to invest in it is that governments can't mess with it and cyber coins autonomous qualities. Excuse me, but Bitcoin and other cyber currencies are anything but autonomous. A dollar bill or gold coin has no memory, which is to say what it was spent on is forever unknown to the next holder. Look at a dollar and tell me what is has bought. Ditto with gold and silver coins. Cyber coins however, being in cyber space, forever maintain a record of where and when it moved. This is the ultimate in a tracking history should governments wish to install themselves more into the universe of Cyber. That the anti-government and conspiracy crowd flocks to this anti-cash asset where its record keeping is airtight and written in stone forever, is to me, more than baffling.

## How Taxes are Decided in California

Let's start with the premise that taxation is largely arbitrary.

Despite efforts to frame tax policy in moral or at least philosophical terms, what or who is taxed and the form and level of that taxation merely reflect current political priorities.

Take, for example, South Lake Tahoe, a small city that sits on California's border with Nevada. If you live in that city, you pay the nation's highest state income taxes. However, if your home is located a few feet to the east, inside Douglas County, Nevada, you pay no state income taxes.

That explains why there's a steady rivulet of high-income Californians resettling in Nevada, or at least changing their official addresses. If a couple of pending California ballot measures are approved in November, state taxes on the wealthy will increase even more and Nevada will become an even more popular tax refuge.

California's income taxes became the nation's highest through a series of incremental decisions made by legislators or voters and they now provide more than two-thirds of the state's general fund revenue. Nevada, on the

other hand, makes do without taxing incomes.

So which state is correct? Neither. They just happened to take different taxation paths for different reasons.

The arbitrary nature of taxation is evident, too, within the California revenue system, particularly in sales taxes.

One oddity is that cold food is not subject to taxation but hot food is and the differential can be very difficult to sort out. Some years ago, a movie theater chain asked the state Board of Equalization to shift popcorn from being a taxable hot food to a tax-free cold food. The rationale was that by the time theater patrons returned to their seats with popcorn in hand, it had turned cold. The board agreed.

If someone buys computer software, such as Turbo Tax, in a store to file federal and state income tax returns, that purchase is subject to a sales tax. But if a large company obtains a custom computer program to prepare its tax returns, the purchase is free of sales taxes. Why? Because those who sell custom software lobbied the Legislature for an exemption in the 1980s.

The Legislature, at the behest of Gov. Gavin Newsom, is on the verge of enacting a new and especially questionable tax anomaly.

One budget trailer bill would impose a hefty new tax on the embryonic industry of extracting lithium from the brine of the Salton Sea in the Southern California desert.

Lithium is the key ingredient of long-life, rechargeable batteries used in everything from cellphones to electric cars and immense electrical energy storage banks and therefore plays a key role in the state's drive to make itself carbon-free.

Most lithium is imported from other countries, including China. The Salton Sea, however, is a potentially huge source of the mineral that, if developed, would both contribute to energy independence and create many new jobs in an economically depressed corner of the state.

Lithium companies have warned that taxing extraction, \$400 to \$800 per metric ton, would make California lithium more expensive than imports and discourage investment in the industry, but were ignored.

Another trailer bill, however, would give sellers of legal marijuana a hefty cut in taxes, responding to their complaints that taxation makes their product too expensive vis-à-vis pot from illegal growers and sellers.

So California politicians may be strangling an industry vital to their vision of a carbon-free future while encouraging – in essence, subsidizing – an industry that helps people get stoned.

That's about as arbitrary as it can get.

# Supreme Court Narrows EPA’s Ability to Regulate Carbon Dioxide Emissions

The Supreme Court ruled 6–3 on June 30 that the Clean Air Act doesn’t give the U.S. Environmental Protection Agency (EPA) widespread power to regulate carbon dioxide emissions that a popular theory says contribute to global warming.

Chief Justice John Roberts wrote the court’s majority opinion in *West Virginia v. EPA*, court file 20–1530. Roberts was joined by the court’s other five conservatives. The court’s three liberal justices dissented.

While “capping carbon dioxide emissions at a level that will force a nationwide transition away from the use of coal to generate electricity may be a sensible ‘solution to the crisis of the day,’” Roberts wrote, quoting a 1992 precedent, “it is not plausible that Congress gave EPA the authority to adopt on its own such a regulatory scheme in Section 111(d)” of the Clean Air Act.”

“A decision of such magnitude and consequence rests with Congress itself, or an agency acting pursuant to a clear delegation from that representative body,” he wrote.

West Virginia and 18 other states challenged the authority the Clean Air Act provides the EPA.

In 2016, the Supreme Court overturned the Obama-era Clean Power Plan (CPP), which expanded controls over the industry. Next, the deregulation-minded Trump administration reversed course, easing control on the industry with its Affordable Clean Energy Rule (ACE Rule).

On Jan. 19, 2021, the U.S.

Supreme Court Chief Justice John Roberts

Court of Appeals for the District of Columbia Circuit struck down the ACE Rule, restoring some of the EPA’s authority in *American Lung Association v. EPA*. The court held that the EPA, under Trump, had misconstrued section 7411(d) of the Clean Air Act.

In the new opinion, the

Supreme Court reversed the D.C. Circuit decision and remanded the case “for further proceedings consistent with this opinion.”

In Justice Elena Kagan’s dissent, she criticized the court majority for a decision she said “strips” the EPA of the power Congress gave it to respond to “the most pressing environmental challenge of our time,” citing *Massachusetts v. EPA* (2007).

“Climate change’s causes and dangers are no longer subject to serious doubt. Modern science is ‘unequivocal that human influence’—in particular, the emission of greenhouse gases like carbon dioxide—‘has warmed the atmosphere, ocean and land.’”

“Whatever else this Court may know about, it does not have a clue about how to address climate change. And let’s say the obvious: The stakes

here are high. Yet the Court today prevents congressionally authorized agency action to curb power plants’ carbon dioxide emissions. The Court appoints itself—instead of Congress or the expert agency—the decision maker on climate policy. I cannot think of many things more frightening.”

West Virginia Attorney General Patrick Morrisey, who previously told *The Epoch Times* that the EPA is trying to transform itself from “an environmental regulator into a central energy planning authority,” praised the Supreme Court.

“For many years, we’ve argued that EPA only had a narrow bit of authority to regulate carbon emissions,” Morrisey, a Republican who brought the appeal, said at a press conference.

“I think that the court today

amplified that point. And once again, they also made clear that when you have something this big, something with vast economic and political significance, then that represents an extraordinary question. And that means Congress needs to step in, as opposed to the unelected bureaucrats.

“We know that over the last year and a half, the Biden administration has tried to run roughshod over the American economy with respect to its energy agenda.

“We want to make sure that the Biden agenda is limited by basis of what Congress authorized these agencies [to do],” he said.

“Our founders envisioned” that “Congress and not the unelected bureaucrats” should make decisions “about the major issues of the day.”

“They didn’t want to just have these unelected bureaucrats reach out and try to seize power where it didn’t exist,” Morrisey said.

U.S. Sen. Bob Menendez (D-N.J.) criticized the ruling and the six conservative justices.

“As the devastating impacts of climate change are becoming ever-more present, it is mind boggling and deeply alarming that the Supreme Court today has decided to hamstring the EPA’s authority to regulate greenhouse gases. This ruling not only restricts the agency’s ability to limit air pollution from the second-largest source of emissions in America, it also undermines the landmark Clean Air Act that gave it such authority,” the senator said.

“Make no mistake, with this devastating ruling in *West Virginia v. EPA*, the conservative majority of the Court continues to take our country backward and more worrisome, it opens the door to far-reaching implications for how other federal agencies generally create regulations to implement existing legislation moving forward.”

# After 53 Die in Smuggling Tragedy, Texas Governor to Start Truck Checkpoints on Highways

EAGLE PASS, Texas—The Texas Department of Public Safety (DPS) will be setting up random highway checkpoints to inspect trucks following the deaths of 53 illegal immigrants who were being smuggled in the back of a tractor-trailer earlier this week.

“We’ve seen increased brazenness by cartels that feel empowered, because we do not have a federal government that’s pushing back against those cartels and their illegal activity,” Gov. Greg Abbott said at a June 29 press conference in Eagle Pass, one of the busiest regions for illegal border crossings in the country.

“And of course, the worst thing of all is the catastrophic death that we have witnessed.”

DPS Director Steven McCraw said state troopers will assist civilian inspectors in setting up checkpoints along

the main highways running from the Texas–Mexico border to San Antonio, Houston, and other major hubs.

Often, illegal aliens wade or are rafted across the Rio Grande into Texas and, while avoiding Border Patrol, are taken to stash houses to await vehicle transport further into the United States.

McCraw said he also plans to deploy DPS special agents to identify stash houses near the border, “which is very important to disrupting Mexican cartel operations.”

The truck that was carrying the illegal immigrants who died in San Antonio passed through a Border Patrol highway checkpoint 30 miles north of Laredo on Interstate Highway 35, McCraw told *The Epoch Times*.

The checkpoint often has two truck lanes and three car lanes operating simultaneously.

Tom Homan, the former chief of Immigration and

Customs Enforcement, told *The Epoch Times* that smugglers will turn off the freezer unit in refrigerated trucks to give the appearance that it’s an empty trailer and that there’s no need for a secondary inspection.

The refrigeration was turned off in the truck in San Antonio and there was no water inside, even as the mercury topped 100 degrees.

“The truck passed through a Border Patrol checkpoint, it was not inspected. It was not inspected because the Border Patrol does not have the resources to be able to inspect all of the trucks,” Abbott said.

“Many of these deaths could be prevented if Biden simply fully funded the Border Patrol operation of the United States of America and implemented the policies that the Border Patrol needs in order to do their real job. And the real job is not the paper processing work that they’ve been assigned to do.”

President Joe Biden called the deaths in San Antonio “horrible and heartbreaking,” and he vowed to crack down on the criminal smuggling organizations.

“Exploiting vulnerable individuals for profit is shameful,” he added.

White House press secre-

tary Karine Jean-Pierre told reporters on June 28, “The fact of the matter is the border is closed, which is in part why you see people trying to make this dangerous journey using smuggling networks.”

Since Biden took office, the number of illegal crossings has hit multiple record highs. Border Patrol has apprehended more than 3.2 million illegal immigrants since January 2021, according to Customs and Border Protection data.

Four people have now been arrested in connection with the truck smuggling operation that resulted in the 53 deaths, according to the U.S. Department of Justice.

Homero Zamorano, the driver of the truck, was charged

on June 29 with one count of alien smuggling resulting in death, and Christian Martinez, 28, was charged with one count of conspiracy to transport illegal aliens resulting in death.

If convicted, both Zamorano and Martinez face up to life in prison or potentially the death penalty.

Two Mexican nationals, Juan Francisco D’Luna-Bilbao and Juan Claudio D’Luna-Mendez, were arrested on June 27. The men have each been charged with three firearm-related offenses after exiting a San Antonio property listed as the registered address of the truck used in the smuggling operation. Both had overstayed their B-2 visas.

"California's fish, wildlife and their habitats are facing continued impacts from climate change including persistent drought conditions," said CDFW Director Charlton H. Bonham.

The approved projects complement CDFW's ongoing initiatives toward species recovery and provide resilience to climate change, representing priorities outlined in the solicitation, as well as the California Water Action Plan, State Wildlife Action Plan, Sacramento Valley Salmon Resiliency Strategy, Delta Plan, California EcoRestore, Safeguarding California Plan, the California Biodiversity Initiative and the fulfillment of CDFW's mission.

Projects approved for

funding through the Prop. 1 Watershed Grant Programs include:

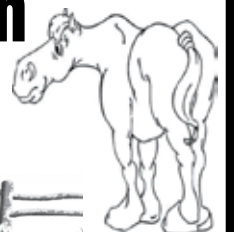
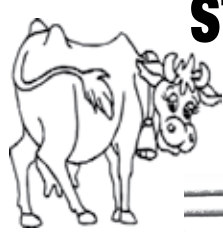

Jedidiah James Wright, 30, was found guilty of a single count of second-degree murder following a six-day jury trial, and two full days of deliberations. The charge stemmed from an incident at Comanche Creek in Chico,

Butte County District Attorney Mike Ramsey said that during the trial, evidence was presented that in the summer of 2021, both Wright and Snoberger were living at the homeless encampment in the Comanche Creek Greenway near the intersection of E. Park Avenue and the Midway. Snoberger had a camp near the front north entrance, while Wright had a camp near the south back of the camp.

Witnesses from the encampment testified during the trial that Snoberger had just returned from a convenience store down the street and was at his camp when Wright approached and asked his name. Snoberger identified himself and was almost immediately stabbed directly in the chest by Wright with a two-inch long knife he had concealed in his back pocket. A later autopsy showed the knife pierced Snoberger's heart leading to his rapid death. Evidence was also presented that the attack was

Ramsey said his trial attorneys, deputy district attorneys

Jessica Miller and Stephanie Roose, argued to the jury that even if Snoberger swung on Wright prior to the stab, self-defense was not applicable as Wright used much more force than was necessary to defend himself against the older and smaller Snoberger. In addition, evidence was presented at trial that Wright was friends with a man that Snoberger had bested in a fight the day before. The prosecutors proposed the attack on Snoberger was in retaliation for that earlier fight and that Wright had

Wright remains in custody at the Butte County Jail with no bail. He is currently scheduled for sentencing on June 30, 2022, at 9:30 a.m. where he faces a 16-year to life term in state prison. ★

# McClintock’s House Floor Remarks on the January 6th Committee

**WASHINGTON, DC (MPG)** - Congressman McClintock delivered the following remarks on the House floor discussing the January 6th Committee.  
*House Floor Remarks

June 15, 2022*  
*On February 27, 1933, the Reichstag – Germany’s Capitol building – was set on fire. Who was responsible remains in dispute even today. What is undisputed is that the Nazis, barely holding onto power in a coalition government – used the attack to besmirch their political opponents, consolidate*

*their grip on the government, arrest hundreds of political opponents, and ultimately rescind the due process rights and fundamental freedoms of the German people.*  
*It remains a cautionary tale, for obvious reasons.*  
*The January 6th riot at the Capitol has become the centerpiece of the Democrats’ agenda. No other issue facing our country – not the worst inflation in 40 years, not the highest gasoline prices in history, not the fastest increase in homicides ever recorded, not the historically unprecedented illegal mass migration at our southern border – none of these crises has commanded prime time congressional hearings from the Democrats.*  
*What happened here on January 6th was an affront to our Constitution and a national disgrace. Those who entered the Capitol with the intent to disrupt the counting of electoral votes deserve to be denounced by their fellow citizens and prosecuted to the fullest extent of the law.*  
*More importantly, questions involving the authority of Congress to refuse to count electoral votes, or why adequate security was not present to protect*

*the Capitol, or whether there were conspiracies to break into the Capitol, are all important to fully resolve to assure that this never happens again.*  
*What is unfolding instead is a sick mockery of the principles of fairness and due process that this House is founded upon. It promises to discredit these proceedings and to dishonor its participants.*  
*Congress has a time-honored process to get at the truth. It guarantees the right of both sides to appoint their representatives, who then question and debate the facts, offer conflicting evidence, and hold an issue to every light. For the first time in the history of this institution, the Speaker arrogated to herself not only the selection of the majority members, but the minority members as well, thus assuring only one side – her side -- would be heard.*  
*Without having both sides represented, it becomes impossible to test the accuracy of facts, the truth of narratives and the soundness of opinions. And it robs the process of the credibility that is a necessary pre-requisite to legitimacy.*  
*Instead of the sober inquiry that should have been undertaken a year and a half ago, we have a*

*Soviet-style show-trial, all carefully choreographed by an ABC television producer.*  
*To add hypocrisy to outrage, some of the speaker’s representatives played a crucial role in developing and fanning the Russia collusion hoax that groundlessly challenged the legitimacy of the Trump election and presidency. Some were themselves involved in challenging electoral votes counted after the 2016 election. Some were apologists for the violent riots that consumed this country in 2020. Some have been eerily silent as Supreme Court justices have been intimidated in their own homes.*  
*The FBI thoroughly examined the riot last year and found no evidence that President Trump conspired with protesters to enter the Capitol. Nor have the Democrats offered any now. They instead repackage and rehash the snap impeachment trial in which the President was acquitted by the Senate.*  
*Indeed, this committee knows, but has deceptively suppressed, the stunning fact that FOUR DAYS before the riot, President Trump offered the use of National Guard troops to keep the peace. The Democrat leadership turned it down. Do they really expect us*

*to believe that the same guy who meticulously planned the riot also authorized the National Guard to prevent the riot? This is insane.*  
*Insurrection? The constitutional process immediately resumed once these yay-hoos were kicked out of the building. Do the Democrats actually expect us to believe that some lunatic wearing buffalo horns was moments away from seizing control of our government? Their narrative cannot survive an open debate and the Democrats know it. That’s why they’re not permitting one.*  
*Our institutions are strong because they are backed by the common sense of the American people. Our traditions of due process and fairness are too deeply engrained in the American character to succumb to this madness. After Americans have recorded THEIR verdict in the upcoming election, perhaps we can forge a bi-partisan consensus on the measures necessary to assure that the excesses of both January 6th AND the January 6th Committee never threaten us again.*

## Can Sanity Prevail in California?

Victor Davis Hanson is a resident scholar at the Hoover Institute and lifelong Californian from the Central Valley. He recently spoke at a conference of Howard Jarvis Taxpayers Association members. For the naïve who want an optimistic presentation about how great California is, VDH is not your guy. He gives an accurate, if depressing, view of the current state of the state. In both his writings and speeches, he assesses just how far California has deteriorated; from homelessness, poverty, cost of living, crime, taxes, business climate, etc., ad nauseum.  
The decline of California has, as most know, led to an unprecedented exodus out of the state. So much so that for the first time in its history, California has lost representation in Congress. In addition to the 2 million people who have already left California, far more are seriously considering it. Facebook now has a group called “Life after California” with rapidly

growing membership, but most Californians are unlikely to leave, at least anytime soon. They will stay either because they are willing to tolerate all that is wrong here, or they are not able to leave.  
A Central Valley farmer isn’t going to pick up his orchard and move to Texas, neither is the retired couple who want to stay close to family members, including grandchildren but simply because tens of millions will stay in California does not mean they are oblivious to its ills.  
Those deciding to stick it out here in the formerly Golden State are constantly on the lookout for some faint signs that things might get better. The primary election returns might provide such a sign, although it would be foolish to believe there has been a political sea change.  
First, the good news. It now appears that voters in the most liberal city in America have had it with rising crime. Given that you can count the number of Republicans in San Francisco on two hands, the rejection of the city’s District Attorney, Chesa Boudin, certainly wasn’t a partisan fight. San Franciscans of all political stripes simply felt unsafe on city streets as tens of thousands had their cars or homes broken into. It doesn’t take a conservative to want serious criminal acts to result in serious criminal penalties, including incarceration.  
The similarly Soros-backed

district attorney of Los Angeles, George Gascón, wasn’t on the ballot, but it appears he is in deep trouble as he tries to deflect a recall of his own. Also, L.A. mayoral candidate Rick Caruso, previously a Republican and now registered in the Democratic party, is headed to a runoff against progressive Democrat Karen Bass, currently in Congress and previously Assembly leader.  
As in San Francisco, crime and homelessness are top issues.  
Throughout California, even within Democrat-on-Democrat races, the more moderate candidates seemed to be outperforming their more progressive counterparts, although many races remain too close to call.  
Whether California’s election results represent a meaningful shift away from radical progressivism or merely a blip in the relentless leftward movement in California is the subject of a national debate. Even the New York Times wrote that the recall of Boudin was “a stark warning to the Democratic Party.”  
It is way too early to predict a significant return to sanity in California, and November’s election results will be more telling. But for now, even a slight movement toward responsible politics is a welcome change.  
As the Chinese proverb reminds us, a journey of a thousand miles begins with a single step. ★
