No Gas for You



California unveils proposed measure to ban new gasoline-fueled cars. MPG file photo

California's clean-air regulators unveiled a far-reaching proposal requiring a ramp-up in sales of zero-emission cars, culminating in a ban on new gasoline-powered cars by 2035.

The rules to force Californians to end their dependence on conventional cars are a critical component to California's goals to tackle climate change and poor air quality.

If adopted by the California Air Resources Board this summer, the regulations would be the first in the world and could pave the way

for nationwide standards. At least 15 other states pledged to follow California's lead on car standards on previous clean-car rules, and the federal government usually follows.

Carrying out Gov. Gavin Newsom 2020 executive order ordering the board to end the sale of gas-powered cars in California by 2035, the new proposal sets in motion the public regulatory process. Public comments will be collected for 45 days, then a hearing will be held on June 9 and the board is expected to vote in August.

"This is a hugely important inflection point. This rule finally, definitively puts us on the path to

100% zero-emission vehicles," said Daniel Sperling, a member of the Air Resources Board and founding director of the University of California, Davis Institute of Transportation Studies.

An alliance representing nearly all automakers said in a statement Wednesday that they are "committed to electrification and a net-zero carbon transportation future." Many major manufacturers, including General Motors, have already announced goals to ramp up clean-car models on a similar timeframe.

But the automakers added that it's critical for governments to ensure

Yuba City Implements Mandatory 20% Water Conservation

City of Yuba City News Release

YUBA CITY, CA (MPG) - The City of Yuba City will begin implementing an information and education campaign for Stage 3 (Severe Shortage) of its Water Shortage Contingency Plan.

The transition and outreach will begin May 1, 2022, and enforcement will begin June 1, 2022. This is a direct response to the current water supply shortage occurring with the ongoing drought and the recent issuance of a state executive order calling for 20% water conservation compared to 2020 usage.

This stage of water conservation implements required water restrictions, including limited irrigation days to achieve the 20% goal. The City will begin issuing water violations on June 1, 2022, for the following: Irrigation limited to Mondays and Thursdays for ALL property addresses - mornings and evenings recommended to reduce evaporation.

Water waste is a water violation, including Irrigation outside of designated times. Excessive watering resulting in gutter flooding. Using a hose without a shutoff nozzle. Washing down hard surfaces such as sidewalks and driveways. Using a non-recirculating fountain. Not repairing leaks in a timely manner.

A Water Conservation Guide for Summer 2022 is included in customer's utility bills for the month of April, which provides information and resources. For further information or assistance regarding available water conservation rebates or irrigation timer adjustments please contact the Public Works Department at (530) 822-4626 or publicworks.admin@yubacity.net, visit www.yubacity.net/water, or submit a request via the City's yc311 online customer service system and app.

The city also recommends that water customers monitor their water conservation efforts in real time by signing up for a free EyeOnWater account, which provides up-to-the minute water meter data delivered directly to the customer via a consumer engagement website and smartphone/tablet app. To set up an account, visit <https://eyeonwater.com/signup>. Catalytic Converter Thefts Lead to Search Warrant and Arrest

OLIVEHURST, CA (MPG) - Yuba County Sheriff Detectives and Patrol Deputies served a search warrant on April 21 at approximately 9:00 a.m. and discovered a stolen vehicle and auto parts chop-shop operation at a dilapidated residence in the 1600 block of Broadway Road in south Olivehurst.

The owner/occupant of the property, identified as 59-year-old William Morrissey, was located at the home and placed under arrest for Auto Theft, Possession of Stolen Property, Possession of a Controlled Substance, and Drug Paraphernalia. Yuba County Code Enforcement also responded to the scene and declared the home unsafe to occupy.

Today's search warrant and subsequent arrest was the result of a several-months-long investigation into catalytic converter thefts in the community. Dozens

of auto parts were seized from the property, including several catalytics. Additionally, during the course of the investigation, approximately 30 catalytics were intercepted and seized from shipments allegedly made by Morrissey to mail-in recycler businesses.

Locating owners of stolen catalytics can be difficult since the parts do not

usually contain any identifying properties to trace back to victims. We encourage vehicle owners to have identifying information, such as your driver's license number, etched onto these valuable parts. Catalytic converters are commonly targeted for their precious metal content. If you have been a recent victim of a catalytic converter theft and your part had an

identifiable mark or number on it, please contact our department to see if we may have recovered your stolen property.

A second subject contacted on scene, identified as Roy Crabb age 47, was arrested for several outstanding warrants including a violation of parole. Both Crabb and Morrissey were booked into the Yuba County Jail. ★

that “everything from (electric car) infrastructure, demand, critical minerals and supply chain are in place.” Even then, the companies said the state’s proposed rules “will be extremely challenging even in California and may not be achievable” in other states.

If enacted, 35% of new cars, SUVs and small pickups sold in the state must be zero-emission starting with 2026 models, then increasing yearly, reaching 51% of all new car sales in 2028, 68% in 2030 and 100% in 2035. Of those, 20% can be plug-in hybrids.

The rule does not apply to sales of pre-owned cars, and it wouldn’t do anything to force the millions of existing gasoline-powered cars off roads. Only about 2% of cars on California’s roads were zero emissions in 2020.

Vehicles that run on gasoline or diesel fuel are the state’s biggest sources of planet-warming greenhouse gases, smog and dangerous particles. Under the proposed regulation, about 384 million fewer metric tons of greenhouse gases will be emitted between 2026 and 2040, according to air board staff — a little less than the total amount that the state emitted in 2019 across its economy.

California has already enacted standards that will require roughly 8% of new cars sold in the state to be zero emission in 2025, according to air board staff. That goal already has been exceeded: About 12% of California’s 2021 new vehicle sales were clean cars, according to state data.

But the pace would have to triple in just five years to reach the new target, which the automakers dubbed “aggressive.”

One of the biggest roadblocks could be the lack of charging stations for electric cars. Nearly 1.2 million chargers will be needed for the 8 million zero-emission vehicles expected in California by 2030, according to a state report. Right now, there are only about 70,000 with another 123,000 on the way, falling far short.

Another obstacle is the cost of the vehicles. “The cost to manufacturers will be high per vehicle in the early years, but significantly decrease over time by 2035,” the air board’s staff report says.

The economic benefits of the mandate are expected to exceed the costs: The costs could run \$289 billion over the lifetime of the rule while the economic benefits could reach at least \$338 billion — a net benefit of \$48 billion, according to air board staff.

Electric cars now cost more to purchase, but price drops plus savings on gas and maintenance would add up, saving consumers an estimated \$3,200 over ten years for a 2026 car and \$7,500 for a 2035 car, the air board calculated.

In an effort to address consumer

reluctance, manufacturers would be required to meet minimum performance, durability and warranty requirements for zero-emission vehicles. Cars must be able to drive at least 150 miles on a single charge, up from the current 50-mile mandate, and batteries will need to last longer and carry a manufacturer’s warranty.

The goal is to ensure that new and used zero-emission vehicles “can serve as full replacement vehicles for conventional vehicles in every household in California,” the air board says.

Environmental advocates had raised concerns about previous drafts, saying they ramped up too slowly, allowing millions of cars powered by fossil fuels to remain on the roads since the average car

is driven for 12 years.

Starting at a sales requirement of 35% is “a marked improvement,” said Don Anair, research and deputy director of the Union of Concerned Scientists’ clean transportation program. Still, he said, “It’s kind of the bare minimum. So we really see that as a floor, not a ceiling, to get started.”

Environmental groups urged the board to set a more stringent target of 75% zero-emission sales in 2030. They also are seeking mandatory equity provisions that would ensure electric cars are in communities that suffer the most pollution.

Under the proposed rule, car manufacturers would be allowed to meet a small portion of their sales targets through 2031 with credits aimed at helping low-income

residents. For instance, they could earn credits for selling less-expensive new zero-emission cars costing less than \$20,000 or ensure that vehicles are offered up for resale in the state.

Last year Newsom approved a \$3.9 zero-emission vehicle budget that included about \$1.2 billion to bolster rebates and other clean-car incentives, particularly for low-income and disadvantaged communities. Another \$300 million will go toward building charging and fueling infrastructure.

Newsom touted the \$10 billion zero-emission vehicle funding package in his January budget blueprint, which he said would “expand access and affordability for all.”

The state auditor has warned the Air Resources Board, however, that it “has generally not determined the effects its incentive programs have on consumers’ behavior and thus, has overstated (greenhouse gas) emissions reductions its incentive programs achieve.”

While battery-powered cars emit no pollutants, the generation of the power that runs them does. However, air-quality regulators say emissions from electricity generation are far lower than from vehicles. Much of California’s electricity comes from natural gas, solar, wind and hydropower.

Other nations are on similar paths toward phasing out fossil fuel-powered vehicles, but no state or nation has adopted a rule that bans them. However, the European Union is considering a large package of climate change laws that would, in effect, prohibit fossil fuel cars by requiring a 100% cut in all carbon dioxide emissions by 2035.

California’s proposal comes as gas prices soar to more than \$5 per gallon in the state. Critics say the Newsom administration is sending mixed messages about gasoline-powered cars by proposing rebates for car owners.

The zero-emission vehicle proposal will require approval of the U.S. Environmental Protection Agency for implementation. Since the 1960s, the state has led the country in cleaning up the exhaust that creates California’s choking smog. The federal Clean Air Act gave California authority to set its own tailpipe emissions standards.

The Trump administration acted to eliminate that authority but President Joe Biden’s EPA overturned the decision in March. Newsom called it “a major victory for the environment, our economy, and the health of families across the country” and said the state “looks forward to partnering with the Biden Administration to make a zero-emission future a reality for all Americans.” ★

California Comment on the Small-Business Inflation and Exacerbating the Crisis

SACRAMENTO, CA (MPG) - The release of a special survey on inflation conducted by the nation's largest and leading small-business association highlights a huge 'Made in California' problem, according to the state director for the association that conducted the sampling.

"Inflation is devastating small businesses across the nation, and energy prices are an out-sized culprit," said John Kabateck, California state director for the National Federation of Independent Business (NFIB), which took the survey of its small-business-owning membership. "Although there are many national factors contributing to soaring inflation rates, states can either help alleviate the problem or exacerbate it, and California is exacerbating the problem in a huge way with the energy policies it has put in place," said Kabateck.

Kabateck pointed to a recent NFIB California

podcast interview with Catherine Reheis-Boyd for some of the reasons why. On the podcast, the president and CEO of the Western States Petroleum Association says: "We can actually produce crude oil in a low carbon intensity way. Why would we not want to do that?" One reason we don't is California's singular way of having policies that not only harm its economy but also hamper its own environmental goals.

"We produce only 30% of the crude we need. Could we produce more? You bet we could produce more. If we don't produce more, it just means more foreign imports, which increases greenhouse gases, loses jobs, loses tax revenue for the state. There is no logical reason why you would not want to produce more crude oil in California versus importing it.

"Oil is not the enemy. Emissions are the enemy."

Selected Highlights from the Inflation Survey

More than half (62%) of small-business owners reported inflation having a substantial impact on their business; 31% said it was having a moderate impact.

Nearly all (99%) of small-business owners reported the recent increase in gas and fuel prices is having some degree of negative impact on their business.

More than three-quarters (77%) of small employers reported rising fuel costs (gasoline, diesel, fuel oil, etc.) was a substantial contributor to higher costs.

Eighty-six percent of small employers are increasing the price of the goods or services. Thirty-one percent of small employers are taking on debt to finance higher costs.

"Inflation is a new challenge for most small business owners. Inflation has reached levels not seen for the last 40 years and is dominating business decisions for small employers across the country. Small business owners have been adjusting business practices in order to compensate for inflation pressures resulting from supply chain disruptions, staffing shortages, and rising gas prices."

When Markets Fall

With the markets in free fall, investors are scrambling as to what to do. The buy and hold belief works great when markets are normal, but during times of severe pull backs, the pain of seeing ones hard earned savings evaporate daily the conviction to stay the course is difficult to say the least.

Indeed, over the long term, the chart of the Dow is up, and the current pull back on a long term chart is just one of many small familiar dips. That said, times like these do make some investors pull the rip cord and jump out of the market. Historically, that has not worked well as in the past the markets have always come back and jumped higher than it was previous to the crash. Just take a look at the Dow chart.

Those that do pull out, in my experience, just sit on the side lines and don't get back in until there are many months, even years of a prolonged recovery, only to get back in way late to the party and missing out on huge recovery gains. Once again, becoming unknowing victim of FOMO (Fear of missing out) and sometimes get back in right when the next correction is upon us.

I once believed the buy and hold strategy was the ticket, until 1987, when, as young trader, I saw \$400,000 fall to \$220,000 in one day when the Dow crashed 22.6%. It recovered but the painful memory is still with me to this day.

The stress on me was unimaginable and I vowed to never make that mistake again.

I have rarely gone to all cash, with the exception of 2008 and March of 2020. Both of these events were complete obliterations of capital as markets cratered mercilessly. There were other times when I wished I had been in all cash. Hey it happens. But usually I exercise a middle ground strategy where as the market falls, I sell stocks on the way down, a little at a time. There are many indicators I look at that help me decide when to sell, but the obvious one is the market itself.

If markets persist in cratering down, my cash percentage gets larger and larger. This accomplishes three things:

1. Gets me out slowly, helping protecting my capital from a complete obliteration (hey it can happen). Some

analysts are calling for more downside. ****

2. Builds "dry powder" for a rebound if and when it occurs.
3. Eases the pain of the fall as being proactive gives me a feeling I am doing something and not just sitting there losing money daily and hoping it stops.

The combination of these three actions and mental thoughts not only makes me not so anxious, but is smart money management in my opinion. Validating this opinion is the fact that almost all professional traders practice some sort of loss limiting practices. They know being wiped out is always a possibility. If the professionals do it, it's probably a good idea right?

For those listening to the buy and hold crowd, I would ask:

When told that, does it ease the pain even a little bit? Do you think seeing gains go away and then your principal threaten your mental and physical health? If you don't sell anything, where will the money come from to buy stocks when the blood-letting stops if you're all in and stay all in?

It doesn't take a rocket scientist nor much common sense to arrive at the answers to these questions, and you'll probably find you come up with the same answers I do. Those answers probably don't jive with just sitting there doing nothing and hoping things get better.

CA Farmers may Face New Competition or Seek New Markets due to Ukraine War

Several California crops may begin to feel market impacts from the Russian invasion in Ukraine. The war is driving up prices of grains, sunflower oil and other commodities. Meanwhile, California apple growers may be facing a new global competitor. Poland, the European Union's largest apple producer, is expected to expand its export markets to replace Russia. California rice growers may also be shipping products to new destinations to replace Russian customers.

Butte County Farmers Closing in on Goal of New Water District

Much of Butte County has long operated without a regional water district. In recent years, local farmers have been working hard to change that. Now farmers in a tree-nut region north of Chico are close to their goal of winning approval for the proposed Tuscan Water District. The district is due for a ratification vote later this year. Farmers say its approval would provide help in managing groundwater supplies in conformance with state law.

Insurance Issues Persist, as Farmers Lose Wildfire Coverage

Some California farmers say their insurance companies are refusing to renew their wildfire coverage. And some are disputing policy cancellations, arguing that farms and ranches are not in extreme fire-risk zones. The California Department of Insurance is aware of the issue. The agency says it is conducting a survey to identify which geographic areas are impacted by coverage restrictions to recommend potential solutions to address property owners' concerns.

Chicken Owners Warned to Take Precautions Over Avian Influenza

Highly contagious avian influenza has infected or killed wild and domestic birds in 29 states. Maurice Pitesky, a poultry specialist at the School of Veterinary Medicine at the University of California, Davis, is urging commercial and backyard chicken owners to take precautions. He recommends preventing chickens and other poultry from exposure to waterfowl and wild birds that may carry the infection. The bird flu, or HPAI virus, doesn't affect humans. ★

California Saw 3.8% Increase in Used Car Purchases During COVID-19

SAN DIEGO, CA (MPG) - Inflation has been the dominant story in the U.S. economy for most of the last year. Year-over-year increases in the Consumer Price Index have reached their highest levels in 40 years, with consumers paying more for expenses from food to housing to energy. And one of the categories that has consistently seen the highest price increases in this inflationary period is vehicles, both new and used.

While the early months of the COVID-19 pandemic saw lower demand for vehicles as people avoided travel and commuting, the vehicle market has rebounded strongly since the second half of 2020. COVID-related concerns and transitions to remote or hybrid work have put a dent in public transit ridership, and instead, more former transit users have opted to buy cars. Low interest rates, strong government stimulus, and a rebounding economy have given many households the wherewithal to make vehicle purchases.

A lingering challenge, however, has been supply. COVID-19 outbreaks over the last two years have disrupted global supply chains, and carmakers have been particularly hard hit. Obtaining parts like semiconductor chips has been more challenging, and backlogs at ports worldwide have made it harder to ship new vehicles. In total, manufacturers produced approximately 1.7 million fewer vehicles in 2021 than 2019, and with a limited number of new vehicles hitting the market, used models are selling at a significant premium.

According to data from the U.S. Bureau

of Economic Analysis, per capita annual spending on used cars jumped 10.9% between 2019 and 2020, from \$460 to \$510. This increase was the second highest single-year increase in nearly 25 years. The new vehicle market is historically prone to larger swings but spending on new vehicles only increased by about 2.1% from 2019 to 2020, from \$870 to \$889.

Car shoppers in some locations have felt the effects of these price increases more than others. Typically, residents of the central U.S. tend to spend the most on both new and used vehicles annually. Residents in these locations are typically more car-dependent because their rural geography puts more distance between people and communities. While residents of less car-oriented locations can spend less or put off vehicle purchases more easily, their car-dependent peers spend more, and now are carrying the extra burden of rising prices.

The data used in this analysis is from the U.S. Bureau of Economic Analysis's Personal Consumption Expenditures. To determine the states with the biggest increase in used vehicle purchases during COVID-19, researchers at CoPilot calculated the percentage change in total used car spending between 2019 and 2020. In the event of a tie, the state with the greater total change in used car spending over the same period was ranked higher.

The analysis found that used car spending in California increased by 3.8% during the pandemic, a total change of \$439.8M. Here is a summary of the data for California:

This Month In Your Garden

May is usually not too hot, nor too cold – great gardening weather.

May is month to put in your vegetable garden if you have not already done so. No more unexpected freezes most likely and the warmer nights with temperatures in the 50's make it the best month to plant your vegetable garden. The availability of vegetable starts is abundant right now so you should be able to find what you want.

As the weather begins to warm in the spring, along come many insects that enjoy it as well. There are many insecticides for sale, some are "specific" and some are "all purpose" and one needs to check the label to be sure your needs are covered. Mealy bugs seem to like citrus trees. If you notice small white dots on the limbs and in the crotches of the limbs, they are probably young mealy bugs. They grow slowly and look like a scale problem. They stay flat and develop a white fuzzy coating that is difficult to penetrate unless a small amount of liquid soap or horticultural oil is added to the spray. When the bugs die spray them off with a strong stream of water. Keep an eye out for citrus leaf miner as well. It will look like snail tracks in the leaf. If you see that, spray with Monterey garden insect spray with Spinosad. It works very well at controlling leaf miner.

As we work our way into May we can get brief warm weather spikes, so be ready. Be sure all your irrigation systems are working properly. Drip systems should be turned on so that you can see where repairs are needed. Sprinklers should be checked to be sure they have not become plugged and that they work properly. Be sure to add mulch around your trees and shrubs to keep the ground cooler and preserve the moisture in the ground. You can significantly reduce the amount of water being used by applying 3 inches of mulch. It will also be

time to restore basins around any trees or plants that had been cut to allow for drainage during the winter. They will be needed for deep watering again for the summer season. Remember that trees benefit from deep infrequent watering rather than daily short watering. Deep watering encourages deep rooting which will make for a much healthier tree to withstand summer heat and dry periods.

Roses are setting nice buds and beginning to bloom, so they are now in their first bloom of the season or soon to be. Make sure to dead-head them after the blooms fade. Fertilize them regularly to keep them blooming. About once a month. Spray them with a fungicide or Neem oil at the first sign of a fungus infection (Black Spot, Powdery Mildew or Rust) because they can spread quickly and be difficult to conquer. Those first flowers are often large and beautiful. As the summer heat comes the size of the flowers usually become somewhat smaller, but still lovely.

Just a reminder – if you have camellias, keep the fallen flowers raked up. As they decompose they can harbor a fungus that can damage the plants. If you have rhododendrons that have bloomed, the flower truss should be snapped off at its base and discarded. If they are not removed the plant will spend energy making seeds and may not bloom the following year.

Time spent gardening is a great way to relieve stress and forget about all that is going on in the world. Well, at least get it out of the mind for some time, and enjoy getting your hands dirty while spending time outside in the beautiful spring weather.

Allergies or COVID? Emergency Physicians Explain How to Tell the Difference

WASHINGTON, D.C. (MPG) - The springtime sniffles are here, and it can be tricky to determine whether common symptoms are due to COVID-19 or seasonal allergies. The American College of Emergency Physicians (ACEP) offers tips to distinguish between the two and determine when symptoms become an emergency.

“It can be confusing to figure out whether your symptoms are allergies or something worse,” said Gillian Schmitz, MD, FACEP, president of ACEP. “Some symptoms of COVID and allergies overlap, but there

are a few clear signs that indicate a COVID infection.”

A quick quiz can help you determine whether you have COVID-19 or seasonal allergies:

Do you have a fever? Seasonal allergies do not typically include a fever. It is possible to get COVID without a fever. But, when the body temperature is unusually high, it’s often a sign of illness rather than allergy.

Do you typically have allergies? It’s understandable to be concerned about COVID, but if the season reliably brings familiar symptoms like an itchy or runny nose, sneezing, or watery eyes, it’s likely allergies flaring up again. COVID symptoms can overlap but often include

additional signs of concern. The duration of symptoms is important, too. COVID symptoms last about a week but could have longer-term effects, while allergies tend to stick around for months.

Are your symptoms more than coughing or sneezing? Some of the most common COVID symptoms are consistent with allergies or a cold and can include a sore throat or runny nose. A likely sign of COVID is the addition of one or more symptoms, including body aches, fatigue, nausea, stomach problems or diarrhea, or loss of taste or smell.

People with COVID may feel short of breath or have difficulty breathing, but seasonal allergies

don’t usually cause breathing issues unless there’s an underlying respiratory condition, such as asthma, according to the Centers for Disease Control and Prevention (CDC).

Are you taking avoidable risks? Even without symptoms, it is helpful to continue to wear a mask, social distance, and get vaccinated to decrease the chances of getting sick and slow the spread of COVID.

Stay home if you are sick, whether it is with COVID or another illness and contact a primary care physician when symptoms are mild to discuss treatment options. It is time to visit the closest emergency department or call 911 for any

medical emergency, such as trouble breathing or shortness of breath, when illness become severe, or there is a high risk of illness or complications due to age or preexisting conditions.

To stay safe, visit a testing site or take an at-home COVID test when symptoms start. Free at-home tests are available to order from the government on COVID.gov or they can be purchased at retailers or pharmacies.

“We should all continue to take every precaution to prevent the spread of COVID,” said Dr. Schmitz. “The best way to clear up doubt is to get tested for COVID when worrisome symptoms appear.” ★

Woman Pleads Not Guilty to Injury to Child While Evading Police

Butte County DA Press Release

BUTTE COUNTY, CA (MPG) - An Oroville woman accused of running her car into a car containing a five-year-old child while fleeing a police vehicle, was in court Thursday, April 28. The child was seriously injured as a result.

Banessa Santana, 33, of Oroville, appeared this morning in Butte County Superior Court on charges of Fleeing a Pursuing Peace Officer’s Vehicle and Hit and Run Driving, resulting in serious injury. Santana entered a not guilty plea.

Butte County District Attorney Mike Ramsey said the charges relate to a March

12, 2022, incident where an Oroville Police Department officer saw Santana driving a vehicle and recognized her as being wanted on a felony warrant for a charge of Escape. The officer turned on his red lights and siren, but instead of stopping, Santana took the officer on a high-speed chase through a residential area of Thermalito, running stop signs and traveling in excess of 50-60mph. The officer had started to slow down after three miles as the chase had become too dangerous, and Santana had gone over a hill approximately a quarter mile away.

Ramsey said Santana then collided into the rear of another vehicle being driven by a father and his two children, ages eight and five. The father and children were taken to

the hospital for treatment. The five-year-old child however suffered major injuries and spent several weeks in the hospital because of the collision. The child is slowly recovering but will have permanent injuries.

Ramsey said Santana fled from her damaged vehicle on foot and remained at large until April 21, 2022, when she was spotted as a passenger in a vehicle by Gridley Police Department. When the car was pulled over by Gridley police, Santana jumped out of the passenger seat of the vehicle and led officers on a foot chase but was quickly chased down and arrested.

Santana also appeared in court Thursday on the Escape charge. Ramsey said that last year, on May 26, 2021, Santana had been

placed on a home incarceration program by the Butte County Jail for a conviction of felony vandalism and a GPS monitor was placed on her ankle. That same day, Santana cut off the ankle monitor and deposited it in the trash can of a gas station less than a mile from the jail. A warrant was issued for Santana’s arrest for Escape and was outstanding on the day she was spotted by the Oroville police.

Santana will next appear in court for a preliminary hearing on all charges on May 19, 2022. She is currently in custody in the Butte County Jail. The judge has denied her request for bail given her history of flight. She faces up to nine years in prison on the charges. ★

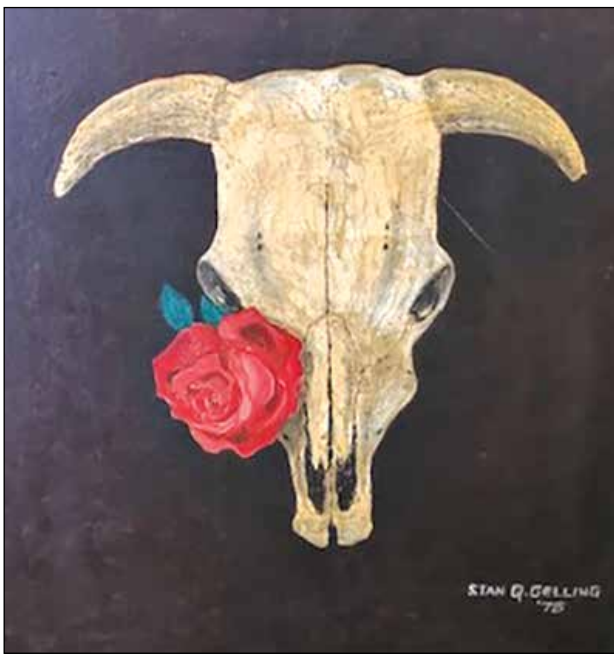

A cartoonist and caricature artist extraordinaire, Stan was born in Pocatello, Idaho and died in Marysville in 1985 after a swashbuckling life of boxing, military service, hunting and fishing, many jobs, and an overriding passion for art. Bearing a passing resemblance to Clark Gable he cultivated his image with a pencil thin mustache.

Stan was a colorful well-known figure in the local community from the 1950s into the 1980s. Though employed as an advertising salesman by the Appeal Democrat, his talent shown in his cartoons with which he illustrated his Saturday "Making the Local Scene" column. Before he found his niche in Marysville, he wrote and illustrated the Farragut Fables, the newsletter of the United States Naval Station in Farragut Idaho where he was stationed during World War II.

Stan also painted western scenes and wildlife in oil along with pencil sketches and watercolors, many of which remain in the area in private collections, but his talent lay in the few strokes of ink with which he could capture the physical essence of anyone. Before the dictates of political correctness, no subject was off limits. If a prominent attorney was cited for drunk driving, he could expect to be

lampooned in Stan's column on Saturday along with the cop who stopped him.

New Study Finds Nearly 60% of Office Workers Staying at Their Jobs

WASHINGTON, DC (MPG) - Some 47 million Americans voluntarily left their job last year, as the COVID-19 pandemic ushered in what has become known as the "Great Resignation." As the debate continues as to whether this is a lasting workforce trend or just a blip on the radar, a new survey released last month by the data management platform Kizen shows that most office workers appear content with their current job.

According to the survey, 57% of so-called "knowledge workers," or those who use a computer for at least 2 hours a day in their work, said they have not quit or even considered leaving their current job in the past year. An equal percentage also believe that they work the right amount of hours. Conversely, 37% of respondents considered quitting and 6% said they left their job. Of those who have considered quitting, the survey found most are young adults, people in urban areas and those going into a physical office.

"Leaders are navigating a totally new paradigm for attracting and retaining team members, and so understanding what employees value and appreciate is key," said Kizen co-founder and CEO John Winner in a news release.

Kizen (www.kizen.com) uses a no-code

data platform and an intelligent business assistant to help companies streamline business processes and boost productivity.

While 24% of these workers reported no job dissatisfaction, top complaints among those who expressed some level of discontent included: workplace culture and pay (19%), issues with management and lack of opportunities to advance and recognition (16%) and lack of flexibility (12%).

Earlier this year, the Pew Research Center found that a majority of workers who quit their job last year cited low pay, no advancement opportunities and feeling disrespected at work as major reasons for leaving.

When it comes to achieving a work-life balance, the Kizen survey also found that outside of financial security and compensation, the benefits workers valued most included more flexibility for activities outside of work (15%), a sense of purpose and opportunity to serve others (12%) and having the opportunity to be around likable colleagues (10%).

"There's no one-size-fits-all approach to satisfying employees, who value different aspects of work depending on their interests and circumstances. But flexibility and a sense of purpose seem to be powerful tools for recruiting talent and building a fulfilled, happy workplace," Winner added.

As for those who quit their jobs last year, one new survey found that approximately one in five workers regretted the decision.★

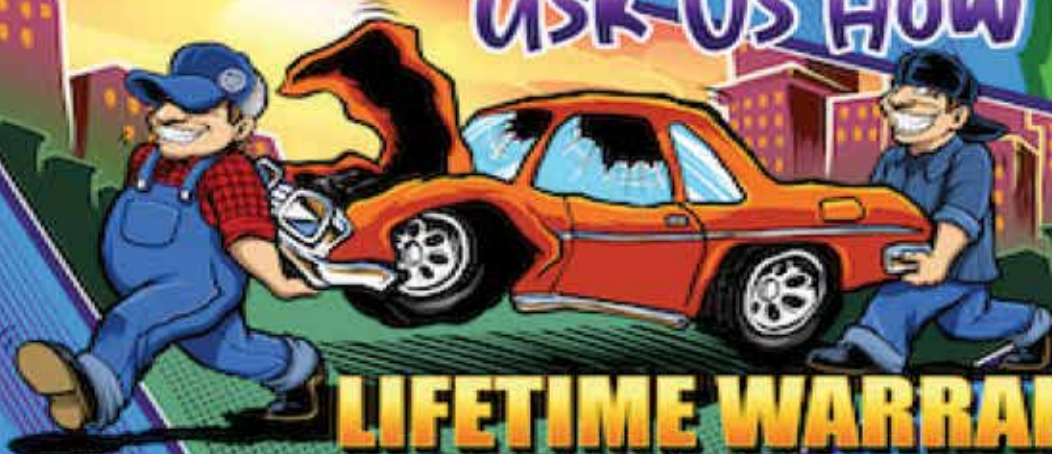
