

## **Cyranny on Hold**

Although more than three-quarters of California adults are vaccinated against COVID-19, opinions are more divided when it comes to vaccinating children. That sentiment played out Thursday (April 14, 2022) when first, the author of a bill that would have mandated vaccines for all children pulled the legislation, and then again when state health officials pushed back the date of their student vaccine mandate.

It was a striking shift for a state that had been the nation's first to announce a planned K-12 COVID-19 mandate.

The bill by Sen. Richard Pan, a Sacramento Democrat who chairs the Senate Health Committee, would have granted no personal belief exceptions to the requirement that all children get the COVID vaccine to attend school or childcare. In sidelining his own bill, Pan said the focus needs to be on making sure families can access the vaccine for their children.

Within hours, the California Department of Public Health announced it will not begin the process of adding the COVID-19 vaccine to the list of mandated childhood vaccines for K-12 public and private school students because it has not been approved by the federal Food and Drug Administration. Previously the state had intended to require it for the upcoming 2022-23 school year, but now that won't happen until at least July 1, 2023.

The health department said in a statement that even after COVID vaccines for kids receive full approval,

it would also consider the recommendations of a Centers for Disease Control vaccine advisory committee and the American Academy of Pediatrics and American Academy of Family Physicians before issuing a school vaccine requirement.

Support for Pan's bill has been wavering for several weeks. Last month, another member of the Senate Health Committee, Democratic Sen. Connie Leyva of Chino, told the group Stand Up Ontario, in the Inland Empire, that she was not going to vote for the bill.

She said she told Pan, "I just don't think it's the right time. We are too divided in the community," she said. "I think this bill is too divisive."

GOP political consultant Mike Madrid said legislators pull bills for many reasons, including a lack of Continued on page 12

## Free Clean **California Dump Day Saturday**

#### MARYSVILLE, CA (MPG) - Caltrans is celebrating Earth Day with free Dump Day events throughout Califonia on Saturday, April 23 – including one in Linda, just south of Marysville and Yuba City. Caltrans welcomes you to bring non-hazardous, unwanted items to the nearest Dump Day event for free disposal.

The statewide Dump Day events are made possible through Governor Gavin Newsom's Clean California initiative, a sweeping \$1.1 billion, multiyear clean-up effort led by Caltrans to keep roads and waterways free of litter, create thousands of jobs and transform state and local public spaces through beautification efforts.

"The best way to keep California clean is not to trash it in the first place," said Caltrans Acting Director Steven Keck. "Clean California's goal is to make sure trash never reaches our roadsides or waterways. These Dump Day events discourage illegal dumping along highways and roads by giving people throughout the state a convenient place to dispose of bulky items safely, properly, and at no

Caltrans will have staff on-site to accept household waste and approved debris free of charge. A Dump Day event will take place at the following location in District 3:

Marysville Maintenance Station – 1001 North Beale Road, Linda, CA 95901 from 8 A.M. to 3 P.M. or until capacity is reached at the site.

Free Dump Day collection is limited to household items such as tires (max 4), metal, plastic, fiberglass, fabric, glass, wood, mattresses, household appliances, and landscape trimmings. No construction materials, hazardous waste, e-waste, treated wood waste, or asbestos of any type will be accepted.

Caltrans reminds motorists to properly secure and tarp all cargo loads prior to driving. Transporting unsecured loads is unsafe, illegal, and pollutes California's roads and waterways. Loads that are not tied down, enclosed, or secured by tarps or other means, will not be accepted.

Tips for securing your load: Completely cover loads with tarps or cargo nets. Debris can escape from gaps. Remove loose Continued on page 3

## Major Roadwork Starting on Highway 70

YUBA COUNTY, CA (MPG) - Caltrans is alerting motorists and residents that major highway construction activity is scheduled to start Monday, April 18 along a nine-mile stretch of State Highway 70 between Laurellen Road and the Yuba-Butt County line.

Over the next two years, construction crews will be working at various locations during day and nighttime hours Monday through Saturday. Motorists should allow additional travel time and may expect intermittent traffic-interfering work, especially during overnight hours.

Residents in the area may hear loud construction noise, including OSHA-required vehicle backup warning alarms. The contractor will maintain access to all driveways and cross streets during construction.

Caltrans reminds motorists to "Be Work Zone Alert" and that the construction zone speed limit has been reduced to 45 mph between Laurellen Road in Yuba County and East Gridley Road in Butte County, where a separate construction project is underway.

The \$131 million Yuba County project will widen and pave the


shoulders to 8 feet, provide a 14-foot-wide two-way left turn lane, continuous passing lanes and 6-footwide unpaved shoulders for slow moving farm equipment. The project will also straighten some curves to improve sight distance, improve culverts, repave the roadway and create a 20-foot clear recovery zone for errant drivers to return their vehicle safely to the roadway.

DeSilva Gates Construction of Dublin, Alameda County, is the prime contractor. Completion is targeted for December 2023. The

schedule is subject to change due to weather, availability of equipment and/or materials or other construction-related issues.

# Man Faces Life in Prison for Killing His Children and Brother-in-Law

**OROVILLE, CA (MPG)** - A Sacramento man, who drove his truck into a local canal on Easter in 2020, appeared in Butte County Superior Court where he admitted to the evidence that he killed his two children and his brother-in-law.

Colby Allen Brookman, 29, pleaded no contest to felony Gross Vehicular Manslaughter While Intoxicated. Brookman also admitted that it was his fourth "strike" making him eligible for a life sentence in prison.

Butte County District Attorney Mike Ramsey said on April 12, 2020, Brookman drove his truck into the canal at the end of Grand Avenue in Oroville. Brookman's wife, J'lynne Stothers, was a passenger in the front seat and their two infants – Arianna, 17 months; Ava, 7 months; and Stothers's brother, Matthew Stothers, age 32 – were passengers in the rear of the quad cab truck.

Ramsey said Brookman was drinking numerous beers throughout the day and had been told multiple times not to drive. A blood test taken two hours after the crash showed his blood-alcohol level to be 0.12 percent.

California Highway Patrol's Multidisciplinary Accident Investigation Team (MAIT) investigated the incident.

The MAIT team was able to determine through the truck's "black box" that Brookman was driving at over 80 mph just before the road ended at the canal. The truck launched over the canal's levee into the waters below. The children were strapped in their car seats in the rear seat with Matthew Stothers between them.

Brookman and his wife got out of the truck and swam to shore. Ramsey said Matthew was also able to get out of the truck but struggled to swim. A witness saw Matthew treading water next to Brookman and his wife. The witness, who was standing on a levee overlooking the water, told Brookman to help Matthew, but Brookman refused. The witness said he then saw Matthew struggle and sink below the water's surface.

Butte County Search and Rescue later recovered the bodies of Matthew, Arianna, and Ava from the canal's water.

Ramsey said this conviction would be Brookman's fourth "strike" under California's "Three Strikes and You're Out" law. Brookman had previous convictions for two counts of felony assault with a motor vehicle and a count of grand theft with great bodily injury. All his previous strike counts were in Sutter County. Brookman's sentencing is scheduled for May 23, 2022, at 8:30 a.m. Brookman is facing 37 years to life in prison and remains in Butte County Jail without bail.

Continued from page 1 material and trash before driving. Don't overload keep materials level with your truck bed. Put light items lower, tie large items to the vehicle for traffic safety.

Caltrans has hosted 72 free Dump Day events since July and collected more than 18,000 cubic yards (more than 300 tons)

of trash. Items collected include 7,719 tires, 1,973 mattresses, 804 appliances (including 295 refrigerators), and a hot tub. This Caltrans News Flash video highlights recent Clean California Dump Day community events in Kern, Inyo, and Mono counties.

Since launching Clean California in July, Caltrans has removed more than

536,000 cubic yards of litter from state highways - the equivalent of 9,000 tons or enough to fill 164 Olympic-size swimming pools – and hired 678 new team members as part of Clean California, including 526 maintenance workers who collect litter and remove graffiti. ## **Did NATO Push Ukraine into War?**

There are at least two sides to every story, globalists own all six of the major news outlets thus, mostly globalist news is presented in America. When censorship prevails

there exists one side. The Deep State media still refuse to share two important aspects of the Ukrainian / Russian story—Ukraine's connection to the New World Order and NATO's roll in provoking Russia. As to the first, LibertyUnderfire. com formally published, "Putin is Destroying the New World Order in Ukraine." The other presents NATO as the foundational cause of the conflict. Cold War history, foreign to most millennial journalists, cannot be omitted. The facts presented here can easily be verified, not by an non-degreed fact checker employed to discredit any view outside the globalist view, but by a common 20th Century textbook or encyclopedia.

Russia correctly saw the alliance as a threat to its socialists interests. In response she created the Warsaw Pact in 1955 comprised of eight surrounding nations to counter NATO, They too adopted the philosophy—an attack on one by the West is an attack on all. Its eight members were: Albania, Bulgaria, Czechoslovakia, East Germany, Hungary, Poland, Romania, and Russia,. A standoff between the NATO, "freedom" nations, and the Warsaw Pact, socialist nations, lasted for the next 36 years. The Berlin wall collapsed in 1989 and two years later, in 1991, the Soviet Union disintegrated under Russian President Mikhail Gorbachev.

A unified Germany was looking to join one or the other alliance. President George H.W. Bush wanted to ensure Germany joined NATO and made an offer to Russian President Mikhail Gorbachev. That offer "suggested if Germany became a NATO member NATO would stop expanding 'not one inch eastward'-no new members. Today the US says it made no such promise, that no such agreement was ever struck, but hundreds of memos, meeting minutes, and transcripts from U.S. archives indicate otherwise." Germany joined NATO in 1990. Part of that understanding was that both the Warsaw Pact and NATO would dissolve. Russia dissolved the Warsaw Pact ending the Cold War, NATO did

That promise was broken and "NATO refused to cease its operations. And to add insult to injury, they kept the door for membership open. Russia saw it as a stab in the back and NATO kept pushing the dagger deeper." Without any effective resistance to NATO expansion it continued to assimilate country after country coming ever eastward toward Russia—absorbing former USSR, or Russian federated countries. In 1999 Poland, Hungary, the Czech Republic joined NATO followed five years later, in 2004, by another wave of seven Central and Eastern European nations: Bulgaria, Estonia, Latvia, Lithuania, Romania, Slovakia, and Slovenia. In 2009, "Albania and Croatia joined NATO and the most recent entries are Montenegro and North Macedonia, both situated in Russia's backyard.... As of 2021, NATO officially recognized three more aspiring members,

Bosnia/Herzegovina, Georgia and Ukraine" as wanting membership. Since then NATO had been in talks with Sweden, Finland and Serbia for membership ("Two Sides to Every Story: Did NATO push Ukraine into War? Gravitas Plus, by Palki Sharma Upadhyay, March 6, 2022, https:// www.youtube.com/

watch?v=TzgPJeYZaOU). Although the West applauded the disintegration of the Soviet Union most Russians instead were traumatized by it. "In an instant they lost 1/3 of their territory, half of their population and most of their military might.... They felt that an unjust settlement had been imposed on them and it was done in their moment of maximum weakness and vulnerability. So they looked at any state leaving Russia sphere of influence as both a strategic loss and a matter of national humiliation."

NATO started with 12 founding members when there was fear of Russia bringing communism to Western Europe, now it has more than doubled to 30 countries where Russia has posed little threat to retake land outside what it once governed as the USSR. So much of Eastern Europe, once part of the Soviet Union, has now been assimilated into "NATO and this happened despite Russia's protests

and warnings." In 2007 Vladimir Putin addressed the annual Munich Conference. "NATO has put its frontline forces on our borders. This expansion represents a serious provocation that reduces the level of mutual trust. And we have the right to ask: Against whom is this expansion intended? And what happened to the assurances our Western partners made after the dissolution of the Warsaw Pact?" Said another way, "This NATO "military alliance has technically absorbed the entire security belt of Moscow" (Ibid).

We too ask Bill Clinton, father and son Bush, Barack Obama, and Joe Biden the same thing. The United States had more impact in NATO's enlargement than any other country. You are the ones who financed and built 16 or more bioweapons labs in Ukraine and placed a historical enemy military pact on Russia's very border. Why would Russia not feel threatened when NATO organized 30 nations against it? You're disregard of, and insensitivity to, NATO history is equivalent to poking the once Soviet Bear into rage.

#### Water Supply Cuts Expected to Curtail Klamath Valley Farm Production

Food production along the California-Oregon border is due to suffer this year, with federal water cuts impacting farmers. An arrest warrant has also been issued for 47-year-old Timothy King from Olivehurst for murder. Mr. King is currently in custody in prison on an unrelated case and will be charged in this case.


previously hurt by the shutdowns will start to see their revenues climb and their stock prices should reflect that.

# Fears of Recession Intensify as US Inflation Rises to 8.5 Percent

Economist warns US economy could be in "a dreaded state of stagflation" by November elections

U.S. inflation accelerated to an 8.5 percent annual rate in March, heightening fears of a recession.

My expectation is that we are close to a peak in inflation, but that inflation will remain uncomfortably high for the next few months.

Some economists believe that regaining control of prices will require far more aggressive rate increases by the Federal Reserve, which may topple the U.S. economy into a recession.

Wall Street analysts are already projecting a downturn for next year. Last week, Deutsche Bank became the first large bank to foresee a recession in 2023. The further Fed tightening is projected to have a significant impact on the U.S. economy by late next year and early 2024, according to the bank.

Bank of America has a similarly pessimistic outlook. Chief investment strategist Michael Hartnett stated in a recent note that the Fed's belated response to "out-of-control inflation" would lead to a recession. In one sentence, he summed up the bank's position: "Inflation shock' worsening, 'rates shock' just beginning, 'recession shock' coming."

High inflation, according to many, is a product of Washington's policy decisions, which include excessive government stimulus spending and the Fed's "money printing."

The yield curve recently inverted for a few days, meaning short-term interest rates exceeded long-term rates. This caused investors

to wonder if a recession is imminent. Since 1980, yield curve inversions have always preceded recessions.

"My expectation is that we are close to a peak in inflation, but that inflation will remain uncomfortably high for the next few months," Desmond Lachman, economist and senior fellow at the American Enterprise Institute, told The Epoch Times.

The bond market, Lachman noted, which has inverted the yield curve, is correct in anticipating that inflation will moderate because Fed tightening will trigger a recession.

"In fact, I think that there is a real risk that the U.S. economy could have a very hard landing if higher U.S. interest rates burst the current equity, housing, and credit market bubble. In that case, we could be back to a situation of a very weak economy and rapidly decelerating inflation by early 2023," Lachman said.

"All of this does not bode well for the Democrats' prospects in the midterm elections since, by November, the economy could be in a dreaded state of stagflation."

The U.S. central bank, however, is aiming for a "soft landing" for the U.S. economy while waging war on inflation. The Fed indicated that it would raise interest rates by 50 basis points

at next month's policy meeting and trim the \$9 trillion balance sheet by \$95 billion each month to tighten its monetary stance.

#### **New Threats**

Current wage pressures and rising rents, according to Lachman, would continue to keep inflation high and make the Fed's fight more difficult.

China's COVID-19 restrictions are also posing a new threat to the global supply chains. The Chinese regime's strict "zero-COVID" policy has prompted fresh lockdowns in major cities, including Shanghai. This is expected to intensify global supply disruptions and add to inflationary pressures on goods and raw materials imported from China.

A decline in oil prices because of a drop in Chinese demand also is expected to be temporary. While analysts believe the Biden administration's recent actions on oil will bring some relief to consumers at the pump, they anticipate crude oil prices to surge over the 12-month horizon.

The Biden administration recently authorized a "historic release" from U.S. petroleum reserves and has approved the use of affordable E15 gasoline in the summer.

These actions won't have the

desired impact on gas prices, according to Phil Flynn, senior energy analyst at the Price Future Group.

Releasing oil from strategic reserves is "like taking alcohol as a pain reliever. It may seem like a good idea now, but you will end up with a heck of a hangover," he wrote in a recent note.

Following last week's drop, oil prices have begun to rise again, owing to optimism that Chinese demand would soon recover and OPEC warnings that replacing Russian oil exports would be impossible.

Meanwhile, global food prices have risen at their fastest pace on record.

The Russian invasion of Ukraine has created significant uncertainty and volatility in global commodity markets, particularly in agricultural commodities. The United Nations' Food and Agriculture Organization said that its food price index in March climbed 13 percent, reaching an all-time high. Vegetable oil, grains, and meat prices, in particular, soared to unprecedented levels.

The crisis in Eastern Europe and the sanctions on Russia are making the food supply chain more vulnerable. Russia and Ukraine together produce over a third of the world's wheat. In addition, Russia's decision to

halt fertilizer exports for the remainder of 2022 is expected to exacerbate the problems faced by U.S. producers.

CHS, one of America's leading cooperatives owned by farmers, sounded the alarm last week about the possibility of fertilizer supply shortages due to Western sanctions against Russia, which is a major source of fertilizer for global markets.

The crisis in Ukraine and its impact on commodities pose immediate challenges to U.S. consumers and the economy, according to Luke Tilley, chief economist at Wilmington Trust.

U.S. consumer sentiment indexes have dropped to "extremely low" levels, and this suggests consumer spending will slow going forward, he told The Epoch Times.

Tilley expects the Federal Reserve to be aggressive over the next couple of months. However, he forecasts that when inflation and the economy decline in the second half of the year, Fed policymakers will need to take a step back from their aggressive posture.

This could prevent a hard landing for the economy.

In addition, Tilley stated there are some signals in the economy that may ease inflationary pressures. One of them is the Manheim index for used cars and trucks, which has dropped over the last two months.

The port congestions have also improved dramatically. Drewry's World Container Index shows that the cost of shipping a container has fallen more than 20 percent since its peak in September of last year, he noted. In addition, while wages continue to grow, the pace of increase has cooled over the past three months.

"However, I think inflation is highly unpredictable," Tilley said.

"There's certainly a lot of risk that inflation could keep rising," he said, compelling the Federal Reserve to move more aggressively to contain it.

According to a Bloomberg survey conducted between March 29 and April 1, nearly half of investors expect the U.S. economy to fall into recession next year. About 21 percent of those polled believe the next recession will occur in 2024, while only 15 percent predict it will occur this year.

## ICE Arrests 23 Illegal Alien Human Rights Abusers, Violent Criminals

In a nationwide operation, Immigration and Customs Enforcement (ICE) agents arrested 23 illegal alien fugitives who were being sought for their roles in known or suspected human rights violations.

All 23 had already been ordered removed from the United States, according to ICE.

Thirteen of the fugitives also have convictions for crimes including homicide, aggravated assault with a weapon, burglary, indecent exposure, resisting an officer, and DUI offenses.

Among those arrested are two known or suspected human rights violators from China who were "complicit in forced abortions and sterilizations by government entities," according to an ICE statement.

Others are from Central and South America, as well as southern and Eastern Europe.

"ICE will not allow the United

States to be an escape for those entering the U.S. to evade prosecution and punishment for the crimes they have committed against others," said ICE Acting Director Tae D. Johnson.

ICE declined to provide The Epoch Times the country of origin for three of the fugitives, saying, "We have no additional information to provide at this time."

The agency said the three fugitives "participated in or supported political violence, including mistreating political prisoners, inciting violence against minority populations, and assisting officials in a regime known for extensive human rights abuses against its political opponents."

ICE also refused to provide

the current number of illegal aliens who have been ordered removed by an immigration judge, yet remain in the United

In May 2016, there were more than 950,000 fugitive illegal aliens in the country who had received final orders of removal, according to a report by ICE to the Senate Judiciary Committee.

Since then, Border Patrol has apprehended more than 5 million illegal aliens entering the United States, according to Customs and Border Protection data.

ICE deportations have hit record lows under the Biden administration, which narrowed the agency's criteria for enforcement in 2021

ment in 2021.

Deportations in the first five months of 2021 plummeted to 18,713, according to ICE records obtained by the Center for Immigration Studies. In contrast, while deportations in the first five months of 2019 totaled

186,089, they decreased to 93,247 during the same time period in 2020, in part due to the COVID-19 pandemic.

In addition, ICE is unable to locate more than 47,700 individuals who were issued a notice to report to the agency within 60 days of crossing the border illegally between March and October 2021, but failed to do so, according to official data received by Sen. Ron Johnson (R-Wis.).

In his letter accompanying the data to Johnson, Department of Homeland Security Secretary Alejandro Mayorkas said: "DHS is committed to ensuring a safe, orderly, and humane immigration system.

"It is important that we continue working together during these unprecedented times as we strive to keep the country safe and secure."





## **World's Most Extreme Pro-Abortion** Bill Signed as World Recoils

#### CHRISTOPHER, HARRIET, ÁNGEL, **HOLLY, AND PHOENIX**

Those are the names given to five children allegedly killed by an abortionist near or at term whose remains were recently recovered in the Washington, DC, area by pro-life activists. The five were among 115 babies' bodies allegedly discarded by an abortion clinic and scheduled to be incinerated at a Maryland power plant.

The extremely graphic, gruesome, and deeply disturbing images of those five children have now been made public.

The Progressive Anti-Abortion Uprising organization, whose members turned the remains over to authorities, said in a press release, "Their late gestational ages as well as their apparent sustained injuries potentially show violations of the Partial Birth Abortion Act as well as the Born Alive Infants Protection Act which are federal crimes."

Pro-life activists and members of Congress are calling for full investigations. In contrast, Democrat lawmakers in states across America are working to rapidly pass laws granting immunity for the slaughter of babies in the womb up to birth, and in some cases after birth up to 28 days!

Democrats are feeling the pressure to enshrine radical abortion rights now out of fear that the U.S. Supreme Court decision in the pending case of Dobbs v. Jackson Women's Health Organization will reverse its infamous 1973 pro-abortion decision of Roe v Wade. Since Roe, abortion has taken the lives of at least 63 million children in America and has been the number one cause of death worldwide for many years.

In Colorado, only three days after news broke about the 115 aborted baby corpses in Washington, progressive Democrat Gov. Jared Polis brazenly signed into law North America's most extreme pro-abortion law, all the while celebrating the new law's grant of absolute unrestricted freedom to kill innocent babies.

Among the disturbing provisions of new Colorado law (deceptively called the "Reproductive Health Equity Act"):

Unborn babies are explicitly stripped of any rights under state

All babies can be aborted at any time up to birth with no civil or criminal legal consequences for anyone.

Minors are empowered to obtain unlimited abortions with no parental notification. While a number of Republican-

led states have passed laws protecting the unborn in anticipation of Roe's reversal, Democrat led states are following Colorado's lead. California and Maryland are even considering measures allowing babies to be killed after birth - outright legalizing infanticide. It's a strategy to create abortion 'sanctuary' states ahead of the possible overturn of Roe.

Children are a gift from God (Psalm 127:3), and shedding innocent blood is an abomination to Him (Prov. 6:16-19).

In the Bible, Israel was forbidden from worshiping the false god Molech (Lev. 18:21), a practice which involved child sacrifice. Biblical scholars believe Molech's priests would place live infants into the outstretched arms of the idol, which had been superheated by fire, cooking the child to death. The sacrifice was committed to earn prosperity from the false god.

How different are Colorado and other Democrat-controlled states these days from the cult of Molech? In just 50 years, activists have gone from claiming a "right" of abortion (not found in the U.S. Constitution), to demanding taxpayer funding and enthusiastically supporting the death of babies up to and well after birth.

Is the outright butchery exposed in images of aborted children in Washington any different than the detestable ritual of child sacrifice to Molech? Consider recent reports of women happily taking abortion pills on the Supreme Court steps while taunting pro-life activists – all for the attention of the adoring left-wing media.

The overturn of Roe is far from certain. But even if it is ultimately retracted by the High Court, states under Democrat control (like Colorado) will still be abortion havens. Americans who value the sanctity of life and want unborn babies protected must continue to stand for truth, insist that lawmakers protect life, work for the election of genuinely pro-life candidates, and resist all attempts to legalize the barbaric practice of child sacrifice.







## **Volunteers Preparing** for the Stonyford Rodeo

STONYFORD, CA (MPG) - David Brandenberger is leading a crew of stalwarts in preparing the arena for the upcoming Stonyford Rodeo, which begins on Friday, April 29, and lasts through Sunday, May 1, 2022. This year the task is building a livestock pen of welded iron pipes.

Preparing the rodeo grounds and arena for the current year's rodeo is a necessity that involves Horsemen's Association volunteer workers. Every year they work on the arena and rodeo grounds construction and repair efforts, they refurbish and create new fence signs, and they perform cleanup work on the kitchen and toilets. Usually it's the same group of twenty, or so, men and women; however, if the job is large, the work may involve the whole town.

A "whole town" effort occurred in 1986 when the old, "falling down" bleachers were replaced with a new grandstand that was fronted with a five-foot high concrete block wall. This wall set the grandstands off from the action in the arena. This was a massive effort that cost in excess of \$40,000 and involved forty or more workers. This effort is documented in the history book, 75 Years and Counting, which will be available for purchase at the Stonyford Rodeo.

Tickets are now available at www. stonycreekhorsemen.org and at the

following locations: Stonyford General Store, Stonyford; Carl's Feed, Willows; Boot Barn, Chico & Yuba City; Bucke's Feed & Grain, Orland; Marie's Lakeshore Feed, Clearlake; Rainbow Ag, Lakeport; and Ace Hardware, Arbuckle. Pre-rodeo ticket prices are \$10 for adults and \$5 for children, ages 7-12. At the rodeo gate, ticket prices are \$15 for adults and \$7 for children, ages 7-12. The pre-rodeo cheaper prices are only available until April 25, so get your ticket now and save money. Tickets for the May 1, 2022, amateur events can only be purchased at the rodeo gate on that Sunday. Ticket prices are \$5 for persons aged 13 and older; children 12 and younger are free.

support or because there is another way to reach the same goal.

"If a better way to solve it is access without the acrimony of mandate that is fine," he said. "The point isn't to disagree, it's to get to a point where we have public health protections."

Pan's bill was one of eight aggressive COVID-19-related bills introduced as part of a slate from the Legislature's vaccine working group, made up of Democratic legislators. Among the bills still alive in the Legislature are proposals that would punish doctors who share misinformation, require schools to continue regular COVID testing and change how the state's vaccination registry works. Also still in play: a bill that would allow 12- to 17-year-olds to get vaccinated without parental consent.

The COVID vaccine is fully authorized for those older than 16 and can be given to children as young as 5 under an emergency authorization. It has been available since last year, but the uptake has been slow. About two-thirds of 12to 17-year-olds have been vaccinated, but the numbers are much lower for kids 5 to 11, with only about one-third vaccinated.

Citing the low COVID vaccination rate among children, Pan said a mandate is not a priority until the state can make the vaccine more accessible. He said that in his experience, as a pediatrician, when parents ask about vaccinations they want to see their child's doctor. But most doctor's offices don't offer the vaccine for COVID-19 and are referring families to drug stores or vaccination sites that are not child-centric.

"The challenge is that we are not getting vaccines into essentially the places where people normally get vaccines for their children," he said, referring to pediatricians' offices. "We still have a long way to go."

A Berkeley IGS poll released in late February found that two-thirds of California voters supported requiring the COVID-19 vaccine for K-12 students. But there is a big split along party lines: Democrats and liberals overwhelmingly support a mandate while only about a quarter of conservatives and Republicans do.

Among parents, two-thirds said they felt having their kids vaccinated was essential or important, while 26% percent

said it was "either not too or not at all important." This question did not address the mandate.

Pan's was the second of the working group's bills to be sidelined by its author. A proposal to require all people who work, including contractors, to be vaccinated was also pulled.

Critics have been pushing back, arguing that the bills are burdensome and infringe on health and privacy rights and no bill was more controversial than Pan's. Many parents who opposed it said that parents should get to choose whether to vaccinate their children, especially when the vaccine does not fully prevent transmission and it's still unclear how long it is effective.

'We did not feel it was the appropriate policy for children with respect to COVID-19 at this time," said Christina Hildebrand, head of A Voice for Choice. The group advocates for parental choice and has worked since 2015 to keep personal belief exemptions for various vaccines in place. She points to the low rate of COVID vaccination among 5- to 11-year-olds as a reason to hold off on a mandate.

"Those parents have had ample opportunity to get their children vaccinated but the parents are hesitant," she said.

Pan said it's difficult to require something that two-thirds of young children have yet to receive. "Mandates are good at getting you to that final bit when we are at 80 percent and have to get to 90, not when you are below half," he said. "If you are that far behind there's a reason. Some of it is people have questions and want to get them answered, and they want to hear from the person they have been going to for a long time to get vaccinated.'

Madrid said the bills signal the possibility of future vaccine mandates as the world becomes more globalized and pandemics happen more frequently.

"There is an appetite to have more protection for public health and not less," he said. "You give it a year and study how you can make it work if you are going to pass legislation this broad and sweeping. You have to make sure you get it right the first time."

Pan said the mandate is not dead. He intends to watch the vaccination rates and said it could be something he brings back later.


