Financial Education Comes to Sutter County School

LIVE OAK, CA (MPG) - In addition to reading, math and science, students at Luther Elementary School in Live Oak can now add financial literacy to their academic portfolio.

This new offering is from the Junior Vestors program, a financial literacy program created by a husband-and-wife team with local roots. Lulu and Martin Curiel live in Mountain View, California. While Lulu was born and raised in Venezuela, Martin is a Live Oak native and Luther Elementary alumnus.

The venture was born during the pandemic when the Curiel's own children began online schooling. The parents gained an insight into what their children were learning and discovered that financial education was lacking. They were also struck by the number of young adults who struggled with debt and lacked basic money management skills. "Being a high school or college graduate doesn't mean you have the skills for being successful in the 21st century." Says Lulu Curiel. The parents took

it upon themselves to fill in this gap and before long were teaching their children's friends as well. Before long the couple decided that they wanted this opportunity to be available for more young people and the Junior Vestors program was born.

Junior Vestors is a virtual program and now has students from throughout the country. The Curiels wanted to offer the course at Luther Elementary due to Martin's local roots. A teacher in the after-school program helped facilitate the in-person components.

For six weeks in January and February, the class comprised of 4th and 5th graders met and learned about investing, financial portfolios and the stock market. Rather than using a traditional lecture method, the curriculum included hands on activities designed to make learning engaging and relevant. Students used substitute currency and Lulu jokes that "No real money was harmed in the process."

The program was a success and received positive feedback from both parents and students. There are plans to offer a follow-up course in the near future.





add a variety of acts and a diverse calendar for the remainder of 2022 and into 2023.


The center is also designed to be converted for use during a local

Farmers, Ranchers Meet with Legislators at Farm Bureau Conference

Some 130 California Farm Bureau members interacted with state lawmakers and legislative staff as Farm Bureau's Capitol Ag Conference returned to Sacramento last week. The event was canceled in 2020 and held online in 2021 because of the pandemic. Representatives from 33 legislative offices met with farmers and ranchers in wide-ranging discussions on critical issues facing California agriculture.

Farm Bureau President Urges California to Keep its Water Promises

California Farm Bureau President Jamie Johansson says the Golden State is failing to live up to its water promises. Addressing the Capitol Ag Conference, he noted the lack of progress in building water storage under Proposition 1, approved by voters in 2014. "We have to decide as a state how serious we are about this water," Johansson said. He urged farmers and ranchers in America's largest agricultural economy to let legislators know "how important we are to this state."

California Dairy Farms Cash in on Manure, Curb Emissions

California dairies are cleaning the air and finding a new source of revenue - manure. Scores of dairies are installing manure processing systems, which break down solids to produce energy and reduce greenhouse gas emissions. One San Joaquin Valley hub is collecting biogas from five dairies. The refined methane is being purchased by the Southern California Gas Co. California is seeking to cut emissions from dairy manure by 40% by 2030.

Usda Seeks to Increase Domestic Fertilizer **Production, Curb Prices**

The U.S. Department of Agriculture is seeking to boost domestic fertilizer production to address higher crop costs faced by American farmers. The USDA is offering \$250 million in grant funds to producers to increase fertilizer supplies and market competition. The U.S. relies heavily on fertilizer imports. Costs have soared due to the supply chain crisis, and market conditions have worsened with the Russian invasion of Ukraine. \star

Quite a few people now are getting their vegetable gardens prepped for planting. Watch temperatures closely when getting ready to plant your vegetable garden. April is a good time for it but sometimes early April still brings us some very cold nights. Keep in mind that the night time temperatures should be at a consistent 50 degrees to sustain the best growth. Seeds that have been planted should be fine, but small plants can be stunted by cold nights. Many people feel that April is a late start, but, that is an opinion, not a fact. Monitor the night time temperatures for a few nights and make your decision. Up in our foothill areas there are lots of microclimates depending on whether you are up on the hill or in a valley where the cold is more apt to settle - the difference in temperatures can be significant. Many people in the higher foothills, such as Grass Valley or Brownsville wait until May because of the almost inevitable late cold spell that is apt to come along and freeze the small plants making it necessary to start all over again. If you planted any fruit trees during bare root season or recently purchased any in containers, this is just a reminder that the tree trunk should be painted with tree-trunk paint from the ground up to the first limbs to protect them from sunburn. Sunburn can cause the young, still thin bark to crack creating a possible entrance for pests. As we progress into the hot weather, the young trees will need a good, deep watering two to three times a week, depending on how hot it is. This is very important to help them develop deep roots to become healthy trees. A quick watering every day or so will develop shallow roots that will not be able to sustain them well as they grow larger. This actually applies to any trees you may plant - especially with the hot weather that we know is coming along. Roots seek the water wherever it is. Now is the time to start fertilizing trees

and shrubs. An all-purpose fertilizer works for nearly all the plants in the landscape. Citrus trees need a citrus fertilizer. Roses will benefit from a rose food but all-purpose fertilizer works well on them too. Fertilize roses regularly. They are heavy feeders. You can use a systemic rose food to control aphids as well as feeding them.

Citrus trees are available and have been blooming and soon the very small fruit will be seen in their place. They are probably no longer in need of protection from cold weather, but be ready to protect them should some freezing weather be predicted. Citrus trees should be fertilized regularly to keep them nice and green. If they begin to have yellow leaves with green veins they should be given some chelated iron.

Lawns should be fertilized with a lawn food. If your lawn areas have weeds invading them, it is helpful to use a lawn food that has a weed control incorporated in the formula. This is also a good time to plant a new lawn if that is in your plans. It is much easier to do it now before the



daytime temperatures become hot. That requires more frequent short watering sessions to keep the soil moist enough to help the seed sprout without washing some of the seed away or drowning the first new little sprouts.

It has been nice to see all of the early blooming plants. Our fence line of daffodils at the nursery were beautiful. I have noticed orchards in full bloom and the few fruit trees we had left from bare root season were pretty to see in all their different colors. Of course, the flowering quince along the roads and the yellow forsythia in yards are always early clues that spring like weather will soon be here.

Finally, Progress on Vital **Sites Reservoir Project**

Simple logic tells us that as climate change alters precipitation patterns, California must expand its capacity to capture and store water.

Even if the overall amount of precipitation remains unchanged, we will receive more of it in the form of rain and less as snow, which means the natural reservoir of the Sierra snowpack will decline as a water source.

We can prepare for that decline by creating more storage, either in new reservoirs or by replenishing underground aquifers. However, despite the urgency of the situation — one underscored by the current drought California politicians have been lackadaisical about doing what needs to be done.

Local and regional water authorities have been more diligent. Southern California's recent construction of more storage capacity is one reason it is less affected by the current drought than Northern California.

Belatedly, increasing storage is moving upward on the political agenda. Last week, the federal **Environmental Protection** Agency invited sponsors of the Sites Reservoir project, which has been Pass west of Los Banos. on the back burner for During periods of high decades, to apply for a \$2.2 billion loan that would cover roughly 40% of the project's estimated cost.

Along with some state water bond money and commitments from prospective users of the project — Southern California water agencies, mostly — Sites is now in position to put together a financing package to make it a reality.

"We've definitely turned the corner and we have a nice tailwind at our back," said Jerry Brown, executive director of the Sites Project Authority. Brown is not related to former Gov. Jerry Brown, whose Colusa County retirement home, incidentally, is not far from Sites.

It's not going to happen immediately, despite the urgency of the situation. Just assembling the loan package and getting approval could take several years and there are other hurdles to clear. Nevertheless, the strong possibility of a federal loan is a huge step forward.

If it becomes reality, the reservoir would be constructed on the west side of the Sacramento Valley, west of Maxwell. It would have a capacity of up to 1.8 million crucial while forcing us to acre-feet of water, about rethink the entire pattern half the size of the state's of water use. Lake Oroville, but unlike Oroville, would not dam a major river.

Sites would be an offstream reservoir, similar to — and slightly smaller than — the San Luis working for California Reservoir in the Pacheco *newspapers*.

precipitation and runoff, Sacramento River water would be pumped into Sites, then released back into the river as needed for agriculture, residential use or to maintain flows for fish.

As an off-stream reservoir, Sites escapes at least some of the traditional opposition to big water projects from environmental groups, but there is some criticism that it could be used to divert water during low precipitation periods.

"It's just a, kind of, different way of thinking about it," project boss Brown told the Associated Press. "There's a lot of fear and distrust and we have to operate in a way that we, you know, secure trust and address the fears."

The good news about Sites should be kept in perspective. It's just one of many steps that California must take to protect its vital water supply from the potential ravages of climate change.

It's entirely possible that climate change will not only change the mix of precipitation — more rain and less snow - but reduce the overall volume of water that falls on California, thus making more storage even more

Nothing is more critical to California's future.

2008/09 and then again in March of 2020, the rebounds that followed were nothing less than spectacular. Those that bought into the teeth of crash or right after either event, likely saw their balances soar.

Not a recommendation to buy stocks during crashes or anytime for that matter, investors can consider the absolute hammering certain stocks have had since the start of 2022. The technology-heavy Nasdaq stocks actually started eroding mid-November, with the more pronounced sell off starting around the first week of January.

stocks, as I called them, have been absolutely creamed, with some stocks off more than 80%.

Although no one can forecast market direction at any time, and markets can go a lot lower or higher than one might think and for longer than one might think, one has to consider some investors bought many of these stocks at much higher levels before the crash, and although many of these companies have seen their revenues drop as the country came out of the shutdowns, did these companies deserve the incredible haircuts they saw in their stock prices?

Much like after 2008/09 and the March 2020 sell off, it takes guts to start shopping in the garbage heap of obliterated stocks in the face of the negative sentiment surrounding such carnage.

But much like a clearance sale at your local retailer, one could make a case that if people loved these stocks at triple the same companies at a fraction of the price they were such a short time ago?

After all, although earnings may have taken a hit for some of these past Wall Street darlings, are the companies' still strong and viable entities with good products?

Many are.

When the markets crashed hard in months ahead, and some stocks might even surpass their previous highs.

> As is common in massive sell off events. many a baby is thrown out with the bath water, as previous high flyers turn into the most hated stocks on Wall Street.

> It is said to buy when there is blood in the streets, and certainly some sectors and individual stocks are gushing red.

> Like super stock rally events, many stocks go much higher than thought possible, and during horrific crashes, many stocks get way oversold to the point of ridiculousness.

Although bottom fishing can be a dan-Some of the popular stay-at-home gerous business, I like to nibble on beaten up securities during severe market sells off, garnering the cash for such buys when stops are hit on some of my stocks on the way down.

Stops are predetermined sell orders I have installed during the rallies to try and protect my profitable positions. As the stocks I may have bought go up, I set the sell points higher and higher, known as a "trailing stop" in an attempt to retain any profits I may have.

Although stops and trailing stops don't guarantee that gains or losses will be controlled, when executed properly, they can provide some comfort and react accordingly during market sell offs.

Then as the market continues down, I use cash from any sells to slowly add some stocks that were badly hammered when the obliteration levels reach, at least in my mind, the point of ridiculous.

Although prices may continue to drop, at least I know I am buying hopefully some price, why would one hesitate to buy these good companies at much lower prices during the "blue- light-special fire sales" event that severe market crashes present.



Shooter Sentenced in Motel 6 Homicide

BUTTE COUNTY, CA (MPG) - One of three suspects charged with the murder of John David Noonan, 41, of Chico, in a rear parking lot of the Chico Motel 6, was sentenced March 9 in Butte County Superior Court.

Eric Allen, 38, of Chico, was charged with using a firearm to shoot and kill John Noonan on Jan. 23, 2020. Allen pled to first degree homicide in January 2022 and was sentenced to 25-years-to-life in prison on March 9.

Butte County District Attorney Mike Ramsey said John Noonan's father, Michael Noonan, addressed the court during sentencing and described the extensive loss he has experienced throughout his life, but noted that nothing compares to the loss of a child. John Noonan left behind seven siblings and two children.

"Despite Allen's 25-to-life sentence, he will be eligible for parole in just 20 years, because of the Legislature's new 'Elder Parole program,' which allows inmates to seek parole after only 20 years of custody once they reach the age of 50, regardless of their how many years a judge ordered." Ramsey said.

The remaining two defendants, Justin Cozakas and Monica Ruggiero, are set for jury trial June 13. Both are charged with first degree homicide for their role in Noonan's murder, and they remain in custody at the Butte County Jail while they await trial.



Westwood Resident Arrested for Assault with a Deadly Weapon

Butte County Sheriff's Office Press Release

MAGALIA, CA (MPG) - On March 14, at approximately 10:21 p.m., BCSO began receiving reports that a victim was hit by a vehicle on Oak Park Drive, Magalia.

BCSO deputies, California Highway Patrol Officers (CHP), and medical personnel immediately responded to Oak Park Drive and located a female victim who had been hit by a vehicle. The victim was transported to a local hospital where she underwent emergency surgery. Doctors were able to stabilize the victim during the emergency surgery. She is currently in critical condition.

Deputies and detectives investigated and located evidence that Kayla McCally, age 29, of Westwood, was involved in an altercation with the victim. During the altercation, McCally got into the victim's vehicle, rapidly accelerated, hit the victim, and hit a tree. After crashing the vehicle McCally fled the area on foot.

Deputies, detectives, and CHP Officers contacted McCally at a residence on Bille Road, Paradise around 1:45 a.m. on March 15. Detectives located additional evidence which gave them cause to believe McCally was the individual who hit the victim.

McCally was arrested for the following felony charges: Assault with a deadly weapon, inflicting great bodily injury on a victim during the commission of a felony. felony hit and run, and felony driving under the influence of alcohol. "Transportation Tax Initiative"

Commentary by Bruce Lee

If you saw my last column ... "More Tax Please", you are aware of the recent court opinions which are now allowing politicians to take dusty, previously failed tax proposals and repackage them as new "citizen initiatives". And, by doing so, local government is bypassing the constitutional requirement for a two-thirds voter approval, and letting a "citizen initiative" for a new tax pass by only a simple majority vote requirement. SO MUCH EASIER TO PASS NEW TAXES!!

And also with this new method, local governments do not even have to bother with those pesky things like public hearings, keeping the public informed, and having reasonable public debate!! That darn public, don't they know the political elites know what is best for them? (sarcasm)

As I said before, now any special interest group with enough cash can push taxes that benefit themselves. If I can convince the bare majority to tax others for some "feel good" topic, then I'm the winner and feel no pain. I can tax business or the perceived wealthy for whatever issue has the emotional attention of the majority. All I have to do is pay enough signature gatherers!

And, so it is with a half percent, 40 year, transportation sales tax hike for Sacramento County. First proposed in 2016 and voted down; then resurfaced in 2020 to be pulled off the ballot at the last moment when the Sacramento Transportation Authority realized it would again miss the two-thirds threshold for passage.

Their consultant said the tax increase would not pass if there was any organized opposition to it. At that time, the Sacramento Taxpayers Association (SacTax) led the community wide coalition to oppose that proposal. The coalition consisted of business, agriculture, social groups and others - including the NAACP and the National Action Network; and the reasons to oppose the tax hike have not changed too much in the past two years.

First, it is still a bad time to propose a new tax. Although the pandemic appears to be subsiding, the county's economy is still weak. One third of SMUD customers are either

behind or have stopped paying their bills altogether. And small family businesses are still closing their doors. Inflation is raging. The cost of food and fuel is way up! This proposal has been kicking around for years, but county leaders seemingly cannot read the room that homeowners, renters and businesses are struggling.

Second, while we likely need roadway improvements because of age and deterioration, local governments, and especially Sacramento, have a history of neglecting infrastructure and instead fund fancy new projects or programs until roads, sidewalks, and other infrastructure start to fall into disrepair. It is only then they run to taxpayers for more money. We believe that historic neglect and lack of prioritization shouldn't be rewarded.

Third, this is a highly regressive tax falling disproportionately on the shoulders of the working poor and the middle class, hence the historic opposition by the NAACP and NAN.

As a concluding comment, the proponents of this half-percent tax increase are well aware of the broad spectrum of community concern and opposition of over the past years ago. Yet, as President of the Sacramento Taxpayers Association, nobody has reached out to us to even discuss digging up this sad proposal from the grave. That just gives the impression that the powers at hand simply scoff at the community at large, and simply want to take the easier path for themselves by holding out their hand for more money from us with the hope that they can beguile the public most of the time.





California School Choice Initiative

There's a saying that money talks. But, it's concerning to me when money is a bigger priority to schools than the concerns of parents. Parents know what is best for their children, and their concerns should be not just listened to, but responded to. I have seen firsthand that many public schools are not doing that.

So I will cave. If public schools won't listen to parents unless they have money, then parents need to have money. Money does talk. That's why I believe we need school choice.

Families of every ethnicity, educational and economic background are exploring home schooling and private schools. But, most can't afford to escape a system that is systemically failing their children.

The California School Choice Initiative

(Educational Freedom Act) would change this. With the act, every student will receive \$14,000 to spend on an accredited private or religious school of their choice. While this is the average, many options are less than this, and families would save the extra money for the students to use at college or vocational schools until the student turns 30.

Teachers will benefit from this, too. There will be an increased demand for teachers who migrate to private schools, which will result in better compensation.
