Cadets Share Aviation Encounters

YUBA CITY, CA (MPG) - On Sunday, February 20th youth from the local chapter of the Navy Sea Cadets had the opportunity to participate in aviation activities led by experienced pilots. The crew, many of whom were Navy veterans, flew into Yuba City to meet the local youth and their families. Three of the pilots were women and there is hope to encourage girls to pursue aviation and aeronautics.

The Cadets were shown various small airplanes and helicopters, including a 2-seater plane from the World War 2 era. One highlight of the experience was when each of the 40 cadets were able to take turns

being flown over the Sutter Buttes. Some even chose to livestream it on Facebook.

The Sea Cadets is a nationwide youth organization sponsored by the U.S Navy. While not officially part of the military cadets (ages 10-18) they regularly participate in drills and physical training. Younger cadets (10-14) make up the T.S Randy Goodman division while 10-to 14-year-olds belong to the Mathew Axelson Division

In addition to physical training there are classes on various topics from mechanics to resume writing. Some cadets even elect to undertake more advanced military style training. Any teen who completes the program can enlist in the military at an advanced rank should they choose to do so. Cadets come from a variety of different backgrounds. "Everyone is equal when they put on that uniform," says Lt. Sherry Herkal, who leads the Sea Cadet chapter.

Herkal makes sure that all potential cadets have the chance to be included. There are some fees for membership and uniforms, but local individuals and groups have made donation or sponsored individual youth. Sea Cadets has paid this forward, and volunteering is another of their values. They have recently been involved with assisting local veterans and military families.

LaMalfa Announces Economic Assistance Grant to Local Business

This EDA investment funds the Hands-on Tools Mobile Construction Training to create a mobile construction training educational program. The program is

anticipated to create over 100 new construction jobs in the area, which can help the region rebuild following a destructive wildfire or flooding.

"I'm looking forward to seeing the great things Valley Contractors Exchange accomplishes with this grant award. This Hands-on Tools Mobile Construction Training will expand workforce training opportunities that will address our area's construction worker shortage. I previously sent a letter of support for this award to the EDA. For over 60 years, VCE has provided high quality services and programs throughout the North State, and with this grant award they can continue their good work and extend the reach of their hard work," said Congressman LaMalfa.

"Valley Contractors Exchange is thrilled about EDA's grant award to support the launch of Hands-on Tools Mobile Construction Training, which will get tools in the hands of local youth, women, residents of fire-affected communities, and so many others," said Amy Rohrer, Executive Director of Valley Contractors Exchange. "This project is truly a community collaboration, enlisting construction industry professionals, community partners, and education to address the region's critical need to expand the construction workforce and rebuild homes and lives after years of devastating wildfires. By meeting potential workers where they are, many in our community will have the opportunity to secure well-paying, upwardly mobile careers in construction, all while playing a role in the region's emotional heal-

ing post-disaster.

"Our Butte Strong Fund citizens committee felt strongly about supporting this excellent program

with a \$326,000 grant,"said Chris Copeland, an NVCF program officer specializing in housing for the Butte Strong Fund. "We are always looking for ways to help in the rebuilding effort, but it's very complicated and requires varied approaches. This is an innovative one. The program will be run by skilled and connected building professionals to introduce young people to the construction trade, train eligible workers and upskill the current workforce. Elements of the program will also introduce fire survivors to the construction industry to provide opportunity to help replace homes that were lost."

Community Feedback

- Caltrans is soliciting feedback from community members on pedestrian and bicyclist location-based needs identified in District 3's Caltrans Active Transportation (CAT) Plan.

The goal of the CAT Plan is to align the state's bicycle and pedestrian network with the needs of local communities, with an emphasis on improving social equity, reconnecting communities, and improving access for all modes of transportation including people who walk and bicycle.

Caltrans has been working to develop the CAT Plan in coordination with regional partners, local governments, community-based organizations, and transportation planning agencies in all 11 District 3 counties since fall 2020. Survey feedback from community members and local stakeholders gathered in summer 2021 assisted Caltrans in developing a list of more than 600 location-based needs spanning urban, suburban, and rural communities along all parts of the state highway system. Needs identified include sidewalk gaps along Main streets, bicycle crossings at intersections, and limited crosswalk visibility at freeway interchanges.

Caltrans would appreciate public feedback on the list of identified bicycle and pedestrian needs by April 1, 2022. The summary report and accompanying story map are available for review at https://www.catplan.org/district-3. "Stories of the Museum"

Series 2 by Bill Crocker, CDR, USNR, Ret. Museum of the Forgotten Warriors board member and webmaster

More than a thousand military men and women and family members have donated thousands of personal items and stories to the Museum of the Forgotten Warriors over the past forty years. The displays span World War I to the conflicts in Iraq and Afghanistan and tell the stories of those who fought and died. The series, Stories of the Museum, describes a few of these in more detail.

THE DMZ ANGEL AND THE DUSTOFF PILOT

Sandy Peterson was raised in Rochester, New York, graduated from high school in 1966, and entered college in a nursing program. A US Army recruiter convinced her to become an Army nurse upon graduation. After basic training, she was sent to the 18th Surgical Hospital in Quang Tre Province, Vietnam, about fifteen miles south of the

A nurse's day in the hospital was filled with long hours and little sleep. She often worked twelve-hour shifts, sometimes for two or three days straight. A few hours of sleep were obtained on a stretcher on the floor. The routine was fifteen to twenty minutes with each patient prior to surgery. Once her preparation of the patient was complete, it was on to another. Often, she did not know if her guy lived or died.

Demilitarized Zone.

"There were times when the injuries were so bad, I just sat by their bed side," Sandy said. "I talked to them so they knew they weren't alone . . . so their mothers would know they didn't die alone."

Chief Warrant Officer Robert Oren Hill, Jr. was a DUSTOFF pilot assigned to the 237th Medical

Detachment. DUSTOFF is an acronym for Dedicated Unhesitating Service To Our Fighting Forces. A DUSTOFF pilot flew an unarmed Bell UH-1 Iroquois helicopter, known as a Huey, into the heat of battle to rescue the wounded and transport them to field medical units. These men were the bravest of the brave, defenseless and dedicated to one mission: providing the wounded with a chance to live. Hill and the other pilots were stationed at Phu Bai, south of Quang Tre. They flew the wounded to the hospital where LT Peterson worked.

Bob and Sandy became very close friends. Several times, Bob invited Sandy to fly with him during periods of downtime. He taught her to handle the Huey for short periods and even gave her the call sign DMZ Angel and a pink pilot's helmet. One can image the surprise of the ground crew as a female voice came over the intercom requesting permission to land.

On 27 September 1970, Bob was the copilot of a flight directed to search for a missing Huey

that was transporting a very badly burned Vietnamese child to the hospital in Quang Tri. His helicopter crashed while trying to operate at a very low altitude in extremely adverse weather. All the crew perished.

Sandy left the Army after fifteen months of war and continued her career as a registered nurse in Lodi and later in Stockton, California. She retired from Dameron Hospital as the endoscopy department manager. She passed way in Stockton on 6 August 2021 at the age of seventy-two. First Lieutenant Peterson's donations may be viewed in the glass case marked B-14.



West holds a Master's Degree in Geography from CSU, Chico. She is a Butte County native, the place of her childhood home, which was destroyed in the North Complex Fire.

Federal Water Supplies Cut Off from Central Valley Project

Thousands of California farmers and ranchers will get no federal water deliveries for 2022. The U.S. Bureau of Reclamation announced that it is suspending all shipments to irrigation contractors that rely on the Central Valley Project. This marks the second straight year no federal water was supplied due to drought conditions. The water picture has only worsened since December snowstorms. Most of that early snowpack melted away in the dry January and February.

UC Merced Study: Drought in 2021 Cost California Agriculture \$1.1 Billion

The drought is having a severe economic toll on California agriculture. A new study from the University of California, Merced, said exceptionally dry conditions in 2021 resulted in a \$1.1 billion loss for farm businesses in the state. An estimated 8,750 full- or part-time agricultural workers lost their jobs. The report also said 395,000 acres of farmland were idled. Crops most affected by fallowing were rice in the Sacramento Valley, cotton in the San Joaquin Valley and grain and field crops statewide.

Cattle Ranchers Face Tough Decisions as Pastures Turn Brown

The next two weeks may be crunch time for California ranchers, who are hoping for rain to get their pastures growing and keep their livestock fed. With grazing lands browning, many ranchers may need to rely on feed hay, for which prices are surging. Freight costs are also soaring. Without more precipitation, more ranchers may have to weigh decisions on culling their herds. The cattle market is better than last year, but prices are lower than during the state's last drought.

USDA Funding to Boost Market Access for Regional Food Producers

The U.S. Department of Agriculture is releasing \$130 million in supplemental funding to help promote and create expanded markets for regional food producers. The funding from the American Rescue Plan Act and the USDA's Local Agriculture Market Program is intended to strengthen opportunities for farmers and rural producers to sell products to institutions, including universities and hospitals.

DC area bracing for trucker convoy protests as nearly 1,000 vehicles hit Maryland town | 5 March 2022 | Long lines of 18-wheelers and other trucks crowded the roads of Hagerstown, Maryland, early Saturday as the Washington, DC-area prepared for protests over COVID-19 mandates. While other similar US trucker convoys have fizzled, this one started gaining steam Friday evening. Roughly 1,000 vehicles arriving from all directions converged on Hagerstown Speedway, clogging traffic, the Washington Post reported. As of 8 p.m., a twomile-long line of cars and trucks could be seen stuck in traffic on Route 40 trying to get into the location, WUSA-9 TV reported. Some truckers participating in the "People's Convoy" said they planned to head to the DC Beltway area Saturday, but others said they were awaiting instructions.

US Surgeon General asks Big Tech platforms to hand over Covid 'misinformation' data | 4 March 2022 | Joe Biden's Surgeon General Dr. Vivek Murthy formally requested Big Tech companies submit data on the prevalence of COVID-19 "misinformation" on social media, instant messengers, search engines, e-commerce platforms, and crowdsourcing platforms. The request for information is part of the Covid National Preparedness Plan that Biden announced during the State of The Union address on Tuesday. The surgeon general's office wants platforms to submit data on the prevalence of alleged Covid misinformation, beginning with the common examples of such misinformation outlined by the CDC. Dr. Murthy's request asked about the major sources of Covid misinformation, including those that have been providing "unproven" treatments. The request for information asked platforms to provide data on "exactly how many users saw or may have been exposed to instances of Covid-19 misinformation," and the demographics that have allegedly been disproportionately exposed and affected by Covid misinformation.

Pfizer Vaccine Only 12% Effective in Kids 5 to 11, Study Says – | 1 March 2022 The effectiveness of the Pfizer-BioNTech COVID-19 vaccine against Omicron "declined rapidly for children, particularly those 5-11 years," according to a study released February 28. The authors of the study still recommended the vaccine for that age group, stating it was protective against severe disease. They also proposed the recommended dose for 5- to 11-year-olds was too small, suggesting a higher dose might solve the problem. According to The New York Times, the study's lead author, Dr. Eli Rosenberg, briefed Dr. Rochelle Walensky and other officials at the Centers for Disease Control and Prevention (CDC) on the New York data in early February. U.S. Food and Drug Administration (FDA) officials learned of the data around the same time. Some scientists at those agencies then pushed for the data to be made public before an FDA meeting, scheduled for Feb. 15, to review Pfizer's application for Emergency Use Authorization of a three-dose regimen of its vaccine for infants and children 6 months to 5 years old. But the study's findings were only made public on Monday.

Durham Tells Court Not to Dismiss Charge Against Lawyer Who Hid Ties to Clinton Campaign | 5 March 2022 | Special Counsel John Durham on March 4 told a federal judge not to dismiss a charge against a lawyer who lied to the FBI about representing Hillary Clinton's presidential campaign. Michael Sussman was representing the Clinton campaign when in 2016 he passed along information to an FBI counsel. His lawyers say the documents "raised national security concerns" while prosecutors describe them as purportedly detailing a covert channel between a Russian bank and the business of Donald Trump, Clinton's rival at the time. Sussman was charged with lying to the FBI because he falsely told the counsel he was not providing the allegations to the FBI on behalf of any client despite presenting the information on behalf of the Clinton campaign, prosecutors say. In a filing in February, Sussman's lawyers moved to dismiss the charge, claiming their client "did not make any false statement to the FBI" but even if he had, "the false statement alleged in the indictment is immaterial as a matter of law."

Feinstein Now Must Decide Whether to Retire

Whither Dianne Feinstein? California's senior U.S. senator, a California political fixture for more than a half-century, was facing a turning point even before her husband, financier and philanthropist Richard Blum, died on Sunday of cancer.

The Senate's oldest member at 88 and the state's longest serving senator has clearly fallen out of favor with voters, even her fellow Democrats.

A new poll by UC-Berkeley's Institute of Governmental Studies found that after years of steadily eroding popularity, just 30% of the state's registered voters now approve of her, including just 45% of Democrats. Meanwhile, 49% said they disapproved.

"The five-term senator now receives more negative than positive job ratings from strong liberals, women, voters of color, younger voters, as well as voters in Los Angeles County or the San Francisco Bay Area," the poll noted.

Feinstein has been a senator for nearly 30 years, following two decades of public service in San Francisco, including a stint as mayor. She was once one of the state's most popular politicians due to her centrist, pragmatic approach, interest groups with issues in Washington.

However, political polarization has left her drifting in political no-man's land, reflexively despised by Republicans because she's a Democrat and increasingly alienated from a leftward-drifting Democratic Party.

As Donald Trump's presidency widened the ideological divide, Feinstein' centrism, particularly her willingness to cross the Senate aisle and do business with Republicans, made her a pariah to the Berniecrat wing of her party. Four years ago, as she was seeking another Senate term, the state party endorsed rival Kevin de

Feinstein easily defeated de León in 2018 but her popularity continued its downward course, not only because she's out of step with her party but due to her age and media reports that she may be suffering the cognition effects of old age. She must now - and soon decide whether to seek still another term in 2024.

Feinstein has said she's running again, but she would say that under any circumstances because that's what politicians do. Were she to announce retirement, her clout in the Senate, which already has waned somewhat, would vanish and there would be a feeding frenzy among California's ambitious Democratic politicians.

That said, it was at least a 50-50 bet that Feinstein wouldn't seek another term in 2024 even before the devastating poll and her husband's

and was the go-to per- death. There's now a son for California's strong probability she won't run, approaching near-certainty.

> As that probability sinks in, those ambitious politicians will be maneuvering to become her successor and all eyes will be on Gov. Gavin Newsom.

> Newsom won't have any trouble winning re-election this year, barring some cataclysmic x-factor, but what then?

> Had Trump won a second term in 2020, the door would have been open for Newsom to make a run for the White House in 2024. But with Joe Biden's victory - and more pointedly, Californian Kamala Harris' elevation from the Senate into the vice presidency - a 2024 presidential run by Newsom seems highly unlikely.

> Newsom wears ambition on his sleeve and if he wants to extend his political career, the next logical move would be into the Senate, and there's no better springboard than a landslide re-election as governor this year.

> Newsom is certainly not the only California politician who might want to succeed Feinstein. There are probably several dozen Democratic members of Congress who see a senator staring back when they look in the mirror, plus some other statewide officials and big city mayors.

> It all hinges on whether Feinstein is ready for a well-earned political retirement.

The Continuing Erosion of the Stock Market

The continuing erosion of a stock maris interrupted by bouts of stock buying, kets is a painful event for investors. Like the latest 7 week period starting around the first of the year, the market seemingly fell almost nonstop until last Thursday, February 24th.





CDC Under Fire for Not Publishing All COVID-19 Data It Collects

A top U.S. agency is under fire for withholding some of the COVID-19 data it collects.

The Centers for Disease Control and Prevention (CDC) confirmed to The Epoch Times that it hasn't published some of the data it has collected on COVID-19 reinfections.

The spokesperson said the agency dropped plans for publishing a paper based on the data "given other response priorities" and because part of the same data was already presented in a published manuscript. An agency representative told The New York Times that it has also withheld other information, including details on how COVID-19 vaccine booster doses have affected young people.

The data hasn't been released or has been released slowly because it takes time to make sure that "it's accurate and actionable," the representative said, noting that there are fears that the information might be misinterpreted.

Multiple experts say the CDC should make all data available.

Dr. Robert Malone, who helped create the messenger RNA technology used in some of the vaccines, said the CDC's actions are a type of fraud.

"Withholding data, key data, is scientific fraud," Malone told The Epoch Times.

Dr. Jay Bhattacharya, a professor of medicine at Stanford University, said the CDC shouldn't "withhold information in order to manipulate behavior."

The agency should "help Americans understand the data in context and provide guidance to improve the lives of all Americans," he wrote on Twitter.

Paul Mango, a former official at the Department of Health and Human Services, said the CDC's role should be collecting and disseminating data, not analyzing it itself.

"The CDC just doesn't have the capacity to conduct research as quickly as the pandemic is moving," Mango told The Epoch Times.

As one example, the Cleveland Clinic has been publishing papers since mid-2021 on the natural immunity that many of its employees enjoy after recovering from COV-ID-19. The CDC didn't publish a major study on the subject until January.

Mango, whose book on his time with Operation Warp Speed will be published soon, said the federal government would have done things differently if the role of natural immunity was better known in the wake of the COVID-19 vaccines being authorized. Instead, the government led efforts that resulted in many people who had immunity getting some of the early doses, ahead of people who were more at risk.

The CDC has been collecting data on so-called breakthrough infections— COVID-19 cases among the vaccinated—a spokesperson told the NY Times, but the agency hasn't published the figures because people may interpret them as the vaccines not performing effectively—the same reason given by Scottish health officials recently in halting the publication of some data.

On April 30, 2021, the CDC published data on breakthrough infections for the last time. The data show that at least 9,245 people

had suffered breakthrough infections and that 132 of the patients had died.

Those numbers were reported by 46 U.S. states and territories but were described as a likely undercount because the reporting system is passive and doesn't require reporting, in addition to the jurisdictions that didn't report any data.

The CDC kept reporting hospitalizations and deaths among the vaccinated, but it transitioned from publishing raw numbers in the fall of 2021 to reporting rates of cases, hospitalizations, and deaths.

As of Oct. 18, 2021, juris-

dictions reported more than 30,200 hospitalizations and more than 10,800 deaths among the vaccinated.

Breakthrough infections and reinfections are important to check because they're barometers of how strong immunity is against the CCP (Chinese Communist Party) virus, which causes COVID-19.

A CDC spokesperson told The Epoch Times that it's holding unpublished data on reinfections that it received from the Emerging Infections Network, a group made up of roughly 3,000 medical professionals.

More Nuanced

The CDC didn't provide a response to the criticism by press time, but some experts say the agency is working under constraints and has already published a lot of data.

"The fact is that the CDC website and publications have extensive information, and many of the limitations reflect the reality of working in the U.S. health care and public health systems," Dr. Tom Frieden, a former CDC director who's now president and CEO of Resolve to Save Lives, told The Epoch Times in an email.

Dr. Roger Klein, a health policy expert who has advised the CDC and other federal health agencies, said transparency is a good idea, but information conveyed by agencies needs to be accurate and put into proper context.

Holding back incomplete datasets is appropriate, according to Peter Pitts, a former Food and Drug Administration associate commissioner.

Mango believes the CDC should move to release the data while emphasizing which numbers agency experts feel comfortable with and which numbers they don't.

Poison Control Centers Warn About Toxic Chemical in At-Home COVID-19 Test Kits

Some at-home rapid COV-ID-19 tests contain a toxic chemical that may be harmful to both children and adults, according to health officials.

The Cincinnati Drug and Poison Information Center reported an uptick in accidental exposures to a possibly toxic substance, sodium azide, in at-home COVID-19 test kits, according to a blog post. Meanwhile, the National Poison Control Center issued a warning about the chemical.

"It is important to know that the extraction vial in many rapid antigen kits includes the chemical sodium azide as a preservative agent," the center said. "The BinaxNow, BD Veritor, Flowflex, and Celltrion DiaTrust COVID-19 rapid antigen kits all contain this chemical."

Sodium azide is a colorless, odorless powder that testers dip cotton swabs into. The chemical is found in herbicides, pest control agents, and airbags for cars.

"Small doses of sodium azide can lower blood pressure, and larger doses may cause more serious health effects," an advisory from Health Canada also said. "ProClin is also found in many kits. It contains chemicals that can cause skin and eye irritation, as well as allergic reactions."

Some hospitals around the United States say they have received a surge in phone calls about exposures to the chemical.

"We started getting our first exposures to these test kits around early November," said Sheila Goertemoeller, pharmacist and clinical toxicologist for the Cincinnati Children's Hospital Medical Center. "It was, really, all ages."


"Mostly, I've been very worried about our young children."

Accidental exposure is occurring among both children and adults, said Dr. Kelly Johnson-Arbor, with the National Capital Poison Center in Washington, told WNEP over the weekend.

"People might mistake them for eye drops. Children might drop it onto their skin. Adults will sometimes mistakenly put them into their eyes," she said.

"You don't want to leave it on the skin because it could potentially cause an allergic reaction or a skin rash.

"If someone drinks the solu-

tion, it's really important to contact poison control right away. The solutions have different ingredients. Some have non-toxic ingredients and others have more dangerous ingredients."

Officials told WNEP that there's no need to throw away the test kits, but people should be mindful when using them.

"Use them properly, dispose of them properly, and it won't cause an issue," Dr. Jeffrey Jahre, with St. Luke's University Health Network,

told the outlet.

If you suspect you or someone you know has ingested the chemical, officials recommend not to make the person vomit. For eye exposures, rinse the eyes for 15 to 20 minutes with warm water. For skin exposures, rinse the skin well with tap water. Immediately check the Poison Control Center's online tool for guidance or call poison control at 1-800-222-1222, the website says.






