### Yuba Water Approves a Local Costshare Grant

MARYSVILLE, CA (MPG) -The Yuba Water Agency Board of Directors today approved a local costshare grant worth up to \$240,000 for the Yuba Watershed Protection and Fire Safe Council to reduce the risk of catastrophic wildfire and improve public safety for communities in the Yuba County foothills.

The funding will serve as the local cost share to help the Fire Safe Council be more competitive in its application for a Cal Fire grant worth up to \$3.2 million. If the council is successful in getting the Cal Fire grant, the funds will be put toward a major project to reduce roadside fuels on approximately 1,000 acres within the five eastern Yuba County fire districts.

"Roadsides are the most frequent ignition points for wildfires," said JoAnna Lessard, Yuba Water project manager, "So, this work will not only reduce the risk of wildfire, but also protect evacuation routes in the case of a large fire." "This project is critical to protect rural Yuba County residents, as well as our facilities located in the foothills," said Yuba Water Board Vice-Chairman Randy Fletcher, whose district encompasses the foothills. "It would be great if our grant can leverage millions in state funds to minimize the risk of wildfire in our communities. With the dryness we're already experiencing and the winds, the potential for wildfire exists right now." If the Fire Safe Council is approved for the Cal Fire grant, Yuba Water's funding will be used for project management costs, required surveys and hiring a forester to provide implementation coordination and oversight. Yuba Water's grant application acceptance windows are during March and September each year. This grant was considered sooner because the Cal Fire grant application is due Feb. 9 and it uses Yuba Water's grant program to leverage external funding. Learn more at yubawater.org. \*

# **DA Files Charges for Attempted Murder of CHP Officer**

#### **Office of Yuba County District Attorney**

MARYSVILLE, CA (MPG) - Yuba County District Attorney Clint Curry filed a criminal complaint in Yuba County Superior Court, alleging charges against Aaron Tobias Quinn for his alleged actions during an incident that ended on La Porte Road in Yuba County on Sunday, January 16, 2022. The criminal complaint

(1) PC 664(f)/187(a)

alleges five charges:

a Peace Officer; (2) PC 245(d)(2) - Assault with a Semiautomatic Firearm on a Peace Officer; (3) PC 29800(a) - Being a Felon in Possession of a Firearm; (4) VC 2800.2(a) - Recklessly Evading a Peace Officer; and (5) H&S 11379 Transportation of Methamphetamine.

The complaint contains additional allegations that Quinn personally discharged a firearm while committing the attempted murder, that he was out of custody on

- Attempted Murder of bail or released on his own recognizance on a pending felony case in Butte County when he committed the offenses, and that he has two prior strike offenses that would qualify him for sentencing under the three strikes law.

> Quinn, who is presumed innocent, is facing a maximum penalty of Life. An arraignment date has not been scheduled because Quinn remains hospitalized with injuries he received during the incident.

# Four Arrested in Paradise for Contracting Without a License

#### **Butte County District Attorney Press Release**

BUTTE COUNTY, CA (MPG) - A multi-agency investigation involving Butte County District Attorney Investigators, Paradise Police, and the California Contractors State Licensing Board (CSLB), led to multiple felony arrests yesterday of unlicensed contractors operating on the Paradise Ridge.

Butte County District Attorney Mike Ramsey announced today that his office has been working with several state and local agencies after receiving complaints of unlicensed contractor activity occurring on the Ridge. In the aftermath of the Camp Fire, the town of Paradise has seen an obvious increase in contractor activity. Ramsey said while the majority of contractors maintain all required licenses and insurances, some individuals attempt to skirt the laws meant to protect consumers.

Ramsey said that the operation carried out yesterday focused on unlicensed activity and led to the arrest of four individuals who held themselves out to be contractors but are not licensed through the state.

Gustavo Noriega, 30, of Live Oak and Josiah Westby, 35, of Paradise were arrested for contracting without a license and released on \$15,000 bail. Zachary Green, 36, of Oroville was arrested for contracting without a license and later cited to appear. All three are scheduled to appear in Butte County Superior Court April 8, 2022. None have any record of holding a contractor's license.

Terry Sumpter, 43, of Corning was arrested for contracting without a license, two counts of possession of controlled substance, and one count of possession of drug paraphernalia. Sumpter remains in jail in lieu of \$22,000 bail and will appear in court on January 21, 2022. Sumpter has never held a contractor's license.

Ramsey said he understands the

pressure and stress those affected by the Camp Fire feel in trying to rebuild and move forward with their lives. The lack of resources, lack of available licensed contractors and increasing costs only aggravate those emotions. Unlicensed contractors, however, use those emotions to get building contracts, and often leave their clients with poor quality work, or in some instances, no work at all. Licensed contractors are required to have a bond to commit to completion of their work.

Unlicensed contractors, who do not pay worker's compensation insurance and other fees, are able to underbid licensed contractors, who are following the law. Ramsey said his office and Paradise Police are currently working other contractor fraud investigations.

"It is important we do everything we can to protect the hardworking contractors who are trying to do it right." Ramsey said. The joint effort is also aimed at protecting the citizens of Paradise as they try to rebuild and reestablish their lives. While these investigations are technical and complicated, both Paradise Police and the District Attorney's Office are committed to review any complaint for potential criminal activity.

Ramsey said he urges citizens to research their potential contractors through the CSLB website https://www. cslb.ca.gov/onlineservices/checklicen-

seII/checklicense.aspx for the current license status and worker's compensation insurance coverage. Ramsey also said it is important that potential homeowners know their rights and protections when using a contractor- such as not fully paying for services prior to completion.

# **Chico State Hacker Sentenced**

#### **Butte County District Attorney** Press Release

BUTTE COUNTY, CA (MPG) - A 22-year-old Chico man appeared in Butte County Superior Court where he admitted to illegally hacking numerous computers at Chico State University and was sentenced to probation, fines, and community service. The illegal "hacking" led to the online posting of a list of university students who had applied for COVID-19 vaccine exemptions.

Butte County District Attorney Mike Ramsey said an extensive investigation by University Police lead to Alejandro Benitez, a recent graduate of the University, who worked in the Information Technology Support Services Office on campus. Ramsey said the investigation began when a Sacramento newspaper published an article in August describing a spreadsheet that had been posted on several online forums. The spreadsheet included requests from about 130 students who requested religious exemptions from the University's vaccine mandate. Student names and personal information were included in 18 of the entries.

Ramsey said the Chico State University Police examined the posted spreadsheet and were able to back trace a trail to Benitez. The police also discovered it was a Chico State professor who had tipped off the media as to the existence of the online posts. The professor told police rather than alerting the University about his discovery, he instead alerted his union and the media with the hope any potential civil rights and privacy violations would be investigated. Ramsey stated the professor would not be facing charges, as his actions were not criminal. Ramsey explained the criminal conduct involved in this case was unlawfully accessing the University's computers.

Ramsey said it was determined Benitez got the confidential exemption lists by illegally accessing and downloading files during the course of his employment from at least two computers assigned to Chico State administrators.

Ramsey said prior to his posting the spreadsheets on the internet, Benitez attempted to redact the students' personal identifying information, but he failed to note some of the students' personal identifying information was located in other columns of the spreadsheet.

Benitez entered a plea of no contest to the crime of Unauthorized Computer Access. Butte County Superior Court Commissioner Kurt Worley sentenced Benitez to three years of probation and fines of \$370. Benitez terms of probation include completing 80 hours of community service and a prohibition from accepting employment where he could have access to a computer unless that employment is approved by the court. Commissioner Worley warned Benitez he will be required to serve a minimum of 180 days in Butte County Jail if there are any violations of probation.



#### Proposition 12 Hog Requirements Could Complicate Junior Livestock Sales

The housing requirements for hogs under California's Proposition 12 don't apply to 4-H programs and exhibitions at fairs or rodeos. And yet the California Agricultural Teachers' Association says administrative costs and burdens imposed by the law on meat processers will impact junior livestock exhibitors who want to sell project pigs into the general food market. That's because those market hogs will need paperwork showing they come from farms certified as Proposition 12-compliant.

#### Citrus Farmers Face Rising Costs, Smaller Harvests

California citrus growers are facing increasing costs for bringing their crops to market. The California Citrus Mutual trade association says farmers are facing price increases in water, labor, fertilizer, pesticides and transportation. Amid drought and pandemic-related supply-chain challenges, 4% of last season's citrus crop was neither picked nor sold. This year, a down-year growing cycle, the navel crop is expected to drop by 20% and mandarins by as much as 45%.

#### December Storms Deliver Modest Increase In Water Allocations

California farmers and ranchers may have some modest relief in water allocations this year due to December rains. The California Department of Water Resources is increasing deliveries from the State Water Project to 15% of requested supplies for 2022. That's an improvement from last year when water officials provided just 5% of allocations. That was before the state cut off surface water supplies from the Sacramento-San Joaquin Delta in August due to severe drought.

#### Output Drops For Processing-Tomato Farmers Amid Challenges

California's anticipated tomato production shrank last year due to water shortages and higher production costs, farmers say. Some processing-tomato growers who once paid \$3,000 per acre on their crop say they're paying more than \$4,000. Last year, state processors intended to contract for 12.1 million tons of tomatoes. By the end of harvest, that figure had dropped by 1.3 million tons, as farmers adjusted production forecasts downward.

## **NET-5 Task Force Makes a Bust**

#### Yuba Sutter NET-5/GTF Press Release

SUTTER COUNTY, CA (MPG) -On Tuesday, January 18th, 2022, at approximately 07:00 a.m., Agents from the Yuba Sutter Narcotic and Gang Enforcement Task Force (NET-5) executed a search warrant in the 2100 block of Live Oak Blvd., in Yuba City. The target of the search warrant, Marcus Mercado (31 years old), was believed to be selling powder fentanyl out of the residence. During the execution of the search warrant, NET-5 Agents located 15.3 grams

of powder fentanyl, 20 broken Xanax pills, packaging, and a digital scale, inside of Marcus Mercado's bedroom. At the time of the warrant, Mercado was inside his bedroom with Kylie Torres (22 years old) of Marysville, CA. Bryan Stacey (45 years old) was also believed to be living in the residence during the search warrant and found to be in possession of approximately 136 grams of methamphetamine.

#### Commentary by Andrew Langer

Google just suffered a major defeat in its legal battle with Sonos. A judge ruled that Google infringed on five of Sonos' audio patents. If the ruling is upheld, Google could pay hundreds of millions and face a ban on importing everything from Pixel smartphones to Nest speakers.

This isn't a trivial development. It's the latest in a string of lawsuits intended to stop Big Tech from pilfering from smaller companies. In recent years, Big Tech firms have increasingly infringed on smaller rivals' IP. Those smaller firms have started fighting back. Now, the largest tech companies could face tens of billions in damages.

If Big Tech executives continue, their firms could suffer irreparable financial and reputational damage. Stealing rivals' IP is no longer merely unethical, it's a business decision so disastrously short-sighted that it constitutes a breach of duties to shareholders.

For a long time, giant technology firms like Apple figured they could freely prey on smaller competitors, who wouldn't have the financial firepower to fight back. That's no longer the case.

Small firms have decided suing is worth the cost and have won big. In three cases this past year, juries awarded small firms more than \$1 billion.

In August, Apple was ordered to pay PanOptis \$300 million over 4G technology infringement. Last year, a court ordered the company to pay \$1 billion to VirnetX, a VPN patent holder. Last October, a federal court ordered Cisco to pay nearly \$2 billion to Centripetal Networks, a cybersecurity firm.

IP theft has the potential to put a dent into Big Tech's bottom lines. Cisco's payout cost it 4% of its annual revenue. Apple recently threatened to pull out of the United Kingdom entirely rather than face a \$7 billion patent-infringement fee in British courts.

Even if big firms can weather the financial penalties, the reputational damage is considerable. Congressional committees regularly haul executives into their chambers for hearings about anti-trust and privacy infractions. Consumers increasingly regard Facebook, Google, Apple, and Amazon with distaste. If politicians and customers learn these companies' profits rest on persistent theft, their reputations will take a pounding.

Big Tech executives have a duty to their shareholders. Executives who turn a blind eye, exposing their firms to immense legal and reputational risk, will eventually find their morally questionable decisions reflected in share prices.

Shareholders, rank and file employees, and other stakeholders should hold executives to account. It's in the interest of investors to pressure Apple and others to settle cases and hash out licensing agreements.

If Big Tech starts operating within the bounds of IP law, they'll prime the entire sector for success. Consumers and shareholders should want both small and large firms to thrive. Smaller firms develop software, applications, and hardware that often end up in consumer-facing products.

But when the big guys bully the little guys, pillage their best ideas without paying, the little guys have no incentive to innovate.

It's time for Big Tech to stop patent theft.

## **Newsom's Vacillation on** Vaccinations, Phase 2

Is California – and its politicians – ready for VAX War II?

More pointedly, is Gov. Gavin Newsom ready?

Three years ago, the Capitol was wracked by one of the most heated conflicts in its history – legislation to make it more difficult for parents to exempt their children from mandatory vaccinations if they attended public schools. A bill sought to close a loophole that allowed doctors to approve exemptions without specifying reasons, leading to doctor-shopping by anti-vaccination parents.

Hundreds of opponents besieged the Capitol, claiming that the legislation would violate parental rights and require vaccines that could trigger autism or other adverse reactions. The measure's author, Sacramento Sen. Richard Pan, and other backers were accosted and threatened and on the final night of the legislative session, someone in the Senate gallery threw a cup of what authorities said "appeared to be blood" onto the Senate floor.

Eventually, the bill passed and was signed by Newsom in his first year as governor, but he engaged in some bizarre political theater before finally acceding.

As the bill was moving

Newsom suddenly demanded a number of changes that weakened its provisions. "I'm a parent," Newsom said at one point. "I don't want someone that the governor of California appointed to make a decision for my family."

After two weeks of private negotiations, he finally accepted a revised version, telling a reporter, "All those amendments, if they're made, stamp of approval."

Two-plus months later, however, Newsom did another 180-degree pivot, demanding more changes. Eventually, a final compromise was reached, but Newsom had violated one of the Capitol's unwritten rules of conduct: once you make a deal, you don't renege. It drove a wedge between the new governor and lawmakers that affected other issues.

The possibility of renewing superheated vaccination warfare arose this week when Pan, a physician. introduced legislation to close what he regards as a huge loophole in Newsom's promise to have all school children vaccinated against COVID-19 when vaccines are available for youngsters.

"We have to be willing to take a stand," Pan said. "We need to be able to respond to this pandemic and future pandemics, but there is this asymmetrical warfare going on right now, and we're seeing the anti-vaccine movement trafficking in misinformation, threats, and violence."

"Today's measure, just like our first-in-the-nation school masking and staff vaccination requirements, is about protecting our children and school staff, and keeping them in the classroom."

> That would seem to be a strong endorsement of mandatory vaccinations. However, Newsom subsequently watered it down, at least verbally, by repeatedly reminding parents that they could opt out under state law's "personal belief" exemption. Pan's new bill would eliminate that exemption, leaving only precise medical conditions as a way to avoid vaccination.

Newsom's n e w fence-straddling is not going unnoticed.

"He's trying to be comforting and non-confrontational, but it sends a message that if you don't want to get the vaccine, don't get it," Catherine Flores Martin, executive director of the California Immunization Coalition. told CaliforniaHealthline. "Gov. Newsom struggles with this - he's trying to have it both ways."

Yes, he is.

### 2022 Inflation

When 2020 ended, we had hoped 2021 would bring us back to some sort of normalcy. CoVid-19 had other plans however, and it was not to be. Now, as we enter 2022, hopefully with better medical knowledge on how to deal with the virus, vaccines and a somewhat milder version that the Omicron variant is rumored to be, we can once again hope the world returns to some sort of semblance of order.

Unfortunately, the market is not cooperating and falling uncharacteristically hard.

In March of 2020, the Dow fell a stunning 38% in three weeks, which was the fastest swing from a bull market to a severe correction in history.

At 38% down, it had arrived at a mathematical resistance point indicated by the Fibonacci method detailed here: (https://www. investopedia.com/terms/f/ fibonacciretracement.asp)

This theory states there are a variety of resistance points, of which some of the major ones, and include crashes that go down 38%, 50% and 80%. At down 38% in March 2020, the Dow appeared to have halted its decline and in hindsight, it nailed the Fibonacci resistance point almost to a "T".

For comparison, the 2001 crash hit the S&P by 50% down and the NASDAQ by 80%. The 1929-1932 crash events also were down 80%. All Fibonacci numbers. a whole.

(Coincidence?) Take a look at those cor-

rection numbers again. Can you imagine a 38%

the world of markets. And are you prepared for

that kind of crash? Few are.

2021 arrived and early on, the market started to bounce wildly with every new variant, new vaccine and the latest rumors of Government responses to CoVid-19.

Although 2021 saw some scary sell offs, it never witnessed the type of crash that occurred in 2020. The reasons for this are heavily debated, but it is thought the massive amount of money creation (rescue programs) by the Fed to stave off massive economic damage from the shut downs found its way into the markets, as money creation usually does.

Unfortunately however, as a result, we are now witnessing another outcome from all this created cash. which is severe inflation. In order to stop inflation, the Federal Reserve will usually raise interest rates, which puts a damper on the money supply and therefore slows the economy.

The risk of a Fed tightening (raising interest rates) may be the cause for the current severe erosion in stock prices. No doubt, the current fall is a serious event, already taking down the Nasdaq by over 10%, with some technology 60-80% off their highs. Some analysts are calling for a 50% correction in the Nasdaq, while others say another 10% sell off is in the cards for the market as

Now here is the rub. Money creation will not cause inflation without velocity (faster money circulation). However right now, money velocity is almost at an historic low. (530) 559-1214.

Anything is possible in Velocity increases as more people acknowledge inflation. With inflation at the highest it's been since 1982, and money velocity still near zero, when velocity does pick up, inflation may outright crush the consumer.

Coupled with supply shortages due to CoVid sick outs, the inflation that may be headed our way may beyond what we have seen in our lifetime, barring the 1980's, if you were alive back then like I was.

If that happens, the FEDS will be forced to raise rates, and not by the anemic 1/4 of percent we have seen by the current dovish, market sensitive FED. They may have to jack rates up quick, and that may crush the markets even more than what we are witnessing now.

When the market reacts violently in response to an interest rate hike, those having no protection strategies will likely see their balances move and possibly by a lot.

Already the market has been almost relentlessly hammered with no end in sight at the time of this writing. Should inflation accelerate from here, the market may decline at an even faster pace in anticipation of an even more aggressive FED to address it.

### Nielsen and Borgeas Introduce Bill to Fund Critical Water Infrastructure Projects

As a result, farms, cities and rural communities that rely on the canal are losing up to 300,000 acre-feet of water per year in deliveries. Similarly, the diversion capacity of the Delta-Mendota Canal has decreased from 4,600 cubic feet per second to 3,211 cubic feet per second at the terminus.

Rosenberg will present on crop rotation economics and on the web-based cost calculator developed for rice growers to explore the costs and benefits of switching over to selected rotation crops. SB 890 advances the goals of Proposition 1 (2014) by making significant investments in California's aboveground water storage and conveyance infrastructure. Specifically, SB 890 will establish the Water Storage and Conveyance Fund that will provide:

\$2.6 billion to complete the funding of Sites Reservoir in Colusa County; and \$685 million to repair the Friant-Kern/Delta-Mendota Canals and the San Luis Field/San Joaquin Divisions of the California Aqueduct.

"California's water storage and conveyance challenges transcend partisan divides and have been exacerbated due to the recent drought," said Senator Borgeas, who chairs the Senate Agriculture Committee. "Clean, reliable water in California is not only critical to our country's economy and food supply, but also our national security. Without proper storage and conveyance investments, California cannot continue to lead the nation in food production."

Completion of Sites Reservoir would ensure an additional 1.5 million acre-feet of

fund these critical water infrastructure projects using taxpayer revenue that has already been collected. This is because under state law, infrastructure projects may be financed using revenue from the General Fund when it exceeds the State Appropriations Limit, or Gann limit.

The need for reliable and dependable water storage infrastructure and conveyance is vital. The completion of Sites Reservoir and repairs on the Central Valley canals would go a long way toward preserving public health, protecting the environment and maintaining economic viability.

### **CTC Allocates \$589 Million for Transportation Improvements**

**SACRAMENTO, CA (MPG)** - The California Transportation Commission (CTC) allocated \$589 million for projects to repair and improve transportation infrastructure throughout the state. Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017, accounts for \$302 million – more than half of the funding.

"This investment follows our 'fix-it-first' commitment to repair California's aging infrastructure, while at the same time increasing transit and active transportation options," said Caltrans Director Toks Omishakin. "These projects will make our transportation system safer and more convenient for all users and create thousands of good-paying jobs in the process."

Among those projects approved was one on State Highway 32 in Chico from Muir Avenue to Highway 99 that will rehabilitate pavement, install signals and lighting, upgrade Transportation Management System (TMS) elements, rehabilitate drainage systems, and upgrade facilities to Americans with Disabilities Act (ADA) standards. The project was allocated \$3.51 million.

Caltrans also presented the CTC with the draft 2022 State Highway Operation and Protection Program (SHOPP) at our meeting. Aimed at preserving the condition of the highway system, the draft 2022 SHOPP accounts for \$17.3 billion in funding over a four-year period and includes projects for safety, restoration, road and bridge preservation, and other highway-related facilities.

The CTC will host a public hearing in February to receive comments on the draft SHOPP. All the comments will be considered in the final version that goes before the CTC for adoption at its March meeting. All 2022 SHOPP projects are available on the Caltrans' Ten-Year Project Book website, ProjectBook. dot.ca.gov

SB 1 provides \$5 billion in transportation funding annually split between the state and local agencies. Road projects progress through construction phases more quickly based on the availability of SB 1 funds, including projects that are partially funded by SB 1.

## **Rewarding Failure in The K-12 System**

California spends a lot on education. Ever since the passage of Proposition 98 in 1988, which guarantees to education a minimum of 40% of the general fund, per-pupil spending on K-12 has risen faster than any other category of state appropriations. And yet, for all that new money, the state's education monopoly continues its history of failure to deliver a quality product.

Just last month, this column cited the federal government's National Center for Education Statistics, showing that in 2017-2018, the most recent year for which statistics are available, per-pupil spending for the state's K-12 public schools was \$13,129 in inflation-adjusted 2019-20 dollars, the highest ever. Measured in the same constant dollars, per-pupil spending was \$9,594 in 1999-2000.

California is quickly rising in the ranks in spending according to multiple metrics and we are now at least 17th highest in the United States. And many of these statistics are pre-pandemic, before the state plowed even more money into the system.

Where it excels in spending money, California lags in educational outcomes due to a clear hostility to meaningful education reforms. For decades, reformers have unsuccessfully advocated for more school choice, merit pay for teachers, advancement based on merit rather than seniority and the ability to fire bad teachers including some credibly accused of crimes against children.

The "reforms" coming out of the union-dominated Legislature will only make matters worse. The latest iteration of this is Senate Bill 830 by Sen. Anthony Portantino, D-La Cañada Flintridge, that would change the way schools are funded. Under current law, schools get financial support based on a formula that includes average daily attendance. This bill would eliminate daily attendance from the formula, and with it the financial incentive for school personnel to attempt to get students in the building.

This, mind you, comes after the state already froze funding to pre-pandemic levels to paper over historic declines in enrollment across the state these last two years.

But according to supporters of SB 830, the current system is unfair because it punishes low-income districts that have higher rates of absenteeism and truancy. It would seem to a rational person that, if a school is having a problem with absenteeism and truancy, it would be better to address those problems directly as opposed to hiding the problems and rewarding those schools with more money for fewer students.

As evidenced by the teachers' unions' hesitancy to return to the classroom, especially in the Los Angeles Unified School District, it is not a good idea to give teachers' unions a financial incentive to reduce their workload by rewarding districts with high truancy rates.

# **\$5 Billion Introduced for UC and CSU Housing**

#### Office of Assemblymember Kevin McCarty

**SACRAMENTO, CA (MPG)**- Assemblymembers Kevin McCarty (D-Sacramento), Sabrina Cervantes (D-Corona), Jose Medina (D-Riverside) and Phil Ting (D-San Francisco) introduced the Student Housing Revolving Loan Fund Act to expand affordable housing options for California college students. This \$5 billion self-sustaining fund will provide zero-interest loans for the University of California (UC) and California State University (CSU) to construct approximately 25,000 student housing beds at below market rents.

Nearly half of all students enrolled at the CSU, and 40% of students at the UC are low-income and struggle to afford the rising costs of attending college. Housing insecurity negatively impacts students' ability to attend and perform well in classes, and it's linked with a higher risk of withdrawing or refraining from registering for classes.

"We have a college affordability crisis and a housing affordability crisis in California. This bill addresses both of these important issues. We'll help existing students thrive by addressing basic housing needs" said Assemblymember Kevin McCarty. "And we'll be able to significantly grow UC and CSU enrollment by proving new student housing beds.

one more month of bare root season to go. If you are wanting to plant bare root fruit trees there is still time and selections are still good. Bare Root Season is January and February.

Now for the other things that we need to do in February. One of the most necessary things to be done is the third and final dormant spraying in mid-February with a copper based fungicide. It is important to keep ahead of the fungal pests that might occur on fruits and nuts, as well as some vegetables and ornamentals. Rose are very susceptible to black spot, powdery mildew, and rust. Copper spray is well known for its use for curly leaf on peaches and nectarines. Once a fungal disease is started it is difficult to control because the spores produced are easily blown to neighboring plants that might become infected. Because of its variable uses, it is a good product to have on your shelf for gardening needs. You should mix it with horticultural oil or Neem Oil, to help the spray spread evenly and cling to the foliage. Neem Oil has many other good uses. It is an excellent insecticide as well as controlling some fungi, to a lesser extent than the copper spray.

February usually brings hints of spring with it. Buds for the spring blooms begin to form. Wait to fertilize until the plants have their full set of leaves. The plants won't utilize fertilizer when they are bare of leaves. If they leaf out soon following the application of fertilizer, they will utilize any fertilizer that hasn't been washed away by rain or irrigation, but the usefulness of some has been lost. So- not too soon, but get on it when the signs of life show and give them a boost into spring. Use an appropriate fertilizer for the plants being fertilizes. There is a basic all purpose fertilizer that can be used on most things. It is often referred to as a "balanced" fertilizer since it has

With February upon us, we still have almost equal amounts of the three basic elements that are in moist formulas. Those three elements are N, P and K, or Nitrogen, Phosphorous and Potassium. They will frequently be seen on the front of fertilizer packages. Acid fertilizer is used on azaleas, camellias, rhododendron and gardenias, plus other things that do well in similar conditions. Other elements will have been added to the basic three to create the desired acidity. Citrus trees have a special fertilizer with nutrients needed by that species. There is an abundance of formulas available to meet the needs of differing plants, there is also an abundance of plants that do well on the basic fertilizers.

> As the weather gets warmer, be on the lookout for slugs and snails. Irregular holes in leaves are a clue that they are out and about. They also leave a slightly shiny trail behind. Use snail bait to destroy them. I have had very good luck with Sluggo - it is granular and is sprinkled in the infested areas. It is safe around pets and wildlife. I never saw the snails, just their empty shells. Snails also like beer and will be attracted to a bowl of beer cradled in a depression in the ground and will drown when they fall into it. Of course, it has to be emptied and wastes a bit of beer. Aphids are also one of the early pests that you will encounter. They produce a sweet and sticky substance that is left on the leaves. Ants are attracted to that and will farm the aphids and that compounds the problem, so look for ants at the base of a plant infested with aphids and bait for or spray them. Spring is on the way enjoy it.

## **PG&E Offering to Remove Debris from Trees Cut Down During 2021 Wildfires**

#### PG&E Press Release

SAN FRANCISCO, CA (MPG) - In response to customer and community feedback, Pacific Gas and Electric Company (PG&E) is offering customers free removal of large-diameter wood from trees that were cut down for safety during the company's 2021 wildfire response.

As PG&E worked to restore power quickly and safely during the 2021 wildfire season, crews inspected and cut down hazardous trees that posed a potential safety risk to crews and electric equipment. The work was done in coordination with agencies responding to the wildfires.

With this work now largely complete, PG&E is offering landowners the opportunity to have trees that were cut down for safety removed from their property, provided it is safe to do so.

Because the wood is the landowner's property, removal of the wood is optional, and landowners must provide written permission to PG&E to have the wood removed. PG&E is in the process

of reaching out to impacted landowners to offer the removal services and provide permission forms.

Earlier this year, PG&E and contractor crews began removing and disposing of large-diameter wood from 2020 wildfires. PG&E recently expanded the voluntary program to encompass 2021 wildfires.

If approved by the landowner, PG&E will be removing wood debris from trees cut down for safety in response to the following wildfires: Anderson Fire, Cache Fire, Caldor Fire, Dixie Fire, Fawn Fire, Hopkins Fire, KNP Complex Fire, Linda Falls Fire, McFarland Fire, Monument Fire, North Complex Fire, River Fire (Colfax, Oakhurst), Salt Fire, Washington Fire

### **NRA Wins Case Against Los Angeles County**

#### NRA Release

FAIRFAX, VA (MPG) - The Ninth Circuit sided with the National Rifle Association Institute for Legislative Action (NRA-ILA) on Thursday, January 20th, 2022 when it struck down a Los Angeles County order that forced gun stores and shooting ranges to close in 2020 during the COVID-19 pandemic. NRA-ILA originally challenged this order in March of 2020, and filed an appeal a year later.

"The court today rightfully recognized that Los Angeles County violated Second Amendment rights when it shut down gun stores and ranges in the beginning of the COVID-19 pandemic," said Michael Jean, NRA's director of the Office of Litigation Counsel. "This is an important decision. It ensures that California-or any state-cannot use a crisis to trample on the Constitutional rights of citizens."

The decision highlights that these orders, which prevented the exercise of basic constitutional rights like acquiring and practicing with firearms, could have been "perpetually extended if the County so decided."

Given the current state of the world and the periodic resurgence of COVID-19 continuing to affect daily life, this decision ensures that states cannot restrict the fundamental rights of Americans for any reason. In this spirit, the decision

concludes by citing Justice Gorsuch's words: "Even in times of crisis - perhaps especially in times of crisis - we have a duty to hold governments to the Constitution."

NRA-ILA also challenged overbearing COVID-19 restrictions in New Mexico and New York. In addition to Los Angeles County, NRA-ILA challenged four additional counties in northern California.

The case is captioned Martinez v. Villanueva. NRA-ILA was joined by local gun stores and ranges, the California Gun Rights Foundation, the Firearms Policy Coalition, and the Second Amendment Foundation in this lawsuit.

- Student enrollment in public schools has nosedived as parent disgust with school COVID-19 policies, student learning losses, and controversial education policies has gone through the roof. In the wake of this enrollment implosion, homeschooling has boomed across the country.

At the beginning of the current school year, the U.S. Department of Education estimated that 1.5 million students had left the public schools since the COVID-19 pandemic began.

If students are not enrolling in public schools, where are they going? The numbers show that many former public school students are now being homeschooled.

The U.S. Census Bureau found that the percentage of homeschooling households more than doubled in 2020 from 5 percent in spring to 11 percent in the fall.

According to a recent University of Michigan study, from 2020 to 2021, the enrollment at public schools in Michigan fell by nearly 46,000 students, which represented a more than a 3-percent drop. Among kindergartners, there was a decrease of more than 11 percent.

The increase in home-

of the American population. A University of Washington Bothell analysis found, "The diversity of homeschoolers in the U.S. mirrors the diversity of all students nationally." including all racial, religious, political, and income groups.

For instance, the Census Bureau found that among African American households the increase in homeschooling was much steeper than in the country as a whole, rising from 3 percent to 16 percent, a five-fold jump.

This increase in African American homeschooling is not surprising given recent research by McKinsey & Company that found "Students in majority Black schools ended the [2020-21 school] year with six months of unfinished learning."

Demetria Zinga, one of the country's top African American homeschool YouTubers, says, "I believe homeschooling is growing and exploding amongst African Americans and there will be more and more homeschoolers."

Homeschool mom Magda Gomez, an immigrant from Mexico, has become an activist for homeschooling in the Hispanic community.

ourselves in different areas of education, especially since we are not in our [native] country but are immigrants."

"It is my dream," she says, "to see more Hispanic families doing homeschool." Her dream is coming true with homeschooling doubling among Hispanic households, from 6 percent to 12 percent.

In addition to the racial diversity of homeschoolers, in 2021 the school-choice organization EdChoice found: "Many parents of children with autism, ADHD, and other neuro-developmental disorders report that public schools cannot effectively address their child's specialized learning needs."

Pediatric nurse and homeschool mom Jackie Nunes unenrolled her special-needs daughter from public school saying, "There just wasn't enough of the things that matter - time, attention, patience, persistence, passion, support."

The COVID-19 pandemic has exposed all the flaws in the one-size-fits-all public schools, which is why the homeschool boom is shaking up American education.


