

## Canceling Surgeries

Throughout California, as COVID-19 infections deplete their staff of nurses, anesthesiologists and other essential workers, hospitals are canceling or postponing so-called "elective" surgeries to repair injured knees and aching back, remove kidney or bladder stones, and repair cataracts or her-

nias, among other procedures.

Alarmed by a growing shortage of specialized health care workers, the California Department of Public Health is evaluating whether to issue an order to hospitals statewide to suspend elective surgeries in cases in which patients wouldn't

be immediately harmed.

For now, the decision is volun-

canceled, for example, but not heart surgery or a breast cancer biopsy.

In response to the shortages, the state health department on Saturday issued controversial new guidance to hospitals and skilled nursing facilities. Workers who are infected with COVID-19 but have no symptoms may immediately return to work without isolation or additional testing. Exposed health care workers may also work. The new guidelines remain in effect until

Health workers immediately attacked the new policy.

In the Sacramento region, at least 11 elective procedures at Mercy Hospital of Folsom had to be postponed last week because of staffing shortages, said Dr. Brian Evans, CEO of the Folsom facil-

workforce out sick, spokeswoman Julie Greicius said Saturday. "We have seen a doubling of nurses calling off per shift, reporting that they are ill," Greicius said.

California ranks fifth in the nation in the percentage of hospitals reporting severe labor shortages.

A year ago, during the last surge, the state health officer directed hospitals for about one month to cancel certain procedures if their intensive care capacity was less than 10%.

Since then, the highly contagious omicron variant has transformed California's COVID-19 landscape and hospitals' decision-making. Omicron appears to cause less severe disease, but it's more likely to infect vaccinated people than the original novel coronavirus and the delta variant. As a result, even though about 71% of eligible Californians are vaccinated and 38% of them are boosted, more people – including health care workers – are becoming infected,

many with mild or no symptoms.

"This is not about beds, this is about the staff to care for the patients in those beds," said Kiyomi Burchill, group vice president of policy for the California Hospital Association.

Exacerbating the problem: labor strife and an exodus of nurses and other hospital staffers who have quit or retired, citing burnout and lack of protections on the job.

Fanelli told county health officers last week that the state is working on other measures to support hospitals as they cope with yet another surge. The state health department predicts as many as 53,000 hospitalizations a day in the coming weeks.

In response, the state plans to send up to 1,500 health care workers to hospitals with staffing shortages and has stockpiled oxygen, saline and other supplies ahead of the surge. Officials also are working with hospitals to help them adapt spaces to triage patients and more quickly find placements for patients ready to be discharged, she said.

# Council Suggests Habitat for Humanity Clarify Proposals

City of Yuba City

YUBA CITY, CA (MPG) - The City of Yuba City announced they will not be moving forward at this time with a request by Habitat for Humanity to seek state funding to purchase and convert the Bonanza Inn into permanent affordable housing.

"We are extremely supportive of what Habitat for Humanity does for our community, but at this time there are too many unknowns for us to proceed," said Yuba City Mayor, Dave Shaw. "It is not clear what the long-term revenue commitments from the City would be, or what the long-term impacts on the community would be given this property's location."

In 2020, through the passing of Assembly Bill 140, the California Department of Housing Community Development created a homeless housing initiative, termed Homekey. State funds were made available to purchase and rehabilitate buildings – including hotels, motels, vacant apartment buildings, and other properties – and convert them to permanent, longterm, affordable housing units. Projects using the funds must remain affordable permanent housing for at least 55 years. In September 2021, an additional \$1.4 billion was added to the program; of which approximately \$40 million is anticipated to be available for funding projects in our region.

Habitat for Humanity recently coordinated two Homekey funded projects with local jurisdictions: a \$6.3 million project converting the 62-room Travel Inn & Suites in Yuba County, near the Walmart in Linda; and a \$6.7 million project in Sutter County (with an additional \$520,000 in local COVID relief funds from Sutter County) to convert the 62-room Baymont Motel along Highway 99. Both locations had been fraught with criminal activity and required a significant amount of law enforcement intervention.

Unlike typical development projects, projects using Homekey funds are expedited through the permitting process, automatically granted any jurisdictional permit and zoning changes necessary to complete the project, do not require Comprehensive Plan Land Use Map amendments or Site & Design review, and are exempt from CEQA review.

tary for hospitals. But the state health department's chief deputy director, Susan Fanelli, on Thursday told a meeting of county health officers, "We know (a directive on elective surgeries) has to be on the table." Officials with the public health department did not respond to CalMatters' requests for more information.

"Elective" means a surgery is not an emergency and can be scheduled in advance; it does not mean it's optional. Waiting in some cases can be life-threatening.

Hospitals are carefully weighing which surgeries can be delayed, executives say. A cataract surgery or knee replacement might be

ity and Mercy General Hospital in Sacramento. Evans could not provide details about the types of procedures that will be canceled.

The two hospitals, both owned by Dignity Health, had about 54 patients admitted specifically for COVID-19 on Friday, but "we're seeing many of our workers and health providers getting sick as well. We expect next week to be worse," Evans said.

More than twice as many California hospitals reported critical staffing shortages last week than last summer – although not as many as a year ago.

## \$14,000 Tuition Credit per Student for School Choice

The November 2022 election may offer a number of measures to improve the educational opportunity for students. The election will pit unions against parents and students. The California Teachers Association (CTA) alone will use its 331,000 members' dues to crush any move to add competition to government schools.

The last school choice campaign in 2000 failed. The CTA spent tens of millions to protect its communist schools control. People remaining in California to fight might review the Education Freedom Act (EFA) of 2022 (see www.californiaschoolchoice.org). The EFA, if approved by voters, would bring true school choice to all K-12 students in the state who choose to opt-into the proposed program. The initiative is designed to see state education funding follow the student.

Mike Alexander, chair of Californians for School Choice says, "Parents wanting to leave the disastrous public school system would receive a yearly tuition credit of \$14,000 per child to attend a private or religious school of their choice and save any money left over for college, vocational training or other qualified expense."

The Education Freedom Act has four key components: 1) An Education Savings Account ("ESA") will be established for each K-12 child in California on request. The Act treats all K-12 California students equally; 2) Each year, that account will be credited with the student's share of what are known as Prop 98 funds. That share will rise to over \$14,000 per year. The Act is designed to be tax neutral and does not impose any changes to

public education.

All programs under Prop. 98 will continue as before. Students who leave public school will have their fair share of Prop. 98 funds only, which will follow them to the accredited private school of their choice: 3) Parents can direct those funds to a participating public, charter, or accredited private or religious school. Private schools must be accredited and conform with local health and safety standards. There will be no curriculum or hiring requirements. There are no caps on the savings account; 4) Any unspent funds will accumulate and can be spent on college, vocational training or other qualified educational expense. Funds not spent by the time a student reaches age 30 will be returned to the treasury.


The EFA is designed to encourage free market competition. "This will cause schools, both public and private, to improve performance and lower costs to get their fair share of education dollars. By empowering parents to take advantage of how schools will have to compete for funding will lead to improved customer service at all schools, both public and private," Alexander

The initiative will require 1 million valid signatures to qualify and it would amend the State Constitution. Californians for School Choice have about 120 days left to obtain signatures.

NEVADA CITY, CA (MPG) - When Nevada City Winery opened in 1980, it was the first winery to operate in Nevada County since prohibition. Since then, they have made over 600 wines and served thousands of customers, locals, and tourists alike. This small, local winery is located in the Sierra Foothills of Northern California, nestled between the same brick buildings and Victorian houses built by hopeful gold miners in the rush of 1849.

In the 41 years since opening, the winery has had but two Winemakers, the latter being employed for the last 29 years. ### **Violence is Broadly Felt by Millions**

**SACRAMENTO, CA (MPG)** - Research led by UC Davis Professor Garen Wintemute shows that violence indirectly impacts most Californians.

Though relatively few may experience or witness a violent act, a large majority of surveyed Californians reported having an "experience of violence" (EV). These included hearing gunshots in their neighborhood, encountering a sidewalk memorial to a violent death or learning about a violent event through their social network.

The research was published in the journal Injury Epidemiology.

"If we ask broadly about the experience of violence, rather than focusing on acute events, we find that two-thirds of Californians have a direct personal stake," said Wintemute, who directs the UC Davis Health Violence Prevention Research Program and is an emergency department physician. "Our main conclusion is that almost everybody is touched by this, and we're a state with relatively low rates of firearm violence. I would expect the situation would be worse in many other states."

While most violence research focuses on personal victimization, the UC Davis Health team took a broader view to better understand how these acts become embedded in communities. The survey indicates experiences of violence are perilously widespread:

An estimated 3.4 million Californians may have three or more EVs; 5 million personally know multiple people who have been intentionally shot; 3 million know people who may be at risk of committing violence against themselves or others.

"We had people who responded that they passed sidewalk memorials 25 times or more a week," said Wintemute. "And I thought, at what point does living in your neighborhood resemble living in a cemetery? What does that do to your sense of a future for your community and yourself?"

In addition to hearing gunshots or seeing memorials, survey EVs included being aware

of someone who had been intentionally shot by someone else, intentionally shot themselves or might commit a violent act (against another person or themself).

Of the 2,870 respondents, 64.6% reported one or more EVs; 11% reported three or more. Women and men had similar experiences. Perhaps most surprising, people who did not own a firearm, but lived with someone who did, had more EVs through their social networks, compared to those who owned firearms and those who did not. Secondhand gun ownership may be a public health risk, much like secondhand smoke.

The UC Davis Davis team believes this survey will provide more information on how violence can permeate communities and hopes these findings might inform public policy and education.

"If people who live in homes with guns, but don't own guns themselves, have these many experiences of people at risk of violence, they could be a whole new resource for intervention," Wintemute said. "Maybe we can work with them to help at-risk people and reduce suicides and possibly other firearm violence."

In California, a legal mechanism known as a Gun Violence Restraining Order can temporarily remove firearms and ammunition from people at risk of harming themselves or others.

The group is now working on a follow-up study to measure how these experiences may impact mental and physical health.

"If we show they are associated with ill effects, we may be able to intervene," said Wintemute. "There are few people in California who can say this does not affect them, and since we're all involved, let's work together on solutions."

Other authors included: Amanda J. Aubel, Rocco Pallin, Julia P. Schleimer and Nicole Kravitz-Wirtz of the Violence Prevention Research Program.

This work was funded by the California Firearm Violence Research Center, the California Wellness Foundation and the Heising-Simons Foundation.

## Sequoia National Forest Most Popular for RVs in 2020

**SAN DIEGO, CA (MPG)** - The COVID-19 pandemic has been challenging for the travel and tourism industry as a whole. Through much of 2020, shutdowns and public health restrictions to limit the spread of the virus led many travelers to cancel or postpone trips. Relaxations on these restrictions, the release of vaccines, and declining cases early in 2021 brought back many travelers, but the emergence of the Delta variant last summer and Omicron this winter again scrambled travelers' plans.

Despite the general difficulties of the travel industry over the last two years, one segment that has fared well throughout the pandemic is outdoor recreation like camping and RVing. Because these activities take place outside and social distancing is easier, the risks of COVID exposure are low, which makes them an appealing alternative to airports, hotels, restaurants, and other locations where risk can be higher. The Outdoor Industry Association estimated that 7.1 million more Americans participated in outdoor recreation in 2020 than in the year prior.

New interest in outdoor recreation has forced related businesses to quickly scale up to meet demand. One example comes from the RV market. In February 2020 just before the pandemic began the RV industry shipped a total of 37,113 units, according to data from the RV Industry Association. That number dropped to just 7,197 amid COVID shutdowns in April 2020, but ever since, demand for RVs has exploded. In October 2021, monthly RV shipments totaled 57,971, an increase of 56% from immediately before the pandemic.

the pandemic.
Unlike the segments of the travel industry that have faced low demand, outdoor destinations like those popular with RV drivers

are seeing more visitors than ever. Many

national parks saw record visitation in the summer of 2021, introducing new systems to manage overcrowding and in some cases turning away visitors. But COVID accelerated a trend of increased visitation to public lands that has been taking place for several years. A recent report from the Center for Western Priorities found a 39% increase in the occupancy of reservable campsites on public lands during peak seasons between 2014 and 2020.

States in the western U.S. are seeing the boom and its effects most directly. States like Wyoming, Montana, and Idaho are home to some of the U.S.'s most famous national parks and forests. These features make those states top destinations for camping, RVing, and other forms of outdoor recreation, with visitors and residents alike seeking to take advantage of the states' natural attractions.

While western states experience some of the highest levels of visitation, the effects of stronger interest in camping and RVing can be felt in every state with public lands. For example, some of the top national forest destinations for RV travelers are found in locations like Florida, Minnesota, and North Carolina in addition to western states like California and Colorado.

The data used in this analysis is from Recreation.gov. To identify the most popular national forests for RV campers, researchers at Outdoorsy calculated the total number of RV nights booked in 2020. In the event of a tie, the national forest with the greater number of total RV reservations in 2020 was ranked higher. It's important to note that these statistics only reflect reservations made on campgrounds managed by federal agencies, such as the National Forest Service.

The 130-room Bonanza Inn is located at 1001 Clark Avenue in Yuba City. The current owner purchased the property in 2017 with an assessed amount of \$5.14 million. Habitat for Humanity was requesting the City of Yuba City apply for \$25-million in Homekey funds, of which \$13.25 million would be used to purchase the property and \$4 million for renovations The Bonanza Inn is flanked to the north and east by housing, and the west and south by commercial businesses.

A workshop was held during the December 21, 2021 Yuba City City Council meeting to review the project proposal. During the meeting several citizens spoke in support of Habitat for Humanity; several residents spoke in opposition

Yuba City Police Chief, Brian Baker, noted very little police intervention is needed at the Bonanza Inn, with the few incidents mainly focused on removing non-paying guests. Councilmembers requested that Habitat for Humanity provide further clarification on the project's business plan, financing and longterm implications.

"The City would be committing to a 55-year project. Setting aside the uncertainty of the financial viability of the project to be self-sustaining for 55 years, the City would also lose about \$250,000 a year in existing Transient Occupancy Tax and property tax that the business currently generates," said Shaw. "That's approximately \$14 million in potential lost tax revenue alone. While our

of the project location; and heart strings are definitely pulled, we can't ignore that we will be losing significant revenue. We must be absolutely clear on what the additional costs and obligations to taxpayers might be before moving forward with any Homekey project."

Yuba City staff has recommended Habitat for Humanity seek out other potential Homekey project locations in Yuba City that may be interested in selling, and to present a thorough business plan that would outline long-term funding, operation and viability of the project.

"The City Council recognizes the need to create additional affordable housing in Yuba City, and encourage staff to work with Habitat for Humanity as well as other housing partners to develop viable projects," said Shaw.

## Foggy Head-on Fatal Vehicle Collision

YUBA COUNTY, CA (MPG) - A 60-year-old male was driving a Dodge 3500 at a stated speed of 55 MPH southbound within the #1 northbound lane of SR-99, just south of Nicholas Avenue. A 24-yearold male was driving a Honda Accord at an unknown speed northbound within the #1 northbound lane of SR-99 south of the Dodge 3500. Neither party was able to make evasive maneuvers before both vehicles collided head on within the #1 northbound lane of SR-99. It is still under investigation as to whether drugs or alcohol were a factor in this collision. It was very foggy at the time of the collision with approximately 75 feet of visibility. Both directions of SR-99 were closed for approximately four hours for collision investigation.

## Two Vehicle Collision, One Fatality

YUBA-SUTTER REGION, CA (MPG) - A silver late model Toyota Corolla was travelling east on SR-20 and was descending the Sutter Bypass Bridge, aka "The long bridge" in dense fog. The driver of a red GMC Sierra was driving west on SR-20 approaching the Sutter Bypass Bridge at 55 MPH. The driver of the Toyota lost control of her vehicle and the vehicle began to enter a counter-clockwise spin. The driver

of the GMC Sierra saw the Toyota entering his lane and steered his GMC to the left. The front of the GMC collided into the passenger side of Toyota, causing major damage to the Toyota. SR-20 was closed for approximately 90 minutes for the collision investigation and the cleanup of the scene.

It is unknown if alcohol of drugs were a factor in the collision.

## **Initiative Eliminates Ability to File Lawsuits for Monetary Penalties**

Office of Secretary of State Dr. Shirley N. Weber

SACRAMENTO, CA (MPG) - Secretary of State Dr. Shirley N. Weber announced that the proponent of a new initiative was cleared to begin collecting petition signatures

on December 8, 2021. The Attorney General prepares the legal title and summary that is required to appear on initiative petitions. When the official language is complete, the Attorney General forwards it to the proponent and to the Secretary of State, and the initiative may be circulated for signatures. The Secretary of State then provides a calendar of deadlines to the proponent and to county elections officials. The Attorney General's official title and summary for the measure is as follows:

Eliminates employees' ability to file lawsuits for monetary penalties for state labor-law violations. Initiative

law allowing employees to file lawsuits on behalf of themselves and other employees against employers to recover monetary penalties for certain state laborlaw violations. Labor Commissioner retains authority to enforce labor laws and impose penalties. Eliminates Labor Commissioner's authority to contract with private organizations or attorneys to assist with enforcement. Requires Legislature to provide funding of unspecified amount for Labor Commissioner enforcement. Requires Labor Commissioner to provide pre-enforcement advice; allows employers to correct identified labor-law violations without penalties. Authorizes increased penalties for willful violations. Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local governments:

statute. Repeals 2004 Likely increase in state costs to enforce labor laws that could exceed \$100 million per year. Reduction in state penalty revenue used for labor law enforcement in the tens of millions of dollars annually. (21-0027.)

> The Secretary of State's tracking number for this measure is 1921 and the Attorney General's tracking number is 21-0027.

> The proponent of the measure, Brian Maas c/o Christy Wilson, must collect signatures of 623,212 registered voters (five percent of the total votes cast for governor in the November 2018 general election) in order for the measure to become eligible for the ballot. The proponent has 180 days to circulate petitions for the measure, meaning the signatures must be submitted to county elections officials no later than June 6, 2022. ## NRA Files Suit to Defend Gun **Owners' Privacy in California**

FAIRFAX, VA (MPG) - The National Rifle Association Institute for Legislative Action (NRA-ILA) filed a lawsuit against California on Wednesday challenging a law that allows the state to disclose sensitive personal information about law-abiding gun owners to universities and any "bona fide research institute."

"California must be held accountable for its near-constant, unconstitutional assaults on law-abiding gun owners and the Second Amendment," said Jason Ouimet, executive director, NRA-ILA. "This law strips privacy rights from anyone who has ever purchased a firearm, transferred a firearm, purchased ammunition, or obtained a concealed-carry license. This is an outright violation of our rights and must be reversed."

The bill, Assembly Bill 173, allows for the disclosure of highly sensitive information, including a gun owner's name, address, place of birth, phone number, occupation, driver's license or ID number, race, sex, height, weight,

hair color, eye color, and even their social security number and types of firearms that they own. This information was gathered from law-abiding gun owners with the understanding that it would only be used for legitimate law enforcement purposes.

"This information is a person's identity. And it's being handed over to organizations that have no duty to safeguard it. This will do nothing to prevent crime — it will only serve to put law-abiding gun owners at risk," Ouimet said. "Gun owners are entitled to the same privacy rights as all law-abiding citizens. They should not be 'doxxed' for exercising their rights."

This is only one of the cases that NRA-ILA has filed in recent years to curtail California's efforts to burden the Second Amendment. NRA-ILA is also challenging California's draconian restrictions on ammunition purchases and transfers, magazine bans, and the closure of gun shops and ranges. NRA-ILA will continue opposing California as long as it continues to infringe upon the Second Amendment.

#### Agriculture Secretary says Port Congestion is Easing, but Challenges Persist

U.S. Agriculture Secretary Tom Vilsack says American ports are making progress in clearing logiams that have delayed exports of billions of dollars of farm commodities. However, in a speech to the American Farm Bureau Federation, Vilsack said too many empty shipping containers are still being rushed back to the Far East "without having agricultural products in them." The port crunch has sharply impacted exports of California tree nuts and wine.

#### Intensity of Early-Season Rains Impacts **Pomegranate Growers**

Those heavy early-season rains, welcomed by many California farmers, are challenging for pomegranate growers. If the fruit takes in too much water too quickly, it can split. And pomegranate growers say they are seeing some negative impacts from too much rain too soon. Most of the crop was harvested before heavy rains in October. But some growers estimated that the 2021 harvest was off by 15% or more from the previous year. Overall, California is expected to produce 300 million pounds of pomegranates.

#### Mild Winter Cold plus Fog is a Healthy Recipe for Fruit and Nut Trees

Fruit and nut trees in the Central Valley are chilling out, and that is exactly what farmers want to see. Chill hours, when temperatures are between 32 and 45 degrees, help keep trees dormant. Sufficient winter chill hours promote healthy spring growth and summer and fall yields. Warming can result in late or uneven blooms and lower yields. Hard freezes can cause damage. So far, University of California agriculture officials say mildly cold and foggy conditions have been the perfect recipe.

#### UC Davis Study Identifies Bird Species that May Threaten Crops

Some species of birds that forage on feed grounds near cattle are more likely to spread unwanted bacteria to crops such as lettuce, spinach or broccoli, according to a University of California, Davis study. But researchers, writing in the journal Ecological Applications, concluded that numerous birds found near farms are less likely to carry pathogens with food safety risks. Birds considered safer include many useful, insect-eating species. One bird that risks spreading contaminants is the invasive European starling.

## **Animal Cruelty Found**

Press Release

**OLIVEHURST, CA (MPG)** - On the afternoon of 1/13/2022, Yuba County Animal Care Services (ACS), aided by Yuba County Sheriff Deputies, Code Enforcement Officers, and Sheriff's Posse Volunteers, served a search warrant at a residence in the 1600 block of 2nd Avenue in Olivehurst and discovered dozens of animals living in deplorable conditions in and around the home. 61animals were seized and taken into safekeeping for care and treatment. Found living inside the uninhabitable residence were species ranging from livestock and poultry to domestic animals. The home was observed strewn with garbage and feces, with many animals in small crates and malnourished conditions. One dead horse was also located and removed. There was no sus-

pect present at the time of the search. The investigation began on 12/28/21 after ACS responded to animal welfare concerns from neighbors and a report of a dead horse at the property. ACS officers observed several animals in plain sight at the 2nd Avenue residence that appeared in poor condition, prompting the escalation of the investigation that led to yesterday's search warrant and subsequent rescue.

Yuba County Sheriff Wendell Anderson shared his appreciation for the efforts led by his Animal Care Services team, stating, "This case was a prime example of stellar teamwork by all involved. We had members from Code Enforcement, Animal Care Services, and our Operations divisions involved from the beginning. The Sheriff's Posse was instrumental as well, and had it not been for everyone's involvement and coordination the operation would not have been possible. Men and Women from the posse rallied and brought their personally owned trailers and vehicles out to assist with the

**Yuba County Sheriff's Department** recovery. The willingness of the various members of our department to work together made this possible. The continued care and treatment of the animals that were saved will require additional cooperation as Animal Care Services and members of the Posse will be tasked with the housing and upkeep of these animals. It was truly remarkable to see the work of these men and women who rescued these animals. The condition of the animals and the setting in which they were found was deplorable. Staff never complained, and simply trudged forward in a flooded field and into a house full of debris, litter, and feces, for the benefit of these animals. I would like to thank all involved in the investigation, the operation, and the continued care of these neglected animals."

> All of the animals were transported to two different county facilities and immediately seen by a veterinarian. They will remain in Yuba County care during the course of the criminal investigation and will not be available for adoption until the criminal case has been adjudicated. The Non-Profit Yuba County Animal Care Services Volunteers "ACS STARS" c/o the Yuba County Sheriff's Office can accept monetary donations toward feed and medical care of the seized animals. Product donations such as dog food, pig food, poultry food, and hay would also be greatly appreciated and can be coordinated by contacting the Yuba County Animal Care Services Office at 530-741-6478.

> The home has been deemed unsafe to occupy by Yuba County Code Enforcement and the criminal investigation remains active and ongoing. Investigators will be forwarding the case to the Yuba County District Attorney requesting an arrest warrant for felony animal cruelty. The identity of the alleged suspect is being withheld at this time, pending the outcome of the investigation and DA review. We will provide updates as they become available.

## **Newsom Bases Budget on Rosy Economic Scenario**

The early passages in a 400-page "summary" of Gov. Gavin Newsom's new budget describe the presumably wonderful ways he intends to spend nearly \$300 billion in the 2022-23 fiscal year.

They include what he clearly hopes will make a re-election year splash and become one of his legacies - extending state medical coverage to 100% of California's nearly 40 million residents by folding in undocumented immigrants ineligible for federally financed care.

During a nearly threehour news conference in which he showed off his prodigious memory of data, Newsom also touted new spending on five "existential threats" to California, including climate change, COVID-19, homelessness, the cost of living and crime.

New commitments are doable, he said, because of tens of billions of unanticipated tax dollars, largely from the state's highest-income taxpayers, who are seeing huge profits on stocks and other investments.

The back pages of the budget summary explain why Newsom believes that the overall economy, and particularly the personal finances of the wealthy, will continue to pump billions into the state treasury for at

least a few more years.

The rosy scenario begins with an assumption that the COVID-19 pandemic, despite the sharp surge by its omicron strain, will diminish.

"The public health situation is the linchpin of the economic forecast," the budget declares. "The forecast does not assume the emergence of a disruptive variant, which could lead to a delayed return to pre-pandemic labor force participation, persistent high inflation, and continued supply chain bottlenecks."

The budget "projects continued real GDP growth throughout the forecast period and recovery to pre-pandemic levels of nonfarm employment by the end of 2022," but adds, "Structural (non-pandemic) downside risks to the forecast remain, including the challenges of an aging population, declining migration flows, lower fertility rates, higher housing and living costs, increasing inequality, and stock market volatility."

That last caveat, "stock market volatility," is the real potential kicker. The top 1% of California taxpayers are providing at least 50% of the state's income tax revenues and their taxable incomes are largely tied to the stock market, which has surged recently, thanks largely to the Federal Reserve System's very low interest rates.

Were interest rates to be raised significantly to battle inflation, it would have an adverse effect on the stock market and, in turn, on California's income tax

base in a relative handful of high-income taxpayers and their taxable incomes being rooted in stocks and other investments subject to wide swings of value, any longterm revenue estimates are educated guesses at best.

It's called "volatility," a syndrome that has backfired on California's budget more than once.

"No one is naïve about the volatility of the tax system," Newsom said Monday, contending that careful spending and building reserves guard against the boom-and-bust conditions that have afflicted the state in past years.

His budget declares that "the state's budget resilience is stronger than ever: the result of building reserves, eliminating budgetary debt, reducing retirement liabilities, and focusing on one-time spending over ongoing investments to maintain structurally balanced budgets over the long term."

The budget's \$34.6 billion in projected reserves sound impressive, but a truly serious and prolonged recession, such as the one that struck 15 years ago, could quickly deplete them.

There's been an ongoing debate over whether revenue volatility should be tamed by reducing the state's dependence on taxing the rich or by building big reserves. Under Newsom's predecessor, Jerry Brown, the state opted for the "rainy day fund" approach but it has yet to face a serious challenge.

### The Market Seems to be Continuing its Bipolar Action

Into the third week contagious, investors don't of 2022 and the market seems to be continuing its bipolar action, with certain sectors rising one day and then falling the next. The so-called tech wreck that began late in 2021, although not a complete obliterating event, continues to hammer the fans of many technology stocks. Although the latest Covid Omnicron variant is infecting more people than ever, many of the once popular stay at home stocks continue to erode or at least not recover from their late 2021 sell off.

The last time a variant hit (Delta), the stocks that were selling off in hopes of a reopening economy caught a bid because of the fear that more shut downs might be enacted and cause people to once again stay home and use the stay at home technologies. Stocks like Pelaton and Zoom, which skyrocketed during the first part of 2020 when Covid first hit only to get creamed when it appeared vaccines might finally harness Covid once and for all, rose with the Delta variant news, yet did not react as positively when Omnicron arrived. Although Omnicron appears to be more

appear to be overly worried that it threatens the reopening trade and continue to hit the sell button on these stay at home technologies.

Either the investing public believes Omnicron isn't the threat to the economy Delta and the original Covid virus was, or they are just plain tired of succumbing to the handcuffing of the Covid event.

Investors trying to guess which sectors will rise or fall next are certainly not adding more stability to the indexes. In fact, the market direction seems as elusive as ever. Although some of the major indexes continue to reach towards new highs, the average investor may be scratching his head as to why their portfolios may not be acting as robustly.

Investors riding the indexes as a whole may be faring better than those buying individual stocks, which is a change from the stock pickers paradise witnessed when Covid first hit. Since many stocks got obliterated at the start of Covid because they were in industries hit the worst by crowd throttling, buying an index back then, which are large baskets of many stocks, may not have been

the most profitable route.

Instead, buying companies that specifically benefited from a virus-induced shut down was likely a better and more lucrative decision. Not so apparently now, as although many stocks are bouncing up and down like proverbial ping pong balls, some major indexes continue to steadily climb despite the volatility.

Will the stock markets of 2022 develop some definitive direction to make negotiating the indexes a somewhat easier and a more predictable endeavor?

Or will the severe daily rotations of stock sectors we saw in 2021 continue to frustrate investors in 2022.

Only time will tell.

### Can We Find Our Way to the Common Good?

I still remember a question I got years ago. It was at a public meeting in southern Indiana, in one of those squats, featureless cinder-block buildings you find all across the country. This young woman stood up and commented that I'd traveled throughout the US and had met all kinds of people. So, she wanted to know: What was my impression of Americans? I didn't even hesitate: The American people are fundamentally decent, I told her.

I still believe this. And when I say it, I'm not talking about a bare majority. Most Americans are good people.

Why even mention this? Because at the moment, we live in a country where a lot of Americans don't believe it. They think fellow citizens who belong to a different political party are at best misguided and at worst, evil. We have public officials who want nothing more than to do a good job and stick by the laws - resigning because they're tired of the threats to themselves and their families. Civic-minded Americans who believe in the institutions of democracy are steering clear of volunteering because they're afraid of the anger and physical danger they may face.

I don't think this happened by accident. There are major, powerful forces working to divide us. Some are pernicious, others are just looking to make themselves more powerful. Media companies and political commentators find that they can make money - a lot of money - by putting out divisive information. Politicians have discovered that they can benefit politically by appealing to their base and treating the other side as the enemy. Countries such as Russia and China spend enormous time and money sowing seeds of division in our country so they can make our system of democracy look bad and

weaken us as a country. There's an antidote for this, but it's not going to be easy: All of us, ordinary citizens and politicians alike, have to restore in our lives a belief in the importance of the common good - to ask ourselves not what's good for any one of us, or for our party or business or people who look like us, but what's good for the country as a whole, in all its complexity and diversity.

I know what you're going to say: Especially today, there isn't any single definition of "the common good," so how can we possibly agree on one? And here's my response: We live in a country that was designed to allow us to debate the question and to find common ground so we could move forward. In a sense, the common good in America is the opportunity to define the

common good, together. That's why the threats of violence and extreme behavior we're seeing these days

are so un-American. Our institutions evolved over centuries to allow us to settle political questions, overcome divisions, and compromise in the interest of progress. When elections officials can't do their jobs - or when ordinary citizens are afraid to step forward—then our mechanisms for agreeing on the common good break.

Yet there is plenty of agreement to be found. Let's go back to that question at the beginning. Americans, no matter our political stripe, take a good deal of inspiration from the best ideals of the founding fathers. Most support the enduring values of the country, like striving for a more perfect union and pushing to correct things they think are wrong. They want to be good citizens, useful to their communities. They work hard and though they make mistakes, they're also very serious about improving on the status quo and correcting those mistakes. And when they set their minds to doing something good in the way of change, they'll keep working at it until they get

These are, of course, more qualities than beliefs. But they're the qualities that have stood Americans in good stead through trying times in our past. And, I believe, they're the qualities that, in the long run, will help us get past this period of extreme divisiveness.







## Americans Would Pay a Heavy Price for Amnesty

Democratic leaders on Capitol Hill are scrambling to find a way to amnesty illegal immigrants in their nearly \$2 trillion budget bill.

The Senate parliamentarian, who decides what provisions can and can't be included in the bill that's being advanced under the filibuster-proof "reconciliation" process, shot down their first two proposals. So now, lawmakers are proceeding with "Plan C", which would grant illegal immigrants "parole," a status that gives illegal immigrants work permits and a reprieve from deportation, without immediately granting them green

Lawmakers are also plotting to expand legal immigration levels. All told, their current plan would increase the number of immigrants living and working in this country by several million people at a minimum.

Such rapid growth will put immense strain on our resources, both financial and natural, and the ensuing damage to our environment threatens to set progress there back by a generation or more.

Our country is not underpopulated by any reasonable reckoning. Schools are already overcrowded, especially for young children. California, for instance, would need to build a new school every day for five years to provide class sizes of 15-19 students. Over the next 50 years, immigration is set to account for 96% of the increase in school-age children.

Mass migration is making life more difficult and expensive for working class citizens. Just like everyone else, migrants need a roof over their heads, so they compete against low-income Americans for our scarce supply of rental housing. Nationally, the median rent has surged over 16% since January, in part because of competition from new arrivals.

Environmental groups pretend to be blissfully unaware that adding so many people to the population does irreparable harm to the environment.

Transportation is another example: more people mean more cars, gas or electric, creating more traffic and more emissions (electric cars pollute too, albeit at the power plant, rather than the tailpipe). More development requires the clearing of woods and fields to make way for pavement and parking lots. Federal data shows that around 90% of open space lost in the past decade, both urban and rural, can be attributed to population growth. Yes, more and more of our unique outdoor heritage is being lost.

This sprawl comes with serious environmental and health consequences, threatening wetlands critical for clean water and flood protection as well as harming endangered species. The American Southwest, in particular, faces a dystopian future of water shortages as its population skyrockets. Lake Powell just above the Grand Canyon is now at 29% of capacity, an all-time low, an astounding 156 feet below full capacity.

Poll after poll shows that amnesty is unpopular, as we all see right before our very eyes that such an unsustainable flood of migrants is worsening the quality of life for all. The only question is whether our leaders will grow backbones before it's too late.
