A Right to Housing?

The law says that every student is entitled to a free public education. What if it said the same about

housing? That's what Darrell Steinberg, the mayor of Sacramento, believes to be the key to addressing California's

homelessness. He recently proposed an ordinance that would require the city to provide at least two housing or shelter options to people living on the streets. If those options weren't available,

the person could sue the city. But if the homeless individual turned down the available options, they would be compelled to come inside, albeit using social workers, not police.

In the latest episode of the California Housing Crisis Podcast, The Los Angeles Times' Liam Dillon and CalMatters' Manuela Tobias interview Steinberg on his proposal, and how it has evolved over the years.

"I want to put out what I believe, which is fundamentally, that the public policy of the society must be that people live indoors," he said. "Ninety to 95% of that is the government's obligation. The last five to 10% may fall on some individuals."

Aside from housing or shelter, two of the options that a person must be offered include spaces at "Safe Ground" sanctioned tent encampments, hotel rooms, tiny homes and trailers.

"People have a much better chance to get permanent housing if they're


indoors rather than outdoors," Steinberg explained. "We can't get mental health treatment or substance abuse treatment for people living on the river."

But, like the rest of the state, Sacramento is far from able to provide at least a single shelter bed per person, much less an affordable housing unit. If approved by the City Council, Steinberg's plan would take effect starting in 2023, or later if the city makes substantial progress on housing options by fall 2022.

Liam and Manuela also discussed the results of a poll on homelessness in Los Angeles County conducted by the L.A. Business Council Institute and the L.A. Times.







Dick Marquette, 70,000 Miles in 40 Years

For 40 years Dick Marquette did his job the old way - walking his route through downtown Marysville with his mailbag slung from one shoulder.

He declined offers of a cart and wanted no part of a motor route. He wanted to walk and carry, and boy did he ever.

Five days a week for 41 years, Dick hoofed the same seven-mile route and delivered a daily average of 3,000 letters, plus 460 oddshaped items and packages to 566 addresses.

The supervisors at the US Postal Service calculated that Marquette has walked about 70,000 miles (the equivalent of the world) and packed 37 million pieces of mail weighing close to 700 tons. He wore out 20 mailbags in the process but still keeps the battered letter pouch he began with in 1954 as a souvenir.

At the age of 60 and still walking with long strides the lanky, white-haired postman delivered his last letter and retired, going into the Postal Service record book as the longest-serving pouch-hefting all-walking mail carrier in the country.

It was put into the interoffice e-mail system to see if anyone could challenge his record. No one could top him. All the others had gone to pushcarts or mail

So Marquette, who clung to the old ways, took the national cake.

Dick made the comment "I don't feel any different than when I started, but I won't be taking up hanggliding." as he neared the end of his last day.

Many missed him along the route where he was on a first-name basis with nearly everyone and was a walking historical directory of interesting facts about the town that 40 years ago ranked just behind Atlantic City for vice and corruption.

Dick has since then wrote almost three times around many stories on the historical and Interesting things

of downtown Marysville. One of his hobbies was the historical preservation of downtown Marysville. It was he that discovered that the city did not, as everyone had assumed, own the longforgotten Jewish section of the municipal cemetery. The deed belonged to a Jewish beneficial society that itself had lost track of and gratefully accepted it

He kept a route map when the downtown district was a booming international zone – where Anglo Americans and Japanese, Chinese, Basque, East Indian and African Americans toiled sideby-side - it was used by the Japanese American Citizens League to write a chronicle of Japanese families in Marysville.

Marquette kept a map to know which families lived where, who got the Japanese and Chinese newspapers, which had big dogs and that sort of thing.

His route back then was not only international but worldly, with more than 50 bars and 20 brothels packed into an area called "the Lower End."

"Vice-ridden and moneymaking: is how Dick described the flavor of those times. "Most of the (professional) ladies had post office boxes, but I delivered mail to Anne Davis, the madam at the Davis Hotel, 220-1/2 First Street. Her customers called her Icewater Annie, because she didn't have hot water to wash up with."

California Gun Law Headed to Supreme Court?

California has some of the nation's tightest gun control laws and virtually no session of the Legislature ends without additional restrictions being enacted.

In polling and by their votes, Californians have heartily endorsed making gun purchases and ownership increasingly more difficult.

As California's restrictive laws proliferated, however, the state's current and wouldbe gun owners complained that notwithstanding their political popularity, the laws violate Californians' constitutional right to bear arms, codified in the Second Amendment to the U.S. Constitution.

Those complaints are now likely to reach the U.S. Supreme Court because of Tuesday's decision by the 9th District Court of Appeals upholding two of the state's most controversial gun control laws, banning the sale and possession of magazines holding more than 10 rounds of ammunition. One was enacted by the Legislature and the other in a ballot initiative (Proposition 63) sponsored by Gavin Newsom in 2016 when he was lieuten-

ant governor.

ago, saying that it unconstitutionally interfered with using guns for self-protection. "The statute hits at the center of the Second Amendment and its burden is severe," Benitez

Newsom had become governor when Benitez ruled and denounced the judge as a "wholly-owned subsidiary of the gun lobby and the National Rifle Association."

A three-three judge panel of the 9th Circuit Court sided with Benitez but on Tuesday, the full 11-judge court, dividing along ideological lines, ratified the magazine laws. It declared that they "reasonably supported California's effort to reduce the devastating damage wrought by mass shootings.

The majority opinion added that requiring owners of higher-capacity magazine to get rid of them is not an illegal government "taking" because "the government acquires nothing by virtue of the limitation on the capacity of magazines."

The case sparked a welter of opinions from individual members of the court both endorsing the majority opinion and dissenting.

Three judges appointed by former President Donald Trump were sharply critical of the majority, saying, "these magazines are lawfully owned by millions of people nationwide" and warning that applying California's law across America would

> California being what it is, the nation's most populous state with some of the nation's tightest gun laws, the eventual outcome of the magazine capacity case could have wide effects. Blue state prosecutors filed briefs supporting California's position while those in Texas and other red states backed Benitez's ruling.

> The possibility of it becoming a landmark case was enhanced when lawyers for gun owners who challenged the state's magazine limit immediately promised that they would appeal to the U.S. Supreme Court.

> If, as Tuesday's decision indicated, judicial attitudes about gun control laws divide along ideological lines, California's limit on magazine capacity could face rough treatment from the Supreme Court's 6-3 conservative majority.

> In recent decisions, the Supreme Court has become increasingly critical of restrictive gun laws and has a landmark case now pending, involving New York's ban on carrying guns outside the home.

> During arguments a few weeks ago, majority justices gave every indication they would overturn the law, criticizing it for interfering with citizens' rights to selfdefense. That's essentially the same line of reasoning that Judge Benitez adopted in overturning California's magazine limit.

EU Leader Calls for Throwing Out Nuremberg Code in Favor of Forced Vaccinating All Dissenters - Comments come on the heels of Austria and Germany locking down the unvaccinated | 3 Dec 2021 | On Wednesday, Ursula von der Leyen - the president of the European Union (EU) Commission - told the press that she would like to see the long-standing Nuremberg Code ignored completely in favor of allowing countries to force vaccinate anyone who is refusing to take the experimental jab. The judge issued a preliminary injunction that day directing the hospital to "immediately allow... temporary emergency privileges" to Ng's physician, Dr. Alan Bain, "solely to administer Ivermectin to this patient." The hospital resisted the order on Nov. 6 and 7, denying Bain access to his patient. The hospital claimed that it couldn't let Bain in because he wasn't vaccinated against COVID-19 and that its chief medical officer wasn't available to "proctor" Bain administering ivermectin. The daughter's attorneys filed an emergency report with the court on Nov. 8 and Fullerton heard from both sides. The judge admonished the hospital and restated that it must allow Bain inside over a period of 15 days to do his job. When the hospital filed a motion to stay the order, Fullerton denied it, again directing the facility to comply. The ivermectin appears to have worked, and Sun Ng has recovered from COVID-19. He was discharged by the hospital on Nov. 27.

Austria Now Threatening PRISON to Anyone Who Refuses Vaccine - | 1 Dec 2021 Unjabbed Austrians who refuse to comply with the government's draconian mandates could face prison sentences and crippling fines for non-compliance. After initially placing unjabbed citizens under lockdown, Chancellor Alexander Schallenberg announced that the jab would become compulsory from February 1 onward. Questions as to what would happen to those who refused to comply with the mandate have now been answered in the form of a draft that was leaked to the media. "Under the bill, anyone who refused to attend a scheduled vaccination appointment would receive an official summons from local authorities. If an individual failed to show up, they would then be summoned one more time within the next four weeks," RT reports... Summit.news reports: No one will be "forcibly brought" to a vaccination center to get jabbed against their will, although rest assured, they will be "forcibly" placed behind bars if they continue to refuse. If it passes, the legislation will stay in place for three years, with the government deciding if having recovered from COVID is a reasonable exemption.

Juvenile In Custody after Bringing Firearm onto High School

Bitcoin Gold and Silver for Inflation Hedges

Gold and silver have obviously physical coins. Coins can also be been around the longest. In fact, since the earth began, these metals existed. Humankind has used these two metals since he first needed to exchange goods and services, and stories of gold and silver as a medium of exchange date back as far back as recorded history.

Bitcoin, and the many cyber coins like it, are a little more than a decade old. The length of time in existence is not even remotely comparable. Despite this fact, many have put tremendous faith and funds, into this new phenomenon called cyber coin.

One of the difference between the two metals and cyber coin is that the metals exist in the physical and the digital world, while cyber coin exists only in digital form. I dwell on this oddity from time to time, and ponder that if the power went out all over the world, does cyber coin actually exist?

I know the money spent to buy it would still be there, but would the cybers? An interesting concept, yet probably a moot point, as the odds of a global power outage that never comes back is next to nil.

That said, the thought does provoke a deeper analysis of what digital currency is versus the physical ones like metal coins or paper dollars. After all, we can hold the one type in our hand while only being able to view the other on an electronic screen.

Although the digital currency and physical ones have their similarities, there are other differences as well.

For one, the price swings in the digital cyber coin arena are wildly volatile, and although gold and silver do have their fluctuations, they are not nearly as drastic as cyber coin to say the least.

Bitcoin has gone from a few pennies a coin to over \$65,000.00 in under 12 years. Not what I call exactly stable. And since we are talking about inflation protection, a price stable medium is preferred. This makes gold and silver the obvious candidate when considering stability. Many might argue if bitcoin goes up, it's a better hedge than metals. But the price of cyber coin goes down drastically as well. Maybe cyber is a better speculation but not better protection based on its price volatility.

Ease of transfer is easier with cyber coin as long as one is connected to a power source and has some sort of computer. Gold and silver stocks is www.moneymanagementradio. the markets are open, but not so the OL34249.

harder and take more time to sell and the spread between the buy and sell price can be significant.

Taxes are due on both transactions and how much is dependent on a variety of conditions. The jury is arguably still out on what the tax liability will be on cyber transactions.

Gold and silver, having been around so long, are easier to transact in electronic form from any stockbroker firm. Cyber coin exchanges are difficult to use in my experience, and there are few Wall Street versions of bitcoin funds that are available as of yet.

The stunning price increases in cyber coin has indeed attracted a lot of attention. So much so, when comparing price action of Bitcoin to any other asset in recent history, the mania and price increases surrounding bitcoin is the most volatile ever witnessed. Nothing compares, even in the slightest, to the astounding price swings witnessed in Bitcoin and its cyber relatives. There is little doubt this is a mania of historic proportions. Manias can crash horribly.

There has been talk that buyers of cyber coin have taken a little bit of the luster from gold and silver, which is to say some investors are buying cyber coin instead of the metals. That said, it is likely that at least some funds that would have been destined for gold and silver have made it over to cyber coin. But with the difficulty in the coin exchanges, wild price swings, and not having nearly the history that gold and silver have, it remains to be seen whether cyber will replace the metals as an inflation hedge.

In this analysts opinion, the reasons given above tell me gold and silver are still the safer and more dependable inflation hedge. That may change at some point, but for now its the metal of kings for my inflation protection asset.

Man Arrested for Attempted Murder

LINDA, CA (MPG) - On 11/26/21 at approximately 8:00 a.m., Yuba County Sheriff Deputies arrested 50-year-old Tong Yang of Linda for Attempted Murder, following the shooting of a 59-year-old woman inside a Linda residence. Deputies entered the residence to find Tong Yang held on the ground by another man and the injured gunshot victim on the floor. Deputies immediately detained Yang and rendered medical aid to the victim, who was later transported to the hospital for treatment of a gunshot wound to the abdomen.

Over a dozen family members were in the home at the time of the incident, including several children. The victim remains hospitalized with serious injuries but is stable.

Yang was booked into the Yuba County Jail for Attempted Murder, Aggravated Assault, Burglary, and Threats, with a bail of 1 million dollars. The investigation remains active and ongoing.



YUBA COUNTY, CA (MPG) - On December 3, 2021, at approximately 8:17pm, An unidentified male (John Doe) was walking northbound in the #2 lane when he was struck by a Toyota T100 driven by Deann Middleton, causing major injuries to Doe.

Immediately after the collision, Sheri Vigh was driving a Toyota Highlander and observed Doe in the roadway and slowed to a stop to act as a shield for oncoming traffic. Randall Fox was driving a Chevrolet S10 behind the Toyota Highlander and failed to realize the Toyota Highlander was stopped. The Chevrolet S10 collided into the rear of the Toyota Highlander

which caused the Toyota Highlander to be pushed forward where it struck Doe.

Doe succumbed to his injuries at the scene prior to emergency personnel arrival. The Toyota Highlander and the Chevrolet S10 became disabled in lanes.

MARYSVILLE, CA (MPG) - On September 22nd, 2021, at approximately 2:08am Marysville Police officers were dispatched to Field and Stream Hotel and Tavern, 612 B St, for a report of shots being fired into the bar.

Officers arrived on scene and located a male victim who had been shot in the shoulder, with several bullet holes in the front of the business. Officers rendered medical aid to the victim until Marysville Fire Department arrived and the victim was transported to Adventist Rideout Hospital with non-lifethreatening injuries.

Witnesses on scene stated the suspect got upset at someone in the bar, went out to his vehicle, and retrieved a weapon. When the door to the business opened, the suspect began firing through the open doorway, striking the victim.

On November 30th, 2021, patrons and the original shooting victim called Marysville Police dispatch to report that the suspect was in the bar. Officers responded and contacted Mario Enrique Ramirez (26 years) from Marysville, without incident. Ramirez was positively identified by the victim and two other witnesses that were there the night of the shooting. Ramirez was booked into the Yuba County Jail on attempted murder charges. ★

viewed homelessness as a serious or very serious problem – a similar number as two years ago. However, over the past couple years the city and county have spent hundreds of millions of dollars to deal with homelessness

What has changed, however, is how people think the issue must be addressed: While voters were evenly split last time about

spending money on short-term solutions such as shelter and on long-term solutions such as housing, 57% said officials should focus on "short-term shelter sites."

Senator Nielsen Urges Caution on Projected \$31 Billion State Surplus

SACRAMENTO, CA (MPG) - Senator Jim Nielsen, R-Red Bluff, issued the following statement in response to the Legislative Analyst's Office report, The 2022-23 Budget: California's Fiscal Outlook, which projects a \$31 billion surplus.

"A \$31 billion surplus is not an invitation to build future spending obligations.

"Legislative Democrats used up their bag of tricks last year to avoid triggering the Gann Limit, which restricts how fast state spending can grow.

"The Gann Limit, which was passed on the heels of Prop. 13, expressed the wisdom of voters. The surplus either needs to go back to taxpayers or be used for essential functions, like education, infrastructure and paying down debt.

"As the vice chair of the Senate Budget and Fiscal Review Committee, I urge The Legislature and the governor to proceed with caution."


