PG&E Will Move Some Residential Customers to a Time-of-Use Rate Plan

SAN FRANCISCO, CA (MPG) - As part of a multi-year, statewide energy policy to create a cleaner energy future for California, Pacific Gas and Electric Company (PG&E) will move approximately 60,830 eligible residential electric customers currently on a tiered rate plan called E-1 to a Time-of-Use (TOU) rate plan in April 2022. On the Time-of-Use (Peak Pricing 4-9 p.m. Every Day) rate plan when customers use energy is as important as how much they use.

The transition to this Time-of-Use rate plan occurs by geographical region and affects approximately 2.5 million customers in PG&E's service area in stages. 14,551 customers in Butte County, 11,771 in Nevada County, 9,965 in Shasta County, 6,226 in Sutter County, 5,234 in Plumas County, 5,303 in Tehama County, 3,878 in Yuba County, 2,066 in Glenn County, 1,513 in Colusa County, and 323 in Lassen County will receive a series of notifications by mail starting this month to allow them ample time to make a choice if they prefer another rate plan. Customers can choose another rate plan at any time.

All California investor-owned electric utilities are required to automatically transition customers to the Time-of-Use rate plan to support a cleaner, healthier, and more reliable energy grid. PG&E does not profit from this change. Customers can choose an alternate Time-of-Use rate plan or another rate plan, including the Tiered rate plan, at any time. Customers enrolled in the Medical Baseline program will not be part of the automatic transition.

"To ensure our customers are fully aware of the transition to the Time-of-Use rate and how the program works, we're communicating this change more than 90 days ahead, and we'll continue to share information before each regional transition takes place," said Marlene Santos, PG&E's Chief Customer Officer. "And customers can choose the rate plan that best fits their needs and lives at any time."

Customers who automatically transition to this Time-of-Use rate plan will receive risk-free Bill Protection for the first 12 months on the delivery portion of the bill. If a customer pays more on the Time-of-Use (Peak Pricing 4-9 p.m. Every Day) rate plan than they would have on their

current rate plan, PG&E will also automatically credit the customer the difference for the first year on the generation side.

Customers on these rate plans can choose to shift and reduce some energy use to lower-cost time periods (19 hours) every day, including weekends and holidays. The hours of 4 to 9 p.m. are higher priced (peak times). All other times are lower priced (off-peak). Environmental advocacy groups such as the Natural Resources Defense Council (NRDC) support the transition to TOU rates as the plans help build healthier communities.

"TOU rates help Californians take advantage of less expensive, cleaner and more plentiful electricity during periods when a greater share of renewable energy is flowing through the grid. Combined with energy efficiency, electrification, and demand response programs, TOU helps customers reduce energy costs and their carbon footprints by using appliances when more emissions-free electricity is available," said Alejandra Mejia Cunningham, Building Decarbonization Advocate, NRDC.

Starting in 2018, approximately 150,000 residential customers from across PG&E's service area representing diversity in climate, household size and energy use were randomly selected as part of the first phase of transitions. Eighty percent of those customers stayed on the new Time-of-Use rate plan for more than a year. PG&E incorporated feedback from this initial group into the plans for the full rollout.

will be happy, but I feel that they are fair maps for Californians," she told CalMatters.

California Common Cause - which pushed voters to create the independent panel - also defended the commission: "While the process was at times messy, it was an exercise in democracy done in public," with 150 meetings and 30,000 pieces of public input.

Congressional lines

Slower population growth in California means the state lost one of its 53 U.S. House seats this year.

The population numbers must be exact: There can't be more than a one-person difference between districts to make sure everyone is represented equally.

Trying to meet all the criteria - equal population, Voting Rights Act compliance, communities of interest and compact districts - in a state with California's diverse population and geography made the task difficult.

Political dominos quickly started toppling immediately after the maps were approved.

Rep. Doris Matsui of Sacramento declared that she will run next year in the new 7th Congressional District. It also includes fellow Democratic Rep. Ami Bera of Elk Grove, who within hours announced he will follow many of his current constituents into the 6th District.

Assemblymember Kevin Kiley of Rocklin announced that he plans to run in the new 3rd District, if, as he expects, fellow Republican Tom McClintock of Elk Grove seeks re-election in the 5th District, just to the south. Meanwhile, Democratic Rep. John Garamendi of Walnut Grove said he will seek re-election in the new 8th District, which includes Contra Costa and Solano counties. Rep. Mark DeSaulnier, a Concord Democrat, will run in the neighboring 10th.

State Senate districts

While congressional districts each have about 760,000 people, state Senate districts are larger, with nearly 1 million Californians. For example, one encompasses California's entire border with Mexico. There's also more leeway - a 5% deviation from the ideal population.

Three Senate districts are going from a Democratic advantage in voter registration to a Republican majority, while one favors Democrats more. Republicans need to flip at least five seats in the Senate, or seven in the Assembly, to end the supermajority that allows Democrats to approve tax increases or put constitutional amendments on the

The commission's sixth and last criteria for redistricting is nesting - placing two Assembly districts into one Senate district where possible. In theory, that makes Senate mapping easier. But because the commission placed a higher priority on other criteria, this time, only two Assembly districts were nested into a Senate district, in Northern California.

Assembly lines

While the Democratic majority in the state Senate might shrink under the new map, Democrats' grip of the Assembly could tighten.

They now hold 60 of the 80 seats. The new Assembly map creates 63 solid Democratic seats, according to an analysis by California Target Book.

Board of Equalization

With just four state Board of Equalization districts, they are far less complex to draw.

The board is tasked with ensuring that taxes across different counties are uniform alcohol and beverage taxes, for example. Because of the county-specific policies, the commission tried to keep as many counties as possible intact. For example, densely populated Los Angeles County is one district by itself.

For these lines, there was little drama at the redistricting commission — and certainly nothing like the fights over congressional and legislative districts.

"I'm so proud of the work that together we have completed to serve all Californians. Despite a difference of opinion at times, there was always commitment to our common goal — to the goal of creating representative and fair maps for all Californians," commissioner Pedro Toledo said as he made the motion for a vote.

After Dec. 27, the commission expects it will reconvene not only to defend its maps against any legal challenges, but to work on a report that could make the process smoother for the next redistricting. Common Cause also said it is committed to examining improvements for the 2031 commission.

"We did receive community of interest testimony that did conflict so obviously there are some people that are not going to be happy," said Fernández, a Republican from Yolo County. "We have more VRA districts than there currently are, we listened to more people than the prior commission. We took all the info to heart and worked together to build these maps." ★

LIVE OAK, CA (MPG) - The Sutter County Office of Elections held a Special Election on behalf of the City of Live Oak on December 7th, to fill a vacant seat on the City Council.

The vacancy on the City Council was caused by the resignation of then Mayor Luis Hernandez and was effective May 31, 2021. At that time, the sitting City Councilmembers had 60 days to install an applicant to the position but were unable to come to a consensus during that time. Instead, the matter fell to the Sutter County Office of Elections and a Special Election was held to allow the citizens of Live Oak to decide who would fill the empty seat out of the following candidates: Jeramy Chapdelaine, Rick Dias, Cruz Mora and Alecs Tika.

The un-official results had Chapdelaine leading, and when the official tally came in, it confirmed the fact that Chapdelaine had received the highest number of votes, a total of 420, or 42.21% of the votes tallied for the

Special Election. On Tuesday, December 21st, a special meeting was held by the City of Live Oak to swear in its newest elected official, City Councilmember Jeramy Chapdelaine.

When asked about his new position, Chapdelaine said, "I'm honored to serve my neighbors and look forward to working with City Council and staff to make the progress and improvements the citizens of Live Oak deserve. I know this is a partial term, but I believe this is a great opportunity to be even more engaged with and build a stronger relationship with the public. I know there's been a lot of conflict and things have been slow over the past year and a half, and I'm really excited to get started working with everybody to find that middle ground and solutions that benefit the entire community."

The Live Oak City Council regularly meets the 1st and 3rd Wednesday of the month at 6:00pm at Live Oak City Hall. The next meeting will be held January 5th, 2022, and agenda information can be found at liveoakcity.org.



This Month In Your Garden

We wish everyone a "Happy New Year" as we enter 2022. We've had a very wet and December which is just what we need. Pay attention to freezing weather, especially after the storms clear out. That is usually when the freeze happens. Clear cold nights

Bare root season is the big thing happening in January at the nursery. Bare root fruit trees arrive in late December and are sold through January and February. We usually have some folks who are new to gardening and the term "bare root" may not be familiar to them. It is simply what it says. The trees have been taken out of the ground and the roots are exposed, thus, "bare root". They are less expensive since the pot, soil, and time and effort to plant them into a container has been avoided. It also requires that it must be planted right away, or otherwise stored in a way to protect the roots from drying out or freezing. We have availability lists at the nursery to help one to make decisions. Bare root season for fruit trees is usually considered very late December or early January to the end of February. By then the trees are beginning get too many new fragile roots and new leaves to handle them "bare root" without possible damage. There are advantages to planting your own fruit trees. You make the decisions of what fertilizers etc. are used and avoiding many of the unknows of commercial grower's methods. Allowing the fruit ripen on the tree allows much better flavor to develop as the fruit ripens than that picked early and ripened in cold storage. Often kids and adults are encouraged eat more fruit just because they like picking it themselves and it is close by.

When planting fruit trees, be sure to check if the tree you are buying needs a pollinizer. Some are self fruitful and don't need a different pollinizer and others do. Many of the peaches and nectarines are self-fruitful, but not all of them. Most of the cherries need a pollinizer, but again, not all of them, and so it is with apples, apricots, plums, pears. Most fruit trees have a tag giving some of that information.

Chill hours may be noted on the tag. That refers to the cumulative number of hours required under 45 degrees during the entire winter season to provide normal fruit production and is generally not a concern in our area.

Many camellia plants will finish blooming for the year soon and the flowers will have fallen causing a pile of debris at the base of the plant. That debris should be bagged and sent to the landfill rather than added to a compost pile you may have. It can carry a fungal disease that develops in the debris that then can scatter the spores and spread a problem that is easily avoided by the proper disposal of the debris.

Bare root roses are available during January and February, and have been pruned by the growers. If you have roses that are growing in your yard already, we suggest delaying the pruning until the danger of a heavy freeze is past. In our area roses usually don't go completely dormant. What happens when you prune a rose? It starts putting out new growth at that point. That new growth is too tender to survive a hard freeze and dies back. We have lots of micro climates in the foothills, so consider the temperature range in your area and delay the pruning until freezing danger is past and do the pruning in early spring if it seems more appropriate. If by chance you do prune them and are then hit by freeze that damages new growth, no great harm has been done the rose just has to expend more energy that might otherwise have been saved for its beautiful first bloom and has to start over

Enrollment Declines Squeeze Local School Finances

The 1970s and 1980s were a tumultuous time for California's public schools, to wit:

 A tidal wave of kids from the post-World War II baby boom pushed school enrollment to well over 4 million, but the end of the boom in the mid-1960s and a slowdown in overall population growth drove enrollment downward in the 1970s. Throughout the and birth rates. Also, school state, local school systems pared back school construction, sold off school sites and even closed some schools.

• At the time, schools were largely financed by locally imposed property taxes but in 1971 a successful lawsuit, Serrano vs. Priest, declared that widely varying taxable property values among the state's school districts unfairly disadvantaged children in low wealth communities. In response, the Legislature began overhauling school finances to provide what was called "equalization."

• Subsequently, however, in 1978, voters passed Proposition 13, which clamped tight limits on property taxes, compelling the state to assume the fundamental task of financing

finance to the state Capitol.

• California's population soared in the 1980s due to high immigration and birth rates and so did school enrollment, eventually topping 6 million. In 1988, a decade after Proposition 13's approval, the education community persuaded voters to pass Proposition 98, an extremely complex measure that dictates how schools' share of state revenues is calculated. It has dominated the state budget process ever since.

This snippet of political history is offered because it could be repeated.

California's once-soaring population has slowed to a trickle, or perhaps even reversed, due to sharp declines in immigration enrollment, which topped out at 6.2 million a decade ago and remained virtually unchanged until recently, is beginning what demographers believe will be a steady decline.

The COVID-19 pandemic is partially responsible for some recent declines but the state Department of Finance projects that underlying demographic trends will drop enrollment to 5.5 million by 2030, some 700,000 lower than the peak.

"Projected declines are greatest in Los Angeles and Ventura Counties roughly 20% lower by 2030 – 31," a recent study by the Public Policy Institute of California declares. "The declines in Los Angeles County are particularly noteworthy: county enrollschools from income and ment has already fallen sales taxes and thus shifting over 10% in the past

wrangling over education decade, and enrollment in 2030 – 31 is projected to be 30% lower than it was in 2010 - 11."

State aid to schools is largely driven by enrollment, so districts that are seeing major declines, particularly large urban systems such as Los Angeles Unified, are beginning to feel the financial pinch and confronting the unpopular task of shutting neighborhood schools.

At the moment, school finances have a respite. Gov. Gavin Newsom and legislators have decreed that state aid is temporarily based on pre-pandemic enrollment but the "hold harmless" gesture is due to expire next year. What happens after that is anyone's

Decreasing enrollment could be beneficial in the long run, because it could increase per-pupil spending. But that would depend on the willingness of state politicians to once again change the methodology of school financing, moving away from its enrollment base to some other model.

Given the tens of billions of dollars at stake, however, a major overhaul would be a tough political slog. Until and unless it occurs, the local systems seeing the most dramatic enrollment declines will have a difficult time balancing their budgets as their state aid shrinks and their fixed costs, such as pension fund contributions, continue to rise.

'Striking' vaccine resistance in Omicron variant - Columbia University | 16 Dec 2021 | A new study out of Columbia University says the Omicron variant is "markedly resistant" to vaccines and boosters might not do much to help, spelling bad news for the country as Omicron spreads and COVID-19 cases rise nationally. "A striking feature of this variant is the large number of spike mutations that pose a threat to the efficacy of current COVID-19 vaccines and antibody therapies," according to the study authored by more than 20 scientists at Columbia and the University of Hong Kong. The scientists express concern in the study published Wednesday that the variant's "extensive" mutations can "greatly compromise" the vaccine, even neutralizing it. The report said the booster shots prevent some of the neutralization, but the variant "may still pose a risk" for those with their third shot. "Even a third booster shot may not adequately protect against Omicron infection," the study said, adding it's still smart to get a booster.

CDC over-counted millions of vaccinations - report | 19 Dec 2021 | The U.S. government has over-counted the number of Americans who are at least partly vaccinated against the coronavirus, Bloomberg reports. Data from the Centers for Disease Control and Prevention was revised last weekend for the number of people 65 and older who have received at least one shot, according to Bloomberg. The CDC lowered the percentage vaccinated from 99.9%, where it had been for weeks, to 95%, without changing the raw shot totals... Three states – Illinois, Pennsylvania and West Virginia – found enough over-counting of first shots to indicate millions of unvaccinated people had mistakenly been counted as having received a dose.

White House ripped for doomsday winter message of 'severe illness and death' for unvaccinated people | 20 Dec 2021 | The White House was viciously mocked over the weekend after pushing the message that unvaccinated Americans would experience a winter of "severe illness and death" due to the omicron variant of the coronavirus. Joe Biden, as well as White House COVID response coordinator Jeff Zients, each pushed the messaging last week, with the former issuing the stark and gloomy warning to Americans following a Thursday White House briefing on the pandemic. "I want to send a direct message to the American people: Due to the steps we've taken, omicron has not yet spread as fast as it would have otherwise done," Biden said. "But it's here now, and it's spreading, and it's going to increase... We are looking at a winter of severe illness and death for the unvaccinated - for themselves, their families and the hospitals they'll soon overwhelm," he added. Critics took to social media to mock the White House's message of death, with some referring to Biden as the "Grim Reaper" and others declaring that Biden saying he was going to "shut down the virus" sounded a lot different than "illness and death."

The 21-year-old man was apprehended Thursday night entering the U.S. from Mexico through Yuma, Arizona, according to a tweet from Yuma Sector Chief Patrol Agent Chris T. Clem. He appears to have been wearing a jacket emblazoned with an American flag patch and another that stated: "Central Oneida County Volunteer." The man is allegedly from Saudi Arabia and "is linked to several Yemeni subjects of interest."

Looters caught stealing from ravaged homes of tornado victims in Kentucky | 19 Dec 2021 | Five heartless thieves were busted for looting the ravaged homes of tornado victims in Kentucky, officials said. The group of looters allegedly went to an area "particularly hit hard by the tornado" on Friday and ransacked the destroyed homes, according to Graves County Sheriff Jon Hayden. Law enforcement officers from several agencies quickly converged on the group who were stopped while trying to flee the area with several damaged vehicles in tow. The vehicles "were owned by tornado victims that have been displaced by the tornado, in the hospital, and/or deceased," Hayden said. *



Chico State Faculty and Staff **Charged in Grand Theft Schemes**

Butte County Press Release

CHICO, CA (MPG) - Three former employees of the Chico State University School of Business, Department of Accounting were charged earlier this week in a criminal complaint that alleges they expensed fraudulent time, money, travel and other items to the University and the University Foundation.

Butte County District Attorney Mike Ramsey said the felony case against accounting professors Timothy Kizirian, 53, and Jeffrey Decker, 59, and the Accounting Department secretary Ronda McGrath, 55, began when a new Dean investigation into financial irregularities in the Department of Accounting. That investigation determined some \$1.12 million dollars had been spent over a period of several years on items such as duplicate compensation, gift card purchases, fraudulent mileage claims, improper travel and personal expenses including meals, hospitality and gifts and unreported absences. At the conclusion of the University's administrative inquiry, the matter was turned over to the Chico State University Police Department who launched their own criminal investigation. The Chico State University Police Department's investigation subsequently revealed patterns of alleged criminal fraud and manipulation that extended back to at least 2013. These included fraudulent travel claims, theft of time related to outside employment, improper use of gift cards and meal and mileage claims; as well as the manipulation of class sizes and student enrollment to secure additional compensation for accounting

Ramsey said the five filed charges in the felony

criminal complaint represent overnight "student placea small subset of the discovered activities by the suspects and included only those counts where sufficient evidence existed through witness statements and other evidence to secure convictions at trial.

Count 1 of the felony complaint alleges Kizirian stole approximately \$8,022 in time from the University by fraudulently reporting he took no vacation or leave time from Chico State University when in fact, between April and June of 2017, he was absent on numerous occasions while teaching an accounting course at the University of California at Davis.

Count 2 of the felony of the College of Business complaint alleges Kizirian alerted the University in defrauded Chico State March 2019. The University University and its Foundation administration began an of approximately \$24,517 in expenses for travel, "student placement" activities and other expenses between December 1, 2013, and November 30, 2018, which either did not exist, or were expenses for participants who were either not present, or not connected with university business. This included include a "Spring Social" at a Sacramento accounting firm on April 12, 2017, that never took place.

Count 3 of the felony complaint alleges that Kizirian and McGrath engaged in a pattern of fraudulent activity concerning Accounting Department expense reports between May 2014 and December 2018, wherein some \$9,219 in expenses submitted to the University and its foundation were determined by investigators to be either false or personal in nature. Some expenses included gift cards reportedly given to students who reportedly never received them, and reimbursements for student meetings that the students themselves did not attend.

Count 4 of the felony complaint alleges Kizirian and Decker defrauded Chico State University and its Foundation of approximately \$1,015 in expenses for an ment" trip to Davis, CA on May 6 to May 7, 2017, where, in part, expenses were claimed for individuals that investigators determined were not present.

Count 5 of the felony complaint alleges Kizirian and Decker billed the University and its Foundation approximately \$2,094 for a trip to Tucson, AZ to attend a "celebration of life" event for a deceased former colleague on September 30, 2016. Email discussions between Kizirian and Decker demonstrated their belief the trip would be a "blast from the past" and contained discussions about their efforts to conceal the true nature of the trip.

Ramsey said the balance of the activities discovered in the civil and criminal investigations represented situations resulting from lax oversight by the University, including insufficient management and accounting controls and inadequate policy safeguards, but were not by themselves criminal, or were cases where evidence was insufficient to obtain a conviction.

Ramsey said he was informed the University suspended Kizirian, Decker and McGrath shortly after the administrative investigation was concluded in December of 2020. McGrath voluntarily resigned then retired in January 2021. Decker resigned in August 2021. Kizirian was dismissed in June 2021 but is contesting that dismissal through an arbitration board. The board held a hearing on the dismissal and is expected to issue a ruling next month to determine whether to uphold the dismissal or not.

Ramsey said if criminally convicted, Kizirian, Decker and McGrath face between three and five years, eight months in county jail. Ramsey said the case is set for initial arraignment in **Butte County Superior Court** on January 6, 2022. Ramsey said his office continues to investigate the matter and charges against additional defendants are possible. ★






