Life Legal to **Defend Pro-Life Speech Against Power Grab**

Commentary by Life Legal Defense **Foundation**

SACRAMENTO, CA (MPG) -Life Legal filed a lawsuit in federal court October 11, 2021 challenging a new California law that will suppress pro-life speech outside abortion mills. Using the threat of COVID as an excuse, the Legislature enacted a breathtaking restriction on speech that will ban core First Amendment activity in numerous locations across California.

The law, SB 742, was signed by Governor Newsom on Friday. While SB 742 started out as a bill to restrict protests concerning COVID vaccines, it was amended to cover every location where any type of vaccine is provided. Planned Parenthood, Family Planning Associates, and other abortionists dispense STD vaccines, including Gardasil, which makes them "vaccination sites" for the purpose of the law.

The law makes it a crime to approach within 30 feet of another person who is within 100 feet of a "vaccination site" for various purposes, including obstructing, which is already illegal, and "harassing"- a term the legislature has redefined to include everyday free speech activity.

SB 742 defines "harassing" as "knowingly approaching, without consent, within 30 feet of another person or occupied vehicle for the purpose of passing a leaflet or handbill to, displaying a sign to, or engaging in oral protest, education, or counseling with, that other person in a public way or on a sidewalk area."

This contorted - and unconstitutional - definition of criminal harassment is only found in this statute. Other California laws define harassment as "seriously alarming, seriously annoying, seriously tormenting, or seriously terrorizing." This is what most people think of when they think of harassment - NOT handing a leaflet to someone, providing education

Advance Warning Sign Activated on Highway 99 South of Chico

Caltrans Traffic Alert

BUTTE COUNTY, CA (MPG) - In a continued effort to boost motorist safety, Caltrans has installed a permanent advance warning system at the intersection of northbound State Highway 99 and Neal Road south of Chico.

Motorists will see an electronic board displaying the message "Caution Slow Traffic Ahead" when vehicle speed slows to 25 mph or less at the traffic signalcontrolled intersection. The message will stay on until vehicles resume traveling above 25 mph.

These transverse rumble stripes are made of thermoplastic material which, when driven over, create noticeable sound and vibrations to warn drivers of an approaching intersection where they may be required

to slow down or stop.

Caltrans District 3 maintains more than 4,385 lanes miles of state highway in 11 Sacramento Valley and Northern Sierra counties. Medical Aid-in-Dying to Be More Accessible


SACRAMENTO, CA (MPG) -Mentally capable, terminally ill patients with less than six months to live will now have much easier access to medical aid-in-dying, thanks to a bill just signed

by Gov. Gavin Newsom. Patients still have to get the approval of two doctors, but Senate Bill 380 shortens the waiting period between 2 oral requests for the prescription from 15 days to 48 hours.



Newsom, Legislature Push the State Leftward

Before celebrating his 54th birthday Sunday, Gov. Gavin Newsom closed out the landmark 2021 session of the California Legislature by signing the last of the 770 bills he decided should become law.

It was a remarkable session because a new wave of COVID-19 was hitting. Newsom was facing a recall election, he and legislators had many billions of dollars in federal pandemic aid and unanticipated tax revenues and, finally, because they spent much of that money on an array of new and expanded public services.

The new spending on health care, social services, public schools, early childhood education and increasing personal incomes of the poor makes California the national leader in advancing the Europeanstyle "social democracy" model that the Democrats' left wing wants the federal government to embrace.

Before this year's session began, for instance, 94% of Californians had some form of medical care coverage, thanks to Obamacare and a sharp expansion of the state's Medi-Cal program for the poor to more than a third of the state's population. The leftward tilt of the session is also evident in other ways that do not spend money, such as making ethnic studies a requirement for high school education, banning gasoline-powered lawn equipment, imposing new restrictions on guns, or compelling department stores to have gender-neutral toy and child care departments.

The Legislature and Newsom also continued to move the state's criminal justice system leftward, reducing punishment for some crimes and cracking down on police officers who misbehave by lifting the licenses, called "certifications," they need to be employed.

Interestingly, while Newsom endorsed 770 bills that the Legislature sent to his desk, he also vetoed 66 of them, in some cases because, he said, they went just a bit too far.

One of his more significant – and surprising - rejections was the latest of many years-long efforts by Democratic legislators to help the United Farm Workers Union expand its tiny foothold among the state's agricultural workers.

Assembly Bill 616 would have allowed pro-union workers to sign cards rather than having an election on whether the UFW should be recognized as a contract bargaining agent. It faced stiff opposition from farmers and Newsom said in his veto message that the bill contained "various inconsistencies and proce-

The UFW had backed Newsom in his successful victory in a September 14 recall election, and he vetoed the union's bill eight days later, earning a denunciation from the union's leaders, who likened the measure to the all-mail state election process that Newsom and legislators have decreed.

AB 616 was just one of two bills on the California Chamber of Commerce "job killer" list to reach Newsom's desk intact. While he vetoed it, he signed the other, Assembly Bill 62, also a union-sponsored measure than bans piecework pay in the garment industry.

Legislative leaders tout this year's session as one of the most expansive in history, and they are correct. The state is now a beacon for the national progressive agenda that President Joe Biden is trying, so far unsuccessfully, to move through Congress.

There's every reason to expect that Newsom and the Legislature will continue to paddle California's canoe to the left. Republicans are powerless and the influence of Democratic moderates has waned. The only question is whether the economy will continue to churn out enough money to pay for the new benefits without tax increases.

Mint a Platinum Coin

With the U.S. government running a 29 in the last decade, the logic of it, well, trillion dollar deficit (USDEBTCLOCK. ORG), with another 157 trillion in unfunded liabilities (debts not due yet but still owed) the additional 1.9 trillion stimulus proposal (the amount changes daily) is being hotly contested in Congress. Washington desperately wants to authorize this additional spending. Opponents of the bill from both parties point to the debt already spent during CoVid (about 4.5 trillion) saying another two trillion is excessive and will add even more debt to an already bloated U.S. budget. Now a U.S. default approaches, which is only compounding

Where there is a will there is a way, and an idea that was originally tossed about and discarded in last decade is once again up for discussion. The idea is to mint a platinum coin with a face value of one trillion dollars, then give that to the Federal Reserve of United States who in turn would deposit it into the U.S. Treasury. Then the Treasury Department could essentially cash the coin back at the Federal Reserve to fund one trillion dollars in additional spending. The idea is with the theoretical \$1 trillion coin on deposit, the government could pay its bills without additional borrowing, making the debt ceiling a nonissue and, therefore, averting a government shutdown. Since the coin would be legal tender per the original U.S. Coinage Act, it is essentially just making change from the coin to U.S. dollars, which it could then spend.

The idea is being pushed by, among others, Professor of Economics and Nobel Prize winner in Economic Sciences, Economist Paul Krugman. In his latest article (Oct 1, 2021) entitled "Wonking Out: Biden Should Ignore the Debt Limit and Mint a \$1 Trillion Coin", Krugman suggests the coin could provide a respectable solution to the spending plan and not officially increase the deficit. Krugman also suggests the coin does not have to actually contain a trillion dollars' worth of platinum (that would be beyond huge), but would only have to be denominated as such.

That the coin is being seriously considered by the powers at be makes more than a few of us shake our heads.

More concerning is that the Treasury Department and the Federal Reserve for the most part are not commenting much, nor outright killing the idea like they did way back when. We have to remember different people run these institutions now, and along with many other ideological changes, what seemed impossible a few short years ago is now on the proverbial table of consideration.

Not everyone in Washington is onboard with the idea. Ex-Federal reserve chief now our Treasury Secretary, Janet Yellen, dismissed the of minting a \$1 trillion coin as a last-ditch effort to help the United States pay its debt, saying the concept shouldn't be considered seriously despite its popularity.

Like I said, where a will comes a way. I would ask why stop at a trillion? Why not stamp it 29 trillion and wipe out that nasty deficit once and for all. Well the "for all" part is probably not going to happen. Wipe the deficit clean is like destroying a beaver dam. Get rid of it and you'll likely find another in short order. Wipe the deficit clean and do you think they would start running it back up again?

Me thinks so.

In any case, the very concept seems ludicrous. Why bother wasting the platinum? Just print a "one trillion dollars" on a lead fishing weight and be done

Many analysts and economists doubt the coin idea will ever make it out of the concept stage, but if we have learned anything in the last six years or so, don't bet against putting anything past those that rule us. It can get a whole lot wackier before we come to our senses.

The new organisation is now known as the 'UK Health Security Agency.' That's a slightly sinister and extremely concerning name isn't it? The new UK Health Security Agency released a report on Thursday, September 30, entitled "Vaccine Surveillance Report - Week 39," and within it they have published the number of alleged Covid-19 cases, hospitalisations, and deaths from week 35 to week 38 of 2021, by vaccination status. 138 State Legislators Have Signed 'New Declaration of Independence' Letter Led By Wendy Rogers - | 15 Oct 2021 | 138 legislators from 38 states across America have signed what Arizona Wendy Rogers called the "new Declaration of Independence," calling for a 50-statewide audit, decertification where appropriate, and potential convening of the US House of Representatives. Rogers, who revealed the updated figure on Twitter Friday, introduced the letter at the end of the Arizona Audit hearing. In the letter, Rogers and the signatories call for states to audit their 2020 election results and decertify them where appropriate and floats the possibility of a convening of the United States House of Representatives to reexamine the results of the last election.

Australia Building Permanent Covid-19 Quarantine Camps for 'Ongoing Operations' 15 Oct 2021 | Despite the Covid-19 "pandemic" being pretty much over, at least for the unvaccinated, Australia is busy constructing new "quarantine" camps, which the government states will be needed next year to house people "who have not had access to vaccination." Ambassador Katherine Tai called for engaging China on trade while defending "American economic interests from harmful policies." China has pledged to buy \$40 billion of U.S. food and agricultural products annually. But wide-ranging tariffs that affect California commodities remain in place.

Biden Administration to Reaffirm Biological Opinions in Water Supply Decisions

The Biden administration is looking to elevate federal biological opinions in managing water supplies from the Sacramento-San Joaquin Delta. The effort seeks to reverse Trump administration rules that downgraded the role that opinions by the U.S. Fish and Wildlife Service and other federal agencies played in decisions related to California water projects. California officials sued, claiming the Trump-era rules lacked safeguards for protected species and habitat.

UC Merced gets \$10 million for 'Climate Resilient Water Future' Research

University of California, Merced researchers are working to generate detailed climate information to help farmers and water agencies make water-management decisions in the face of longer and more severe droughts. UC Merced received a \$10 million research grant from the USDA for a four-year effort to enhance data-driven practices to protect groundwater supplies and make agriculture and ecosystems more water resilient.

Vineyard Growers look to Remove Steel Reinforcement Without Burning

California growers are looking for new ways to remove non-productive orchards and vineyards. Starting in January, new state rules will prevent the burning of many former vineyards as part of a gradual phaseout of agricultural burning by 2025. One of the challenges for growers is removing reinforcing steel from vines. That has been separated out through burning. Enmeshed steel can't be run through chippers, requiring more expensive machinery.





Death Investigation in Taxi Driver Assault

CHICO, CA (MPG) - On October 03, 2021, at 3:54 AM the Butte County Sheriff's Office (BCSO) received a 9-1-1 call from the owner of a local taxi company. The caller told BCSO dispatchers that he had been assaulted by two individuals in the area of Lone Pine Avenue, Chico. BCSO deputies were immediately dispatched to the area and contacted the taxi driver. The taxi driver was injured during the assault and was immediately transported to a local hospital.

Beat a Cyberbully: Here's **How Parents Can Help**

SACRAMENTO REGION. CA (MPG) - While remote learning during the COVID-19 pandemic lowered reported instances of bullying, parents fear that, for some students, going back to school will mean going back to being bullied.

"Bullying is something we worry about, especially with the beginning of each new school year," said Zury Bourque of her family of four in Cypress, Texas.

Now 15 years after the inception of National **Bullying Prevention Month** in October, technology's ever-greater presence in children's lives has given bullying a new outlet. With just a click, cyberbullies can taunt, harass and threaten relentlessly, even reaching into the home via

cellphone or computer. As a result, victims report feeling hopeless, isolated and even suicidal.

What can parents do to protect their kids? Taking an interest in their children's online world can make a difference, says the National Parent Teacher Association.

This interest does not necessarily require parents to become tech experts. Instead, the federal stopbullying.gov site advises parents to watch for subtle clues that something is wrong, such as their child becoming withdrawn, hiding their screen when others are nearby or reacting emotionally to what is happening on their device.

For Zury Bourque and her husband Chris, that has meant being keenly aware of what "normal" looks like for their two boys, ages 12

"Knowing my children's

moods is very important because I can then detect shifts or changes in their personalities that might signal something is going on," Chris said.

Talking with kids openly and often – helps too. "The more you talk to your children about bullying, the more comfortable they will be telling you if they see or experience it," UNICEF says in its online tips for

As their two daughters enter their teens, Houston parents Thiago and Auboni Cordolino have found that talking less and listening more works best. "We try to focus on being approachable and listening actively without reaction," Thiago said.

Beyond talking, listening and observing their kids, parents should not be afraid to make and enforce rules for online activities. experts say.

Gallagher Wraps up Successful **Legislative Session to Help Locals**



Office of Assemblyman James Gallagher News Release

SACRAMENTO, CA (MPG) -Assemblyman Gallagher (R-Yuba City) announced the final actions on his legislation for the 2021 legislative session. In all, Assemblyman Gallagher successfully passed five bills, including legislation to help Paradise recover from the 2018 Camp Fire, and legislation to help provide safe and affordable drinking water for the City

of Willows. AB 36 will aid the Paradise recovery by fast tracking construction of the Paradise Irrigation District (PID) water intertie and the Paradise sewer project. Specifically, the legislation authorizes the use of design-build, a cost-effective contracting method that can prevent project delays while providing more flexibility for these projects.

"AB 36 helps ensure that as the town rebuilds, it rebuilds better and more resilient to natural disasters than before by facilitating critical projects that modernize the town's infrastructure," said Gallagher.

AB 379, which restores the natural and cultural right of Native American Tribes to be stewards of conservation land, was also approved by the

tribes to the list of entities the Department of Fish and Wildlife and the Wildlife Conservation Board may enter into agreements with for conservation purposes. The legislation will help the Mechoopda Indian Tribe of Chico Rancheria partner with Chico State to steward property currently managed by Chico State.

The Governor also signed Gallagher's AB 850, which extends the sunset date on a pilot program to encourage the voluntary consolidation of small municipal water systems to improve water services for Californians. The City of Willows, whose drinking water supply has naturally occurring Chromium VI, plans on utilizing this pilot program and supported Gallagher's legislation.

"It is critical that residents feel confident in their drinking water supply, especially in drought years, and AB 850 will help facilitate access to safe, clean and affordable drinking water for the City of Willows," said Gallagher.

In addition to AB 36, AB 379 and AB 850, the Governor signed:

-AB 232 (Gallagher) -This bill requires residents of Arizona, Idaho, Utah, and any other state that require California residents to purchase OHV permits in their state, to obtain a California out-of-state OHV permit before they could legally operate their vehicle in California. Reciprocity is a two-way street. AB 232 will make sure states that rescind OHV reciprocity do not benefit from California's reciprocity law.

Governor. The bill adds Not only is this fair, but it encourages other states to keep their reciprocity laws in place.

-AB 1079 (Gallagher)-This bill, sponsored by the California Lawyers Association, clarifies which beneficiaries under a revocable trust are owed duties by the trustee in the event the settlor or other person holding the power to revoke the trust is deemed incompetent. The bill passed the Assembly and Senate with unanimous support

Gallagher also spearheaded ACR 27 to continue the "Farm-to-Fork Corridor" into the North State by designating additional portions of SR 99 as part of the Corridor. Originally established by Gallagher in 2019, the Corridor recognizes the people of the North State who dedicate their lives to provide high quality agricultural commodities for California and the United States and helps introduce people to the area where their food is grown. Gallagher also passed ACR 19 to name the portions of Highways 20 and 70 running through the city of Marysville as part of the "Purple Heart Trail." This symbolic trail runs throughout all 50 states to commemorate and honor all men and women who have given their lives in combat while serving in the U.S. armed forces.

Here's What "Everyday Low Prices" Can Teach Us About Health Care

"Everyday low prices" are coming to health care. Walmart recently launched its own analog insulin, a synthetic form of the hormone that's genetically modified to be released rapidly or slowly, depending on a person's needs. It will be manufactured by pharmaceutical giant Novo Nordisk – but cost 75% less than brand-name analog insulin.

The deal stands out as proof that markets can deliver outcomes that work for producers and consumers alike - if we let them.

Generally speaking, the "market" for medicines is dysfunctional. It bears little resemblance to the markets for groceries or electronics, where insulin's full list price, consumers can compare prices and product reviews, shop around for the best deal, and purchase what they want.

Instead, patients typically pay for prescription drugs through their insurance plans. They may be responsible for a co-pay or co-insurance – a set

percentage of a drug's that Sanofi received, after nominal price – and their insurer pays the rest.

The exact co-pays and co-insurance are determined by entities called pharmacy benefit managers – middlemen hired by insurers to administer drug plans and negotiate drug prices with pharmaceutical companies.

Because PBMs decide which medicines are, and aren't, available through a given plan, they have immense leverage over pharmaceutical companies. Three PBMs handle more than 70 percent of prescriptions filled in the

United States. That leverage allows them to extract deep discounts from drug manufacturers. If drug makers want to have their products included on an insurer's formulary, they have to pay up. If they don't, the PBM will simply go with a drug maker that will.

In the market for insulin, PBMs routinely extract discounts exceeding 70%. They pocket some of that money and pass the bulk along to insurers.

Patients, meanwhile, pay a percentage of the which is many times higher than what the PBM negotiated with the manufacturer.

Consider the insulin made by Sanofi. From 2012 to 2019, its list price increased 140%, from about \$150 to more than All (Encounter 2020). \$350 per vial. But the amount of net revenue sallypipes.

paying discounts to insurers and PBMs, declined 41% during that time period.

Those insurers and PBMs didn't share those rebates directly with the people buying insulin. Instead, consumers had to cover for co-pays and co-insurance based on the escalating list price.

A patient with a 25% co-insurance requirement on a \$350 drug got a bill for \$87.50 at the pharmacy. That co-pay is greater than Sanofi actu-

ally received in total. By cutting out these middlemen and selling directly to retailers like Walmart, drug makers can maintain or even increase their profit margins. The retailers charge a small mark-up, just as they do for everything they sell.

And in this case, patients save money, too.

Middlemen siphon billions of dollars out of the healthcare system each year - while providing questionable value to consumers. As the deal between Walmart and Novo Nordisk shows, market principles offer a better way.
