# Out of Time

California legislators won't extend eviction ban

California's eviction protections will almost certainly not be extended once they expire after Sept. 30, the state Assembly Housing chairperson said today.

The legislative session ends Friday, so that's the last day that lawmakers could push off that deadline. But the political appetite just isn't there to act, according to David Chiu, a San Francisco Democrat who spearheaded the previous efforts to stall the displacement of tenants amid the pandemic.

"I believed our eviction protections for tenants should be extended beyond September 30. The delta

variant and the end of many unemployment benefits make that even more urgent," Chiu told CalMatters. "Unfortunately, some of my colleagues feel differently, and there's not enough consensus for that."

The current round of eviction protections were extended on June 25, just days before they were set to expire. At that point, Assembly Speaker Anthony Rendon said he hoped the economy would be in full swing so that another moratorium would not be necessary. Rendon's office declined to comment on the absence of another extension.

"The Legislature has kind of set a trap for itself because it won't be in session when that expires," said Brian Augusta, legislative advocate for the

California Rural Legal Assistance Foundation, who has been lobbying for stronger protections throughout the pandemic. "So, that means, what we see is what we get."

Augusta said the governor could still call a special legislative session to extend protections before the end of the month, or issue an executive order as he did at the beginning of the pandemic to pause court proceedings relating to evictions. But he said that's unlikely.

The governor's office also declined to comment.

The California Rental Housing Association, which represents more than 20,000 landlords and has sued the state over the last round of

## Ethnic Studies Now Required for All High School Students

SACRAMENTO, CA (MPG) - On September 8, 2021, the Legislature passed Assembly Bill 101 (Medina) to mandate that every high school student take a course in ethnic studies in order to graduate. Vice Chair of the Assembly Education Committee Kevin Kiley (R-Rocklin) responded to the passage of this bill with the following statement:

"The first version of the Ethnic Studies model curriculum was universally condemned by Jewish leaders across the state. But instead of scrapping the bill, the Legislature accepted some minor tweaks and has decided to impose Critical Race Theory on every high school student in California.

"The purpose of education is to prepare students for citizenship and civic engagement. As our state has lost sight of that purpose, CRT has filled the void as the anti-civics. In essence, a failure to teach students how to build their communities up has created an opening for those who would have them tear their communities down.

"I urge Governor Newsom to stand by his word and reject this harmful bill."

Earlier this year, Assemblyman Kiley gave a speech in opposition to the bill on the Assembly Floor.

The model curriculum on which AB 101 is based has been embroiled in controversy for many years, prompting Governor Gavin Newsom to veto a similar graduation requirement in 2020 citing concerns that it did not go far enough to eliminate bias and discrimination. Jewish-American groups remain strongly opposed to the bill, with one even calling it "tantamount to putting an even larger target on the back of every Jewish student." 70 organizations sent an opposition letter to the State Senate last week urging legislators to reject this harmful attack on the Jewish community.

Assemblyman Kevin Kiley represents the 6th Assembly District. ★


Organizations Team up for a "Pink October" Community Trapshoot

protections, was pleased by the decision, but not surprised.

“Our lobbyists did not come to us and say, ‘Hey, you know, we’re going to have to compromise somewhere or anything like that,’” said Sid Lakireddy, a board member for CalRHA. “So, I think the legislators are starting to get it as well. This can’t go on at infinity.”

The eviction protections in place state that tenants will have a defense in court should their landlord evict them over non-payment of rent through Sept. 30. They still have to submit a declaration saying they are unable to make full rent, and pay at least 25% of their monthly rent since Sept. 1, 2020, in installments or in bulk, by Sept. 30.

The protections are tied to \$5.2 billion in federal aid for rent relief. People making less than 80% of their area median income who were financially affected by COVID-19 can still apply for the full amount of missed rent and stave off eviction. They can also now apply for three months of forward rent.

But distribution of those dollars remains a problem. While the state has received applications for about \$1.9 billion in rental aid, it has distributed only about \$491 million. Still, that’s about a 500% increase since the current moratorium passed at the end of June, according to Russ Heimerich, spokesperson for the state’s Business, Consumer Services and Housing Agency.

According to a recent analysis of California’s rental debt by Policy Link,

an Oakland-based research group, about 753,000 families are behind on rent, and owe a cumulative \$2.8 billion.

“I think everybody’s hope was that more families would have received the funds by now, and that the people who didn’t apply or were denied were a minority, as opposed to an overwhelming majority,” said Francisco Dueñas, executive director of Housing Now!, a tenant advocacy group.

Existing law has some stopgaps that, in theory, should prevent the tsunami of evictions tenant advocates and researchers have predicted. Heimerich said tenants will be shielded from an eviction procedure by the courts for 15 more days to apply for their missed rent – a provision that extends through March 2022.

To take advantage of those protections, tenants will have to show evidence they applied for the rental assistance program in court, Heimerich said. He said the state agency is working closely with the Judicial Council to inform judges of the procedure.

While the stopgap might seem promising on paper, tenant advocates are leery of its application.

“The problem with relying on the courts is it requires people to go to court,” Dueñas said. “And a lot of people don’t respond to a court notice. They just move.”

# Fatality on Dry Creek Road

For unknown reasons, a male pedestrian wearing dark clothing was walking in the roadway in a dark, unlit portion of SR-65 south of the Ford. 
First responders arrived and attempted life-saving measures, but the pedestrian succumbed to his injuries and was pronounced deceased at the scene.



# Inspiring Future Leaders to Soar

## California Capital Airshow Awards Scholarships to Local Youth

**SACRAMENTO REGION, CA (MPG)** - At its annual aviation festival, the California Capital Airshow (CCA) does more than showcase thrilling performances by talented pilots – it creates an environment that highlights the way science, technology, engineering, and math (STEM) are used to create amazing achievements in aviation and aeronautics. The non-profit organization is inspiring the next generation of leaders by helping students reach for the stars and pursue exciting futures in STEM and aviation fields.

The CCA scholarship program awards scholarships to graduating high school seniors who are pursuing an education in science, technology, engineering, math, aviation, aeronautics, aerospace, or airport management. Since the program was established in 2007, a total of \$314,100 in scholarships have been awarded to aspiring youth. These funds have helped 178 students from around the region pursue their dreams at 36 different educational institutions across 14 states.

Mike Miller, CCA board member and chair of the scholarship committee, explained that “inspiring the next generation is at the heart of the CCA mission.” Helping lead the scholarship program has given him the opportunity to directly impact the lives of some amazing students, and he said, “I am always the one who ends up inspired. I am optimistic about the future because I have seen firsthand the strength of

character, intelligence, work ethic, resilience, accomplishments, dreams, and aspirations of these incredible young people. I can't wait to see what happens next!”

While all of CCA's 2021 scholarship winners are impressive and aspiring youth, four must be highlighted for the inspiring stories they shared in their application essays.

Zataro Nepomuceno showcased his spirit of determination by navigating

the college application process without any family assistance. Nepomuceno wrote that as a child, he “recognized that the core of engineering was creation.”

With a knack for hands-on work and a desire to create, he found his way to the field of robotics, which taught him skills in design, fabrication, and leadership. He hopes to become a mechanical engineer with a concentration in aviation.

Hania Arshad outlined

her goals for addressing the serious issues of climate change and pollution, writing that “our future, and our children's future, is at stake.”

She is pursuing a degree in mechanical engineering with an environmental emphasis, because “engineers develop modern solutions in order to tackle problems across dozens of fields.” Arshad wants to create innovations to reduce our carbon footprint and

target air and water pollution: “It is essential that even small steps are taken to help pave the way for a brighter future.”

Manpreet Kaur wrote about her commitment to finding a cure for her mother's disease, nonalcoholic steatohepatitis. She is pursuing a degree in biology in order to “build the foundation of chronic liver disease research focusing on patient-care and social change.” She highlighted

the importance of recognizing chronic pain at the early stages, while also developing standard treatments for life-threatening diseases. She hopes to find “breakthrough discoveries that will transform the current health-care system.”

Elizabeth Snyder aspires to work in environmental or sustainable engineering, so she can help “reverse or remedy the dangerous situations we are in due to man-made environmental damage.” Her goal is “to invent something new in the world of environmental technology or to find a way to make sustainability more appealing to large corporations and worldwide governments.” Snyder also wants to serve as an example, encouraging other young women to pursue careers in STEM fields.

The CCA scholarship program is open to seniors in Sacramento, El Dorado, Yolo, Placer, Yuba, Sutter, or Solano counties who plan to attend two- or four-year colleges or universities, or vocational or trade schools. Students must have a cumulative GPA of at least 3.5, demonstrate financial need, and be enrolled full-time for the coming semester. Scholarship awards range between \$500 and \$8,000, with preference going to students whose expected family contribution is less than \$10,000. The scholarship funds can be used for tuition, fees, and books.

wanted to see another dispensary. He pointed out this could bring in one to two million dollars to the city coffers. After the Mayor spoke, each of the Council Members had their turn to weigh in. Taking ten to fifteen minutes per speaker, each Council Member expressed their feelings about another dispensary.

In the end, when all was said and done, all the Council Members declared they were against another dispensary. For the record, nothing was approved although the matter may come up for further discussion at some unspecified later date.

Mayor Branscum once again spoke and said he would continue to do what he could to have the City provide for a third dispensary. The Mayor was the only proponent for a third dispensary.

The City Council chambers are cozy and intimate. Instead of a bank of people lined up in a row, the Council seats are pleasantly curved. Standing at the podium, one is at eye level with the Council Members. However, the wooden seats for the audience are a bit stiff. ★

# California Wildfires Ignite an Insurance Crisis

As if California needed another crisis, the state's seemingly perpetual wildfires are forcing millions of homeowners in fire-prone areas to pay skyrocketing premiums for insurance coverage – if, indeed, they can buy it at all.

As the number and severity of wildfires increase, insurers are increasingly reluctant to renew policies and even if they do, premiums often double or triple.

Insurance is required for most homeowners since their mortgage lenders demand it. And if they cannot obtain regular coverage, they are forced into the insurer of last resort, FAIR, that has very high premiums and limits on coverage.

Insurance Commissioner Ricardo Lara has repeatedly invoked a law he authored three years ago as a state legislator, imposing one-year moratoriums on policy cancellations for property in or immediately adjacent to the sites of major fires.

In 2020, Lara's moratoriums covered 2.4 million policyholders after fires scorched more than 4 million acres and consumed hundreds of homes and other buildings. When this year's fires are finally extinguished, including the immense Dixie fire and the Caldor fire that nearly wiped out South Lake Tahoe, Lara will extend the

moratoriums to their burn zones.

At best, however, such moratoriums are merely stop-gaps. So what, one might ask, are politicians doing about the crisis?

There is some scapegoating. This month, Assemblyman Marc Levine, a Democrat from fire-prone Marin County, fired off a letter to insurance trade groups, telling them, "I do not believe that the costs of utility mismanagement, or the impacts of climate change should be arbitrarily and capriciously passed through to my constituents in the form of homeowners' insurance being declined, non-renewed, or their insurance premiums being raised exorbitantly. Particularly when there has been no change of conditions or circumstances."

Circumstances are also beyond insurers' control as they assess potential losses and calculate whether to offer coverage and if so, what to charge. They cannot, as Levine seems to suggest, ignore the perils regardless of their causes.

Levine later introduced legislation that would have the state become an insurer for those unable to buy coverage elsewhere.

John Norwood, a veteran insurance industry lobbyist, set forth the dilemma in a recent article for an industry publication:

"The availability and affordability of property insurance in California are not likely to change until the worldwide reinsurance market believes California is serious about addressing its wildfire risks and there are demonstrable results in reducing the number and severity of wildfires in the state.

"Without the reinsurance

market backing California property/casualty insurance companies, there will continue to be an availability crisis in the state for property insurance and prices for such coverage will continue to increase substantially to the detriment of California's homeowners and businesses."

The initial state budget signed by Gov. Gavin Newsom appropriated \$2 billion for making the state more fire-resilient, but was criticized for spending many billions more on problems of lesser import. Last week, with big fires still burning, the wildfire budget was sharply increased before the Legislature adjourned for the year.

Reducing the likelihood of destructive fires is a good step in the right direction, but the insurance crisis demands more – perhaps, even, an entirely new approach.

The state could, for instance, purchase basic disaster insurance for every California property owner – covering earthquakes and floods, as well as fires – and pay for it through some sort of property-based assessment. Property owners could tap the private market for coverage beyond the basic policy's limits.

Through reinsurance, the risk would be spread worldwide and Californians wouldn't have to worry about scrounging for coverage. The state's voluntary earthquake insurance program already embodies that concept.

There may be other workable approaches, but without new thinking, the insurance crisis will, as Norwood warns, continue to worsen.

## Farm Bureau Advises Members to Manage Stress in Face of Drought, Severe Challenges

## Healthy Composting Helps Winegrape Growers go Organic

Winegrape growers in Napa County are crediting healthy composting measures for helping transition vineyards to organic production. Napa County ranks second to Mendocino County in total organic winegrape acreage. Organics still account for less than 10 percent of winegrape production in Napa and about one-fourth of production in Mendocino. But improvements in fertilizers are convincing more growers to transition to organics.

The California Department of Food and Agriculture is accepting proposals for a 2022 grant program to improve research, quality and production of California specialty crops and promote related collaborative agricultural projects. Awards up to \$500,000 are available for projects promoting better practices for fruits and vegetables, tree nuts and nursery crops as well as supporting research enhancing food safety and prevention of plant disease and pest infestation.

## USDA Allocates \$700 Million in Pandemic Relief for food, Farm Employees

The U.S. Department of Agriculture is allocating \$700 million to help farm and food employees impacted by COVID-19. The money is intended to help front-line grocery workers, meatpacking and farm employees recover personal and family expenses resulting from the pandemic. Those costs may include protective equipment, dependent care and expenses for quarantine or testing. ★



# What if Fake News is Not the Only Thing Fake?

This column is my 500th published column on liberty and the Constitution. I taught the Constitution and Current Events for forty years at the college level and therefore am qualified to pose the following question. "What if fake news is not the only thing that is fake?"

What if things are not as they seem, that we not only have fake news but fake history, education, science, and more? That our world is far more Orwellian than presumed.

Let's begin with a not so fake history. What if after the Civil War certain enterprising and gifted men, such as John D. Rockefeller, Andrew Carnegie, and J. P. Morgan, used the free market philosophy to gain great wealth and monopolistic power over oil, steel, railroads and banking. These men then funding the politicians that would protect their interests from "real" legislative control over their monopolies.

## October is Historically the Worse Month for Stocks

There have been many horrible stock events that have occurred in October. The Bank Panic of 1907, the Stock Market Crash of 1929 and Black Monday 1987 all occurred during Halloween month. Because the 1929 and 1987 crashes were horrific in speed and scope and therefore have been covered extensively in the history books, it is not surprising that October is thought to manifest ghosts and goblins in the stock market.

The worst month for markets historically has been (sitting down?) September.

Stocks are down more often than up in September but the differences are slight. The S&P markets have scored a positive just 45% of the time since 1945. Interestingly enough, February is the only other month with an average negative performance.

The question that arises would be is there something about the economy earlier in the year that causes the markets to pull back in the fall, or is there something going on in the investing public's mind during this particular month?

Could it be something as silly as superstitious investors correlating an upcoming Halloween month to negative stock performance the month before, or is it simply nervous traders returning from summer vacation hitting more sell than buy buttons for whatever the reason?

Cyclical reasons aside, since the difference between September and other months is so nominal, perhaps it's just an odd coincidence. More importantly, in my opinion, although historical patterns should not be ignored entirely, the state of the economy, the political environment and other macro influences should take precedent when looking for successful stock prognostications.

At this time, as investors enter into September 2021, there are many reasons to be both bullish and bearish. Not much help there I know, but this analyst holds the opinion that fear should be the slightly elevated emotion over elation. My portfolios positioning currently reflects this view.

The bullish reasons are many. The Fed is continually printing massive amounts of cash and handing it out willy-nilly to various banking entities of the world, and yes, they do hand out cash to foreign money conduits as well. Congress is also continuing its various stimulus programs and cash payments encompassing trillions of dollars for both infrastructure and individual enhancement. 6 trillion and counting is a lot of money and adding that to the monetary payments going to the various money centers of the world

makes many a reason for stocks to continue their ascent. The reopening of the economy, albeit stalled by the Delta Variant, continues to see the consumer exhibit a relentless propensity to spend money, perhaps making up for lost time during the shut downs and shut ins. Interest rates are still in the dirt at historically low levels. That's good for consumers and vendors alike.

Ignoring other considerations would make one think a rising market is a slam-dunk.

Not so fast there cowboys and cowgirls.

Negatives include stimulus could be running out of gas because of the "debt trap" (described as a situation in which a debt is difficult or impossible to repay because high interest payments prevent repayment of the principal).

Congress meanwhile is seeing increased resistance to more stimulus programs for the general populace. Afghanistan and POTUS concerns are dampening outlook, while the Delta variant is once again causing a consumer slowdown.

Non-time specific considerations includes the current "cost" of the S&P500 as measured by the 10-year P/E (price/earnings) ratio. It currently stands at **38.7**. This is an astonishing *97% above the modern-era market average of 19.6*. That puts the current P/E 2.5 standard deviations above the average.

Yikes.

Simply put the market is very expensive right now. Caveat Emptor.

As is standard operating procedure when it comes to markets, no one really knows which way the market will go.

We can say one thing for certain: we know the market will pull back at some point. The trick is knowing when. Since trying to know that is an exercise in futility, we can look back in history to hopefully catch a glimpse of the future.

We will get a trick or a treat in September?

We will definitely know in October.

The postal service's status as an independent agency frees it from the purview of the executive order. Fauci's backing of a travel vaccine mandate comes after Rep. Don Beyer (D-Va.) introduced a bill on Thursday that calls for all airline and train passengers in the U.S. to show proof of vaccination or a present negative COVID-19 test in order to travel. The legislation, dubbed the Safe Travel Act, advocates for all travelers on Amtrak and commercial airlines to be vaccinated against COVID-19 or provide a negative coronavirus test taken within 72 hours of traveling.

**Biden to Announce Even More COVID-19 Measures This Week - Surgeon General** | 12 Sept 2021 | Joe Biden will announce more COVID-19 measures before the U.N. General Assembly this week, according to U.S. Surgeon General Vivek Murthy. Speaking to CNN on Sept. 12, Murthy didn't say what new measures would be announced by Biden... 

## Chico Bike Path Shooter to be Tried as an Adult



**Butte County District Attorney Release**

**BUTTE COUNTY, CA (MPG)** - A now 18-year-old youth will be tried as an adult after a finding by the Butte County Juvenile Court that he is unfit to be tried as a juvenile. Deshawn Kelley, 18, of Chico, was charged as an adult today in Butte County Superior Court with attempted murder with great bodily injury and possession of an illegal assault weapon.

District Attorney Mike Ramsey said the charges stem from a May 13, 2020 shooting on a bike path near Rio Lindo Avenue in Chico. At approximately 5:30 p.m. that day, Chico Police dispatchers received numerous 911 calls regarding gunshots in the area. A nearby officer arrived in under one minute and found a 23-year-old male severely wounded on the bike path with numerous gunshot

wounds.

The male victim was transported to Enloe Hospital with life-threatening injuries involving no less than seven gunshot wounds. The victim survived the shooting despite the extensive injuries he suffered. After a month in the ICU and multiple surgeries, the victim was discharged from the hospital and began a lengthy recovery process that continues to today.

Ramsey said an extensive investigation ensued and through surveillance videos, witness statements, and phone records, officers identified Deshawn Kelley, who was 17 at the time, as the shooter. Chico police detectives determined that Kelley went to the bike path with a semi-auto pistol that day to confront a high school classmate. However as Kelley was walking down the bike path, he heard a bicyclist coming from behind. Kelley hid in bushes at the side of the path and waited until the 23-year-old male was approximately three to five feet away. Kelley then jumped out of the bushes and unloaded the entire magazine of his gun at the victim. The victim told detectives that Kelley

did not say anything to him before the unprovoked shooting. The investigation determined Kelley and the victim did not know each other and there was no motive for the shooting.

Detectives later learned that Kelley fled to Southern California after the shooting. On June 17, 2020, Chico Police located and arrested Deshawn Kelley, who had an AR-15 assault rifle in his possession.

Ramsey said his office filed charges in the juvenile court and petitioned that court to have Kelley tried as an adult due to the egregiousness of the crime. After an extensive review over several months of the evidence in the case as well as Kelley's criminal and social background and psychologists' reports, the juvenile court judge agreed last Wednesday that Kelley should be tried as an adult. The judge ordered Kelley to be transferred from the Butte County Juvenile Hall, where he had been detained since his arrest, to the Butte County Jail.

Kelley was arraigned in court this afternoon. Further arraignment and entry of plea are scheduled for September 15. Kelley will remain in custody with bail set at \$1,565,000. ★

## North Yuba Water District Fall 2021 Summary

It is September and it's time to do a summary of what has been going on with the North Yuba Water District in the Foothills of Yuba County.

Back in 2017, the water district received a \$500K grant from the State to develop the engineering plans to pipe ten miles of the Forbestown Ditch constructed in the time of Lincoln. The first question, how big to make the pipe? The answer, it would be designed to handle 24 CFS or to convey 3,700 AF a year. Yuba Water Agency Director Randy Fletcher knew all about it and made sure the Agency provide \$35K to help the water district get started.

Director Fletcher knew the water district had permits for 23,700 AF and this pipe, by design, would only be big enough to handle 3,700 AF. He also knew the 20,000 AF, that could not fit down the pipe, was worth millions.

All was going to plan with an expected completion date in late 2019. Then something unexpected happens. Long time North Yuba Water District Director Donnie Ferguson lost his re-election bid in November of 2018.

His seat was won by someone with a scientific background that happen to know all about streams and small bodies of water. Soon after this Director takes office, she asks to see the engineering plans for the Forbestown Ditch piping project.

The General Manager Jeff Maupin panicked. He knew if this Director saw the plans it would be obvious that only a fraction of the water permitted to the water district could go down the pipe. The question would immediately arise, what's going to happen to the water that cannot fit down the pipe?

He refused to provide the documents even as he would provide these plans at meetings with the Yuba Water Agency staff. Director Fletcher was following all this closely. What General Manager nor Fletcher counted on was that this person would find an experienced attorney who relished suing public agencies that did not follow disclosure rules. The Director filed a lawsuit against her own District. How often does that happen?

After eighteen months of legal wrangling, while the District did everything it could to avoid judgment, judgment day finally arrived. A Yuba County Superior Court Judge ruled that the General Manager must turn over the documents forthwith. Facing contempt of court, Manager Maupin complied. Having lost, the District then became liable for the plaintiff's legal costs. This, along with the District's legal costs, amounted to about \$100K.

Meanwhile, in March of 2020, another lawsuit was filed against the water district. This lawsuit challenged the piping project by making the case that, as demanded by the California Environmental Quality Act (CEQA), a full environmental review along with the required mitigations, would make the project financially infeasible.

Nevertheless, in June of 2020, the District filed a Mitigated Negative Declaration. In August, realizing the MND would not withstand legal challenges, the water district withdrew the filing. Rarely does this happen.

In June of 2020, the North Yuba Water District made a special presentation

to the Yuba Water Agency about its Forbestown Ditch piping project. At this meeting, the Yuba Water Agency pledged to provide a grant for 60% of the project's estimated \$12 million costs. Director Fletcher was instrumental in procuring the Agency's grant funding promise.

It's now January 2021. The Yuba Water Agency must elect a new chair for the year. There are several new board members so it's a different board. As planned, Director Hastey nominated Director Fletcher for the position. But hark! What is this? Director Mathews then nominates Andy Vasquez for the coveted chair position. The startled clerk of the board comments that, in all of his experience at the Agency, never had there been two concurrent contenders for the chairperson. Director Vasquez won. Fletcher was instantly marginalized, he no longer had the power he once enjoyed.

This was also curtains for any financial support from the Yuba Water Agency for Manager Maupin's piping project. The Agency wanted nothing to do with this ill-conceived restrictive piping project.

What's a General Manager to do? Having no possibility of funding from the Yuba Water Agency and with other sources of funding drying up due to all the lawsuits, Manager Maupin had no choice but to try and sell the district's 20,000 AF of water to the highest bidder he could find downstream.

With the assistance of some unnamed intermediary, a representative from the consulting firm Provost & Pritchard happens to call up Manager Maupin and offer to help him find markets for the District's water. Under the ticker NQH20, 20,000 AF is trading for \$900 an acre-foot making this block of water worth \$18 million. They always say, follow the money and the money leads to Randy Fletcher.

The only problem is the District can only provide its water for beneficial use which means for domestic and irrigation users within the District's service area. To sell water outside of these boundaries, it would have to renegotiate the water permits with the California Department of Water Resources. To make the case to DWR to change the permits, the District will have to show it cannot provide this 20,000 AF for beneficial use to its customers. No problem, that little detail will be taken care of by the undersized pipe that cannot carry the 20,000 AF.

Except the piping project can't happen without the environmental documentation which will show this restrictive pipe is financially infeasible. Is the District caught in one of those Catch 22's?

Director Fletcher is furious, okay very upset, with all the lawsuits against the District, six at last count. He knows these lawsuits are an existential threat to the undersized pipe and his grab for the 20,000 AF. Wouldn't you be annoyed if your carefully laid out plans to line your pockets with this water were going down the tubes? Fletcher's entwinement with the North Yuba Water District is defining his legacy.

This is the situation the North Yuba Water District finds itself in as it contemplates who it will choose to appoint to the recently vacated Division 4 seat.

## Renewed Tax Credit Can Help Employers Hire Workers

### IRS Special Announcement

WASHINGTON - With many businesses facing a tight job market, the Internal Revenue Service reminds employers to check out a valuable tax credit available to them for hiring long-term unemployment recipients and other groups of workers facing significant barriers to employment.

During National Small Business Week, the IRS is highlighting tax benefits and resources designed to help new and existing small businesses. For any business now hiring, the Work Opportunity Tax Credit (WOTC) may help.

Legislation enacted in December extended the WOTC through the end of 2025. This long-standing tax benefit encourages employers to hire workers certified as members of any of ten targeted groups facing barriers to employment. With millions of Americans out of work at one time or another since the pandemic began, the IRS noted that one of these targeted groups is long-term unemployment recipients who have been unemployed for at least 27 consecutive weeks and have received state or federal unemployment benefits during part or all of that time.

The other groups include certain veterans and recipients of various kinds of public assistance, among others. Specifically, the 10 groups are: Temporary Assistance for Needy Families (TANF) recipients, Unemployed veterans, including disabled veterans, Formerly incarcerated individuals, Designated community residents living in Empowerment Zones or Rural Renewal Counties, Vocational rehabilitation referrals, Summer youth employees living in Empowerment Zones, Supplemental Nutrition Assistance Program (SNAP) recipients, Supplemental Security Income

(SSI) recipients, Long-term family assistance recipients, Long-term unemployment recipients.

To qualify for the credit, an employer must first request certification by submitting IRS Form 8850, Pre-screening Notice and Certification Request for the Work Opportunity Credit, to their state workforce agency (SWA). Do not submit this form to the IRS.

Normally, Form 8850 must be submitted to the SWA within 28 days after the eligible worker begins work. But under a special relief provision, a Nov. 8, 2021, submission deadline applies to two groups of new hires – qualified summer youth employees living in Empowerment Zones and designated community residents living in Empowerment Zones.

To qualify for the Nov. 8 submission deadline, eligible employees must start work on or after Jan. 1, 2021, and before Oct. 9, 2021. Other requirements and further details can be found in Notice 2021-43 and the instructions (.pdf) to Form 8850.

Eligible businesses claim the WOTC on their federal income tax return. It is generally based on wages paid to eligible workers during the first year of employment.

The credit is first figured on Form 5884, Work Opportunity Credit, and then is claimed on Form 3800, General Business Credit.

Though the credit is not available to tax-exempt organizations for most groups of new hires, a special rule allows them to claim the WOTC for hiring qualified veterans. These organizations claim the credit against payroll taxes on Form 5884-C, Work Opportunity Credit for Qualified Tax Exempt Organizations.
