## The Recall is Here

Two weeks before voters decide whether to remove Gov. Gavin Newsom, a second round of stimulus payments is landing in the bank accounts of Californians who make less than \$75,000 per year with one glaring carve-out.

To get the money, you must have earned income last year - for example, from work, interest, rental income or private pensions - and filed tax returns. That excludes potentially hundreds of thousands of low-income retirees, veterans and disabled Californians who receive government benefits and do not work.

They live on fixed incomes - and they're asking why they were left out. Nearly 700 people have signed a petition to urge Newsom to send the benefit to people on Social Security Disability Insurance. More than 60 elderly and disabled readers have contacted CalMatters to express their frustration. In interviews and emails, 13 of them said that being left out of the Golden State Stimulus has caused them to doubt Newsom's leadership, if they didn't already.

"I'm very upset at him for that," said Chris Cummins, 64, who rents a house in Martinez with her daughter and three of her grandchildren. She said she lives on \$1,197 a month in disability benefits and \$395 in widow's insurance. Usually a Democrat, Cummins has lost faith in Newsom. Unconvinced by his opponents, she's considering not voting at all in the Sept. 14 recall election.

## **Yuba Water Provides** \$15,000 to **CCSD** for **Improved** Reliability

MARYSVILLE, CA (MPG) - The Yuba Water Agency Board of Directors approved a \$15,000 grant for the Camptonville Community Services District to help them seek additional financial and technical support to ensure the community is better able to handle drought.

Camptonville will use the grant to prepare a drought relief funding application through the California Department of Water Resources' Small Community Drought Relief Program.

During drought conditions, Camptonville's surface and groundwater supply falls below the amount needed for basic community services. The district's users, which includes the Camptonville Fire Department, voluntarily reduced their average water usage by 66 percent in recent weeks to conserve their limited supply.

The community's surface water source is already drying up and may soon be unable to supply water, which poses a threat to the health and well-being of the area's residents, as well as to public safety.


"The Camptonville Community Service District's water supply is just able to keep up with the demand of the public and local fire department, but the surface water is drying up and may soon be unable to meet the community's needs," said Yuba Water Agency Director Randy Fletcher. "This funding will help the district get their application in in a timely manner, in hopes of getting assistance from the state to secure a more reliable water supply."

DWR's SmallCommunity Drought Relief Program provides immediate and near-term financial and technical support to help small communities impacted by drought.

The grant funding will allow the district to contract Bennett Engineering Services to complete the grant application, which includes preparation and procurement of organizational, financial and legal information and the development of a project proposal.

## **Chico Man Arrested/Arraigned** on Child Molest Charges

BUTTE COUNTY, CA (MPG) - A 32-yearold Chico man was arraigned on multiple child molest charges this afternoon in Butte County Superior Court. His arraignment was continued to Wednesday morning for entry of a plea and appearance of counsel.

Adrian Fuller, 32, of Chico, was arrested last Friday, August 27, 2021, by investigators from the Butte County District Attorney's Office with the assistance of the Butte County Sheriff's Office. District Attorney Mike Ramsey said the arrest of Fuller was the culmination of a nearly two-year investigation, which alleged Fuller molested the 13-yearold daughter of a former girlfriend with whom he lived in 2019.

Ramsey said his investigators were initially alerted to the situation when the teenager disclosed the alleged molests to a friend. The friend then told a school counselor, who reported to the authorities. The girl's mother was then alerted, and the mother and child immediately left Fuller and then the state. Ramsey said investigators ensured the child was safe and no other children were at risk. The complex investigation depended on not only gaining the trust of the child to fill in details of the alleged molests, but also forensic evidence to corroborate her allegations.

Ramsey said Fuller is facing multiple counts of felony child molest and faces up to 36 years in state prison. He is being held in Butte County Jail in lieu of \$790,000 bail.

21-05 on August 10, 2021. Ben Taylor arrived in Grass Valley in September of 1849 and, besides his home place, is most known for road building. He and his partners built the Grass Valley and Illinoistown Turnpike that mostly follows today's Dog Bar Road. The

Bear River crossing is called Taylor's Crossing to this day.

Originally, Mr. Taylor settled in what is now known as the Peardale area. He named his property Buena Vista Ranch after a famous battle in the Mexican American War to which he was a veteran. Ben Taylor found he much preferred farming and horse breeding on the ranch rather than mining. As he and his wife Esther E. Huling's family grew he began to build the home place.

The Carpenter Gothic home was built in 1865-1866. Originally, the property stretched from West Main Street to Ridge Road and from Peabody Creek to Alta Street in Grass Valley.

The home place was created as a family home and has since been handed down to children, grandchildren, and cousins. The property was subdivided over the years, but the plot the home sits on has never left the family. The beautiful home with its dovetailed timbers and original artisan wells still stands proudly on Linden Street.

The purpose of the Nevada County Historical Landmarks Commission is to promote the general welfare of Nevada County and its citizens through official recognition, recording, marking, preserving, and promoting the historical resources of Nevada County.

## **U.S. Army Troops to Support** NIFC in Wildfire Response

U.S. Army North (Fifth Army) News Release

SAN ANTONIO, TEXAS (MPG) - At the request of the National Interagency Fire Center, approximately 200 U.S. Army Soldiers will support a wildland fire ground response operation in Northern California. U.S. Army North (Fifth Army), U.S. Northern Command's Joint Force Land Component Command, will provide operational command of the active-duty military ground forces in support of federal and state efforts.

"This request marks the fortieth time federal military ground forces have been mobilized to support wildland firefighting response efforts in a decades-long interagency agreement," said Lt. Gen. Laura J. Richardson, ARNORTH and JFLCC commander. "We had a very active fire season last year, employing ground forces from both the Army and Marine Corps in California, and are proud to once again support NIFC and the state."

The supporting units, the 23rd Brigade Engineer Battalion and the 2-3 Infantry Battalion, both from the 1-2 Stryker Brigade Combat Team, 7th Infantry Division, I Corps, assigned to Joint Base Lewis-McChord

(JBLM), Washington, will assist with wildland fire response efforts on the Dixie Fire in the Lassen National Forest, Lassen Volcanic National Park and Plumas National Forest.

Beginning Monday, Aug. 30 at JBLM, the Soldiers will be outfitted with wildland fire personal protective equipment

during NIFC-led training, which will cover the basics of wildland fire suppression and firefighter safety. Upon completion of training at JBLM, the Soldiers will deploy to Northern California to conduct additional fireline training prior to serving as hand crews assisting with wildfire suppression on the Dixie Fire.

"The rigorous training and certification process our Soldiers undergo, prior to operating in a firefighting environment, will ensure that once deployed, they will safely augment federal wildland fire fighting capabilities in order to protect lives, natural and cultural resources, and property," said Maj. Gen. Xavier T. Brunson, I Corps and JBLM commander.

While providing support, the Soldiers will be accompanied by experienced wildland fire strike team leaders and crew bosses.

The JFLCC, through USNORTHCOM, is the primary Department of Defense organization for coordinating defense support of civil authorities to help federal partners, like NIFC, respond to natural or man-made disasters.

In addition to the U.S. Army activation, eight U.S. Air Force C-130s equipped with Modular Airborne Fire Fighting Systems are currently fighting fires from the air, providing wildfire support across Western states.

# **Wildfire Solutions**

Revives Cancelled Legislative Hearing on the Capitol Steps

SACRAMENTO, CA (MPG) - In response to the cancellation of the only scheduled legislative hearing on wildfires, Assemblyman James Gallagher (R-Yuba City) joined other lawmakers in fire prone districts to host their own wildfire forum on the steps of the State Capitol. The event, titled Wildfires & Climate: Finding A Better Path Forward, was intended to identify barriers and solutions to preventing catastrophic wildfires.

"The political establishment in Sacramento has put this off for far too long," said Gallagher. "Committees have refused to even hear bills on wildfire and most recently, oversight hearings on the topic have been cancelled. We should not and cannot wait any longer.

Gallagher was joined by Senator Jim Nielsen (R-Tehama) and members of the Assembly Working Group. The forum appropriation.

featured testimony from eight expert witnesses, including five panelists from the North State.

The lawmakers highlighted several solutions they are pushing for, including:

Allocating \$500 million from the General Fund for Fire Prevention and Forest Health Grants; Exempting wildfire mitigation projects from the California Environmental Quality Act (CEQA); Extending the Greenhouse Gas Reduction Fund commitment in SB 901 through 2028-29 with Republican Wildfire a \$200 million a continuous

"I'm not the type to give up or give in. Clearly the status quo on wildfires is not working," said Gallagher. "These cataclysmic fires are burning down communities, taking lives and livelihoods, obliterating California's climate reduction goals, and destroying critical habitats. I will not allow the Legislature to bury their heads in the sand in denial. We will keep pushing until we get results.'

MARYSVILLE, CA (MPG) - Yuba-Sutter Transit is excited to announce that it is extending the fare-free service for those traveling to or from COVID-19 vaccination appointments through December 31, 2021. This offer, which is being provided in cooperation with the Yuba and Sutter County Public Health Departments, is available on all services operated by Yuba-Sutter Transit, including Dial-A-Ride, but all service eligibility requirements still apply.

To ride free of charge, when boarding the bus passengers must present valid confirmation of their appointment that day at any COVID-19 vaccination site in Yuba or Sutter Counties. Confirmation may be in the form of an appointment card, email, or text with the passenger's name and appointment information (date, time, and

location). The driver will acknowledge that the confirmation meets the requirement and that the passenger may continue

## A Morning Like No Other - Ground Zero at 20 Years

After a long night of late work well into the morning, I was in a deep sleep. The repeating ring of the telephone wakened me. I received an alarming telephone call from a close friend frantically trying to get my attention. She said "just get up and turn on the TV. You won't believe what is happening". She was absolutely right.

white leather couch in my small rental home in Roseville, tuned in as the world was tuned it, to the disaster in New York as it unfolded live for everyone to see. We were all New Yorkers that day.

I had previously lived in Manhattan. After returning to California, I traveled to New York City often to teach classes at The Learning Exchange and spiritual training centers as a part of my ministry. I also met with many clients as a spiritual life coach each visit. Through these visits I became friends with so many great people who lived in The City. I stayed at their homes, got to know their families, learned about their lives, loves, and fears. Many of them worked in the immediate area of the Twin Towers.

As I sat there watching the towers fall along with the rest of the world, I had no idea if any of those friends or members of their families were being crushed under the weight of that destruction. It was a personal anguish and horror felt by millions simultaneously. It was a grief embedded forever. And we as a nation vowed

to never forget. Everything changed for everyone during those hours. Terrorism had come to our shores, and those whom we had charged to protect us failed miserably. We have been paying for their failures ever since.

And for those who paid the ultimate price, giving their lives to save others inside and around the Twin Towers? And for all the First Responders who witnessed the death and destruction at the end of

their fingertips and right before their own eyes? What did they get from so many after only 20 years? Many forgot.

Our time is limited. We are here to understand life, liberty, love, and loss. We are here to understand joy the web that builds our evolution, our DNA that we pass on to those who follow us. If we do not teach our emotional history to our children, good and bad, they will suffer repeating our mistakes and the feeling of betrayal from us for not forewarning them.

Neon Nation. Have we lost our way in one generation? Does the "Shiny thing" distract us so easily because it is too hard for us to focus on the truth and explaining it to others

as our society crumbles

I thank God to this day that not one of my friends was on that list.


The history of Ground Enter our current day Zero is complex and still unfolding. The more the years fall away the more important it is that we reveal as much as we can about that fateful morning and all that led up to it.

When someone kills

your son or daughter, husband or wife, it doesn't matter what political party they belong to. It doesn't matter what religion they belong to. It doesn't matter their motive. All that matters is your loved one is gone forever. Grief takes over. And no one can ever really fill that void. It never truly heals. You just learn how to manage it in the silent times, alone with your Creator.

## Some 14,000 Nurses Reach Tentative **Agreement with Dignity Health**

OAKLAND, CA (MPG) -Registered nurses at Dignity Health facilities reached a tentative agreement on a four-year contract, announced California Nurses Association (CNA) and National Nurses Organizing Committee (NNOC). The agreement covers more than 14,000 RN members in California and Nevada, represented by CNA/NNOC.

The tentative agreement features stronger infectious disease prevention measures for nurses and patients. "As we face yet another surge of Covid-19 patients filling up our hospitals, we are proud to have achieved additional health and safety protections for our RNs and patients," said CNA/NNOC President Sandy Reding, RN negotiator.

Over the next few weeks, more than 14,0000 RN and Nevada will vote on the tentative agreement that includes greater economic security and health care

benefits to improve staff- The agreement includes a ing. "We are hopeful that with the greater economic and health care gains we can recruit new nurses and retain experienced RNs to better protect our patients' safety," said Kathy Dennis, RN negotiator and CNA board member.

Agreement highlights include:

Health and safety provisions to ensure nurses get the highest level of personal protective equipment, including when caring for patients suspected of having Covid. Nurse participation in the Pandemic Task Force;

Comprehensive workplace violence prevention language which involves the union's input and recommendations:

Investment in education: Increased tuition reimbursement for education so nurses can continue expanding their knowledge and skills;

Economic gains and members across California health benefit provisions to help retain and recruit experienced nurses, including no takeaways for pensions or retiree health.

13.5 percent wage increase over four years;

Equity and inclusion provisions, including agreement to fight racial injustice and health care disparities within the community, a commitment to a workplace free from racism and unlawful discrimination, and expanding implicit and unconscious bias training;

Shared vision on health care: Dignity Health agrees with the union that health care is a human right and that everyone should have access to quality health care; that we must end racial and ethnic disparities in healthcare outcomes, promote the delivery of culturally competent care and the diversity of our health care work force: and have a commitment to the community.

#### California Farm Bureau Backs **Upgrades To Critical Canals**

Farmers and ranchers are working with lawmakers in hopes of passing legislation to fund repairs and upgrades to California's water conveyance system. Senate Bill 559, from Democratic Sen. Melissa Hurtado of Sanger, would pay for more than \$300 million in repairs on the Friant-Kern Canal, the California Aqueduct and the Delta-Mendota Canal in the Central Valley. The California Farm Bureau supports the improvements.

#### Raging Timberland Fires Renew Calls For Better Forest Management

Calls for improved forest management approaches are echoing again as devastating fires rage in California timberlands, even burning into the Tahoe Valley. Licensed timber operator Mike Albrecht in Tuolumne County encourages forest thinning efforts that won't repeat mistakes of the past. For years, rather than thinning forests, California thinned out sawmills and biomass plants – removing useful forestry infrastructure.

#### California Plums Get Improved Market Access to Japan

Export rules have been streamlined to help more California plums reach buyers in Japan. Caroline Stringer of the California Fresh Fruit Association says multiple rounds of negotiations have refined protocols for fruit entering the Japanese market. While she doesn't expect an export spike this year, she said the new rules will expand market opportunities over time. The California plum harvest wraps up in October.

#### Agricultural Exports Surging in 2021 and 2022 Looks Bright

U.S. agricultural exports for 2021 are running nearly one-fourth higher than last year, based on forecasts through August. And an even better export economy is forecast for 2022. According to the U.S. Department of Agriculture, 2021 farm exports are expected to total \$173.5 billion for the fiscal year. That figure is expected to increase by another 4 billion in 2022. Rising soybean and corn shipments to China are a key factor.

## **California Housing Plans Need an Overhaul**

For more than a half-century, California has been trying to nudge county and city governments into generating enough new housing to handle an everincreasing demand.

The state's chief tool has been a legal requirement that local government "general plans" include an adequate "housing element." Every eight years, the state Department of Housing and Community Development issues regional quotas of housing needs which then are divvied up into specific city-by-city goals for zoning enough land to meet projected needs.

The allocations are very controversial, especially in suburban communities, because they run counter to the not-in-mybackyard sentiments of local residents. As housing production falls chronically short of the state's goals, the cyclic quotas steadily increase and in recent years the state has added penalties for failure.

Obviously, the quota system hasn't been working very well and researchers at UCLA's Lewis Center for Regional Policy Studies have concluded that it has a "fundamental

to meet the quotas is only rarely used for housing. Rather, the housing being built – which is still too little - tends to go on other property, including some previously being used for other purposes.

The study focused on what has happened in the San Francisco Bay Area vis-à-vis the housing quotas issued in the last decade for the eight-year period that will end next year.

"The median Bay Area city is on track to approve housing projects on less than 10% of the sites listed in its housing plan," the study found. "On average, however, cities are achieving a substantial portion of their (too low) housing targets - nearly 60% for the median city - just not on the sites they had selected and presented to the state as likely or apt for development. Across the Bay Area as whole, nearly 70% of housing built during this period was on sites not listed in housing plans."

While cities zone specific sites to meet quotas, "housing development occurs in a way that is hard to anticipate. In spite of planners' efforts to select imminently viable sites, they do not."

The solution, they say, is to create a more realistic set of requirements that identifies all potential sites for housing, a "change (that) may require cities to include many more sites in their housing plan."

While a more realistic inventory might require more work - and possibly UCLA team also proposes that "cities receive preflaw" because vacant land emptive credit for housing

being zoned for housing they expect to be built on sites not listed in their plan.

> "The credit would be tied to production on noninventory sites during the previous period, giving cities an incentive to accommodate muchneeded development when it is proposed, even if they can't anticipate exactly where or what developers will want to build."

> "The Legislature should stop proliferating ever more detailed requirements for a site to be included in the inventory, and instead require cities to consider every parcel on which residential use is allowed," the UCLA team suggests. "Since cities aren't very good at picking the sites where developers want to build, the focus should shift to estimating how much housing is likely to be built during the planning period on the entire stock of residentially zoned land in a city.

This is wonky stuff, but important because of the state's worsening housing shortage. The proposals would shift the housing quotas from an exercise in paper-shuffling into something more likely to produce real results. But implementing it would require an official admission that the current system isn't working and a willingness to correct its "fundamental flaw."



## My Thoughts on Afghanistan

Throughout the last few weeks, I have watched Afghanistan descend into disarray with sadness, embarrassment, and anger. It truly did not have to turn out like this. As the last of our troops were flown out of Afghanistan, I felt the need to share my thoughts with you all on this tragic situation and stain on our international reputation.

Since early July, the United States has been pulling troops out from various posts throughout Afghanistan in an attempt to meet an August 31st deadline. By early August, the Taliban was making rapid gains across the country, culminating in their uncontested capture of Kabul on August 15th. The very next day, Commander in Chief. claimed he had made the right decision and solely the chaos.

Although the Biden Administration had intelligence indicating a strong possibility that the Taliban could quickly regain significant portions of the country, it continued to pull American troops and failed to create a plan to assist Americans or our Afghan allies in evacusafely and efficiently. We could have, in an orderly and more sensible fashion, withdrawn personnel that kept the most vulnerable secure. While providing close air support to our Afghan allies, we could have shown them that we would continue to support them in their effort to hold off the Taliban. A sane plan would have evacuated all American civilians and identified Afghan allies before we pulled back militarily. Instead, American citizens, women and children included, were beaten by the Taliban at checkpoints as they attempted sneak to the airport in hopes of being rescued. Many

### Inflation has been called the Stealth Tax

Inflation has been called the stealth tax, as family that sees a 5% increase in prices due few people realize inflation is a form of tax, and that it enriches the wealthy as it impoverishes the lower income strata.

How this transfer takes place is easily explained.

Imagine I fill a room with 100 people and I lock the door. I give each person \$1,000.00, then offer up a \$5,000.00 Rolex watch to the highest bidder. The only rule is two people cannot combine funds. Since the watch (or whatever it is I offer to sell) has a higher value then the cash each person holds, the assumption is everyone will want to buy

Since each person only has \$1,000.00 and cannot combine funds with another, the top bid would be \$1,000,00

Before I close the deal, I now I hand out \$1,000.00 more to each person.

The top bid would immediately rise to the maximum each person has which is now \$2,000.00.

We have just witnessed "monetary" inflation which was inflation caused by an increase in the money supply when I passed out more money. The price of the watch doubled because more money was introduced into the system (the room).

Extrapolating, when more money is introduced into an economy, the prices of things rise as each person has more money to spend. This is monetary inflation.

Since the only entity allowed to manufacture more money is the government (in the case of the U.S. it is the Federal Reserve Bank), they alone are the cause of monetary

The transfer of wealth to the rich from the rest of the populace is accomplished by the inflation that is caused by the introduction of new money through government deficit spending.

Since the Federal Reserve creates money through the push of a button, at the instant the money is created, it goes into government coffers, which is then spent. An important note is that the first entity to spend this new money sees no increase in prices as the money is not in the system yet. Prices only start to rise as the money filters out to the rest of us. One could argue that not only does the government get free money from the Federal Reserve's money creation ability, they are not the victim of the inflation they are

to this newly created money. Their standard of living goes down because prices of the things they need goes up. Living hand to mouth as many do, this 5% price increase places undue hardship on the lowest income

But because inflation increases the price of everything, those that own assets see those assets rise in value by the same percentage.

So if person owns 100 million in assets (like businesses, stock or real estate), they see a 5% rise in the value of these assets. In this example, a 5% inflation rate pencils out to an increase of 5 million. (5% of 100 million). The more assets that are owned, the more money is made. It is this rise in asset prices (inflation) that continually increases the wealth of the rich while steadily impoverishing the poor. The longer inflation runs, the more the rich get richer and the poor get

Because a majority of families do not own assets and spend all their money on living expenses, they are hurt by inflation, while those that own assets profit from it.

The stealthy part of inflation is that it also causes salaries to rise, increases home values and retirement accounts. This increase gives the illusion that things are improving. Nothing could be farther from the truth. Because wages never keep up with the overall price increases in the economy (called wage/price lag) people are left wondering why they find it harder to make ends meet despite rising salaries, retirement balances and home values.

In conclusion, the more cash governments hand out, the worse it gets for the lower classes and the more the wealthy profit. This wealth migration consistently drives more people into poverty as it concentrates more and more of the wealth at the top in the hands of the few. In essence, the loss of wealth from the poor is transferred to the rich.

Next time you see more government handouts, bailouts or stimulus payments, realize that the more money they spend, the worse the situation becomes for the majority





## Unintended Consequences The Recall is Here



#### Commentary by Bruce Lee

Driving by a local Chick-fil-A recently, I was surprised to see their largest sign (30 feet in the air) proclaim \$17 per hour as their starting wage! The restaurant's premium ad space was not directed to customers, but to potential employees! Wow, that's \$4 an hour over the \$13 minimum wage if 25 employees or less (\$14 if over 25 employees). \$35,000 a year for unskilled labor – that's more than some teachers make. I don't think the Chick-fil-A prices have increased much, so this small business's bottom line is being squeezed.

At a local Denny's, I called to reserve a table and was told that they close at 5pm because they had no employees! What? Yes, the manager advised. "We need 30 employees, but only have ten. We can't find anybody to work."

I related the Denny's experience to a friend, who said, "It serves them right. These big corporations don't pay a livable wage to workers to risk their life with Covid!" I explained that this Denny's is a franchise (a small business owner who I know) and Covid barely impacts younger, healthy people.

Clearly, the lack of employees has become a big thing for many businesses! Remember Costco food samples by Club Demonstration Services

Costco visits! They stopped with Covid, but they're back, in limited number. A CDS employee advised that they need 25 servers at Folsom, but could only find five, and one of those drives 36 miles from Jackson -

one way! Kathrin Grosse, a German immigrant, started Kathrin's Biergarten in Rocklin in 2017, says the employee shortage for she (and vendors she depends on) is extremely stressful – working herself and family to death while not knowing what business hours she can keep open due to staffing. "Soon people will not know how to work anymore and feel entitled. And, when I'm closed, it hurts my people who want to work!"

Here's the thing, basic unemployment is about \$400 per week (it ranges \$40-\$450), and the Federal Pandemic Unemployment Compensation (FPUC) provides \$300 weekly. That's \$700/week, \$2,800 a month, or \$36,400 a year!

A manager of a Tahoe breakfast restaurant was blunt: "Not everyone wants to come back to work. If you work, you make \$3,000 to \$3,500 plus a little extra tip income. But, if I can make \$2,800 a month, why bust my ass, I'll stay home!"

The lesson is that government interference with the economy is a delicate balance (from "laissez-faire" to "command and control") and almost always creates "unintended consequences." Working years in the Governor's Finance, I was briefed on these matters. For example, Proposition 13 reformed

(CDS)? A highlight of my extension ends Labor Day, but it could be extended to 2022 (per rumors as of this column submission).

> Government tends, with the best of intentions, to bumble along. Nobody thought the FPUC payments would stifle employment by creating a worker dependency upon government money - disincentivizing employment. Politicians were being "nice." But the "politics of niceness," as I call it, creates problems. Bureaucrats who live thousands of miles away cannot predict all consequences. And, their "one shoe fits all" approach seldom works well.

> Hence, decentralized decision making is usually the best approach. Local decision makers are in-tune with local circumstances. And, better yet, the most decentralized process is to provide reliable information to citizens and let them make the best choices for themselves! In this way, we have liberty, as well as healthy decision making.

Decentralized government to practical extent is an important protection of our unalienable rights. This is the sixth principle in my list of founding principles of our America. This is why Thomas Jefferson wrote in 1811, "(T)he true barriers (defensive walls) of our liberty in this country are our state governments ..."

So were elderly, blind and disabled people who receive Supplemental Security Income. But recipients of other disability benefits, including Social Security Disability Insurance, were not included.

In May, with California overflowing in tax revenue from its wealthiest residents and federal relief dollars, Newsom proposed sending the payments to California's middle class, too. Lawmakers approved the plan in late June.

Under the expansion, taxpayers earning as much as \$75,000 a year qualify for a \$600 payment. Families with at least one dependent get a \$500 boost, which increases to \$1,000 if they are undocumented and file taxes.

However, the state delayed clarifying what kinds of income made people eligible for the stimulus, confusing many Californians on fixed incomes.

Only in late July did the state tax agency update its webpage to clarify that income from various public assistance programs Social Security, disability insurance and veterans disability benefits — didn't count.

When asked in June why those receiving disability payments were not automatically made eligible, Newsom's administration cited logistical challenges. California maintains an up-to-date list of residents who get Supplemental Security Income, but doesn't have access to the same information for Social Security Disability

A spokesperson in Newsom's office pointed out in an email that several forms of income besides wages from work could make people eligible, but sidestepped questions about why people whose only income comes from Social Security or disability benefits can't qualify for the stimulus payment.

How many Californians could that be? California is home to about 673,000 people who receive Social Security Disability Insurance, but not Supplemental Security Income, according to the Social Security Agency. National research shows that fewer than one in five recipients work during a typical year, so the vast majority didn't qualify for the stimulus. About 4.6 million Californians receive Social Security retirement income, but it's unclear how many have no other forms of income, and thus wouldn't qualify. National research shows that about 40% of all retired adults rely solely on Social Security retirement income. About 355,000 veterans in California received disability compensation in 2015, but it's unclear how many have no other forms of income.

It's a large group of potential voters, but it's difficult to predict how much they could sway the recall. Low-income voters and older voters both tend to lean blue in Berkeley Institute for Government Studies. nomic survival in California.

However, poor voters are less likely to cast ballots, while older voters consistently have the highest voter turnout rates.

No statewide polls have zeroed in on low-income older voters, or asked people whether they have disabilities or are veterans. National studies show that both groups vote less often than the general population and veterans tend to vote Republican.

Newsom has explained that he gave extra help to undocumented workers because they have been excluded from federal stimulus checks, as well as unemployment benefits if they lost work during the pandemic.

"When the federal government was not able to provide those supports, the state of California will step in to do what we can," Newsom said in May, while announcing his spending plan.

But Newsom's top challenger in the polls, Republican radio host Larry Elder, quickly pounced.

"Illegal aliens qualify for the Golden State Stimulus but Californians on Social Security disability benefits do not," Elder said in a statement. "It makes zero sense, but this is one of the many failures of Gavin Newsom."

Though Elder said he sympathized "with those left out," he wouldn't expand the stimulus to include them. Instead, he said he'd make California more affordable by cutting taxes and regulation.

Republican recall candidate Kevin Faulconer, a former mayor of San Diego, called Newsom's exclusion of people with disabilities "unfair." He said he'd address the cost of living for people on fixed incomes by making retirement benefits for veterans tax-free.

John Cox, a former small business owner, did not respond to requests for comment, but previously criticized the stimulus as an effort by Newsom "to avoid being recalled."

Kevin Kiley, a Republican Assemblymember from Rocklin, has characterized the stimulus payments as part of the "playbook of corrupt regimes." Republican recall candidate Caitlyn Jenner, an Olympic gold medalist and reality television star, has likened the program to a "bribe" and criticized it for doing nothing to entice businesses to move back to California.
