## Where's All the Water?

Why some Californians are running out and others aren't

In Los Angeles, people have been hearing about the dangers of drought for decades. But in this land of infinity pools and backyard putting greens better suited for rattlesnakes and scrub – water never seems to run out.

Yet little Redwood Valley in Mendocino County, which gets a bountiful 38 inches of rain in an average year and sits near the headwaters of the Russian River, has been devastated by this year's drought. Each resident has been told to use no more than 55 gallons per day – enough to fill a bathtub and flush a toilet six times.

drought, location is key. Rain and snow vary greatly across California's myriad microclimates, leaving some towns, mostly in the north, accustomed to yearly refills of their rivers, reservoirs and aquifers. Others farther south have fewer natural supplies of their own, and in parts of the Central Valley, the drought never really left.

But drought resilience is manufactured, too. Decades of planning and extraordinary engineering and technology keep the water flowing to arid

#### **Yuba City Passes Structurally Balanced Operating Budget**

From City of Yuba City

YUBA CITY, CA (MPG) - This month, the Yuba City City Council unanimously approved a comprehensive budget of just over \$106 million for the 2021-22 fiscal year-marking a tidal shift from the pandemicinduced deficit and tone of uncertainty that foreshadowed the 2020-21 budget to one with optimism for the year to come.

Designed under the City's longstanding strategic priorities to be a safe place to live, work, play, and do business, the 2021-22 budget projects general fund revenue and expenditure increases over the prior year, furthers fiscal solvency and commits to significant capital improvements.

"With short- and longterm planning, the City's lasting dedication to fiscal stability is reflected in how we are emerging from the significant challenges created by COVID-19," said Mayor Marc Boomgaarden. "This budget for next year continues our diligent efforts to provide for our City and our vision looking forward as we continue to support and uplift our community."

The FY2021-22 budget anticipates general fund revenue increases over the prior year by nearly \$5.5 million, made possible by strong sales and property tax receipts. It also projects a general fund expenditure increase of nearly \$3.6 million.

"We are all encouraged to see our budget begin to recover from the challenges of the last year and to reflect great promise for the future of Yuba City," said City Manager Dave Vaughn. "Not only is it structurally balanced, but it demonstrates investments in the areas we and our citizens care most deeply about."

Public safety remains the City's utmost priority, with 62 percent of the budget dedicated to law enforcement and fire protection. The budget includes the creation of six permanent firefighter positions that were previously grant-funded and limited in term, while also creating an additional homeless liaison officer within police field operations.

Public Works represents the next most significant portion of the City's budget allocations. As the City continues to grow and age, its leadership is committed to investing in all aspects of infrastructure, from roadways to parks to water and wastewater provision. Projects include

## Yuba County Offering Loaner Life Jackets at New Bullards Bar and Lake Francis

MARYSVILLE, CA (MPG) - To further promote recreation and water safety, Yuba Water Agency has partnered with Yuba County to establish the Life Jacket Loaner Program.

Four loaner stations have been installed at New Bullards Bar Reservoir and Lake Francis to increase the use and accessibility of life jackets and prevent drowning-related incidents. Each of the life jacket stations is stocked with 20 life jackets of various sizes, which are available to borrow at no charge on a first-come, first-served basis.

"Safety is always our number one priority in everything we do," said Yuba Water General Manager Willie Whittlesey.

"This program will help ensure that those who don't own or have access to life jackets still have the opportunity to recreate safely."

Three loaner stations have been installed at New Bullards Bar – one near the Emerald Cove Marina and boat ramp, and two at the Dark Day camping area and boat ramp. A fourth station was installed at Lake Francis on the public side of the lake near Lake Francis Resort.

According to the Centers for Disease Control and Prevention, from 2005 to 2014 there was an average of 3,868 fatal unintentional drownings annually in the United States, which is approximately 10 drowning deaths every day.

"It only takes a moment. In the time it takes to check a fishing line, flip a hamburger on a BBQ or apply

sunscreen, a child without a life vest can drown," said Megan Marshall, deputy director of public health for the Yuba County Department of Health and Human Services. "In joint celebration of Father's Day and the importance of our children's safety, we are proud to partner with Yuba Water Agency to make life vests available at these four recreation locations in our community."

In September of 2019, Yuba Water granted Yuba County more than \$47,600 for the installation of the loaner stations and cost of the program during its first year. Due to the COVID-19 pandemic, both agencies made the decision to hold off stocking the stations until they deemed it was publicly safe to do so.



Continued from page 1 improvements and rehabilitation of many miles of surface streets, widening of Bridge Street, construction of Harter Park, closing the Sutter Bike Path Gap to Tharp Road, a second groundwater well at the Water Treatment Plant, a water transmission line to Barry School, and a sewer trunk connection from Harter Parkway to Bridge

Additionally, the City Council has directed staff to program current and prior year savings to fund

\$1.9 million in general fund capital improvement projects including fire station repairs and renovation, lighting replacement at Blackburn-Talley Field, and facility and grounds improvements.

In recognition of the importance of economic development to the City, the FY2020-21 budget also adds a business liaison position to the Development Services Department to assist developers with new projects by creating a single point of contact.

Continued from page 1 truck in water to make it through the year. At the same time, most of California's urban hubs are prepared to weather the summer with and wild coast, Mendocino only voluntary cuts and limited restrictions that in many cases are holdovers from previous droughts.

A CalMatters survey of the state's 10 largest water agencies found only one – in San Jose – has issued new limits on watering yards, washing cars and other outdoor uses. Eight, including Sacramento, already had rules curbing irrigation and water waste on the books. And four, including water agencies in the East Bay and Riverside, have asked people to voluntarily cut back between 10% and 25%.

The grip of drought even varies within single counties. For instance, one Mendocino County town is flush with recycled water and groundwater stores, but in another, residents are ordered to reduce use.

This year, California regulators announced that they because of extreme drought conditions.

But water experts caution about the potential for more dry days ahead, exacerbated by climate change, so a gallon of water used now is one less saved for later.

Water is much more precarious in Mendocino County, which is isolated from state and federal aqueducts. Instead, residents

rely on patchy aquifers and water that's stored in Lake Mendocino and released into the Russian River.

Known for its wine, weed County was one of the first places where California Gov. Gavin Newsom declared a drought emergency.

This year's drought is the most dire situation they've faced in decades. At the end of May, Lake Mendocino hit a record low of just 40% capacity. Earlier this month, the county faced projections that the reservoir could be dry by the end of the year. In response, the state adopted emergency regulations that could stop 2,400 water right holders from diverting water from the Russian River as early as July 5.

But at this point, there's no surplus. Agricultural connections have been shut off in Redwood Valley and residents are limited to 55 gallons per person per day – enough for just a 22-minute shower and nothing else.

Farther out along the coast, in the town of Mendocino, wells pumping from rainfed groundwater stores. The town declared a stage 4 water shortage emergency in May requiring residents to use 40% less water than allotted.

Ukiah, just ten miles from hard-hit Redwood Valley, is weathering the drought much better because of steps taken after the last dry spell. Today the city is facing extremely dry conditions in the Russian River, which typically makes

up about half of the supply for its 16,000 residents.

Ukiah will lean more heavily on groundwater, bolstered after the last drought with a state grant that helped pay for three new wells. The city also built a \$34 million recycled water plant that pumps out irrigation water, making up a third of its supply.

Marin County's largest water provider, too, has been hit hard by shortages in its own reservoirs and those in Mendocino and Sonoma counties. Marin Water, which aims to cut use across the county by 40%, has banned watering plants during the day and limited sprinklers to two days a week, among other mandatory restrictions,

## Construction Begins on **Emergency Drought Barrier**

California Department of Water Resources

SACRAMENTO, CA (MPG) - In response to worsening drought conditions in California, the Department of Water Resources (DWR) began construction on a temporary emergency drought barrier on the West False River in the Sacramento-San Joaquin Delta. The barrier will help slow the movement of saltwater into the central Delta and prevent contamination of water supplies for Delta agriculture and municipal supplies for millions of Californians.

"California is experiencing a second consecutive dry year and snowpack runoff into our state reservoirs has been far less than anticipated, so we are taking emergency actions to protect the state's water supply and environment now," said DWR Director Karla Nemeth. "DWR along with partner agencies is looking at all options to bolster the state's drought response and mitigate drought impacts."

The barrier will help prevent saltwater contamination of water supplies used by millions of Californians who rely on Deltabased federal and state water projects for at least some of their supplies. The emergency barrier will also help conserve critical water supplies in upstream reservoirs for later use by avoiding the need to send large volumes of water into the Delta to repel salinity this

"Keeping saltwater from intruding into the central Delta is essential as a large portion of the state's fresh water for urban and agricultural use goes through this part of the Delta," said Ted Craddock, Deputy Director for the State Water Project.

On June 1, a temporary urgency change petition to modify State Water Project and Central Valley Project water rights conditions was approved by the State Water Resources Control Board, which will allow for water to be conserved for later instream uses and water quality requirements. These modifications are needed to help protect cold water pools for salmon and steelhead and maintain water quality while ensuring some water supplies are maintained if drought conditions persist next year.

Simultaneous to the drought barrier's construction, DWR is pursuing long-term planning and permitting in anticipation of Programs/All-Programs/Drought

future drought conditions. There will be opportunities for public involvement during this process, which will continue into 2022.

DWR is working to get the temporary emergency drought barrier in place as soon as possible. The approximately 800-footwide temporary barrier consisting of nearly 90,000 cubic yards of rock will span the West False River and prevent salty tides and slower moving salinity from intruding into the interior Delta. Construction is expected to be completed by July 1. The barrier will be removed no later than November 30.

The barrier will block watercraft passage on West False River until its removal and will be marked by warning signs, lights, and buoys. Alternative routes between the San Joaquin River and interior Delta will be

On April 21, Governor Gavin Newsom signed an emergency order directing state agencies to take immediate action to bolster drought resistance across the state. The installation of a West False River drought salinity barrier during the 2012-16 drought proved to be an effective tool for reducing the intrusion of salt water into the central and south Delta and helped preserve fresh water supplies for future critical uses including drinking water and the environment. The West False River drought salinity barrier is just one of many actions DWR is taking to mitigate drought impacts consistent with the emergency order.

## **Route 1 Express Service Ends June 30th**

MARYSVILLE, CA (MPG) - In response to recent changes in state and local health directives, Yuba-Sutter Transit has dropped all on-board passenger capacity limits. Signs blocking off certain seats have been removed and all seats are now available allowing full capacity on all buses. As a result, the Route 1 Express service will end on Wednesday, June 30th.

The Route 1 Express service was added in June 2020

to facilitate social distancing as on-board capacity limits had resulted in passengers being passed by especially on Yuba-Sutter Transit's cross-town Route 1. The limited-stop express service greatly reduced the number of passengers being left behind at bus stops and made cross-town trips faster by serving only the major transfer points along the route. Without on-board capacity limits, the express service is no longer necessary, and the drivers can be better used elsewhere.

Ridership is tracked daily on all Yuba-Sutter Transit services and future changes to return services that were suspended last year will be considered as ridership grows. Suspended services include half-hour weekday service frequency on Route 2 and several morning and afternoon Sacramento Commuter schedules.

## Woman Pleads to Elder **Embezzlement Abuse**

- As jurors waited to be selected for her trial this morning, (June 21, 2021) a 31-year-old woman changed her not-guilty plea and pleaded no contest to embezzling over \$63,000 of Camp Fire insurance money from an elderly Camp Fire victim, who had raised her from the age of eleven.

District Attorney Mike Ramsey said the 75-yearold Camp Fire victim had received insurance payments totaling over \$127,000 for the loss of her home in the November 2018 fire. After relocating due to the Camp Fire, the victim had taken the defendant, Brenda Rose Asbury, into her new residence to help the defendant escape a bad relationship in Oklahoma. The victim had paid travel costs so that the defendant, whom she called her "daughter", could make it to California.

tim received the insurance payments starting in December 2018 through June 2019 and placed them into a separate bank account she created for the settlements. The victim's husband's health deteriorated after the fire and he was placed in a care home. In May 2019, Asbury convinced the victim that placing Asbury's name onto the account would protect the money from any attempt by the state to recoup money for the husband's care. Still distressed from the Camp Fire, the victim agreed to Asbury's plan and put Asbury on the account, in name only, so that noth-

ing would happen to the

money, which was sup-

posed to help the victim

rebuild her life.

Ramsey said at no point was Asbury given permission to access the account or use any of the money in the account. However, unbeknownst to the victim, shortly after being added on to the victim's bank account, Asbury created a new, separate, secret account and transferred over \$63,000 into that account. Asbury then packed up all of her property and secretly moved out of the victim's home while the victim was out for the evening. Asbury disconnected her cell phone and cut all ties from the woman she called "mom", fleeing back to Oklahoma.

Within a few weeks, Asbury's secret bank account was completely empty through cash withdrawals and further transfers to different accounts. Bank records show Asbury spent thousands paying off credit card debt and making various purchases including from Best Buy, Lowe's, Costco, Victoria's Secret. and Amazon.

Ramsey said the victim was doubly traumatized, not only by the Camp Fire, but by the betrayal of her trust by the woman she helped raise as her "daughter." Because of the theft, the victim did not have sufficient resources to rebuild her home and had to move into a small travel trailer.

Ramsey said detectives from the Butte County Sheriff's Office used search warrants, cell phone location pings, and various interviews to eventually locate Asbury in Oklahoma. She subsequently turned herself in to the local sheriff's office in November of 2019 and was booked into the Butte County Jail where she stayed for three weeks before being released by a local judge pending today's (June 21, 2021) jury trial.

During today's hearing, Asbury stipulated that she stole a total of \$63,100, which will be ordered as restitution for the victim when Asbury is sentenced on October 7, 2021. She faced upwards of four years in county jail for embezzlement from an

## **How Should California Confront Wildfire Threat?**

Physicist Albert Einstein is widely, albeit erroneously, thought to have said that "insanity is doing the same thing over and over again and expecting different results," but regardless of its source, the aphorism accurately reflects California's attitude about wildfires.

fires whip through communities in the "wildland-urban interface," often killing those who cannot or will not leave their homes and causing untold billions of dollars in property losses.

The frequency and severity of wildfires appear to be a commission appointed by increasing as our climate changes, droughts persist and greenery dries and becomes recently. explosive fuel. What was once a relatively brief fire season in late summer and early fall has morphed into a year-around peril.

And yet, more often than not, burned-over land soon sprouts new housing whose owners and tenants once again place themselves in harm's way.

A new study by UC Berkeley's Center for Community Innovation, commissioned by the think tank Next 10, attributes this seemingly loony practice to misguided state and local policies that incentivize reconstruction in

fire-prone areas.

Wildfire threatens the lives and homes of more than one-quarter of California's population," F. Noel Perry, the founder of Next 10, said in a statement that accompanied the report. "We must overhaul local and state policies and planning procedures to ensure that we are not incentivizing actions that elevate wildfire risks."

The study found that replacing current homes in high-risk areas would cost at least \$610 billion and that huge number scares insurers. As they pay out huge sums to burned-out policyholders and the danger of future catastrophic losses increases, insurers either shun coverage Year after year, destructive altogether or impose steep hikes on premiums.

> 'With climate-fueled wildfires scorching hundreds of thousands of acres, causing the loss of life and property, wildfire insurance availability has shrunk while the premiums charged have increased," Insurance Commissioner Ricardo Lara declared

> Insurance is required by mortgage lenders and many property owners, unable to purchase coverage in the private market, have turned to a statewide insurance pool of last resort that has high premiums and limited coverage.

> The Next 10 study recommends that the wildfire risk be approached by overhauling land use policies that lack "incentives to avoid building in fire-prone areas" and thus are "contributing to the persistent and increasing risk of significant economic and human costs associated with wildfires."

largely controlled by state and county governments through zoning and construction permitting. The state's housing crisis has demonstrated that those governments are often reluctant to approve highdensity housing, especially that meant for low- and moderate-income renters, within urban areas.

However, as the Next 10 study points out, they tend to be more supportive of housing, especially single-family homes, in urban peripheries, which also tend to be the areas of the highest wildfire risk.


The report proposes "moving homes out of the WUI (Wildlands-Urban Interface), incorporating greenbelts and wildfire buffers, increasing density in existing commercial cores, adding gentle density in the form of 'missing middle' housing and accessory dwelling units to areas not in the WUI, and embracing manufactured housing as an affordable-bydesign approach."

Lara's commission, meanwhile, suggests insurance premiums based on forecasts of future peril, rather than past experience, blanket policies that spread risk, rewards for making homes more resistant to damage and other steps that can mitigate not only wildfire impacts but the less obvious risk of destructive flooding.

Both studies underscore a fact we ignore at our existential peril: Despite its many attributes, living in California means living with constant threat of catastrophe.

demanding more money;

**Grandparent Scams:** Imposters pretend to be your grandchild or an authority figure holding your grandchild. They claim the grandchild is in trouble and needs money to help with an emergency, tricking grandparents to wire them money. Scammers say not to alert the grandchild's parents. Ask some simple questions that only your grandchild would know the answer to;

**COVID-19 Scams:** The Federal Trade Commission has sounded the alarm on products falsely claiming to treat or prevent the novel coronavirus, as well as fake charities. Be wary of alleged government calls to set up COVID-19 tests and avoid phishing emails touting vaccinations and home test kits.

Kryger adds, "Whether a family lives close together or is scattered across the country, staying in touch with an aging loved one can help

prevent senior isolation, reassure the senior that they can rely on family if they become victimized by fraudsters, and help family members spot signs of cognitive decline that can lead to financial

## **New Home Sales in Sacramento Region Ease Back in May**

SACRAMENTO, CA (MPG)

- New home sales in the Sacramento region eased back during May from the frenetic pace reported during the past 12 months, but still were well above historical averages for the month, the North State Building Industry Association reported.

During May, area builders reported selling 570 new homes in the greater Sacramento region, including Sacramento, Placer, Yolo, Sutter, Yuba and Nevada counties. That is the lowest number since November, when 523 sales were reported and down sharply from the 760 sales reported in April, said Michael Strech, the BIA's president and CEO.

"Despite the modest dropoff in sales last month, the demand for new homes in our region remains incredibly strong," Strech said. "Sales during the month were far above the 448 builders have seen on average during May since 1997, and historically, March and April have been the strongest released last week shows

gradually fall off through the rest of the year."

"It's also important to note that last month's sales were higher than all but one May's figures since 2006 and that year -2019 – was a five-week month." Sales that month totaled 585.

Strech said that even as pandemic restrictions are easing, many buyers are still looking for homes that provide the space and amenities they need, and today's new homes – particularly in the Sacramento region - meet those needs.

Still, builders are seeing headwinds, including the high price of lumber, other supply chain constraints and now a growing concern about available lots in the region as builders have ramped up production. It can take years to get government approvals to build new communities which hinders builders' ability to keep pace.

In addition, he said the excessive fees charged to builders in the Sacramento region mean some communities simply aren't feasible.

"The fee study we



Buyers continue to purchase higher-priced homes. The vast majority of purchase continued to occur between \$401,000 and \$750,000 during May.







#### We are into the Fire Season and the Calls about and for Fire Insurance Policies Abound

Once again we come into the fire season and the calls about and for fire insurance policies abound. As an agent and owner of an insurance company, I find homeowners asking good questions and not so good questions, of which some are based on misconceptions about what is going on in the industry at it relates to homeowners policies.

Some time ago most residential homes were covered under one inclusive policy called an HO3 (HO= homeowners).

With the increase in wild fires, many insurance companies took huge losses and over time, some have elected to remove the fire portion of coverages from their policies. They also removed lighting, wind and internal explosion and other related coverages for a variety of reasons.

Insurance companies may still offer coverage for your home, but many have removed the fire and related risks mentioned above.

On rare occasions, an insurance company will still offer the all in one HO3 in fire areas but homeowners won't know this unless they submit an application. The why or why nots as to why an insurance company may make these rare exceptions have some rhyme and reason to it, but usually that is known only to the insurers.

Nowadays it is common to have a fire policy and what is called a "wrap" policy or better known as a "Difference in Conditions" policy (DIC). The DIC is written by your regular insurer if they decide not to offer you a complete policy (HO3), and then you will likely need a California Fair policy for the fire portion of the coverage.

Cal Fair is not a state agency. It is a group of all the insurers that do business in the State and operate much like the "assigned risk" coverage for bad drivers. Cal Fair is all these insurers grouped together which then share in the losses and gains of the combined policies.

One could argue they may be financially bulletproof, which means unlike some insurance companies that may have gone under due to massive wildfire losses in recent years, Cal Fair may draw on the resources of the combined strength of the entity. They are also covered under the California Insurance Guarantee

Association. (https://www.ciga.org/about ciga.html).

Many of the phone calls I receive complain about Cal Fair and some say they want other options. When asked why, they usually respond, "because they're too expensive".

I always respond with the same answer, which is "usually no agent wants to write a Cal Fair policy because its compensation to agencies may not be commensurate with other rates. In addition, if you're stuck in a hole and only one guy throws you a rope, vou don't complain. Your choices are if you don't like Cal Fair, don't get insurance. And when you're regular insurer does come back to insure fire, you will probably wish you had Cal Fair".

I say this because I find Cal Fair to be highly regulated, scrutinized and skinny on compensations as mentioned above. Not so with the big insurers in my opinion. So if you think Cal Fair is high, just wait. My opinion again of course.

The trick to navigating all this is getting a responsive agent who will take the time to discuss coverages, limits, deductibles and explain how it all affects your premiums. I can honestly say many customers I talk to tell me horror stories of agents not returning phone calls or not even answering their phones, being rude or short, telling customers they're just too busy, or out of state cookie-cutter type agencies winging quotes with little discussion to the client.

The best way to make sure you get the right coverage at the right price is to work with an knowledgeable local agent, who will call you back, explain the policies, take the time to make sure all your questions are answered and get you the right limits and deductibles for your situation.

#### **Drought Brings New Focus** on Water Facilities

Canals that stay dry due to drought may water facilities. Water district officials say the drought and resulting water shortages have further exposed weaknesses in water systems. A national coalition has urged U.S. Senate leaders to boost funding for water facilities in any infrastructure package, while the state Legislature also considers water investments.

#### Dry Pastures, Wage Rule Threaten Sheep Ranchers

Pastures have dried out much earlier than usual, leaving California sheep ranchers having to decide how to sustain their operations. Many have thinned flocks by selling lambs early. Ranchers who offer targetedgrazing services to reduce wildfire fuel say demand for their services has surged. But all ranchers say an impending state overtime rule for sheepherders threatens to undermine the entire sheep business.

#### Analysts Expect Strong Beef Demand This Summer

The economic reopening of the counbe more prone to cracking, intensifying try appears to be contributing to strong calls for federal and state investment in demand for beef. An American Farm Bureau economist says restaurants and other food-service establishments have been trying to secure beef supplies in anticipation of pent-up demand. Grocery stores are also competing for beef supplies, because as more people cooked at home during the pandemic, they may have become more comfortable in preparing different cuts of meat.

#### Almond Sales Establish New Record

Despite disruptions caused by the pandemic, trade disputes and port slowdowns, sales of California almonds have reached record levels. The Almond Board of California reports annual sales establishing new highs with two months remaining in the crop's marketing year. The board attributes the increase to people's interest in plant proteins and the almond's versatility in a range of products and cuisines.







Fireworks are a symbol of America's independence, but with so many state and local limitations placed on them it's hard for Californians to feel all that liberated when celebrating Independence Day.

Reasons for that generally pertain to safety concerns. Authorities contend that injuries and fires are minimized by allowing the sale and use of only safe and sane fireworks in certain communities and for no

signed the Declaration of Independence during one of the hottest months of the year.

"With California entering warmer weather with drought conditions in place, it is important to remember that fireworks are illegal in certain areas of California," State Fire Marshal Mike Richwine told Messenger Publishing Group. "Each year serious injuries and millions of dollars in property loss occur

more than seven days a year. Not helping

matters is the fact that our founding fathers

from wildfires sparked by fireworks."

Adding to this season's challenges, the domestic fireworks industry is dealing with another type of drought - as in the potential lack of product due to unprecedented delays in receiving ordered products from suppliers in China, maker of nearly 100 percent of product for the U.S. market.

"This is a very challenging year for the entire industry," Hass said. "Fingers crossed! Shop early!'

## Sutter-Yuba Mosquito & Vector Control District

#### **MOSQUITOES ACCUMULATING IN TOWN AREAS**

#### **TOWN SPRAYING SET TO BEGIN**

When mosquitoes move into town areas, it is important to reduce their numbers and lower mosquito-borne disease risk. Public health insecticides formulated for application in urban and residential environments undergo rigorous safety testing before they are approved for use. For the 2021 season, the District will be using a permethrin product applied at an ultra low volume rate of 0.29 ounces per acre. All applications are predicated on mosquito abundance, disease activity and favorable weather conditions. Although these materials pose a low risk to human health, some people may prefer to avoid or minimize exposure by staying indoors, keeping their windows closed and turning off their window mounted air conditioners, evaporative coolers and whole house fans when spraying is taking place in the immediate area. You can obtain additional information about spray operations by calling the District office at 674-5456 ext. 0 between the hours of 7 AM to 3:30 PM, Monday thru Friday or by viewing our website at www.sutteryubamvcd.org. Residents can also sign-up for email spray notifications by visiting the District's website.



#### **SCHEDULE**

Beginning on Thursday, July 1, 2021 and continuing weekly, fogging routes will begin as early as 3:30 AM and continue until 6:30 AM in Olivehurst, Linda, Arboga, Plumas Lake, Wheatland, East Marysville, Live Oak, Tierra Buena, Yuba City (Hillcrest area) and Sutter. Meridian and Robbins will be fogged on Tuesday or Wednesday evenings. Additional town areas and nights may be added if mosquito-borne disease activity becomes elevated. The program generally ends in mid-September, when mosquito abundance declines.
