Cash for VAX!

Newsom offers big bucks for Californians who get their shots



Newsom announced a \$116.5 million "Vax for the Win" program, the largest inoculation lottery program in the country.

For Californians who are insufficiently compelled by civic duty and self-preservation to get vaccinated, Gov. Gavin Newsom is offering another reason to get the jab: cold, hard cash.

This afternoon, Newsom announced a \$116.5 million "Vax for the Win" program, the largest inoculation lottery program in the country. The money will be split among dozens of lucky Californians: \$1.5 million to each of 10 "grand cash prize" winners who will be picked by random draw on June 15, and \$50,000 each to 30 "Fridays for 30" winners to be selected by random draw on June 4 and June 11.

The remaining \$100 million will be divided up in \$50 retail gift cards among the next 2 million Californians to complete their vaccine regime.

"These are real incentives," the governor said at a press conference. "And these are an opportunity to say thank you to those not only seeking to get vaccinated, as we move forward, but also those that have been vaccinated."

According to the most recent state vaccine data, a little more than half of all Californians over age 12 have been fully vaccinated. Another 13% have received one of two shots.

That still leaves more than 12 million Californians unvaccinated.

The percentage vaccinated varies wildly by race and income. Among Californians living in the top quarter

of the healthiest ZIP codes, 76.6% have received at least one dose. In the least healthy quarter in the state's "Healthy Places" Index, the share is

only 52.1%. "Some Californians weren't ready to get their COVID-19 vaccine on day one, and that's okay. This program is designed to encourage those who need extra support to get vaccinated and help keep California safe," Dr. Tomás Aragón, director of the California Department of Public Health, said in a statement.

H.D. Palmer, a spokesperson for the state Department of Finance, said the lottery funding will initially come out of the state's emergency operations account, but will be repaid with the state's multi-billion dollar Continued on page 3

Violent Criminals Get Less Consequences under New **Proposal**

SACRAMENTO, CA (MPG) -

The Democrat majority of the Senate passed a measure requiring the courts to dismiss sentence enhancements, thereby, resulting in shorter jail or prison time for convicted criminals. Senate Bill 81 (Skinner) further removes the discretion of judges and provides them no guidance when evaluating whether an enhancement should be dismissed.

Some of these enhancements like the Three Strikes law have been placed into law by the votes of the people.

"By eliminating the enhancements, the Legislature is sending the message that it is ok to do multiple crimes without consequences," said Senator Jim Nielsen (R-Red Bluff). "The criminals understand this message well."

"This legislation emboldens the criminals and ignores the rights of victims and the rest of society."

According to the San Diego District Attorney, "Senate Bill 81 serves to mandate dismissal of sentencing enhancements imposed by the original sentencing judge for many offenders by creating a new opaque legal concept - a presumption of dismissal unless the prosecution shows by clear and convincing evidence that the dismissal of the enhancement would endanger public safety."

This bill would likely eliminate all property crime enhancements, as such crimes are deemed "non-violent."

For example, embezzling or defrauding a person of \$5,000 or embezzling and defrauding their entire \$500,000 life savings would essentially have the same penalty.

"This is completely unfair and unjust for both the victim and the community at large," said Senator Nielsen.

Senate Bill 81 received 27 yes votes. No Republican voted for this measure. It now moves to the Assembly for additional hearings.

Elected to the State Senate in January 2013, Senator Nielsen represents the Fourth Senate District, which includes the counties of Butte, Colusa, Glenn, Placer, Sacramento, Sutter, Tehama and Yuba. The New Lomo Crossing

Those travelling State Route 99 between Yuba City and Live Oak soon will find themselves exposed to a much greater risk of Accidental death or injury as a result of the ill-conceived Caltrans' plan to enhance what they peddle as

"highway safety" at the Lomo Crossing. As of May 24, 2021, the Lomo Crossing intersection of Hwy 99 was reconfigured. Vehicles using Live Oak Blvd and/or Encinal Roads will only be able to enter Hwy 99 if they are merging into the flow of traffic in the lane nearest them. Neither crossing nor left hand turns will be allowed from Encinal or Old Live Oak Blvd onto Hwy 99. Nor more left hand turns for southbound travel on Hwy 99 onto Old Hwy 99. Sorry, you'll have to wait and get off Hwy 99 at Eager Road approximately 2 miles south.

Aside from the inconvenience, this Caltrans' plan for Lomo Crossing will result in a much greater risk of serious accidents as it shifts traffic entering Hwy 99 at Lomo Crossing to Clark Road roughly one mile north. Arguably it "may" make the Lomo Crossing/Hwy 99 intersection "safer" but the net effect will be to create a much more dangerous roadway just one mile south.

Hwy 99 at Clark Road is a high speed, heavily travelled two lane north/south

Sate Highway.\; there are little or no shoulders on the wast or west side of the highway; poor visibility due to lighting and trees along the shoulders of Hwy 99; Union Pacific RR tracks border and are contiguous to the west side of Hwy 99 right-of-way; eastbound vehicles stopped, waiting to enter onto Hwy 99 from Clark Road will be straddling the RR tracks; and finally no merger lanes for traffic departing Clark Road and entering either the north or southbound flow of travel.

Even before this remodel of Lomo Crossing, entering onto or crossing Hwy 99 at Clark Road has be a "suicide exercise". This Caltrans' engineering decision qualifies as what California Law defines as a "dangerous and defective design" and will expose the State of California to legal liability for the inevitable resulting accidents. A "bad idea" by the State and a foolish waste of highway funds (\$100k) that could be put to better use.

Drop a line to our Assemblyman James Gallagher and Senator Jim Nielson and invite them to travel the Clark Road/Hwy 99 intersection at peak hours for a real look at an accident waiting to happen.

Foot Pursuit of Machete Wielding Assault Suspect Ends in Arrest

WEST LINDA, CA (MPG) - On Tuesday 5/25/2021 at approximately 11:00 a.m. Yuba County Sheriff Deputies arrested 36-yearold Parolee William Brooks for resisting arrest, assault on a peace officer, and assault on a police canine. Brooks, a local transient, was wanted after being identified as the suspect in a May 20, 2021 incident in which he ran from deputies and threatened them with a chain after allegedly committing a burglary and brandishing a knife at a Linda hotel. He evaded capture in that incident when pursuing deputies lost sight of him in the river bottoms last week.

At approx. 10:45 a.m. on 5/25/21, Yuba County Deputies on patrol in West Linda spotted Brooks wearing a gas mask and carrying a machete while walking in the middle of the road on Garden Avenue near Cedar Lane. The deputies attempted to stop Brooks but he fled from them and proceeded to run through several residential yards. Deputies concerned that the machete-armed suspect was running toward a nearby elementary school, pursued Brooks. A deputy trying to

detain Brooks as he climbed a fence was physically assaulted by the suspect, who ignored orders to stop and despite being tazed, continued to actively resist and run.

Additional deputies responded to assist and a perimeter was established. Deputies and a Sheriff K9 closed in on Brooks who they found barricaded in an RV in a backvard. Brooks refused orders to come out, and K9 "Chase" was deployed to take him into custody. Brooks continued to resist arrest, hit and threw K9 Chase, then proceeded to run again and jumped another fence into a yard on Poplar Avenue, where additional Deputies were located. Brooks remained combative as Deputies took him into custody at that location.

K9 Chase obtained a laceration over his eye after being struck by Brooks. Chase was treated and released for his injury and is expected to make a full recovery. No other deputies were seriously injured in the incident. Brooks was transported to the hospital and treated for dog bite injuries before being booked into the Yuba County Jail. He is currently being held without bail on a violation of parole in addition to the new charges.

Continued from page 1 allotment of federal relief funds.

"The cost of not getting vaccinated is exponentially, incalculably higher," Newsom said.

The governor noted that Californians who have already been inoculated will be entered into both the \$1.5 million and \$50,000 contests. When the state rolled out its MyTurn website as a one-stop-shop for vaccine appointments, most Californians turned elsewhere. But the state also maintains a confidential registry of all vaccine recipients. The names of winners will be kept confidential unless they volunteer to have them released, said Newsom.

Republican Gov. Mike DeWine of Ohio was the first to launch a statewide cash-forvax lottery program in mid-May. Nearly 3 million Ohioans entered and a 22-year-old recent college grad was the first winner on Wednesday. According to one analysis, vaccinations jumped by 40% in the week after DeWine's announcement.

Since then other state governors have followed suit. Colorado is offering a total of \$5 million to the newly inoculated. West Virginia has tempted vaccine-hesitant young residents with savings bonds and New York has dangled the possibility of a tuition-free public university education.

But California's cash giveaway is the biggest yet.

For Newsom, the program represents a political win-win. The governor has vowed to ease most of California's COVID restrictions by June 15. The more vaccinated Californians, the more likely it is that the reopening process will go off without another surge in cases and hospitalizations. That, in turn, would be good news for the state, but also a governor who is hoping to survive an all-but-certain recall election later this year.

In a Public Policy Institute of California poll released this week, 57% of likely voters said they oppose removing Newsom, while 40% said they supported the recall. In the survey, 61% approved Newsom's handling of the coronavirus pandemic and 75% gave the state excellent or good marks for vaccine distribution.

Earlier this month, the governor went on a statewide tour announcing various goodies from his latest revenue-rich budget proposal – a convenient mix of policymaking and politics. Handing out even more cash to Californians in the name of public health can't hurt the governor's political image either.

Republican John Cox quickly accused Newsom of trying to "buy votes before the recall."

Based on the nearly 20 million Californians who have received at least one dose now, the odds of winning the

1.5 million prize are 1 in 2 million – 100times better than the chances of winning the Powerball or Mega Millions jackpots, but for far less money.

Newsom said the administration consulted with researchers at UCLA's COVID-19 Health and Politics project in putting the program together.

According to research conducted by political scientist Lynn Vavreck, lead researcher at the project, about a third of survey respondents said they were "more likely" to get a COVID vaccine if offered a cash prize of \$50 to \$100. That's compared to other tactics, including pro-vaccine public messaging from celebrities.

"Those types of message treatments did not work, but changing people's material condition – giving them a little bit of money or telling them they don't have to wear a mask anymore – made them more likely," Vavreck told CalMatters.

But for a minority of survey respondents about 15% – the offer of cash backfired. That's consistent with some criticisms made of these lottery programs noting that some vaccine skeptics could falsely interpret a cash reward program as an indication that the vaccine presents a risk that has to be compensated.

Peter Chin-Hong, an infectious disease physician at the University of California San Francisco, said that different people remain unvaccinated for very different reasons - a lack of social pressure, inconvenience, concerns about common side effects and more unfounded and outlandish safety concerns - so a single policy isn't likely to convince them all.

A possible cash incentive "will move the needle for the people on the fence," he said. "The people who are watching and waiting, who are not necessarily opposed to the vaccine but waiting to see people they know get it...that group will probably be most moved."

Earlier this month, the federal Centers for Disease Control and Prevention announced that fully vaccinated Americans can largely dispense with mask-wearing and social distancing - providing a powerful incentive for many. Though California has been reluctant to adopt more coercive measures, such as a statewide vaccine passport requirement, the reopening rules allow fully vaccinated people to attend larger events. Also, state and local governments have imposed selective requirements on certain Californians – public university students are likely to be required to have their shots, though prison guards are not.

This Month In Your Garden

June can be a good month for gardening. The days are warm but usually not too hot. Mornings are nice and cool so it's good to get out early for gardening and planting then relax, or do less strenuous tasks in the garden during the warmer part of the day. But get out early and enjoy the cool! Many people now find the time to work on some landscaping projects. Watering is also more important now than earlier in the season where if you missed the watering, the weather is pretty forgiving and no dire consequences. Now that it is getting warmer, the need to keep on the schedule is important. If you are planning a vacation, and you are fortunate enough to have an automatic watering system, you have it made. Be sure it is working well, and you might want to ask someone to check the system occasionally just to be certain it is working properly when you are gone. If you need to have someone do the watering for you, be sure they know exactly what is to be done. Have a good itemized list for them and also make several copies that can be placed around the area they are responsible for, so they can then refer to them if they need to. Then there are few excuses for things not being done the way you want them done. Going through the routine with the care-taker-to-be is safest, especially if they happen to be a youngster. Actually, I think most of those kids are very conscientious or they wouldn't have sought a summer job. If they know what is expected they will probably do it right. Just use your judgement on how detailed you need to be. I only go into this in a bit of detail because of post vacations stories we sometimes hear, or some past

experiences of my own. It is generally recommended that fertilizing should be done 3 times a year, February or March, June and September. March fertilizing helps to get everything off to a good start after the winter dormancy. June is for maintaining growth and energy needed for flowering and/or fruiting. September 's feeding is taken up by the plant, some of it used and most of it is stored by the plants through the winter while they are dormant and then used when needed as they awaken for spring. Many people have definite ideas about fertilizing and what should be used. Basically, we have chemical or organic fertilizers to use. You will usually see a faster response by the plants to the chemical fertilizers, but organic fertilizers actually build up the soil so have a much better long term effect. If you have always used the chemical fertilizers and decide to go organic, keep in mind that you will see slower results from the organic fertilizers but they work equally

well, and do it without depleting the soil. Much of our time during the summer months is spent outside. The summertime pastimes seem a bit more carefree than winter activities – not needing coats or jackets each time we go out and that sort of thing, and the summer days are much longer. Along with more time outside, we enjoy seeing all of the color that is available. If you are looking for colorful plants that are great summer bloomers that really seem to enjoy our heat, look for Crape Myrtles or Rose of Sharon. They both are available in several different colors - shades of red, white, pink. Of course there are many beautiful roses to add color to the landscape. They need regular watering and fertilizer every four to six weeks to keep them looking their best. It is also necessary to dead head them regularly. If the spent flowers are left on the plant they will become red seed pods, called rose hips, and the rose will quit blooming because it has done its job for the year. That is true of many plants since they set seed to carry on their species. If the seed pod – or whatever form they are - is removed, they will bloom again to produce more seeds. Perennials are also a good choice for summer color and they come back year after year. Annuals are available that will provide all summer color. Most gardeners take advantage of their quick growth and varied colors, shapes, and growth habits to add color and interest to their

More calls come during the summer months about wilting and dead plants than any other time of the year. The best thing you can do, especially for a plant that was planted earlier this season is to mulch around the base, keeping the mulch a few inches away from the trunk or main stem, and deep water it twice a week. Deep watering is achieved by creating a slight basin and laying a hose that is running slowly enough so that there is no run off – all of it is soaking into the soil at the base of the plant. Let the water run slowly for several hours or overnight. Roots are better able to get well into the soil, thus the plant is able to better sustain itself through the heat of

Fatal Overdoses are Up 35.5% in California, 14th Highest Nationwide

Economic Picture

There is a seamless connection between what Gavin Newsom is saying and doing as governor and his campaign to survive a recall, encapsulated in the slogan "California Comeback."

Newsom's much-revised state budget, unveiled this month, is centered on a "\$100 Billion California Comeback Plan" that would, he says, put the COVID-19 pandemic and its economic fallout in the rearview mirror.

Last week, when new employment data were released by the federal Bureau of Labor Statistics. Newsom immediately hailed them as proof that under his leadership, the

state is booming again. "California is continuing to lead the nation's economic recovery, adding 101,800 jobs in April — 38% of all the jobs created throughout the entire country," Newsom crowed. "Over the past three months, California has created 390,300 jobs. But we're not letting up; the California Comeback Plan is the biggest economic recovery package in the state's history and will provide historic investments in small businesses and workers to bring California roaring back."

A closer examination 1,089,000," the center's numbers, however, indicates that — as politicians are wont to do — Newsom is cherrypicking the most favorable economic indicator while ignoring others that are less positive.

One of the latter is the state's unemployment rate of 8.3% in April, unchanged from the March level in new jobs. It's still markedly higher than the national jobless rate of 6.1% and is the nation's second highest behind Hawaii's 8.5%.

California's unemployment rate had been the nation's third highest in March, but New York improved enough to displace California in April. Four states were tied for having the nation's lowest jobless rates of 2.8% in April. Arch-rival Texas was slightly higher than the national rate at 6.7%,

The data point cited by Newsom, that California added 101,800 jobs in April, 38% of the nation's job gains, is also somewhat iffy.

The California Center for Jobs & the Economy, a business-supported research organization, points out that the jobs number is a "seasonally adjusted" estimate, rather than a hard count, noting that the federal agency "so far has revised their adjustment formula three times in an effort to overlay seasonal factors to data that is overwhelmingly driven instead by the pandemic."

"The underlying unadjusted numbers instead show California gaining a stronger 151,500 nonfarm jobs, and the U.S. doing far better with a gain of newspapers.

of the latest employment analysis continued. "Using the adjusted data, California had 38% of the national jobs gain. Using the more relevant unadjusted, California had 14%. As of the April numbers, California has regained 48% of the nonfarm jobs lost to the state shutdowns. The U.S. in total has regained 63%."

Newsom's Employment despite the supposed surge Development Department (EDD) simultaneously released its version of the federal jobs report, which demonstrated just how much ground California must regain to return to prepandemic levels.

EDD said that just 38,600 more Californians were employed in April than in March while 1.6 million remained unemployed and that doesn't count those who have dropped out of the state's workforce.

The employment situation is especially daunting in Southern California. The Los Angeles region had the highest unemployment rate of any major U.S. metropolitan area in April at 11.7%, dragging down the state as a whole.

So, it would seem, California is recovering, bit by bit, the more than three million jobs lost when Newsom, under emergency decrees, closed large segments of the state's economy a year ago to battle the pandemic. However, we still have a very long way to go before he can legitimately claim a California Comeback.



The Beijing-controlled news agency paid another 1 million to American newspapers, including the L.A. Times, Chicago Tribune, and Houston Chronicle, to print copies of its own publications.

Guilty Verdict in Trial of Domestic Violence and Rape Suspect

MARYSVILLE, CA (MPG) - On the morning of June 9th, 2020, Marysville Police Department officers were dispatched to a residence on the 600 block of F Street regarding two female victims, a 38-yearold female adult and her 14-year-old daughter. Both females had fled from a residence on the 500 block of 6th Street and called 911. The mother stated her boyfriend, 36-year-old Marvin Wade Jr. of Marysville, with whom she and her daughter were living, had struck her numerous times, strangled her, and would not allow her to leave the residence. The mother was able to distract Wade during the altercation which allowed her daughter to escape and run to a neighbor's house. The mother also eventually escaped the residence and she had sustained visible injuries to her neck and her chest and she was suffering from head pain. The 14-year-old juvenile victim alleged Wade had sexually assaulted her the previous morning. Both female victims were transported to the hospital and the juvenile underwent a forensic medical examination.

Wade was located and arrested at his residence later in the morning on June 9th, 2020. Wade was booked into the Yuba County Jail for felony domestic violence in violation of 273.5(a) PC, felony assault likely to produce great bodily injury in violation of 245(a)(4) PC, and felony false imprisonment in violation of 236 PC. The investigation into the sexual assault of the juvenile victim continued while Wade was in custody.

After further investigation, The Yuba County District Attorney's Office filed additional charges on Wade for felony rape of a juvenile 14 years of age or older by means of force in violation of 261(a) (2) PC, felony oral copulation of a juvenile 14 years of age or older by means of force in violation of 287(c)(1)(C) PC, and felony dissuading a victim in violation of 136.1(b)(1) PC.

During the course of the investigation, several search warrants were authored which produced both biological DNA evidence and digital evidence. Testing and analysis conducted by the California Department of Justice-Bureau of Forensic Services confirmed Wade's DNA was discovered during the forensic medical examination of the juvenile victim. This evidence, along with the testimony of numerous witnesses, was presented to a jury in the Yuba County Superior Court over the course of approximately two weeks. On Wednesday, May 19th, 2021, the jury returned guilty verdicts on the charges of 273.5 PC, 236 PC, 261(a)(2) PC, & 287(c)(1)(C) PC.

Wade is scheduled to be sentenced on Monday, June 14th, 2021 at 9:00 A.M. ★

California State Board of Equalization Adopts \$126.8 Billion in Assessed Property Value

SACRAMENTO, CA (MPG) -The California State Board of Equalization (BOE) unanimously adopted the \$126.8 billion in assessed property values of 341 companies within California, which include telephone, gas, and electric companies, independent power producers, regulated railroads, and intercounty pipelines. In the upcoming fiscal year, schools and local communities statewide will receive a total of approximately \$1.99 billion in property tax revenue resulting from the Board exercising one of its core constitutional

"The BOE's critical role protects the tax dollars

schools and local communities depend on every day," said BOE Chairman Antonio Vazquez. "On behalf of the entire Board, I commend BOE staff for their expertise and hard work as today's action translates to funding teachers, public safety officials, parks, and roads across California."

Whereas most property in California is assessed by the 58 County Assessors, the BOE serves as the "59th assessor" by directly assessing certain public utilities, regulated railroads, and intercounty pipelines throughout the state. Also, since these properties are not subject to Proposition 13, the BOE annually determines the market value or the "unitary value" of property that includes improvements, personal property, and land.

The BOE develops the fair market value by considering market conditions, use of and income generated by the property, replacement costs, investments in the property, regulatory climate, depreciation, and other factors as of the January 1 lien date.

For fiscal year 2021-22, there was a 6.7% increase in the total value from last year in the amount of \$7.9 billion which will generate approximately more than \$124 million additional tax dollars. County governments will use the values set by the BOE to levy the local property taxes.

Murder Suspect Found Legally Insane

OROVILLE, CA (MPG) - A homeless Chico man was found legally insane by a Butte County judge today after that same judge found the defendant guilty of the first-degree murder of a homeless Chico woman in a court trial last week. The murder occurred on the Chico State University campus in 2018.

Butte County District Attorney Mike Ramsey said as a result of that insanity finding, Samuel Eugene Johnson, 30, was therefore found not guilty by reason of insanity for the murder of Linda Blacksten, 55. Ramsey said Johnson will be committed to the state mental hospital.

Ramsey said Blacksten's battered body was discovered on October 30, 2018 shortly before 5:00 a.m. in a pool of blood in an alcove on the south side of Kendall Hall on the university campus. Witnesses noted Blacksten was homeless and occasionally slept on campus.

The Chico State University Police investigated the homicide and quickly developed information leading to Johnson's arrest. Ramsey said the night of the murder, at 1:18 a.m. a 911 caller reported a male yelling at a female and threatening to kick the female's teeth in. In a later interview, the caller told police he heard the verbal altercation take place at the alcove where Blacksten's body was later discovered. The caller also said he saw Johnson nearby the alcove.

An autopsy revealed Blacksten was killed by blunt force trauma and suffered multiple

broken bones including fractures to her skull, vertebra, pelvis and fractures to most of her ribs. DNA testing revealed Blacksten's blood was on Johnson's pants and shoes.

No motive was discovered for the murder. Ramsey said Johnson then pleaded not guilty by reason of insanity. Ramsey explained that when a defendant pleads not guilty by reason of insanity, the defendant's trial is broken into two phases - the guilt phase and the sanity phase. Johnson waived a jury trial and submitted both phases to the

On May 19, 2021, during the guilt phase of Johnson's court trial, Butte County Superior Court Judge Jesus Rodriguez found Johnson guilty of 1st degree murder.

During the sanity phase of the court trial, the defense presented evidence of Johnson's extensive history of Schizophrenia. A courtappointed psychologist testified and opined Johnson was in a psychotic state when he killed Blacksten and that Johnson did not understand the difference between right and wrong at the time of the killing. After hearing the evidence, Judge Rodriguez found Johnson not guilty by reason of insanity and set the matter for a placement hearing on June 23,

Ramsey said due to the violent nature of the offense, Johnson, who has been in custody since the murder, will be placed in the state mental hospital for psychiatric treatment. Such a commitment carries the potential for a life sentence in the state hospital until doctors and a court determine he has regained his sanity and is safe to release. *

Can Marijuana Ease the Pains of Growing **Old? The Jury is Out and Still Deliberating**

WASHINGTON, DC (MPG) -"More and more states are legalizing the use of cannabis [marijuana] and more and more seniors are using it to deal with the aches and pains of aging. Some have the consent of their physicians while others are tempted simply because 'they hear it works.' But, according to medical professionals, it's use comes with risks," warns Rebecca Weber, CEO of the Association of Mature American

Weber cites a report in Medical News Today, that lists those risks, not the least of which is using "unregulated" cannabis that might be available in legalized marijuana shops simply because the "weed," as some call it, can be contaminated. Meanwhile, there is the danger that its use can impair your judgment, affect your

disease. According to the National Institute on Drug Abuse, which is an arm of the National Institutes of Health: "Marijuana is the most commonly used addictive drug after tobacco and alcohol." And, in addition to the dangers listed in the Medical News report, it can make you grouchy, cause sleepless nights, impair your appetite and cause anxiety.

Doctor Marc Agronin, chief medical officer at the MIND Institute at Miami Jewish Health, recently wrote a "special report" on the growing use of marijuana based products among the elderly. And, in conclusion Agronin said "The bottom line is that more rigorous scientific study using randomized controlled trials is needed to substantiate the proposed benefits of cannabis and more fully understand the range and impact of

While he noted that since the legalization of marijuana started spreading across the country, merchants and distributors have sought to increase sales by hyping its benefits. But he says, for example, some of the claims that are made may have some basis in fact. He cites a study that found the use of a THC and CBD oral spray for peripheral nerve pain "was well tolerated [by users] and showed a trend toward improvement in pain and sleep." THC and CBD are two of the principal components

of marijuana.] But the fact finding is underway to see if marijuana's benefits outweigh its risks, and a new report published by the Gerontological Society of America agrees with Mr. Agronin that the jury is out and still deliberating.

"It comes down to this," says AMAC's Weber, "if you are thinking about trying marijuana, whatever its form, ask your physician if it is a good idea."

Convicted Child Molester Faces Life Sentence

OROVILLE, CA (MPG) - A Chico man was convicted by jury in Butte County Superior Court of multiple counts of forcible child molest against a young girl in his custody when she was between the ages of 12 to

Jurors sat through two weeks of evidence and deliberated for two hours Thursday afternoon before finding William David Lawson, Jr., 45, guilty on all 15 counts and seven special allegations of which he was charged. The trial judge later found true a special allegation that Lawson had previously suffered a previous "strike" conviction for a residential burglary he committed in 2000, which serves to double his potential sentence in this case.

Butte County District Attorney Mike Ramsey praised the jurors and alternate jurors for doing their civic duty in listening to two weeks of emotional and often difficult evidence related to the ongoing sexual abuse of the young girl.

The trial prosecutor Leah Sears said the now 20-year-old victim was "resilient

and courageous, taking the stand to testify against her abuser on three separate days during the two-week trial." Sears also noted that cell phone data forensically downloaded from Lawson's phone corroborated the girl's testimony about the areas in Chico where she was molested. Sears applauded the Chico Police Department and the work of Detective Sophia Parsons, noting that "the extensive and meticulous investigation conducted in this case allowed the jury to deliver justice for the

Lawson remains in custody with no bail. He will appear on June 16, 2021 for sentencing. He faces a maximum exposure of 150 years to life in prison, plus an additional 214 years.

Ramsey however noted that legislation passed last year by the state legislature would qualify Lawson to seek parole after only twenty years of custody. "The state's new 'Elder Parole program' allows prisoners sentenced to life, regardless of the statutory minimum of that life sentence, to seek parole after only twenty years of custody once they reach 50 years of age." Ramsey said.



Drought Hits Hard on North Coast Farms, Ranches

Along the North Coast, farmers face what one calls a "bleak" situation, with low water levels in the Russian River watershed. With supplies from the river likely to be curtailed, some farmers have tried to diversify by acquiring recycled water from the city of Ukiah. Others will have to fallow land or grow crops without irrigation. Livestock owners must haul water to cattle and sheep after springs and reservoirs dried.

Larger Cherry Crop Reaches Height of Harvest

They expect a larger crop, but cherry growers say heat and wind early in their season will likely prevent a near-record harvest. With the harvest now peaking, farmers say the dry, sunny spring allowed cherry trees to set plenty of fruit. Bing cherries remain the top variety grown in California, but farmers have been planting more of a type called Coral Champagne, which matures earlier. Peak cherry harvest will continue through the first week of June.

Research Aims to Grow Tomatoes in **Unusual Environments**

Small-stature tomato plants being developed by the University of California could benefit indoor urban agriculture, and could perhaps be grown on long-duration space flights. Researchers at UC Riverside have been studying different types of small tomatoes. One type has been engineered for use in urban "vertical farms." Other, similar tomatoes will ultimately be grown in microgravity on the International Space Station.

Survey Traces Food Trends During Pandemic

Some pandemic-related changes in eating habits have begun to ease, and others appear to have endured, according to a new survey. The International Food Information Council says its annual survey shows a decrease from last year in the proportion of Americans cooking at home more than usual. But a trend toward increased online food shopping appears to have continued, especially among younger shoppers, African Americans and parents

Crypto Currencies is a Hot Topic

With the explosion both in investor interest and price action, crypto currencies is a hot topic. Originally conceived as an alternative currency, Bitcoin was the first digital money to make its debut in 2009. Since then, over 4000 different cyber coins have hit the market. The allure is that it reportedly cannot be manipulated or eliminated by any one person, entity or government. Created and stored in cyber space, the argument appeared to be a valid one.

Since their creation, stories of overnight millionaires abound, and I am hearing more of these rags to riches stories everyday. And it's not just about making a few bucks. If what I am told is to be believed, ungodly sums of money has been made for more than a few acquaintances.

I have to admit, I can't say I understand fully how crypto works. I would guess neither do many of its investors.

What I can say is this has all the trappings of a mania. From the buzz, to the quick profits by the inexperienced, to the price charts and right down to the "this time it's different" story, it reeks of a mania. And now perhaps the sad late chapters of manias: they fall down, and usually hard.

I have issues with crypto. I own a small amount through a Wall Street vehicle and not on any phone app. Stories of investors losing passwords or hacked apps resulting in absconded funds abound. One investor profiled in a Wall Street article was locked out of 100 million and only had two chances left to remember his 132-character password before losing this fortune into the black hole of cyberspace.

And no, there is no one you can call. Once it's locked, it's essentially gone forever.

Besides the "too good to be true" aspects of all the stories and overnight zillionaires, cyber coin will never, at least in its current form, function as a valid currency.

Currencies must possess a variety of characteristics, among which one of the most important is "store of value". This means if you take a currency for something real, you must be sure the currency you received maintains the value it had when you took it.

No problem you say? It will eventually, if not overnight, skyrocket in price?

Think Mexican Peso.

A skyrocketing price is not a store of value. Store of value must be in both directions. Which means both the buyer and the seller must not lose value over time in the transaction. Simply put, for every winner in cyber coin, there is a loser. Which is why currencies must be STABLE, and not fluctuate in value and what it can buy.

investors thinking they will gladly take a cyber-coin for payment. Ah, but would you pay one out to buy something?

A currency must remain at relatively the same value over time to be a valid receipt of products or services, as that is what a currency is, a receipt of a consistent value.

Cyber-coin is anything but price stable. Just look at its run up, and most recently, its 'run down", and I can't say I am surprised in the least bit.

Besides it roller coaster action, a few other things bother me about sinking thousands into cyber-coin.

Elon Musk, the maverick founder of Tesla, appeared on Saturday Night live and then two days later tweeted Tesla would no longer accept bitcoin in the foreseeable future. That hammered bitcoin down 12%.

I don't know about you, but I don't want oodles of my hard-earned money susceptible to obliteration when a single tweet or statement can crash it. The last two weeks has crashed it in half.

No thanks

As for being an indestructible cyber space currency no one government can manipulate, governments don't have be able to "get at it" to eliminate it.

All they have to do is outlaw its use, and/ or remove the apps that trade it. Bitcoin crashed 4% when the country of Turkey outlawed its use as payment. They are not the

The following countries have in some form or another banned, restricted or warned against cyber coin usage: : Kyrgyzstan, Bolivia, Bangladesh, Iran, Nepal, Thailand, India, Denmark and Ecuador.

This list is bound to grow larger as sovereign currencies, the checkbook of governments, are threatened by the use of cyber coin. Just think what would happen to the price if the U.S. or another major super power took similar steps?

Again, no thanks.

Someday cyber-coin may find its rightful place among monetary instruments, but for now, it scares the hell out of me.

Warning to Remote Workers: Out of Sight Could Mean Out of Job

Although debate continues about whether the business world will return to normal even after most people have the COVID-19 vaccine, the expectation is that many companies will soon call employees back to the office.

Some workers may still get to work part-time from home, and some businesses will make remote work permanent. But tension between owners and workers is building as it becomes evident many employees are resistant to giving up working from home. In a survey, 65% said they want to work remotely full-time after the pandemic. And in a poll conducted by LiveCareer, 29% of working professionals said they would quit if they couldn't continue working remotely.

But those who push back against ownership's preference to return to the office might paint themselves into a corner, especially if they aren't in a position to quit, says Rod Robertson, Managing Partner of Briggs Capital (www. briggscapital.com), international entrepreneur, and author of Winning at Entrepreneurship: Insider's Tips on Buying, Building, and Selling Your Own Business.

"The expected stimulus money will dissipate by the third quarter and as companies continue to struggle, the cuts will begin," Robertson says. "Once we reach herd immunity, companies will be deciding whether it makes sense to keep expensive office space.

"Corporate gravity will begin to pull key workers back to the office, and there will be resistance from employees. And those companies that do choose to go remote at least part of the time may still downsize. mean out of mind, or out of job, The bottom line for workers is, if when it's time to trim the ros-

steps to ensure they stand out."

Robertson says employees who continue to work mostly from home should do these things to keep their performance and communication levels high:

Show up. Even if a company allows employees to work from home permanently, Robertson says they would be wise to go to the office at least one day each week. "Out of sight might also

to lower your skill level, your engagement, and your productivity. Employees need to make the time to have facetime in the office and stay in the groove with ownership and management. You can't do that as well at home relying on technology."

Show the human touch. "When we achieve herd immunity, faceto-face meetings with co-workers, managers and clients should be 20 to 25% of someone's portfolio of time," Robertson says. "Zoom they want to work remotely, they ter," he says. "Working from meetings are a pain because you

would be wise to take the extra a distance all the time is going have to set them up. Remote employees should prioritize live voice communication with colleagues, managers, and clients in order to stay in the game. Picking up the phone to talk with someone keeps the relationship alive and brings more clarity than constantly texting or emailing."

Push your boss to measure you quantitatively. "Woe to the remote employees who believe they are not under increasing scrutiny – downsizing is on the way," Robertson says. "The good employees working at home will before selling.

have more reporting mechanisms in place. Show your boss your genuine enthusiasm by being proactive and coming up with more measurables for your performance."

Do extracurricular work. "The question is, how can you be front-and-center with the boss?" Robertson says. "One way is to do extracurricular work by bringing relevant and helpful articles to ownership. Develop a thesis for those articles to show that you're a thought leader. Executives and managers are flooded with emails, so the smart employees send a synthesis of an article that's to the point.

"Businesses can't afford slippage," Robertson says. "Once there is herd immunity, the remote work issue shouldn't be just about where employees feel they are most comfortable, but how they can be the most valuable and effective."
