DOBBINS, CA (MPG) - Yuba River Endowment Vice-President, Joe Maslan, was joined by Yuba County Supervisor, Randy Fletcher, to present the Foothill Food Pantry volunteers with 3,000 pounds of locally grown rice.

The rice was a portion of last month's 7,800 bags donated to the Yuba-Sutter Food Bank, all of which has now

"This generous donation is enough rice for three to four months of food distributions," said Lisa Mulder, Foothill Food Pantry President. "We usually receive perishable goods that must be used within days. This rice is a fantastic long-lasting staple that our community will be excited to receive."

During their weekly food distribution event, the Foothill Food Pantry serves about 120 families. In 2020, the Pantry distributed over 4,100 food boxes, providing for over 12,000 people. Originally founded over 30 years ago

by the Lake Francis Grange, the Pantry became an official non-profit organization in 2015. The Pantry is located at 10775 Texas Hill Road, Dobbins, and distributes every Thursday from 12:00pm - 1:30pm. The pantry is staffed by volunteers and funded through donations and grants.

"Food insecurity in the foothills has always been an issue," said Maslan. "The Yuba River Endowment board is committed to helping our most severely been distributed to Yuba County food disadvantaged residents. As the representative from the Browns Valley Irrigation District on the Yuba River Endowment board, it's an honor to be part of this donation to help foothill residents."

The Yuba River Endowment is a nonprofit organization created by Yuba County farmers. Since formation in late 2019, the Endowment has donated over \$160,000 to support Yuba County ag education, provide food resources, veteran's support, and much more.

In a truly win-win situation, the farmers' water is used to provide the required flow levels to protect endangered fishes on the Yuba River, then once past this critical point, the water can be sold to drought-stricken areas of the state. Proceeds from these transfers provide the funding for the Yuba River Endowment.

"As the County Supervisor for this area in the foothills, and a Yuba Water Agency Director, this donation is a full circle moment," said Fletcher. "Our Yuba County farmers are the backbone of our local economy, a great partner in water resources, and are now literally feeding our local residents through their Yuba River Endowment. I'm proud to be here to support their efforts."

MARYSVILLE, CA (MPG) - The First 5 Yuba County Children and Families Commission has committed \$1,341,000 (\$447,000 annually) of Proposition 10 funds to be released through a formal Request for Proposal (RFP) for fiscal years 2021/2022 -2023/2024. The First 5 Yuba Strategic Partners RFP and funding will be aligned with the 2021-2026 First 5 Yuba Strategic Plan in order to continue to promote the First 5 Vision and support the overall health, development and wellbeing of children 0-5 and their families in Yuba County.

The vision of the First Five Yuba Commission is that all Yuba County children are healthy and thriving in safe and nurturing family environments and ready to succeed in their educational experiences.

The First 5 Yuba County Children and Families Commission is seeking Requests for Proposals (RFP) from organizations interested in providing direct services to children prenatal though age five and their families living in Yuba County. These services will be funded by the Commission using Proposition 10 funds and will fund programs targeting one primary Strategic Goal Area as described in the 2021-2026 First 5 Yuba Strategic Plan. Applicants are to request funding in one Strategic Goal Area that is commensurate with the complexity of services, geographical scale, number of participants to be reached, and the proposed need.

The Commission will consider proposals from governmental, nonprofit and for-profit entities and organizations, including city and county agencies, school districts, local service organizations, neighborhood and community-based agencies, faith-based and civic organizations, and businesses. The award is competitive based on the overall capacity and experience of the agency serving the target population, quality of the program, level of need addressed, and desired results.

Proposals will be reviewed, scored and selected in accordance with the criteria and procedures set forth in the RFP guidelines. Successful applicants will be expected to sign a formal agreement with the Commission for the provision of services outlined in their proposal.

Three Arrested in Plumas Lake Mail Thefts

YUBA COUNTY, CA (MPG) - On 3/8/2021 at approximately 5:30 a.m., a Yuba County Deputy on Patrol in Plumas Lake located and subsequently arrested three suspects that were in possession of stolen property reportedly taken overnight from various neighborhood mailboxes in the Plumas Lake area. Arrested for Burglary, Possession of Stolen Property and Identity Theft were Joshua Collins age 33, Sean Smiley age 26, and Samuel Smiley age 30, of Oroville. Additionally Collins had an active warrant in Butte County for a parole violation.

The patrol deputy contacted the three men in a red 2008 Nissan Altima in the 1700 block of Stinson Way in Plumas Lake. The driver of the vehicle was unlicensed and the story they provided as to what they were doing in the area was suspicious to the deputy. Ultimately, during an inventory search of the vehicle prior to impoundment, dozens of items of suspected stolen property were located in the car and later confirmed stolen from several cluster mailboxes throughout the Plumas Lake community. The investigation remains open and ongoing while deputies continue to locate victims and confirm property ownership of the multiple suspected stolen items located in the suspects' vehicle.

Yuba County Sheriff has reported the incidents to the United States Postal Inspectors. Anyone with further information about this crime is encouraged to contact the Sheriff's Office at 530-749-7777.

Upon Yuba County Sheriff Deputies arrival, they located a woman with obvious area as a result of a car

Yuba County Sheriff Detectives responded to the scene and assumed the investigation. A suspect, identified as 43-year-old Bryan Adams and husband of the deceased, has been detained on a Ramey Warrant for Homicide. The suspect is currently hospitalized in the Sacramento

CAL FIRE Officers Arrest Multiple Suspects for Arson

BUTTE COUNTY, CA (MPG) - In the early hours on January 11th, 2020, an occupied residence in Oroville, CA was set on fire in an intentional act of arson. During the same time frame, approximately 9 miles away in Gridley, CA, a vehicle was set on fire in another intentional act of arson.

Over the course of a year-long investigation CAL FIRE Law Enforcement Officers learned that Ember Lee Bert, Levy Dylan Williams, and Andrew Joseph Tune were allegedly responsible for the planning and commission of the crimes.

Arrest warrants were issued out of Butte County for Bert, Williams, and Tune for one count of Penal Code 451(b) arson to an inhabited structure and one count of 451(d) arson to property. Over the course of the last week all three have been taken into custody by CAL FIRE law enforcement officers. Tune and Williams have been booked into Butte County Jail and are being held on \$300,000.00 bail. Bert has been released pending future charges.

Hrenko had been previously acquitted by an Alameda County jury for lewd acts on a different victim in 2014. Ramsey said that victim bravely testified before the Butte County jury to convince the jury of Hrenko's predatory nature.

Ramsey said under the current state of the law, Hrenko will not be eligible for release until he is 58 years old, at which time he may be evaluated as a sexually violent predator requiring indefinite commitment in a state hospital. ★

East Linda Man Sentenced to Prison for Child Molestation

MARYSVILLE, CA (MPG) -This week Shawn Michael Jones (26), of East Linda, was sentenced to 14 years, 8 months, in prison for sexually molesting five different children in our community. He will be required to register as a sex offender and serve 85% of his sentence before being released on parole.

Jones was arrested in October 2020, after an investigation by the Yuba County Sheriff's Department. During the course of the investigation, it was determined that there may be other victims of sexual abuse who have yet to be identified. The Yuba County Sheriff's Department is requesting that anyone with information contact the Detective's Unit at 530-749-7777.

Parents often ask what they can do to prevent their children from becoming victims of child molestation. Unfortunately, child molesters are typically

trusted individuals, family members or friends. Child molesters are master manipulators who will try to isolate your child through secrets, gifts, and fear. It's okay to keep the

people you allow to be alone with your young children very small. Trust your gut, and don't let relatives or friends pressure you into allowing access to your child that makes you uncomfortable.

As a second line of defense, it is imperative to teach your children early the knowledge and skills they will need if they encounter a child molester. Start with proper names for their private parts. Help them understand that those are special parts that nobody is allowed to touch (except your parents, caregivers and doctor under appropriate circumstances). Teach them to trust their "uh oh feeling," and give them permission to run from an unsafe adult to an adult they trust. Help them understand

the difference between surprises and secrets, and that children never get to have secrets from their parents.

Finally, make sure your children know that if a person ever touches their private parts that they are not in trouble, and they need to tell their parents or another trusted adult right away. If your child does disclose sexual abuse, it's important to remain calm and listen. Contact law enforcement as early as possible without alerting the abuser. In Yuba County we have some amazing DA Investigators, detectives, and social workers who, have special training

for interviewing children who may have been abused. If abuse is discovered, the law enforcement officers, prosecutors, victim advocates and social workers will walk with you towards recovery and justice.

Drive-by Shooting 2 Dead and 3 Injured

MARYSVILE, CA (MPG) - On Saturday, March 6th 2021, residents at home in Yuba City were the target of a drive-by shooting that claimed

Shortly after 8:20 pm a gathering was taking place at a home in the 1400 block of Countryside Drive and Littlejohn Drive. It was at that time that the Yuba County Sheriff says the initial report claims a vehicle pulled up to the home and fired multiple rounds into the backyard where the victims were gathered. Two people were struck by the gunfire and killed. Three others were injured and transported to Adventist Health and Rideout Hospital for treatment.

On Sunday, Yuba County Undersheriff Scott Smallwood reported to Action News Now that the investigation was "evolving" and that his office had reached out to the Department of Justice for help processing evidence. The suspects have yet to be identified and the Sheriff's Department is not releasing the names of the victims out of concern for their safety.

Correctional deputies immediately responded and observed Silva and Borgman involved in an altercation. Correctional deputies immediately separated Borgman and Silva. Correctional deputies and jail medical staff noted Silva was not responsive, and they immediately began providing Silva with emergency medical treatment. Paramedics responded provided additional emergency medical



Butte County District Attorney's Office Investigators and Butte County Sheriff's Office detectives responded to the jail and began conducting an investigation. During the investigation personnel located evidence indicating Borgman and Silva were involved in a brief altercation and Silva expired during the altercation. Based on the evidence obtained during the initial investigation, Borgman was placed under arrest for a felony count of murder. This is an ongoing investigation. Butte County District Attorney's Office Investigators and Sheriff's Office detectives are actively investigating this incident.★

YUBA CITY, CA (MPG) -Assemblyman James Gallagher (R-Yuba City) alerted the public of a new attempt to circumvent local control over dangerous needle giveaway programs. Gallagher is encouraging California counties, cities and members of the public to make the intent of state law

their voices heard in opposition to the proposed regulatory changes by the California Department of Public Heath (CDPH).

"Everyone saw what a disaster the needle giveaway program was in the City of Chico," said Gallagher. "The state should be spending more time on vaccine delivery and opening schools and less time trying to put needles in the hands of drug addicts."

some local governments that do not support the establishment of authorized Syringe Exchange Program (SEP) are taking steps to circumvent

by blocking SEPs from operating through restrictive local ordinances. By changing the regulations, CDPH is attempting to completely eliminate local control over the establishment of these needle giveaway programs.

Gallagher is urging every City government, County government and concerned community member to log their opposition to the regulations.

LETTER TO THE EDITOR

The Marysville City Council approved Resolution No. 2021-XX approving a Plan Review application for a 71 Unit Affordable Complex in an R-4 Multi-Family Zoning District at 1315 Yuba Street on the block bounded by E. 13th, E. 14th, Ramirez and Yuba Streets (formally the Caltrans District 3 Corporation yard).

With approximately 50% of Marysville properties being rentals, and an estimated 50% of those being subsidized and tax free including government buildings, Marysville can hardly afford another Tax-Exempt property.

The concerned citizens of Marysville are troubled by the lack of consideration and planning regarding the following:

- An increase in traffic congestion on Ramirez Street and Yuba Street particularly accessing E. 12th street (Highway 20). The apartment complex would add an additional 70-100 vehicles to an already congested traffic pattern. In addition, Yuba and Ramirez Streets are currently a truck diversion route to avoid the overpass on highway 70 coming into Marysville.
- Evacuation plans since there are

only two stop lights currently in East Marysville to access Highway 20 in case of an emergency. During the 2017 evacuation with only three main routes out of Marysville it took hours to access the highways to evacuate.

The construction of a three-story building is not well-suited to the surrounding housing. Currently, the only three-story building in East Marysville is located on the Marysville High School campus. In addition, the complex will impact our schools and our already strained police and fire services.

In conclusion, Marysville needs the tax revenue to fund the current needs of our City. For example: road repairs, replacement of sewer systems, and code enforcement. It is our feeling that the financial and future goals for Marysville should not be to provide more tax-exempt buildings that are counterproductive in our opinion and don't serve the citizens of Marysville.






Governor Delivers a State of Newsom Address

With the nation at war in 1944, tunesmiths Harold Arlen and Johnny Mercer wrote an uplifting song for a morale-building movie, "Here Come the Waves."

"You've got to accentuate the positive, eliminate the negative, latch on to the affirmative," Bing Crosby crooned. "Don't mess with Mister In-Between."

It's doubtful that Gov. Gavin Newsom, born in 1967, ever saw the movie or heard the song, but he was humming it last week in an elaborately staged State of the State address in an empty Dodger Stadium.

Newsom boasted that California, with himself at the helm, has survived the COVID-19 pandemic and "so now, we look ahead California can-do spirit with the energy and optimism that defines us we will beat this virus and realize our dream of a California for All."

It was clearly a campaign speech by a politician who faces the likelihood of a recall election later this year, using his official pulpit to persuade voters that he's been working hard for them and thus deserves to remain in office.

for instance, that avoid early spikes in has remained one of the lowest per capita in the nation" – and downplayed the negative. He glossed over the complete meltdown at the Employment Development

Department, an erratic vaccination program and his passive attitude toward reopening schools until the recall was on the verge of qualifying.

Newsom dismissed the negatives in one brief passage: "And look, we've made mistakes. I've made mistakes. But we own them, learn from them, and never stop trying."

And he referred to the recall only obliquely, saying, "We won't change course just because of a few naysayers and doomsdayers. So to the California critics, who are promoting partisan power grabs and outdated prejudices, and rejecting everything that makes California great, we say this: we will not be distracted from getting shots in arms and our economy booming again."

Overtly political aspects became especially evident in recent weeks when the recall movement neared the threshold of 1.5 million signatures on petitions to force an election. Suddenly, the state eased up on restrictions by redefining its county-by-county "tiers" and Newsom, after months of passivity, pushed hard to reopen schools.

Newsom cited lower infection rates as his rationale, but he had done that previously in easing up on restrictions only to reimpose them when infections spiked upward. He's betting that easements will continue and that as children return to classrooms, businesses reopen, unemployment rates drop and Californians' mood brightens, he can accentuate the positive and beat the recall.

49 percent of GOP men say they won't get vaccinated - PBS poll | 11 March 2021 | Nearly half of U.S. men who identify as Republicans said they have no plans to get the coronavirus vaccine, according to a new PBS NewsHour/NPR/Marist poll released Thursday. The study, which surveyed 1,227 U.S. adults from March 3 to March 8, found that approximately 30 percent of Americans overall said they do not plan on getting vaccinated. The poll found a higher amount of opposition among Republicans, with 41 percent saying they would not get one of the three federally approved coronavirus vaccines and 49 percent of Republican men saying the same.

House Passes Gun-Control Bill Expanding Background Checks on Firearm Sales | 11 March 2021 | The House of Representatives on Thursday passed a bill expanding background checks on individuals who are seeking to purchase or transfer firearms as top Democrats have vowed to reintroduce gun control measures. Rep. Mike Thompson (D-Calif.) sponsored the measure known as H.R. 8, as Sen. Chris Murphy (D-Conn.) introduced the companion bill in the upper chamber. The bill, titled Bipartisan Background Checks Act of 2021, passed 227-203, receiving eight Republican votes and one Democrat vote against. Five Republicans co-sponsored the bill along with several Democrats.

Multiple CoVid Stimulus and Relief Packages Flowed Out of Washington

In 2020, multiple CoVid stimulus and relief packages flowed out of Washington. Some programs you have may heard about and possibly benefited from, but much more money did not go to consumers, but instead assisted the financial conduits of the economy. Some might rush to call those conduits "Wall Street", but that is a topic for a differ-

With another 1.9 trillion dollar package about to be approved by Washington, any talk of excessive government spending is relegated to limiting package amounts rather than to killing these programs all together.

With that in mind, little concern seems to exist in Washington or in the news media as to the dangers of massive government spending. To this analyst the silence is deafening.

Since the government gets its money from taxing it, borrowing it or creating it out of thin air, there is historical precedent as to the hazards of excessive government spending. The word "excessive" is key and when that spending becomes excessive is a topic of debate.

A common metric for measuring just how much is too much when discussing government spending is the ratio of public debt to Gross Domestic Product (GDP). GDP is the total amount of monetary transactions for all goods and services within a country.

Although there is more than government spending measured in the "public debt" definition, the correlation of the two is commonly accepted among certain scholars.

It was once thought that a debt to GDP ratio exceeding about 90% meant a serious risk of an eventual sovereign default (a country unable to meet its debt obligations).

Needless to say, a sovereign default is about as serious as it gets when it comes to a negative economic event. Even a default from a relatively small country can cause serious economic damage to the global economy. The bigger the country, the more severe the damage. The event can cause worldwide financial disruptions at minimum, and the risk of a total global financial implosion in the worst case. Think 2008/2009.

With modern central banking having more and more influence over global financial mechanisms, the ratio metrics have been repeatedly tested, and the amount of how much debt is too much is constantly being revised upwards. During the last few decades, as more countries have gone further and further into debt yet failed to succumb to it, the spending continues to accelerate in just about every country of the world.

Some argue central banks bailouts have mitigated the risk while others claim bailouts have only postponed the day of reckoning. The limits continue to be tested and CoVid-19 has only pushed debt levels even higher.

Japan is an egregious example of pushing the envelope, with current public debt levels surpassing the 230% level.

At the conclusion of the 4th quarter of 2019, United States public debt-to-GDP ratio was 106.7%. Today's U.S. estimate is over 120%. Albeit far below Japan's, it is still argued to be excessive when compared to initial theoretical levels.

As the upper limits are tested, it is important to remember a failure of a GDP/debt ratio means a sovereign default.

The ramifications being so dire, it would be best not find out what that limit is by exceeding it. At that point, it would be too

Much like loading a bridge with more and more weight to see how much it would take to cause its collapse, the reality is the bridges failure would destroy the entire structure and everything on and under it.

Extrapolating that into the discussion of what is a toxic GDP/debt level, the answer should be arrived upon by theory and ongoing study, and not by real world experimentation.

To instead keep adding more and more debt until something breaks, given the consequences which could be regional at best, and global at worst, is to tempt a redo of 2008/09 financial implosion which almost wrecked the entire global financial system.

With ever increasing global debt levels, theory suggests each subsequent debt-failure event is larger than the one that preceded it, and they have been.

And that dear reader, means another one of these debt/GDP failures would spawn an event which would be unparalleled in its

Covid-19 Vaccines Reach More Farm Employees

Availability of COVID-19 vaccines for farm employees has been increasing in a number of California's rural counties. Farmers have joined with local health agencies and nonprofits to sponsor vaccination clinics, and to encourage their employees to receive the vaccines. A Fresno County supervisor says the vaccine has had "wide acceptance" among farm employees. Farmers say they have conducted education efforts on vaccine safety.

Texas Freeze Could Affect California Citrus Demand

Demand for California-grown citrus fruit may rise because of crop losses in Texas caused by its mid-February freeze. Farmers in Texas lost much of their grapefruit and Valencia orange crops. California farms may produce more of both this season, according to a new estimate. Government forecasters also expect more tangerine production in California, but say crops of lemons and navel oranges could be smaller.

Farm Groups Renew Support for Immigration Bill

With a House vote expected later this month on an agricultural immigration bill, farm groups have renewed their support for the measure. The Farm Workforce Modernization Act intends to improve agricultural visa programs and accommodate immigrant farm employees already in the United States. It passed the House of Representatives in 2019 and sponsors have reintroduced it. The California Farm Bureau calls the bill "a top priority" and other farm groups have endorsed it.

Award For Agricultural **Teachers Names Finalists**

Six high school teachers from California have been named finalists for an award that recognizes outstanding agricultural instructors. The Golden Owl Award is sponsored by Nationwide, which presents it in California in partnership with the California Farm Bureau and California FFA. This year's six California finalists teach agriculture at high schools in Angels Camp, Eureka, Lakeside, Madera, Santa Maria and Tulelake.





Is Buying a Second Home on Your2021 To-Do List?

Owning a second home can provide retirees – or even younger families – a mountain retreat or a house at the beach for those family vacations or quick weekend getaways.

But if buying a second home is on your list of New Year's resolutions for 2021, be sure to consider all the upsides and downsides before committing, says Patrick Rush (www.patrickrushtfa.com), CEO of Triad Financial Advisors and the ForbesBooks author of Gain Big and Give Back: Financial Planning with Intention.

"Many retirees end up regretting it," Rush says. "They feel they are forced to go to that second home every weekend just because they spent so much on it. A vacation property or second home can certainly provide a lot of joy, but it rarely works out financially." That doesn't stop people from buying them, though.

The National Association of Home Builders estimates that Americans own about 7.4 million second homes, which is about 5.6 percent of the total housing stock.

"People tend to purchase a second home either as a rental property or a vacation home, which they might also rent for part of the year," Rush says. "But unless you're in a hot real estate market, the return on investment usually isn't worth the hassle. There are better ways of growing your money."

Rush says a few things to know about investing in a second home include: **Real** estate doesn't automatically mean easy money. People mistakenly believe real estate provides a guaranteed return, but that's not always true. Rush recalls one client who, over Rush's vehement objections, withdrew all of his retirement money to build an expensive second home. The client was certain the house would pay off, but he eventually was forced to sell it for half his investment. Consider the overall impact on your life. Most people don't have endless streams of money, even if they have done well for themselves financially. So, a splurge in one area often requires a sacrifice in another. "If you want the second home, then perhaps an Alaskan cruise won't be in the budget," Rush says. "It comes down to what your priorities are." Upkeep can become overwhelming. People tend to overlook the ancillary costs that make owning a second home expensive, Rush says. Take those into consideration as you make your decision. "Property taxes, homeowners association dues, insurance, and maintenance start to add up," he says. "Renting the house out when you aren't using it does provide an income stream, but managing the property and dealing with tenants is a hassle. You can hire a property manager, but that has its own disadvantages." Renting can work just as well. While it might feel exhilarating to own a mountain home in North Carolina or a Pacific Ocean beach house, Rush says another option is simply to rent a place for a week or a weekend whenever you're in need of a getaway. None of this means a second home is always a mistake, Rush says.

One client whose parents died and left her a generous inheritance wanted to invest the money in a beach home. Rush warned her of the potential pitfalls. She teared up. She agreed it might not be the best financial decision, but when she and her sister were growing up, their parents took them every summer to Sunset Beach on the North Carolina coast. She wanted to continue that tradition for her children, her sister and her sister's children

"It was a reminder that it's not always about the numbers," Rush says. "You have to weigh the return on investment against the emotional benefit. Financially, it wasn't the best choice, but to her, it meant so much more. It was about keeping her parents' memories alive. Some things truly matter more than money."
