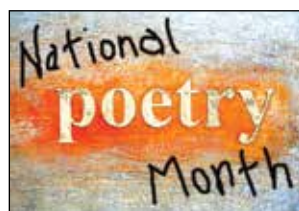

## Marysville's Long-Term Rating Raised One Notch

**MARYSVILLE, CA (MPG)** - The City of Marysville is pleased to announce that effective February 3, 2021, S&P Global Ratings raised its long-term rating to 'A+' from 'A' on Marysville, Calif.'s pension obligation bonds (POBs) outstanding. At the same time, S&P Global Ratings raised its long-term rating to 'A' from 'A-' on the city's outstanding certificates of participation (COPs). The outlook is stable.

"Further supporting the raised ratings is our view of the city's available general fund reserve and liquidity levels that have been maintained at very strong levels during the previous three years," said S&P Global Ratings credit analyst Michael Parker.

"The rating action partially reflects the discovery of an error in our analysis regarding the city's participation in the Yuba City metropolitan statistical area, or MSA," analyst Michael Parker. In our prior review of the city (Sept. 6, 2019), the Yuba City MSA was incorrectly assessed as weak rather than strong, negatively affecting the city's economic score applied through our "U.S. Local Governments General Obligation Ratings: Methodology And Assumptions" criteria (published Sept. 12, 2013).

We note that the recessionary pressures from the COVID-19 pandemic as well as the statewide shelter-in-place order that went into effect in previous months have not substantially affected the city's revenue streams. According to estimated fiscal 2020 (June 30 year-end) financials, general fund revenue fell roughly 3.4% due to reduced economic activity affecting overall sales taxes. However, management was largely able to offset the modest revenue loss by delaying planned capital projects. In addition, officials are currently budgeting to increase overall general fund reserves by fiscal 2021 year-end. Although we expect the ratings to remain stable, S&P Global Ratings believes uncertainty remains high regarding the evolution of the coronavirus pandemic.

The City of Marysville will be able to utilize this increase in rating to their advantage on future projects when funding is required – saving the City a limitless bottom-line. ★

## Sutter County's Award-Winning High School Student Speech Contest Returns

- The County of Sutter's high school speech contest, which won national recognition for engaging youth in the local government process, returns May 6.

The "Public Business From The Floor" high school speech contest was designated the best entry in the category of Civic Engagement and Public Outreach in the National Association of Counties 2020 Innovation

Awards competition.

The speech contest, open to all high school age students who either attend a public or private Sutter County school or live in Sutter County, was designed to foster an understanding of the right of Americans to petition their government and to provide the opportunity to directly address the County Board of Supervisors on matters under their jurisdiction.

The speech contest is sponsored by the 20-30 Club of Yuba City-Marysville. In addition to providing cash

prizes, members of the club in previous competitions have joined the Board of Supervisors as judges.

"The speech contest is an outgrowth of our Board's desire to engage the youth of this community and build an understanding and appreciation for how local government functions," said Board Chairman Dan Flores. "The success of the program, which was recognized by NACO, is the result of the effort of the students, their teachers, their parents, and the participation of the 20-30 Club. This

is a community that values its youth, and that was reflected in the award from NACO."

Unfortunately, as a result of COVID-19 concerns, there was no competition in 2020. But the competition returns on May 6 at 6 p.m. at a location still to be determined. Tentatively, the competition will be held at the chambers at Yuba City Hall, where the Board of Supervisors is conducting its regular meetings, but the County may establish an outdoor location to

# Poor Salmon Forecast for 2021 Suggests Restricted Fishing Season

**SAN FRANCISCO, CA (MPG)** - Officials forecast there are about 271,000 adult Sacramento Valley salmon now in the ocean off the West Coast. This compares to 473,183 forecast a year ago at this time and suggests some restrictions are likely to be enacted in the 2021 salmon fishing season. In the months ahead, officials with the Pacific Fisheries Management Council will use this forecast and other information to set times and areas open to both sport and commercial ocean salmon fishing for 2021. If restrictions are deemed necessary, we'll learn of them then.

Although 473,000 plus salmon were forecast last year, after the number caught was added to those that returned to spawn, the real number came out to be 370,000, about 22 percent fewer than forecast.

About 138,000 adult salmon returned to spawn in the Sacramento Basin during 2020, which is 105,000 fewer than the 233,000 salmon predicted to return to spawn. In addition, about 14,000 jacks, or two year old salmon, returned to spawn. The jack number in 2020 is used to forecast the number of adult salmon officials believe are now in the ocean.

One reason for the drop off in the 2021 salmon forecast is chronic over-diversion of Central Valley rivers. 2020 returns were also bolstered by added hatchery production in 2017 that contributed to the 2020 fishery. There was no additional hatchery production to aid 2021 fisheries and returns.

"It will be several more weeks before we begin to learn what kind of restrictions we might see on fishing this year, but the treatment of our salmon resource by freshwater managers as an afterthought is taking its toll," said GSSA president John McManus.

The number of fish that returned to the Klamath Basin, although slightly better than forecast, was still not enough to plot a 2021 commercial fishery free of concern. Commercial fishing in the Fort Bragg zone, stretching from Pt. Arena

to just north of Shelter Cove in southern Humboldt County, will likely be limited in 2021.

"If water managers would leave more water in the rivers during some of the drier years, we'd always have more salmon," said GSSA director and co-owner of Reel Magic Sportfishing Mike Aughney.

Since baby salmon are considered one year old when they leave the Central Valley in the spring, and most return as three year old adults, you can usually count on good fishing two years after lots of rain and snow. Although there was decent rain and runoff in 2019, this year's forecast is poor, in part because of the severe decline of salmon in the last drought.

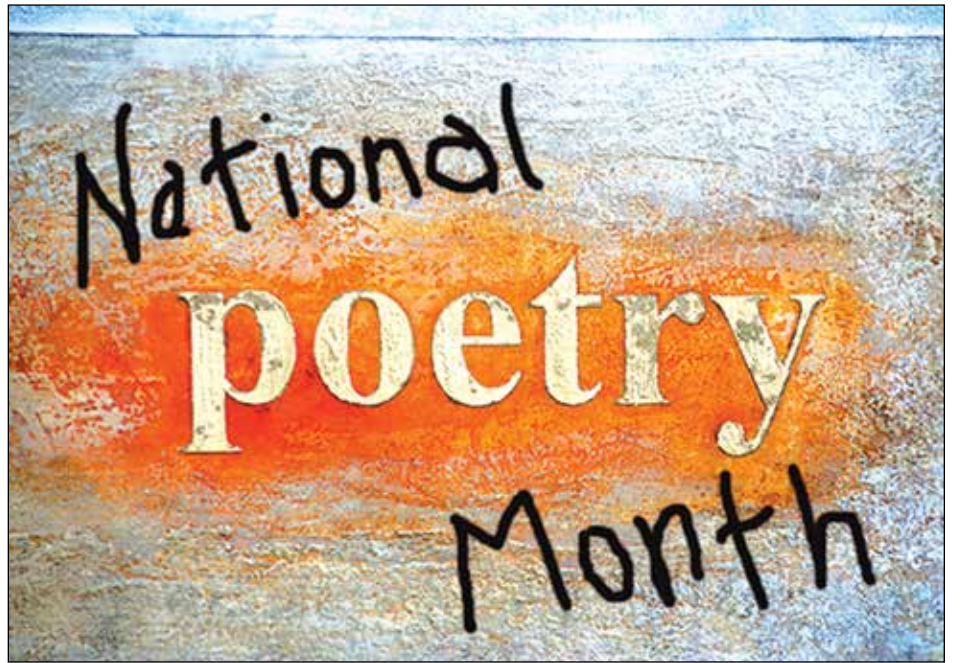
"Drought could revisit us almost anytime, including this year. We need to build and fortify in the good years so we don't get wiped out again in the bad," said GSSA secretary Dick Pool.

"That's why GSSA is working overtime to get salmon recovery, habitat improvements, and hatchery improvements on the state's radar."

The Golden State Salmon Association ([www.goldenstatesalmon.org](http://www.goldenstatesalmon.org)) is a coalition of salmon advocates that includes commercial and recreational salmon fishermen and women, businesses, restaurants, a native tribe, environmentalists, elected officials, families and communities that rely on salmon. GSSA's mission is to restore California salmon for their economic, recreational, commercial, environmental, cultural and health values.

Currently, California's salmon industry is valued at \$1.4 billion in economic activity and 23,000 jobs annually in a normal season and about half that much in economic activity and jobs again in Oregon. Industry workers benefiting from Central Valley salmon stretch from Santa Barbara to northern Oregon. This includes commercial fishermen and women, recreational fishermen and women (fresh and salt water), fish processors, marinas, coastal communities, equipment manufacturers, the hotel and food industry, tribes, and others. ★

## FCC's \$50 Internet Subsidy Will Help Yuba City Residents

**SEATTLE, WA (MPG)** - Late last week the FCC unanimously voted to establish a \$3.2 billion Emergency Broadband Benefit Program to provide qualifying low-income households with a \$50 discount on their internet bills. The FCC intends to open the program up to those who need it within 60 days.

According to doxo, the all-in-one online and mobile bill pay service, residents in Yuba City pay \$121 on average per month on Cable/Internet (the national average is \$115/month). Given this amount, the \$50 subsidy is well worth taking advantage of, especially when considering that residents in Yuba City pay \$992 on average on the

eight most common household bills (minus rent/mortgage) per month (the national average is \$1016).

Here is a look at what Yuba City residents pay per month for each bill pay category, including Cable/Internet: Utilities - \$392/month; Auto Loan - \$441/month; Auto Insurance - \$148/month; Csble/Internet - \$121/month; Mobile Phone - \$97/month; Health Insurance - \$99/month; Life Insurance - \$97/month; Alarm/Security - \$97/month.

The above data, which doxoINSIGHTS has for Yuba City as well as over 900 towns and cities, breaks down bill payments into eight different categories, including utilities, auto loans, cable/Internet and more. ★

Mom was here at the nursery nearly every day up until she was 89. She was a wealth of knowledge and enjoyed talking to all the customers who came in.

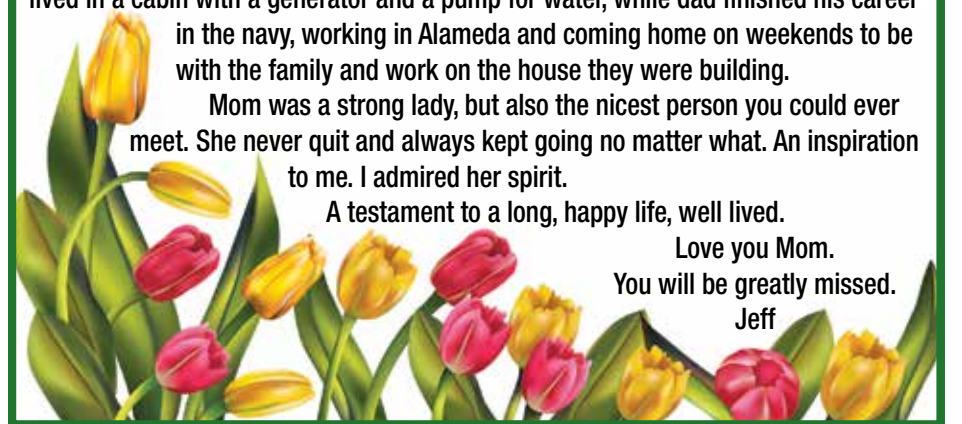

Senator Grove was elected to represent the 16th Senate District in November 2018, which includes portions of Kern, Tulare, and San Bernardino counties. In January 2019, she was elected Leader of the Senate Republican Caucus where she served in that capacity for two

years. As the Republican Leader-Emeritus, Grove remains a committed representative working with legislators to advance policies that benefit the constituents, businesses, and communities within Senate District 16.

Prior to her election to the California State Senate, Shannon Grove was the first woman veteran elected to the California Legislature as she served the 34th Assembly District from 2010 to 2016. Shannon Grove was born and grew up in Kern County, California. She attended Nueva Continuation High School in Lamont, California, and graduated from Arvin High School in Arvin. After graduating from high school, Senator Grove served in the United States

Army. While stationed in Frankfurt, Germany, she witnessed the fall of the Berlin Wall in 1989.

Following her service to our nation, she established a staffing company with her sister-in-law called Continental Labor and Staffing Resources. Senator Grove currently serves as the CEO.

Senator Grove is an advocate for small business, school choice, the developmentally disabled, farmers, and families. She currently lives in Kern County with her husband, Rick. They are the proud parents of five children and eight grandchildren.

There is no membership requirement to attend, and everyone is welcome. Doors open at 6:00 pm; meeting begins at 6:30 pm. Come early to register, socialize with like-minded patriots, and get a good seat.

## Drinking Green Beer? Use a Designated Driver!

**YUBA CITY, CA (MPG)** - St. Patrick's Day celebrations in America date back to the country's founding. While this year's celebration may look a little different in your hometown, however you celebrate, make sure you and your friends stay safe this St. Paddy's Day by remembering one important piece of advice: Buzzed Driving Is Drunk Driving. This means that if you plan to drink any alcoholic beverage, it's essential that you plan for a sober designated driver beforehand. To help keep your community safe, the Yuba City Police Department is teaming up with the U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) to spread the message about the dangers of drunk driving. Even one drink can be one too many.

"We understand people are looking for a reason to celebrate, and we want our community members to enjoy the St. Patrick's Day, but we also want to impress upon everyone the importance of safe driving," said Sgt. Dennis Hauck. "If you've been drinking, make the right choice to find a sober driver to get you, and your friends, home safely. Before you put your keys in the ignition, remind yourself: Buzzed Driving Is Drunk Driving."

According to NHTSA, 10,142 people were killed in drunk-driving crashes in 2019. On average, more than 10,000 people were killed each year from 2015 to 2019 – one person was killed in a drunk-driving crash every 52 minutes in 2019. This is why the Yuba City Police Department is working with NHTSA to remind drivers that drunk driving is not only illegal, it is a matter of life and death. As you head out to the festivities, help us spread the word: Buzzed Driving Is Drunk Driving.

During the 2019 St. Patrick's Day weekend alone (6 p.m. March 16 to 5:59 a.m. March 18), more than three out of

five (63%) crash fatalities involved a drunk driver. In fact, from 2015 to 2019, a total of 280 lives were lost in drunk-driving crashes during the St. Patrick's Day period. Drivers should also keep an eye out for pedestrians who have had too much to drink. Walking while intoxicated can also be deadly, as lack of attention to their surroundings could put pedestrians at risk of getting hit by a vehicle.

"Drunk drivers are a continuing problem on our nation's roads, especially around days like St. Patrick's Day," said Sgt. Dennis Hauck. "People need to know that they can go out for a night of fun and return home safely by ensuring they have a sober driver take them home. Don't be the reason someone – including yourself – doesn't get home. Don't let St. Patrick's Day become an anniversary of a tragic night."

If you're the designated driver, make sure you keep that promise of safety to yourself and your passengers. It can be a long night, but people are counting on you, not to mention the other drivers, passengers, and pedestrians on the streets. Take the role of designated driver seriously – people are relying on you.

Party with a Plan - Before ever heading out, it's vital to plan ahead. Be honest with yourself: You know whether you'll be drinking or not. Follow these ideas to ensure you and your fellow partygoers stay safe.

Remember that it is never okay to drink and drive. Even if you've had only one alcoholic beverage, designate a sober driver or plan to use public transportation or a ride service to get home safely.

If you see a drunk driver on the road, contact the Yuba City Police Department.

Do you have a friend who has been drinking and is about to drive? Take the keys away and make arrangements to get your friend home safely.

promote in person participation. Students will have the option of participating in person or by Zoom.

Under the rules of the competition, students have up to three minutes to address the Board of Supervisors on any topic that falls under its jurisdiction. Participants must ask

the Board of Supervisors to take a specific action on a topic, such as adding, changing, or removing a local ordinance, authorizing funding for something, or advocating for action by the state or federal government.

The speech contest takes place at a real meeting of the Board of Supervisors,

attended by members of the public and subject to coverage by the media. The event will be streamed live on the County's video portal.

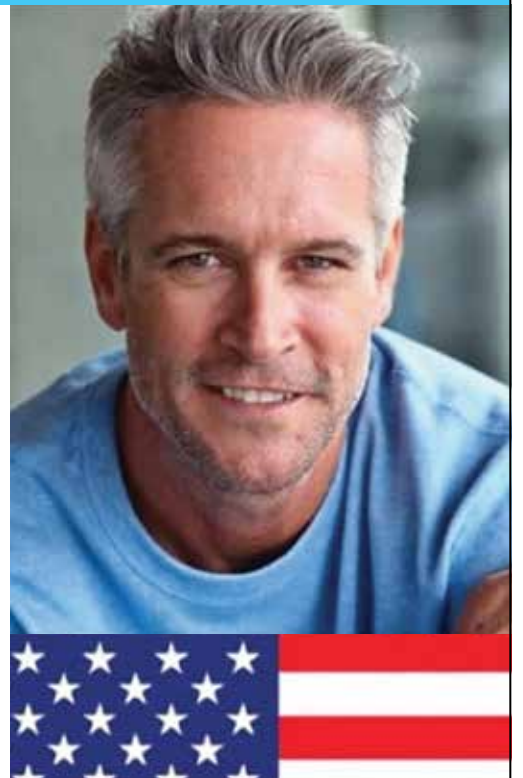

# Another Chance to Act on Housing

When he was running for governor three years ago, Gavin Newsom promised, rather absurdly, that he would spearhead a drive to build 3.5 million new housing units by 2025.

It was absurd because it would require California to escalate new construction from about 100,000 units a year to 500,000, which would be financially and physically impossible.

Once elected, Newsom backed away from that pledge, calling it “aspirational,” but he did attempt, a year ago, to once again focus attention on the state’s housing crisis by devoting nearly all of his State of the State address to it and the closely related homelessness issue.

Within weeks, however, his attention shifted to the COVID-19 pandemic and housing went on the Capitol’s back burner.

Meanwhile, California’s housing shortage has gotten significantly worse. This month, Newsom’s Department of Finance revealed that just 102,800 residential building permits were issued in 2020, down 8.8% from 2019’s total, which itself was a 3.8% drop from 2018.

Not only is overall construction headed the wrong

way, but all of last year’s decline was in apartments and other forms of multi-family housing where shortages are the worst. Moreover, when housing lost to fires, old age and other causes is included in the equation, the net gain last year was only about 75,000 units, under half of the state’s official yearly goal.

The cold fact that housing construction is headed the wrong way, and that housing shortages and high housing costs are feeding a high poverty rate and pushing employers and workers out of the state doesn’t seem to be having much effect on the Capitol.

Newsom and other politicians talk a good game, but don’t back up their words with action. What happened, or didn’t happen, to last year’s major housing bill is a telling example.

The measure, carried by Senate President Pro Tem Toni Atkins, was a modest stab at the housing issue’s biggest roadblock – the not-in-my-backyard attitudes in local communities. The bill would have made it easier to build duplexes and other low-impact multi-family projects on lots zoned for single-family homes.

Atkins’ measure cleared the Senate easily and had enough votes to pass the Assembly. However, due to conflict between Atkins and Assembly Speaker Anthony Rendon over legislative procedures, it was held in the Assembly on the last night of the session until just minutes before the midnight deadline, leaving too little time for a final Senate vote.

Newsom could have intervened in the petty squabble to get the bill to his desk, but didn’t, for reasons best known to himself.

The Legislature is back in session and its leaders and Newsom have another opportunity to match their words on the housing shortage with action – or not.

Atkins has introduced a new version of her failed bill, now known as Senate Bill 9, and others have proposed measures to speed up construction, most notably a four-bill package by Sen. Scott Wiener. The San Francisco Democrat has emerged as the Legislature’s leading housing advocate with a willingness to challenge the reluctance of many cities to build their fare share of low- and moderate-income housing.

The most important of the four is Senate Bill 478, which would neutralize local ordinances that effectively prevent construction of multi-family projects on land zoned for them by imposing unworkable land-to-building ratios.

The Atkins and Wiener bills challenge local governments’ much-cherished powers over land use, which is the most contentious but most important piece of the housing conundrum. They also will test the willingness of California’s political leadership to do something more than talk about the crisis.

# Cordua Irrigation District Joins Historic Lower Yuba River Accord

**MARYSVILLE, CA (MPG)** - Yuba Water Agency’s board of directors approved an agreement that adds the Cordua Irrigation District to the historic Lower Yuba River Accord, a model water management agreement that supports endangered salmon and steelhead, ensures water supplies for cities and farms and reduces conflict over water use.

“This new agreement significantly enhances how we manage the region’s surface and groundwater resources by bringing everyone together around the same common rules,” said Scott Matyac, Yuba Water’s water resources manager who worked closely with Cordua to develop the agreement. “We deeply appreciate the willingness of the district’s past and current board members to work together on this important effort.”

“Cordua appreciates the outreach and the effort by Yuba Water to include us in their effort to greatly improve conditions on the lower Yuba River for fish, wildlife and the people of Yuba County,” said Charley Mathews Jr., Cordua’s chairman of the board. “This greatly streamlines the activities of the Accord and enhances the reliability of water for agriculture and the environment in Yuba County.”

Cordua’s board of directors approved the agreement last month.

Implemented in 2008, the Yuba Accord resolved decades of controversy and litigation over instream flow requirements in the lower Yuba River. Instream flow is the rate of water flow required for fish, recreation and

water use at different times of the year at specific locations.

The Yuba Accord includes three separate but related agreements: a fisheries agreement with the California Department of Fish and Wildlife and certain non-governmental organizations, a water purchase agreement with the California Department of Water Resources and conjunctive use agreements with local water and irrigation districts.

Each year, Yuba Water supplies about 260,000 acre-feet of water to local water districts, called member units, which convey water supplies to Yuba County farmers and ranchers. Yuba Water has long sought to have all eight member units participate in the Yuba Accord to enhance coordination and management of surface and groundwater resources.

The conjunctive use agreements enable Yuba Water’s member units and their landowners and well owners to participate in the Yuba Accord’s Groundwater Substitution Water Transfer Program. Under this program, the member units pump groundwater as a substitute supply for the agency’s surface water deliveries in dry years. This allows Yuba River water to stay in the river during dry years, benefiting fish and wildlife species and water users in areas of need throughout California.

Yuba Water’s additional member units include Brophy Water District, Browns Valley Irrigation District, Dry Creek Mutual Water Company, Hallwood Irrigation Company, Ramirez Water District, South Yuba Water District and Wheatland Water District.

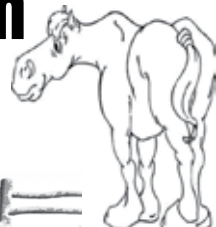
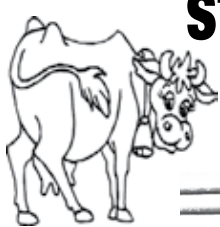

## Inmate Found Guilty of Assaulting Another Inmate

### Butte County District Attorney's Office

**BUTTE COUNTY, CA (MPG)** - Jail Inmate Found Guilty of Assaulting Another Inmate After a three day trial, a Butte County jury on Friday found a jail inmate guilty of seriously injuring a fellow inmate at the Butte County Jail in an August 2020 attack.

Cornelius Eugene McCauley, 28, of Chico was found guilty of assault with force likely to produce great bodily injury along with a special enhancement for great bodily injury.

McCauley was accused of an unprovoked attack in a housing pod at the jail, which resulted in the victim suffering a fractured skull

and repeated loss of consciousness. The victim was transported from the jail to Oroville Hospital for treatment and recovery.

Prosecutors presented evidence to the jury in the form of a jail surveillance video and testimony of a tower guard who witnessed the attack. The video showed McCauley “square off” in front of the victim inmate, a 49 year-old Oroville man in jail on a parole violation, then suddenly launch a vicious physical attack on the older inmate, beating him about the head.

No motive for the attack was ever definitively established.

McCauley was being held in the jail pending

sentencing for a series of car break-in burglaries in the Chico area between July 2019 and February 2020.

McCauley faces up to 16 years in state prison at his pending sentencing hearing on April 7, 2021, which includes an enhancement for a strike offense of robbery in 2014 in Sacramento.

District Attorney Mike Ramsey said Butte County is seeing increases of jail assaults due to recent reforms under AB-109 legislation and COVID-19 pandemic restrictions, both of which have contributed to jail over-crowding by limiting the transport of inmates who would otherwise serve time in state prison. ★



### Survey Confirms Erosion of Sierra Snowpack

Recording a fifth straight dry month, state surveyors report the Sierra snowpack has slipped further below average. Survey results released Tuesday showed the statewide snowpack at 61% of average, compared to 70% at the time of last month’s survey. Farmers have been warned to expect low water supplies, and say they will have to leave land idle as one response to the dry conditions.

### Farmers Look To Accelerate Wood-Disposal Alternatives

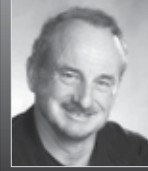
With a final decision having been made to phase out agricultural burning in the San Joaquin Valley by 2025, farmers seek alternatives for disposing of vineyard and orchard prunings. The state Air Resources Board voted last week to end the practice. Farmers can grind discarded wood and incorporate it into the soil, but that’s not now possible in all cases. Farmers asked the board for help in developing alternatives for wood disposal.

### Pandemic Takes Toll On County Fairs

County fairgrounds face a cash crunch, as the pandemic forces ongoing cancellations of events. A number of county fair boards have already voted to cancel their 2021 fairs. Some fairs have made accommodations for junior livestock sales, so students can still market their animals. In other locations, fairs have pushed back their traditional start dates, in hope pandemic restrictions will ease in time.

### U.S. Capitol Christmas Tree Will Come From North Coast

A tree from the North Coast of California will serve as the official U.S. Capitol Christmas tree. The Six Rivers National Forest, based in Eureka, announced it had been chosen to provide the tree, which will be placed on the west lawn of the Capitol in early December. It’s the first time a tree from the Six Rivers forest has been selected, and the fifth time a tree from California will serve as the Capitol Christmas tree. ★

## The Stock Market Sold Off Hard Last Thursday

The stock market sold off hard last Thursday and the reason is believed to be a spike in interest rates.

Although it is thought by many the Federal Reserve (the FED) controls all interest rates, they actually control only one part of the interest rate arena, called the Overnight Discount Rate.

This is the interest rate the banking sector pays to borrow money for overnight operations. These overnight loans are a mainstay of the banking system. Banks borrow huge amounts on a daily basis while other banks deposit excess money into the same pot. Think of this overnight facility as a huge octopus taking in money and handing it out every moment of every day, all to fund banking operations which keeps the economy functioning.

The rest of the global bond market however and its interest rate is not controlled by the Fed simply because it is worldwide and encompasses too much money.

Think of it as a much larger octopus which operates worldwide.

What is the bond market?

Bonds are simply IOU’s. There is a lender and a borrower like any other loan. The financial sector calls them by many names to confuse you. For example, when a city borrows money, it’s called a muni bond. When money is borrowed for a house, it’s called a mortgage. When the U.S. government borrows money, it is called a bond, a treasury or even a bill. No matter what the name, it is all just debt.

There are all sorts of bond markets, from corporate bonds to mortgage bonds and all types in between. Much of the world’s bonds are publically traded in the bond market.

Bonds pay an interest rate. The rate is to compensate the lender for loaning money. The riskier the borrower, the higher the rate is paid by the borrower to the lender.

The U.S. government might pay a very low rate to borrow money, while a financially strapped company might pay a higher rate.

Higher rates are also paid commensurate with how long the loan will be. The longer the loan, the higher the rate paid.

When things are calm in the world economies, rates remain fairly stable or may even fall. When investors becomes worried about something however, rates will generally start rising. When they rise quickly, it can signify the onset of a panic or at least the fact that

something is spooking market participants.

A worrisome world or economic event that threatens the stability of the financial environment can cause rates to spike, but the most common cause for a spike is a concern that inflation will start to accelerate.

As detailed in a previous Money Matters article entitled: “A look at Inflation” (<https://www.theunion.com/news/business/marc-cuniberti-a-look-at-inflation/>), I detailed how the creation of too much money by a government can cause “monetary” inflation. Monetary inflation is the most insidious type of inflation and can be the most damaging to an economy.

Trillions of dollars have been created for the CoVid-19 rescue and bailout packages by the U.S. government and indeed governments everywhere. It is no surprise that because of this fact, the bond markets may be sniffing out coming inflation, and perhaps a lot of it.

Since inflation is the loss of purchasing power of a currency over time, when the bond markets think inflation is coming, rates rise, as lenders require higher interest rates to compensate them for the loss of purchasing power, which will be caused by that very same inflation.

When rates rise, investors fear that the copious amounts of money currently flooding into the stock markets will slow, money will become tighter (harder to get and more expensive to borrow), and that will eventually cause a pullback in stocks.

The stock markets therefore look ahead, and the selling begins. If the rate creep turns into a quick jump in rates, stock market sell offs can intensify, which is what might have occurred last week. Only time will tell if the event was a one-off scare, or the start of something more insidious.

Be careful out there.
