## Photos for a Future

**GRIDLEY, CA (MPG)** - A nonprofit group is helping the victims of California wildfires by addressing some unmet needs of our neighbors as they rebuild.

Highlights & Shadows, out of the Vacaville area, documents and publicizes other nonprofit organizations by offering free photography and videography services. Kristina

Claudio, founder and photographer with Highlights & Shadows, says that with the upheaval of 2020, her group was called on by the SF Zion Church to something positive and uplifting for those in need that may not be immediate or obvious, such as clothing, food or shelter. We were challenged, "to do something, in a creative manner, to be able to shine the light to other people," says Claudio,

and the group desired to focus on something meaningful, "something that will last forever."

Therefore, the volunteer photographers of Highlights & Shadows have reached out to families affected by fire, including Camp Fire and Bear Fire survivors, offering free family photos and videography session to replace photos lost to the flames.

The response has been

pure gratefulness from the five families that they have been able to help so far. Claudio says that some have expressed that "this is the most thoughtful thing that someone has ever done for them...because those are lost memories that they can't really bring back... But this is a way where they are able to start anew and start new memories as well."

## Gallagher Responds to New Northern California Stay-at-Home Order

**YUBA CITY, CA** - California Assemblyman James Gallagher (R-Yuba City), who successfully sued Governor Newsom for abuse of power during the pandemic, issues the following statement in response to Newsom's new stay-at-home order that goes into effect tomorrow night throughout the "Greater Sacramento" region, closing hair salons and all outdoor/indoor dining, among other businesses and activities.

"ICU capacity should be looked at regionally because people do utilize different hospitals throughout the region, and healthcare facilities help each other if one hospital is getting at capacity. But any restrictions must reflect the true facts of the situation.

Earlier this week, the Governor and Dr. Ghaly both avoided answering a reporter's question about what ICU capacity is normally like this time of year. I hear this question a lot. Why not just report the data? Leadership is about giving people the facts and letting them make informed decisions.

Then the Governor's Director of Public Health publicly admitted that the decision to close outdoor dining wasn't based on science or the transmission of COVID. "This is an absolute slap in the face to restaurant owners and their employees who are struggling to pay the bills and feed their families. And it's yet another example of how this Governor's inconsistency and hypocrisy have caused the public to completely lose trust in his dictatorship."

## It was the Mission

If San Diego is a Navy town, then Yuba/Sutter is an Air Force town. It's going to be some time until we stop talking about the passing of Gen. Chuck Yeager. I had the opportunity to sit and talk with Gen. Yeager, and it is an opportunity I will cherish for the rest of my life. It is not often that one gets to speak to a living legend, a person who already has been inducted into the Hall of Fame, had movies and books written about them, and whose life story is used to train people as a motivational program.

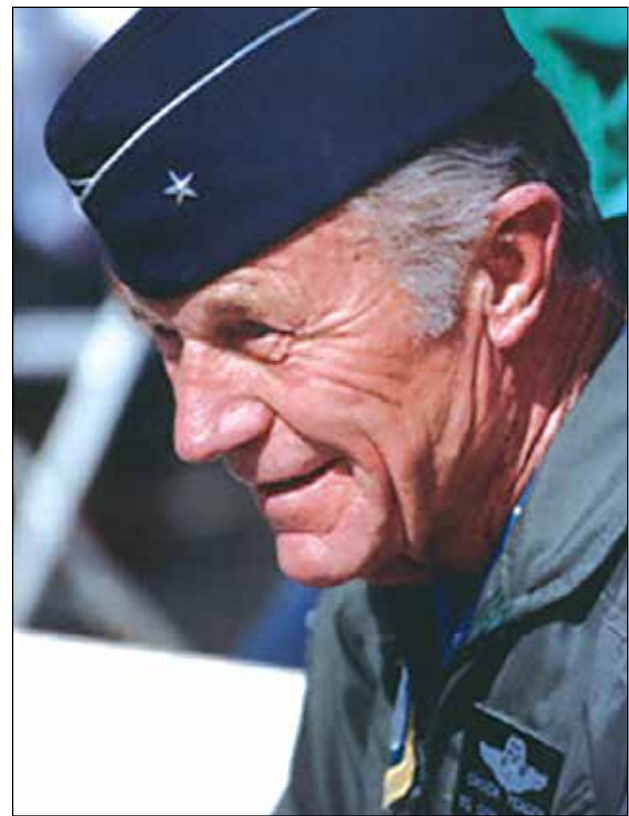
I met him at Charlie Matthew's house at some event Yuba Supervisor John Nicoletti invited me to. He really was a non-sense kind of guy. He certainly didn't come across as a famous person - or come across as arrogant. After about three minutes I became aware that my questions were quite rudimentary, and he was kind enough to indulge me and tell me one or two stories about World War II. I asked if I could get a photograph with him, and he

cheerfully agreed.

Gen. Yeager lived up the road toward Grass Valley in the foothills. Not long ago, the Yuba County Board of Supervisors named the back road into Beale Air Force Base after him. The road is the road he would use to go on base and shop at the PX.

It was a smart move to honor a world-famous local while he was still alive. We have seen a lot of base commanders pass through Beale AFB over the years, and all of them have been very aware that they have a neighbor who is a VIP, every one of them has waited with great anticipation for a visit with an American legend. Let's revisit just for a moment some of his more notable accomplishments: In 1944 Yeager became the first in his flight group to shoot down five enemies in a single mission. In that same year, he scored one of the first air war victories against the German Messerschmitt ME 262, a jet airplane. That accomplishment led to my favorite Chuck Yeager quote, "The first time I saw a jet airplane, I shot it down."

In 1947 he became the

first person to ever break the sound barrier by flying X1 at Mach 1.07. After a North Korean pilot defected to South Korea, he became the first American to fly a MiG-15. In 1962 he was named Commandant of the United States Air Force Aerospace Research Pilot School. In

1969 he was awarded his Star and promoted to Brig. General. When he was 63 years old, he drove the pace car for the 70th anniversary of the Indianapolis 500. He truly is one of the greatest of the greatest generation. He lived in a time when people

## Defeating Deplorables and Non-Essentials

Professor Klaus Schwab born in Ravensburg, Germany in 1938 is Founder and Executive Chairman of the World Economic Forum, the International Organization for Public-Private Cooperation. He along with an elite group of uber-wealthy world leaders has planned to eliminate nations and national sovereignty to have the world controlled by one government. To this end Schwab wrote the book, "The Great Reset."

Some believe the Corona Virus was intentionally developed and spread and others think it occurred and replicated naturally. Whatever its origins the virus has been exploited in a few months to remove freedoms that millions of Americans have suffered and died to secure and preserve since our nation's founding. Moreover, the whole world is now under the spell of a global communist movement and the U.S. a color revolution.

Schwab says that the American middle class and its small businesses that produce most U.S. employment must be eliminated to bring the nation under submission. Hillary Clinton referred to these people as "deplorables" and the Corona King-pins call them "non-essentials."

The middle class and its enterprises are American icons of freedom, independence liberty. They represent the antithesis of Communism and a Global Order. Therefore, there is an ongoing assault on small businesses in most of our states to destroy the American idea.

As one local example, last

week California Governor Newsom's Attorney General Xavier Becerra served Randy Mitchell, owner of Upper Cut Barber Shops in Marysville, Wheatland, and Rocklin with a lawsuit for defying the Governor's and Yuba-Sutter Health Officer Phuong Luu's order to close his locations. They claim he is "endangering the public health, safety, and welfare" by not closing and not insisting on muzzles, 6-foot socialist distancing, no barriers between barbers, Covid signage or disinfecting stations for the public.

Mitchell, 41, and a single father of four, has been a barber for 18 years. Currently, thirty-four barbers and 3 cosmetologists work in his four shops. The enterprises provide a livelihood for 38 workers and their family members, 104 people in all.

Mitchell says neither he nor his barbers could survive without working so he remained open initially just in Marysville if the barbers wanted to work. Ten chairs were shared in rotation by the barbers.

Luu first sent the Marysville Police to order Mitchell to close and he refused. Officers threatened him with jail and finally gave him a \$1000 citation. Yuba County District Attorney (DA) Clint Curry suggested to government leaders that he could cut power and water to Uppercut barbers. The DA eventually removed the case from the court calendar with no explanation given to Mitchell.

State letters sent in late July and early August to Mitchell said "you must close your establishment or move permitted services outdoors." Most daytime temperatures then were in the high 90s with nearly a third of the days between 100-110 degrees. 'Experts' said Corona couldn't stand the heat but would Luu care about barber shop deaths on the asphalt parking lot from heat stroke or heart attacks?

Each violation of the Governor's order is a misdemeanor punishable by a fine up to "\$1,000, imprisonment

for up to six months, or both." Business people that do not comply with stay at home - self isolation orders can also be subject to disciplinary action against their license according to the state.

Mitchell not only stayed open but after visits from the Marysville Police, Yuba County DA personnel, and state inspectors he informed the Board of Barbering and Cosmetology in June 2020 that under the Constitution he does not have to apply for and purchase a license to work in America. Inspectors visiting his shops were told to leave.

The state is hoping to suspend Mitchell's barber establishment licenses and prohibit him and other respondents from practicing their trade in California. California leads all states in the issuing of licenses to operate in hundreds of occupations. It is a means of control, which curtails competition, causes higher prices for consumers misdirecting millions of dollars out of the economy to government.

Meanwhile, Governor Newsom goes to an indoor birthday dinner with top medical lobbyists, more than 20 people wearing no muzzles and not socialist distancing. While the barber shop workers' children cannot attend public school Newsom's enjoy private school.

If the Governor's family wants to shop, establishments open just for them. Mitchell's barber families are nonessential while the Governor's personal businesses and employees remain active. As Mitchell could get no response for financial assistance, the Governor's nine businesses collected nearly \$3 million in Federal Payroll Protection Program loans which can later be forgiven.

Mitchell's court date is December 23 at 9am via video-conference or by phone. Merry Kristmas Komifornia!

## Yuba County Farmer Wins Discussion Meet

**SACRAMENTO, CA (MPG)** - Following a discussion about agricultural technology, a contestant from Yuba County won the annual Young Farmers and Ranchers Discussion Meet at the 102nd California Farm Bureau Annual Meeting.

Madeline Meyer of Wheatland, a member of the Yuba-Sutter Farm Bureau, was named winner of the competition, which was held at the California Farm Bureau building in Sacramento and webcast live as part of the organization's virtual Annual Meeting.

In the final round of the competition, contestants were asked to discuss the use of big data in agriculture. Meyer, an assistant manager at Tollcrest Dairy in Wheatland, encouraged farmers to make more use of the data available to them, in order to improve efficiency.

"Technology is here to stay, and it's our job as young farmers and ranchers to make it work for us, not the other way around," she said.

Darin DuPont of Merced County was first runner-up in the contest. The other finalists were Ryan Amaral of Stanislaus County and Joseph Jackson of Tulare County.

As the winner of the Discussion Meet, Meyer earned \$5,000 courtesy of sponsors Farm Credit and Kubota. As first runner-up, DuPont received \$1,000.

Meyer will represent California at the American Farm Bureau Federation Open Discussion Meet, to be held virtually next month as part of the AFBF Annual Convention.

The California Farm Bureau works to protect family farms and ranches on behalf of nearly 34,000 members statewide and as part of a nationwide network of nearly 5.6 million Farm Bureau members. ★

# City of Yuba City Holiday Closure

**YUBA CITY, CA (MPG)** - This year, City Hall will be closed during the holiday period. The holiday closure will begin on Thursday, December 24, 2020, and continue through Friday, January 1, 2021. The City's Police and Fire services will remain at full staffing during the holiday closure.

City Hall will open on Monday, January 4, 2021.

Historically, the number of City Hall routine counter service requests or utility bill payments around the holidays are

low. Additionally, the holiday closure provides a good opportunity for employees to take extra time off while customer service demands are low.

The services to be suspended are those that are not critical to public safety, mandated by law or required under existing contracts. City Facilities to be Closed to the Public: City Hall. City Facilities to Remain Open: Police Department; Fire Administration; Corporation Yard; Fire Station #1, #2, #3, #4, #7; Water Treatment Plant; Wastewater Treatment Facility; Animal Control Services. ★

# Placer County Superior Court Approved a Stipulated Judgment

**YUBA CITY, CA (MPC)** - The Placer County Superior Court approved a stipulated judgment between the Plaintiffs, Feather River Air Quality Management District (FRAQMD) and Placer County Air Pollution Control District (PCAPCD), and Defendants Jim Day, Barbara Day, and Mid Valley Consulting and General Engineering for serious violations of State and local air quality laws.

In the original filing with the court, the Districts alleged violations relating to air quality testing, construction, maintenance, and repair services on vapor recovery systems at six retail gasoline stations in Placer and Yuba counties.

While not denying nor admitting any issue of law or fact or any violation of the law, the Defendants agreed to pay a civil penalty of \$250,000 and consented to a judgment with a permanent injunction. For the next five (5) years, the injunction requires the Defendants (and their employees) comply with applicable air quality regulations.

The Defendants will be required to obtain and maintain all required certifications and licenses and provide these to the Districts. Defendants must verify the accuracy of information before submitting it to the Plaintiff Air Districts. Defendants will be subject to periodic auditing and must notify the Districts prior to performing work within each.

"In this case, FRAQMD alleged the Days and Mid Valley intentionally deceived both Air District inspectors

and a station owner, over an 18-month period, about the true nature of problems with equipment Defendants installed. Defendants perpetuated the scheme by making false statements and repeatedly clearing alarms, which would have otherwise shut down gasoline dispensing, all the while without making any repairs to the system as required by the gas station's permit. All station owners and their third-party contractors must comply with the permit conditions and District Rules. The goal in this case was to establish a legally binding tool – the injunction, to govern future compliance and to secure a sufficiently deterrent penalty" said Christopher Brown AICP, the Air Pollution Control Officer for the Feather River Air Quality Management District.

"The PCAPCD alleged the Defendants were responsible for a variety of violations at five gas stations, which included the circumventing of equipment installed to protect the public, concealing emissions of toxic gasoline vapors, using non-certified technicians to perform work, and falsifying documents. The Air District is committed to ensuring that there is a level playing field for all businesses so that one business does not gain an unfair competitive advantage by not complying with important air pollution control laws," said Erik White, the Air Pollution Control Officer for the Placer County Air Pollution Control District.

# Slow The Fast Down

**YUBA CITY, CA (MPG)** - A new statewide initiative encourages drivers to "slow the fast down" and understand the dangers of speeding. The Yuba City Police Department supports the California Office of Traffic Safety efforts to address an emerging safety issue: Speeding.

"We are seeing changes in driving behavior, and the number of people traveling at excessive and hazardous speeds is alarming," said Yuba City Police Sgt. Kim Slade. "COVID-19 puts the value of protecting lives in perspective, and practicing safe driving is one simple way everyone can keep themselves and others safe."

Excessive speeding went way up during the beginning of stay-at-home orders in March. Between March 19th and April 30th, CHP officers issued 4,000 citations for speeding over 100 miles per hour, more than double (113%) from last year despite a steep decline in traffic volume. Slow down and be safe! ★

### Agricultural Pilots Seek Bigger Firefighting Role

Agricultural aviators say they stand ready to help fight wildfires, but that Cal Fire rarely calls on them. The chairman of the California Agricultural Aviation Association says 37 single-engine air tankers could have been available during severe fires this fall. A Cal Fire spokesman says the agency allows front-line commanders to decide what planes to deploy. Incident commanders typically order twin-engine air tankers, rather than single-engine planes.

### Canned-Fruit Business Prepares for Rising Demand

Canned fruits and vegetables continue to see increased retail sales. Farmers and marketers say they expect that trend to continue as winter sets in and COVID-19 cases rise. One canner says it’s preparing for a greater-than-usual spike in sales during the holidays. Supplies of canned fruit became short at times early in the pandemic, but processors and retailers say they have taken steps to avoid that in coming weeks.

### Christmas Tree Sales Increase

Choose-and-cut Christmas tree farms report surges in early attendance – a trend they attribute in part to people wanting to decorate their homes early during the pandemic. The president of the California Christmas Tree Association says the opening day of sales at her farm was one of the biggest she’s ever experienced.

Christmas tree farms that have opened this season have modified operations or eliminated some activities to accommodate distancing and other health protocols.

### Farm Bureau Presents Annual Awards

A longtime agricultural and water leader from Sonoma County received the California Farm Bureau’s highest honor during its Annual Meeting Tuesday. Tito Sasaki, a Sonoma Valley grape grower, received the Distinguished Service Award. Farm Bureau also presented Fresno County farmers Nick and Kimberly Rocca and San Diego County winemaker Alysha Stehly with awards for young farmers and ranchers, and honored the Monterey, Napa, Sonoma and Sacramento County Farm Bureaus. ★

## LETTER TO THE EDITOR

We need to re-implement C.O.O.L. “County of Origin Label” back on meat sold in the grocery stores so consumers know what they are getting and USA producers get a better price for their produce? (Born, fed, slaughtered).

Other countries don’t have the same restrictions as we do in the United States. We don’t know where the meat comes from. Our government imports meat from 23 countries, as aid in the form of trade and balanced trade. Consumers have a right to know where their meat comes from.

I think the Canadian Beef should be B.S.E. checked. Alzheimers victims have increased 25% in the last five years, and Alzheimer victims should be checked

when they die for mad cow disease. All Canadian beef should be inspected at slaughter.

I suggest you go to a real butcher shop and buy some kids 4-H or FFA animal instead of buying grocery store meat. Ask your 4-H or FFA leaders where they’re selling their meat since there is no fair due to Corona virus. Your County Ad Commissioner will be able to tell you the names of your local 4-H and FFA leaders.

Also drink organic milk. U.S.D.A. Sec. Sonny Perdue said it’s illegal to check for mad cow disease. He said it’s a trade issue, not a health issue.

## Never Have I Witnessed Such Man-Made Damage Foisted onto the World’s Economies

Never in the decades of following economies and the markets have I witnessed such man-made damage foisted onto the world’s economies such as is occurring now. With a second complete economic shutdown now initiated in my home state of California due to spiking CoVid cases, the expected fall out on American businesses is no doubt going to be even more catastrophic.

I say man-made damage because although the CoVid virus itself is an organic culprit, the decision to shut down is one of man.

My initial forecast in March of this year was that somewhere around 25% of small businesses would be obliterated by the initial shutdowns.

This second round will certainly increase that estimate by an unknown degree. From an economic standpoint, the shutdown is unprecedented. We have never had an instance where almost all business everywhere was either severely restricted or outright shuttered completely.

The pushback from business owners is more pronounced this time around. Those business owners that have somehow survived the first prolonged shutdown now stand in disbelief as they are once again asked to close their doors and turn away much needed revenue from would-be paying customers.

The debate on whether shutdowns were the appropriate response to CoVid is increasing as more and more businesses go under. The initial shutdown was never imagined to last as long as it did, and just when the country began to reopen, giving some hope to the surviving businesses, the winter season brings once again more restrictions. Adding insult to injury, it is the Christmas season that brings many businesses the majority of their annual revenue.

At this point, the debate of whether the cure is worse than the disease is being voiced by more than a few.

Some argue CoVid would bring about more personal devastation in the form of death and disease should this second shutdown not be initiated. Others insist that to shut down again would cause massive personal and economic damage which will far outweigh the misery the virus would ever cause on its own.

The argument is not exclusively centered around the cold reality of death versus dollars however. In an article posted in the Washington Post on Sept. 24, 2020 entitled “The pandemic pushes hundreds of millions of people toward starvation and poverty”, it states: “David Beasley, the executive director of the U.N.’s World Food Program, warned during a Sept. 18 briefing that a “wave of hunger and famine still threatens to sweep across the globe. He said his organization needed close to \$5 billion to prevent 30 million people from dying of starvation.”

Adding to the argument is the fact that domestic violence (<https://www.nytimes.com/2020/04/06/world/coronavirus-domestic-violence.html>), suicide (<https://www.healio.com/psychiatry/journals/psycann/2020-12-50-12/%7B60567d09-854d-4092-b3fe-11d040f2c92c%7D/the-increase-in-suicide-during-the-covid-19-pandemic>) and mental issues (<https://www.webmd.com/lung/news/20200813/levels-of-anxiety-addiction-suicidal-thoughts-are-soaring-in-the-pandemic#1>) presumed to be brought about by isolation are on the rise.

With the belief by some that the new restrictions are necessary to contain the worst outbreak since CoVid’s inception, still others are questioning whether shutting down the economy has accomplished its goal of slowing the spread at all. If not, is another shutdown just one bad decision followed by yet another?

Many claim the reason for the failure is not everyone followed mask and distancing mandates. Still others say mandates will never be followed by everyone, that the first shutdown was the best that could be expected and that a second shutdown is a futile attempt at a failed methodology. This will only cause thousands of more businesses to go under and bring about another round of unnecessary human suffering.

If there is any good news in all of this, it is that the Pfizer vaccine has been approved and is on its way to distribution centers, with some people already getting vaccinated.

It will be months however before the majority of Americans will have access to it while some say they will refuse to take it no matter what.

No matter what side of the argument one believes, the fact is that the economic damage and the amount of human suffering is beyond any comparisons.

That said, there may be some good news on the horizon for those thinking of starting a business. Despite the notion that the idea of hatching a new endeavor at this time seems farfetched in the face of such a stark business environment, I’ll touch on this unexpected suggestion next week.

## California is No 1 in Rough Highways

Much has been said and written about the nation’s stark political divisions and a state-by-state map of November’s presidential election confirms them.

The 50 states were evenly divided between President Donald Trump and his successful challenger, Joe Biden, but the latter triumphed by winning the more populous states.

This week, another map was published that bore an uncanny resemblance to the ones portraying the presidential outcome. Generated by Money Geek, a website devoted to personal finance issues, it displays the differences among states in the conditions of their highways and in how much they are spending on roadway maintenance.

Overlaying the political and roadway maps reveals that in general, the bluer states – those that favored Biden – also tend to have the roughest roads while motorists in pro-Trump red states generally have smoother pavement beneath their tires.

Coincidence? Perhaps, but the data may also say something about political priorities.

California, not surprisingly, fares the worst in Money Geek calculations

of roadway roughness, based on federal data. Anyone who has driven extensively in other states can attest that highways elsewhere are much more user-friendly and that crossing the state line back into California is literally a jarring experience.

The only place American drivers can find rougher roads is in the deep blue District of Columbia.

California is followed in the rankings by blue states Rhode Island, Hawaii, Wisconsin, Massachusetts, New York and New Jersey.

Among red states, the worst roads are found in No. 11 Louisiana. At the other end of the scale, very red Oklahoma has the nation’s smoothest roads, followed by Idaho, Indiana and Alabama, all of whom went for Trump.

Why California has such crappy roads is one of those nagging questions that defy easy answers.

Californians drive a lot, well over 300 billion miles a year, so one of the factors is that our highways get a lot of wear and tear.

However, lots of driving also consumes lots of fuel, more than a billion gallons a month, and generates lots of gas tax money. A few years ago, former Gov. Jerry Brown and the Legislature boosted fuel taxes sharply to the second-highest level of any state. At nearly 75 cents a gallon, including federal taxes, they are just behind those in Pennsylvania, which also has relatively bad roads.

Despite the tax increase,

however, Money Geek says California is no better than mediocre in spending on highway maintenance and improvements at \$13.95 per lane mile a year. That’s twice what Oklahoma, which has the best highways, spends, so California clearly hasn’t been getting much bang for its gas tax bucks.

The big tax increase, which also included a stiff hike in auto registration fees, raises an estimated \$5 billion a year and was billed as a way to catch up on decades of maintenance neglect.

The money is going out the door. Earlier this year, the California Transportation Commission approved \$17.4 billion in state and federal funds for nearly 900 projects that will, the commission’s chairman, Paul Van Konynenburg said, “make roads and bridges safer for California drivers (and) will save drivers money by fixing the potholes that can damage vehicles.”

The tax increase legislation requires the California Department of Transportation (Caltrans) to meet certain goals by 2027, including that 98% of the pavement on the state highway system be in good or fair condition and that at least an additional 500 highway bridges get fixed.

Will Californians actually see better roads, or will deterioration outpace even this big boost in spending? We may know by 2027.

## \$10.7 Million for Fisheries Habitat Restoration Program Projects

**SACRAMENTO, CA (MPG)** - The California Department of Fish and Wildlife (CDFW) announced the selection of 27 projects that will receive funding for the restoration, enhancement and protection of anadromous salmonid habitat in California watersheds.

The grants, which total \$10.7 million, were awarded through CDFW's Fisheries Restoration Grant Program (FRGP). Established in 1981, FRGP has included funding from the National Oceanic and Atmospheric Administration's (NOAA) Pacific Coastal Salmon Recovery Fund since 2000. The federal fund was established by Congress in 2000 to reverse the declines of Pacific salmon and steelhead throughout California, Oregon, Washington, Idaho and Alaska.

"The ongoing momentum to restore California's habitat for these historic species hasn't stopped as we face a global pandemic and devastating wildfires," CDFW Director Charlton H. Bonham said. "Awarding these projects highlights the resilience, passion and vision for salmon recovery by our state's restoration community, for which we are grateful."

In response to the 2020 Fisheries Habitat Restoration Grant Solicitation, CDFW received 80 proposals requesting more than \$40.6 million in funding. As part of the competitive grant program, proposals underwent a rigorous technical review by CDFW and NOAA scientists.

The 27 approved projects will further the objectives of state and federal fisheries recovery plans, including removing barriers to fish migration, restoring riparian habitat, monitoring of listed populations, and creating a more resilient and sustainably managed water resources system (e.g., water supply, water quality and habitat) that can better withstand drought conditions. These projects further the goals of California's Water Action Plan and CDFW's State Wildlife Action Plan, as well as addressing limiting factors specified in state and federal recovery plans.

The list of approved projects is available on the FRGP website.

If a request for an accommodation has been submitted but due to circumstances is no longer needed, please contact the Accessibility Coordinator immediately. ★

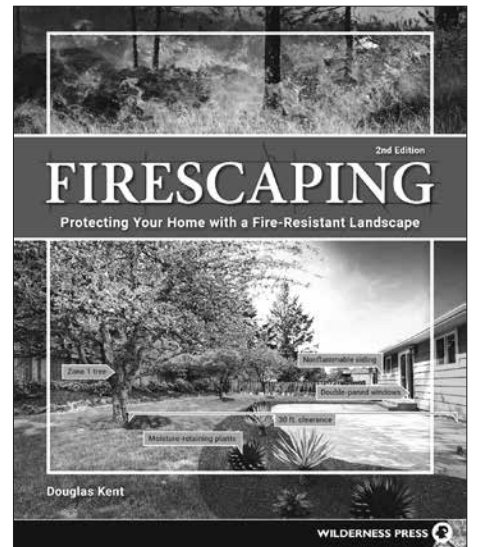
## Green Stuff Still Burns, Use it Wisely and it Will Treat You Well

Butte County Fire Safe Council

**BUTTE COUNTY, CA (MPG)** - What survives after a wildfire largely depends on what preparation was done before a wildfire. Having defensible space is a crucial component, but the way your landscaping is laid out and maintained is hugely important. "The primary job of (Zone 1 Defensible Space) is to withstand intense heat and the onslaught of fire brands... while also providing recreational and nutritional value" says Douglas Kent, author of the recently released 2nd edition of his book *Firescaping: Protecting Your Home with a Fire-Resistant Landscape*.

Laying out garden paths with non-combustible mulches such as gravel or decomposed granite act as natural fire breaks and creates patchiness to slow down fire. While at the Butte County Fire Safe Council we encourage the use of California native plants, it is also important to keep up on maintenance of dead, dying and diseased plant material. "Plant lists themselves aren't of as much importance as the condition and maintenance and age that are paramount to the success of the fire safe strategy" says Kent.

Being aware of the placement of landscaping plants is also critical, planting highly flammable plants such as rosemary near the home is tempting but poses a major hazard. Also planting within the 0'-5' immediate zone is discouraged, at the very least having plants in containers

Douglas Kent released the second edition of his book in October of last year. It covers factors that influence fire behavior, ways to plan your landscaping design to resist wildfire and provides a suggested plant list for fire resistance. Many California native plants are well suited for Fire Safe landscaping and often require little water. ★

**Flynn Speaks at Rally: 'We Cannot Accept What We Are Going Through as Right'** | 12 Dec 2020 | Lt. General Michael Flynn spoke in front of a large crowd that rallied on Washington on Dec. 12 to protest election fraud, and began with the story of Jericho. "We are in a crucible moment in the history of the United States of America," he said at the "Let the Church Roar" rally at the National Mall. "And remember, the courts do not decide who the next president of the United States will be... We the people decide." Thousands gathered to join marches and rallies in Washington on Dec. 12, petitioning the government for fair elections and transparent counting. Similar grassroots protests took place every Saturday since the general election in capitals across the 50 states.

**Ex-Facebook exec suggests everyone who gets vaccinated to wear certain color mask, reminiscent of Nazi Germany's use of the Star of David** | 11 Dec 2020 | Former Facebook executive Chamath Palihapitiya suggested in a tweet on Friday that everyone who gets vaccinated should "all wear a mask of a special design or color" in order to let other people around them know that they have been vaccinated. The idea did not sit well with many on social media, who quickly blasted the idea, comparing it to Nazi Germany's use of the Star of David. "How about we just put a gold star on ones that aren't,?" one user tweeted sarcastically. Other users didn't see the point of having to continue to wear a mask when the vaccine is supposed to provide protection on its own.

**Facebook sued by FTC, 48 attorneys general alleging it operates an illegal monopoly --Attorneys general included those for Guam and Washington, D.C., and every state except for Alabama, Georgia, South Carolina, and South Dakota** | 09 Dec 2020 | A group of 48 U.S. attorneys general led by New York filed an antitrust lawsuit against Facebook on Wednesday, alleging the social media giant is violating antitrust law by buying up competitors and depriving consumers of alternatives that would better protect their privacy. The Federal Trade Commission (FTC) filed a separate suit alleging similar antitrust violations. At the heart of both lawsuits are claims that Facebook's acquisitions of Instagram in 2012 for \$1 billion and WhatsApp in 2014 for \$19 billion, as well as other smaller technology companies, were carried out in order to quash competition. As part of its lawsuit, the FTC wants to force Facebook to break off both Instagram and WhatsApp.

**Chinese Spy Was in 'Relationships' With at Least Two Midwestern Mayors - Report** | 08 Dec 2020 | A suspected Chinese spy was linked to at least two anonymous Midwestern mayors, according to a bombshell report from Axios. The political journal said Fang Fang, who also goes by Christine Fang, developed political contacts primarily in California, including Rep. Eric Swalwell (D-CA). It went on to report: "Fang attended regional conferences for U.S. mayors, which allowed her to grow her network of politicians across the country. She also engaged in sexual or romantic relationships with at least two mayors of Midwestern cities over a period of about three years, according to one U.S. intelligence official and one former elected official. At least two separate sexual interactions with elected officials, including one of these Midwestern mayors, were caught on FBI electronic surveillance of Fang, according to two intelligence officials," Axios said.

**WHO against making coronavirus vaccine mandatory - Such moves have backfired and caused greater opposition in the past, the UN health agency warns** | 08 Dec 2020 | The World Health Organization said Monday that persuading people on the merits of a Covid-19 vaccine would be far more effective than trying to make the jabs mandatory. The WHO said it would be down to individual countries as to how they want to conduct their vaccination campaigns against the coronavirus pandemic. But the UN health agency insisted making it mandatory to get immunized against the disease would be the wrong road to take, adding there were examples in the past of mandating vaccines use only to see it backfire with greater opposition to them. "I don't think that mandates are the direction to go in here, especially for these vaccines," Kate O'Brien, director of the WHO's immunisation department, told a virtual news conference. "It is a much better position to actually encourage and facilitate the vaccination without those kinds of requirements. I don't think we envision any countries creating a mandate for vaccination."

**Gov. Kemp Daughter's Boyfriend Killed in Fiery, Explosive Wreck - Loeffler staffer Harrison Deal's death came mere hours after Gov. Kemp called for signature audit of state's ballots. Witnesses reportedly heard explosions from crash over a mile away.** | 07 Dec 2020 | A staffer and close family friend of Georgia Gov. Brian Kemp died in a tragic car wreck Friday morning, hours after the governor called for a signature audit of 2020 election votes. Local media reported 20-year-old Harrison Deal, an aide to Sen. Kelly Loeffler, former intern to Sen. David Perdue and boyfriend of Kemp's daughter Lucy, was the only person who died in a fiery three-car wreck on I-16 in Pooler. Witnesses reportedly heard explosions from the crash over a mile away... Some claimed to have heard multiple explosions that lasted until first responders arrived. ★

## Why Americans are Dying Younger than Canadians and Brits

Pharmaceuticals have added about a year to U.S. life expectancy since 1990, according to new research published in Health Affairs by scholars from Harvard and the University of Michigan.

Yet Americans don't live as long as their counterparts in Canada and the United Kingdom. British life expectancy is over 81 years; for Canadians, it's 82 years. U.S. life expectancy is just 78.6 years.

Fans of Medicare for All believe that's proof of the superiority of socialized medicine. Dig a little deeper, though, and it's clear that life expectancy is an imperfect measure of the quality of a nation's healthcare system.

In fact, by rationing cutting-edge pharmaceuticals — or not providing them in the first place — socialized medicine could actually be depriving Canadians and Britons of extra years of life.

The Health Affairs study found that U.S. life expectancy increased 3.3 years between 1990 and 2015. Pharmaceuticals were

responsible for 35 percent of that gain.

This is only the latest study to confirm that we have medical innovation to thank for our steadily increasing lifespans. According to research from Columbia University professor Frank Lichtenberg, average life expectancy across 52 countries increased by almost two years between 1986 and 2000. New pharmaceuticals were responsible for 40 percent of that increase.

In the United States, cancer mortality has declined 29 percent since 1991. Lichtenberg attributes most of that decrease to new drugs.

Britain and Canada have not fared as well against cancer. In the United Kingdom, cancer mortality has gone down only 17 percent since the 1970s. The United States posts better five-year survival rates for breast, colon, prostate, and lung cancers than either Great Britain or Canada.

It's no coincidence that American cancer patients have access to more cutting-edge drugs than their peers elsewhere. Seventy-four new oncology drugs were launched worldwide between 2011 and 2018. Americans had access to 70 of them. Britons could get 55 of them; Canadians, just 43.

The story is much the same for drugs that treat other diseases. American patients had access to 88 percent of the 243 new medicines launched between 2011 and 2018.

Residents of the U.K. had access to less than two-thirds, and Canadians, less than half.

If cutting-edge pharmaceuticals extend life, and Americans have access to more of them than their British and Canadian peers, then why do Americans die sooner?

Factors that have nothing to do with health care explain a lot. For example, the United States unfortunately has a much higher murder rate — more than quadruple Great Britain's and more than triple Canada's, according to data from the World Health Organization.

Drug overdoses are also more common in the United States. Then there are traffic accidents, which are sadly more common in the United States.

America's comparatively high murder, drug overdose, and car-crash rates are serious problems. But they don't tell us much about the quality of the American health care system.

Thanks to the widespread availability of innovative pharmaceuticals, there's likely no better place to get sick than the United States. If America were to follow the example of Canada and Great Britain, and embrace government-run care, that would no longer be the case.

# Slave or Free – Your Call

Of all of his oratory, the Ronald Reagan Freedom Speech may be his most iconic, as it not only explained the precarious nature of freedom but served as motivation for liberty lovers. His comments came on Oct. 27, 1964 at the Republican National Convention, years before he would become President of the United States.
