

- directions.
- Everyone should frequently wash their hands with soap and water or use hand sanitizer which must, of course, be done outside.
- Food and drink must be in single-serve disposable containers.
- No food or drink on the table other than your plate and cup.
- Masks must be worn and removed only briefly to eat or drink.

In Tentative Ruling, Court Declares Governor's **Abuse of Power Unconstitutional**

YUBA CITY, CA (MPG) - A State Superior Court judge tentatively ruled in favor of Assemblymembers James Gallagher (R-Yuba City) and Kevin Kiley (R-Rocklin) in their abuse of power lawsuit against Governor Gavin Newsom.

In the tentative ruling, Judge Sarah Heckman declared the Governor's recent Executive Order N-67-20 unconstitutional. More importantly, Judge Heckman's tentative ruling places a permanent injunction against the Governor which prevents him from unilaterally making or changing state law moving forward.

Gallagher and Kiley said, "We have been arguing that the California Emergency Services Act does not provide for one-man rule. Today, the Court agreed with us.'

"This is a victory for separation of powers. The

women veterans for their input during the design process. He said that this particular piece was "a very challenging panel, partly because there wasn't a theme, like a given conflict" but more so a "theory to express...that we have the support of women throughout the whole aspect of the military." He says, "I was very pleased with how it turned out," and shares that it has been a privilege for him to "honor the heroic work of military men and women."

Among those Veterans in attendance at the installation were women veterans, Cheyenne Bart and Vickie Bateman. Bart, former Gridley VFW Commander and Navy vet said that it was "past due" and spoke about the roles of women in military service. "When we think of veterans, people then to think of men." Bart says, "Now that women enter conflicts, combat and hostile situations, it's time they get the recognition." She adds, "I'm not one that thinks any less of my brother, but we're brothers AND sisters in arms." Bateman, who served in the Army for 20 years said, "It's about time we get the recognition. Not just for me, but all the women that served. For all that they did, for all that they gave up and weren't allowed to have-like families. This is in honor of them. If it weren't for them, we wouldn't be able to do what we're doing."

Sanders, who has worked on the project from the onset says that the placement of the "Women of the Military" Sculpture meant a lot. "This whole process...just makes you very proud." He said.

The Colusa VFW plans to have a socially distanced ceremony on Veterans Day, November 11th, to dedicate the historic sculpture while honoring all that served. ★

The election is over but little is settled. Socialist mayors and governors permit hired criminals to destroy their cities and then expect a federal government bail-out. It is up to God-fearing, law-abiding and Constitution-loving Americans to now fight for their future or lose it all.

An American writes from Cambodia this past week saying, "I was in Laos from 1968-1971. I was a contract employee of the US Embassy in Laos. I watched as Laos went from a constitutional monarchy to a communist state. I witnessed the major destruction of this country, through infiltration, fear, dissemination of propaganda via rumor and print, developing slogans like 'jackapot,' meaning roughly 'colonialist slave master.' There were demonstrations against the government, village leaders and police were routinely assaulted and assassinated, eventually leading to open civil war.

I not only lived through this in Laos, but I observed Cambodia, as I was stationed on the border of was part of daily CIA/ USAID briefings.

Cambodia was the

Phnom Penh and gasped, "I hope someday my country can look this good!"(Singapore is now a leading world class nation.) Cambodia maintained neutrality until the overthrow of Prime Minister Sihanouk in 1970 by a pro-American general named Lon Nol.

I thought Sihanouk was the wisest leader in the world; he'd kept his country out of war, but then the coup occurred when Lon Nol came into power. Nixon ordered 30,000 US troops across the Cambodian/Vietnam border to destroy munitions supplies for the Viet Kong.

There was much political pressure at home (U.S.) and Nixon pulled the troops back replacing them with B-52 carpet bombing. That gave the struggling Khmer Rouge communists a propaganda foothold that was the beginning of the end for Cambodia.

By 1975, Phnom Penh, the capital, was destroyed. (The Khmer Rouge killed nearly 2 million Cambodians). If you think that can't happen in America, you need to pray. Just look at where we are now versus Christmas last year."

Just before November 3, some were portraying our election as not just between two candidates but between two political ways, freedom versus socialism / communism.

C.S. Lewis in his 1958 essay 'Willing Slaves of the Welfare State' said, "To live his life in his own way, to call his house his castle, to enjoy the fruits of his own labor, to educate his Laos and Cambodia and children as his conscience directs, to save for their prosperity after his death - these are wishes deeply envy of Southeast Asia ingrained in civilized man. in the 1960's. Lee Kaun Their realization is almost Yew, Prime Minister of as necessary to our virtues and his articles at

their total frustration disastrous results both moral and psychological might follow."

While advocates for the welfare state argue that government programs produce happiness and security, Lewis insists they are deceived and mistaken. Freedom is the path to achieve these ends.

Lewis writes, "I believe a man is happier, and happy in a richer way, if he has 'the freeborn mind.' But I doubt whether he can have this without economic independence, which the new society is abolishing. For economic independence allows an education not controlled by Government; and in adult life it is the man who needs and asks nothing of Government who can criticize its acts and snap his fingers at its ideology. Read Montaigne; that's the voice of a man with his legs under his own table, eating the mutton and turnips raised on his own land. Who will talk like that when the State is everyone's schoolmaster and employer?"

Tyrants or rulers treat their subjects like domesticated animals.

In 'The Abolition of Man', Lewis says: "In a sort of ghastly simplicity we remove the organ and demand the function. We make men without chests and expect of them virtue and enterprise. We laugh at honor and are shocked to find traitors in our midst. We castrate and bid the geldings be fruitful."

America is beyond a fix by changing officeholders. Our Founding Fathers did not believe the nation or the Constitution could survive a people that rejected God and His moral way.

ile most in the crowds of people were masked, social distancing was enforced and hand sanitizing stations were available throughout the park, it almost felt like the world had gone back to normal. The park was full of visitors enjoying themselves. Children played on the giant slides, giggled as they circled round on Charlie's Carousel, fed the animals at Weeland Petting Zoo or took the tour on the BPF Line train. The more adventurous

visitors got lost in the corn maze or flew fast and high down the zip line.

As always, the Cider Mill was a popular spot for pressed apple cider, caramel apples and popcorn balls, and the bakery satisfied with home-made cakes and pies. Hay-filled tractor rides shuttled families out to the fields dotted with hundreds of pumpkins to hunt for the perfect pick, be it orange, white, green or speckled, large or small. Yuba Water Agency Funds Drinking Water Infrastructure Repairs for Foothill Residents

MARYSVILLE, CA (MPG) - Yuba Water Agency took action today to improve water supply reliability for Camptonville residents.

A \$56,000 grant, approved by Yuba Water's board of directors, provides necessary funding for the Camptonville Community Services District to perform repairs to its Campbell Gulch diversion structure, which captures and diverts water for the entire community of Camptonville.

"Our goal is to make sure that our communities have excellent water quality for their residents, and this project is crucial for foothill residents' drinking water supply," said Yuba Water Chairman Randy Fletcher, whose district includes Camptonville. "Without these

repairs, it is just a matter of time before the system fails."

The structure captures raw water from a creek that runs through Campbell Gulch before it is carried downstream through a pipe to the district's filter plant, where it is then processed for drinking water.

The diversion structure sustained significant damage due to high creek flows as a result of torrential rain events and is in need of repair to continue to provide a reliable water supply for the foothill community's residents.

This project is also part of the area's Integrated Regional Water Management Plan, a collaborative effort to identify and implement water management solutions on a regional scale.

- At least today, we know the answer to the old question - "Who was that masked man?"
- The November election in California is starting out to be as honest as in Venezuela or Cuba. Hundreds of thousands of ballots have been sent to the dead, illegal aliens and persons who moved out of State more than a decade ago. Postal workers have been destroying ballots. Some of that excess ran as high as 187% in Texas, 177% in New Mexico and 171% in South Dakota.

Wildfires Reduce Feed Supplies for Livestock

Hundreds of thousands of acres of scorched rangeland leave livestock ranchers with limited options for finding more feed for their animals. California wildfires have damaged both private and public rangelands, killed animals and ruined fences, corrals, water systems and other equipment. The president of the California Cattlemen's Association says the loss of rangeland may force some ranchers to sell off their animals early due to lack of feed.

Trespassers, Thieves Trouble Walnut Farmers

Walnut farmers say they're confronting two problems this harvest season: low prices for the crop and thieves who trespass into orchards to steal nuts. A number of counties have enacted ordinances to slow thefts by people who may then sell nuts on roadsides, but farmers report ongoing problems. Because of low prices, farmers say they need to sell as many nuts as they can to recoup their costs, and don't want to lose more of their harvest to thieves.

Pandemic Leads to Tough Year for Lemon Farmers

Closure of restaurants and bars due to the pandemic brought "major hurt" to the lemon business, marketers say, and improved sales at grocery stores have only partially compensated for the losses. Farmers and marketers say lemon sales to food-service customers have improved somewhat since dropping sharply in the spring, and shoppers have bought more lemons at retail. But people in the lemon business say farmers have seen their incomes drop significantly.

China Receives First Shipment of California Rice

California-grown rice unloaded at a Chinese port Tuesday completed the first shipment of U.S.-grown rice to China. The USA Rice Federation says the premium, medium-grain rice from California will be sold by a Chinese retail chain known as Sungiven. Chinese importers visited California and two other rice-growing states last year as part of a longstanding effort to open the market to U.S. rice. ★









Markets are said to Look Ahead Up to Six Months or More

Although many people assume the stock markets will react the actual day of an event, in actuality the-markets are said to look ahead up to six months or more.

For example, the CoVid-19 event has been a good example of how markets anticipate things way of ahead of time.

Wall Street loves its comparisons, and the rise in sales, compared to an anemic CoVid shut down economy, will no doubt set some records. This is what Wall Street has visualized since the shutdowns began, and is likely the reason the March sell off panic quickly turned into a buying frenzy. Once the panic subsided, Wall Street looked ahead to the recovery.

The weeks leading up to election day may have been especially damaging to portfolio balances. This could lead however, to another example of the markets looking ahead further than occurrence of a specific event happening on a specific day like election day.

I am of the opinion that the markets latest hissy fit was not so much concern about who will be elected, but the uncertainty of the event itself. Wall Street has pretty much prepared itself for the election of either candidate, knowing it will be either one or the other, and unlike a Bernie Sanders White House, which the markets DID fear, a Biden presidency no longer scares Wall Street

After all, the "talk" that is rumored to take place when a new President is sworn in covers nuclear footballs, dead alien invasions, secret bunkers and other clandestine and lurid facts that the public best not be made aware of. Among the discussions will also be what can and cannot be done when it comes to the big money centers of the world, put forth in way that may be much more than mere suggestion.

My conjecture of course.

I predict the current markets nervousness may be like the Gulf War stock markets of Operation Desert Storm. The markets feared the coming war action and sold off in the days and weeks preceding it, but when the shooting actually started, the markets took off, as the uncertainty of war gave way to the certainty of it.

It's by no means certain that California voters will pass Proposition 15, but if they do, it would be the largest tax increase in the state's history.

That said, it would provide a relatively small down payment on the long-standing desire of the state's educational establishment for a massive increase in spending that's needed, advocates say, to improve California's rather dismal K-12 educational outcomes.

Proposition 15, largely sponsored by the California Teachers Association and other public employee unions, would increase property taxes on some commercial real estate, such as office buildings and hotels, by requiring their taxable values to be upgraded more often. Estimates of its effects vary somewhat, but generally are in the \$10 billion to \$12 billion per year range, with schools getting about 40% of the proceeds.

Those are big numbers, but the few billion extra dollars that would flow to schools are a fraction of the \$25 billion to \$30 billion more per year that unions and other educational groups have been touting. The increase is needed, they say, to make a real difference in academic test scores, high school graduation rates and other measures of academic attainment.

Does More Money Mean Better Schools?

from a 2018 report from a multi-university team of academic researchers saying that California should spend 38% more, or about \$4,000 per pupil per year, to raise overall achievement and close the "achievement gap" that separates poor and/or English-learner students from

their more advantaged peers. The 2018 report and much other academic drumbeating for higher education spending comes from Policy Analysis for California Education (PACE), a consortium of the state's major university schools of education.

As the campaign over Proposition 15 – basically a duel between public worker unions and business interests – entered its final stages, PACE issued another report to reinforce its advocacy for a big increase in school financing.

Its core is a series of charts comparing education spending in California to that of other major states and tracing what it says is a relative decline in California's commitment to schools.

Citing the global size of California's economy, the report laments that "California school funding even before COVID-19 – was insufficient to meet educational goals and address the needs of students, particularly given the state's high cost of living. How can that be true? Why is education funding so low in California, despite its wealth and comparatively high tax revenues?"

The report's charts appear The number derives to be accurate as far as they

go. But they don't go far enough because they are confined to financial comparisons on the questionable assumption, also reflected in the 2018 study, that money automatically equates to educational achievement.

If PACE and other advocates of big increases in school spending were intellectually honest, they would not only compare spending levels to other states, but also compare how well they are faring vis-à-vis California in national academic testing results and other measures of attainment.

New York, for instance, is spending at least 50% more per pupil than California but its scores on the last batch of National Assessment of Educational Progress tests were virtually identical to California's - both being subpar. Meanwhile, many states that spend much less than California routinely score higher.

Regardless of Proposition 15's outcome, the neverending debate on California education will continue, but it should be a debate about more than money. Some of the academic resources being devoted to persuading Californians to raise taxes for schools should be spent on exploring why outcomes elsewhere bear little or no relationship to how much money other states are spending.



- inhaler, medication or light-headedness). · Singing, chanting and shouting are strongly discouraged, but if they occur, a face covering must be worn. And the singing should be quiet.
- Instrumental music is allowed but no wind instruments.

For some families, Thanksgiving will not include grandma and the children or siblings due to the three-family limitation. Imagine family members traveling for hours only to be restricted to a two-hour outdoor gathering without physical contact! What if it's hot or rains? Under these rules, the host must bear the weight of the entire meal because family cannot be inside to help.

BCSO Detectives Arrest Three Individuals for Two Murders that Occurred in the Oroville Area

OROVILLE, CA (MPG) - On the evening of October 21, 2020, the Butte County Sheriff's Office (BCSO) was contacted by family members of Jerry Bonds, age 39 and Randy Bonds, age 33, of Florida. The family members reported Jerry and Randy had flown from Florida to Los Angeles, rented a vehicle, and traveled to the Butte County area. The family members were concerned because they lost contact with Jerry and Randy after they arrived in the Butte County area. BCSO deputies and detectives immediately began conducting an investigation.

During the investigation that followed, BCSO detectives, Butte Interagency Narcotics Task Force detectives, BCSO Special Enforcement Unit detectives, Designated Area deputies, and Agents from the Chico FBI Office worked together and developed information that led them to believe Jerry and Randy were last in the area of Pondersoa Way, Forbestown. During a search of the aforementioned area, detectives located the bodies of Jerry and Randy in a wooded area. Detectives determined Jerry and Randy had both been shot.

Detectives worked with the Reno Police Department and located the vehicle Jerry and Randy had rented in the area of Boomtown, Nevada. Detectives traveled to Reno, worked with the Reno Police Department, and executed a search warrant at a residence in Reno. Detectives located additional evidence related to the murders of Jerry and Randy in the

Based on information obtained during the investigation, detectives identified Michael Griff, age 21, Austin Hogan, age 21, and Kyle Smith, age 24, as the individuals who murdered Jerry and Randy. Detectives determined Griff, Hogan, and Smith were residing at a residence on Coho Court, Oroville.

On October 22, deputies and detectives contacted Hogan and Smith during a traffic enforcement stop in the Kelly Ridge area of Oroville. Detectives obtained a search warrant for the Coho Court address, and an arrest warrant for Griff. On the afternoon of October 22, deputies with the BCSO SWAT team executed the search warrant. During the execution of the search warrant, Griff was contacted and placed under arrest. During a search of the Coho Court residence, detectives located additional evidence showing Griff, Hogan, and Smith were the individuals responsible for the murders of Randy and Jerry. Detectives are currently following-up on additional information regarding the circumstances of the murders.

On October 22, Griff, Hogan, and Smith were booked into the Butte County Jail. Griff, Hogan, and Smith were each booked for two counts of first degree murder. Griff, Hogan, and Smith are scheduled to be arraigned at the Butte County Superior Court on Monday, October 26, at 3 PM. The Sheriff's Office is asking anyone with additional information about this investigation to contact Detective Tristan Harper or Detective Zach Price at 530-538-7671.

Yellow Fever Mosquito Detected In Oroville

BUTTE COUNTY, CA (MPG) -The Butte County Mosquito and Vector Control District (District) detected an invasive (non-native) species of mosquito on Wednesday, October 28th, 2020. The Aedes aegypti, commonly known as the yellow fever mosquito, was found in west Oroville, in the area of Oroville Dam Boulevard and Feather River Boulevard. The California Department of Public cal role in helping to control Health confirmed the inva-

sive species detection. "The District is working to evaluate the extent water-holding containof the infestation and we ers and prefer being in and plan to do everything we around our homes. A breedcan to eradicate this mos- ing ground for this mosquito quito and to protect our residents from the potential disease risk of these invasive mosquitoes," said Matt Ball, District Manager. "Our goal is to control and eliminate this species of mosquito so that it does not become established in our community.'

The District utilizes a science-based, data-driven approach to mosquito control. This Integrated Vector Management approach will include immature surveillance and control that includes door to door inspections, as well as adult surveillance and control, which will include ultra-low

volume spraying, barrier aegypti eggs can remain treatments and a variety of live mosquito trapping.

The Aedes aegypti mosquito has been detected previously in Chico (Butte County) and other areas of California, but never in Oroville. Aedes aegypti have the potential to transmit viruses such as chikungunya, dengue, yellow fever, and Zika, that are not known to be transmitted by Butte County's native mosquitoes.

The public plays a critithe spread of this mosquito population. "Aedes aegypti love to breed in small can be as small as a water bottle cap. Eliminating all standing water regardless of size is essential to effective control," says Matt Ball.

Inspect your yard for standing water sources and drain water that may have collected under potted plants, in bird baths, discarded tires, and any other items that could collect water; Check your rain gutters and lawn drains to make sure they aren't holding water and debris; Check and clean any new containers that you bring home that may contain water. Aedes viable under dry conditions for months.

As with all mosquito issues, native and nonnative, the Butte County Mosquito and Vector Control District staff urges residents to take precautions to avoid mosquito bites by implementing the 4 Ds of protection:

Drain any standing water that may produce mosquitoes, this includes flowerpots, old tires, and buckets. Some species of mosquitoes can lay their eggs in very small sources of water, like a bottle cap; Defend yourself and your home by using an effective insect repellent and making sure screens on doors and windows are in good condilong sleeves and pants when mosquitoes are active.

BCSO Announces Child Endangerment Arrests

Butte County Sheriff's Office

MAGALIA, CA (MPG) - On the evening of October 9, 2020, Butte County Sheriff's Office (BCSO) deputies and detectives were contacted by a local hospital regarding a possible child abuse victim. Deputies and detectives responded to the hospital and determined a sixteen month old victim had been brought to the emergency room with severe burns. After receiving emergency treatment, the victim was transferred to a children's hospital in the Sacramento area. The victim is in stable condition and is expected to recover from his injuries.

Deputies and detectives identified the victim's parents as Jennelle Laye, age 39, and Jeremy Laye, age 47. Detectives determined tion; Dusk or Dawn, avoid Jennelle, Jeremy, and their three children outside activities; Dress in reside in Magalia. Detectives conducted an extensive investigation. Detectives determined Jennelle and Jeremy left their children at their residence with a juvenile babysitter on the evening of October 8. Based on the investigation, detectives believe the child was burned as a result of a spill sometime during the evening hours on October 8.

Detectives located evidence Jennelle and Jeremy returned to their residence in the early morning hours on October 9. Detectives located further evidence that despite being aware of the life-threatening injuries the victim sustained, Jeremy and Jennelle intentionally waited approximately 14 hours to take the victim to the hospital. Doctors and medical staff concluded the failure to provide the victim with immediate medical attention caused additional harm to the victim. Doctors also concluded the aforementioned subjected the victim to additional pain and suffering.

On October 20, detectives arrested Jennelle and Jeremy. Jennelle and Jeremy were booked into the Butte County Jail for a felony count of child abuse. Jennelle and Jeremy are scheduled to be arraigned at the Butte County Superior Court on Thursday, October 22, at 3 PM. The Sheriff's Office is asking anyone with additional information about this investigation to contact Detective Mary Barker or Detective Zach Price at 530-538-7671.
