

## Unsafe to Drink

Wildfires Threaten Rural Towns with Tainted Water

When wildfires spread across California, they leave a cascade of water problems in their wake: Some communities have their drinking water poisoned by toxic substances. Others wrestle with ash and debris washed into reservoirs and lakes. And many living in remote stretches of the state struggle with accessing enough water to fight fires.

Drinking water has been far beyond the scope of reg-

In a state plagued by water shortages, rural California has suffered a cascade of water woes in the wake of wildfires that is likely to happen again and again.

The problems now encountered in California are

> "It's safe to bet that with this year's fire season the way it is, winds picking up and the magnitude of fire that we've got, we're going to see more (water) systems like this," said Daniel Newton, assistant deputy director of the state water board's Division of Drinking Water. "The number of fire impacts I am starting to hear throughout the state is stag-

"From a water perspecadvice to give residents in acres of California, killing 31 tive, this is just when the problems are all about to begin – when we put the fire out," said Kevin Bladon, associate professor of forest ecohydrology and watershed science at Oregon State University. "We can see effects (on water) persist for decades."

The first clues that fires could contaminate pipes with chemicals came in the fall of 2017 in Santa Rosa, where the Tubbs Fire had destroyed roughly 3,000 homes and

commercial buildings. Testing revealed contaminants, including benzene as high as 40,000 times the state's limits, according to a recent study led by Andrew Whelton, an associate professor of civil, environmental and ecological engineering at

Purdue University. Long-term exposure to benzene, a component of crude oil and gasoline, is a well-proven cause of leukemia, and immediate, high exposure can cause dizziness

and stomach ailments. Drinking water in Paradise also was contaminated with chemicals including dangerous levels of benzene at least 2,200 times the state limit in one sample, Whelton's study reports when the Camp Fire killed 85 people and destroyed nearly 19,000 buildings in Butte County in 2018. Nearly two years later, the town's utility warns that water connections to unoccupied houses and empty lots may still be contaminated.

The tab for combating Paradise's contamination has hit an estimated \$50 million, plus \$80 to \$100 million for additional repairs, Mickey Rich, information systems

**Moves into Red Tier Status** By Russ Brown, Yuba

MARYSVILLE, CA (MPG) -Evolving state processes and guidelines for addressing the COVID-19 threat prompted Yuba-Sutter Bi-County Health Officer Dr. Phuong Luu to set aside a previous local health order and replace it with one that aligns with the state. Dr. Luu said the change is necessary to ensure residents have a clear understanding of what they need to do to progress further into less-restrictive

"My previous May 4 Health Order was written to reflect guidelines and terminology used at that time by state public health officials, but they have greatly revamped their approach since then," Dr. Luu said. "I want our residents to see a very clear path to reopening, so my new order aligns us with state requirements."

Although the main Health Order is now revoked by Dr. Luu's newest order, a Health Emergency ratified by the Board of Supervisors on March 10 - issued as COVID-19 was beginning to spread through California - remains in place. That emergency declaration is necessary to gain access to important state and federal resources to support local response to the virus.

A separate May 4 Health Order requiring residents to wear facial coverings when in public is still in effect.

Both Yuba and Sutter counties will qualify to enter the state's Red Tier -Yuba County this week and Sutter County the following week. Dr. Luu and other county officials caution that the easing of restrictions makes daily precautions to guard against COVID-19 more important than ever.

"These past several weeks we have seen most of our residents step up and take extra precautions to protect themselves and others against the virus, and those precautions become even more important as we move through the various colored tiers," Dr. Luu said. "We can't lose sight of the fact that we are still seeing new COVID-19 cases every day and people are still being admitted to our local hospital."

The new Yuba-Sutter Health Order still focuses on the basic tenets needed to protect residents from COVID-19 but points to California's "Blueprint for a Safer Economy" as the guide for how businesses and organizations can reopen.

And uncontrolled conflagrations can increase erosion and pollutants that rush into the lakes and reservoirs supplying Californians with water. California Center for Jobs and the Economy: For the 12 months ended July 2020, California's higher electricity prices translated into Commercial & Industrial ratepayers paying \$11.6 billion more than ratepayers elsewhere in the US using the same amount of energy. California's energy policies now cost the state's households and employers more than \$44 billion a year compared to the average prices paid by the rest of the US. And this amount is far larger when compared to the ability of the state to provide reliable and less costly energy in the past. These growing cost gaps are generally the outcome of the state's climate change regulations, but they are not the price of addressing the challenges of climate change. They are the result of the way the state has chosen to do so, relying on a con-

regulations regardless of the cost to Californians and to California jobs.

The state has achieved climate change emission reductions through its regulatory approach, but at a pace that differs little from the rest of the nation and that in some cases even lags what other states have been able to achieve at a far lower cost. In the most recent data from the US Energy Information Administration, California ranked only 12th in the share of in-state electricity generation coming from non-CO2 sources. That year was an improvement from 14th in 2018, but passing Tennessee and Iowa in the rankings was made possible only by a nearly 6 percentage point increase in the share coming from conventional hydroelectric generation - the result of favorable weather not the state's regulation.

### Gallagher Bill to Increase Elections Transparency is Signed into Law

SACRAMENTO, CA (MPG) - Assemblyman James Gallagher (R-Yuba City) successfully moved the State towards more transparent local elections by passing Assembly Bill 2151. Assembly Bill 2151 will improve campaign finance transparency by requiring local election officials to post campaign finance documents on the Internet within 72 hours of reporting these documents to the State's campaign watchdog, the Fair Political Practices Commission. Assembly Bill 2151 passed out of both houses with strong bi-partisan support and was signed by the Governor on September 28, 2020.

Current law requires candidates running for local office to submit campaign finance documents outlining information about who is contributing to their political campaigns. These documents are required to be available for public review. However, many local agencies only make these documents available for in-person review, at the local elections office building, during normal business hours Mon-Fri. In more rural areas, individuals seeking to review this information are required to travel great

distances. In more urban areas, lack of parking or parking costs may also be an issue. These restraints discourage the public from accessing important information regarding who is funding local candidates. Simply put, the current system does not allow for the greatest public access and transparency.

Upon receiving confirmation of the Governor's signature, Gallagher stated, "Transparency in political campaigns at all levels of government is vital to the success of our democracy. I am proud that Assembly Bill 2151 will allow greater access of local campaign finance information to the public."

Already, the public can access campaign finance documents online for candidates running for State or Federal office. Under Assembly Bill 2151, local campaign finance documents will also be easily accessible on local government websites.

coming weeks, we have a team dedicated to helping businesses, churches, and other non-profit organizations navigate the various state tier colors," said Yuba County CAO Kevin Mallen. scheduled ramp closures:


**Sunday, October 11:** McGowan Parkway on- and off-ramps.

manager with the Paradise Irrigation District, told CalMatters. The district is seeking federal and state emergency funding, and has tapped into insurance to help pay for the

"Our goal is to get everything paid for by emergency funds that we can. We don't feel like our customers should have to pay for any of this damage," Rich said.

Stefan Cajina, north coastal section chief of the water board's drinking water division, said that drinking water officials usually reserve issuing stricter guidance around showering and bathing for when they know for certain the water is contaminated.

Now the state is considering reversing that approach to recommend water systems start with more stringent cautions, and scale them back as test results show the water is safe.

As California heads into the rainy season, the threats to drinking water will be amplified. Rains may extinguish wildfires, but they can also wash contaminants into water sources.

Fires kill plants, increasing runoff and accelerating snowmelt. Burning soil can also change its structure, trigger erosion and leave behind layers of ash and debris that flow into streams and lakes.

After the 2007 Zaca Fire, the organic material clouding Cachuma Lake jumped by 165%. And it still hasn't returned to historic lows. Near Redding, water from Whiskeytown Lake grew roughly 20 times dirtier after the Carr Fire.

All that material can challenge ground in scientific research.

downstream treatment plants to cope with the added mud and altered water chemistry, and it may fuel algal blooms. But adding chlorine to treat the water can kick off chemical reactions with all the additional organic matter to form disinfection byproducts linked to health problems, including bladder cancer.

More of the ingredients that form these disinfection byproducts were found in Northern California creeks after the Rocky and Wragg fires burned through the region in 2015, according to a recent study.

"It's very common that in rural parts of California that water is difficult for us," said Daniel Berlant, an assistant deputy director with CalFire, the state's firefighting agency. "I've been on a number of fires, where communities – even communities you would think are more urban - that just because of the amount of water being used, the water supply and the pressure goes down."

It's why CalFire sends water tenders that can carry water to wildfires, engines are equipped with pumps to pull from lakes and pools and helicopters can swoop in.

Paradise is leading the way to fireproof its water. "You hope no city ever has to go through this. The good that I see is we got a lot of the research done and we have a lot of the answers now," Rich said.

The state, too, is working on developing its playbook for water systems to ensure they're prepared to immediately flush pipes, isolate burned neighborhoods and test for contaminants

### Farm Bureau Releases Voter Guide

SACRAMENTO, CA (MPG) - Reiterating its strong opposition to a ballot initiative that would establish a split-roll property tax, the California Farm Bureau Federation has announced positions on the other statewide measures to be decided this fall. The CFBF Board of Directors released a Voter Guide for the Nov. 3 general election.

Farm Bureau was among the first organizations to oppose Proposition 15, which would create a split-roll property tax to reassess and raise taxes on commercial and industrial property. Although its proponents claim agriculture would be exempt, the measure would allow reassessment of agricultural facilities and improvements such as barns, dairies, orchards, vineyards and processing plants.

"In the middle of a pandemic that has severely disrupted our food-production system, Proposition 15 would impose a new tax burden on family farms and ranches," CFBF President Jamie Johansson said. "Ultimately, those higher costs to the food system would lead to higher food prices. Make no mistake: A tax on farms is a tax on everyone."

Among its other ballot positions, Farm Bureau emphasized public safety by supporting Proposition 20, which would increase penalties for certain theft-related crimes, and opposing Proposition 25, which would abolish the state's cash-bail system.

Theft, vandalism, trespassing and other crimes remain chronic and growing problems in rural California," Johansson said. "By passing Proposition 20 and rejecting Proposition 25, voters have an opportunity to reinforce protection for rural and urban communities alike."



"Whoever engages in any conduct with intent to convey false or misleading information under circumstances where such information may reasonably be believed and where such information indicates that an activity has taken, is taking, or will take place that would constitute a

violation...." Politicians may also have violated 18 U.S. Code § 1040 - Fraud in connection with major disaster or emergency benefits. This involves perpetrating or complying with a hoax to gain disaster benefits. Codes also address how the gained funds are used.

California Health & Safety Code § 101080 says that "whenever a local health emergency is declared by a local health officer, the local health emergency shall not remain in effect for a period in excess of seven days unless it has been ratified by the board of supervisors, or city council, whichever is applicable to the jurisdiction. And they shall proclaim the termination of the local health emergency at the earliest possible date that conditions warrant the termination."

Politicians are also forbidden from calling for a local emergency when there isn't one (Gov. Code §§ 8630 - 8634 - California). If the emergency cannot be proven and justified in court along with the extreme response, local officials may be in serious trouble.

### Taxpayer Funded Campaign Outreach **Contract Tied with Democrat Candidates**

SACRAMENTO, CA (MPG) - Without legal authority and bypassing the state's open bid contracting procedures, the California Secretary of State entered a \$35 million agreement with a partisan public relations firm to conduct "voter outreach." These state funds were intended to help with the administration of local county elections.

"We write to you to express significant concerns with the Secretary of State's (SOS) recently reported contract to spend \$35 million, ostensibly to provide voter outreach, through a firm widely known for its partisan history," said Senator Patricia Bates (R-Laguna Niguel), the Vice Chair of the Senate Appropriations Committee, and Senator Jim Nielsen (R-Tehama), the Vice Chair of the Senate Budget and Fiscal Review Committee, in their letter to decision makers. "This creates an obvious conflict of interest in the administration of these public funds, no matter the protestations from the SOS and the contracting firm that the money would be used in a nonpartisan manner."

In a September 29 article from the Sacramento Bee, the Secretary of State's office asserts that he is spending money "on the counties' behalf."

The letter from Senators Bates and Nielsen continues, "This explanation raises significant legal questions as to how the SOS can unilaterally decide it will spend money on behalf of all 58 counties. Thus far, we have seen no indication from counties that any of them in fact did ask the SOS to engage in the contract on their behalf."



The ups and downs in the markets continue to keep investors guessing. With 2020 only three quarters of the way through, there is little doubt in anyone's mind that this year is one of the strangest ones on record. It has also been an unfortunate series of events that have roiled markets, shut down economies, caused untold economic damage and personal misery, and has arguably pitted half the country's inhabitants against the other

The result in the world of investing has been record breaking crashes followed by breathtaking recoveries, only to have the cycle seemingly repeat over and over as the latest headlines hits the wires.

Sector rotation has been exhibited in spades in 2020, meaning one day one sector will rise like technology, and the very next day tech reverses and industrial sectors skyrocket.

No doubt in the repeated rinse cycles of these rotations, the amateur day trader has been made rich one day only to be taken out to the woodshed the next. Mr. Newbie Day Trader, enticed by headlines of daily doubles in certain stocks and with lots of time on his hands sequestered in his home, entered the markets through quick trading platforms like Robinhood and E Trade. He bought high flyers like Nikola and Zoom and played the riskiest sectors like cruise ships and airlines.

But Mr. Market usually punishes beginners mercilessly, but only after having lured him in by giving him an initial quick profit or two to complete the "set up". Unlike the dot.com rally that continually lifted all boats in the internet arena, the CoVid-19 trading has been as bipolar as it gets, hoodwinking even the most experienced traders.

The take away on this whole market has been unpredictability. I have always said the market will reflect reality eventually, but its day to day movements are only the sum of the conceptions of the billions of players in it at any one time.

What we can be certain from the stunning wild swings in both indexes and sectors is that nothing IS certain.

Unlike one-off events like 9/11, Y2K or a major bank imploding, where the event has a beginning and an end, CoVid-19 is different. Its outcome is unknown, its timing uncertain. It could end tomorrow entity. (530) 559-1214

with a vaccine announcement, or go on for months or even years.

The decisions on how to address it have been difficult and controversial. The radical idea of shutdown has devastated economies worldwide. Businesses have folded and will continue to do so causing untold human suffering. CoVid itself has sickened millions and killed hundreds of thousands. Adding market insult to injury is an election which is arguably the most contentious in history. Wildfires in the west only adds to the suffering and heaps on mounds of more uncertainty.

Navigating these markets has been difficult if not impossible for many. In times like these, the fewer things investors do to try and second guess the next turn in direction the better. Investors might consider lightening up holdings and going to more cash. Cash smooths out bumps and grinds and reduces volatility. ### **Cal Water: \$5,000** to Marysville Mayor

The latest Fair Political Practices Commission finance reports reveal that California Water Service (CWS), a private for-profit water company serving Marysville contributed \$5,000 to Mayor Ricky Samayoa's re-election effort. This is a sore subject for rate-payers feeling exploited by the utility.

In 2012, residents began to realize that they payed 2-3 times more for water than friends in Linda, Olivehurst and Yuba City. Those communities were all served by municipal utilities where voters have a say in the rate-setting.

At that time, residents learned that since 2003, CWS had bumped rates nearly every year for a net cumulative 121.80% over ten years -- an average 12% annually. Additional increases were proposed -- 18.4% in 2014, 20.1% in 2015 and 9.4% in 2016 or another 47.9 % over 36 months.

A citizens' complaint was filed with the California Public Utility Commission (CPUC) highlighting ratesetting abuse. However, the residents were naïve to the fact that the CPUC was corrupt, with the complaint the utilities. The action was rejected by a utility judge.

During the complaint process the residents sought support from the Marysville City Council and the Yuba County Supervisors. The council where Samayoa was a member was not interested in challenging CWS.

CWS touts its nearly 90 years of service to Marysville. However, something occurred along the way causing water rates to far surpass neighboring municipal utilities. Residents and even the city quit watering. It was just too expensive.

Mayoral Candidate Chris Branscum remembers the city when he was raised in Marysville in the 1950s-60s. Every lawn was green and mowed, shrubs and trees alive, parks watered. Branscum left for a stint in the Navy and then a career in business in Texas. When he returned to retire in Marvsville where he has family and property he noticed what many call 'Brown Town' and the general deterioration.

CWS is an incredibly successful corporation operating in multiple states, wonderful for stockholders, but punishing for ratepayers. Cal Water's gift to insure that Samayoa remains mayor comes at the expense of ratepayers. Cal Water and the mayor win while the residents lose.

In 2016, the city council denied a medical marijuana sales permit to River City Phoenix (RCP) since one of its board members failed a background check. RCP appealed, removed

process rigged in favor of its board member and gave Samayoa \$5,000. Then, an acquaintance of RCP contributed another \$5,000. The appeal was granted. Now RCP has a dispensary business in Marysville.

In 2015, Samayoa voted to refinance the bond used to purchase "the B Street Property," (bonds first issued Oct 2010) thereby increasing the debt to taxpayers on 5 acres of property to between \$15-17 million. Samayoa said the property could be sold in 3 years. The property remains unsold today.

In 2016, Samayoa was a major advocate of Measure C the first ever local sales tax passed in Marysville changing rates from 7.50% to 8.50% the highest in the region. Sales taxes, particularly those on transportation (fuel / auto maintenance) have the biggest negative impact on the poor.

On Samayoa's watch 'Brown Town' deteriorated. It is one of the roughest local jurisdictions in which to live and the most expensive (water and taxes). Few city and county employees live or shop in the city. It's a job not a place to live. Families travel outside the city to use parks.

With no enforcing of vagrancy infractions or laws governing unruly behavior, businesses have resorted to hiring private security while residents fend for themselves. Downtown has become a

Applicant organizations must have a record of serving the community in a meaningful way. The application process is simple, and the guidelines and application form can be found at yubasutterarts.org. Interested organizations may also contact Yuba Sutter Arts & Culture directly to request the application. Grant awards will be made in amounts from \$500 to \$10,000. Applying organizations must show a history of service to socially vulnerable populations. Newer organizations must be able to demonstrate a plan to provide arts and culture programming within the grant guidelines.

"Yuba Sutter Arts & Culture is following the lead of the California Arts Council to ensure that all of our policies reflect democratic principles of equity and justice," said David Read, YSAC Executive Director. "The whole point of this regranting program is to begin to eliminate discrimination and barriers to access in our local arts and culture ecosystem, and to avoid disproportionately high and adverse effects on communities of color," he added.

The deadline for applying is Monday, November 9, 2020. Grant award announcements will be made on November 23.

### **Three Measures Test** decade that have reduced whether reform is working

Gov. Gavin Newsom said earlier this year that as the state's prison population continued to decline, he wanted to start closing down

He made good on that and Rehabilitation announced plans to shutter **Deuel Vocational Institution** near Tracy, which had been constructed in the 1950s as a place where young felons could be transformed into solid citizens.

"Given the need to achieve savings and the decline in the prison population since 2007, the state budget called for the closure of a prison. (Deuel Vocational Institution) was chosen for closure based on cost to operate, impact of closure on the workforce, and population housing needs, and prioritization of public safety and rehabilitasaid in a statement.

The announcement is the latest manifestation of the immense change in California's approach to criminal justice, from the lock-'em-up policies of the 1980s and 1990s - which increased the prison inmate populations eight-fold – to the "reforms" of the past

those populations by more than a third.

Some of that reduction stemmed from federal court orders to decrease the severe overcrowding that developed despite construction of dozens of new prisons. However, it mostly reflected a leftward shift in the state's political atmosphere and former Gov. Jerry Brown's desire, during his second governorship, to reverse the tough sentencing policies he had embraced during his first tour of duty four decades earlier.

Brown encouraged the intention last week when the Legislature's dominant Department of Corrections Democrats to modify the state's tough sentencing laws, symbolized by the "three strikes and you're out" doctrine approved by voters in the early 1990s, and personally sponsored one of several ballot measures to go easier on those

convicted of crimes. In effect, Brown and others in the criminal justice reform movement have sought a return to the penal philosophy that California had adopted during the post-World War II era - that counseling, education, drug treatment and vocational training could convert offenders into productive members of society. tion," Secretary Ralph Diaz It was the philosophy that led to construction of Deuel Vocational Institution in the early 1950s.

The new reformist approach, however, is not without its critics who contend that crime will increase with fewer offenders behind bars, although there's no statistical support for that, at least so far. The debate over

has also found its way, as do many contentious California issues, onto the ballot via three propositions. In numerical order:

- Proposition 17, placed on the ballot by a reformminded Legislature, would allow felons who have completed their sentences, but are still on parole, to vote. It's a mostly symbolic gesture but draws ire from criminal justice hardliners who say it would dishonor victims.

- Proposition 20 is the hardliners' response to the recent spate of laws that lighten punishment, including Brown's Proposition 57, a 2016 measure that made parole easier for "nonviolent" inmates. If passed, Proposition 20 would make fewer felons eligible for parole, particularly those convicted of sex crimes, by changing the definition of "nonviolent."

- Proposition 25 is a referendum to repeal one of the Legislature's landmark criminal justice changes, a 2018 law that eliminates cash bail for criminal defendants on the assertion that bail discriminates against the poor. The bail bond industry, facing extinction, sponsored the referendum and is seeking a "no" vote to repeal the law, arguing that it allows dangerous defendants to roam freely and commit new crimes.

Together, these three measures test whether California voters endorse the criminal justice reform movement or believe that it's gone too far.



### **Plumas National Forest Camping** and Fire Restrictions Extended

By Lee Anne Schramel, U.S. Forest Service

QUINCY, CA (MPG) - Fire Restrictions on the Plumas National Forest (PNF) are continuing due to unprecedented and historic fire conditions throughout the state. A ban on all campfires, outdoor BBQ's, and smoking is in place. Portable lanterns and camp stoves using gas, jellied petroleum, or pressurized liquid fuel may be now be used in four open, developed campgrounds on the PNF.

Areas near active and recent fires (North Complex (Bear/Claremont and Sheep) and Walker) remain closed. The entire Feather River Ranger District (west side of the PNF), including all national forest system land, roads, trails, campgrounds, lakes, etc., remains closed. No activities, including hunting and woodcutting, are allowed on the Feather River Ranger District currently. The Bucks Lake area is under continuing evacuation orders per the Plumas County Sheriff.

Camping is available on a first-come/ first-serve basis at specific developed campgrounds; dispersed camping is not allowed.

Frenchman Lake: Boat launches include Frenchman (wet launch) and

Lunker Point (dry launch). All campgrounds are now closed for the season.

Lakes Basin: Gold Lake and Lakes Basin Family Campgrounds are open until October 15, 2020 and then closed for the season. Goose and Haven closed for the season on September 30.

Lake Davis: Grasshopper Flat and Lightning Tree Campgrounds will be open until October 31, 2020 and then closed for the season. Dry boat launch is available at Lightning Tree while wet boat launch opportunities include Camp Five, Honker Cove and Mallard Cove. All other campgrounds are closed for the season. Antelope Lake: The Lost Cove Boat Launch is open at Antelope Lake (wet launch) with no fees and services. All campgrounds are closed for the

Woodcutting is allowed with a permit in open areas and if daily fire restrictions allow (1-800-847-7766).

Note: The free personal woodcutting permit program has been extended through December 31, 2020 and current permits slated to expire September 30 will be honored until December 31, 2020.


