### SACRAMENTO, CA, (MPG) -Were California able to leave well enough alone, today's release (September 8, 2020) of NFIB's latest monthly Small Business Economic

Trends report would give our state's Main Street entrepreneurs more than just hope that economic recovery is gaining real traction, but – uniquely - our Legislature's recent actions are doing their best to slow things down - with one more expected action adding to the down-shift.

"Coming right on the heels as it does of the promising news from NFIB's latest Jobs Report and the U.S. Labor Department's latest Jobs Report, today's SBET findings that its Optimism Index increased to 'a reading slightly above the historical 46-year average' would make for a nice trifecta that in measurable ways, real economic recovery is underway," said John Kabateck, California state director for NFIB. "But California of late goes out of its way to be the big asterisk to any good national trends."

Kabateck pointed to the passage of Assembly Bills 685 and 3216 as two examples of his point, and the expected signing into law by Gov. Gavin Newsom of Senate Bill 1383 greatly expanding employee leave time, an issue that particularly rankles, according to Kabateck, because leave time is something 73 percent of small-business owners have been providing for years and in the best possible way: tailored to the need of the employee not forced into an ill-fitting suit of a state law. Brief descriptions of the bills, and even some ones that were mercifully derailed can be found here.

"You don't need a degree in economics to know what it takes to turbocharge our state's economy, you just need an ounce of common sense," said Kabateck. "The common sense to know you don't lure small businesses to re-open or stay open by adding more costs, rules, and regulations on them. In addition to doing things counter to common sense, our Legislature took a few extra steps in not providing some liability protection against COVID-19 lawsuits, which other states made a priority, and it failed to relax its 'Sue Your Boss' law for even the best of reasons. Fine message we're sending the state's No. 1 job generators."

## Water District Defaults on Appeal; **Board Member Seeks Attorney Fees**

MARYSVILLE, CA (MPG) - On August 31, 2020, a director of the North Yuba Water District (NYWD) filed a motion with the Yuba County Superior Court seeking \$65,560.00 in attorney fees.

"Since I was elected as of 2018, I have been asking for records about the Forbestown Ditch Pipeline Project," said Dr. Gretchen Flohr, NYWD Director, Division 4. "From the beginning, the NYWD administration, backed up by the other board members, have stonewalled me and the public from finding out what is going on. I sued to get those records. I won, and the California Public Records Act requires NYWD to pay my attorney fees that were necessary to prove that NYWD violated

the law," Flohr said.

NYWD is planning on building a pipeline in the Forbestown Ditch - the Gold Rush-era stream bed that provides water to farmers and homes. But NYWD has kept information about the project secret, preventing the public from being part of the planning process.

"Access to water in Yuba County means life and death, wealth or ruin for the people who elected me," Flohr said. "The voters suspect that the Board majority has given total decision-making power to Jeff Maupin, the General Manager, and the people are worried that Mr. Maupin is making mistakes that will result in the loss of future water access, Flohr

"Denying the public access to records relating to the conduct of the public's

law," Flohr continued. "So my only choice was to ask a judge to order NYWD to give me access to the records and information the public needs to find out what is going on and to exercise their constitutional rights to participate in the pipeline planning process."

On March 31, 2019, Flohr filed a lawsuit enforcing her and the public's right to access the records NYWD was withholding. NYWD fought back and filed a cross-complaint against Flohr accusing her of being "frivolous" and motivated by personal animosity.

Yuba County Superior Court Judge Stephen Nicholas Boylan, an attor-Berrier disagreed. On July 30, 2020, Judge Berrier Flohr all of the records she sued to get. As for the NYWD's cross-complaint

Constitution and the California Public Records Act make it clear that every person has the right to participate in the making of any public agency decision, especially the ones that result in spending taxpayer dollars. "But you can't participate in the governmental decision-making process effectively if you don't know what an agency is actually doing," said Paul ney based in Davis who specializes in free speech ordered the District to give and records access law. ## **Yuba Water Invests More than** \$1.25 Million in Community Projects

MARYSVILLE, CA (MPG) - Yuba Water Agency's board of directors approved more than \$1.25 million in grants and a low-interest loan for flood risk reduction, water infrastructure, water quality improvements, fish habitat and emergency water rescue equipment.

"As we all grapple with the ongoing impacts of COVID-19 on our economy - and now wildfires as well, now more than ever we must work to improve community resilience where we can," said Board Chairman Randy Fletcher. "The board's actions today advance critical work to reduce flood risk, improve water quality and infrastructure, habitat, and to support our first-responders here in Yuba County."

#### \$500,000 - Hallwood Flood Risk **Improvements**

Further advancing Yuba Water's longstanding mission to reduce flood risk along the lower Yuba River, the board approved a \$500,000 grant for the Three Rivers Levee Improvement Authority to strengthen the Yuba River North Training Wall, which reduces flood risk to the rural community of Hallwood. The work, expected to be complete in 2021, will bring a 100-year flood protection level to the site, meaning there will be less than a 1-in-100 chance in any given year that a storm will come along that is more powerful than the area is designed to handle. The level of protection is significant because it will prevent the area from being mapped into a Federal Emergency Management Agency flood zone, which would increase flood insurance costs and restrict building in

#### \$90,080 – Hallwood Side Channel And Floodplain Restoration Project

The board also approved an additional \$90,080 for the nearby Hallwood Side Channel and Floodplain Restoration project, which will be used to plant riparian habitat on the Yuba River. This will be the final step of the first phase of this multi-agency, multibenefit project that creates approximately 89 acres of habitat for Chinook salmon, steelhead trout and other native fish. Yuba Water has been working with the U.S. Fish and Wildlife Service, South Yuba River Citizens League, cbec eco engineering, Cramer Fish Sciences, Teichert and Western Aggregates on this critical project to remove a total of 1.2 million cubic yards of sediment from a midchannel training wall in the lower Yuba River, and develop the improved habitat features.

## \$140,000 – Ellis Lake improvements

The board authorized \$140,000 for HDR, Inc. and the City of Marysville to develop a plan to improve and manage water quality and recreational fisheries at Ellis Lake. Yuba Water has been working with the city since January, gathering monthly samples to better understand seasonal changes in water quality. That data feeds into the development of this plan. While Yuba Water will support water quality monitoring and refinement of the plan through 2020, Marysville will oversee the long-term implementation of the plan and management of the lake and its facilities. Implementation of the plan could begin by the summer of 2021.

"Ellis Lake has long been a point of pride for the City of Marysville, providing beautiful views and recreational fishing opportunities for our residents and visitors," said Marysville Public Works Director Craig Platt. "This latest grant brings us closer to improving conditions at the lake, restoring it for the benefit of the entire community."

#### \$500,000 - Opud Water And Wastewater **Infrastructure Expansion**

The board approved a \$250,000 loan and \$250,000 grant to the Olivehurst Public Utility District to complete California Environmental Quality Act work related to a multi-million-dollar water and wastewater infrastructure expansion project planned in southern Yuba County. Once the design phase is complete, the project will be "shovel ready," hopefully making it eligible to compete for state and federal stimulus funds that may be offered in the future to boost the region's economy.

#### \$16,100 - Arboga Residential Water/Septic System Study

An additional \$16,100 will pay for a feasibility study to determine the cost and financing options for connecting residential water and septic systems in Arboga to OPUD's systems. A future connection could help protect groundwater quality by reducing the likelihood of septic system failure in a community with aging infrastructure and a high water table.

### \$10,000 – Emergency rescue equipment


The board also approved a Bill Shaw Rescue Equipment and Training Grant for up to \$10,000 to the Yuba County Sheriff's Office to purchase specialized rescue equipment, including underwater search and rescue gear and rescue climbing rappelling equipment. Named after Yuba Water employee Bill Shaw, these grants cover the one-time costs of up to \$10,000 per applicant annually to support the purchase of rescue equipment or specialized personnel training by first responders in Yuba County.

#### **Letter Of Support For Emergency** Wildfire And Public Safety Act Of 2020

Board members today also expressed their support for Senate Bill 4431: The Emergency Wildfire and Public Safety Act of 2020, which will protect Yuba County's communities by reducing wildfire risk in federal forests, harnessing public-private partnerships to address dead and dying trees, improving best practices for wildfire management and creating more resilient communities and energy grids. The board authorized the chairman to sign a letter of support, which will be sent to the office of Senator Diane Feinstein, one of the bill's authors.

"The devastating fires in our region emphasize the urgency of acting now to protect our communities and improve forest management," said Chairman Fletcher, who also represents the rural communities of Smartsville, Browns Valley, Challenge and others recently evacuated due to the North Complex fire. "This bill is an important move toward more resilient forests and communities for Yuba County and the entire western U.S." Learn more at yubawater.org.

and information. It is a right that is fundamental and necessary to democracy," Boylan said.

To make sure that ordinary people can be involved in governmental decision-making, the Public Records Act encourages people to petition to enforce their records access rights by requiring a losing agency to pay the petitioner's legal cost and attorney fees of the petitioner, which encourages agencies to provide access to records instead of keeping them secret.

"The rules on government transparency aren't rocket science," Boylan said. "Every agency knows that they have a duty to provide the public with access records. When an agency that violates the Public Records Act is ordered to pay the petitioner's attorney fees, it happened because that agency tried to conduct the public's business in secret, and that is just plain against the law," Boylan concluded.

NYWD had until August 24th to appeal Judge Berrier's judgment. That day came and went without any appeal

being filed. As a consequence, Judge Berrier's judgment became final and enforceable.

"Fighting against the public's right to know resulted in a huge waste of time and money," Flohr said. "I cringe when I think of how much public tax money NYWD spent trying to defend the decision to keep the public in the dark about the pipeline project. But the public's right to know what is going on is an important right worth enforcing. I hope that the Board majority and Mr. Maupin learn from this huge mistake and start conducting the public's business more transparently. All they have to do is what the law says they are supposed to do, and this won't happen again," Flohr said.

Dr. Flohr's motion also asks for reimbursement for the cost of preparing and filing her motion, as well as a fee enhancer awarded for successfully prosecuting a difficult case.

Dr. Flohr's motion is scheduled to be heard on September 28, 2020, at 10:00 AM in Department 4 of the Yuba County Superior Court.

SACRAMENTO, CA (MPG) - Governor Gavin Newsom toured the North Complex Fire today. Local lawmakers who represent the region, Senator Jim Nielsen (R-Tehama) and Assemblyman James Gallagher (R-Yuba City), issued the following statement:

"The excuse of climate change cannot be used to deflect from the fundamental failure to address the fuels build-up in our forests that are the cause of these devastating fires. Two years of long-awaited forestry management investments don't make up for decades of inaction by Democratic politicians who control this state, and the radical environmentalists that drive their agenda.

"These same misguided policy decisions have led to rolling blackouts and an energy grid that is falling apart. It has also resulted in

antiquated equipment that sparks wildfires that spew massive amounts of pollution into the air, and unsustainable green power that cannot meet our state's needs.

"We have proposed solutions this year that would do much more to invest in forestry management and modernize the state's electrical infrastructure. Democrats wouldn't even give them a hearing in committee.

"The cause of our recent catastrophic wildfires and rolling blackouts is decades of bad policy enacted by Democrats, not climate change.

"To help reduce wildfires, this Administration must fully fund Senate Bill 901. Money can be achieved by reviewing existing General Fund commitments and immediately pledging the state's Greenhouse Gas funds towards reducing fuel loads in our forests, the primary cause of these fires."

## 19-Year-Old Man Killed **Attempting to Stop Thieves**





The suspects fled in a white sedan. The

resident's 19-year-old son 20's with thin builds. attempted to stop the suspect's vehicle by reaching into the vehicle to disable it. The son was dragged by the vehicle and was found on the roadway with major injuries. Deputies attempted to render aid to the victim and called for medical. The victim was transported to a local hospital via ambulance and later pronounced deceased.



## President Gets Briefed on Wildfires

It was looking a little lonely on the tarmac when President Donald Trump arrived in California to be briefed about record-breaking wildfires that have burned an area the size of Connecticut, killed two dozen people and blanketed the West Coast with smoke. Not a single California state official greeted Trump as he stepped off the plane at an airfield in Sacramento County.

Gov. Gavin Newsom was in a hangar nearby, and promptly met with Trump and several fire officials. But his absence at the steps of Air Force One revealed the latest move in what's become the Democratic governor's delicate dance with the Republican president who is both a tantalizing political foil – and a key link to aid the state needs as disasters mount.

"We've been working very well with Gavin," Trump told reporters gathered on the tarmac.

"We're obviously from different sides of the spectrum, but we have a very good relationship."

Then, inside the hangar where Newsom (wearing a mask) and Trump (not wearing a mask) met with emergency officials, the governor also took a cordial tone.

"I want to thank you and acknowledge the work that you've done to be immediate in terms of your response," Newsom told Trump.

Newsom said they agree on the need to thin more trees and delicately lectured Trump about global warming driving the frequency and intensity of wildfires.

"Climate change is real and that is exacerbating this," Newsom said.

The dynamic between Newsom and Trump has turned out to be one of the major surprises of Newsom's short time as governor. Newsom won office in 2018 positioning himself as the antithesis of Trump, and pledged to lead a "resistance state." But his tenure has been marked by an extraordinary spate of disasters - catastrophic wildfires, the deadly coronavirus pandemic, a decimated state budget and record unemployment – that have required cooperation between two men who once cast each other as clowns.

Newsom has repeatedly praised Trump's disaster aid for California, saying he wants to put political differences aside when problems need to be solved. But it's involved a bit of whiplash. He recently called their relationship "very effective" in responding to emergencies

iust the day after he dissed Trump for saying California wildfires were due to insufficient forest raking. He talked last week about a productive phone call with Trump, even as he criticized the federal government for a lack of action on climate change.

It's a fine line to walk, and Newsom has occasionally slipped, by being so nice that he gave ammunition to a political opponent. While heaping praise on Trump for sending a batch of coronavirus test kits in April, Newsom used one of the president's campaign slogans – "Promises made, promises kept" - and promptly found himself in an ad

for Trump's reelection.

Newsom's approach – meeting with Trump to discuss forest management and climate change, but not appearing in any chummylooking photo ops in front of Air Force One suggests that he is trying to thread the needle. On the one hand, he needs to demonstrate apolitical leadership amid disaster, but also avoid looking too bipartisan in an election year when he's campaigning for Trump's Democratic rival.

"It's a carefully-considered, carefullyorchestrated tango with the president that the governor has no choice but to participate in,"

said Nathan Ballard, a Democratic political consultant who worked for Newsom when he was San Francisco mayor.

Though Newsom disagrees with Trump "about almost everything under the sun," Ballard said, "it is vital for the governor's constituents that he continues to play ball with the president during these unprecedented disasters."

While Newsom and Trump kept things cordial, Newsom's environmental deputies got into a terse exchange with the president.

Wade Crowfoot, Newsom's secretary of natural resources, emphasized the unprecedented heat and warming trend, saying: "If we ignore that science and put our head in the sand...we are not going to succeed together protecting Californians.'

Trump, smiling, said, "It'll start getting cooler, you just watch."

Crowfoot shot back, "I wish science agreed with you."

Trump responded, "I don't think science knows, actually," then briskly called on another presenter.

Demonstrators – of both parties – outside the meeting said they understand why Newsom plays nice with Trump.

Lance Caster said Newsom's approach makes sense to him, even though he doesn't like it. "It depends on what he wants. When he doesn't like what Donald's doing, he bad mouths him, and when he wants something, he's really nice," said Caster, a Republican who works as a truck driver and lives in the Sacramento suburb of Citrus Heights.

Most Californians believe climate change is "extremely important" or "very important" to them personally, according to a Public Policy Institute of California survey last month, and just one-fifth of the state's likely voters said they trust the federal government to handle environmental issues. Not surprisingly in this overwhelmingly blue state, 70% of voters said Joe Biden would be better than Trump on environmental policy.

# Tax Hikes Easier

In a roundabout, passive way, the California Supreme Court last week handed a big victory to the advocates of higher taxes.

Without comment, the justices declined to take up a state appellate court decision that would allow specialized local government taxes to be increased by a simple majority of voters, if they are placed on the ballot by initiative petitions rather than by the governments themselves.

The victory for tax proponents, especially government worker unions, was an equally large defeat for anti-tax organizations such as the Howard Jarvis Taxpayers Association. However, it also may bring more ballot box budgeting and indirectly weaken the role of city councils and other locally elected boards.

Proposition 218, approved by California voters in 1996, declares that local governments seeking more revenue must win voter approval. Proposals for general purpose revenue through increases in sales taxes or other levies need only simple-majority approval. However, if cities, counties and other local governments seek new taxes for specific purposes, Proposition 218 requires two-thirds votes.

Three years ago, the state Supreme Court issued a decision called "Upland" because it dealt with a ballot measure on taxing marijuana in that Southern California city.

Writing the 5-2 majority opinion, Supreme Court Justice Mariano-Florentino Cuéllar declared, "Multiple provisions of the state constitution explicitly constrain the power of local governments to raise taxes. But we will not lightly apply such restrictions on local governments to voter initiatives."

He thus implied that special purpose taxes placed before voters via initiative may not be affected by the two-thirds vote requirement for taxes sought by governments themselves.

Quickly, special purpose taxes placed on the ballot via initiative that garnered less that two-thirds votes were challenged by the Jarvis organization and other taxpayer groups, but trial court judges differed sharply on whether Cuéllar's opinion did, indeed, validate them.

Two of the tests were San Francisco taxes placed on the ballot via initiatives personally sponsored by members of the city's Board of Supervisors, one for early childhood education, the other to battle homelessness. Both received less than two-thirds votes, but a local judge, Ethan Schulman, validated them anyway.

In June, a San Franciscobased appellate court upheld Schulman on the homelessness taxes and the Jarvis organization appealed to the state Supreme Court, which last week validated the appellate court ruling by refusing to take it up.

The tax on business gross receipts for homelessness services will raise as much as \$300 million a year. "San Francisco voters have the right to direct democracy and self-government," City Attorney Dennis Herrera said in a statement. "We're pleased that this legal victory will free up millions of dollars to provide services, housing and mental health treatment for those who most desperately need it in our city."

The Supreme Court's action, or non-action, also may validate other disputed special purpose taxes, including another for early childhood education in San Francisco, an Oakland parcel tax for education and a Fresno sales tax for parks. Local judges had blocked the Oakland and Fresno taxes, declaring that Proposition 218 required them to have two-thirds

Local government officials prefer to ask voters for general revenues because they are more flexible. But advocates for particular causes prefer special purpose taxes to prevent revenues from being diverted elsewhere.

The way is now clear for interests with the wherewithal to qualify and pass ballot measures, such as unions, to push for taxes that benefit their members, thus reducing the authority of local elected officials to set budget priorities.



## Markets Have For The Most Part Slowed

In recent weeks one could argue the markets have for the most part slowed their eye-popping and relentless ascent that became the norm since about the 3 rd week of March.

Investors may be seeing little definitive movement in the Dow but most certainly the same cannot be said for their portfolio balances. A classic rotation has been taking place with some analysts arguing a speculative bubble in particular stocks has popped.

Without singling out any specific names, I'll just say some stocks have gone crazy up, with valuations (the price of the stock versus what the underlying company earns) bordering on the mania phase. One needs only to think back to the dot. com bubble to envision what stock manias look like. Indeed, most will agree the last three months or so has seen similar stratospheric price rises in many stocks.

When stocks gain 50, 75 or 100% in a few weeks, you're in a stock mania folks, and manias, when they end, usually take at least some of the gain and turn it into stomach churning pain. So goes the last few weeks for some stocks and the investors that bought them.

Since the Dow itself has not rapidly deflated as a whole as has happened in the past, these last few weeks is not an all-out rout of the markets, at least not yet.

More so what we're seeing are the previous shooting stars of the shutdown falling back to earth, and since many of these stocks were the popular household names we all know of and love, its more than likely few investors avoided some portfolio bloodletting.

The question now becomes will the rotation become an all-encompassing market blow out? Or will the rotation only deflate some stocks with those monies going into a whole new group of sectors?

The market has indeed been in somewhat of a disconnect of late, with many stocks and indexes reaching or surpassing all-time highs. All this while the economy remains in partial shutdown, likely causing many businesses of all sizes to close their doors for good. If many businesses do shut down for good, and this analyst thinks a good many will, the damage to the economy will be massive.

Most experts believe the Fed bailouts and stimulus programs can only go so far in rescuing the economy. Real growth has to be of the organic type, which means real businesses selling real stuff.

The concern is that the market has not fully accounted for just how much damage there will be. As more economic statistics are reported, reality might bite the markets more than they are now. Add to that a contentious election, wildfires in the west and who knows what waiting in the wings (yea it's been that kind of year), to expect the market to continue its explosive rally may be asking a lot.

As we move into fall, analysts remember that when the leaves fall, markets have fallen in the past, with some historic crashes happening in the months of September and October.

Some good advice might be to take some money off the table where gains have been made. An old Wall Street adage addresses this quite nicely: "No one ever went broke taking a profit.

And lightening up on equities and going to more cash smooths out volatility and reduces risk in a portfolio. Indeed, going to more cash is a favorite of mine when looking at healthy profits while fretting over iffy markets. Trying to squeeze more profits from an already profitable position means the GREED gene is alive kicking. Although this can yield fields of dreams, it can also lead to nightmares if taken too far.

However research for an article titled "Pollution: It's Spreading Like Wildfire" noted that a single Alaskan wildfire emitted more carbon monoxide (CO) pollution than all human caused pollution from "tailpipes and smokestacks in the United States" during the same period. To the state, bad forest management does not equal a human cause of GHG. Maybe it was an 'act of God' even though they tend

"That single (Alaskan) fire emitted 6,600 times more CO during the 3 months it burned than all the pollution ExxonMobil, one of the top five corporate polluters, emitted during an entire year" according to researcher and author Zachary Gerber.

Gerber says the worst wildfire year on record in California was 2017 as 1,266,224 acres burned. According to the EPA (Environmental Protection Agency) those fires emitted more than 1 billion pounds of PM 2.5. PM 2.5 are particles 2.5 micrometers in diameter or smaller that have a damaging effect on health.

In comparison, the EPA estimates that California drivers in 2017 created 22 million pounds of PM 2.5 or just 2% of the fires' output during the same time period. And the state doesn't want to look at the impact of criminal forest management? Gerber estimates that it would take 50-years of California driving emissions to equal one of its wildfire emission events.

Do the environmental-fascist groups really care about creatures? The answer is no. Many biologists, land managers, ranchers and others believe wildfires are the greatest threat to species. The Arizona Bear Wallow Fire in 2011 is estimated to have killed at least 1.5 million vertebrate animals. Using the same survey methods 3.5 million animals perished in the fires of California in 2017.

The article didn't count the human lives lost because to liberals there are 6.5 billion too many of those already.

## Don't Be Fooled: Prop. 15 **Raises Taxes on Farmers**

retired public servant, and a walnut farmer. I recently wrote to the Appeal Democrat to express my concerns about how farmers, among many others, would be harmed if November's proposed Proposition 15 property tax increase passes. A community member reached out to me asking me to clarify my comments. They argued farmland would be unaffected by Proposition

Why are people confused about Prop. 15? As a leading agricultural county, understanding this measure is important to protecting our local jobs and economy.

A thorough examination of the text of Proposition 15 reveals while the measure does not raise taxes on farm "land," it still hits farmers with major tax increases, through new taxes on our trees, vines, fences, barns, silos, and irrigation systems.

Such a plan is like a car dealership offering you a "free" Mercedes Benz. What's the catch? Fine print that says if you want the car you also have to purchase the tires that it comes with for \$40,000. Such a gimmick would be dishonest. Likewise with claims that Prop. 15 doesn't raise taxes on farmers.

Voters should always "read the fine print," especially when it comes to plans to take more of our hard earned dollars Yuba City Councilmember

through new taxes.

While Prop. 15 exempts agricultural to include "improvements" and "fixtures" on that land, which are taxed separately per California Revenue & Taxation Code, Section 607.

The definition of a "fixture" or an "improvement" needs to be looked at to see the real ramifications of Prop. 15. Board of Equalization Rule 124 states improvements, "include mature fruit and nut trees, grape stakes and trellises, buildings, fences, dams, paved roads, sprinkler systems, and mature grapevines."

Don't fall for false campaign promises that farmers will not be hurt by Prop. 15. Like so many other family businesses in our community, California farmers are struggling this year. The last thing farmers need is more costly taxes.

The California Farm Bureau Federation was among the first to oppose Proposition 15, stating the measure raises taxes on farmers by billions and will further hit struggling consumers with higher grocery bills when farmers must pass these costs

I'm voting no on Prop. 15. But don't take my word for it. Read the measure for yourself.

#### Variety Of Forces Affects Winegrape Harvest

As winegrape harvest accelerates around California, farmers navigate forces that include high temperatures, wildfire smoke and the marketing impacts of the pandemic - on top of large supplies that left some grapes unharvested a year ago. Analysts expect this year's harvest to be about the same size as last year's. Marketers say the pandemic has shifted wine demand to retail outlets, with less being sold at restaurants or tasting rooms.

#### Pandemic Widens Gap In Farm And **Retail Meat Prices**

Impacts of the pandemic continue to reverberate through the meat business. An American Farm Bureau Federation analysis shows the gap between the retail price and farm price of beef is the largest in 50 years of recordkeeping. A similar gap exists in pork prices. While pandemicrelated demand boosted retail prices, slowdowns at meat processing plants led to a backup of animals in the marketing chain that drove farmers' prices down.

#### Fires Damage University **Agricultural Facilities**

Agricultural and forestry research and teaching projects have suffered damage from California wildfires. A representative for Cal Poly San Luis Obispo says it could take months for a full assessment of damage to its Swanton Pacific Ranch in Santa Cruz County, where structures including classrooms burned. Fires also hit six reserves managed by the University of California, with researchers still working to determine the impact on their projects.

#### **UC Studies How Birds Can Reduce Orchard Pests**

Bug-eating birds can help farmers reduce populations of a damaging orchard pest, according to University of California research. The project showed wintertime feeding behavior by the beneficial birds reduces larvae of the codling moth, which can damage walnuts, almonds and other crops. Some birds can themselves damage crops, but the researchers say in nut orchards, the benefits of attracting beneficial birds outweighs any risks. ★

## Physicians Urge You to Recognize the Warning Signs of Suicide

WASHINGTON, D.C. (MPG) -In recognition of National Suicide Prevention Week, the American College of Emergency Physicians (ACEP) urges everyone to do their part to support those who may be struggling with depression or other mental health challenges by recognizing the warning signs of suicide, knowing how to help, and becoming more familiar each community.

"Spotting suicidal thoughts or behaviors could help avoid a tragedy," said William Jaquis, MD, FACEP, president of ACEP. "Each of us will process this pandemic in our own way, but people may be more likely to experience difficult feelings during a crisis. You can be sure that emergency physician will be there for you."

Call 911 or visit the closest emergency department in the event of a medical emergency or if there is an immediate health or safety threat. Contact a mental health professional if you, or someone you know, exhibits one or more of these warning signs:

Hopelessness; Rage, uncontrolled anger, seeking revenge; Acting reckless or engaging in risky activities; Increased alcohol or drug use; Withdrawal from friends, family, or society; Anxiety, agitation, trouble sleeping

Dramatic mood changes

Consider contacting a health professional if stress impedes your daily activities for several days in a row. Talk to the person to understand what they are thinking and feeling. Research shows that discussing suicide may reduce suicidal thoughts. Help a person at-risk by connecting them with trusted friends or family, or a mental health professional.

If emergency care is with resources available in required for a suicide attempt, a physician-led care team will keep the patient safe until they are ready to go home. Prior to discharge, resources for longer-term care will be outlined as appropriate and a list of nearby experts and places to go for help will be provided as available. The care team will work with the patient to create if and when you need us, an a written safety plan that includes their unique warning signs, coping strategies, and resources for help.

It is critical that patients try to maintain a safe environment for themselves at home. More than half (52 percent) of suicides involve a gun, according to research available through AFFIRM, an emergencyphysician-led organization dedicated to firearm injury prevention research. Misuse of medication also poses significant risks. Ask a doctor about how to safely dispose of unused, expired or unwanted medicines. Consider taking steps to identify the best or sleeping all the time; strategies for safe storage

of medication, firearms or other potential home hazards. One helpful tool that encourages safe storage based on personal choices is Lock2Live, an education website developed by emergency physicians.

"Suicide is complicated, and emergency physicians are vital partners in the collaborative effort necessary to prevent these incidents from occurring. If you ever feel like you may hurt yourself or others or you have thoughts about taking your own life, please seek help right away," said Dr. Jaquis.

If you or somebody you know experiences suicidal thoughts or behaviors, call 911 or go to your nearest emergency department. The National Suicide Prevention Lifeline at 1-800-273-TALK (8255), is available 24 hours a day, seven days a week. The service is available to anyone and all calls are confidential. The Centers for Disease Control and Prevention (CDC) offers additional resources for help.

The American College of Emergency Physicians (ACEP) is the national medical society representing emergency medicine. Through continuing education, research, public education and advocacy, ACEP advances emergency care on behalf of its 40,000 emergency physician members, and the more than 150 million Americans they treat on an annual basis. ## No Pandemic Shutdown for Scammers, They Are Still on the Prowl

COVID-19 may have shut down portions of the economy and put restrictions on Americans' daily lives, but cyber scams and other efforts to defraud people continue to

"Scammers are tapping into the uncertainty related to the global pandemic," says Chris Orestis, the president of LifeCare Xchange who is known as the "Retirement Genius" (www.retirementgenius.com).

"They are using social engineering to target people with tactics that take advantage of today's technology. Seniors need to be especially mindful of the mechanisms that have been explicitly designed to target people in retirement."

Some scams to be on the lookout for

include: Dishonest retailers. Many dishonest retailers and fake products are popping up, Orestis says. "The shortage of toilet paper, hand sanitizer, soap, and masks at the beginning of the quarantine resulted from people's panic," he says. "The fear of scarcity created a gateway for scammers. Fraudulent online retailers are showcasing these items as bait, especially medical supplies." But they don't have any inventory, so stick with reputable stores, Orestis says. Scammers also try to sell products to prevent or cure COVID-19, even though they do not exist. "Anyone who receives a message from someone selling any of these items should not respond," Orestis says.

Phony advertisements. Scammers also try to advertise hard-to-find products through social media, email or ads that pop up on certain sites. Avoid clicking on anything unfamiliar because cyber criminals may be trying to steal your personal information or infect your computer with a virus, Orestis says. "Be cautious of people who try to contact you under odd usernames and do not have a profile picture," he says. "If anyone asks for your personal information or invites you to click on a link, block them immediately or report them as spam."

Government or organization disguises. Is a government official or someone from the CDC or from the World Health Organization trying to contact you? Maybe, but probably not. Scammers often try to convince potential victims that they are with a legitimate agency or group, Orestis says. "For example, an email might claim that there have been

new COVID-19 cases in your area and ask for your personal information to see if you have been in contact with anyone infected," he says. "Be suspicious of any COVID-19 related emails and use only official government websites to get information about the virus."

Fake charities and crowdfunding. Criminals have also created counterfeit charities and crowdfunding sites. They ask for money in the form of cash, gift cards, and wire transfers. "Real charities will never use these resources," Orestis says. "Be sure to use reputable sites and research the charities you want to donate to for coronavirus relief.'

**Phone scams.** Phones are still the No. 1 way scammers target seniors, both through calls and text messages. The Federal Communications Commission warns about these methods being used by people who claim to be the IRS or have coronavirus treatments, at-home testing kits, and vaccinations. "If you receive a robotic voice call, do not press any buttons or return any calls," Orestis says. "Hang up immediately. If you receive text messages regarding this information, do not respond or click on any links."

"It's important to be wary of these and other scams, both off and online," Orestis says. "The more conscious people are of how scammers are trying to trick them, the less likely they are to fall for one of those tricks."

Arson investigators have opened a probe into the suspicious origins of a deadly Oregon wildfire that began in the town of Ashland and destroyed hundreds of homes in nearby communities, Ashland's police chief said on Thursday. The remains of two victims have been found in ruins from the blaze, which erupted on Tuesday and roared through a third day in the midst of a spate of wildfires across Oregon, according to a spokesman for the state fire marshal. More bodies are expected to be discovered as search teams comb through the wreckage of dwellings that were engulfed during a chaotic evacuation of populated areas along the path of the swiftly spreading flames, Ashland police chief Tighe O'Meara said.

Trump announces deal between Bahrain, Israel to normalize relations in push for Mideast peace
