## Fire Rages Again

**BUTTE COUNTY, CA (MPG)** - Heat lightning from thunderstorms moving through the valley early this week have set off over 26 fires in the area. Evacuation warnings turned into orders in the matter of hours, affecting large areas of Oroville, reaching to downtown areas, Kelly Ridge and Cherokee. Residents have since been allowed to return to their homes.

At the time of this article, Cal Fire firefighters and volunteers in the area were working overtime to contain two separate incidents in and above the Oroville area: the Potters Fire

and Butte Lightning Complex Fire, which was composed of 35 confirmed smaller fires.

CAL FIRE established a North Lightning Coordination Area (LCA) encompassing the Paradise and Forrest Ranch areas and a South LCA encompassing the Kelly Ridge and Oroville areas to address the smaller fires in remote locations that continued to pop up. Over 50 reports of fires have come in (not all confirmed), with new fires reported in the Butte Creek and Sterling City area. Containment of the largest, the Potters Fire, remains top priority with firefighters vigilantly monitoring the

others.

Fire crews have been able to tie into the lake and are using pumping platforms as another option to fight the blaze, which has burned all the way down to the Oroville Dam spillway. The typical equipment used to contain a blaze, dozers, engines, water tenders and aerial support are also being utilized.

According to the CAL FIRE website, there are currently 24 active fire incidents across the state, many nowhere near contained and some comprised of multiple fires, straining resources. At a briefing Tuesday

### JONES FIRE

Three Temporary Evacuation Points have been opened by Nevada County with assistance from Red Cross volunteers:

Ready Springs Elementary School, 10862 Spenceville Road, Penn Valley; Nevada County Fairgrounds, 11228 McCourtney Road, Grass Valley; Cottage High School, 22600 Kingston Lane, Grass Valley

### POTTERS FIRE

Red Cross volunteers are staffing a Temporary Evacuation Point at the Oroville Church of the Nazarene, 2238 Monte Vista Ave, Oroville

Those impacted by these fires can visit a Temporary Evacuation Point for water, snacks and information about Red Cross services. We can also provide hotel lodging assistance as needed, for those who have been forced out of their homes. Depending on the size and scope of a fire, hotel accommodations are being prioritized to ensure social distancing amid the coronavirus pandemic. Residents must check in with the Red Cross at a Temporary Evacuation Site in order to receive assistance.

### DONATIONS:

At this time, we cannot accept donations of water, clothing or food due to COVID-19 restrictions. Those interested in supporting Red Cross disaster response operations can do so by making a financial contribution at 1-800-REDCROSS or by visiting redcross.org.

## New Recipe for Salmon

**SACRAMENTO, CA (MPG)** - The second year of our Pilot Salmon Project field-work has yielded some exciting results and should pave the way for the Rice Commission and our fish conservation partners to develop methods to utilize winter-flooded rice fields to help struggling salmon populations.

In late-March, we released nearly 350 baby salmon that were raised in rice fields. Later, we released a set of control groups that were reared and released using more traditional approaches. Fish in both of these groups were fitted with a very sophisticated tag, allowing us to track their travels through the watershed and out to the ocean. Our hope was to demonstrate rice field-reared fish might

survive their journey out to the ocean better than those that are raised in hatcheries. We hypothesized this possible outcome based on previous studies showing that salmon grow very fast in rice fields because of the abundance of their natural food sources in these fields. I'm happy to say that our 2020 graduating class of our young salmon did not let us down!

# News Outlook

I ran across a very interesting article in Stateline magazine. Some things we already knew were coming are arriving a lot sooner than we thought. An Oxford University study in 2017 found that 86% of restaurant jobs, 85% of manual labor, and 92% of retail sales jobs could be automated. In a June survey, 44% of corporate financial officers said they were considering more automation in response to coronavirus issues. Rural areas, where companies have built many factories because of lower labor costs, are particularly vulnerable to “task replacement” by robots and other machinery, according to the Brookings report. Tyson Foods, which already was experimenting with automation, sped up work on a robot chicken butcher in recent months, citing increased urgency because of the pandemic. Fast-food chain White Castle plans to start using a robot fryer named Flippy this fall in Chicago, a measure to minimize human contact with food. The company said workers should be able to help more customers while Flippy does its “time-consuming and dangerous” job over a vat of hot oil. Fast

food venues everywhere are adding kiosks for contact-free ordering, department stores are dropping off automated orders at the curb, and robots are delivering towels and room service at Hilton and Marriott hotels. I have said it before when I am disappointed in my customer experience... the robots are coming.

morning, firefighting crews were told to expect working double or triple shifts, being pulled off one fire to be put on another, and that support and relief, although requested, may not arrive. CAL FIRE Butte Unit and Butte County Fire Department Chief, John Messina said to the somewhat small crew gathered for the briefing, “I want you to look around and look next to you....This is it. For 26 fires, about 1,500 acres.... And when we mean this is it.... THIS IS IT.” He was adamant that, “We’ll get through it” referring to a solid plan of attack established

to contain the fire areas threatening communities and the public, adding that “the stuff that’s high in the elevations, those may burn for awhile before we can get to them.” He asked for crews to be patient and overall, to “Hold the line. We cannot give up anything we have held... it is essential that we do not let something get out that’s already contained.” As of Wednesday morning, the Potters Fire had burned over 930 Acres and was 20% contained. The Butte Lightning Complex was 1500 acres (35 separate fires) and 10% contained. ★

# California’s Crisis of Competence

Year by year and article by article, Ralph Vartabedian has revealed to Californians the woeful shortcomings of the state’s largest public works project, a north-south bullet train.

Vartabedian, a writer for the Los Angeles Times, has made a virtual career of uncovering the project’s managerial, financial and political failings, lending factual credence to the conclusion that the wisest course would be to cut our losses and give it up.

Although the project enjoyed strong personal support from two previous governors, Arnold Schwarzenegger and Jerry Brown, Gov. Gavin Newsom came very close to calling it quits when he took office 19 months ago — then backtracked and proposed a modified version that’s still unrealistic.

Vartabedian’s latest revelation in the Times underscores that fact, describing that “a series of errors by contractors and consultants on the California bullet train venture caused support cables to fail on a massive bridge, triggering an order to stop work that further delayed a project already years behind schedule...”

“Hundreds of pages of documents obtained by the Times under a public

records request show the steel supports snapped as a result of neglect, work damage, miscommunications and possible design problems.”

“High-strength steel strands supporting the 636-foot-long structure began to snap on Oct. 22, one after another,” Vartabedian wrote. “Ultimately, 23 of the strands, which are composed of seven individual wires each, broke unexpectedly, according to rail authority documents and officials. The order to stop work was issued Nov. 4.

“A forensic engineering analysis, obtained by the Times, found that the strands corroded from rain-water that had leaked into the internal structure of the bridge and then broke.”

Vartabedian quotes Robert Bea, emeritus professor of civil engineering at UC Berkeley and co-founder of its Center for Catastrophic Risk Management, as calling it “a horrible sequence of mistakes.”

Vartabedian’s article not only once again demonstrates that the bullet train is a multi-billion-dollar boondoggle, but exemplifies why a vigorous and unshackled press is invaluable in overseeing the conduct of public officials.

Unfortunately, the failings of the bullet train that Vartabedian has so consistently and thoroughly revealed are also emblematic of a larger malaise: the erosion of competence in a state government that once prided itself on doing big things well.

California once built highways, bridges, university campuses, dams, canals and other public works quickly and efficiently. It even dispatched its crack highway

engineers to other nations to provide can-do advice.

Those days are long gone. For example, it took two decades, with huge cost overruns, to replace one-third of the San Francisco-Oakland Bay Bridge even though building the entire bridge originally took just four years in the 1930s.

The bullet train’s managerial shortcomings are also reflected in recent meltdowns in the Department of Motor Vehicles and the Employment Development Department, largely due to managerial neglect of their outmoded information technology systems, a condition that plagues numerous other state agencies.

The underlying syndrome is the obsession among bureaucrats and their political overseers with short-term actions to get public attention while ignoring consequences and long-term issues.

The bullet train is a prime example. It was launched without a well-thought-out plan, without complete financing, without an effective organizational structure — and without a valid factual need. The folks in charge have been making it up as they go along and the result has been a disaster.

It’s something to ponder every time a politician proposes some grand scheme, such as the universal health care system that Newsom often touts. Why should we believe it would be any more functional than the DMV, EDD or the bullet train?

# Yuba Water approves more than \$2.2 million for community water supply, flood risk projects

MARYSVILLE, CA (MPG) - Yuba Water Agency’s Board of Directors today committed more than \$2.2 million in grants for Yuba River-focused water education, water supply improvements, flood risk reduction and swift water rescue equipment.

As part of its continued support of water education and community development projects in Yuba County, Yuba Water approved up to \$71,000 to South Yuba River Citizens League for education and community engagement.

The bulk of the grant, \$56,000, will support the organization’s popular salmon expedition tours for fourth-grade students, which teaches them about Chinook salmon, the ecology of the Yuba River watershed, and the impacts of Gold Rush-era hydraulic mining to the Yuba River and the native people. The tours also share information about current restoration programs. In light of COVID-19, the funding will be used to develop and professionally produce a six-episode video series showcasing – and temporarily replacing – the on-river expeditions. The video series will be shared with all fourth grade classes in Yuba County.

“We are thrilled to support programs that educate young people about the incredible natural resource right here in their own backyard,” said Yuba Water Director Andy Vasquez. “But we’re also excited about the possibility of expanding this educational opportunity to other distanced learning programs beyond our region since it will now be available as a video series.”

\$10,000 will be used to support SYRCL’s active involvement in the development of Yuba Water’s planned Watershed Experience Center and ongoing water-based curriculum for schools in Yuba County.

The remaining \$5,000 will go toward the organization’s involvement in a diverse stakeholder group focused on community development pertaining to river resources in and around Yuba County on the Yuba, Bear and Feather rivers.

Helping conserve and enhance water supply reliability for Browns Valley Irrigation District’s customers and service area, Yuba Water also approved a cost-share match of up to \$2 million to leverage potential additional funding for continued work on the district’s Sicard Pipeline Project.

Once the project is complete, approximately 10 miles of inefficient ditch that is used to deliver water will be fully piped, conserving up to six percent of the water in the district’s main reservoir – Collins Lake –in addition to

mitigating several high-risk vulnerabilities with the current, unlined ditch.

Yuba Water’s funding is contingent upon the district receiving a U.S. Bureau of Reclamation WaterSMART Water and Energy Efficiency cost-sharing grant, which is designed to fund projects that conserve water by converting open canals into pipelines, installing irrigation flow measurements, and hydropower projects. If the Bureau of Reclamation’s grant is awarded to BVID, the agency will then collaborate with the district on a specific grant agreement.

Reducing flood risk for southeastern Yuba County, Yuba Water approved a \$150,000 grant for Reclamation District 2103 to repair a critical erosion site along the Dry Creek levee.

The site was first observed in 2017 when erosion started near a tree that had fallen. In 2019, the erosion worsened, growing from approximately 50 to 250 feet.

Approximately \$75,000 in state funding is available for the \$225,000 total cost of the project. Funds from Yuba Water will allow RD 2103 to complete the necessary repairs prior to the start of the upcoming storm season.

To maintain and enhance a reliable water supply for people living in the Yuba County foothills, Yuba Water approved a grant worth up to \$34,200 to help the Camptonville Community Services District with two projects.


Up to \$18,400 will be used to replace the district’s internally-corroding, 64,000-gallon disinfection tank, which ensures safe drinking water for Camptonville Elementary School, residents and businesses.

The additional \$15,800 will be used to plan and design a well system that has the ability to produce reliable amounts of water during times of drought and can be connected to the district’s water plant distribution system.

This grant will fund dry suits and personal flotation devices for the Linda Fire Protection District as part of Yuba Water’s Bill Shaw Rescue Equipment and Training Grant program. The district’s current equipment is aging and in need of replacement.

The Bill Shaw Rescue Equipment and Training Grant Program, which was created in 2018, is designed for first-responder agencies in Yuba County and will cover the one-time costs of up to \$10,000 per applicant annually, associated with the purchase of rescue equipment and specialized personnel training. Since its inception, the program has supported 15 agencies with more than \$193,000 in grants.

# Butte County Sheriff's Office Exhumes Body and Identifies 1969 Missing Person

Butte County Sheriff's Office Press Release

BUTTE COUNTY, CA (MPG) - In November of 2019, a citizen began communicating with the Butte County Sheriff's Office (BCSO) regarding a 1969 missing person case. The citizen had received information from the Doe Network about the missing person case. The Doe Network is a 100% volunteer organization devoted to assisting investigating agencies in bringing closure to national and international cold cases concerning Missing & Unidentified Persons. Detectives researched the 1969 case and determined an unidentified male died in Butte County in 1969 as the result of an accident involving a train. Detectives were not able to identify the male in 1969.

Detectives conducted research and determined there was a high probability the male was Marvin Price McMullen, of Florida. Mr. McMullen was born in 1931 and was believed to have been traveling in California in 1969. Detectives began communicating with Mr. McMullen's family and ultimately

obtained DNA samples from a relative of Mr. McMullen.

On April 22, 2020, BCSO received a permit from Butte County Public Health to exhume the body of the unidentified male. On Saturday, May 2, 2020, BCSO detectives, Chico State Forensic Anthropology Professors and Butte County Public Works personnel exhumed the body. The body was transported to a local funeral home where DNA samples were collected for testing and comparison, in an attempt to confirm the identity of the male.

BCSO transported DNA from Mr. McMullen's family members and DNA from the unidentified male to the California Department of Justice DNA lab in Richmond for processing. In July of 2020, BCSO obtained the results of the DOJ DNA analysis. Based on the DOJ DNA analysis, BCSO positively identified the male as Marvin Price McMullen. Mr. McMullen's remains have been released to his family. The Butte County Public Guardian's Office assisted Mr. McMullen's family members with burial expenses. ★

# Stepping Up to Support California's Energy Crisis

Between the heat and the rolling blackouts, I'm sure you've figured out that we are seeing record breaking demand on California's electrical system this week. At Yuba Water Agency, we are stepping up our power generation efforts to support the state through this energy crisis.

Starting Tuesday (August 18), we increased our hydroelectric power generation to add an additional 20 megawatts to the state's power grid during this critical time. This additional clean power production covers all hours of the day, including the peak hours between 3-10 p.m. when it is needed the most. This increase can power an additional 20,000 homes or businesses. It also means increased flows below Englebright Dam along the lower Yuba river, so anyone trying to escape the heat at the river should be aware of the possibility

of faster, higher flows.

We're able to support the state's needs in this crisis because of the award-winning Yuba Accord – a landmark agreement that sets the rules on how much water we release and when. That collaborative agreement spells out how we operate in a way to benefit both fish and people, and how we change those plans based on extreme weather conditions.

Under normal operations, we'd save this water for future needs, but in light of the historic heat wave and energy shortage California is experiencing, we are proactively taking the initiative to increase our power generation to help the state through this crisis.

I would also be remiss if I didn't take this opportunity to reinforce the importance of hydroelectric power as part of our state's broader energy portfolio. It truly is the best of the renewable energy options, because in addition to being carbon-free, it's incredibly reliable, flexible and sensitive to the sudden changes

in demand. It doesn't matter if the sun is shining or if the wind is blowing. At New Colgate Powerhouse, we can ramp up to full production in just 8 minutes.

And what do we do with the revenue that we get from all that hydro-power? Our earnings are invested right back into Yuba County, into important projects that are truly powering a brighter future for our residents. We are actively improving forest health in our watershed to lessen the risk of catastrophic wildfire and reducing flood risk in communities that have been hit too many times already. We are improving water supply infrastructure and investing in water education for our schools, all to spark economic development in a community that has been disadvantaged far too long. All that and much more.

So, for our Yuba residents, I hope you can view this as a "glass half full" to this otherwise miserable heat wave.

Stay cool, if you can, but please do so safely. ★

# Population Control and Racism

Nearly 2400 years ago, Grecian philosopher Plato spoke of the need for population control. Plato's student Aristotle then advocated the use of abortion and infanticide toward that end.

Just over 300 hundred years later Christians fought against infanticide - the killing of children and raised live babies rescued from the garbage heaps.

In 1798, Thomas Malthus wrote an essay on population control when the earth had about 800 million people. He argued for needed checks on population such as disease, wars, disasters, famines and genocide. Malthus said these are beneficial to increase the death rate and that human suffering and misery were necessary to thin the crop of people. He could not conceive of the earth sustaining more tenants. Neither could alarmist Professor Paul Erlich who wrote the grossly inaccurate Population Bomb in 1970.

In 1859, Charles Darwin published "On the Origin of Species by Means of Natural Selection, or the Preservation of Favoured Races in the Struggle for Life" and in 1883 Darwin's cousin Sir Francis Galton wrote more pointedly about the need for nurturing 'favoured races' via eugenics (preserving those of a noble birth or white supremacy).

In the early 20th century the eugenics movement gained footing in universities and funding for organizations embracing it. The eugenics proponents rejected the Founding Fathers' Biblical belief that all humans were valuable and born equal, and instead began promoting the idea of a master race from a noble blood line.

In 1916, Planned Parenthood (PP) was formed by racist eugenics advocate Margaret Sanger to purge minorities. In 1939, President of IBM and eugenics proponent Thomas Watson established a subsidiary in Poland to provide technology to the Nazi war effort. The IBM outpost helped the Nazis throughout the war and was managed from IBM's New York headquarters.

During the Nuremberg trials Nazi defendants argued that their purging of inferior blood lines was being directed from the United States. They quoted Supreme Court Justice Oliver Wendell Holmes, "It is better for all the world, if instead of waiting to execute degenerate offspring for crimes, or to let them starve for their imbecility, society can prevent those who are manifestly unfit from continuing their kind... three generations of imbeciles are enough."

The Nazis were punished but not Watson who passed IBM to his son and whose

granddaughter married Alexander Sanger, the PP founder's grandson.

Microsoft Bill Gates' father William Henry Gates II served on the board of PP and Bill's mother Mary Maxwell Gates was on the board of IBM, from which he launched Microsoft.

## Does the Average Investor Truly Understand How Stocks Work

With the recent stock split announcements from Tesla and Apple, it got me thinking as to whether the average investor truly understands how stocks work.

Although stock splits are common, my guess is stock splits are not completely understood by the average investor and even some advisors.

A stock split is thought to be a good thing. It is however one of life's better examples as to the difference between perception and reality.

There are two types of stock splits: A common "split" and a "reverse" split. Due to the complexity of the two events I will cover the reverse split in next week's article.

A common "split" is the type more investors are familiar with. It entails a company giving current shareholders more shares.

For example, if you own 100 shares of ABC company and they undertake a 2 for 1 split, you are given one extra share for every share you own which is why it is called two for one. You end up with two shares instead of one.

So in a 2 for 1 split, instead of having 100 shares you would end up with 200 shares.

A 3 for 1 split would mean you would end up with 3 times as many shares (300). A 4 for 1 split would mean your 100 shares would become 400 shares.

Sounds great right?

Not so fast.

What many investors don't realize is whatever the ratio is for the split, the stock price is reduced by the same (negative) multiple.

So if the share price is \$10 and you originally have 100 shares, you have \$1,000 worth of stock (\$10 x 100 share = \$1,000).

If the company announces a 2 for 1 stock split, you end up with 200 shares, but the stock price drops to \$5 the day of the split. Your new amount of shares is 200, each worth \$5. Net worth of stock? The same \$1,000.

Simply put, if they double the amount of stock, the price is cut in half.

Do a 3 for 1 split and the share price is cut in thirds while you end up with 300 shares, and so on.

Net effect?

None.

Think of it like taking a pencil and breaking it in two. You now have two pencils but no more actual pencil than you started with.

The question then becomes, if an investor ends up with more shares after a split but each share is worth that much less, how does he benefit?

He doesn't.

It's all perception.

In a stock split, there is no monetary gain to the shareholder.

There is a reason however a stock split is thought to be a positive thing for existing shareholders.

After a split the stock price is lower. In the basic presumption of the theory of economic demand, a lower price means more demand.

Indeed, if a stock price is lowered through a split, that can mean more people may buy the stock, and the more buyers there are for a stock, the higher the price may go.

For a real world example, the share prices of both Tesla and Apple when split, will come down dramatically.

Tesla did a 5 for 1 stock split with a share price in the area of 1400 when announced. That means for every share of Tesla you own, you will get four more. The price of Tesla will be cut by that same percentage, meaning Tesla shares will be in the \$300 range instead of in the thousands.

Apple did a 4 for 1 split, so its price will drop to 25% of what it is the day of the split.

Although the actual split garners the shareholder no real advantage in the math of the split, the reality of the lower stock price means more people may buy the stock.

Indeed, as a generally accepted belief, investors like lower priced stocks. If a stock price is too high, fewer investors will buy it and if a stock price is lower, more people may buy it.

Stock splits look to take advantage of this investor propensity.

### USDA Expands Pandemic-Relief Program

As farmers and ranchers continue to struggle during the pandemic, the U.S. Department of Agriculture announced Tuesday it has made more crops and commodities eligible for relief under the Coronavirus Food Assistance Program. Farmers of 42 new fruit, vegetable and nut crops may now apply, along with producers of cut flowers and nursery crops, farmed fish and other products. USDA extended the application deadline to Sept. 11.

### Pandemic Alters Demand For Mushrooms

Mushroom farmers around California say they have reduced production as the pandemic cut demand from restaurants and other food-service customers. Shipments had hit record highs late last year, before customers began cutting orders as restaurants closed or reduced business. Several mushroom farmers say they have cut volumes as much as 30% as they adjust to see-saw markets.

California ranks second in the nation in mushroom production.

### State Senate Won't Hear Livestock-Feed Bill

A bill that could have reduced recycling of food waste to feed livestock has been pulled from consideration before a state Senate committee. The bill, to have been heard this week, would have prevented livestock producers from receiving food byproducts from restaurants, grocers and others. Farmers recycle and upcycle the food waste as livestock feed. Opponents say the bill would have forced more food waste into landfills rather than being used to feed animals.

### Researchers Report More Progress Against Citrus Disease

A few days after authorities said an insect carrying a deadly plant disease had been found for the first time in a California commercial citrus grove, University of California scientists described progress in possibly counteracting HLB disease. UC Riverside researchers say they created models of the bacterium that causes HLB, which could help manage it. Another UC Riverside team recently announced progress on a treatment. ★

# California's Mixed Messages on COVID-19 Create Confusion

**SACRAMENTO, CA (MPG)** - There have been too many conflicting messages to the public surrounding the COVID-19 pandemic. There has been a loss of focus on the people of California's overall health and well-being, and the guiding values of this administration have been misplaced.

Since a public health emergency was declared in March, my office has received thousands of calls from people and local governments confused by conflicting guidance. This confusion stems directly from the administration and state health authorities. Local health officials have had little to no direction; instead, they watch the governor at his noon briefings talking about his dimmer-switch approach to his health orders, while Californians hope and pray for real answers.

"Localism is determinative," Gov. Gavin Newsom said during one briefing. When counties started opening, they were told to stop and wait for state approval, acting like more of an on-off switch than a dimmer.

At first, local variances were allowed, counties were told that an "attestation" required the health officer's signature. Later, after some

counties announced openings, they were told the state would review and approve them. A defiant county risks losing state relief money. When Modoc, Yuba and Sutter counties were cleared to open by their health officers, as instructed by the state, the administration sent agents from the Bureau of Alcohol Beverage Control to shut down businesses complying with local guidance.

Things have become so bad on the local level that county health officers and other officials are caught between an irate citizenry, including death threats, and a state bureaucracy drunk with power.

Unsurprisingly, more than 10 county health officials have resigned rather than face the reality of having no control over the residents they took an oath to protect. And, now the California Department of Public Health director has resigned after reports of major inconsistencies in the testing data.

We were told to go for walks to get fresh air and maintain good health, but then they closed state parks and beaches while leaving others open in high infection areas.

When protesters demonstrated and rioted across California, the governor's response was, "God bless you. Keep doing it." Why is it that the Constitution gives us the freedom to protest, and the same amendment gives us the freedom of religion, yet we can't go to church? The governor obviously deemed church non-essential even though it's protected by the Constitution.

Since March, consolidation of political power under the guise of public health has

given Newsom sole authority to freely spend tax dollars and dictate public policy at will. Our constitutional freedoms have been trampled, and we must take them back. Currently, there is one branch of government making all of the decisions, decisions aligning with one party's agenda.

The executive branch has taken the emergency declaration as a license to unilaterally govern, spend money, make policy and enforce laws without including other branches of government. History shows us that human rights given away during an emergency are rarely given back.

Perhaps most discouraging has been the abdication of the Legislature's role. Legislative leaders closed the Capitol, returning to their districts. Leaders are supposed to face fear head-on and continue to represent the people they were elected to protect.

At this time of year, parents are preparing their children to return to the classroom. Instead, counties that are on the state watchlist are required to distance-learn for now, and local school districts not on the watchlist are grappling with fears and liability that can be solved by legislative action and bold leadership. Both in short supply right now.

Californians are suffering under the confusing and ever-changing messages from the top-down rather than being guided by their local circumstances. It's time we look at individual areas of the state and implement sensible, safe policies that make sense based on the situation as they see fit by the local county health officers. ★

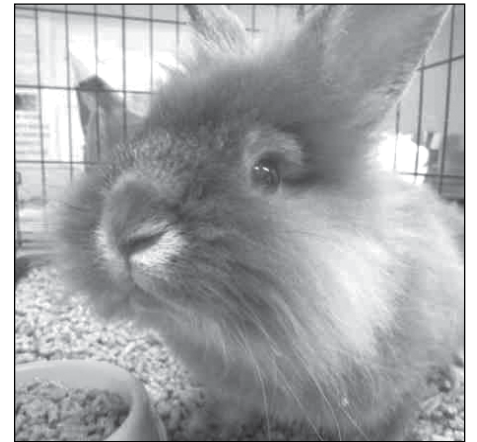

# Enough Subsidies for Electric Vehicles

Americans are naturally wary of electric vehicles (EVs). Salespeople may pitch battery-powered cars as the future, but most drivers see them as an expensive, chancy alternative to petroleum-fueled automobiles. This has been true for more than a century.

Electric cars once stood on their own. "In the late 1890s, at the dawn of the automobile era, steam, gasoline, and electric cars all competed to become the dominant automotive technology," wrote David Kirsch in *The Electric Vehicle and the Burden of History*. "By the early 1900s, the battle was over, and internal combustion was poised to become the prime mover of the twentieth century."

In 1896, in fact, when a young Henry Ford asked Thomas Edison about electricity for his horseless carriage, Edison banged the table with a "no," citing reduced driving range from a heavy battery and inconvenient recharging.

Today, government policies have put EVs back into the market – for the elite. There are federal write-offs of \$7,500 per vehicle and 30 percent for EV refueling stations. Car dealers use EV credits to average down regular SUVs to meet Corporate Average Fuel Economy (CAFE) standards too.

Still, range is poor and recharging time-consuming for EVs, not to mention searching for scarce refueling stations. And far from emission-free, EVs are "elsewhere emission" vehicles since nearly two-thirds of U.S. electricity is generated from natural gas and coal.

Throwing good money after bad, states are handing out subsidies to EV buyers. New Jersey recently instituted rebates of up to \$5,000 per car. California offers up to \$7,000 in electric vehicle rebates, while Oregon provides \$2,500.

Will this change true ways of driving? New Jersey officials believe their plan will

increase electric vehicles to 330,000 in just five years. By 2040, lawmakers hope that electric motors will power 85 percent of light vehicles sold or leased in the Garden State.

That's fantasy. Electric vehicles only accounted for 2 percent of new vehicle sales nationwide in 2019 even with a host of tax bribes. In fact, EV sales have stagnated; California, which provides the strongest incentives for purchasing electric vehicles, saw sales decline in 2019.

It should be no mystery. While gas-powered cars can travel up to 500 miles on a single tank, electric vehicles get a mere 100 to 300 miles per battery charge. Winter heating and summer cooling drain batteries, leading to "range anxiety" wherein drivers fear the engine might die before reaching its destination.

Future battery costs are unsettling to buyers. The Nissan Leaf, for example, requires a new battery every 10 years at a cost of as much as \$8,500. This is one reason why the average new EV loses more than half of its value in just three years, with some losing almost 70 percent. By comparison, the average three-year depreciation for all vehicles is just 38 percent.

Inexpensive gasoline and diesel have made traditional cars even more desirable. Advances in drilling and other technologies were behind gasoline's drop to below \$3 a gallon. Today, regular unleaded averages below \$2 per gallon nationally.

Post-pandemic, when oil demand returns to normal levels, gasoline will remain far below \$4 a gallon price in the summer of 2008, thanks to the shale-oil revolution. Car emissions, too, have significantly declined since the 1970s.

Environmentally conscious regulators and prudent lawmakers can let Americans buy regular cars. Taxpayers will be thankful too.

# New Recipe for Salmon

Before getting to the results, it's probably best to understand what reasonably expected salmon survival rates are from year-to-year. In extremely high-water years, it is possible to get to as high as 15 to 20 percent survival. However, those years are quite rare. In drought years, similar to the 2019/20 season, expected survival is typically around zero to 3 percent and is often close to zero.

The outmigration survival rate of our 2020 rice field-reared salmon was nearly 4.5 percent. This was nearly 4.5 times higher than our control groups and substantially higher than other similar tagging study during this period. We could not be happier with these results and they will now serve as the basis for further work by CRC and its fish conservation partners to continue efforts to develop a larger-scale strategy to use our fields to help salmon just as we have used them to help birds for decades now.

We want to thank UC Davis and CalTrout for their extraordinary work in the field over these past two years. And, of course, this project could not be possible without the help of our funding partners and par-

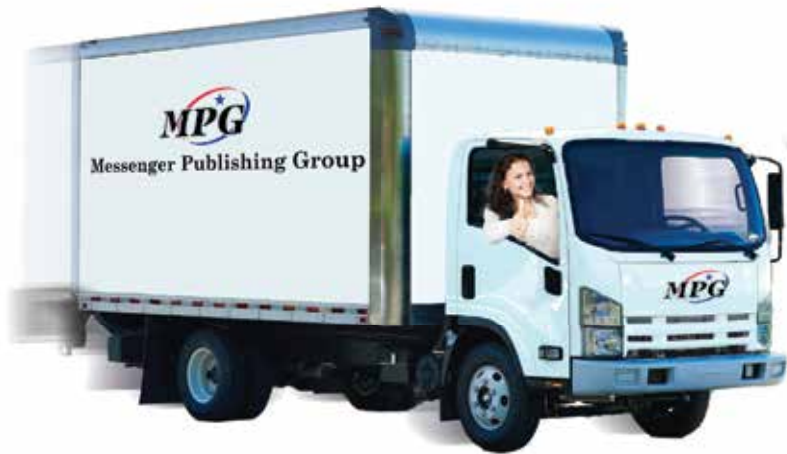
