**MARYSVILLE, CA (MPG)** - Yuba Sutter Arts & Culture has been very active the past few years creating an outdoor gallery of public artwork including utility box mini murals and full-scale exterior and interior wall murals. These works of art have been funded by a series of local collaborations with the Cities of Live Oak, Yuba City and Marysville with matching grant funds provided by YSAC. Occasionally, schools, individuals, service clubs and private businesses commission public art. The most recently completed exterior wall mural is in Marysville.

Titled “History of the Japanese Americans,” the mural was conceived and created by local muralist, Madelyne Templeton. The mural is 17’x125’ and is on the north facing wall of the industrial building at 103 B Street. The wall faces the parking lot of the Marysville Buddhist Church. The mural was funded by a grant received by YSAC from the California State Library through its Civil Liberties and Education Program. The funding is specifically for projects and programs to help document the Japanese American experience during World War II. The YSAC procured grant has paid for the mural and will be used to create

a memorial site in Arboga at the location of an assembly center used to incarcerate 2,500 Japanese Americans in the early days of WWII. This grant was secured in partnership with the Japanese American Citizens League of Marysville, and it will also be used to create a JACL website and to digitize many historic documents. “When I have attended the Obon Festival at the Buddhist Church in past years, I thought that the wall would be a great canvas for a large mural with a Japanese theme as a backdrop for the drummers and dancers,” said David Read, Yuba Sutter Arts & Culture Executive Director. “Watch what you wish for I guess, so

## Superintendent Responds to Academic Decathlon Cancellation

*Publisher’s note: We received dozens of emails here at the Territorial Dispatch from those concerned about the cancellation of the Academic Decathlon. We had planned to run their letter. Just before deadline we received the following from the Superintendent addressing their concerns.*

Dear AcaDeca Students, Alumni, Parents, and Colleagues,

In the last few hours, I have received numerous letters from students and MJUSD alumni outlining their concerns regarding the cancellation of the yearly Academic Decathlon (AcaDeca) for the coming school year. First and foremost, I want to extend my admiration and respect to all for getting in touch with me directly. Clearly, AcaDeca participants give all of us hope and optimism given these challenging times.

Secondly, I do want to address a number of statements that were raised in the letters that do not accurately

reflect how and why the decision was made to postpone the event to the following year. Given the growing concerns surrounding the COVID19 pandemic, the state made the decision in June to have the event online this year. Conducting an online AcaDeca competition clearly raises unique challenges.

As Yuba County Superintendent, I collaborated and consulted closely with all our District Superintendents in a June meeting (not Zoom) to assess our next steps. At that gathering, there was a general consensus to postpone AcaDeca for this year, especially given the declining student participation in the yearly event. Clearly, this was not a unilateral decision on the part of YCOE.

Moreover, and subsequent to the meeting, YCOE’s AcaDeca Coordinator, personally communicated with Marysville High School’s Academic Decathlon coach, to share the challenges and rationale surrounding the decision. The general

feedback, especially from MHS’s AcaDeca Coach, was that it would be difficult to field an AcaDeca team given the online nature of the event. More to the point, This was not a baseless prediction, but an informed one.

In closing, I want to underscore that AcaDeca has NOT been terminated, just postponed to re-evaluate for the spring of 2021 with the hope of keeping students safe and increasing participation. Rest assured that the Yuba County Office of Education is a strong supporter of our Academic Decathlon. Indeed, YCOE resurrected this beautiful event after years of neglect. We strongly support and continue to pledge our commitment to our students. 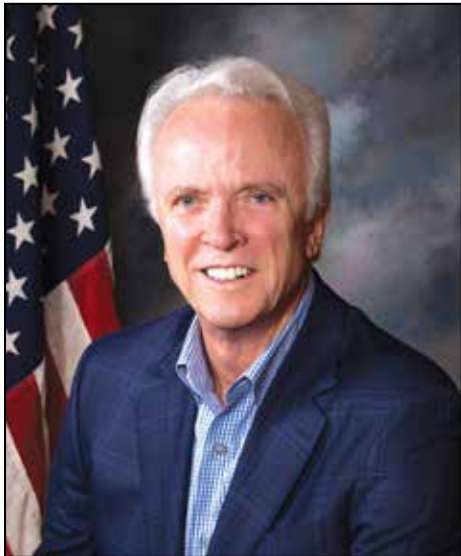

## Scammers Exploit California's COVID-19 Contact Tracing Program

**MATHER, CA (MPG)** - During the COVID-19 pandemic fraudsters are using this opportunity to create fear amongst residents across California.

Many traditional financial crimes and schemes are now orchestrated through electronics. Now, more than ever people of all ages, including the elderly can be victimized by these criminals.

The newest plot line in these online crimes, include California contact tracers.

**What Is A Contact Tracer?**

To mitigate the spread of COVID-19, Governor Gavin Newsom launched “California Connected,” the state’s comprehensive contact tracing program and public awareness campaign. A contact tracer from the local health department might call if you've been exposed to COVID-19. Under this program, public health representatives will telephonically interact with those who have tested positive, alert anyone that may have been exposed, and keep personally identifiable information (PII) confidential.

**How To Spot A Scammer?**

Real contact tracers won’t ask you for money - Only scammers insist on payment by gift card, money transfer, or cryptocurrency; Contact tracing doesn’t require your bank account or credit card number - Never Share account information with anybody who contacts you asking for it- Legitimate contact tracers will never ask for your Social Security number. Never give any part of your Social Security number to anyone who contacts you; Your immigration status doesn’t matter for contact tracing, so real tracers won't ask - If they do, you can bet it's a scam; Do not click on a link in a text or email - Doing so can download malware onto your device.

Be wary of suspicious emails, phone calls, and text messages. Contact your local health department to verify that the call or messages are valid, think before clicking on any links, and be aware of suspicious attachments.

The artist, Madelyne Templeton, is known for her magnificent murals often featuring portraits of Asian women and large-scale floral motifs. She has created several murals in Roseville and Sacramento, and she is responsible for many of the popular utility box murals in Yuba City and Marysville.

"I have worked with Yuba Sutter Arts & Culture for several years and really appreciate their support and belief in me and my work," said Madelyne. "My first commission with them was the "Poppies, Bike and Buttes" utility box mural in Marysville at 10th & Ramirez," she added.

Madelyne's other utility box murals include the Bees on Garden Highway, the Jack Rabbits near Sam's Club, the Maidu Woman on Butte House Road, Honkers at Yuba City High School and the Cactus array

at Gray and Queens. She has also done interior murals inside the offices of the Sutter County Children and Families Commission and Pepsi. She just completed another mural at Encinal Elementary School in Live Oak and soon will start one at Luther Elementary School, also in Live Oak.

# Family SOUP Executive Director Announces Pending Retirement

Founding member of the 1992 non-profit organization, the Sutter County Parent network, Chandler has been instrumental in expanding the Parent Network into Family SOUP's reach to three counties, Sutter, Yuba, and Colusa, serving children ages birth to 22 with disabilities. The Family Soup organization assists families with system navigation, resource referral, emotional support, parenting classes and activities designed to serve the entire family. Family SOUP is also home to Able Riders, the only therapeutic horseback riding program in the area. Chandler is often asked why the name Family SOUP? The explanation, "We are about families of children with special needs and collaborating with our partners to best serve these families. A soup is made up of many ingredients and now you're a part of our warm and inviting SOUP. And maybe the soup stands for "Serving Our Unique People". Chandler often says to parents, "don't take this journey alone because together we can make a difference." Chandler's involvement with Family SOUP started with her own experience as a parent of a toddler with no language, a limited diet and sensory disorder. "Fear was my driving force and finding a supportive team of parents and professionals was a lifeline and a game changer. I wanted that formula for all parents with concerns about

their child's development."

Over the years services and opportunities for children with disabilities have grown along with the empowerment of parents to serve as their child's best advocate. Chandler sees a future with increased inclusion of individuals with different abilities in the community including increased employment and independent living opportunities.

Working with moms and dads, grandparents, adoptive and foster parents all wanting to help their child with special needs has been rewarding and inspiring. Families with children facing medical, developmental or mental health challenges appreciate the help they find at Family SOUP.

Chandler is confident that the dedicated Family SOUP board will find the right person to lead the organization. "This is a community that cares about the diverse nature of our families and believes in the potential of all children. Chandler feels confident that Family SOUP staff will be here to support them." The Family Soup board and staff believe that Chandler, as Board President Kimberly Butchers says, leaves "big shoes to fill"! The search for her successor will not be an easy feat, but we are charged with finding someone who goes the extra mile, as Cindy Chandler has, to navigate special education policies that not only protect, but strengthen the development of children with disabilities."

Currently Family SOUP staff is working remotely from home and is serving families. ★

## Marysville Resident Arrested for Human Sex Trafficking of a Victim

**MARYSVILLE, CA (MPG)** - The Butte County Sheriff's Office (BCSO) announced the arrest of Zydya Saunders of Marysville, 25, for human sex trafficking of a minor victim. On June 16, Butte County Sheriff's Office deputies were contacted by a victim who reported his firearm had been stolen. Deputies determined the victim's firearm was stolen by a female

working as a prostitute, who was later identified as Zydya Saunders.

On July 01, a BCSO detective acting in an undercover capacity began communicating via telephone with Saunders. Saunders told the undercover detective she was willing to have sex for \$230. Saunders then asked the undercover detective if he/she wanted "two girls" for \$500. The undercover detective agreed and made arrangements to meet Saunders at a local motel on July 02.

On July 02, Saunders contacted the undercover detective via telephone and stated she and another female were walking through the motel parking lot. Undercover detectives contacted Saunders and a minor victim. Saunders was placed under arrest and the minor victim was transported to the Butte County

Sheriff's Office so she could receive services from Butte County Children Services.

During an interview Saunders admitted she brought the minor victim to the motel so the minor victim could perform sexual acts for money. Saunders also admitted she brought the minor victim to at least three other prostitution meetings where Saunders and the minor victim performed sexual acts on adult men in exchange for money.

Saunders was arrested for four felony counts of pimping a minor victim, one felony count of human trafficking a minor victim, and one felony count of child endangerment. Saunders' bail was set at \$300,000. This investigation is ongoing. The Sheriff's Office is asking anyone with additional information to contact Detective Mary Barker at (530) 538-7671. ★

## Three Oroville Residents Arrested for Ongoing Sexual Abuse of Children

### Butte County Sheriff's Office

**OROVILLE, CA (MPG)** - In July of 2020, Butte County Sheriff's Office (BCSO) detectives received information Joshua Chadwick of Oroville, 39, was possibly acting inappropriately around several children. BCSO detectives conducted an investigation and determined Chadwick is on federal probation and is required to register as a sex offender pursuant to the Sex Offender Registration Act. On July 08, BCSO detectives and federal probation officers conducted a search of Chadwick's residence in Oroville pursuant to the terms and conditions of his federal probation. During the search detectives located an electronic device containing multiple images of child pornography. Detectives placed Chadwick under arrest.

During the investigation detectives determined Chadwick had recent contact with three children, who were all under the age of 10. Detectives located evidence Chadwick had been sexually abusing the children over an extended period of time. Detectives also located evidence an associate of Chadwick's, who was identified as David Acuff of Oroville, 38, was also sexually abusing the aforementioned three children.

Detectives contacted the Oroville Police Department (OPD) and determined OPD detectives had an open investigation regarding allegations Acuff had sexually abused the three children. Based on additional information obtained on July 08, OPD detectives authored a search warrant for Acuff's residence, which is located on Greenville Street, Oroville.

On the evening of July 08, BCSO and OPD detectives as well as members of the OPD Problem Oriented Policing (POP) Team served the search warrant at Acuff's residence. During the service of the search warrant detectives located additional

evidence. Acuff was not home at the time of the search warrant. Detectives immediately authored a warrant for Acuff's arrest. On July 09, Acuff was located and placed under arrest. Based on the additional evidence located, detectives determined Acuff had been sexually abusing the children over an extended period of time.

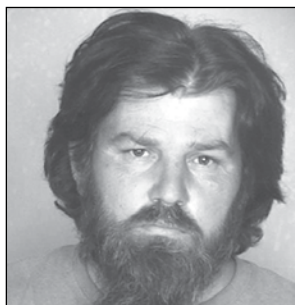
Chadwick was placed under arrest for eight felony counts of lewd and lascivious acts with children, and for violating the terms and conditions of his federal probation. After reviewing the facts surrounding the federal probation violation, a federal judge determined Chadwick was not eligible for bail until future court proceedings take place. Acuff was placed under arrest for two felony counts of oral copulation or sexual penetration of a child, one felony count of possession of a firearm by a prohibited person, and one felony count of possession of ammunition by a prohibited person. After reviewing an arrest warrant for Acuff, a Butte County Superior Court Judge determined Acuff was not eligible for bail until future court proceedings take place. Chadwick and Acuff are scheduled to be arraigned at the Butte County Superior Court on Monday, July 13, at 3 PM.

July 13, detectives placed Carver under arrest and booked her at the Butte County Jail. Carver was arrested for three felony counts of making a child available for the purpose of allowing lewd and lascivious acts to be committed on the child, three felony counts of child endangerment, one felony count of lewd and lascivious acts with a child, and two felony counts of continuous sexual abuse of a child. Carver's bail was set at \$825,000. Carver is scheduled to be arraigned at the Butte County Superior Court on Wednesday, July 15, at 3 pm.

### UPDATE – July 14, 2020

During the investigation, detectives identified the three juvenile victims' mother as Summer Carver of Oroville, 33. Detectives located evidence showing Carver was present on multiple occasions when Acuff molested the victims. Detectives also located evidence Carver was present on one occasion when Chadwick molested one of the victims. Detectives determined Carver had a total of five children. Based on the aforementioned information, all five children were detained by Butte County Children's Services Division.

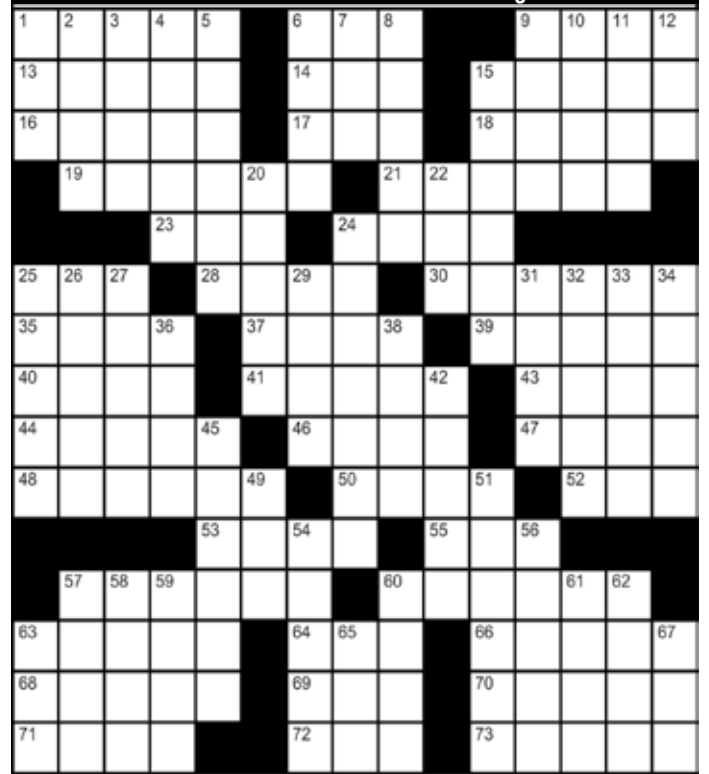

### Gerrymandered Map by Foothills Water District

On June 30, the North Yuba Water District filed its 2020 division map with the Yuba County Elections Department for the upcoming November elections. It was not the gerrymandered map that the district had hastily submitted and desperately wanted, one that would have grouped the irrigation customers into one division, disenfranchising the irrigation customers from their historical two Board members to one Board member.

This was entirely due to General Manager Jeff Maupin's bungling of the LAFCO 400 odd parcel detachment process. Three years ago, Yuba LAFCO notified the NYWD there were 403 parcels that were in the Browns Valley Irrigation District (BVID) area and politely requested the water district formally remove these parcels.

Why did the water district wait three years before undertaking detaching these parcels?

Is it because the water district is getting a portion of property tax money from these owners? Indeed, that seems to be the case.

The NYWD director's actions seemed to be based on the contemptible notion that as long as these parcel owners were not aware of the overlap, they would just keep on taking the money. However, to get their gerrymandered map accepted by the elections department, the district directors, Hansard, Neilson, and Hawthorne, had to clean up the parcel overlap with BVID.

LAFCO has yet to approve this detachment and the owners are still paying taxes to the water district for services they will never receive.

It would be appropriate for the North Yuba Water District to give this ill-begotten money back, with interest, along with an apology.

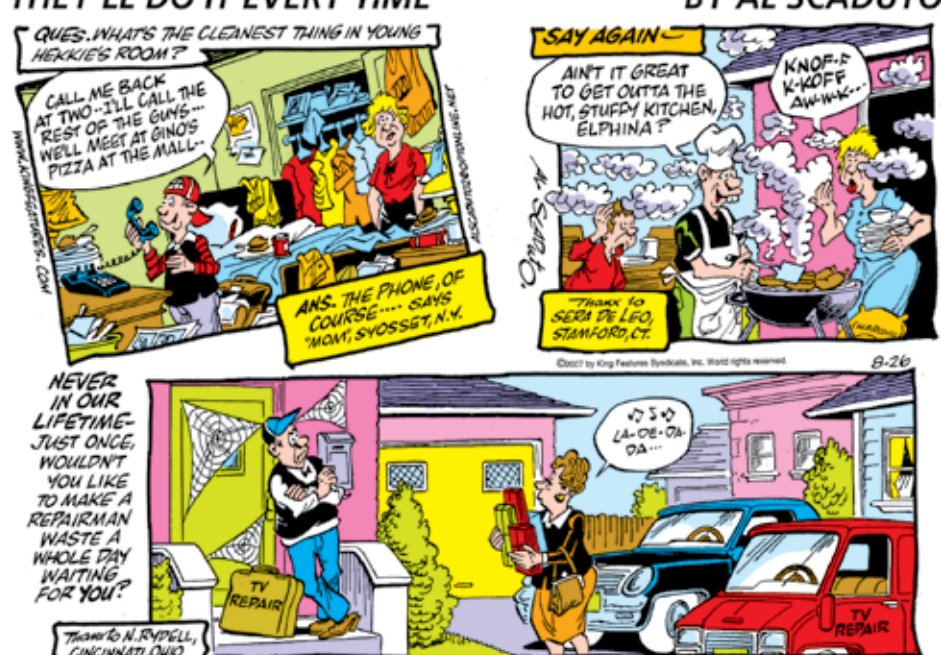

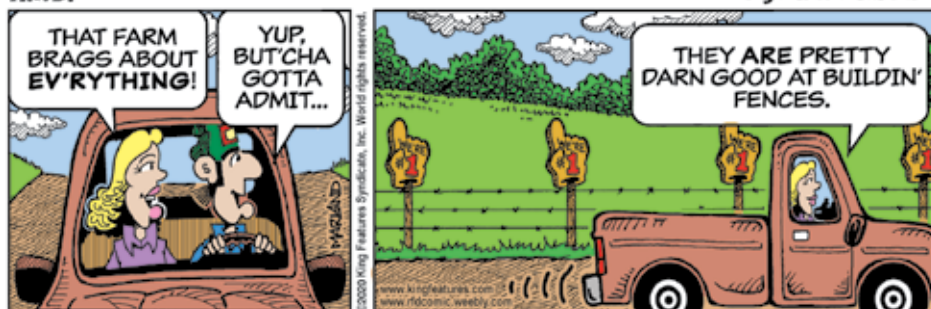

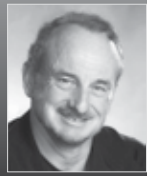

## Economies of Travel - Traveling During the Covid Shutdowns

In last week's expose' of my "Economies of Travel- Traveling during the CoVid shutdowns", I detailed my trip by airplane to Newport Beach and what it was like to travel during the pandemic. My next trip took us by car to a hotel casino resort in neighboring Reno.

We left the Thursday of the Fourth of July weekend, July 2nd.

Although I expected traffic, highway 80 was as busy as I have ever seen it for a get-away holiday.

The typical tailgating at 60 mph jammed both lanes all the way to Truckee.

Half expecting many to be heading to the gambling mecca of Reno like I was, I was pleasantly relieved to see most of the traffic exit highway 267 towards Lake Tahoe. An estimated 250,000 besieged the Tahoe area that week so I hear.

Although Reno streets looked like an average day of traffic, the hotel parking lots was packed. I had been told the hotel

was at 80% occupancy during my reservation phone call. The 80% figure is a familiar one as most casinos will always say they are 80% full to appear they are in demand so the reservation phone call didn't cause me undue panic. Arriving in the parking lot however the level of concern in the car definitely increased.

Entering the casino, a heat camera had been placed over the escalator with a sign said "bodytemperatures scanned."

Ok then, but since the camera was on the ceiling and I saw no attendant anywhere, I wasn't sure if an alarm would go off or what. Apparently our temperatures were ok but at that moment I realized if a high temperature was detected, and no attendant was present, I would be well into the casino before anyone could react.

Humm.....

The lines to check-in were long and those familiar social distancing dots were on the floor. The receptionist was masked and

behind Plexiglas. Most patrons we saw wore masks.

Signs were up saying masks required and elevators were limited to 4 people with distances X's on the elevator floors.

Once checked in, we strolled the casino. This casino had installed Plexiglas panels between each machine but another casino we visited did not.

Honestly I saw a lot less hand sanitizers than I expected and throughout the 3 day visit, I saw few if any employees wiping down the machines. I couldn't help but think all the "we're clean" hype was beginning to bring the word "malarkey" to mind. One bar did remind me when my mask ended up around my neck but the rest of the casino locations didn't really say anything to those that had their masks pulled down.

The hotel had reduced patronage numbers in the pool so unless you got there at 10:00 am, you were wait listed. Both days I got my call three to four hours later. Obviously hanging out at the pool was going to be a nonevent for a family that has kids that sleep in until noon.

The restaurants had reduced seating so a reservation was impossible. We ended up going off site and eating early to get a seat.

The movie theaters only had one showing with familiar but old reruns. A common theme to those of us familiar with movie-going during CoVid.

The buffets were also gone but I'm not a buffet guy anyway so no harm no foul there, at least for me.

We were charged the typical "resort fee" (don't get me started) but were informed there would be no maid service after the first day. We could order fresh towels and such but there would be no room attention. So much for the amenities paid by the "fee."

All in all, the whole thing felt a little desperate. Desperate like those that were there were so determined to "get away", they would settle for this type of "half access" to just about all the reasons for being there.

After two days we were ready to leave and determined not to come back. And like I said in the conclusion of last week's article:

"..... despite great prices everywhere, the amenities and reasons for going are so hampered and dampened down it might be better to set up a tent somewhere and chill by a campfire or just stay home."

Like I said last week, traveling right now is really not worth it.



# Brightest and Most Virtuous Wanted

The Founding Fathers were far smarter than ‘leaders’ today. That is clear from a casual reading of their writings and their fabulous success culturally and economically in launching the nation.

They held one another to a high moral standard and devoted their lives (including wealth) to seeing the Constitution implemented and America become a world leader. They were students of world government systems and of the philosophies leading to those governments (monarchs, republics, socialist utopias).

They had strong convictions, were rugged men, and they could explain what they believed and the philosophical streams from which their values were formed. They received a Bible-based rigorous education primarily at home from parents and others arriving from Europe. The depth of learning and level of literacy in America was much higher then than today.

The Founders saw government service as a calling and a ‘divine science.’ It was a life’s work that they planned for. They intellectually prepared to one day serve their fellow man and country. They were convinced that unless an educated and informed population elected the brightest and most virtuous representatives the nation was doomed.

They understood Exodus 18:21—“But select capable men from all the people--men who fear God, trustworthy men who hate dishonest gain--and appoint them as officials over thousands, hundreds, fifties and tens.” This was Moses’ father-in-law Jethro’s counsel as to how Moses should govern millions of Israelites that recently won their independence from Pharaoh.

Another favorite scripture of the Framers was Proverbs 29:2 – “When the godly are in authority, the people rejoice. But when the wicked are in power, they groan.”

The Founders had a Biblical perspective on human nature, that it was a mixture of good and evil. If people were to govern themselves and have the best possible government, then a political process should be developed where the wisest, most experienced and most virtuous could be found and elected to public office.

As James Madison wrote, “If men were angels, no government would be necessary. If angels were to govern men, neither external nor internal controls on government would be necessary.”

The Founders hoped to develop a spirit of public virtue by having leaders of private virtue. They wanted a “freemen aristocracy” or “natural aristocracy” which would be open to all but inheritable by none. Every leader would have to rise to his high office by personal merit, not by the wealth and reputation of his ancestors.

Thomas Jefferson and others had disdain for an “artificial or European aristocracy (ruling class).” These rulers obtained office because of wealth, their station in life and special influence brought to bear in their behalf.

Jefferson felt it the goal of the nation to use education and all other means to stimulate and encourage those citizens with a special talent for public service. The greatest national threat would be when the best refused the tedious, arduous and sometimes unpleasant task of serving. Sadly our current schools undermine our heritage and today teach students to hate America.

Samuel Adams and younger cousin John Adams sacrificed their fortunes to serve in politics. James Madison borrowed money at attend meetings to draft a Constitution. George Washington was called from retirement 3 times to again serve his country. Never did he take payment to lead the nation’s military in time of war or serve as President.

Benjamin Franklin and leaders of the day at the Constitutional Convention in 1787 felt it was an honor to serve and do so often at their own expense. The Founders worried that ambition, the love of power, and that avarice, the love of money would be too powerful unless politicians remained unpaid or minimally so.

Franklin warned that the high salaries for government offices are the best way to attract scoundrels and drive from the halls of public office those men who possess true merit and virtue.

The country today is the opposite of what the Founders hoped and planned for.

# Yuba Water Agency Approves \$14M for Water Supply and Infrastructure

**MARYSVILLE, CA (MPG)** - Yuba Water Agency’s Board of Directors today committed approximately \$14 million in grants and loans for water infrastructure upgrades, levee maintenance and Yuba County’s annual California Public Employees’ Retirement System payment.

## Wheatland Wastewater Treatment System - \$2.6 Million

Building upon other recent water infrastructure investments in southeastern Yuba County, Yuba Water approved a \$1.3 million grant and matching low-interest loan for the City of Wheatland to begin design engineering of improvements to its wastewater treatment system and connection to neighboring Olivehurst Public Utility District’s existing wastewater plant. The upgrades will protect groundwater quality, improve water supply reliability and expand economic development opportunities for communities along the Highway 65 corridor.

“The combination of Yuba Water helping fund OPUD and Wheatland really opens up economic opportunity in the southern part of the county where wastewater capacity has been a significant barrier to development,” said Yuba Water Vice-Chairman Brent Hastey. “This is something our community has been working toward for decades.”

“This funding will help us get the project shovel-ready,” said Wheatland City Manager Jim Goodwin. “That’s going to be incredibly important to help us qualify for state and federal grants as recovery efforts get underway.”

Yuba Water is able to provide funding for projects that ensure groundwater quality as part of its broader authority under the Sustainable Groundwater Management Act. As part of the Yuba Integrated Regional Water Management Plan – a collaborative effort to manage all aspects of water resources in a region – the project also has the potential to qualify for additional state grant funding.

## North Yuba Water District Oreleve Ditch Piping Project - \$480,000

Helping improve water supply for a disadvantaged community that has historically experienced issues with drinking water reliability, Yuba Water also approved a \$480,000 grant to help the North Yuba Water District pipe the Oreleve Ditch, which is a mile-long section of the larger Forbestown Ditch.

The Forbestown Ditch is currently unpiped and is prone to breaches. Additionally, up to

60 percent of the water is lost due to seepage and evaporation, and contamination from dirt, trash and other materials is common.

This funding will help improve water supply reliability for the approximately 3,100 customers served by the district.

## Marysville Fire Department Vegetation Management Program - \$17,500

To help with the maintenance and inspections of local levees and to reduce the risk of a large fire, Yuba Water approved a \$17,500 grant for the Marysville Fire Department for its vegetation management program.

This funding will allow the department to continue its program and hire three additional seasonal positions to specifically help manage vegetation along area levees. This will help protect the levees from wildfire and preserve the quality of water in the local river systems.

The vegetation management will take place on the levees along the Yuba and Feather rivers and Jack Slough.

## Yuba County Annual Calpers Payment - \$10,881,032

Yuba County will save approximately \$325,000 over the next year with the help of a low-interest loan from Yuba Water.

The \$10.88 million loan will allow the county to make its annual payment to CalPERS in one lump sum, rather than financing it through CalPERS at a much higher 6.5 percent interest rate.

This marks the third year that Yuba Water has provided this loan to the county, and the county has made all monthly payments in a timely manner.

Public jurisdictions that have an unfunded CalPERS retirement liability are required to make annual payments to cover a percentage of that unfunded liability, in addition to the jurisdiction’s regular ongoing CalPERS costs. ★

# BCSO Announces Arrest of Oroville Resident for Sexual Abuse of a Child

**BUTTE COUNTY, CA (MPG)** - The Butte County Sheriff’s Office (BCSO) announced the arrest of John Zulkoski of Oroville, 31 for sexual abuse of a child. On June 22, Butte County Sheriff’s Office deputies were contacted by a parent who reported Zulkoski had sexually abused a minor victim. Deputies responded to a residence in Oroville and contacted two minor victims and their parent. Both minor victims were under the age of 10. The parent of the minor victims explained Zulkoski was a family friend who the parent had allowed to stay at her residence.

On the evening of June 22, one of the minor victims disclosed he/she had been sexually abused by Zulkoski. The parent confronted Zulkoski and contacted the Sheriff’s Office. After being confronted about the

sexual abuse, Zulkoski fled from the residence on foot prior to the Sheriff’s Office arriving at the residence.

Detectives transported the minor victim to a Sacramento area hospital for medical treatment. Detectives conducted follow-up and located additional evidence related to the sexual abuse. On June 26, detectives interviewed Zulkoski. During the interview Zulkoski admitted to sexually abusing one of the minor victims.

Detectives placed Zulkoski under arrest for oral copulation or sexual penetration with a child 10-years-old or younger, oral copulation on a person under 14, and committing a lewd act upon a child. Zulkoski’s bail was set at \$1,200,000. This investigation is ongoing. The Sheriff’s Office is asking anyone with additional information to contact Detective Mary Barker at 530-538-7671. ★

# Economic Recovery Requires Balanced Leadership

As many businesses hung on for their existence during the COVID-19 lockdown, they also stepped up to protect jobs, cover health premiums, and expand paid sick leave benefits for workers. They applied for government loans to meet payroll and re-imagined how they could maintain business operations with social distancing, curbside service, and virtual commerce.

Most employers exercised prudence and patience as state and local officials charted a path through an unprecedented pandemic. Businesses large and small prioritized their employees because workers power California’s economy. Many stepped up and stayed on the job to meet the essential needs of Californians. And workers will help drive our economic recovery in the months ahead.

As California moves forward into a staged reopening that balances health and safety with the broader resumption of commerce, employers urgently need ongoing support, balance and flexibility from state government leaders.

A potential pain point for employers is burdening our workers’ compensation system with COVID-19 claims that originate outside of the workplace. In early May, Governor Newsom enacted a temporary measure that COVID-19 claims among workers from the March stay-at-home order through July 5 are “presumed” to be work related. This presumption means that workers who test positive for the virus do not need to show a connection to work, which is the usual legal standard for workers’ compensation claims.

The rationale for such a move is to streamline the ability for workers who fall ill on the jobs to get benefits. The risk is that presumptions sweep up far more than work-related illnesses. As a result, the employer-funded workers’ compensation system will be tasked with serving as broad, societal response to the pandemic. The question is whether such measures are necessary when employers already report accepting claims.

As employers now struggle to resume operations, restore jobs and public services as quickly as possible, they must now factor in the potential for new workers’ compensation costs that could originate from anywhere, anytime outside of their workplace.

Multiple legislative proposals have been submitted that would broaden, extend or expand these workers’ compensation presumptions. Given the tendency of the workers’ compensation system to enter crisis mode, lawmakers should carefully consider how to take thoughtful, balanced action in this area. They would be right to question whether any additional action in this area is needed – and seek out data to justify further modifications.

Employers have proven through the pandemic they value the health, safety and well-being of their workers. They have gone to extraordinary lengths to take care of their workers, so these workers could be there for the rest of us during the statewide lockdown and in the economic reopening that lies ahead.

During this reopening, lawmakers have an opportunity to partner with employers to deliver a brighter future for us all. Burdensome new costs that inhibit the restoration of jobs will only delay and diminish our opportunity for recovery.
