New Amended Order Aligns with State **Guidance**

YUBA-SUTTER COUNTIES, CA (MPG) - Starting Friday, June 12, more businesses are permitted to re-open with appropriate precautions under new guidance from the California Department of Public Health. Yuba-Sutter Health Officer Dr. Phuong Luu issued an amended Public Health Order to align with the State, and so residents can see, in one place, all the businesses that are permitted to operate at this point.

"With proper COVID-19 protocols in place to ensure the safety of patrons and staff, I am confident we can safely reopen more sectors within the community," Dr. Luu said. "That said, without a vaccine, COVID-19 is still here and an ongoing threat. We all must follow the proper tenets of social distancing, wearing facial coverings, practicing good hand hygiene, and staying home when sick, in order to minimize spread of the virus- especially to those who are most vulnerable to more severe symptoms."

The sectors permitted to reopen last Friday include bars/wineries, family entertainment centers like bowling alleys and arcades, gyms/fitness centers, hotels, and zoos/ indoor museums. The State of California has not vet permitted the reopening of nail salons, tattoo shops, live performance theaters, theme parks and festivals. In-person K-12 schooling in Yuba-Sutter is permitted to begin at the start of the new school year, in mid-August.

New cases are increasing but fall within two distinct themes: among family/household clusters, and within previous "essential" workplaces that have remained open throughout the pandemic. Hospitalizations also fall within two prominent categories: people who delayed testing, and those who already tested positive but delayed seeking care because of their uninsured

Residents should know that insurance should not be a barrier to seeking care for COVID-19, especially if symptoms worsen. Businesses that reopen, especially those that have remained open throughout the past three months, should adhere to the protocols in place including temperature checks and symptoms screening of employees, maintaining social distancing and adhering to facial

SACRAMENTO REGION, CA (MPG) - This

is the first in a two-part series covering how the Sacramento Valley will celebrate Independence Day with traditional fireworks in an untraditional year. Watch for our annual fireworks buyers guide in the next issue.

Between California's months-long shelter-in-place order and other "don'ts" issued by governments of all levels during the coronavirus pandemic, citizens might feel that they're living in the home of the brave, but not so much the land of the free.

That sentiment could make this coming Independence Day the most important one since the first.

"I don't disagree with that," said John Kelly, vice president of TNT Fireworks, the most recognizable symbol of the

"There have been widespread cancellations of Independence Day parades, concerts and fireworks displays nationwide," said APA Executive Director Julie Heckman. "Due to social distancing mandates related to COVID-19, the skies will be dark above the vast majority of cities, towns and municipalities."

Continued from page 1 of a fireworks-sparked pro rodeo held every Fourth of July weekend. Further south,

Elk Grove has approved an aerial show for July 4. Instead of setting off fireworks over Elk Grove Regional Park and the 22,000 or so gathered there, the staging area will be at an undisclosed location so that residents can watch from their homes.

Yuba City, Folsom and

Elk Grove are lighting up, but from Rancho Cordova and Sacramento to South Lake Tahoe and Davis, aerial displays have been grounded to the disappointment of pyro fans and the detriment of pyro

We are down 90 percent in sales and shows," said James Souza, CEO of industry bellwether Pyro Spectaculars, which does have the Elk Grove gig. "Everyone wants a show but is not going to commit due to the state's public gathering policy."

At press time, hope was being held out for the show to go on in a smattering of locations awaiting health data on the staged reopening approach. Even with favorable figures, putting on a professional firework display still might not be possible given the short fuse.

"All the more reason for the general public to stock up on consumer fireworks and plan a backyard or neighborhood celebration – of course, abiding by social distancing guidelines," said the APA's Heckman.

Many of the nearly 33 jurisdictions in Sacramento, Placer, Yolo and Yuba counties warm to consumer fireworks had left existing laws as-is at press time, while others may enact a one-year moratorium on sales that has no impact on use. Best to check with your local fire department before lighting. A list of "open" communities can be found at http://ca-fireworks.presskit247.com.

For most of the state including Sacramento County, June 28 starts a potentially big week for non-profits that could be more cash-

strapped than usual.

Whereas residents of other states can also

let the sparks fly on New Year's, if not yearround, celebrating the anniversary of our country's fervent declaration of independence from Great Britain in 1776 is the occasion for

which California consumers can legally light fireworks, and only the state-approved "safe and sane" variety.

Depending on ordinances in effect at the

nances in effect at the time, law-abiding revelers and sellers may need to wear masks and separate households by at least six feet during the show. Except for rules around personal protection equipment and distancing, buying fireworks may not be all that different from non-pandemic years.

"Key guidelines that will need to be met are already built in," said Kelly of TNT, which has its Northern California regional offices in Sacramento. "We're already selling out of stands where the volunteer salespeople and customers are separated by wood panels and chicken wire. Buyers don't touch product until purchase."

Phantom Fireworks, the state's secondlargest fireworks reseller, is confident that patriotism, community support, a hunger for outdoor family amusement and the most favorable day of the week for a Fourth of July will outweigh any inconveniences associated with compliance.

"A weekend Independence Day is always great for fundraising, but with the fourth falling on a Saturday, that's even better," said Linda Hass-Kreman, Phantom's West Coast operations manager based in Sacramento. "A Saturday July Fourth means many among the workforce have that Friday off as a corporate holiday and the next day off as well being a Sunday. I think society is so ready to have fun outside the home, enjoying something separately, but together, that we're going to have one of the most special and successful fireworks seasons ever."

It's not as if the country doesn't have experience dealing with pandemics at this time of year. Smallpox, measles and other diseases had wary colonists shutting themselves in their houses at the time future president John Adams correctly predicted that the first Independence Day would be celebrated with "bonfires and illuminations."

Two and a half centuries later, American history will repeat itself when patriotic citizens ooh and aah to star-spangled fireworks under pandemic conditions.

"Fireworks are the most widely anticipated tradition of celebrating our nation's independence," Heckman said. "Americans are ready to celebrate and looking for something to do after being cooped up for so long, and many of us still are in parts of the country."

ing Talk" for the local Dispatch Territorial newspaper for approximately 30 years until his death. During the 1980's Dan would phone in fishing reports on locations to the Saturday morning radio fishing program in Sacramento.

Pastor Chris Madsen officiated at a graveside service on June 9th at the Sutter Cemetery. Military Honors were held with the United States Navy Honor Guard.

Dan is survived by his life partner, Valerie Otten of Yuba City; sons, Dan Johnson, Jr. (Terese) of Yuba City, Ted Johnson, Sr. (Holly) of Yuba City; sisters. Faye Bates of Santa

Clara, Leotta Rueda of Marysville, and Beth Reimers of Yuba City; brothers, David Johnson, Don Johnson, Bruce Johnson and Rick Johnson all of Yuba City; 9 grandchildren, 22 great-grandchildren, and great-great-grandchildren.

He is preceded in death by his parents John Clem Johnson and Virginia Clark; sons, John Ora Johnson, and Michael Kevin Johnson, Sr.

Yuba Water Agency Commits Funding to Levee Improvements and Conservation Projects

MARYSVILLE, CA (MPG) -Yuba Water Agency's Board of Directors committed \$785,000 for levee improvements, water conservation and other Yuba County water projects in support of its core mission areas of flood risk reduction and sustainable water supply management.

which maintain levees along the Yuba, Feather and Bear rivers in Yuba County. A \$650,000 grant for RD 784 will fund the the fields rather than burn

replacement of a critical storm drain pipe along the Horseshoe levee area near Dry Creek. An \$80,000 grant for RD 2103 will cover the cost of evaluating the Grasshopper Slough Levee in southern Yuba County in an effort to secure Federal Emergency Management Agency accreditation. If accredited, the change will significantly reduce flood insurance premium costs for a specific area of homes in Wheatland currently considered to be in a special flood hazard zone.

Additionally, Yuba Water approved a \$50,000 grant to replace manual toilets, sinks and dispensers in Yuba County's facilities as part of its water conservation program.

The agency also renewed its commitment Yuba Water awarded of \$5,000 to District 10's two levee improvement Wild Duck Egg Salvage grants to Reclamation Program, which res-Districts 784 and 2103, cues wild duck eggs from flooded rice fields before they're destroyed by heavy farm equipment during harvest. Farmers flood

them because of the harm burning does to air quality. As an added benefit, the flooded areas create waterfowl habitat. During its 27 years of operation, the program has rescued more than 38,000 duck eggs and educated the public about waterfowl habitat in the region, including its significance as part of the Pacific Flyway.

The board also recognized General Manager Curt Aikens for 22 years of service to the agency. Aikens will step down as general manager next month and focus on special projects ahead of his January 2021 retirement.

"The agency would not be where it is today without Curt's leadership," said Randy Fletcher, the agency's board chairman. Fellow board members echoed Fletcher's praise of Aikens, commending him for his trailblazing natural resource management and his creation of a culture of partnership and innovation at the agency.





We have lived in the area surrounding Happy Park bordered by Lincoln, S. Walton, Bogue and Sanborn Roads in Southern Sutter County for 20 years. Annexed by Yuba City 18-19 years ago, we expected the same treatment as other city citizens. WRONG. After annexation, over 18 years ago, I contacted the Yuba City Police Department asking when we could expect Yuba City Police patrols and presence. I was informed patrols would begin 'soon'. I want to commend the Sutter County Sheriff's Department. You have done a great job with the available resources. The Sutter County population has doubled since 1970. An increase in Sutter County deputies, negligible. Instead of taking responsibility for policing the newly annexed area, Yuba City dumped us on the overworked and understaffed sheriff's department.

We have a lot of traffic concerns in this area, e.g. illegally parked motorhomes, trailers, vehicles with flat tires parked for months and months at a time on city streets and a crap load of people speeding and running stop signs. I would like to point-out, the sheriff's department's primary duties are not writing parking tickets and we don't expect them to do that, they



Wild Swings Up and Down

ones we have now but more and more analysts and trading professionals are fessing up this one is starting to top them all. The quickest fall from an all-time new high to not only an official correction (down 10%) but an all-out bear market designation (down 20%) occurred during the March downturn, only to be followed by an historic and blistering recovery which placed the Dow within a healthy spitting distance of that all time high two months later.

Wild swings up and down (but mostly up) have investors and professional money managers looking over their shoulders for the Archangel or the devil himself, depending on which way their portfolio swung that day.

June 11th witnessed an 1861 point hammering of the Dow Jones Industrial Average (DJIA), down 7% from the day before. The next day the DJIA ricocheted up 477 points. Whoa.

Professional traders love the volatility which can bring fast profits. Day traders have come out of the wood work, some shut in from the CoVid-19 event and some flush with cash from stimulus and unemployment checks. Indeed, trading volume is heavy and theories abound as to what comes next. Meanwhile those not akin to these casinos like markets and/or just trying to save for retirement may find the violent ups and downs not at all conducive to a full night's sleep.

What is confusing everyone including the heavy weight professionals like Warren Buffet, David Tepper and other gigantic hedge fund managers is the speed of the March fall and the subsequent lighting fast recovery. Few if any forecasted such wild and violent swings, and the speed of the recovery in light of the obvious ailing economy was and is still an unexpected turn of events.

Explanations and theories as to why markets are moving so violently include investors are eager to buy stocks at bargain prices, the Fed is throwing trillions into the economic feeding troughs of corporate America and that trillions more are going directly to consumers.

This analyst, and many of my peers, attribute much of the markets recovery to the Federal Reserves' willingness to go "all in" to avoid a catastrophic collapse due to the CoVid 19 shutdown. With trillions going to support debt assets like corporate bonds, trillions more to consumers and business owners and even more trillions in Quantitative Easing (Feds buying Treasury, mortgage and other public and private debt), the amount of money being injected everywhere means some of it is

> That's not to say the disconnect between the market and the economy makes total sense. Indeed, the argument could be made the Fed is doing what is always has done in recent decades: throw money at corporate America in the hopes that fewer corporations will be vaporized in bankruptcy, others will be able to access the debt markets in order to survive, and that some of that money will trickle down to workers.

> In contrast to the 2008/09 crisis, this time around more money is being shuttled into the hands of consumers and small businesses through liberalized unemployment programs and a variety of loan and CARE programs.

> This is not to say the all clear can be given. There are many realities that may dampen the exuberance that investors may have succumbed to in the recent market

> With last week's Dow 1800-point hammering, stock participants may be rethinking just how bad (or good) the economy may be coming out the other side of the shutdown. Indeed, we may find we emerge from the CoVid shutdown funk only to see a spike in new cases due to what some call premature

> reopening, mass protest gatherings due to the recent racial issues, or a lackadaisical attitude toward the virus itself.

> Other considerations would also have to include the damage done to the economy will be much worse than expected, will last longer than expected and some damage done will never be undone. The business landscape may be permanently altered which will require some sort of adaptation or rethinking of how business should be conducted. This shift in business methodology may incur significant transitional costs which will take time to unwind because of the resource and monetary reallocation that in itself could cause more economic damage.

Resist Germ Phobia

As more people are convinced of being 'punked' by government with the Corona Cold there will be acts of resistance. Many citizens are still reeling from being bombarded with junk Corona science, media double-speak and the complicity of local officials declaring the cold to be a plague. Former Yuba County Health Officer Nichole Quick resigned last week from her Orange County Health position as Sheriff Don Barnes refused to enforce the state's order and angry protesters arrived in front of her home. Some supervisors wanted face covering rules relaxed but Quick was acting more like an employee of the state than her County.

Orange County has had large demonstrations resisting Newsom's illegal closure rules. Newsom retaliated by opening all California beaches except Orange County's. If you doubted the legitimacy of quarantine and venue closures to save lives this political payback should get your attention.

The First Amendment right of assembly to redress grievances with government has been suspended unless the gatherings agree with Newsom. The First Amendment was written to address outof-control government. The requirement to obtain a permit to peaceably assemble is unconstitutional.

Yuba-Sutter officials that profess ignorance or political impotence to justify not confronting tyranny violate their oath of office. Health Officer Luu advised closed businesses on the verge of bankruptcy to consult attorneys when reopening. How can small operators damaged by her order afford an attorney? Whose side is the county on? Why wouldn't the county hire attorneys to assist businesses?

As Governor Newsom repeatedly ignored the Constitution and the

separation of government's powers he has alienated even many of his own party's legislators. Finally, someone decided to do something about him.

Assembly members James Gallagher (R-Yuba City) and Kevin Kiley (R-Rocklin) requested a temporary restraining order against Newsom's executive decree for a statewide vote by mail. Sutter County Superior Court Judge Perry Parker granted the order and scheduled a June 26 hearing for the state to show why the Governor's executive order does not violate the Constitution.

However, who else will resist the Governor's many dictator-like actions, all justified by a highly questionable emergency?

Everyone can do something to get Yuba-Sutter back to normal. Open your business. The government has done its best to scare people to death. Tell its representatives to go to hell. They are stealing your freedom and destroying vour health.







Social Security Matters

When Should We Claim Our Benefits?

Dear Rusty: We served overseas for several years, not earning many quarters for Social Security. However, we have made sure that we paid in over time so we can receive a benefit, but it will not amount to much. For the past several years now, we have been back in the US, earning some professional salaries. Now it looks like at full retirement age my husband will get \$1147/ month, and I will get \$1026/ month. I was born in 1957 and my husband in 1956. Question #1: For the most financial benefit, when should we each start collecting SS (either now or at full retirement age)? And question #2: Will our amounts change because we are married and both collecting? Signed: Overseas Worker

Dear Overseas Worker: To answer your second question first, no, your benefit amounts will not change because you are married and both collecting. Based upon the numbers you provided, neither of you will be eligible for a "spousal boost" from the other because your benefit amounts at your FRA are too similar, so maximizing your individual benefits should be your goal.

As for your other question, when you should



needs and, importantly, your expected longevity. Both of you can get the maximum benefit available to you by waiting until you are 70 years old to claim, but that only makes sense if you are in good health and expect at least average longevity (about 84 for a man and 87 for a woman).

If you claim benefits before you reach your full retirement age (66 ½ for you and 66 plus 4 months for your husband), those benefits will be cut. If you collect now, your benefit would be cut by about 27% and your husband's by about 22% (based upon your respective years of birth). Further, if you claim before your full retirement ages and continue to work, you'll be subject to Social Security's earnings test, which limits the amount you can earn before they take back some of your for information purbenefits (the 2020 earnings limit is \$18,240; if you exceed that they'll take back half of anything you earn over the limit). The earnings limit changes annually but goes

away at your FRA. At your full retirement ages, you'll be NSSA and the AMAC entitled to 100% of the benefits you've earned from your lifetime of working (approximately the amounts estimated now). per year of delay), up to age 70 when your maximum benefit is reached. As a point of information, if you wait until your full retirement age to claim, you will have collected the same amount of money at age 78 as if you had claimed at age 62; and if you wait until age 70 to claim you'll have collected the same amount of money at age 82 as if you had collected at your full retirement age. If you live at least until "average" longevity, you'll collect more in cumulative Social Security benefits by waiting.

So, when should you claim? If you're still working and earning "professional salaries", then waiting at least until your full retirement age would be a wise choice. If you expect at least average longevity and don't need the money right away, waiting until age 70 would be a prudent strategy. But if you don't work and expect less than average longevity, then claiming at any time you need the money would be a reasonable decision. This is a choice only each of you can make.

What the Coronavirus Did to the National Debt, Your Bill Exceeds \$37,726

In March Congress added \$2.3 trillion to the national debt with the stimulus package. Most were jubilant to receive a stimulus check. But what does this mean? Just to pay this back today would cost each taxpayer \$18,863 (compare U.S. Debt Clocks Nov. 2019 with April 2020).

In May the Treasury Department announced that it will borrow another \$3 trillion this quarter making our total coronavirus indebtedness \$5.3 trillion and thus what we owed for the smaller loan more than doubles (Matt Egan, The US is becoming the king of debt. It's a necessary risk, CNN Business). To pay both loans in August would be more than \$37,726 per U.S. taxpayer.

Those who pay no federal taxes, which is about 50% of American adults, are not assessed. "The latest spending packages are estimated to be worth about 14% of the country's economy...the national debt soared above 100% of GDP" ("Coronavirus: US to borrow record \$3tn as spending soars," BBC News, May 4,

So what is a trillion dollars? To begin with a trillion is the number one followed by twelve zeros. A trillion dollars is a thousand billion and a billion is a thousand million. These numbers mean very little to the average person. who count their money in tens, twenties and

One mathematician gave us a very practical way of evaluating our outstanding debt. One trillion one-dollar bills stacked atop each other (not end to end but flat) would reach nearly 68,000 miles into space a third of the way to the moon (See CNN News Cast, Feb. 4, 2009). If so, the debt thus far incurred by the coronavirus alone, \$5.3 trillion, would reach to the moon and two-thirds back to earth.

Senator Mitch McConnell gave another illustration just as awe striking. He calculated that if we spent a million dollars every day since Jesus was born, we still would not have spent a trillion dollars - only three-fourths of a trillion dollars (Ibid).

Who will pay these two coronavirus loans? Since we never liquidate our debt - only increase and pass it on to posterity - our grandchildren yet unborn, will be saddled with this debt plus the interest on it. How can I prophesy with such certainty? The United States has not been free of debt since Warren G. Harding 98 years ago (US Debt by President by Dollar and Percentage Who Increased the U.S. Debt the Most? Depends on How You Measure It. By Kimberly Amadeo Updated November 04, 2019)?

Yes the coronavirus is a massive rogue wave that has sunk many businesses in its path but following closely behind it is a tsunami almost six times its size - the national debt – that is and will bring down this country because our children cannot pay it either. Our national debt has soared to \$25.5 trillion, and with the newly announce \$3 trillion loan to \$28.5 trillion. Our debt in one dollar bills laid flat atop each other will now go to the moon and back almost five times.

I ask students, "Who gets to go without so that this debt can be paid?" "Go without!!!?" That is a concept foreign to this generation!! They do not know, and neither do their parents and grandparents who laid it on their backs. When they are told that their share to liquidate this debt is not just \$37,726 for a coronavirus, but \$205,440 per taxpayer – due immediately, they get angry (see USDebtClock.org). Someone should have told them that government handouts are not free.

The 13th Amendment ending slavery has been rescinded, they are America's new slaves. Bondage was given them before their birth, or while they were in the womb, or before they were old enough to know what it meant to be sold into slavery. The past generation wanted nice costly programs for free and were willing to sell their children to have them. Worse, the older generation is still anxious to incur even more debt on our defenseless children and grandchildren. Are we not the most debt addicted, insensitive generation in U.S. History?

Yes these are hard times and in such adding to a national debt is said to be justified. What isn't justified is that in prosperous times, of which most of the last 70 years have been, we should, and could have, liquidated that debt. Then a \$5.3 trillion debt to handle a virus could have been repaid in the next prosperous time or perhaps by the children, but not now. We have squandered our wealth in foreign endless wars, foreign aid and domestic welfare.

I had hoped with the robust Trump economy (the best in several decades) that we could get to paying back the debt. I previously published that we could survive and turn things around if we did three things: made significant cuts in our top 6 major expenditures, did not elect a big spending congress, and did not incur a big funding event. Unfortunately we made no major cuts in spending, maintained a big spending congress, and did incur a big funding event – the coronavirus.

Trump remains our only hope for rebuilding the economy because he already did it once, but chances of removing even the coronavirus portion of the national debt enslaving us is slim.



Governor's Powers Checked by the Courts

SACRAMENTO, CA (MPG) - Great news! A State Superior Court judge granted my request for a Temporary Restraining Order against Governor Gavin Newsom.

The restraining order suspends the Governor's recent Executive Order N-67-20 regarding the conduct of elections, and further restrains him from "exercising any further legislative powers in violation of the California Constitution and applicable statute, specifically from unilaterally

amending, altering, or changing existing statutory law or making new statutory law."

The Governor's Executive Order changed a variety of state election laws, including the elimination of public meetings with protected groups such as Californians with disabilities and limited English proficiency.

The order was issued in Sutter County Superior Court.

This action by the court is a victory for separation of powers. The Governor has continued to brazenly legislate by fiat without public input and without the deliberative process provided by the Legislature. The judicial branch finally gave him the check that was needed and that the Constitution requires.

Our election laws have been drafted to ensure that the rights of all people to vote are protected. They are the result of public input given in a legislative process. For the Governor to arbitrarily change these laws is wrong. This is why we acted to end this abusive practice and to restore representative government.




