## Food Insecurity Rising

Feeding America Study Projects Yuba-Sutter Community Shortfall

**YUBA CITY, CA (MPG)** - The novel coronavirus (COVID-19) pandemic will have a devastating impact on people facing hunger across the country and Yuba & Sutter Counties according to a new study by Feeding America, the nation's largest hunger-relief organization. This study is the first of its kind to explore how food insecurity rates at the local level may increase in 2020 due to COVID-19.

The Impact of the Coronavirus on Local Food Insecurity analyzes food insecurity rates for the overall population and children by state, county and congressional district. Pre-pandemic, here in Sutter County, 13,250 people, including 5,230 children, did not have adequate access to nutritious food to live a healthy life. However, this new study demonstrates that this number is likely to grow by 5,370, including 2,520 children. That means approximately 18,620 people (1 in 186 people) may experience food insecurity in 2020, including 7,750 children (1 in 77 children).

In Yuba County, 10,870 people,

including 4,450 children, did not have adequate access to nutritious food to live a healthy life. However, this new study demonstrates that this number is likely to grow by 4,320, including 2,140 children. That means approximately 15,190 people (1 in 151 people) may experience food insecurity in 2020, including 6,590 children (1 in 65 children).

Across the two counties, it is projected that 1 in 338 adults and 1 in 143 children will face food insecurity.

The Yuba-Sutter Food Bank remains committed to partnering with food pantries, local businesses, community groups, and volunteers, to respond to the increase in food insecurity in the Yuba-Sutter community by doing what we do best; feeding those who are in need, said Michelle Downing, Food Bank Interim CEO. The coronavirus pandemic, and its resulting impacts on food insecurity, will require a continued, creative response to making sure people who are in need of food know the Yuba-Sutter Food Bank is a vital resource and is here to help them.

This new analysis was conducted by building upon the approach

Feeding America used in two earlier briefs to predict changes to national food insecurity rates for the overall population and children in response to changes to poverty and unemployment. The annual projected unemployment rate (11.5%) is within close range of expert estimates when annualized, including those from a monthly Wall Street Journal survey of more than 60 economists as of May (11.6%), the Congressional Budget Office (11.4%), and Goldman Sachs Global Investment Research (10.3%), and represents an increase of 7.6 percentage points. To account for local unemployment variation, this new analysis adjusts the projected national unemployment increase for likely job loss due to COVID-19 based on an analysis of projected changes in the unemployment rate by industry and occupation by Goldman Sachs Investment Research. The projected local unemployment change for Sutter County is 0.083.

The underlying analysis for the food insecurity projections was conducted by Dr. Craig Gundersen using the model developed for Map the

## Unemployment Insurance Claims Increase by 20 Percent

**SACRAMENTO, CA (MPG)** - After a relatively stable level in the prior 4 weeks, total California initial claims (regular UI plus PUA claims by the self-employed) jumped 20% for the week of June 20. As suggested in the separate WARN Act analyses, most layoffs continue to be temporary but an increasing percentage is now shifting to permanent, an indication that the recovery period will face additional difficulties in returning to previous job and employment levels.

Nationally, actual claims (not seasonally adjusted (NSA)) for regular UI were essentially level at 1,457,373, while the seasonally adjusted (SA) level used for trend analysis is being reported as a decrease at 1,480,000. Combined with PUA claims, the national NSA numbers eased 2%. California showed 287,354 initial UI claims (NSA) along with 86,130 initial PUA claims (NSA). As with last week's employment and job numbers, the initial claims data is another indication that the economic downturn has been more severe in California and continues in many sectors, while the US on average appears to be in the initial stages of a recovery.

Combining both the regular UI and PUA initial claims, California had the highest number of initial claims among the states. Total initial claims for California for the week were 2.0% of the May labor force, moving up to the 8th highest among the states. To date, total initial claims of 6.6 million since the beginning of the state's shutdown represent over a third of the labor force. This level, however, does not translate directly into the unemployment level. Not all claims are necessarily approved, filers may have secured employment after submitting their claim, and individuals may have filed more than one claim in this period.

Although not included in the table above, claims under the new Pandemic Emergency Unemployment Compensation (PEUC) program continues to show significant numbers. This new category allows an additional 13 weeks of coverage for persons who have exhausted their

## Governor and Democrats Ignore Millions of Californians in Budget Deal

The Legislature sent the Governor a budget that increases billions of dollars in taxes, prevents funding for charter schools and jeopardizes public safety. This deal was cobbled together with little public input – an agreement that lacked transparency. Senator Jim Nielsen (R-Tehama), Vice Chair of the Senate Budget

Committee, issued the following statement:

“I do appreciate the pro Tem, the Speaker and the Governor for their continued support in Paradise to fund the promised \$7.3 Million to the Paradise Irrigation District. This money will help bring clean water to survivors of the Camp Fire.

“It is, however, disappointing that this budget came together without public discussion or representation. Citing concerns with Covid-19, the conference committee

– a forum for bipartisan discussions – was scrapped.

“There is no excuse for the denial of public input and lack of transparency. By cutting out the minority party, the Governor and Democratic lawmakers have denied millions of Californians the opportunity for their voices to be heard through their representatives in discussions and negotiations.

“Californians deserve to have a voice in their government.” ★

# Govt Charity Keeping the Dead Alive

The dead have a life of their own in America. Whether receiving bonus bucks or applications to vote absentee, the dead are cashing-in on government incompetence. Some addresses receive multiple requests to vote where only two voters are living and the rest were dead or relocated. In a society lean on virtue, that is a big temptation to pass-up voting early and often for your favorite candidate.

Some states needed to be sued to remove the names of the dead from voter rolls. Millions of people left this world or the state for greener pastures but remained on the registry.

The Internal Revenue Service recently sent out 1.1 million stimulus checks to dead people totaling \$1.4 billion to help them with the Covid Scamdemic. As the IRS rushed to get payments to those reeling from the national shutdown, the Government Accountability Office said the tax agency didn't use Social Security death records to filter-out payments to the deceased. The \$1.4 billion paid to the dead accounts for 0.5% of the total value of stimulus checks.

The government was shown how to avoid such a misuse after a botched stimulus pay-out in 2013 but did not employ the filtering mechanism. Treasury Secretary Steven Mnuchin said that relatives of dead recipients needed to return the money. Good luck, this is 2020 virtue.

Coming into Independence Day weekend Americans find themselves dependent upon the government dole. So many justify their hand in the till that it is impossible to get any traction to reform 'sugar daddy' Uncle Sam. Even churches took stimulus hand-outs though claiming they are allergic to government entanglements.

Counties and cities do whatever the state tells them in order to protect their payday. Though leaders swear oaths to defend and uphold the Constitution the precious document is ignored or its meaning mangled to get available cash.

While the federal government has a role in maintaining voting integrity it was never intended to be charitable, that was the task of the people.

However, less than 20 years after the nation's founding, the House debated providing \$15,000 relief for Haitian refugees fleeing a civil war and coming to New England.

James Madison's dissent was clear: "Charity is no part of the legislative duty of government. It would puzzle any gentleman to lay his finger on any part of the Constitution which would authorize the government to interpose in the relief of...sufferers." Madison was not heartless. The government was not intended for such work, is horrible at it, wastes trillions today and does much harm with its 'charity.'

A few years later, Virginia Rep. William Giles condemned a relief measure for fire victims, saying it was neither the purpose nor the right of Congress to "attend to what generosity and humanity require, but to what the Constitution and their duty require."

Franklin Pierce, our 14th president, vetoed a bill to assist the mentally ill, saying, "I cannot find any authority in the Constitution for public charity," adding that to approve such spending "would be contrary to the letter and the spirit of the Constitution and subversive to the whole theory upon which the Union of these States is founded."

In 1887, the 22nd and 24th President Grover Cleveland said when he vetoed a bill to assist drought-inflicted counties in Texas, "I feel obliged to withhold my approval of the plan to indulge in benevolent and charitable sentiment through the appropriation of public funds. . . . I find no warrant for such an appropriation in the Constitution."

Tennessee Rep. Col. Davy Crockett, spoke in the House of Representatives against a \$10,000 appropriation for a widow of a distinguished naval officer, "We have the right, as individuals, to give away as much of our own money as we please in charity, but as members of Congress, we have no right to appropriate a dollar of the public money."

Charity is reaching into one's own pocket to assist a neighbor in need. Reaching into someone else's pocket to assist one's neighbor does not qualify as charity. When done privately, it is considered theft, and the perpetrator risks jail time.

Not seeing government as responsible for every need seems strange to people today – we now function as a socialist society. Our founders assigned few powers to the federal government and left the rest to each state and the people. Redistributing wealth was never intended as a role for the federal government.

July 4th falls on a Saturday this year, and to keep families safe, the Yuba City Police Department will have extra officers on patrol throughout the Independence Day Weekend looking for drivers suspected of driving impaired.

"We are all anxious to get out and return to some sense of normalcy," Sgt. Kim Slade said. "But that doesn't excuse forgetting how to be safe on the road by driving impaired."

The Yuba City Police Department reminds the public that impaired driving is not just from alcohol. Some prescription medications or over-the-counter drugs may interfere with driving. While medicinal and recreational marijuana are legal, driving under the influence of marijuana is illegal.

If you plan on drinking or taking medications that may impact your ability to drive safely, plan on staying at home. If you are going to a bar or restaurant, designate a sober driver before heading out for the evening.

The Yuba City Police Department encourages the community to think of the safety of themselves and their families when enjoying the Independence Day holiday. Your actions save lives.

Meal Gap, Feeding America's annual study of local food insecurity and food cost in the United States.

Key findings for Yuba-Sutter from this report regarding food insecurity include:

Yuba-Sutter had relatively high rates of food insecurity before COVID-19 and the study shows Yuba-Sutter will continue to see an increase in the rate of food insecurity; As closures caused by the coronavirus lead to a rise in unemployment and poverty, more people will experience food insecurity; Households with children are more likely to be food insecure. In 2018, across Yuba and Sutter county, 9,680 children (1

in 96), lived in a food-insecure household.

The Yuba-Sutter Food Bank has responded to COVID-19 with increasing food distribution by working with schools and agencies, such as local food pantries and soup kitchens, and implemented a Homebound Delivery program, which food is delivered twice a week to the doorsteps of individuals who are at highest risk for serious illness associated with COVID-19 – including seniors, and people with chronic illness.

# MOSQUITOES ACCUMULATING IN TOWN AREAS

## TOWN SPRAYING SET TO BEGIN

When mosquitoes move into town areas, it is important to reduce their numbers and lower mosquito-borne disease risk. Public health insecticides formulated for application in urban and residential environments undergo rigorous safety testing before they are approved for use. For the 2020 season, the District will be using a permethrin product applied at an ultra low volume rate of 0.29 ounces per acre. All applications are predicated on mosquito abundance, disease activity and favorable weather conditions. Although these materials pose a low risk to human health, some people may prefer to avoid or minimize exposure by staying indoors, keeping their windows closed and turning off their window –mounted air conditioners, evaporative coolers and whole house fans when spraying is taking place in the immediate area. You can obtain additional information about spray operations by calling the District office at 674-5456 ext. 0 between the hours of 7 AM to 3:30 PM, Monday thru Friday or by viewing our website at [www.sutter-yubamvcd.org](http://www.sutter-yubamvcd.org). Residents can also sign-up for email spray notifications by visiting the District's website.

## SCHEDULE

Beginning on Thursday, July 2, 2020 and continuing weekly, fogging routes will begin at dusk and continue as late as 11:30 PM in Olivehurst, Linda, Arboga, Plumas Lake, Wheatland, East Marysville, Live Oak, Tierra Buena, Yuba City (Hillcrest area) and Sutter. Meridian and Robbins will be fogged on Tuesday or Wednesday evenings. Additional town areas and nights may be added if mosquito-borne disease activity becomes elevated. The program generally ends in mid-September, when mosquito abundance declines.

"It is high time we remember that we have sworn to uphold and defend the Constitution which speaks not only of the freedom of speech but also of trial by jury instead of trial by accusation. These are the basic principles of Americanism. The right to criticize, to hold unpopular beliefs, the right to protest, and the right of independent thought. The exercise of these rights should not cost an American his or her reputation or livelihood because he or she happens to know someone who holds unpopular beliefs. The American people are sick and tired of being afraid to speak their minds lest they be smeared as Communists or fascists by their opponents." Now in 2020, as was the case in 1950, free speech is no longer allowed today. History is repeating itself. Shame. ★

## Paradise Irrigation District to Receive Promised Funding

**SACRAMENTO, CA (MPG)** - After much advocacy from Senator Jim Nielsen (R-Tehama), Assemblyman James Gallagher (R-Yuba City), community and business leaders and Paradise residents, the Governor signed the \$202 billion budget Monday evening that continues the promised \$7.3 Million to Paradise Irrigation District. This funding is critical to bringing clean water to residents for rebuilding efforts.

The Governor took the money out of his May revise budget proposal, but the funding was affirmed by the final budget.

"Camp Fire survivors spoke up loud and clear. I thank the people of Paradise for their strength and courage to continue the fight to rebuild their Town," said Senator Jim Nielsen (R-Tehama). "I also want to thank my legislative colleagues for their continued support of Paradise."

Assemblyman Gallagher stated, "It's ridiculous that this was such a budget battle to begin with. The Town of Paradise has already suffered through so much; there was no reason for the Governor to threaten their ability to rebuild. That being said, I'm pleased with the outcome and will continue to protect and defend our ability to recover from this devastating fire."

In November 2018, PG&E's faulty electrical lines sparked a raging fire that decimated the Town of Paradise and killed 84 residents. Since this deadly fire, citizens have combed through rubbles of their destroyed homes and businesses for precious keepsakes, cleared their properties and began rebuilding their lives.

Without water, the rebuilding of the Town of Paradise would have come to a screeching halt.

Butte County Supervisor and Camp Fire Survivor Doug Teeter previously said, "No water = no town." ★

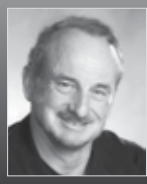

## The Stock Market is Beginning to Convulse Again

With CoVid 19 cases on the rise, the stock market is beginning to convulse again. Since March of this year when the Corona virus first made headline news, the stock markets violent ups and downs have been giving investors fits and confusing market experts.

From a February all time Dow high of 29,568 to a 20% bear market correction of 18,213 in record time, it then catapulted back up within a few thousand points of the all-time high once again in the following months.

Although the early March rout was almost absolute in its destructive scope, taking down almost every stock with it, the rebound which began a mere three weeks later encompassed only a small percentage of securities. This sector rotation, of which I wrote about a few weeks back, has been classically illustrated in the markets recovery.

I can't recall such a time in my recent memory that such pronounced movements of stock sectors rotated back and forth such as what we've witnessed in recent weeks.

The recovery which began on March 23 rd saw only a handful of stocks begin their steep ascent. Those companies represented the things and services people would use while sequestering in their homes due to the shutdown. Once this group had reached dot.com like enthusiasm, traders began their hunt into other sectors that were in any way, shape or form related to the stay and work at home stocks.

Once those stocks were also exhausted by reaching lofty valuations, the buyers took on the most beaten down sectors. The worst of the worst like cruise ship companies, hotels, dine in restaurants and the motel/hotel sectors had gobs of money tossed onto their gambling tables in a search for fast profits.

Trading resembled the last bastion of hope and enthusiasm coupled with the overabundant greed of the star struck day trader. In other words, the gambling DNA of the amateur and the hopeful trader went diving in the CoVid stock dumpster looking for fast and furious gains in the sectors most obliterated by the Corona event. One could liken it to the same mindset of those buying penny stocks looking for explosive riches in the shortest amount of time.

But since markets will always reflect reality eventually but its day to day movements are only the sum of all the millions of investor opinion at any one moment, with the possible resurgence of CoVid, reality may be finally sobering up investors. Perhaps the ships wont sail and the planes won't fly as quickly and as profitably as was thought.

Many states are slowing their reopening processes with some outright halting

it altogether.

The realization that we could be in for a second round of a CoVid wave one, with wave two not expected to hit until the fall with the cooler weather, the ugly math may be showing some depressing results.

With some of the stimulus programs ending soon and any new ones being held up in Congress due to political infighting, investors may be waking up to the fact this thing is indeed really, really ugly and the multitude of problems are not going to magically disappear into a happy go lucky, dancing in the streets recovery any time soon.

In fact, an historical recession or depression may be materializing even if CoVid doesn't spike. And if it does and another shutdown is required, things could get even uglier. Like off the charts ugly.

As a result, last week more stock rotation took place and looks to continue. The latest round of rotation appears to be a repeat of the mid-march action, bidding up both the stay-at-home sectors and defensive areas like consumer staples.

Investors seem to be selling the opening-up fad stocks like those ships and planes again while piling back into the conduits of the internet and essential products.

With the markets stunning recovery, investors who were bleeding red from the initial sell off rejoiced in seeing the red fade to grey heading toward a hopeful full portfolio recovery.

Now with the threat of more CoVid, investors are looking fearfully in the rear view mirror dreading the possibility of a second correction. Not a sector rotation of stock sectors mind you, but an all-out, take-no-prisoners type of wipe out similar to the one that took them by surprise in early March.

If CoVid infections indeed resurge to even more explosive type numbers, the markets once again could reflect that reality by heading south again in a very big way.

# The Be Safe Nation

A reader called as the CCP (Chinese Communist Party) Scamdemic was surging to say that she was 12 in 1969 and became ill with the Hong Kong flu. She explained that the Hong Kong flu was much worse than the Wuhan Flu in terms of impact. Maybe, maybe not, but be assured the HK Flu was not used for political fodder by the Greatest Generation against the nation they just successfully defended.

Between 1968 and 1970, the Hong Kong flu killed an estimated 1 to 4 million, with US deaths exceeding 100,000. Today, deaths from the CCP flu surpass a half million with 128,000 of those being Americans. However, there will be an asterisk by the US number due to anyone dying from anything with a detection of Covid being credited to the flu. The asterisk will forever be a footnote for the lack of integrity in the medical profession and the Scamdemic concocted to topple an American president.

The adults responsible for America in 1969 had suffered the Great Depression, survived WW II, the Korean and Vietnam Wars. They lived on little and later risked all they had for freedom. Today's adults are consumed with staying safe, wearing little masks, sanitizing, and cancelling life to stay at home, confident in conformity.

In the Seinfeld segment about Kramer and the AIDS ribbon Kramer signed-up for the March for AIDS Awareness but was bullied by marchers for refusing to wear the symbolic AIDS ribbon. Kramer protests, "This is America, I don't have to wear anything I don't wanna wear!"

His persecutors were of the "I Care" generation where a thought or symbol equals deed done.

Today, some popular irritable clichés are "You are beautiful inside and out," "Be safe" and "Have a nice day." Literary critic Paul Fussell, ticked with the send-off "Have a nice day" responded "Thank you, but I have other plans." Well done, Mr. Fussell.

Veterans alive in 1969 after being dumped by Higgins boats on Omaha Beach, June 6, 1944, were hoping to survive for more than a few minutes, vomiting and having a-body-fragments-on-your-face day.

Today, police are forced by health officials to confront people for canoeing, being at the beach, not wearing a mask, and working. Meanwhile 'bad guys' are freed to offend again.

In 1969, there were Woodstock and Altamont rock concerts each attended by more than 300,000. Woodstock was a muddy multi-day bash with youngsters sharing

body fluids, drugs, food and drink. There were no places to shower, no bottled water or food trucks. No one cared about a flu epidemic brought here by returning troops from Vietnam.

There was no National Pee-Your-Pants Panic Campaign. The New York Times called the flu "the worst in the nation's history," but it hardly made the news. Schools operated as normal but for a few where too many teachers became ill.

"Life continued as normal," said Jeffrey Tucker, the editorial director for the American Institute for Economic Research. "But as with now, no one knew for certain how deadly [the pandemic] would turn out to be. Regardless, people went on with their lives."

"That generation approached viruses with calm, rationality and intelligence," he said. "We left disease mitigation to medical professionals, individuals and families, rather than politics, politicians and government."

How does the Wuhan Flu compare to the Hong Kong flu? Nathaniel Moir, a postdoctoral fellow at Harvard University's Kennedy School of Government, said there were few precautions taken during the H3N2 (HK Flu) pandemic other than washing hands and staying home when sick.

"It was like the pandemic hadn't even happened if you look for it in history books," he said. "I am still shocked at how differently people addressed – or maybe even ignored it – in 1968 compared to 2020."

In the 1960s, you learned that getting a virus was good for the immune system and getting sick while young (chickenpox and measles) was easier than when old. Adults living then had witnessed many ailments (mumps, scarlet fever, polio) brought under control.

The idea that a pandemic could be managed with social distancing and public lockdowns is new, said Tucker. It was first suggested in a 2006 study by New Mexico scientist Robert J. Glass, who got the idea from his 14-year-old daughter's science project.

"Two government doctors, not even epidemiologists" – Richard Hatchett and Carter Mecher, with the George W. Bush administration – "hatched the idea [of using government-enforced social distancing] and hoped to try it out on the next virus." We are, in effect, Tucker said, part of a grand social experiment.

The CCP flu is the Social Engineering Superbowl for lab - stars Tony Fauci and Deborah Birk. The price of mandatory participation is an altered life.

# The Supreme Court Becomes a Super-Legislature: The *Bostock*, *Altitude*, and *Harris* cases

The Supreme Court has just rendered historic decisions in three cases concerning Title VII of the Civil Rights Act of 1964, which prohibits employment discrimination based on race, color, religion, sex, or national origin. Justice Neil Gorsuch and Chief Justice John Roberts joined the liberal wing of the court to produce a surprising 6-3 majority holding that a gay sky-diving instructor (*Altitude Express v. Zarda*), a gay child-welfare-services-coordinator (*Bostock v. Clayton County*), and a male funeral employee transgenering to a woman (*Harris Funeral Homes v. EEOC*), were illegally fired under Title VII.

The issue of employment protection for gays is the central litigated issue in these cases. However, in order to reach its decision, the majority did considerable harm to one of the most important doctrines of American constitutionalism—the separation of powers. The short and long of it is that the high court converted itself into a super-legislature and in a display of raw “judicial” power inserted “sexual orientation” and “gender identity” into Title VII of the Civil Rights Act. In his dissent, Justice Samuel Alito pointedly observed: “There is only one word for what the Court has done today: legislation.”

On the first page of the Opinion of the Court, written by Justice Gorsuch, there is a foreshadowing of what is to come: “Those who adopted the Civil Rights Act might not have anticipated their work would lead to this particular result.... But the limits of the drafters’ imagination supply no reason to ignore the law’s demands.”

This is a strange and ominous formulation. Justice Gorsuch seems to be saying that those who passed Title VII of the Civil Rights Act had a list of certain kinds of employment discrimination that they made unlawful, but they lacked the foresight and imagination to expand Title VII’s coverage, which the court now in the year 2020 has supplied for them in its decision.

The dissenters (Brett Kavanaugh and Alito) zero in on the majority’s lack of respect for the separation of powers. Justice Kavanaugh says that Title VII clearly prohibits discrimination based on “race, color, religion, sex or national origin.” However, though the question in this case is whether Title VII should be expanded to include “sexual orientation” and “gender identity,” the more important question is “Who decides?”

Kavanaugh says that the Constitution gives a clear answer: “Under the Constitution’s separation of powers, the responsibility to amend Title VII belongs to Congress and the President in the legislative process, not to this Court.”

The history of the Civil Rights Act supports that view. Whenever Congress wanted to add to this list of protections, it did so by passing new legislation! For example, in 1967 it expanded Title VII protections against age discrimination to employees and later discrimination based on disabilities. Since neither of those categories of employment discrimination were in the original 1964 act, they could only be added by legislation, precisely as called for by the Constitution.

Justice Kavanaugh continues by reminding his colleagues that legislators have attempted to add “sexual orientation” and, more recently, “gender identity” to Title VII, but never successfully. In other words, legislative sponsors were never able to garner enough legislative support. This is undeniable proof that the people’s elected representatives have not seen fit to add these categories to the list found in Title VII.

According to Justice Kavanaugh: “In the face of unsuccessful legislative efforts (so far) to prohibit sexual orientation discrimination, judges may not rewrite the law ... may not update the law ... may not predictively amend the law just because it believes that Congress is likely to do it soon anyway.... We are judges, not Members of Congress.”

Why is a preservation of the “separation of powers” so important?

First, the American founders believed that dispersing power prevents the concentration of power in one branch which, if left unchecked, leads to repressive rule. The founders also understood that

legislative bodies are better suited to engage in nuanced law-making because they can hold hearings, gather and evaluate a variety of conflicting opinions from the citizenry, provide for proper exceptions and exemptions, and better craft enactments which will provide relief but also protect fundamental rights. The judicial branch has a much more limited set of tools which are only properly used to interpret statutes and settle disputes between litigants. The more a court moves away from those essential but limited set of functions—when it dabbles in policymaking, for instance—the more likely it is to fail.

It is apparent that Justice Gorsuch was well aware that the language of Title VII had not been expanded by Congress. Therefore, he attempted to argue that the phrase discrimination “because of sex” had already included “sexual orientation” or “gender identity” since a person’s sexuality was involved. He labored over many pages in the majority opinion in an effort to incorporate “sexual orientation” and “gender identity” into the phrase “because of sex.” It was a determined effort on his part, but it fails to be convincing for several reasons:

First, it ignores legislative history. Did Congress in 1964 mean to outlaw discrimination based upon sexual orientation and gender identity? Justice Alito does not mince words in answering that question: “It indisputably did not.” Instead, the choice of the phrase “discrimination because of sex” was clearly meant to address an employer refusing to hire an applicant simply because the job-seeker was a woman or man. The concern, at the time, was more commonly for women who had qualifications equal to male applicants but who were passed over because they were women. In short, notes Alito, discrimination because of sex “was a familiar and well-understood concept, and what it meant was equal treatment for men and women.”

The second objection to Gorsuch’s effort to equate “sex” to “sexual orientation” or to “gender identity” is that plainly, over the decades, congressional legislators who sought expanded coverage for “sexual orientation” had themselves viewed the two concepts (sex and sexual orientation) as distinct. The bills they introduced called for the addition of a new term to the statutory list; that is, a different concept, namely “sexual orientation.” Such efforts reveal that the phrase “because of sex” already referred to a certain kind of discrimination and therefore, a new concept, encapsulated in the phrase “sexual orientation,” was needed to accomplish what they sought—namely, protection for homosexuals.

Thirdly, of the 20-plus states that have anti-discrimination laws that proscribe sexual orientation, those states, almost universally at the same time, separately outlaw discrimination “because of sex.” State governments obviously recognized these two concepts as different types of forbidden conduct.

Finally, Justice Kavanaugh points to the findings of the appellate courts on the federal level: “Until the last few years, every U.S. Court of Appeals to address this question concluded that Title VII does not prohibit discrimination because of “sexual orientation.” Plainly and simply, the category had not been added to Title VII’s list of outlawed employer behavior. Though Gorsuch’s efforts convinced some of his judicial colleagues, his reasoning flies in the face of substantial evidence to the contrary. Discrimination “because of sex” that appeared in the 1964 act did not include “sexual orientation” or “gender identity.”

In summary, the majority’s opinion in this trilogy of cases is a gain for gay rights, but it is most certainly a setback for the separation of powers and for a judiciary dedicated “to interpret statutory terms to mean what they conveyed to reasonable people at the time they were written.”

## Study Details Farm Costs from Pandemic

The pandemic has already caused \$2 billion in losses for California farms, ranches and agricultural businesses, and a study released Tuesday says the impact could go much higher. The study, commissioned by the California Farm Bureau and other organizations, said losses could reach \$5.9 billion to \$8.6 billion by year’s end. The impacts come both from lost sales and from rising costs of food production and processing.

## County Fairs Struggle Amid Canceled Events

Stay-at-home protocols have caused severe losses for county fairs. Some fair boards have said their operations may not survive losses in revenue from canceled events at local fairgrounds. The closures have also hurt students who raise livestock for 4-H or FFA projects. County fairs have organized online auctions to sell students’ livestock, and at least one has managed to hold on-site livestock competitions with social-distancing rules.

## Poinsettia Growers Try to Gauge Holiday Demand

Although Christmas remains six months away, poinsettia growers had to decide a few weeks ago how many plants to prepare for the coming holidays – and the pandemic has made that harder to judge. At least one Central California nursery has announced it won’t grow poinsettias this year. But others say they’re either maintaining or even increasing production, figuring that people may stay home more and want to use poinsettias to brighten their holiday decor.

## Program will use Artificial Intelligence in Agriculture

A new Digital Agricultural Fellowship program at the University of California, Riverside, will employ artificial intelligence to tackle farming problems. Specifically, the program will gather and analyze data involving drought issues and pest problems in the Colorado River Basin and Salinas River Valley. The university received a \$10 million federal grant this week to jumpstart the program. ★

# Gov. Newsom Claims Right to Withhold Federal Grants to Fund California Deficits

## New California State Press Release

**YUBA CITY, CA (MPG)** - California Gov. Gavin Newsom responded to a New California State press release regarding illegal borrowing of federal grant monies to fund budget deficits by claiming the right to seize federal grant funds from counties not requiring face masks.

New California State press release issued early on June 24, 2020 highlighted the State of California intending to fund its \$85 billion budget shortfall through June 30, 2021 by accessing “Borrowable Resources” of over \$59.6 billion, including the over \$27 billion in federal health and financial stimulus dollars to address the COVID-19 pandemic.

Later the same day, Gov. Newsom told reporters, the State of California has the sovereign right to indefinitely hold billions of targeted federal grant monies from counties that are not in full compliance with the “new rules and regulations” in his recent COVID-19 Executive Order.

Newsom stated that after doing what he referred to as a “budget deal” with the California Legislature, “We’re going to attach some considerations and consequences” for withholding federal funds from non-compliant counties.

New California believes that such action is a violation of law, and if implemented would set a dangerous U.S. Constitutional precedent that a state governor and legislature can withhold

spending federal funds during a crisis to fund its own budget deficit needs.

New California State calls on the United States government to immediately take actions to prevent and protect the public safety by assuring that the State of California is not improperly or illegally using federal funds designated for health and financial stimulus as a source of “Borrowing Resources” to fund California’s \$85 billion budget deficits.

New California is a new state in development exercising its Constitutional Right to form from the State of California. The process to form New California is authorized and codified in Article IV Sections 3 & 4 of the United States Constitution. ★

# Protesters Topple Statues of St. Serra

**Catholic League Press Release**

**NEW YORK, NY (MPG)** - Catholic League president Bill Donohue comments on protesters who destroyed statues of Saint Junipero Serra:

Smashing statues of American icons is all the rage among urban barbarians. Ignorant of history, they are destroying statues of those who were among the most enlightened persons of their time. This includes Father Junipero Serra. The 18th century missionary fought hard for the rights of Indians, and was rightfully canonized by Pope Francis in 2015.

A statue of Saint Serra was toppled in San Francisco's Golden Gate Park on June 19, and the next day another statue of the legendary priest was torn down at Placita Olvera in Los Angeles. Archbishop José Gomez of Los Angeles, who is also president of the United States Conference of Catholic Bishops, singled out Saint Serra for his compassion and his effort to establish rights for Indians and women.

In 2015, I published a booklet, "The Noble Legacy of Father Serra," that detailed his many accomplishments. In light of the attacks on him, it is worth recalling some of his heroics.

Serra got along well with the Indians. His goal, and that of the Franciscan missionaries whom he led, was not to conquer the Indians – it was to make them good Christians. The missionaries granted the Indians rights and respected their human

dignity, quite unlike the condition of black slaves. The Indians appreciated their efforts, drawing a distinction between the missionaries and the Spanish crown: the former treated the natives with justice; the latter did not. The civil authorities were the problem, not the priests.

Contrary to the conventional wisdom, the missionaries did not eradicate Indian culture. Indeed, they learned the native language of the Indians and employed Indians as teachers. Some cultural modification was inevitable, given that the missionaries taught the Indians how to be masons, carpenters, blacksmiths, and painters. The Indians were also taught how to sell and buy animals, and were allowed to keep their bounty. Women were taught spinning, knitting, and sewing.

Archbishop Gomez is right to point out that Serra fought for the rights of

women, as well. It was the missionaries who sought to protect Indian women from the Spanish colonizers. The Friars segregated the population on the basis of sex and age, hoping to safeguard the young girls and women from being sexually exploited. When such offenses occurred, Serra and his fellow priests quickly condemned them.

A total of 21 missions were established by the Franciscans, nine of them under the tenure of Serra; he personally founded six missions. He baptized more than 6,000 Indians, and confirmed over 5,000; some 100,000 were baptized overall during the mission period.

If the truth were told about Saint Serra, he would be heralded as a friend of the Indians, not as their enemy. But truth matters little to those whose hearts are full of hatred and whose minds are closed to reality.

★

# Legislative Democrats Pass Legislation to Legitimize Racial Discrimination

# Newsom Signs Legislation to Fortify General Election for the COVID-19 Pandemic

**SACRAMENTO, CA (MPG)** - Governor Gavin Newsom has signed AB 860 – authored by Assemblymember Marc Berman with Senator Tom Umberg as a joint author – which codifies that county elections officials must mail a ballot to every registered, active voter ahead of the November 3, 2020 General Election.

"California is moving in a swift, bipartisan manner to fortify our democracy in the face of the COVID-19 pandemic," Secretary of State Alex Padilla said. "Expanding vote-by-mail statewide is a necessity to protect our right to vote and our public health. Voting by mail has worked safely and securely in California for decades. Mailing every voter a ballot for this election is simply common sense."

"A few simple measures in AB 860 will further strengthen and complement the expansion of vote-by-mail. Providing vote-by-mail tracking options to all California voters will improve voter confidence. Allowing lawfully cast vote-by-mail ballots to arrive to elections officials 17 days following the election will protect against any disruptions in the postal service. And affording elections officials more

time to process vote-by-mail ballots will help with the efficiency of the vote count process for this unprecedented election."

AB 860 provisions for the November 3, 2020 General Election:

Requires county elections officials to mail every active registered voter a ballot; Requires every county elections officials to adopt a vote-by-mail ballot tracking system. Californians can sign up for the Secretary of State's "Where's My Ballot?" tool to receive automatic updates about the status of their vote-by-mail ballot by text (SMS), voice call, or email. Californians can sign-up at [wheresmyballot.sos.ca.gov](https://wheresmyballot.sos.ca.gov); Requires that county elections officials process and count ballots that were postmarked on or before Election Day and arrive to elections officials no later than 17 days after Election Day. Under current law, vote-by-mail ballots that arrive more than three days after the election are not counted; Allows county elections officials to begin processing returned vote-by-mail ballots 29 days before Election Day. Under current law, counties can begin processing vote-by-mail ballots 10 business days before an election. Results will still not be released until after all polls close on Election Night. ★

# Tax Initiative for Certain Commercial and Industrial Real Property is Withdrawn

**Office of California Secretary of State**

**SACRAMENTO, CA (MPG)** - Secretary of State Alex Padilla announced that an initiative eligible for the November 3, 2020 General Election ballot has been withdrawn by the proponents.

The Attorney General's official title and summary of the initiative is as follows:

**REQUIRES CERTAIN COMMERCIAL AND INDUSTRIAL REAL PROPERTY TO BE TAXED BASED ON FAIR-MARKET VALUE. DEDICATES PORTION OF ANY INCREASED REVENUE TO EDUCATION AND LOCAL SERVICES. INITIATIVE CONSTITUTIONAL AMENDMENT.** Taxes certain commercial and industrial real property based on fair-market value—rather than, under current law, the purchase price with limited inflation. Exempts agricultural property and certain small businesses. Dedicates portion of any increased revenue to local services and to supplement, not replace, state's minimum-funding guarantee to schools. Provides tax exemption for \$500,000 worth of tangible personal property used for business and


all personal property used for certain small businesses. Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government: **Net increase in annual property tax revenues of \$6.5 billion to \$10.5 billion in most years, depending on the strength of real estate markets. After paying for county administrative costs and back-filling state income tax losses related to the measure, the remaining \$6 billion to \$10 billion would be allocated to schools (40 percent) and other local governments (60 percent). (17-0055.)**

The measure previously became eligible for the ballot on October 16, 2018, through a random sample verification of signatures.

Pursuant to Elections Code 9604(b), proponents may withdraw an initiative any time before the Secretary of State certifies it as qualified. The 131-day qualification deadline for the November 3, 2020, General Election is June 25.

The proponents of this initiative, Anthony Thigpenn, Helen Hutchison, and Benjamin McBride did not provide any contact information.

## This Month In Your Garden

We have recently passed the mid mark of the year 2020. The last half of the year is ushered in by the Fourth of July. Cooking vegetables from your own garden along with whatever else you want to BBQ is commonplace thing to do. Toss a salad, put out a bowl of fresh fruit and serve it up on paper plates and you have lots of good eating without too much fuss and bother or clean-up. It can be satisfying to think that much of the dinner was from your efforts in your own garden. Continue to enjoy the bounty from your vegetable garden by fertilizing monthly using a vegetable fertilizer. It is best to avoid high nitrogen fertilizers because they create too much just green growth at the expense of more fruiting. Be alert for the big tomato worms – they blend in so well making it hard to see them and they can defoliate a plant quickly. Spray them with Bacillus Thuringiensis (or BT for short) to kill them. It is specific for caterpillars and is organic. Some people hand pick them, others cut them in two with their pruners. Personally, I prefer the BT method.

A common summertime pest is the budworm that seems to prefer geraniums and petunias, making holes in the buds and the stems. They, too, can be controlled by BT. It is a good product to have in your supply of garden pest control items. Lady Bugs and Praying Mantis are two great insects for controlling the bad guys. Many garden supply stores have them to sell earlier in the season, but they may be harder to find now. If you have them in your yard, try to avoid them when spraying insecticides.

July, is a typically warm month, but it is still okay to plant. Many people are enjoying vacation time and want to take advantage of the time to plant a tree where the summer sun has made it obvious that a tree is needed for shade to make an area of the yard more useable. Of course, it will be necessary that anything planted when it is hot will need to be watered more frequently and adequately than normal to help establish new roots. Using a product called 'Superthrive' at the time of planting and then once a week or so will help make the transition from container to the ground easier. If you really need to transplant a well established plant, some root

is usually lost and 'Superthrive' will certainly help that, too. It is best for the tree to be planted in the evening as the temperatures are cooling off. It certainly can be done, but don't neglect them and you will both be happy. The ground should be moist at planting, then use deep watering practices.

Obviously keeping your plants well watered in order that they survive the heat is the most important chore needed now. Most people learned some useful methods during our several drought years. Drip systems are water savers since they are targeted at the plant and not all of the space around. That also helps to keep the weeds down since the whole area isn't always being kept wet. Most weeds can use just as much water as the plants, so keeping them cleared away will save water. Mulching around the base of plants will help prevent evaporation reducing the need of frequent watering, also helping to keep them weed free. We find that trees on drip systems are sometimes short on water just because the owner doesn't think to give more time on the watering cycle. We all drink more liquids during the hot weather – so do plants, and especially trees. We have customers bring a small tree branch with droopy leaves that are dry around the edges fearing that the tree has a disease. Those are actually the first signs of not enough water. It is best to give trees a good deep watering less frequently than to water them daily with a lesser amount of water. As a general rule it is better to water new plantings or plants in containers in the morning so they have moisture to draw on all day. That is not an option for many of us who leave for work early in the morning. In that case, later in the evening may have to do and usually works out well since they don't transpire much moisture in the cooler night environment. If you have an automated system so much the better – check it routinely to be sure it is working properly. Enjoy your July 4 th holiday. We will be closed!

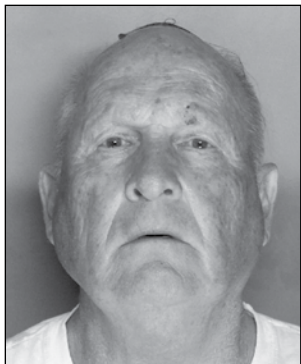

# Golden State Killer Pleads Guilty

## DeAngelo is Sentenced to Life Without Parole

**SACRAMENTO, CA (MPG)** - According to a press release issued by the Office of Orange County District Attorney Todd Spitzer: Joseph James DeAngelo Jr., 74, pleaded guilty to 13 felony counts of first-degree murder and 13 felony counts of kidnapping to commit robbery during a 13-year multicounty crime spree that terrorized much of California during the 1970s and 1980s. DeAngelo was identified through Investigative Genetic Genealogy (IGG) in 2018, more than three decades after he raped and murdered his last victim in 1986. DeAngelo also admitted to 161 uncharged crimes related to 61 uncharged

victims, including attempted murder, kidnapping to commit robbery, rape, robbery, first-degree burglary, false imprisonment and criminal threats. The uncharged crimes occurred in Alameda, Sacramento, San Joaquin, Santa Clara, Stanislaus, Tulare and Yolo counties. The decision by prosecutors to accept DeAngelo's offer to plead guilty to the 26 charged crimes and admit the uncharged crimes was made in consultation with the victims and their family members. The totality of the circumstances, including the age of the victims, the age of witnesses and the death of other key witnesses, and the age of the defendant, were taken into consideration. This six-county joint prosecution resulted in a guilty plea of: 13 counts of first-degree murder with special circumstances allegations of multiple murders and murder during the commission of rape, robbery, and burglary. 13 felony counts of kidnapping to commit robbery with sentencing enhancements for personal use of a firearm and personal use of a knife during

the commission of the offenses. DeAngelo also admitted to the uncharged crimes of: Attempted murder, kidnapping to commit robbery, rape, robbery, first-degree burglary, false imprisonment and criminal threats. DeAngelo's crime spree began in 1975 when he was working as a police officer with the Exeter Police Department. The crimes, which continued long after he was fired from the Auburn Police Department in 1979, escalated from peeping through windows to stalking to rape and serial murder. The hearing was relocated to the Sacramento State Ballroom to accommodate the large number of victims and their family members in attendance and to ensure social distancing in light of the current COVID-19 pandemic. "The investigation, identification and prosecution of the East Area Rapist/ Golden State Killer has been a long journey for justice – a journey marked by passion, persistence and sheer determination," said Sacramento County District Attorney Anne Marie Schubert. "Through the revolutionary tool of Investigative Genetic

Genealogy, this serial rapist and murderer was not only identified and brought to justice but will spend the rest of his life in prison. It is my sincere hope that today brings healing to victims, their families and communities harmed by the atrocious crimes committed by Joseph DeAngelo." Joseph DeAngelo will be sentenced to life in state prison without the possibility of parole. The sentence will run consecutive and concurrent to his sentence for the first-degree murders to which he has pled. His sentencing hearing will commence on August 17, 2020. Victims will be given the opportunity to deliver victim impact statements prior to DeAngelo's sentencing on August 21, 2020. The sentencing hearing location will be announced at a later date. His crimes earned him the nicknames of the Visalia Ransacker, the East Area Rapist, the Original Night Stalker, and the Golden State Killer. It was not until April 2018 that Sacramento authorities announced that Investigative Genetic Genealogy had identified DeAngelo as the person responsible. ★

# Missing Gridley Man's Body Recovered

**GRIDLEY, CA (MPG)** - A sunny afternoon at the Thermalito Forebay Aquatic Center turned grim when lifeguards at the recreation area notified children and families playing in the water that they would need to get out and return to the beach— something was wrong. It was just after 4:45 pm that officials notified patrons that water access was officially closed due to the discovery of a body floating in close proximity to the beach at the picnic area located off of the Garden Drive access point. Units from Butte County Sheriff's Office, Gridley Police Department and California State Parks responded to the scene, converging on a group of people standing near the shore on the north side of the Aquatic Center. Unbeknownst to many of the park's visitors, the area was the sight of an active search investigation for a missing Gridley man, Robert Voss. Gridley Police Department issued a missing persons alert for Voss, who had been missing since Thursday, June 25th, 2020. According to his family, Voss had last been seen at 7:30 in the morning, had missed a work meeting

and attempts to reach him via cell phone were unsuccessful. Voss's vehicle was discovered later that day unattended at the Forebay Aquatic Center, where a pay-stub for a day-pass put the time of his arrival between 7:30 and 8:00 am. California State Parks and Recreation established a Command Center at the Aquatic Center and along with the man's family, had been actively searching the area via foot, air and by boat. According to Lieutenant Quihuiz, Gridley PD was notified that a body had potentially been sighted in the water at approximately 2:50 pm on the afternoon of Sunday, June 29th. Officer Jared Cooley responded to the Aquatic Center and spoke with Voss's son, who had spotted the body with binoculars from the shore. Reportedly, after failed attempts to retrieve his father's body by himself, Voss's son notified State Park officials and Sheriff's Department, so authorities stepped in to handle the recovery. In a heartbreaking scene, Voss's family could be seen standing ashore as State Park officials recovered the body from the water. Officials were as discrete as possible, sheltering the body from the view of the many visitors that packed the picnic and recreation area. Family at the scene positively identified the deceased as that of 68-year old Robert Voss. As of now, the investigation is still open and waiting for a cause of death ruling, which Gridley Police Department anticipates soon from Butte County Sheriff's Office. ★

# Chico Woman Sentenced to Prison in Vehicular Manslaughter

**BUTTE COUNTY, CA (MPG)** - The Chico woman recently convicted of vehicular manslaughter in a deadly 2019 crash on East Avenue

in Chico, appeared in Butte County Superior Court to face the wife and daughter of the man she killed and was sentenced to the maximum term of six years eight months in state prison.

Amery May Sweany, 24, of Chico stood before Judge Michael Deems and apologized to the family of Virgil Santos, 64, of Chico for her actions leading to Mr. Santos’ death. However Mr. Santos’ wife and daughter told the judge how devastating the death of Mr. Santos has been on their lives and asked the maximum punishment be

handed down. Noting that the daughter will be married this fall without her father to walk with her, and that the wife had to move from the family home to a cheaper apartment because of Sweany’s grossly reckless actions, the judge sentenced Sweany to the maximum.

In April 2019, Sweany careened down East Avenue at speeds over 70 mph. Multiple witnesses reported seeing Sweany swerving around other cars on the road and weaving in and out of traffic as she approached the

intersection at Marigold Avenue. Sweany ignored the red light and ran her car into a vehicle driven by Virgil Santos, 64, of Chico. Virgil’s wife, Shelly Santos, 52, was a passenger in the vehicle.

Mr. Santos succumbed to injuries sustained from the collision, and died at Enloe Hospital. Ms. Santos sustained major injuries and underwent multiple surgeries in the months following the collision.

While in custody at the Butte County Jail, Sweany assaulted two correctional officers, punching

one, and spitting on the other. Sweany had previously pled to one count of Resisting an Officer and one count of Battery upon an Officer, both misdemeanors.

District Attorney Mike Ramsey noted Sweany’s case was delayed as her defense attorney sought to have her declared mentally incompetent to stand trial. A court-appointed psychologist finally opined she was competent to stand trial. Her attorney then attempted to place her into a mental health diversion program, but the Butte

County Behavioral Health Department found she was unsuitable. Once she was finally set for jury trial, Sweany changed her plea to no contest.

Ramsey said Sweany’s actions were particularly egregious because although not under the influence, she nevertheless had detectable amounts of controlled substances in her system; she drove at a high rate of speed down a main street in Chico; and she showed no concern for the safety of those around her, causing death and serious injury. ★
