Yuba County Academic Decathlon

The Yuba County Academic Decathlon was held on Saturday, February 1st at Marysville High School. Teams from Lindhurst, Marysville, Wheatland and Yuba City Charter High School tested their knowledge on the 2020 Academic Decathlon theme: In Sickness and In Health: An Exploration of Illness and Wellness. The Academic Decathlon is an academic competition for students in grades 9 through 12. Students compete as team members in a series of aca-

demic tests and demonstrations. Each team consists of three "A" (Honor), three "B" (Scholastic), and three "C" or below (Varsity) students. Awards are presented to the top teams as well as the top individual students in each event. Marysville High School came out on top with the highest overall points per school totaling 33,117. Zoe Rosales from Marysville High School who competed in the Honor Division won gold medals in Speech, Interview, Science, Essay, Economics, Language

& Literature. Sean Simeroth from Marysville High School who competed in the Scholastic Division won medals in Speech, Math, Science, Art, Economics, Social Science, Language & Literature. Sage Houshmand from Marysville High School competing in the Varsity Division won medals in Speech, Art, Economics, Essay, Social Science, Language & Literature. Marysville High School will compete at the California Academic Decath-Ion in Sacramento on March 26th - 29th.

Coronavirus Risk Remains Low in Yuba-Sutter Region

U.S. Steps Up Screenings and Warnings with Emerging Risk

Coronavirus risk remains low in Yuba-Sutter region

U.S. steps up screenings and warnings with emerging risk

The World Health Organization tracking the novel Coronavirus last Friday declared a "public health emergency of international concern," but Yuba-Sutter Health Officer Dr. Phuong Luu notes the overall risk to the general public in the bi-county region is low.

"Currently, there are no persons under investigation for suspected or confirmed novel Coronavirus in the bi-county Yuba and Sutter region," Dr. Luu said. "The overall risk to the general public in the bi-county region remains low."

The novel Coronavirus that began in Wuhan, China in late December 2019 also resulted in a declared public health emergency for the United States, in an effort to aid the healthcare community in responding efficiently to the emerging risk.

Currently, all US citizen travelers and their close fam-

ily members returning from Hubei Province, China, will be re-routed to 11 designated airports in the US to undergo screening and are required to participate in a 14-day mandatory quarantine. US citizens and their close family members who are returning from all other parts of mainland China will undergo proactive screening and are advised to undergo self-quarantine.

Dr. Luu said both the Yuba County and Sutter County Health Departments are in close contact with the California Department of Public Health (CDPH) and Centers for Disease Control and Prevention (CDC) and will be notified if any returning travelers from the bi-county region qualify for mandatory or self-quarantine.

The novel Coronavirus is spread through respiratory droplets, similar to the common cold and flu. The CDC recommends the following everyday preventive actions:

 Wash your hands often with soap and water for at least 20 seconds. Use an alcohol-based hand sanitizer if soap and water are not available

- Avoid touching your eyes, nose, and mouth with unwashed hands
- Avoid close contact with people who are sick
- Stay home from work and school when you are sick
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash, and disinfect your hands after
- Clean and disinfect frequently touched objects and surfaces

Anyone who has recently traveled to mainland China or been in close contact with a person who has should contact his or her doctor for further guidance. Do NOT go into a clinic or Emergency Room without first consulting a medical doctor.

Dr. Luu said there are a number of online rumors cropping up that contain inaccurate information about the novel Coronavirus. She said residents looking for verified information can go to www.cdph.ca.gov or www.cdc.gov.

Sutter County Supervisor candidate John Buckland's arrest January 10, 2020 at the Hard Rock Hotel and Casino raised some questions.

Buckland was taken to jail and held until he sobered-up, a common practice in Yuba County. No charges were filed by the District Attorney.

It is assumed Buckland did not assault the arresting deputy since there were no charges filed. However, Buckland appeared scuffed-up and was belligerent to jail correctional officers. What happened at Hard Rock remains unclear.

FISHIN' TALK



Well folks, the national weather source sure does disagree with our own weather man. As stated last week he indicated we would see rain and snow by mid-February. The big one on weather says there is no rain in sight for the Sacramento Valley. Sure hope their fancy computers are wrong.

Some might wonder why I occasionally bring up the topic of weather in a fishing column. The reason is it is so important for all fish populations in California. We need water sufficient enough to bring the stripers, shad, steelhead and salmon upstream to spawn. We need runoff from the mountain snow to maintain the rivers, creeks, streams and ditches. The runoff also fills the reservoirs, which by the way are slowly dropping. All this improves the fishing tremendously.

A report from Scott's Flat Reservoir, located off of State Route 20 above Nevada City tells us the bigger rainbow trout are on the bite. Fish up to 18 inches are being caught on or near the surface of the water. Trolling with rapalas or other lures is a good bet. Most of the anglers who are scoring big here are leaving the downriggers home and trolling with the lure at least a couple hundred feet behind the boat.

Englebright Reservoir, which is about 25 miles out of Marysville on State Route 20, is also putting out some nice trout. Best place here is to troll by the dam or around the house boats.

This is the time of year to consider fishing Camp Far West Reservoir. We have fished this

Man Arrested in Loma Rica Shooting

On Saturday 2/8/2020 at approximately 6:40 P.M. Yuba County Sheriff's Department received a 911 call of a possible accidental shooting victim injured in the 4800 block of Fruitland Road in Loma

Upon arrival, Deputies located an adult female with a gunshot wound to the leg, and a dog with a gunshot wound to the head, at the rear of a residence.

The deputies made contact with the suspect, identified as 37year-old Scott Anderson of Loma Rica, in the driveway of the residence. Upon attempting to detain Anderson, he became combative with Deputies, but was ultimately taken into custody and booked into the Yuba County Jail for 245(a)(2)/Assault with a Firearm; 246.3PC/ Negligent Discharge of a Firearm; 597(a)PC/Cruelty to Animals; and 69PC/Resisting Arrest.

The female victim was transported to the hospital by ambulance, and the dog was transported by deputies to a local veterinarian for emergency treatment. The female and the dog are both stable and recovering. The shooting remains under active and ongoing investigation.



COUNTY OF YUBA SUMMARY OF PROPOSED ORDINANCE PEALING AND RE-ENACTING ARTICLE OF TITLE II OF THE YUBA COUNTY **ORDINANCE CODE REGARDING PURCHASE OF REAL PROPERTY**

The following is a summary of a proposed ordinance repealing and re-enacting Article 5 of Title II of the Yuba County Ordinance Code regarding the purchase of real property proposed to be adopted by the Board of Supervisors of the County of Yuba on February 25, 2020.

The proposed ordinance pursuant to the authority granted to the Board of Supervisors by Government Code Section 25350.60 would authorize the Public Works Director, or designee, to be responsible for coordinating, planning, and negotiations of all real property purchases, and for maintaining records. The ordinance authorizes the Public Works Director. or designee, to perform all acts necessary to approve and accept for the County of any real property where the purchase price does not exceed \$150,000 and establishes procedures for the Public Works Director. Your NYWD Money

If you are a customer of North Yuba Water District (NYWD), you recently received the District's January 2020 newsletter in the mail. Did you read it? There is some very disturbing news on Page 2 regarding the number of Public Record Requests (PRA's) submitted to the district between January and November 2019. Nine individuals and one organization submitted a total of 106 PRA's, an unusually high number for a small agency such as the NYWD. According to the newsletter, 94 of the 106 PRA's were submitted by just three individuals: Charles Sharp (an irrigation customer) made 24 requests, Alton Wright (not a customer) made 30, and the grand prize goes to our newest Director, Gretchen Flohr, who made 40 requests for information. These 94 PRA's cost the district a whopping total of \$53,994.30 in legal fees out of the total of \$60,394.80 billed.

Now keep in mind,

as a director of the wa-Director district, Flohr is privy to district information that can be obtained directly from the manager or office staff, which could avoid the need for legal research and costs. least twice during board meetings, other directors have advised her that they go directly to the office whenever they need more information. She can email the office. call or go personally into the office with her guestions. Apparently she is not using any of these options and prefers to submit her PRA's directly to the legal team. Why? I can concede that she could be asking for some items that are best handled and explained by the district's lawyers, but 40+ times seems quite excessive. The legal bill she alone has racked up is almost \$50,000!!! And this figure will most likely go up when December's legal bills for PRA's are calculated into 2019's yearly total.

rest of you, but I am more than just a little angry to see district money (yours and mine) unnecessarily paying lawyers if this could easily be avoided and the money used for more worthy needs. To me, this shows a total disregard for protecting district assets on Flohr's part. As I perceive the iob of board directors, they are responsible for the needs of their constituents in their own divisions but, most of all, for the overall health of the district. And it is our job, as customers and tax-payers alike, to pay attention to what this board director is doing with one of our most valuable assets in our foothills, our water district. Director Flohr seems to be thumbing her nose at the district and its customers and pursuing a very expensive path where our water district is concerned.

Angelo's gift is suspicious knowing that Melanie's husband Robert Bendorf is the County Administrative Officer (CAO) and directs the Board of Supervisors in its decision-making. A gift to Robert would be considered a bribe or at least blatant favorseeking.

Permission is required of the board and county bureaucracy for all developments. In this case, Angelo's money to the wife is money to the husband.

Also in 2016, Yuba Water Agency (YWA) gave the Tsi Akim Maidu Tribe a utility truck. Photos were taken at the time with then supervisorial candidate Randy Fletcher handing over the keys. Enterprise Rancheria (Estom Yumeka Maidu Tribe) that owns the casino in south Yuba County recently donated \$7,000 to Supervisor Gary Bradford's 2020 re-election campaign.

All five supervisors sit on the YWA seven member board as well as make decisions governing Yuba County. Their votes and gifts spend Yuba citizens' tax dollars along with water and power revenue produced from Yuba County's Bullards Bar Dam, a project launched by the citizens of Yuba County following the 1955 flood. Peter Schweizer's

book 'Throw Them All Out" explains how millions are made by congress from insider stock trading. Though book's revelations led to the Stock Act (2012) forbidding this unethical and criminal behavior, the ACT was gutted in 2013 by the same Congress. Schweizer's work also exposed politicians using campaign revenue for personal use.

There are numerous examples of local officials benefitting from their positions and influence buying with tax dollars.

In 2007, businessman Dan Flores, now a Sutter County Supervisor, and Campaign Manager Crystal Martin applied for a loan of \$150,000 from the Yuba - Sutter **Economic Development** Corporation (EDC) while serving as EDC board members. When they were informed it was a conflict of interest to get loans as board members they resigned to get the money.

Once off the board they applied for two more loans \$144,200 for Martin and \$113,500 for Flores at 3% interest

rate. However, the loan requests were eventually withdrawn by Flores and Martin after state attorneys said that Federal Department of Housing and Urban Development conflict-ofinterest rules require board members to be off the board for one year to participate in the funding program.

Insiders know how to get tax dollars for personal gain.

The recent pitch at election eve to rename 5th Street in Maryville for Martin Luther King Jr. is a blatant whoring for votes by those seeking election. Liberals can't resist hustling minority groups for personal benefit.

If you can get elected, politics will make you wealthy via favoritism and by acquiring connections. In 2012, the top 20 profiting officials averaged a 422% net worth increase per year. The average net worth spike of the top 21-40 was 68% per year, and for those ranked 41-60 it was 42% annually.

ates disbelief and appears to construct a ruse.

News Chico and Review ran an article about drug and other illicit exchanges at Butte County casinos in 2005 causing the Measure G advisory vote to go against the Yuba Co. casino proposal. The article influenced voters to think that more criminal activity might be coming to Yuba County.

Buckland's statement says, "At the conclusion of the meeting I entered the casino. The duration of the stay was relatively short. Upon exiting...I encountered an unprecedented response to an incident in the parking lot. I was taken into custody for public intoxication of alcohol or drugs. I was released without criminal charges filed. I'm currently working with a civil attorney to investigate and recover evidence. He, and only he will release information...at the conclusion of his investigation."

law. Buckland said he hired an attorney with experience in activities on tribal lands.

In the 'Atlantic,' Sierra Crane-Murdoch wrote an article February 23, 2013 titled "On Indian Land, Criminals Can Get Away With Almost Anything." Enterprise Rancheria and Casino is "Indian land." Different rules apply there than elsewhere in Yuba County.

At the Fort Berthold Indian Reservation in western North Dakota (Bakken Oil Fields), where an oil boom is occurring Crane-Murdoch found there were different rules of enforcement depending on who was the perpetrator and the victim.

"Basically," a mechanic told me (Crane-Murdoch), "you can do anything short of killing somebody."

Crane-Murdoch says, "In 1978, the Supreme Court case Oliphant v. Suquamish stripped tribes of the right to arrest and prosecute non-Indians who commit crimes on Indian land. If both victim and perpetrator are non-Indian, a county or state officer must make the arrest. If the perpetrator is non-Indian and the victim an enrolled member, only a federally certified agent has that right. If the opposite is true, a tribal officer can make the

arrest, but the case still

goes to federal court."

"Even if both parties are tribal members, a U.S. attorney often assumes the case, since tribal courts lack the authority to sentence defendants to more than three years in prison. The harshest enforcement tool a tribal officer can legally wield over a non-Indian is a traffic ticket."

"The result has been a jurisdictional tangle that often makes prosecuting crimes committed in Indian Country prohibitively difficult. In 2011, the U.S. Justice Department did not prosecute 65 percent of rape cases reported on reservations. According to department records, one in three Native American women are raped during their lifetimes-two-and-a-half times the likelihood for an average American woman—and in 86 percent of these cases, the assailant is non-Indian."

The Buckland case reminds us that due to Federal Indian Law patron's rights end at the reservation property line just like a foreign country and who has jurisdiction if trouble starts could get confusing.

Sacramento, Ca. CalFire is awarding Yuba Water Agency \$4.5 million in California Climate Investment funding for the proposed Yuba Foothills Healthy Forest project. The project will include more than 5,000 acres of public and private forestlands in the Yuba County foothills, in various areas around Dobbins, Challenge and Brownsville. A variety of forest treatments will be used including thinning, prescribed fire, pile

burning and biomass utilization. The project will provide benefits to forest health, climate change resilience, species composition, catastrophic fire risk reduction and improved water yield. It also comes with direct benefits to hydropower and bio-energy fuels, and local jobs.

"This is such great news for our communities at risk of wildfire," said Randy Fletcher, Yuba Water Agency board chairman and

Yuba County supervisor for District 5, which includes the foothills. "This grant will enable us to get significant work done on the ground, and much of it on private land, to protect our people, our infrastructure and our water."

Nevada County was awarded over \$1.5 million to enhanced the 1,500-acre Grouse Ridge Research Forest through a diverse suite of treatment options and an ongoing commitment to long-term monitoring. 


Yuba County's New Airport Manager

Valentine's Day plants trending upward

Live plants are gaining in popularity for Valentine's Day, with social media trends leading the way. Orchids are a top seller at one Sacramento-area nursery, with blooming succulents, tropical plants and African violets not far behind. One San Diego County grower said she's selling a lot of plants with pink blooms or leaves, as well as Anthuriums with heartshaped flowers.

Tomato tonnage about steady this year

California tomato processors expect to handle about 12 million tons of fruit this year, a figure essentially unchanged from 2019. That's good news for the state's processing

tomato growers, whose 2019 crop fell short due to late-season rain and hail. As export challenges linger, growers expect more of their harvest to be used domestically in products ranging from soup to salsa.

Natural and working lands offer potential for carbon reduction

California's working lands can help the state achieve negative carbon emissions by 2045, according to a study by Lawrence Livermore National Lab. Scientists found that increasing the uptake of carbon in natural and working lands, as well as converting waste biomass to fuels and storing the CO2, could together reduce annual carbon emissions by 109 million metric tons of the 125 million needed to reach the goal.

Oak trees may hold answer to devastating citrus disease

Scientists have found that appling oak leaf extracts inhibits the bacterium that causes the devastating citrus crop disease huanglongbing, or HLB. The disease has reduced Florida's citrus crop by 90% and led to plant quarantines in Southern California after being found in residential citrus trees. Scientists from the University of Florida and the U.S. Department of Agriculture investigated oaks after farmers observed citrus trees planted near oaks survived HLB.
