

## Suspect and Protect

The Second Amendment to the Constitution reads, “A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.”

‘Militia’ did not refer to the military or law enforcement. The founders’ ‘militia’ meant every man, woman and child should both have a weapon and know how to use it to repel and defeat an over-zealous and power-hungry state.

The right to protect the person and property was God-given, not government-granted. The removal of God-given rights was to be over the dead bodies of patriots. (Throughout the course of the Revolutionary War, an estimated 6,800 Americans were killed in action, 6,100 wounded, and upwards of 20,000 were taken prisoner. Historians believe that at least an additional 17,000 deaths were the result of disease, including about 8,000–12,000 who died while prisoners of war.)

Founders believed the

citizen was primarily responsible to safeguard his family and property, not the government. No society can afford to hire enough police or military to insure personal safety or liberty. It takes seconds to shoot an intruder versus 10-15 minutes or more for a law enforcement response.

Concealed weapon permits, gun type limitations, registration of guns and background checks for purchasing ammunition are all glaring violations of the 2nd amendment. Again, the amendment was written to remind government to not infringe upon the people’s right to keep and bear arms.

The Sheriff is the local official with the greatest authority. Rather than go along to get along with an undermining of the Second Amendment he should honor his oath of office to ‘Defend the Constitution’ and declare the jurisdiction a Second Amendment Sanctuary County as originally written and intended.

County Supervisors offer no leadership if they cannot join

the Sheriffs to stand with the same Constitution they took an oath to defend. Their passivity shows they are pawns of the state rather than representatives of the people.

Assemblyman James Gallagher’s recent video exposing the harassment endured by citizens to purchase ammunition actually concedes the more serious usurping of the authority of the citizens by the state. Though Gallagher is with the minority party he should proclaim the God-given rights wrought with patriots’ blood to be free from government intrusion and not be content to rightfully mock the state’s troubling of the citizens.

Patrick Henry in his speech to the Virginia Ratifying Convention on June 5, 1778, said "Guard with jealous attention the public liberty. Suspect everyone who approaches that jewel. Unfortunately, nothing will preserve it but downright force. Whenever you give up that force, you are ruined.... The great object is that every

man be armed. Everyone who is able might have a gun."

Joseph Story wrote in ‘Commentaries on the Constitution of the United States, 1833’ that "The right of the citizens to keep and bear arms has justly been considered, as the palladium of the liberties of a republic; since it offers a strong moral check against the usurpation and arbitrary power of rulers; and will generally, even if these are successful in the first instance, enable the people to resist and triumph over them."

Samuel Adams at the Massachusetts Ratifying Convention in 1788 said, "The Constitution shall never be construed to prevent the people of the United States who are peaceable citizens from keeping their own arms."

William Pitt in his speech in the House of Commons on November 18, 1783 said, "Necessity is the plea for every infringement of human freedom. It is the argument of tyrants; it is the creed of slaves."

This week, Virginians are confronting tyranny in their state. It is time to stand with the Constitution and oppose the flood of regulations robbing us of our rights. It is time to buy as many guns and as much ammunition as possible from sources off the grid while you still are able. It is time to remove representatives who violate their oath of office.

It’s your republic should you desire to keep it.

## Sex and Sick

You probably didn’t notice particularly if you haven’t been checked lately but sexually transmitted infections (STI) are booming. The myth is that you can live a sexually promiscuous lifestyle and if you notice no symptoms then you are well.

However, health officials say people are infected but may not be experiencing symptoms yet. People in one-night stands and affairs may be comforted by partner assurances of no infections on board but often they haven’t been examined. They just aren’t aware of any symptoms.

Other myths abound in the STI world. People in some African nations believe that intercourse with a virgin female or a monkey could cure HIV and other STIs. What you don’t know can kill you in the STI world.

Unfortunately, politicians and even medical people often play sexual Russian roulette by not telling the whole truth about what is primarily spreading disease. To protect the image of groups with high risk behavior social engineers toss in ‘indirect causes’ like poverty, unstable housing, and insufficient funding. Though there are many contributing factors in spreading STIs including ignorance and the lack of transparency regarding sexual practices, the root problem is risky behavior.

Intravenous drug use, sex with many partners, and sex among homosexual and bisexual men are driving the spike in diseases. Add to the risky behavior the decreased or improper use of condoms, the lack of follow-through on treatment and not properly informing a network of sex partners about being infected.

If you had multiple partners over the years or injected drugs medical people advise telling your doctor and getting tested. Then remain sexually monogamous with someone that has also been tested, treated and cleared. For addicts, use a clean needle, get on suboxone or seek a rehab.

If sticking with one partner is impossible then use a latex condom, always. For the risk takers continue reading to learn about your STI world.

A report shows that from 2017 to 2018, there were increases in the three most commonly reported STIs --- syphilis, gonorrhea and chlamydia. There were more than 115,000 syphilis

## Farmers Celebrate Passage of Trade Agreement

Following the passage of the United States-Mexico-Canada Agreement by the U.S. Senate, the California Farm Bureau Federation said the trade pact will help farmers, ranchers and agricultural businesses throughout the state.

“Passage of the USMCA has been a top priority for Farm Bureau and other farm organizations, and we’re excited to have achieved the milestone of congressional passage,” CFBF President Jamie Johansson said. “Today’s Senate vote brings us closer to realizing the agreement’s benefits to California.”

President Trump’s signature on the USMCA will finalize its ratification by the United States. Mexico has also ratified the agreement. The Canadian House of Commons is expected to vote on the pact in coming weeks.

“We’re grateful to the many California farmers and ranchers who contacted their elected representatives on behalf of USMCA, and we thank Senator Feinstein for her vote to approve the agreement,” Johansson said. “The USMCA will further open markets for California-grown food and agricultural products, and will

benefit the tens of thousands of Californians whose jobs rely on farm exports to Canada and Mexico.

“This has been a big week for trade developments, considering the signing of a Phase 1 agreement between the U.S. and China,” Johansson said. “We’re hopeful the Phase 1 agreement will ultimately lead to further easing of trade between the two nations, and that the United States will continue to pursue trade policies that open markets for high-quality California farm products.”

*Celebrated a Record Year*

Yuba-Sutter Toys for Tots Served 1,985 Children in Yuba-Sutter During December 2019 was an incredible time for Yuba-Sutter Toys for Tots as they celebrated a record year.

assistance from Yuba-Sutter Salvation Army, free family distribution and sorting facilities through Hilber’s Inc. and Reason Farms, and various free services from Grocery Outlet!

Toys for Tots also received more than \$15,000 in gifts at no charge from the Toys for Tots Foundation!

“Donations to Toys for Tots is a VERY pure form of giving as funds received are turned into gifts for families in need of providing Christmas for their youngsters,” Harlan said.

## FEDs Lower Rates

The U.S took out a bad guy by the name of Soleimani last week. Ramifications to the markets are yet to seen but it's beginning to look like a non-event. Defense stocks popped on the news along with gold and oil. Since the bad guy is in (or was) the Middle East, the rise in these stock sectors is not surprising.

Interest rates are falling once again after a few increases from the FED. First they lower them, then they raise them, now they lower them again. All in the span of a few years. Can't say if the FEDS are playing it by ear but you have to wonder if so, what tune are they listening to. The general consensus now is rates will likely stay where they are at least for the time being. One has to wonder why the up and down movement in rates. Interest rates have a monumental effect on markets, and to be jerking them around like this doesn't make for the most stable en-

vironment for investing in my opinion. Ten year notes pay about 2% right now. Ditto with the rate of inflation so says the Bureau of Labors Statistics. (BLS).

Boeing fired its CEO in response to the ongoing problems with its Max jet liner diving twice into the earth seemingly with a mind of its own, killing all aboard in the two well published crashes. A software issue with what is called its MCAS system is to blame. No doubt Boeing will fix the problem eventually. Either that or scrap the plane all together, although with the billions and billions already invested this analyst doubts the Max will go the way of junk heap.

Unemployment sits at historic lows and the stock markets continue to hit new highs. Housing vacancy is at a 35 year low, meaning the demand for housing remains robust. Savings accounts of the consumer is running around 8%, a high figure to be sure, and household debt is the lowest in 2 generations. Those statistics from "The Rant" by analyst Dave Ogilvy.

That does it for this week's Money Matters.



## New Reclamation District 784 General Manager

Following the December retirement of Steve Fordice, Patrick Meagher was selected to serve as the new General Manager for Reclamation District 784, which is located in Yuba County. Mr. Meagher has worked for RD 784 since 2011, serving as the District's Field Superintendent. Mr. Fordice retired December 31 after serving in the position for 12 years.

After graduating from Yuba City High School, Mr. Meagher immediately entered the construction trades where he worked for local area builders until becoming a licensed contractor himself. He then went on working for Sacramento area commercial and industrial contractors serving in various leadership roles over the years until returning to the Yuba/Sutter area to work for a local developer for nearly 10 years as a superintendent, project manager, and estimator.

During his tenure as Superintendent with RD 784, he attended annual DWR Flood Fight Training classes, the Yuba County Supervisory Development Academy, and the ICS/NIMS/SEMS emergency training course at Yuba College. In further



preparation to take on his predecessor's position, he also attended the Special District Leadership Academy, Financial Management For Special Districts, and General Manager's Leadership Summit, all through the California Special District Association continuing education program.

RD 784 was established in May 1908, and operates under the authority of the State

of California's Central Valley Flood Protection Board and the Department of Water Resources. RD 784 operates and maintains over 33 miles of levees, more than 60 miles of internal drainage canals, and ten pumping stations.

Meagher started his new position on January 1 and will oversee all day to day operations within the district.

## Food and Farm News

### Almond farmers expand bee health actions

In advance of the annual pollination season, almond farmers and processors have announced a Pollinator Protection Plan to protect honeybees. The Almond Board of California said Tuesday it will enhance its ongoing work to benefit bees. Plans include expanding the number of farmers who provide pollinator habitat, funding five new studies by bee experts, and holding on-farm workshops on best management practices for bee health.

### Field-crop production decreases

Production of most California-grown field and grain crops declined during 2019, according to

an annual report from the U.S. Department of Agriculture. Farmers sold less rice, cotton, wheat, corn and most other field crops last year. Production of hay rose slightly, and marketing of California potatoes and barley also bucked the general trend by increasing.

### Protein appears to control plant growth

Discovery of a protein that controls plant growth could ultimately help crops withstand challenging conditions. Researchers at the University of California, Riverside, found the protein while studying plant cells. They say the protein, called IRK, sends a signal to root cells on when not to divide. Knowing how to control the protein might

allow plants to grow under conditions they might not otherwise.

### County Farm Bureaus earn national recognition

Three county Farm Bureaus from California have been chosen to highlight outstanding activities during the American Farm Bureau Federation convention next week in Austin, Texas. The Humboldt County Farm Bureau created a program to encourage high school students to pursue agricultural careers. The Sacramento County Farm Bureau created its own mobile app. The San Joaquin Farm Bureau Federation showed adults how to prepare healthy meals with local products.

A drilling company has set up operations seven miles under the oceans surface. What exactly they are drilling for isn't clear, however they do not find what they expect to find. The crew must find a way to safety as the structural integrity of the complex is compromised unexpectedly.

Underwater, earns one out of five, Cool Diving Suit Monkeys. The story has a cold start as the characters are immediately thrown into urgent survival mode. Oddly the crew seems to lose their sense of urgency at random times throughout the story, while the danger of eminent demise remains ever present. The acting is just as good as the director allows. The characters don't have much time to develop a solid foundation that the viewers can care about. The editing of the film is odd and choppy.



### Who Was The Constitution Written For?

"The Constitution," gives Americans the idea that the government was created for them, to protect their person, property, and liberty. My question is, "Were the founding-fathers protecting you-the-people, or were they more interested in protecting themselves from you?"

Will the answer, shine light on: The political polarization of working/non-working people, that pits Conservatives against Liberals? Or is that a smoke-screen, the real battle being between the "Wealthy Class" verses the "Working/Nonworking Class?" And finally, is "James Madison's Federalist Paper No. 10," written in 1887, the beacon-of-light that answers these questions?

Federalist Papers No. 10, stresses James Madison's fear of factions, the common-people's constitutional right to form them; and the affects those factions have on aristocrats and their power to govern. He wrote, "By a faction, I understand a number of citizens, whether amounting to a majority or a minority of the whole, who are united and actuated by some common impulse of passion, or of interest, ad-versed to the rights of other citizens, or to the permanent and aggregate interests of the community."

Madison's concern was with the people's constitutional power to organize, advocate, and vote. Their superior numbers, and the vote gave them more power than the wealth of the aristocrats. They could vote them out of power and then take their wealth, "... measures are too often decided, not according to the rules of justice and the rights of the minor party, but by the superior force of an interested and over-bearing majority." He also wrote. "A rage for paper money, for an abolition of debts, for an equal division of property, or for any other improper or wicked project ..." Listing fears where factions could take advantage

of the rich and he characterized advocating against their interests as improper, even wicked.

Madison categorized the players in these factions into classes: property owners, non-property owners, creditors, and debtors, and he worried about the divisiveness of the wealth gap, "But the most common and durable source of factions has been the various and unequal distribution of property. Those who hold and those who are without property have ever formed distinct interests in society."

He then writes about the different purposes of factions, their economic classes, and pondered what to do with them, "There are two methods of curing the mischiefs of faction: the one, by removing its causes; the other, by controlling its effects." Madison settled on controlling, "... the causes of faction cannot be removed, and that relief is only to be sought in the means of controlling its effects."

To control, Madison outlined the two party political system to divide and animosity for polarizing the people, as a remedy to protect aristocrats power and wealth, "...divided mankind into parties, inflamed them with mutual animosity, and rendered them much more disposed to vex and oppress each other than to co-operate for their common good."

The divide-and-conquer technique outlined in Federalist Papers No. 10 is still enforced today; it has kept the working/non-working people polarized, powerless, and controlled throughout history. As time passes issues change to where today the moral issues are: Abortion, Immigration, Gun-Control, and LGBTQ Rights that keep you-the-people divided and impotent.

It's noteworthy to say that the number of people who are directly-physically effected by these moral issues in their personal-life

is small, and to most the affect on your everyday-life is minor to nonexistent. Whereas, the emotional-impact of you being upset or morally-outraged by the propagandized-distortions these issues have undergone, inciting strong reactions within you, can deeply polarize large portions of the population.

### Foolish California Bonds Put Taxpayers at Risk

If you had just won the lottery, would that be a good time to go further into debt or would it be smarter to pay down the debt you already have?

Most Californians would like very much to be debt-free, and the thought of being able to pay off their mortgage, car loan and student debt is surely attractive.

In some respects, thanks to the forced generosity of California taxpayers, California has won the lottery.

Our highest-in-the-nation tax burden has left our treasury full with billions in surplus revenue.

One would think that with all that revenue, our elected leadership would be a little more circumspect in taking on new debt or at least manage the debt we have more effectively. But this is California.

The Golden State is awash in debt consisting mostly of unfunded pension obligations. Unfortunately, our leadership continues to press on the accelerator in taking on new debt.

Just a few weeks ago, this column criticized a big \$15 billion school bond that will appear on the upcoming March ballot, ironically designated as "Proposition 13."

As we pointed out,

there are two big concerns with this proposition.

First is that it would borrow \$15 billion from Wall Street and then make taxpayers pay it back plus 80 percent in total interest costs. That's an additional \$12 billion we'll be forced to pay.

Second, and by far a more serious problem, a hidden provision of the bond proposal would increase the current caps on local school bonds. Lifting the caps puts homeowners directly at risk of much higher property taxes.

But as bad as the "new" Prop. 13 is, it almost looks responsible compared to what is currently being floated in Sacramento.

Senate Bill 45 is a "climate change" bond ostensibly for the purpose of addressing various climate and environmental dangers in California. The bill is a holdover from last year, when it failed to clear the state Senate.

Even a cursory review of SB45 suggests that it is little more than a grab-bag of proposals onto which the proponents have slapped the label "climate change" in the hopes getting support both within the Legislature and with the public.

As currently drafted, the \$4.2 billion in bond proceeds would be split among several purposes including \$1.6 billion going to wildfire and drought prevention and \$1.2 billion funding safe drinking water initiatives.

Granted, some of the

purposes for which SB45 would provide funding are worthwhile. There is no doubt that water quality issues, especially in the Central Valley, are an immediate and pressing problem. But that problem can be resolved with existing revenues from the general fund without going further into debt.

Finally, this bond violates all the criteria for responsible bond financing, which includes the constitutional requirement that a bond should be issued only for a "single object or work."

That single object or work must have statewide significance if payment involves a general obligation bond that all taxpayers are responsible to repay. Moreover, the "single object or work" should have a useful life that extends beyond the term of the debt repayment.

General obligation bonds should not be encouraged when ongoing state revenues are strong and proper fiscal restraint is not being exercised in the budget process.

If voters approve this policy, there will be no incentive for necessary reforms and fiscal discipline.

Like problem gamblers, Sacramento politicians seem addicted to debt no matter what the circumstances.

But we should reject their gambling with California's future financial security.

### Yuba College Wants More Money

Yuba Community College District wants more of our tax dollars – this time \$228.4 Million! They have a lot of nerve since we are currently paying on four Yuba College School Bonds as follows.

Series A - \$29,504,047 - Ends 8/1/2031 - 11 years remaining  
Series B - \$65,492,278 - Ends 8/1/2046 - 26 years remaining  
Series C - \$34,935,795 - Ends 8/1/2050 - 30 years remaining  
Series D - \$26,500,000 - Ends 8/1/2039 - 19 years remaining

In reviewing the 31-item project list for Measure C, it is extremely general in nature citing such things as "heating, ventilation and cooling systems, irrigation piping systems, maintenance issues, electrical systems and wiring, automotive, plumbing, sewer and drainage systems, decaying walls, old ceiling tiles and flooring, leaky roofs" and many others. The project list is very similar to the list provided for Measure Q approved by the voters in 2016. The majority of the items listed should have been taken care of under the previous bond and on-going routine maintenance. Why weren't they?

Perhaps it is because the District has a \$52 million pension debt, a \$48 million unfunded retiree healthcare debt, is paying \$310,000 a year in rent for an Administration office in downtown Yuba City--which should be located on the college campus--and pays top administrators \$200,000 to \$300,000 a year in salaries and benefits.

The college district includes all of Yuba, Sutter and Colusa counties and portions of Butte, Glenn, Lake, Placer and Yolo counties.

Those of you who rent should be concerned – if property taxes go up, your rent will probably go up to cover the increase.

If approved, the total cost is estimated to be \$412 million.

## ‘Kill Switch’ included in Senate Trail

As the impeachment trial gets underway this week in the US Senate, there’s a lot of focus on how long the process may play out, with Sen. Lindsey Graham letting it be known Sunday that the likelihood of an immediate dismissal is pretty much out.

Senate Majority Leader Mitch McConnell, R-Ky., who has a reputation for being ruthless in his control of the upper chamber, has previously signaled his intentions to make short work of the impeachment trial.

To that effect, McConnell is close to finalizing a rule that would allow President Trump’s team to move to dismiss the articles of impeachment quickly after some evidence has been presented,

The move is seen as a de facto “safety valve” in the event Democrats try to drag out the trial for weeks. In effect, McConnell does not intend to allow Rep. Adam Schiff and his merry band of co-conspirators to hijack proceedings.

At the center of the issue is the matter of whether to allow new witnesses or not, and Sen. Ted Cruz, R-Texas, appeared on Fox News’ “Sunday Morning Futures” to say the Senate trial could extend “to six to eight weeks or even longer”

if additional witnesses are allowed.

“I think it’s certainly possible that this trial could last one to two weeks. On the other hand, if the Senate makes the decision to go down the road of additional witnesses, that could extend it to six to eight weeks or even longer,” Cruz said.

Cruz is one of a small number of GOP senators open to allowing witnesses, which Democrats want to do. Others include Lisa Murkowski, R-Alaska; Mitt Romney, R-Utah; and Susan Collins, R-Maine.

Democrats need just four GOP defections to succeed.

Graham was adamant that he has no interest in a long, drawn out trial.

“I want this trial to get over as quick as possible,” he said. “I want the people of the United States to pick the next president, not a court of impeachment.”

A long trial could impact the presidential aspirations of Sens. Bernie Sanders, I-Vt., and Elizabeth Warren, D-Mass., who would get pulled off the campaign trail.

McConnell, who reportedly has no obligation to publicize his final resolution setting the parameters of the impeachment trial until

Tuesday, has support for including the “kill switch.”

Sen. Josh Hawley, R-Mo., told Axios he would be “very, very surprised” if McConnell didn’t include it.

“I am familiar with the resolution as it stood a day or two ago,” Hawley stated. “My understanding is that the resolution will give the president’s team the option to either move to judgment or to move to dismiss at a meaningful time.”

Hawley shared online that Trump “deserves the right during Senate trial to ask for a verdict or move to dismiss — otherwise trial will become endless circus run by Adam Schiff.”

While Cruz proposed an idea he called “witness reciprocity,” where the defense gets a witness for each one the prosecution gets, Harvard Law professor Alan Dershowitz is confident that he will make the whole matter a moot point.

Alan Dershowitz: “If my argument succeeds, there’s no need for witnesses.”

Dershowitz, a member of President Trump’s legal team, is set to present an argument against impeachment, saying the House charges don’t include impeachable offenses and the Senate should vote “to acquit, or dismiss.”

To qualify for the ballot, 1.5 million valid signatures must be submitted to the California Secretary of State by Feb. 13. Don’t wait until the last minute, if you turn them in locally there still needs to be time to get to the Secretary of State.

The goal is to collect two million signatures since the organizers think the signatures will be subject to close scrutiny and as with any ballot proposition, they expect some signatures to be found invalid.

If you signed a petition that had more than three spaces for signatures you must sign another petition that has only three signatures per page. Otherwise your signature will not count.

cases. The number of primary and secondary syphilis cases – the most infectious stages of syphilis – increased 14 percent to more than 35,000 cases, the highest number reported since 1991. Among newborns, syphilis cases in-

creased 40 percent to more than 1,300 cases. Gonorrhea increased 5 percent to more than 580,000 cases – also the highest number reported since 1991. Chlamydia increased 3 percent to more than 1.7 million cases – the most ever reported to the Center

for Disease Control. Antibiotics can cure syphilis, gonorrhea, and chlamydia. However, left untreated, STIs can be transmitted to others and produce dangerous consequences such as infertility, ectopic pregnancy, increased HIV risk and death. Congenital syphilis – syphilis passed from a mother to her baby during pregnancy – can lead to miscarriage, stillbirth, newborn death, and severe lifelong physical and neurological problems.

An estimated 38,000 new HIV infections occur in the United States each year. HIV diagnoses are not evenly distributed across states and regions. More than 50 percent of new diagnoses occurred in just 48 counties (of 3,142); Washington, DC; and San Juan, Puerto Rico in 2016 and 2017.

California had the most counties, with 8 leading the way in new cases – Alameda, Los Angeles, Orange, Riverside, Sacramento, San Bernardino, San Diego, and San Francisco.

America has an estimated 1.1 million people infected with HIV and is spending \$20 billion annually to treat and stop the spread of the disease.

French-Canadian airline employee Gaetan Dugas, was once vilified for spreading HIV to North America. Dugas told researchers that he

had 750 sexual partners the previous three years before being diagnosed with HIV. Dugas recalled the names of just 72 partners.

That wasn't an unusual number of sexual hook-ups for members of the homosexual community. Researchers said 65 percent of men in a Los Angeles cluster study at the time reported having more than 1,000 sexual partners in their lifetimes. Most of

that sexual activity was with anonymous people thereby prohibiting HIV patients from giving medical officials any names for treatment.

No amount of effective medicine and care will curb STIs where people's habits spread the disease and their ignorance and lack of transparency inhibits treatment. HIV is believed to have come from diseased monkeys in Leopoldville (Republic of the Congo) during the

1970s. The other three STIs have been noted throughout history.

California's Senate Bill 859 is the latest attempt to pour more resources into education, treatment and care to stop this epidemic in spite of the tendency of the at-risk population to ignore facts and caution.
