Deadline Approaching for Filing Fire Claims in PG&E Chapter 11 Case

Fire Claimant Proof of Claim Forms Need to be Received Before the Deadline of December 31, 2019 at 5:00 PM (Pacific Time)

San Francisco, Ca

PG&E Corporation and Pacific Gas and Electric Company (together "PG&E") are sharing an important reminder that the Bankruptcy Court-approved deadline for unfiled, non-governmental fire claimants to file claims against PG&E is December 31, 2019, at 5:00 p.m. (Pacific Time). The deadline for filing claims is known as the Bar Date.

Claims related to the

Northern California fires that arose prior to January 29, 2019, must be filed in PG&E's Chapter 11 cases and received no later than the deadline of December 31, 2019, at 5:00 p.m. (Pacific Time). If any person or entity believes money is owed to them by PG&E for loss or injury resulting from the Northern California fires that arose before PG&E filed for Chapter 11 on January 29, 2019, then

they must file a Proof of Claim before the Bar Date.

If those who are affected do not submit a Proof of Claim by this extended deadline, they may be barred from filing a claim against PG&E and give up rights to any payment or other compensation.



Impeachment (For the Children) **A Political Action Not Based on Due Process**

Impeachment is the process by which a legislative body levels charges (accusations) against a government official. Impeachment does not in itself remove the official definitively from office: it is similar to an indictment in criminal law, and thus it is essentially the statement of charges or accusations against the official. (A political action not based on our law of due process).

Once an individual is impeached, (by a majority of the House of Representatives vote on agreement of the accusations) they must then face the possibility of conviction on the charges or accusations by a legislative vote, which is separate from the impeachment, but flows from it, and a judgment which convicts the official on the articles of impeachment entails

the official's definitive removal from office. (A political action by a majority vote of the Senate, not based on the law of due process).

Because impeachment

and conviction of officials involve an overturning of the normal constitutional procedures by which individuals achieve high office (election, ratification, or appointment) and because it generally requires a supermajority, they are usually reserved for those deemed to have committed serious abuses of their office. In the United States, for example, impeachment at the federal level is limited to those who may have committed "Treason, Bribery, or other high crimes and misdemeanors".

Article One of the **United States Constitution** gives the House of Representatives the sole power of impeachment and the Senate the sole power to try impeachments of officers of the U.S. federal government.

Impeachment is only the first of two stages, and conviction during the second stage requires "the concurrence of two thirds of the members present".

Although the subject of the charge is criminal action, it does not constitute a criminal trial; the only question under consideration is the removal of the individual from office, and the possibilities of a subsequent vote preventing the removed official from ever again holding political office in the jurisdiction where they were removed.

As of this writing the Speaker of the House is refusing to forward the Articles of Impeachment to the Senate, the next step in impeachment. The Senate could reject the Articles or begin a due process to determine if the Articles are legitimate or meet the standard of impeachment rising to Treason, Bribery, or other crimes and misdemeanors. The Senate does not have to, but could call witnesses to refute the accusations: this side of the story has not been told yet.

A majority of Democrats in the House of Representatives said they voted for impeachment "for the children."

When Liberals can't solve a problem they say. It's the "New Normal."

When they pass legislation that cannot be defended they say, "We need to do it for the children."

Protecting Trees from Bark Beetles

Sixty years ago, Boyce Thompson Institute for Plant Research for whom I worked was doing experiments on Ponderosa pines in Crystal Bay Nevada where Incline Village is now located. Before we began there was a meeting of private landowners, the US forest Service, forestry professors and forest entomologists from Germany, Berkeley, Humboldt State College and Oregon State University at Corvallis. The gist of the information conveyed to the people gathered there was drastic thinning was required of the second growth forest that had sprung up after the area had been literally clear cut for timbers for the Comstock lode at Virginia City Nevada. The sandy soil didn't have the water retention required for such a forest.

The thinning never occurred and, in a few years, a minor infestation of the mountain pine beetle attacking the Ponderosa pine became almost a total removal of Ponderosa pine from the Tahoe basin.

Our crew was taking oleoresin (pitch or resin) exudation pressures of the Ponderosa pines.

Before dawn the resin pressures would be above 100 psi. But soon as the sun rays hit the pine needles the resin pressures would drop often to zero. In order to get enough CO2 for photosynthesis the stomata had to open wide, but this led to the transpiration of much needed water. And the soil didn't have enough water to replace the water lost to transpiration. When this happened the resin pressure dropped as water is a necessary ingredient to maintain resin pressure. At over six thousand feet elevation the Tahoe basin has thin air with low CO2 and insufficient water in the soil for thick healthy forests. So, the trees were in CO2 and water starvation. High resin pressure is the trees natural defense against bark beetle attack. When bark beetle populations get high even healthy trees with high resin pressures are susceptible to beetle attack. It is called a mass attack and is like turning on hundreds of water faucets in a home at the same time with the pressure dropping to zero. The tree may be able to flood out a few attacks but not hundreds.

Taking Biochemistry at UC Davis I came to understand the miracle of photosynthesis and the vast amount of energy it removes from the environment during the conversion

of light energy, CO2 and water into glucose and oxygen. Increasing the amount of CO2 in our atmosphere increases the rate of photosynthesis taking more energy out of the atmosphere causing most species of plants to grow faster and letting them encroach on drier regions as they don't have to open their stomates as wide reducing transpiration. To see the effect of photosynthesis put your hand on cement on a hot summer day and it will burn, then put your hand on a lawn and it will be cool. And we haven't discussed the vast amount of photosynthesis that takes place in our oceans.

Most of the CO2 present in our atmosphere and oceans millions of years ago is today locked up in rocks such as limestone, dolomite and other rock assemblages.

There have been ice ages where the CO2 concentrations

in our atmosphere were much higher than it is today, as determined from ice cores from Antarctica and Greenland.

So, the question is does increasing CO2 lower the temperature offsetting its greenhouse effect?

sexual slur to a male student. A week later, long time TEM Principal Chris Meyers was removed from his position after returning a conference. from Vice Principal Steve had inter-Rebozzi viewed staff members in Meyers' absence leading to Meyers' reassignment to teach at Carden School and Rebozzi taking his place at TEM.

Last week, TEM teacher Nicolo Orozco emailed a copy of a letter to more than 200 Yuba County Office of Education (YCOE) employees that he wrote to YCOE Superintendent Francisco Reveles.

The letter indicated first vear employee Orozco had also been dismissed and Orozco was asking Reveles if he was fired in retaliation for reporting an unsafe environment for employees and child abuse at TEM. Orozco had reported both the Sylvester White incident and also inappropriate touching of students by teacher Jim Whiteaker.

Orozco indicated that Whiteaker slapped students on the butt and put his hands on their shoulders and neck area. Whiteaker was hired by YCOE after resigning from Yuba

Committee action sets up House vote on trade pact

With the House of Representatives set to vote this week on the U.S.-Mexico-Canada trade agreement, farm groups say they welcome progress on the pact. The House Ways Means Committee voted Tuesday to send the agreement to the full House. The Senate will likely act on it next year. Farm organizations say the agreement will improve the flow of agricultural trade in North America, which supports jobs in rural and urban areas alike.

Almond sales remain strong to export customers

New advertising and marketing programs in different countries have

helped almond marketexpand exports despite retaliatory tariffs in China and other countries. At an annual conference, people in the almond business said overall export sales have risen even though sales to China fell by about one quarter. In all, California almonds are sold in more than 100 overwhelmingly a family countries, with exports to other nations compensating for the drop in Chinese purchases.

U.S. will import less meat next year

and New Zealand will contribute to reduced meat imports in the U.S. next year. Most beef and lamb imports come from the two nations, and the U.S. Agriculture Department predicts a second straight year of declines in 2020. Pork

imports will decrease due to record U.S. production and strong demand in Asian nations suffering outbreaks of swine flu. Imports represent about 8% of U.S. red meat consumption.

Families dominate nation's farm ownership

Farming remains business, according to an annual government report. The report says 98% of farms are family farms of varving sizes. accounting for 88% of farm production. Many Drought in Australia operators of small and mid-sized family farms rely on off-farm work to supplement their agricultural income. The report says more than 70% of farms receive no farm-related government payments.

The investigation remains active and ongoing at this time.



New Round of DMV 'Motor Voter' **Errors Reported**

One of Gavin Newsom's first acts after taking office as governor in January was to create a "DMV Reinvention Strike Team" to improve the performance of the state Department of Motor Vehicles.

This came after one of the worst years a state agency has had in recent history. In August 2018, CalWatchdog and many other news outlets reported that wait times were nearly 50 percent longer at DMV offices than the previous summer. The problem was blamed on a heavy increase in visits caused by the federal 2005 Real ID Act. It requires Californians to have either passports or new federal ID cards before they can take commercial flights starting in October 2020. The DMV is the agency that issues the Real IDs. A month later, another

scandal emerged, with thousands of thousands of voters reporting errors in their political party affiliation due to mistakes made in the DMV's new "motor voter" automatic registration program, which began in April 2018. An audit released in August of this year found the problem was far worse than initially believed, with more than a quarter-million errors in

registration in the first five

months of the program - 83,684 duplicate voter registrations and 171,145 DMV records with inconsistencies on party membership.

Newsom's "strike team" issued its report in July on what it had done to fix the agency and said internal data showed a reduction in wait teams of 58 minutes over the previous summer. Two weeks ago, the DMV issued a statement saying that wait times had continued to decline and averaged 38 minutes in September.

But now the DMV's other 2018 problem has re-emerged with reports in Northern California of pervasive errors in motor voter registrations, prompting Republican lawmakers to renew their call to put the program on hold until its flaws are comprehensively fixed.

At least 600 complaints so far;

number could soar "At least 600 Californians, including lifelong Republicans and Democrats, have had their voter registration unexpectedly changed, and several county elections officials are pinning much of the blame on the state's Department of Motor Vehicles," the Sacramento Bee reported. The daugh-

ter of California Senate Republican Leader Shannon Grove of Bakersfield, who had recently used a Sacramento County DMV office, was among those affected. Grove is a leading critic of motor voter.

Sacramento CBS 13's news team reported at least 300 apparent complaints in Santa Clara County, nearly 200 in Sacramento County and at least 100 in Shasta County.

Reports noted that it's possible that some of the mistakes were made by voters themselves not used to election services at DMV and that some voters may have misremembered what party status they had chosen previously. But as CBS 13 reported, problems appeared to be turning up in every county as soon as registrars began sending out voter notifications related to the March primary. With El Dorado County sending out notifications last Friday and dozens of counties doing so in coming weeks, the dimensions of the problem could be far bigger than initially assumed - just like last

Oregon, which introduced its version of motor voter in January 2016, has had far fewer problems.
