## Charlie McNiff

**1934-2020**

### ***A Full Life***

**Charles “Charlie” Leon McNiff was born on June 27, 1934 in Utica, Nebraska and passed away in Marysville on January 6, 2020**

Charlie is survived by Pat McNiff, mother of their five children: Katherine Everett from San Jose, Christine McNiff, (Steve Sheeran) Longmont, Co, Annette Martinez (Ernie) Santa Maria, Ca., Kevin McNiff Green Bay WI., Tim McNiff, Santa Maria and close friend Sharon Moffett, as well as twelve grandchildren, twenty-one great grandchildren and one great, great, grandchild.

An athlete, Charlie lettered in three sports (football, baseball, and track) at Gridley High School from 1948 to 1950. He then transferred to Marysville High and lettered in those sports there too.



*Charlie was very proud of his tour on the USS Renshaw and wrote a story in the Territorial Dispatch about his memories of Nuclear Bomb Tests.*

From 1951-1956, he served in the Navy on a destroyer, the USS Renshaw, during Operation Castle. Operation Castle Bravo remains to this day, the largest detonation ever carried out anywhere by the United States, and the fifth largest H-bomb detonation in the world. The ship Charlie was on was 20 miles away when the bomb detonated. Charlie played on his squadron's all-star softball team as a catcher.

After the Navy, Charlie went to Yuba College and later earned a full ride scholarship to Fresno State University which was the top baseball school in the country.

In 1958, he set a Yuba College record in the 220-yard dash (:21.5) which stood until 1982, and in the 440-yard dash (:47.7) which still stands 43 years later. In 1959, he broke the San Jose State 440 record (:47.2) at the Modesto Relays, this was the tenth fastest in the world that year.

In 2001 Charlie was inducted into the Yuba College Athletic Hall of Fame.

Charlie worked for the Appeal Democrat Newspaper as a sportswriter and also sold advertising. In 1984 Charlie founded the Territorial Dispatch Newspaper in Meadow Vista, California. He moved the paper to Auburn Ca. and eventually to Marysville, Ca. He sold the paper in 2001 but continued to write articles in his “Think About It” column until January 1, 2020. Charlie had a sense of humor and enjoyed wearing his trench coat and hat as an investigative reporter.

In the early 70's Charlie was an announcer for the stock car races in Marysville at the Triple M Raceway which was owned by his sister Delores Francis and her husband Cy Francis. He created the Sierra Mesa National Raceway, the first paved oval race track on the west coast off Highway 20 in Browns Valley.

In a recent interview by his granddaughter, Sarah Snyder, Charlie said, "If you believe in something hard enough, and passionately enough, it can happen."

He wants to remind his high school graduating class that he is proud to have lived through over a third of our nation's history.

There will be a "Celebration of Life" to be announced at a later date.

As we pulled out from the marina the sun was peeking over the sierras and there was a chill in the air. We lived by the Yuba River and the Dredger Ponds and it was always a special day when Dad and I walked over to our favorite pond to fish for black bass, catfish and sun perch. The "fish fry" that evening was

always delicious with homemade biscuits, hand churned butter and fresh vegetables from the garden.

I wish my kids and my grandchildren could have seen and lived that time. It certainly was the way to learn about the outdoors and the food you could grow and the fish you could catch instead of a weekly trip to the local supermarket.




McCoy retired Dec. 13 after serving in the position for two years. Administrative Services manages the Yuba County Airport, oversees buildings, maintenance and custodial staff for all facilities, and handles purchasing and contracts for County departments. Bains will be overseeing three major Administrative Services projects, including the \$20 million Yuba County Jail expansion project; the \$20 million Tri-County Juvenile Rehabilitation Hall project; and the \$1.8 million taxiway project at the Yuba County Airport. "Perminder is the right person to continue the excellent work of Administrative Services," Yuba County Administrator Robert Bendorf said. "He has demonstrated great leadership skills in his previous role and we are excited to now have him lead an entire department." Bains started in his new role Jan. 1.

## Local Farmers to Fund All Wheatland High School FFA Trip Costs

Wheatland, Ca.

The board of directors of the new Yuba River Endowment voted unanimously to present the Wheatland High School FFA program with \$15,000 to cover all out-of-pocket expenses for FFA students to attend all Field Day and State competitions for the current school year.

The Yuba River Endowment is a non-profit organization created by Yuba County farmers to benefit Yuba County residents. Last month the Endowment presented Marysville High School FFA with a similar award. The funds for Wheatland will cover all transportation costs, hotel and registration fees for 21 scheduled trips, helping approximately 230 students this year.

“FFA at Wheatland High School is a vital part of our ag program, but we are not able to cover out-of-pocket expenses for students to attend competitions,” said Wheatland High School Principal, Nicole Newman. “The Yuba River Endowment funding will allow all of our students who qualify for FFA events to attend those events, and any funds raised can now go towards new projects and infrastructure to benefit the students.”

The Yuba River Endowment was established by a select group of Yuba County farmers who have a right to water that flows on the Yuba River. In a truly win-win situation, the farmers’ water is used to provide the required flow levels to protect endangered fishes on the Yuba River, then once past this critical point, the water can be sold to drought-stricken areas of the state.

Proceeds from these transfers provide the funding for the Yuba River Endowment, allow these farmers to expand their agricultural operations and create jobs in Yuba County. Through generations of conservation, cooperation, infrastructure investment and groundwater recharge, Yuba County is a model for

water management in California.

The Endowment was created to give back to the community, and provide organizational and educational grants to improve the quality of life in Yuba County.

“Our motto for the Endowment is ‘Local Farmers Giving Back’,” said local farmer and Yuba River Endowment President, Al Lassaga. “Our board is made up of representatives from seven different Yuba County regions,

from Browns Valley to Wheatland. Investing our money back

into our community, and specifically into agricultural education and our future farmers, just makes sense. We want to make sure agriculture stays strong in Yuba County for generations to come.”

Yuba River Endowment board members will award the funds during the upcoming Wheatland High School FFA lunch meeting on January 22nd.



## Warren and AOC Insert themselves in Lawsuit

Upstart Representative Alexandria Ocasio-Cortez (AOC) and Presidential candidate Senator Elizabeth Warren have sent a letter to Sears' former CEO Eddie Lampert, criticizing him for his efforts to avoid repaying Sears for \$43 million in severance to the retailer's workers. A war of words and accusations between Lampert and the now defunct Sears Holdings has Lampert claiming the pay back to employees is no longer valid. The argument stems from Lampert's acquisition of the beleaguered retailers assets.

Lampert bought Sears assets through an affiliate of his hedge fund ESL. Lampert as its CEO headed up Sears as it spiraled into chapter 11. The original deal, which saved the company from total liquidation, also stated that Lampert would reimburse Sears severance costs for workers who lost their employment in the bankruptcy. Further muddying the waters is the fact Steven Mnuchin, Trumps secretary treasury, was on the board of directors at Sears and now both him and

Lampert are being sued by Sears. Adding more conspiracy to the story is the additional fact that Sears bankrupt pension were taken over by the Pension Benefit Guaranty Corporation (PBGC), an organization that helps administer and settle pension's claims from involvement members. It just also happens to be overseen by Mnuchin, as well as the secretaries of commerce and labor. You can't make this stuff up.

Now that the smoke is clearing, or just starting to clear as the case may be, Lampert and his firm are claiming Sear's part of the deal is suspect and he may not pay the severance pay.

Yes it sounds complicated and it likely is, but my point is not the bankruptcy itself but the camel nose insertions by Warren and AOC, who for all intents and purposes, probably know less about Sears and its acquisition then the lowliest assistant accountant in any one of the number of firms that are handling the Sears mess.

Likely based on more of a political pulpit than an employee related one, although Warren has bankruptcy knowledge by study, AOC probably leans more into the personal experience aspect of the mechanism. Not to say she's filed bankruptcy, she hasn't, but her net worth of only a few thousand (Weeklistandard.com) mostly stemming from a bartending job gives little reason to think she knows much about a corporate bankruptcy such as a size that

is the Sears liquidation. More likely she is exercising her well known talent of riding the political bandwagon and shooting off her now infamous mouth.

The point here being is that both the army of Sears lawyers and accountants along with the Lampert's many CPA's together with the bankruptcy courts will get to the bottom of this and probably get pretty close to if not spot on to the truth and who is possibly screwing who.

That Warren and AOC are joining forces, both of whom recently appeared together in their own version of a propaganda video on the Sears issue, the question should be asked is exactly what, besides more dissent, is their goal here?

Like I said, the armies of lawyers and accountants that are likely to see all the financials will bring their findings to the courts and then the courts will decide. That Warren and AOC are attempting to stir up controversy because one of the people involved is a cabinet member of the current administration is typical of the political maneuvering that is common among those that practice such things.

Warren and AOC can't possibly help the financial forensics. The accountants and lawyers involved would never permit it. What Warren and AOC can do is cause more hate and polarization that many claim has become the cornerstone of their party's strategy. In more common language, they love to stir the brown stuff.

I would like to thank my Editor for your very good and well thought out comments about my article on "Health-care," and for the most part I agree with you. My statement, "ObamaCare is the lesser of two evils" was stated because this healthcare program didn't do what it was supposed to do and to some extent made the problem unmanageable. Any single payer not for profit (MediCareForAll is the only one that has been suggested) will provide better coverage's and be cheaper to "administrate" than all the different healthcare plans now available for profit. The key word here is "administrate" because that's all Corporate Healthcare does. They don't provide any real healthcare services, all they do is "Shuffle Papers And Payments" back and forth between you, your doctor, hospital, and pharmacy. And look at all the profit they make for such simple work. More than doctors, nurses and other "Real Healthcare Providers." And at our ex-

pense, they've rigged it so there's minimal risk, and maximum profit.

I totally agree it would be nice to have "True Competition" between insurance companies. And with all businesses throughout the United States, again. "True Competition" is what "True Capitalism" is all about. Many years ago when we had thousands of banks, thousands of newspapers, radio, television, and cable stations; and thousands of hardware and department stores, thousands of pharmacy's and grocery stores, just to name a few; then we had "True Capitalism" and "True Competition;" but that was yesterday.

Today our capitalist system is becoming or has become an oligopoly, where several giant corporations control the market for each industry. We can thank (blame) Executive Orders from Moderate and Conservative Presidents, Moderate and Conservative Legislators and the Conservative Supreme Court for all of this. By them ignoring our anti-trust (monopoly) laws, they've increased corporate wealth and impoverished you and me.

Instead of having free market competition, "True Capitalism," that sets the "True Value" of a commodity or service; these Giant Corporations now set prices at "What The Market Will Bear." Vote No on Measure C

The Governing Board of the Yuba Community College District on October 10, 2019 voted to place a whopping \$228.4 million bond measure on the March 3 ballot.

A bond measure seeks the permission of voters to borrow money by selling bonds (debt) that must be repaid, with interest (up to 12%), over decades from higher property taxes. At current (low) interest, the total repayment amount would be about double the \$228.4 million.

The total repayment depends upon the interest rate at the time bonds are sold. In this instance, the measure contemplates the sale of millions of dollars in bonds each year. Interest rates may increase greatly and would be paid back for 30 years or more.

This is the third bond measure from this district in the last 14 years. The first was \$190 million in 2006 from Measure J. The second was \$33.6 million in 2016 from Measure Q. The \$33.6 bond was just sold in Oct 2019 and will show up on your 2020 tax bill.

Measure C now proposes to authorize use of the next borrowed money on projects that were supposed to be accomplished under the 2006 and 2016 bond measures.

Instead of identifying just what projects would be funded, this bond measure only pledges to use the money raised for any of a broad range of purposes - guaranteeing virtually nothing. It would give the college district administrators and their board members

vast discretion in spending or squandering the money.

The Yuba College District already has a \$48 million Pension Debt and an Aggregate Debt Service of \$369 million since Nov 2000 Enactment of Prop 39. Adding more debt on top of the debt they already have is not fiscally sound management of the money we have already given them.

If this passes, your grandchildren will still be paying for the debt incurred today. Our children are already burdened with too much debt, let's not add to it or to our grandchildren as yet unborn!

Govt Muscle and Scams

The Yuba County Supervisors think alike. Maybe we could get by with just one representative and save some money. They unanimously put the illegal Measure K 1% sales tax increase on the ballot. Then, they unanimously chose to ignore the free advice of election law attorneys at the Howard Jarvis Taxpayers Association (HJTA) that the Yuba Co measure was not legal.

County Administrator Robert Bendorf said the county was not interested in advice from third parties. However, Bendorf and supervisors had no problem unanimously hiring third-party consultants to scheme voters to promote Measure K while using tax dollars and violating the Constitutional rights of taxpayers.

Then, when HJTA, former Charles Mathews and newspaperman John Mistler contested the legality of Measure K in Yuba County Superior Court Bendorf and supervisors again unanimously used tax dollars to hire "third party" lawyers to defend the flawed ballot measure rather than use their county counsel.

When Judge Stephen Berrier decided in favor of HJTA, Mathews and Mistler, rather than the county accepting the decision, supervisors instead chose to appeal the Berrier decision with taxpayer money. That move costs the taxpayers more than \$10,000 each day plus legal fees until the county gives up the fight. Adding insult to injury, the county gets to keep the tax revenue win or lose. That sounds more like a scheme concocted by Charles Ponzi or Bernie Madoff.

According to Yuba Co spokesperson Russ Brown the County has scooped \$3,480,000 since April 1, 2019 from hard-working citizens. Appeal Democrat writer David Wilson quotes Brown as saying, "That money, which was supposed to enhance the county revenue stream, is being held in trust until the legality of the measure's passage is decided in court."

It has taken years for county officials to admit what Measure K was all about ---"enhance the county revenue stream." Maybe the public safety bait

and switch argument is finally wearing thin.

No mention is made in Wilson's article that the Measure K legal fight is a heads the county wins and tails the taxpayer loses. Thank state legislatures for that unjust outcome. Revenue from taxes eventually found to be illegal becomes a cash cow for government. Anyone get refunds for the illegal state "fire tax?"

If the county loses their appeal of Measure K and quits the fight they keep all the money and then can put another "revenue enhancing" tax scam on the ballot.

Lastly, Yuba County Supervisors have unanimously endorsed Melanie Bendorf for Superior Court Judge. Figures, but it sounds politically incestuous. Melanie is County Administrator Robert Bendorf's wife. Robert Bendorf takes care of the supervisors including advising them that they deserve more money. In turn, the supervisors set the pay for Robert Bendorf. It's a great gig if you can get it.

## CalRecycle Funds Cleanup of Illegal Dumpsites

*Agricultural Properties Littered with Old Furniture, Tires, and Appliances*

Sacramento, Ca. — California communities can restore forty illegal dumpsites into productive agricultural properties thanks to \$299,814 in funds from the California Department of Resources Recycling and Recovery (CalRecycle). The department's Farm and Ranch Solid Waste Cleanup and Abatement Grant Program will support counties' and resource conservation districts' efforts to clean up agricultural sites over-

run with unlawfully discarded appliances, furniture, scrap metal, tires, vehicle parts, and more. "California is committed to helping farms and ranches remove illegally dumped items to promote the economic and environmental health of

the state," said CalRecycle Director Scott Smithline. "The department's cleanup grants help local governments restore properties and improve communities."

CalRecycle's Farm and Ranch Cleanup grant program will provide up to \$1.5 million during the 2019-20 fiscal year to help communities remove illegally dumped solid waste from agricultural properties.

The Sutter County Resource Conservation District plans to use \$49,864 to clear appliances, cement blocks, metal and PVC piping, tires, and other debris from three farming parcels in Sanders and Live Oak. The district plans to erect signage and fence-

ing throughout the combined 380 acres to discourage future unlawful disposal.

Under the farm and ranch grant program, cities, counties, federally recognized Native American Tribes, and resource conservation districts may apply for up to \$200,000 per fiscal year, but no more than \$50,000 per site. Grants are funded through the state's Integrated Waste Management Account, Tire Recycling Management Fund, and Used Oil Recycling Fund.

Since the first grants were awarded in 1997, nearly \$11 million has been distributed to clean up more than 700 project sites.

## Food and Farm News

### Farm groups analyze state water portfolio

The new year began with the Sierra snowpack and California reservoirs at near-average levels, and with release of a California Water Resilience Portfolio by state agencies. The agencies outlined a number of actions intended to improve California water quantity and quality. A California Farm Bureau analyst said the organization appreciated the document's substance and its urgency. Comments on the draft plan will be accepted through early February.

### Senate committee approves trade agreement

A new agreement smoothing trade among the United States, Mexico and Canada moved a step closer to ratification Tuesday, with approval by the Senate Finance Committee. Farm groups welcomed the action, which sends the agreement to the full Senate. The House approved the deal last month. It must also be approved by legislatures in Canada and Mexico. Canada ranks No. 2 in foreign purchases of California farm exports; Mexico ranks fifth.

### Strawberry supplies could set record

Record supplies of California-grown strawberries could reach market between Easter and Independence Day, according to a survey from the California Strawberry Commission. The survey indicates strawberry farmers will plant nearly 4% more acreage this year. That, combined with planting of higher-yielding varieties, should increase strawberry supplies compared to last year, if typical weather patterns hold.

### Avocado crop should be much larger

Expect to see more California-grown avocados on the market. The California Avocado Commission projects a crop of 369 million pounds, up from about 215 million in 2019. Hot temperatures curing crop development reduced California avocado supplies last year, but the commission says it expects a "great" 2020 crop. California farmers harvest avocados all year, with peak volumes anticipated in May, June and July.

As a final assignment in his career, Brian volunteered for and was selected to fly the super-secret spy plane, the SR-71.  
Brian’s phenomenal comeback story from laying near dead in the jungle of Southeast Asia, to flying the worlds’ fastest, highest flying jet, has been the subject of numerous magazine articles and an inspiration to many. After 20 years and 5,000 hours in fighter jets, Brian retired from the Air Force

in 1900. He went on to pursue his writing and photographic interests. In addition to own photo studio in Marysville, he has authored five books on flying for which he did all the writing and photography.
