## Wreaths Across America in Smartsville

In 1918 a great tragedy struck the town of Smartsville when news arrived that Edward (Ned) McGanney had been killed in action in France in the WWI battle of Meuse Argonne.

The McGanney family was, of course, well known in Smartsville and Ned was a popular fellow. His family members were parishioners of the local Catholic Church and requested that a redwood tree be planted on the church grounds in his memory. George Rigby describes the somber 1919 planting ceremony in the book “The Sage of Smartsville” and how the school children placed small handfuls of dirt on the redwood seedling.

That Redwood tree today is huge, and is nearly as prominent an icon of the town as the adjacent former Church of the Immaculate Conception currently under restoration.

So, in the centennial anniversary of the town’s tribute to Ned’s ultimate sacrifice for his country we celebrate “Wreaths Across America” an annual event during the Christmas season where we honor fallen military heroes all across our great country.

Festivities will start at 12:00 noon with lunch to follow. The adjacent church under restoration will be open to visitors. Donations are requested to cover the cost of lunch.

Sally and Charle, by the way,

are descendants of Thomas Mooney, the man who owned the Empire Ranch in the early days of Smartsville and the namesake of Mooney Flat, the small community in Nevada County just east of Smartsville. History buffs may find it interesting to talk to these two sisters who have many family memories and mementos of pioneer Thomas Mooney.

## Voters Never Learn

Liberals have controlled California policies for 50 years. They have an anti-freedom, anti-American agenda. They are line by line implementing a socialist minimalist lifestyle in the state. We can’t use the water, roads and the land. And that’s just the beginning.

All the while, politicians are repeatedly deceiving voters with numerous ballot measures touting more water resources and road improvements. They want neither. They are liars, deceivers, and in another era deserving of a Stalinist purging.

Nearly thirty years ago voters were warned that the transportation infrastructure was crumbling and a new fuel tax was immediately needed because the problem was so acute. A slick political campaign led to voters in 1990 approving Proposition 111, a nine-cents-a-gallon tax increase combined with a 55 percent increase in truck weight fees.

The campaign highlighted many projects to be completed and never even mentioned taxes. After passage the monies were diverted.

In 2017, Senate Bill 1 was passed by the legislature, another massive tax increase – 12 cents per gallon on gasoline, 20 cents per gallon on diesel fuel, and a huge spike in DMV fees. People became angry, attempted a repeal of the tax and recalled freshman Senator Josh Newman (D-Fullerton). So, skittish politicians insisted they were telling the truth, for real this time.

During the Proposition 6 Repeal of the SB 1 taxes politicians and even local public works leaders begged, pled and threatened that no road work would be done if the repeal was successful. And that would lead to people dying on dangerous roads. The claims were bogus. It was another scam. These people are no different than a pusher slinging bad dope. Did they keep their promise? No.

In September 2019, Governor Gavin “Creepy” Newsom signed an executive order redirecting SB 1 gas funds to railway systems and other green projects rather than upgrading roadways. The need given was to stop ‘climate change.’ These people are suffering a mental deficiency.

Widening Hwy 99 was cancelled. Assembly member Jim Patterson, representing the region affected by congested and dangerous Hwy 99 called it a “theft of funds meant to

## Moratorium on Insurance Non-Renewing

Insurance Commissioner Ricardo Lara issued a mandatory one-year moratorium on insurance companies non-renewing policyholders. The Commissioner’s action is the result of Senate Bill 824—authored in 2018 by Commissioner Lara while serving as a State Senator—in order to give temporary relief from non-renewals to residents living near a declared wildfire disaster. This is the first time the Department of Insurance has invoked the new law, which took effect in January.

In June, the Rural County Representatives of California (RCRC) Board of Directors approved a resolution creating a Homeowners Insurance Ad Hoc Committee (Committee). RCRC member counties have been disproportionately impacted by recent homeowners’ insurance cancellations and non-renewals following years of devastating wildfires in California. The Committee is tasked with considering potential solutions for the increase in homeowners’ insurance cancellations and non-renewals in high

fire risk areas. In particular, how county governments can develop programs and measures to encourage greater community-wide access and affordability to homeowners insurance.

The potential solutions include, but are not limited to, introducing additional insurers into rural areas, working with the insurance industry on an insurance risk-reduction model, examining insurance industry risk modeling, re-creating/revising California’s Fair Access to Insurance Requirements Plan (FAIR Plan), and working directly with policy advocates, the California Legislature, and the Department of Insurance to explore other options.

The Committee is tasked with issuing a report of findings no later than the August 2020 Board of Directors meeting.

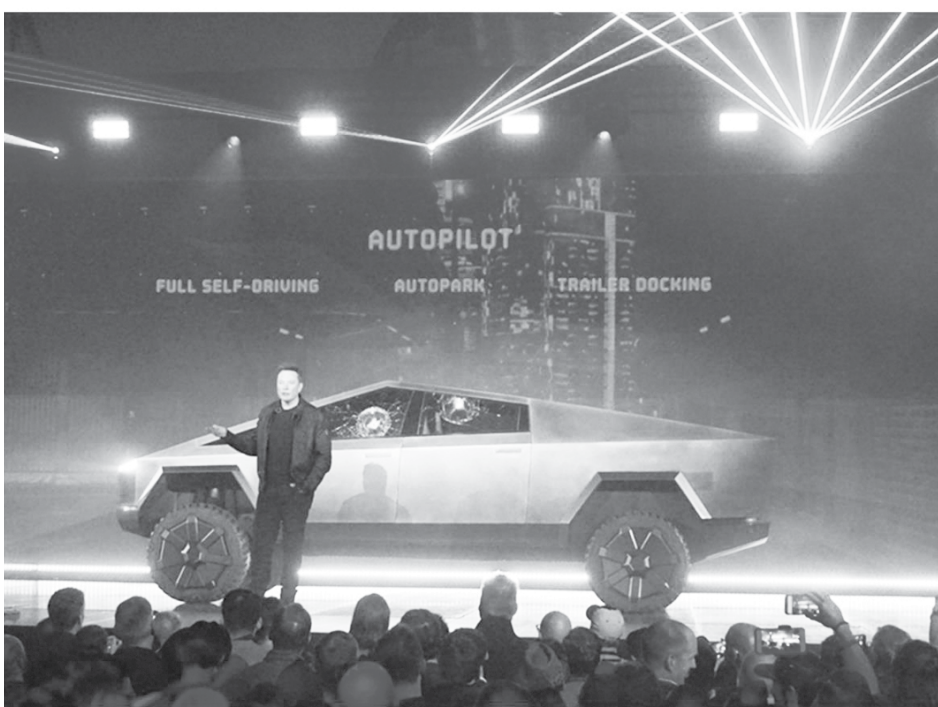

The electric car company TESLA is no stranger to investors. Neither is its maverick owner Elon Musk. Without hashing through its long history, it's safe to say this company pushes a few envelopes in almost everything it does.

From rooftop solar to spaceships, Elon Musk and his companies go big for sure. Not a recommendation to buy or sell mind you any of his companies, TESLA's newest thing-a-machig is the CyberTruck it unveiled last week.

Touted to go from 0-60 in under seven seconds, you have to wonder why anyone would make such a thing and if it really can get up and go like they claim it can. You also have to wonder what would happen to all the stuff in the back as the truck accelerates at this ungodly rate.

Along with bust resistant windows, which by

Those who run the state in regard to hunting and fishing have once again decided to change the regulations on Striped Bass fishing. The overwhelming cries to drop this change was heard loud and clear in 2012 when anglers from all over the state protested in Sacramento. The proposed changes are basically the same they are trying get passed now. The new laws, if passed, would result in smaller and fewer striped bass in California waters. The upcoming meeting will take place in Sacramento at the Natural Resources Building at 1416 Ninth Street starting at 9:30 A.M. If you plan on attending this meeting you must have a valid photo I.D. to be allowing in the building. In a nutshell the DFG wants to remove them from California waters or control their population and reduce their size which would destroy striped bass fishing as we know it.Those who love fishing for stripers must have their objections heard.

Bank fishing at Collins Lake above Marysville has been the ticket for fun at this reservoir. Planted rainbow trout are being caught along every bank using lures, power bait or worms. Get the kids out there

for some fun prior to the Holidays.

Foul weather has not slowed down the trout bite. In fact it just gets better and better between storms. Fish are being taken in streams and reservoirs as well as Lake Tahoe. This goes for natural lakes such as Eagle Lake near Susanville. Reports tell us the bite here is in full swing

and probably the best fishing since the 80's. We remind anglers that this body of water closes the end of December and will not be open to fishing until spring of 2020.

## Campfire Story

The phone rang at 7:20 am on 11.8.18. "I think we've got a fire" my husband said. We had been planning for a fire for a year, just in case. Our plan designated three different locations we would meet at. We still had our go bags on the kitchen counter as we were adding items to them each week.

Things moved so quickly after that phone call. I was working out of town. My husband rushed back home, knocked on all of our neighbor's doors, grabbed our go bags, my parent's wedding picture, our wedding picture, and most importantly, our three dogs.

We had so many blessings that came amidst this horrific tragedy. One of the teachers I work with offered her parents' home to us, they were out of town. The night before we needed to be

out of that home, we had no idea where we would go. That same evening, we received a txt from a dear friend saying another friend had a 5th wheel we could buy from them. My husband gave them a call, they drove 3 hours the next day to deliver it to us. We had our own place... again.

Life in a 5th wheel while dealing with PTSD, plumbing issues, heating issues, no electricity, with 3 dogs, was hectic and challenging. There was also all of the paperwork, phone calls, etc., that are completely overwhelming. We learned we didn't have home owner's insurance – the mortgage company did not pay the monthly premium through escrow as was the agreement. What were we going to do?

7 months later... a home owner accepted our modest offer on their home, we were going to have a home again, this time in Corning CA. The mortgage company eventually paid off the mortgage to our burned down home that we were still paying on, but would not provide personal property loss. We had our lives and our dogs, that is what was important.

We left our 5th wheel 8 months later and moved into a home with electricity. We survived because of all of the love, help, prayers, and sacrifices that our family, friends and strangers provided. We saw our heavenly father's hand carried us through by means of all of them.

## Food and Farm News

### Storms bring relief to farms, ranches

After two dry months to begin the California rainy season, farmers and ranchers generally welcome December storms that deliver rain to lower elevations and snow to the Sierra. State water officials point out that precipitation last year didn't pick up until after Thanksgiving, but eventually brought a wet winter. Reservoir levels remain generally above average as a result, though the State Water Project issued its initial allocation at only 10% supplies.

### Reclamation bureau seeks to repair Central Valley canal

A federal agency has officially kicked off the process to repair a key Central Valley waterway. The U.S. Bureau of Reclamation said Tuesday it will begin accepting public comment on plans to repair the Friant-Kern Canal. The canal has lost much of its capacity due to land subsidence. It delivers water to farms in Tulare and Kern counties, and also serves a quarter-million residential users.

### Sorghum study pinpoints drought tolerance

Knowing more about how sorghum plants survive during drought could help other cereal plants during water shortages, and University of California researchers say they've gained important information. A study of sorghum grown at a Fresno County research center shows how the plants turn certain genes on and off during and after times of water scarcity. UC specialists say the study gives them real-world examples of how to help plants tolerate drought.

### Americans pick up the pace of meat consumption

Meat consumption among Americans has increased, according to analysis by the U.S. Department of Agriculture. USDA says total consumption of red meat, poultry, fish and shellfish rose nearly 8 percent in the most recent four-year period. Beef consumption rebounded, the report says, due to an improving economy and stable retail prices. Chicken remains the most-consumed meat, at about 52 pounds per person per year.

## Atty. General Barr on a ‘Strong Presidency’

Attorney General William P. Barr delivered an “insightful must read” speech to the Federalist Society’s 2019 National Lawyers Convention November 15, 2019.

For the full transcript of 12 pages, dial up “Atty. General Barr’s lecture at the Federalist Society on Nov. 15th.”

***The speech, in small parts, read;***

“I deeply admire the American Presidency as a political and constitutional institution. I believe it is, one of the great, and remarkable innovations in our Constitution, and has been one of the most successful features of the Constitution in protecting the liberties of the American people. More than any other branch, it has fulfilled the expectations of the Framers.

Unfortunately, over the past several decades, we have seen steady encroachment on Presidential authority by the other branches of government. This process I think has substantially weakened the functioning of the Executive Branch, to the detriment of the Nation.

I. Let me say a little about what the Framers had in mind in establishing an independent Executive in Article II of the Constitution.

The grammar school civics class version of our Revolution is that it was a rebellion against monarchical tyranny, and that, in framing our Constitution, one of the main preoccupations of the Founders was to keep the Executive weak. **This is misguided.** By the time of the Glorious Revolution of 1689 in Britain, monarchical power was effectively neutered and had begun its steady decline. Parliamentary power was well on its way to supremacy and was effectively in the driver’s seat. By the time of the American Revolution, the patriots well understood that their prime antagonist was an overweening Parliament. Indeed, British thinkers came to conceive of Parliament, rather than the people, as the seat of Sovereignty.

During the Revolutionary era, American thinkers who considered inaugurating a

republican form of government tended to think of the Executive component as essentially an errand boy of a Supreme legislative branch. Often the Executive (sometimes constituted as a multi-member council) was conceived as a creature of the Legislature, dependent on and subservient to that body, whose sole function was carrying out the Legislative will. Under the Articles of Confederation, for example, there was no Executive separate from Congress.

Things changed by the Constitutional Convention of 1787. To my mind, the real “miracle” in Philadelphia that summer was the creation of a **strong Executive**, independent of, and coequal with, the other two branches of government.

The consensus for a strong, independent Executive arose from the Framers’ experience in the Revolution and under the Articles of Confederation. They had seen that the War had almost been lost and was a bumbling enterprise because of the lack of strong Executive leadership. Under the Articles of Confederation, they had been mortified at the inability of the United States to protect itself against foreign impositions or to be taken seriously on the international stage. They had also seen that, after the Revolution, too many States had adopted constitutions with weak Executives overly subordinate to the Legislatures. Where this had been the case, state governments had proven incompetent and indeed tyrannical.

From these practical experiences, the Framers had come to appreciate that, to be successful, Republican government required the capacity to act with energy, consistency and decisiveness. They had come to agree that those attributes could best be provided by making the Executive power independent of the divided counsels of the Legislative branch and vesting the Executive power in the hands of a solitary individual, regularly elected for a limited term by the

Nation as a whole. As Jefferson put it, “For the prompt, clear, and consistent action so necessary in an Executive, unity of person is necessary....”

In recent years, **both the Legislative and Judicial branches have been responsible for encroaching on the Presidency’s constitutional authority**

A. Immediately after President Trump won election, opponents inaugurated what they called “The Resistance,” and they rallied around an explicit strategy of using every tool and maneuver available to sabotage the functioning of his Administration. Now, “resistance” is the language used to describe insurgency against rule imposed by an occupying military power. It obviously connotes that the government is not legitimate. ***This is a very dangerous*** – indeed incendiary – notion to import into the politics of a democratic republic. What it means is that, instead of viewing themselves as the “loyal opposition,” as opposing parties have done in the past, **they essentially see themselves as engaged in a war to cripple, by any means necessary, a duly elected government.**

The fact of the matter is that, in waging a scorched earth, no-holds-barred war of “Resistance” against this Administration, it is the Left that is engaged in the systematic shredding of norms and the undermining of the rule of law. This highlights a basic disadvantage that conservatives have always had in contesting the political issues of the day. It was adverted to by the old, curmudgeonly Federalist, Fisher Ames, in an essay during the early years of the Republic.

For these reasons, conservatives tend to have more scruple over their political tactics ***and rarely feel that the ends justify the means.***

## Local Farmers to Fund All Marysville High School FFA Trip Costs

In a first-of-its-kind effort, a group of Yuba County farmers has established a non-profit organization and fund, titled the Yuba River Endowment, to benefit Yuba County residents.

As their first funding effort, Endowment board members unanimously voted to present the Marysville High School FFA program with \$15,000 to cover all out-of-pocket expenses for FFA students to attend all Field Day and State competitions for the current school year. The funds will cover all transportation costs, hotel and registration fees for 12 scheduled trips, helping approximately 230 students this year.

"Marysville High School has invested a lot in expanding our ag programs and infrastructure, but we are not able to cover out-of-pocket expenses for students to attend FFA competitions," said Marysville High

School Principal, Shevaun Mathews. "The Yuba River Endowment funding is truly a blessing that will take the burden off students to raise the funds themselves, and will allow all students who qualify to experience these events."

The Yuba River Endowment was established by a select group of Yuba County farmers who have a legal right to water that flows on the Yuba River. In a truly win-win situation, the farmers' water is used to provide the required flow levels to protect endangered fishes on the Yuba River, then once past this critical point, the water can be sold to drought-stricken areas of the state.

Proceeds from these transfers provide the funding for the Yuba River Endowment, allow these farmers to expand their agricultural operations and create jobs in Yuba County. Through generations of conservation, cooperation, infrastructure investment and

groundwater recharge, Yuba County is a model for water management in California.

The Endowment was created to give back to the community, and provide organizational and educational grants to improve the quality of life in Yuba County.

"Our motto for the Endowment is 'Local Farmers Giving Back'," said local farmer and Yuba River Endowment President, Al Lassaga. "Our board is made up of representatives from seven different Yuba County regions, from Browns Valley to Wheatland. Investing our money back into our community, and specifically into agricultural education and our future farmers, just makes sense. We want to make sure agriculture stays strong in Yuba County for generations to come."

Yuba River Endowment board members awarded the funds during the Marysville High School FFA meeting, Tuesday, December 10th.

# Toys for Tots Campaign Faces an Uphill Battle

## But Scheduled Toy Events Will Help

Yuba-Sutter Toys for Tots is gearing up for a very active Christmas season assisting an estimated 1800 children in Yuba and Sutter Counties to have a joyous holiday.

“A tremendous number of children are being raised in households with low incomes in both counties” said Bob Harlan, Yuba-Sutter area coordinator for Toys for Tots.

“The community assists in providing toys,

games and sporting goods for children who might not otherwise have anything to open,” Harlan added.

The shorter time span between Thanksgiving and Christmas this year, in conjunction with a higher demand for assistance, are making for an uphill battle to get about 4000 gifts for children ages newborn through 12 collected in just 21 days.

“The organizations we assist need gifts for the

children they serve by the 10th of December and our distribution takes place on December 20 and 21,” Harlan Said.

There are donation boxes at 61 local businesses, who will assist in collecting gifts through December 19. A list of those locations can be seen on the Yuba-Sutter Toys for Tots Facebook page or online at <http://yuba-city-ca.toysfortots.org>.

In addition to the drop-

off sites, there are multiple special events to collect gifts:

–Once again this year, Results Radio will conduct five live broadcasts, airing live reports on all three radio stations (KUBA, Power 95.5 & Country 103.1). The events are in Yuba City from 3:00-5:00 p.m.: Tuesday at Grange Coop; Wednesday at Dunkin’ Donuts; Friday at Evans’ Furniture; and Monday, December 16 at Rush Personnel. The fifth broadcast will be from 11:00-1:00 on Saturday, December 14 at SunStor Solar inside the Yuba-Sutter Mall.

In addition to the events, Yuba-Sutter Toys for Tots received a total of \$5000 this Fall from the Yuba City and Marysville Walmart’s and the Yuba City Sam’s Club to spend at their stores.

“We are so grateful to the large donations from Walmart and Sam’s Club, and the incredible one-day collections from the Yuba City Firefighters at Target in Yuba City. But we are also so grateful

to the hundreds of smaller donors who go out of their way to give money and gifts targeted to children in need,” Harlan said.

Toys for Tots is most interested in receiving gifts with a retail value of \$14.00 or higher, however smaller items can be gifted in multiples or as stocking stuffer items.

Donated gifts must be new in original packaging and unwrapped.

Toys for Tots is an organization which has virtually no overhead costs. They receive free rent for their distribution center location through Hilbers, Inc., they pay no other fees for storage or utilities and all people involved are volunteers.

“All cash donations are sent overnight to a processing center and 100% comes back to us to spend for gifts for children in need,” Harlan said.

“Even more amazing, is that we receive some \$15,000 in gifts for our children from the Toys for Tots Foundation from national wholesalers at no cost to us!” Harlan added.

Toys for Tots began in Yuba and Sutter Counties in 2002 as a project of Harlan Communications, which then owned KUBA and Cool 104 Radio stations. Subsequent owners have partnered with Harlan to continue the program through heavy radio promotion and providing storage space for Toys for Tots throughout the year.

Toys for Tots partners locally with the Salvation Army, which provides intake services for the families Toys for Tots serves through the family distribution days as well as their own. Salvation Army also provides boxes of food for each family.

Toys for Tots serves about 600 youth directly, with another 1200 through other organizations who carefully choose families in need who will receive gifts. This year, there are eight local organizations requesting assistance, including SoYouCan and CHiPs For Kids.
