Smartsville Church Receives Thomas Mooney Portrait

Part of the mission of the Smartsville Church Restoration Fund, in addition to restoring the former church building, is to make it useful as a museum and visitors center. On September 1st, an unexpected original portrait of Thomas Mooney (1823 - 1888), appeared on the doorstep of the church. Fortunately, Janet Burton, SCRFI secretary, just happened to be there.

Two sisters, Sally Knutson and Charle Lennon, who had been caring for this rare artifact for many years delivered it to SCRFI. It was one of the heirlooms their mother had saved as keepsakes from the Mooney home at Empire Ranch, near Smartsville. Jessie Mooney created this painting of her father, Thomas.

Sally and Charle realized the painting's historical significance and wanted it to have a proper home where it would be valued and exemplify their family's past and Mooney's part in the settling

of the Smartsville area. Sally and Charle learned of the plans for the museum when they attended Pioneer Day several years ago and were pleased by the restoration and decided the former church/museum would make the perfect home.

Their great grandmother, Mrs. Ben Taylor of Grass Valley was the sister of Mary Jane Huling, Thomas Mooney's wife. Thomas and Mary Jane had eight children, two boys and six girls; none of them

Myths, Miracles and Turkeys

On November 11, 1620, they finally dropped anchor and sent a few to shore.

The crew set-out in a small craft in rugged frigid surf. Participants credit a miracle from God for a safe landing as a large

Repo problems intensify

Covered before in Money Matters, the overnight repurchase agreement mechanism (REPOS) is an arrangement between the Federal Reserve and member institutions. From my previous article

The repo market is the plumbing of the financial system. The banks and market funds of all types rely on this market to finance their day to day operations. Billions of dollars flow into and out of this market daily. It's where business and investment firms of all types draw on funds to operate, while others deposit excess funds for safekeeping and possible income. The market operates funding for as short as overnight to longer terms. From CNBC: In a repo trade, Wall Street firms and banks offer U.S. Treasuries and other high-quality securities as collateral to raise

cash, often overnight, to finance their trading and lending activities. The next day, borrowers repay their loans plus what is typically a nominal rate of interest and get their bonds back.

The REPOS market seldom needs cash infusions from the Fed as the inflows and outflows of the mechanism furnish enough funds for the markets and businesses they serve to operate. In fact up until I penned the first article about 6 weeks back, the last time the Fed injected money into this mechanism was 2008/09. Those dates ring a bell?

They should.

The global financial institutions quite literally imploded from the real estate bust. But that was then and this is now. The REPO market has been operating just fine on its own. That was up until about early September when the mechanism suddenly found itself short of liquid cash. Two weeks later and 70 billion injected, I penned the article. (link to article: <https://moneymanagementradio.com/node/1073>)

Turns out the injections by the Fed are intensifying account to the 5 MIN FORECAST. David Gonigam, managing editor of the 5 as it's called, says close to a third of trillion has now been injected by

the Federal Reserve. Rumor says Gonigam is that mega-bank JP Morgan spent 77 billion "propping their shares up" AKA stock buybacks, and that money would have gone into the huge bucket that the REPO market is. Alas it didn't go there. But like he said, it might have went to a JP Morgan stock buy-back.

Maybe me thinks, but maybe not.

The REPO market has been around a long time and it's seen a whole bunch of financial "stuff" happen in the world, stock buybacks being one of the least of them. And 300 billion is not pocket change and it also likely means not all might be well in the money pipes of the system.

What the case may be, this analyst is losing just a little bit of sleep over this and watching carefully the plumbing of the financial markets with a bit more scrutiny. If more funds are shuttled from the Fed into the REPO market, bigger things than a stock buy-back may be afoot. This market rarely springs a leak for little or no reason, but like a slow leak on a cruise ship below decks, it's not something those in the pilot house want to advertise. Only when it's time to abandon ship with the calls over the public intercom be heard.

FISHIN' TALK

The rains finally arrived which means muddy rivers and lots of sturgeon moving inland. With our weather source predicting more rain this week it is expected to raise local rivers and turn the water brown. Reports tell us some good areas to go after the sturgeon is Knights Landing and the Verona area. We are told to also see a few stripers caught and some will be keepers.

Local creeks, ditches and bypasses are a good bet for catfish with the Sutter Bypass leading the pack. When rivers rise so does the waterways that lead into the rivers. Any of these creeks, including ditches, will produce catfish this time of year. Keep in mind your bait does not need to stink to catch cats, but these scavengers usually prefer the smelly stuff over other baits. Years ago we shot a jack rabbit and left the carcass out in the sun for a week before using it for bait. I have caught lots of nice sized catfish with this method. In fact, just about any diehard catfish anglers have their own favorite stink bait.

Channel Catfish are an excellent table fare and are usually found in local rivers. I said usually because they are also found just about anywhere in the valley and foothill waters.

One of my favorite recipes for catfish fillets is to use mayonnaise and Ritz crackers, salt, pepper, garlic powder, dry parsley and pepper. Preparation is easy. On a sheet of wax paper place a cup of mayonnaise on one side and the dry ingredients, including the cracker crumbs, mixed thoroughly, on the other side. Simply dredge the fillets in the mayonnaise and coat the fish

with the cracker crumbs and dry ingredients. Pat the fillets to force the crumbs into the flesh. Heat a skillet to 350 degrees with oil and when hot carefully place the fish pieces in the pan. Cook on both sides and serve with lemon slices along with the rest of your meal.

Pearl Harbor Remembrance Day May We Never Forget

Pearl Harbor Remembrance Day 2019. Pearl Harbor Remembrance Day for the year 2019 is celebrated/ observed on Saturday, December 7th.

Each year on Dec. 7, Pearl Harbor Survivors, veterans, and visitors from all over the world come together to honor and remember the 2,403 service members and civilians who were killed

during the Japanese attack on Pearl Harbor on December 7, 1941. A further 1,178 people were injured in the attack, which permanently sank two U.S. Navy battleships (the USS Arizona and the USS Utah) and destroyed 188 aircraft.

For the first time in more than seven decades, no Arizona survivors were present at

Pearl Harbor when officials commemorated the 77th anniversary of the attack. Only five Arizona survivors are still alive: Lauren Bruner, 98; Lou Conter, 97; Lonnie Cook, 98; Ken Potts, 97; and Don Stratton, 96.

On Aug. 23, 1994, the United States Congress designated Dec. 7 as National Pearl Harbor Remembrance Day.

married. Jessie, one of the daughters, was a professional artist and was listed as such in the directories of the day. She also did civic work and taught art classes to local children. The painting needs some restoration work and SCRFI is looking for a qualified professional to make the repairs.

Thomas Mooney played a formative role in Yuba County as the co-founder of the Empire Ranch an important early staging stop on the road from Marysville to the northern mines. Like most successful people of his time he was an entrepreneur, speculator,

diplomat, philanthropist, civic leader and family man.

He was born in County Kildare, Ireland, January 7, 1821, arrived in California in 1849 and started in the teaming business with a partner, Michael Riley in Sacramento. In 1851 he and Riley purchased the property in Yuba County and named it Empire Ranch. They established the stage stop to service other teamsters who needed a stopping place on the road, a meal and a place to sleep, and care for their teams. They also greatly profited by providing entertainment for the miners,

heartly food with plenty of champagne, claret and milk punch on Sundays.

The post office was established at Empire Ranch in 1855. In later days Mooney kept race horses and held races at the ranch and hosted dances and other social activities. He was one of the hearty folks who came to seek adventure and built a life in Yuba County.

To learn more about this amazing individual and other pioneers of Yuba County, mark your calendars and plan to come to Smartsville's Pioneer Day on the last Saturday in April.

This Month In Your Garden

Another year is about to come to an end. December always seems to be a busy month climaxing with New Year’s celebrations and facing what unfolds in the new year. As far as gardening goes, there is not too much required except the second dormant spraying of fruit trees to protect them from curly leaf and other fungal infections. That should be done near the end of December with a copper spray mixed with horticultural oil. The same spray can be beneficial to other plants that are sometimes damaged by fungal infections. Roses are candidates to prevent powdery mildew, rust and black spot. Fire Blight on apples and pears has been a more prominent problem recently and they should also be sprayed. Pyracantha will benefit from spraying, as it is also subject to Fire Blight.

December usually brings us some very cold weather, and it is good to be ready for it rather than being caught short and possibly losing some plants. Be sure plants are well watered when a predicted freeze comes along. Wet roots will withstand the freezing, and below freezing weather better than dry roots because they are insulated by a blanket of ice that keeps them at 32 degrees. Raised beds that may be somewhat shallow could be similarly affected with the possibility of extremely low temperatures. Just keep in mind “dry roots freeze faster than wet roots”. Citrus trees are especially susceptible to freezing both because they are evergreen and they are out of their subtropical “comfort zone”. Many of them will have fruit on them which will likely be damaged if not protected. If the fruit is ripe it can be harvested, if it is green it will need protection. Plastic will never protect the plant if it is simply thrown over the plant in contact with the foliage since it has no insulation properties. It can be very effective, if it used to create dead air space around the plant. A simple frame work around the tree, leaving several inches of free space, then cover the framework with a plastic sheet of some kind. Some people will hang a light bulb inside to create some warmth if there is power close by. Keep in mind that most of the newer efficient bulbs don’t offer as much heat as the old incandescent bulbs do. For smaller susceptible plants an old blanket or beach towel – just something with some insulation quality can be used to cover the plant. There is a relatively inexpensive manufactured product called “frost cloth” that can be used. It has the advantage of being light weight and shedding the rain rather than becoming

heavy when wet like a towel. It is often found in a light weight, or a heavier weight for better protection.

Christmas tree lots will begin popping up everywhere, if not already. Some nurseries and garden centers will carry live Christmas trees, or other alternatives that intrigue folks. The live Christmas trees often come as a “balled-in-burlap” item, meaning the roots have been dug from the ground with a ball of its soil around it. It is then wrapped tightly in burlap and shipped that way, and it is left that way until it is planted. When it is planted, it should be put in place still in the burlap and situated properly, and at that time the twine holding the burlap can be cut and any extra burlap can be trimmed off leaving any under the tree there (it will disintegrate in time) and finish planting the tree.

Bare root season will be getting underway soon. Bare root roses arrive in mid December and bare root fruit trees arrive in late December and are ready to sell in January. Blueberries, cane berries, pomegranates, figs arrive the last week of November. Asparagus, strawberries, rhubarb, and horse radish arrive in January. We sell them in pots. Bare root fruit tree lists are available at the nursery. You can take the list and plan what you want.

If you purchase or are given a beautiful poinsettia plant for a seasonal decoration, please treat it well. Remove the foil that covers the drain hole for the container and place it on a saucer with pebbles in it so that the plant doesn’t sit in water. There are many beautiful cultivars now, but I still prefer the plain red ones. Ventura, where I grew up, was called the Poinsettia city. The basic red poinsettias needed no special care there. My mother had them growing up the side of our driveway and all she did was cut them way back after they bloomed, they came back and bloomed at just the right time every year. All gardening should be so easy! We wish you all a wonderful holiday season.

wave rather than capsizing, deposited them on the shore. It was winter and raw terrain.

They settled on an area they called New Plymouth. It had a long sloping hill that made it easy to defend. It was the site of the former Wampanoag village of Patuxet people. Its inhabitants had died of disease three years before. The village even had a stash of dried corn remaining.

The newcomers searched for the inhabitants or someone to pay for the food they discovered. They considered this divine providence. Then another miracle --after half the Separatists had died before spring, a local appeared that spoke English, had lived in England, once resided exactly where they landed and was a follower of Jesus.

In 1608, this young man named Tisquantum, or Squanto, had been abducted with others by an English merchant ship in “America” to trade with the locals. Then, Squanto was purchased by Catholic Friars in Spain who then released him. Making his way to England to work his way home, Squanto learned of Jesus and began speaking

English.

A decade later he finally headed home serving on a ship as an interpreter only to find his Patuxet people destroyed by illness. Had Squanto not been taken as a slave a decade earlier he likely would have perished as well.

Squanto, now a man without a family who knew everything about surviving in Patuxet was adopted by the ‘Pilgrims.’ The settlers, beaten by the weather and disease were considering a return to Holland when Squanto surfaced.

Squanto assisted the newcomers to success and sustainability as well as negotiating 50-years of peace with the nearby people groups. Plymouth Colony Governor William Bradford declared in his journal that Squanto “became a special instrument sent of God” who didn’t leave them “till he died” in November 1622. The Separatists were underwritten by European merchants whom they had to repay. The Mayflower Compact spelled out that they would live communally, have all in common to pay back the investors. The ‘Inquiry’ Clown Show Continues ...

The House Intelligence Committee Chairman Rep Adam “Shifty” Schiff impeachment “Inquiry” concluded in a Big Nothing Burger. Fox News contributor Gregg Jarrett has dutifully pegged it as “The Clown Show”. That circus tent folded unceremoniously. Rep. Jerry Nadler’s Judicial Committee has to “endure” the glaring spotlight with his own circus tent...that’s right, more of the HO-HUM attempts to bring down President Trump.

So, as the sun rises on the east coast this morning, Dec. 4th, the Do Nothing Democrats continue with their Despicable Clown Show, Act II.

Following is Gregg Jarrett’s Act I Schiffy Show stumbling with his Nov.12th, 2019 article, in part:

The “Clown Show” known as an "impeachment inquiry" is getting more comical and hapless by the day.

Consider the latest remark from the circus master himself, California Rep. Adam Schiff, (think Clown Bozo, not Pennywise). The Democrat chairman of the House Intelligence Committee says he doesn’t want Republicans turning the impeachment proceedings into a “sham.” The hilarious irony is lost on no one. Schiff has already managed to accomplish it all on his own.

At first, Schiff wanted the faux “whistleblower” who triggered the impeachment farce to testify. Then, suddenly, he didn’t. What changed? In the interim, evidence emerged that Schiff and/or his staff colluded with the “whistleblower” before the complaint was ever filed and then lied about it, earning Schiff “Four Pinocchios” from The Washington Post.

The chairman now wants to conceal his own role in engineering the pretext for impeachment and his subsequent deceit. This is why he has insisted that the “whistleblower” remain anonymous, despite no such right, guarantee, privilege, or entitlement written in the law. Even though the undercover informant (reportedly working for the CIA) does not qualify for whistleblower status under the law as determined by the Department of Justice, any effort by Republicans to call him as

a witness will be blocked by Schiff.

But Schiff’s machinations are more malevolent than masking the key witness. Those he will call to testify are already on record dishing up prodigious plates of multiple hearsay and rank speculation. It is obvious from the released transcripts of the heretofore “super top-secret” inquisition that none of them have any firsthand knowledge of a “quid pro quo” allegedly demanded by President Trump.

Bill Taylor, the acting ambassador to Ukraine who testified to the committee that it was his “understanding” there was a link between U.S. security assistance and an investigation of Joe and Hunter Biden through discussions with other diplomats, although there is no indication that any of these individuals had direct knowledge of anything. The chain of hearsay went something like this: the European Union Ambassador Gordon Sondland told National Security Council official Tim Morrison who, in turn, told Taylor that there was a purported "quid pro quo."

But wait. If Sondland was the original source, where did he get his information? He initially testified that in a brief phone conversation with Trump, the president explicitly told him, **“I want nothing ... I want no quid pro quo.”** Sondland added that he “never” thought there was a precondition on aid. Later, he revised his testimony to state, “I presumed that the aid suspension had become linked to the proposed anti-corruption statement.”

Ah, yes. He "presumed." Reliable witnesses do not assume or presume anything. If they do, it is nothing more than supposition that should be discarded like yesterday’s trash.

My favorite purveyor of assorted hearsay is another star witness for Schiff this Wednesday. Deputy Assistant Secretary of State George Kent testified that he “believed” there was a “quid pro quo” after speaking to Taylor who spoke to Morrison who heard it from Sondland who, **as noted, “presumed” a precondition.** This is conjecture built on triple hearsay. It is not evidence. If this were a court of law, the presiding judge would instruct the jury to disre-

gard such testimony and strike it from the record.

Under cross-examination, these witnesses readily admitted they had no firsthand knowledge of the president’s intent during his telephone call with Ukrainian President Zelensky. They simply propagated and repeated rumors and innuendo in their diplomatic echo chamber. But that has not stopped Schiff from pretending that they are valued witnesses. With the chairman’s encouragement and guidance, they have offered their interpretations of the Trump-Zelensky conversation. It reminds me of Schiff’s own dramatic interpretation of the phone call before Trump had released the transcript of the call which was nothing more than an unconscionable fabrication designed to smear Trump.

A transcript of the real conversation is the best evidence of what actually occurred. Indeed, it is the only relevant and material evidence. Nowhere is there a demand, condition, or pressure for a “quid pro quo” that made an investigation of the Bidens contingent on U.S. military assistance. This is corroborated by Zelensky who is on record stating that there was no blackmail involved and no pressure applied. “Nobody pushed me,” Zelensky said. “We had a great phone call,” he added. “It was normal.”

The Ukrainian government has confirmed that it was unaware that U.S. aid had been temporarily suspended **until almost five weeks after the call with Trump.** As noted in my previous column, it is impossible for there to be a “quid pro quo” when the recipient of the “quid” is oblivious to the existence of the “quo.”

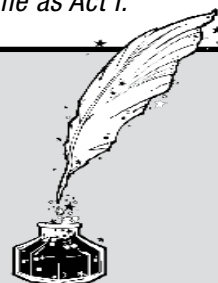
If the inquiry was equitable, both sides would be able to call their own witnesses. Yet, the House of Representatives passed its impeachment measure giving Schiff the right to veto GOP witnesses. He has already made it clear that he will do so, rejecting a request that the faux “whistleblower” testify. Yuba County Awarded Grant for Child Passenger Safety Education Program

Marysville, Ca.

Yuba County Health and Human Services Department announced a \$50,000 grant has been awarded by the California Office of Traffic Safety (OTS) to fund programs that educate parents and guardians on child passenger safety. The grant is for a one-year period from Oct. 1, 2019 to Sept. 30, 2020.

Grant funding will be used for a variety of activities to promote the proper use of child safety seats:

- Car seat checkup events and/or one-on-one appointments to inspect car seats.
- Child safety seat

education classes informing parents on using and properly installing the right car seat based on a child's height and weight.

- Child Passenger Safety Technician (CPST) training and recertification training
- Distribution of child safety seats to families in need.
- Surveys on car and booster seat compliance rates.
- Community events and fairs to increase awareness about child passenger safety.

Car crashes remain the leading cause of death for children 13 and under. According to the

National Highway Traffic Safety Administration (NHTSA), 46% of car seats are not used properly.

“Children should be as safe as possible when traveling in a car,” OTS Director Barbara Rooney said. “Funding for child passenger safety education and training allows our partners to make sure children are in the right car seat that is being used correctly.”

Funding for this child passenger safety program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

Portable pens help with emergency livestock housing

To help house farm animals displaced during disasters, portable livestock pens have been deployed to fairgrounds around California. The pens were formally dedicated Tuesday during a ceremony in Yuba City, and were purchased jointly by the California Farm Bureau Federation's charitable foundation and the state Department of Food and Agriculture. They can be distributed to fairgrounds to help animals evacuated due to wildfires, floods or other emergencies.

Bill in Congress could reduce farms' estate tax burden

Farm organizations welcome introduction of legislation that would

ease the potential federal estate tax burden for family farmers and ranchers. Cosponsored by Salinas-area Rep. Jimmy Panetta, the bill would assure property would be appraised as farmland rather than at its development value when determining estate taxes. Supporters say the bill would make it less likely a family farm would need to be broken up to pay estate tax.

Annual turkey consumption remains stable

With the big turkey-eating holiday coming, the U.S. Department of Agriculture estimates Americans will consume an average of more than 16 pounds of turkey per person this year. That's similar to levels of the past decade. California ranks eighth in the na-

tion in turkey production. USDA reports wholesale turkey prices up slightly from a year ago. But an annual American Farm Bureau retail-price survey shows turkey prices to be down.

Americans spend more time on food prep, less on eating

How much time do you devote each day to eating? According to the U.S. Department of Agriculture, Americans spend an average of 64 minutes a day on eating or drinking as a primary activity. That's down slightly from a decade earlier, but the time Americans spend on preparing food has gone up. So has time devoted to cleanup, grocery shopping and buying non-grocery food, such as from a fast-food restaurant.
