Yuba Board Approves Ordinance Addressing Camping and Personal Property

Marysville, Ca.

In an effort to address serious public health and safety concerns along County rivers, parks, and other public and private properties, the Yuba County Board of Supervisors Tuesday unanimously approved an urgency ordinance concerning camping and storage of personal property. The ordinance affects all residents and is expected to have its most profound impact on the river bottoms and the levee system—where encampments and piles of personal property have affected the health of area rivers, riparian habitat and its visitors.

The urgency ordinance, which took effect immediately upon approval, prohibits camping:

- * on private property without the owner's permission
- * on any park grounds or trail facility
- * on the County airport
- * on any County cemetery
- * on any property within or below 200 feet of the high water mark
- * on any levee or within 50 feet of landside toe of the levee
- * on any County right of

way

* on any other County property from 30 minutes after sunrise to 30 minutes after sunset (with exceptions during cold or wet weather conditions).

The ordinance also prohibits the storage of personal property:

- * on any private property without the owner's permission
 - * on any County park or trail facility
 - * at any County airport
 - * on an public property if it obstructs the use of the property
 - * on any public property that has a posted closure time
 - * on any property that is within or below 200 feet above the ordinary high water mark.
- The ordinance allows for due process prior to removing personal property. Residents are given a 48-hour notice and informal hearing before the removal of personal property. After items are removed, those same residents are given a chance to reclaim the property within 90 days of its removal and storage. While there are some fees associated with moving and storage,

the owner of the removed personal property can apply for a fee waiver.

"This Ordinance puts in place reasonable regulations for dispersed camping and personal property storage, and provides Code Enforcement -- as well as the Yuba County Sheriff's Office -- a much-needed enforcement tool to reduce activities that pollute waterways, that create a hazard in public places, or that damage the levee system which provides flood protection to the community," Building Department and Code Enforcement Manager Jeremy Strang said. "Because regional reservoirs can cause sudden and quick-moving changes in water elevation, proactive enforcement of this Ordinance will facilitate the relocation of individuals that have established camps within our waterways. This type of proactive enforcement will also provide an additional layer of safety for our first responders— who put their lives in harm's way to evacuate from or perform rescues in encampments dangerously situated within our waterways."

Planned Scarcity

The Camp Fire is the deadliest wildfire in the United States since the Cloquet fire in 1918 and is high on the list of the world's deadliest wildfires; it is the sixth-deadliest U.S. wildfire overall.

The Camp Fire actually is considered a blessing by the United Nations Agenda 21 smart growth folks that believe no one should be living in rural California anyway.

The Camp Fire is just one of hundreds of major Armageddon-style infernos in the state ignited by liberal policies. This is a bell ringer accomplishment of liberal legislators after assessing thousands of rural Californians an illegal annual \$150 per dwelling fire tax above their normal taxation from July 1, 2011 through June 30, 2017 for "fire prevention."

By the state being the quasi-managers of PGE and the state's deranged forest care policies normal weather patterns now cause cataclysmic disasters. Gov. CA and Venezuela Socialism and Rationing

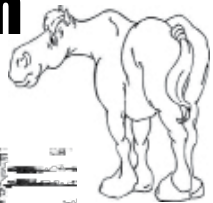

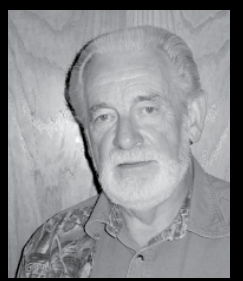

Several Striped Bass reports surprised many anglers in the Sacramento Area. Last week larger

Stripers were being caught in the deep channel area of the Sacramento River as well as in the vicinity of Lupe's Bend. In addition, fish were reported moving up in the Feather River from the Verona Area. The reports were spread out over large areas.

Steelheads are in local rivers and are responding to lures, spinners, bait and roe. The Yuba River in under strict regulations and it would be a good idea to check on this if you decide to go on the Yuba.

Some anglers are putting the boat away for the winter. We suggest you also disconnect the battery, check fluid levels and clean up if necessary. It would be good also to pull the plug to allow any water in the bilge to run off. If your boat is to be stored outside in the elements a cover is mandatory. It would also be a good idea to wash down the hull and clean out the inside prior to storage. While you are at it clean and check your tackle boxes and service the outboard or kicker motor. If you have an electric trolling motor do the same. A trickle charger will also benefit your batteries by prolonging

the service of same.

The bass at Clear Lake are still getting angles excited at this time. With the cooler weather here the bigger bass are available. Live bait is the ticket for big bass with lures coming in second. Catfish are also being taken on live jumbo minnows with some cats being weighed in at ten pounds. The Crappie bite is on and the fish can be found under

docks or in deep water. We are told there is lots of boat traffic here.

Congratulations go out to Yuba City Angler **Brad Bryan**. Brad landed a 9½ pound rainbow trout while fishing Collins Lake recently. He was fishing near the bridge when the "big one" hit his lure.

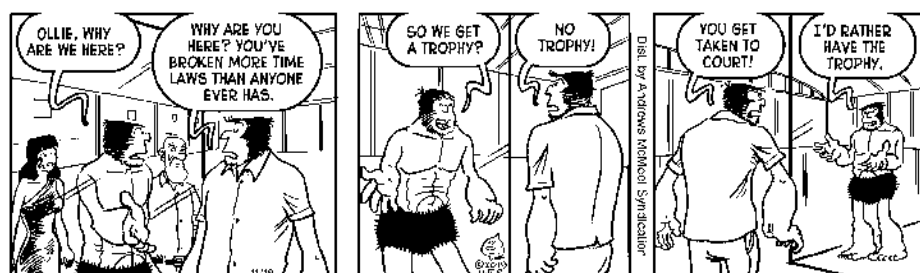

Planned Scarcity

Newsom also neglects to mention the utility has given nearly \$700,000 to his political campaigns, his wife Jennifer's and his sister's nonprofit organizations. The utility has also donated \$1,000 or more to 98 members of the state legislature which is fairly common for monopolies.

Will Yuba City, Marysville or Linda / Olivehurst flood before our utopian rulers organize a think-group to "scope" whether drug addicted and alcoholic squatters should be allowed to tunnel into multi-million dollar levees that hold back raging rivers? Ignoring this behavior is now considered charitable and humane.

The state has abundant run-off and the Pacific Ocean that could provide endless amounts of water. However, the state's managerial incompetence again mucks-up the ability to build more dams and desalination plants to harness and utilize this resource. One-half of all

water is mandated to remain unused by humans destined instead for the ocean.

Californians have been repeatedly suckered to vote for "water" bonds that actually were used to keep more water from humans rather than catch and conserve the rains. The socialists are liars and deceivers.

Therefore, California has enacted new statewide water conservation rules to begin rationing. Water agencies are to limit customers' indoor water use to an average of 55 gallons per person each day. The target is reduced to 52.5 gallons by 2025 and 50 gallons by 2030. But the targets can be further restricted anytime.

Of course, the current electrical blackouts are the beginning of power rationing. As fossil fuels are forbidden, there will never be sufficient green energy to power the state. Buying from neighboring grids will be cost prohibitive, utilities will become unafford-

able and lead to routine interruptions. The state has declared that natural gas be eliminated as well.

All fossil fuel vehicles have been given their drop-dead date and much road maintenance is being scrapped in spite of increasing fuel taxes and DMV fees taken to be used for "up-keep and new roads" another bait and switch lie. Northern California is not benefitted by any high speed trains or mass transit. The truth is that the rulers will not let the northern counties break-away into a new state because they want to depopulate the north in favor of rewinding.

For California to return to its golden past change needs to occur quickly. The start must begin with signing the petition to recall the governor (ranaf.org).

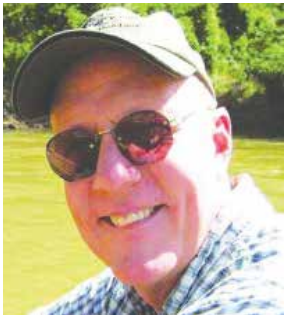

Cal Fair Insurance Basics

The Cal Fair insurance plan is the last resort in fire insurance for many homeowners. Cal Fair is not a government agency. It is much like the assigned risk program for problem drivers. Cal Fair is made up all of the insurers that are licensed to do business in the state of California. Yes, it is made up of the very same companies that may have cancelled you. How much each company participates is in direct proportion to the percentage of business they do in California. They share in the profits and losses. That said, one could say they are financially adequate being all the companies are in it and backing it together versus just being just one company.

Cal Fair is basic coverage only. They cover fire, lightning, internal explosion and some optional coverages. From Google: The FAIR Plan provides basic fire insurance coverage for residential and commercial structures, as well as personal property coverage for residential and business occupancies. There are also optional coverages available for both residential and commercial properties.

Cal Fair does not estimate or warranty coverage will be adequate. That is left up to person applying for the coverage. They will pay up the limit specified given the conditions have been met for a covered peril (a peril is the cause of loss such as fire).

There are standard coverages in homeowner's policies as it pertains to what is covered. They include the dwelling (the structure and all things "attached to it"), personal property (your stuff), fair rental value (your new "rent" in case you have to leave), other structures (structures not "attached) ordi-

nance of law (cost to bring you house up to the new codes if any), debris removal (haul your burnt out stuff away) and other coverages you can add such as fences, plants and more.

You will still need a separate policy called a "wrap" or "difference in conditions" (DIC) to cover the other perils besides fire.

There are many factors and descriptions that homeowners should review with their agent as you discuss how to proceed and with how much coverage.

Costs will likely increase over current premiums but in most cases insurance can be had, contrary to what some may have heard. Make sure you understand what is covered and what is not and how much is covered. An experience agent can discuss this with you.

Agents are plentiful. If you're not getting the service you require, try another agent. As in all things business, there are good ones and not so good ones.

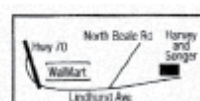

Progress and Action in Yuba County Supervisorial District 5

Last summer, in the Brownsville Barber Shop, a local road contractor made a profound statement, “we are paving more Yuba County Roads this year than in the previous 30 years.” In road distance, most of this paving was done in the Foothills. Fifth District Supervisor Randy Fletcher would be the first to admit that this accomplishment was a cooperative effort by many, but he deserves much of the credit for understanding the need to work with other agencies and individuals for the betterment of Yuba County.

In his role as a Director on the Yuba County Water Agency, he encouraged others to vote for a cost effective loan to Yuba County to fund this summer’s road projects. Previously, his urging caused Yuba County to receive Federal “heavy winter rain money” to repair and pave several other additional mountain roads. Oregon Hill Road is just one example. When Supervisor Fletcher visited the Oroville Dam spillway repair project, he learned that the State of California was paying for Oroville Dam related truck hauling damage to Butte County Roads. With his heads up to the Yuba County Road Department, the paving of Los Verjeles Road was completed at

no cost to Yuba County.

Too many Yuba County residents and especially the majority in the Fifth District, a very important accomplishment by Randy Fletcher was the rescinding of the 99 Plant Outdoor Marijuana Growing Ordinances and replacing it with a ban on outdoor growing. This came only after working with and educating Yuba County Communities and gaining residents’ support and activism. He also convinced the other Supervisors to pass a “State of Emergency” directed at the illegal marijuana grower. These efforts have produced a cleaner and safer environment for Yuba County Residents. The illegal marijuana grower can use our newly paved roads on their way out of the County.

Clearly Supervisor Fletcher’s support for Yuba County related emergencies cannot be ignored. During the Cascade and La Porte Fires and the Oroville Dam Spillway Emergency, Supervisor Fletcher was seen at both the Alcouff and Brownsville Evacuation Centers facilitating needed supplies and coordination with Yuba County Officials. He and the other Supervisors supported police favorable to the replacement of burned homes. Roadside fuel clearing along County Roads is one of his priori-

ties. One of these projects can be seen along La Porte Road in Rackerby. Did you know that, working with the Foothill Fire Department and the North Yuba Water District, he arranged for an emergency escape route for residents along New York House Road while the bridge was being constructed?

Also heard from one long time, critical of government, local were words to the effect “I finally got something for my tax dollar. “ He happened to be, just one, of our residents that obtained a new EPA approved wood stove in replacement for their old inefficient polluting stove. This was through a low or no cost program from the Feather River Air Quality Management District. Randy Fletcher is one Yuba County representative on the FRAQMD Board and he went to great efforts to inform foothill residents of this program.

Supervisor Fletcher also works with private industry. The newly activated AT&T Cell Tower in Brownsville is a result of his efforts. He is currently working to obtain generators for Foothill area schools. The recent PG&E Power Shutdowns now make this a necessity.

Let Them Eat Pig Pie

Our hearts went out to the mom/pop hog farmers, their employees, and local communities that were adversely affected by Trumps trade-wars. Trump immediately gave them billions in aid to help them survive and keep them loyal to him. It has now come to light that most of these hog farms are owned or rigidly controlled by giant corporations that don't hire locally, rather use illegal aliens that will work cheap, sometimes for cash, in terrible conditions, without benefits, and they keep quiet about it.

Confined Animal Feeding Operations (CAFOs), who produce 90% of meat, eggs, and dairy in the United States, are the biggest polluters in the USA and the biggest contributors to drought than any other industry. These CAFOs pollute the air, ground, and water locally and afar, without regulations that control their waste or smell. The excrement is dumped, untreated, like from your septic tank, into giant poop/pee lakes that can be many acres in size, and then sprayed directly on the ground.

And, cattle are worse, they're ten times that of hogs or produce over 100 times more waste than humans. A human produces about 1# of poop per day, a hog 11#, and a cow 115#.

Exporting meat from Confined Animal Feeding Operations in United States doesn't make any sense when average Americans are left with the expense in dealing with all the waste products that all CAFOs are immune from. The adverse effects on health are major and hard to quantify, the same for Global Warming, and the affects on lo-

cal environments where they reside. CAFOs are a major cause of drought throughout the world, a 1/4 pound of pork sausage or beef burger takes 600 gallons of water to produce, so supporting CAFOs by eating meat should not-resonate well with Californians.

Also, the World eats steak while you get cowpies, and it's 10 times worse than your pig polluting problem. The poop from a herd of just 4000 produces as much untreated waste as the city of Sacramento, confined on one 8 acre farm, and what a smell. Cattle are supposed to graze on land, naturally fertilizing it; instead of being confined to a space where they can't hardly move while standing, eating, and sleeping in excrement.

Democrat Rep. Mike Quigley (IL) faced intense backlash on Wednesday afternoon after claiming during Democrats' impeachment inquiry hearing that **“hearsay” can be “much better evidence than direct” evidence.**

In a rambling statement, Quigley said, “And, if gets to closed primer on hearsay, I think the American public needs to be reminded that countless people have been convicted on hearsay because the courts have routinely allowed and created, needed exceptions to hearsay.”

Quigley continued, “Hearsay can be much better evidence than direct ... and it's certainly valid in this instance.”

Donald Trump Jr. immediately turned his sights on Quigley, hammering the congressman in a series of tweets.

“Can you believe this insanity? ‘Heresay can be much better evidence than DIRECT EVIDENCE’ according to Democrat Mike Quigley,” Trump tweeted. “Are you fricken kidding me? 3rd and 4th party info better than hearing it yourself?”

Trump added, “From a reliable 4th party source according to other Democrats like #FullOfSchiff the best evidence is you just make up for political gain as that appears to be what they have been doing all along.”

Trump concluded, “Sounds exactly like what someone would say when they're desperate and have no actual evidence...”

Quigley was widely mocked online over his comments, including from Australian political commentator Rita Panahi, who wrote on Twitter, “I heard that Mike Quigley tortures puppies & then covers himself in goat poop & dances naked in the moonlight.”

Dana Loesch also weighed in, writing: “Just want to add that these lawmakers who say “hearsay can be much better evidence than direct” are the same ones who want to subject you to a due process-less red flag system. I'm sure that will just stop with guns, right? You still cool with that?”

One of the chief com-

plaints from Republicans on House Democrats' impeachment inquiry was the fact that the CIA whistleblower did not have any first-hand knowledge of the alleged incident and instead got all of his information from second and third-hand sources.

The Federalist reported in September that there significant changes made to the official whistleblower complaint form that allowed for hearsay to be used as evidence to submit the form. Federalist co-founder Sean Davis wrote:

Between May 2018 and August 2019, the intelligence community **secretly eliminated a requirement that whistleblowers provide direct, first-hand knowledge of alleged wrongdoings.** This raises questions about the intelligence community's behavior regarding the August submission of a whistleblower complaint against President Donald Trump. The new complaint document no longer requires potential whistleblowers who wish to have their concerns expedited to Congress to have direct, first-hand knowledge of the alleged wrongdoing that they are reporting.

The brand new version of the whistleblower complaint form, **which was not made public until after the transcript of Trump's July 25 phone call with the Ukrainian president Volodymyr Zelensky** and the complaint addressed to Congress were made public, eliminates the first-hand knowledge requirement and allows employees to file whistleblower complaints even if they have zero direct knowledge of underlying evidence and only “heard about [wrongdoing] from others.”

“Whistling” atty for impeachment in 2017 on Twitter

Mark Zaid, the attorney for the Ukraine call whistleblower, on Thursday, November 7th, defended a series of tweets from 2017 in which he predicted a “coup” against President Trump and promised to “get rid of him” -- saying in a statement the tweets referred to “a completely lawful process.”

Shortly after the publication of a Fox News article Wednesday, November 6th, highlighting the stream of anti-Trump tweets, Trump

himself lambasted Zaid during a rally in Louisiana, calling the attorney “disgraceful.”

“Those tweets were reflective and repeated the sentiments of millions of people,” Zaid said. “I was referring to a completely lawful process of what President Trump would likely face as a result of stepping over the line, and that particularly whatever would happen would come about as a result of lawyers.

The statement comes as Trump pointed to those 2017 statements in arguing the impeachment inquiry touched off by the whistleblower's complaint should be ended.

“Based on the information released last night about the Fake Whistleblowers attorney, the Impeachment Hoax should be ended immediately!” Trump tweeted. “There is no case, except against the other side!”

The anonymous whistleblower filed the complaint earlier this year about Trump's July 25 phone call with Ukrainian President Volodymyr Zelensky, in which he asked for Zelensky to assist in the investigations of alleged Democratic activities during the 2016 election, as well as former vice president Joe Biden and his son Hunter, particularly Hunter Biden's business dealings with Ukrainian energy company Burisma Holdings. The related impeachment inquiry has focused on whether Trump tried to pressure Zelensky into taking part in the investigations, and if military aid or a White House visit were used as leverage.

Zaid has been critical of Trump since the start of the administration.

As Fox News reported Wednesday, Zaid tweeted less than two weeks into Trump's presidency that a “#coup has started” and that “#impeachment will follow ultimately.”

On Feb. 5, 2017, still less than a month into Trump's term, Zaid said, “Every day that goes by brings us closer to impeachment.”

The following week, in response to an accusation that Zaid had taken sides against the president, the attorney was completely transparent in his animus.

“100%. I'm not hiding anything,” he tweeted. “Anti-Trump. Worst presidential choice in modern history. Not a repub or dem issue.”

Then, in July 2017, Zaid remarked, “I predict CNN will play a key role in @realDonaldTrump not finishing out his full term as president.” Also that month, Zaid tweeted, “We will get rid of him, and this country is strong enough to survive even him and his supporters.”

Marysville Council Meeting New Agreement Concerning B Street Property

Marysville, Ca. – On the Marysville City Council agenda for November 19, 2019; under consent (without discussion) is "Agreement: New Economics & Advisory for B Street Property, Land Use Disposition Analysis"

This was discussed before with public input which said that the things the City Council is getting from this company they can get for free with commercial realtors. And at least list this property which still hasn't been

listed for quite some time and we're now asking for more money to go to the consultants.

The City recommends that the Council Pass a Resolution amending an Agreement between the City of Marysville and New Economics & Advisory expanding the scope of work for an additional \$9,000 and a new total not-to-exceed amount of \$32,000.

The city analysis states Since undertaking the Scope of Work, New

Economics & Advisory and City staff have realized that drawings of the various land use types that include setbacks and required parking would aid in understanding the site's capacity and maximum building envelope thereby facilitating any future policy direction as to how to dispose of the property. In addition, the visuals would also help with further defining and narrowing the economic and market analysis.

Rural County Representatives of California Tasked with finding solutions to insurance cancellations due to fire risk

On Thursday, November 14th, the Rural County Representatives of California (RCRC) hosted its third Homeowners' Insurance Ad Hoc Committee (Committee) meeting. This meeting was held at the Ronald Reagan Presidential Library in Ventura County. RCRC member counties have been disproportionately impacted by recent homeowners' insurance cancellations and non-renewals following years of devastating wildfires in California.

In June, the RCRC Board of Directors approved a resolution

creating the Committee. The Committee is tasked with considering potential solutions for the increase in homeowners' insurance cancellations and non-renewals in high fire risk areas. In particular, how county governments can develop programs and measures to encourage greater community-wide access and affordability to homeowners insurance.

The potential solutions include, but are not limited to, introducing additional insurers into rural areas, working with the insurance industry on an insur-

ance risk-reduction model, examining insurance industry risk modeling, re-creating/revising California's Fair Access to Insurance Requirements Plan (FAIR Plan), and working directly with policy advocates, the California Legislature, and the Department of Insurance to explore other options.

The Committee is tasked with issuing a report of findings no later than the August 2020 Board of Directors meeting.

Final Update for PG&E 10/9 Event

Pacific Gas and Electric Company (PG&E) released photos of wind-related damage and hazards that were found during inspections following the October 9 Public Safety Power Shutoff (PSPS). The company is making photos available on its website at www.pge.com/octoberpsps.

The 116 incidents of damage or hazards were spread widely across PG&E's service territory. Wind gusts exceeded 50 mph in 15 counties throughout PG&E's service territory, and damage or hazards were found throughout impacted areas. It is possible that these damages and hazards represented potential sources of wildfire ignition.

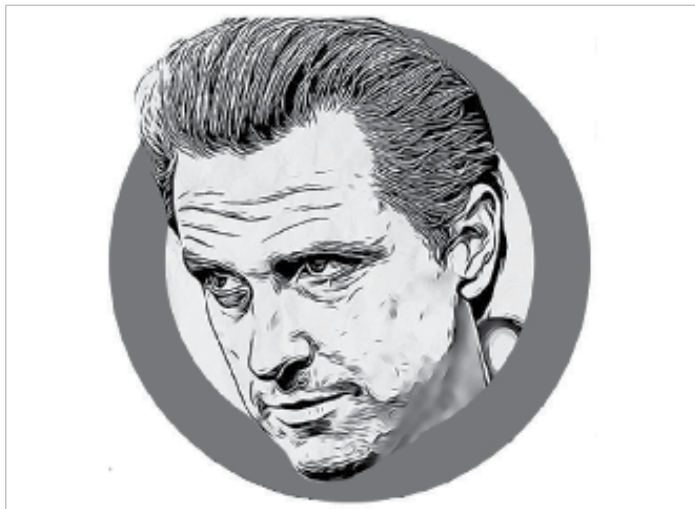

access our money since the banking network was offline. In Zulia, all hell broke loose.”

When available, water is collected in buckets to make it through power /

Instead, government officials have incentives to please voters by selling products at low prices and hiring more employees than necessary, even when that's the wrong industry decision. California working landscapes provide economic vitality

California farms and businesses associated with agriculture continue to be economic powerhouses, according to a new study. It analyzed the economic contributions of California's "working landscapes" and found that agriculture and other support activities account for 6.4% of the state's economy, support more than 1.5 million jobs and generate \$333 billion in sales. The value of the state's working landscapes comes in ahead of health care, real estate, retail and construction industries.

Survey says U.S. is No. 1 in food affordability

Americans have the world's most affordable groceries, according to an American Farm Bureau Federation analysis. The organization reported that people in lower-income countries spend much more of their household budget on food than those in high-income countries, and added that agricultural trade and policy can take some of the volatility out of global food prices.

California to exchange agricultural expertise with two countries

Two agreements have been finalized for agricultural information sharing between California and researchers in the Netherlands and India. The California Department of Food and Agriculture and the Netherlands Ministry of Agriculture, Nature, and Food Quality have committed to exchanging knowledge on topics including climate-smart agriculture, agricultural sustainability, water management and food waste. The second agreement between Fresno State University and Punjab Agricultural University in India involves sharing research on subjects such as water management, irrigation technology, agricultural mechanization and crop improvement.

Power shutoff may have boosted fire risk

A power shutoff meant to stave off a wildfire meant a Ventura County avocado and citrus farmer couldn't irrigate his crops for nearly two days--and when the Maria Fire burned its way into his groves, he couldn't help firefighters battle the blaze. That scenario is frustrating a lot of growers dealing with power shutoffs and the threat of fire. In Sonoma County, losses from the Kincade Fire are still being tallied, but one agricultural commissioner thinks vine damage may be worse than in 2017.
